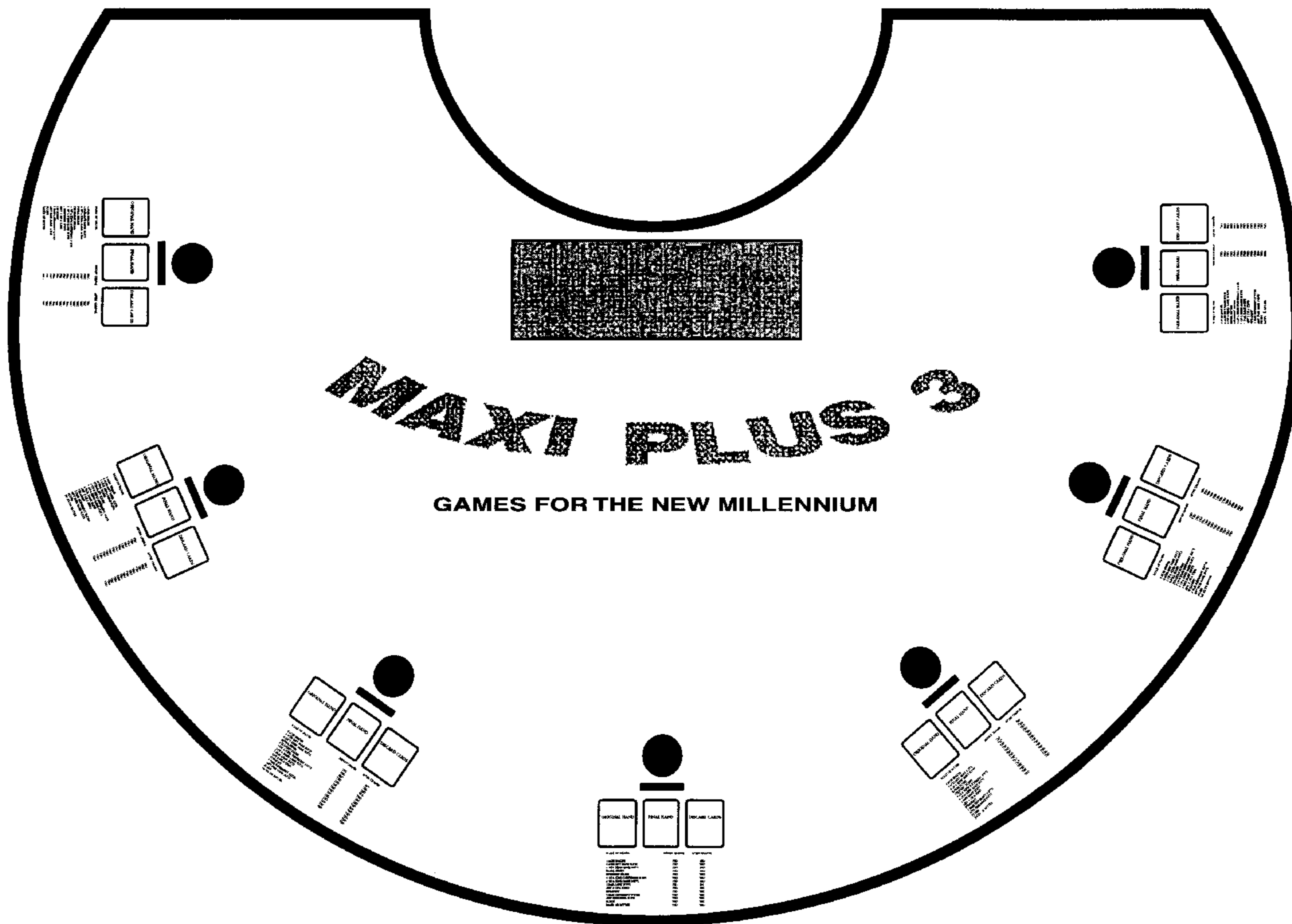
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a plan view of a game table cover illustrating one embodiment of the design.
FIG. 2 is an alternate embodiment of the design in FIG. 1, the only difference being the version number; and,
FIG. 3 is a representative close-up of a portion of the embodiment of FIG. 2.

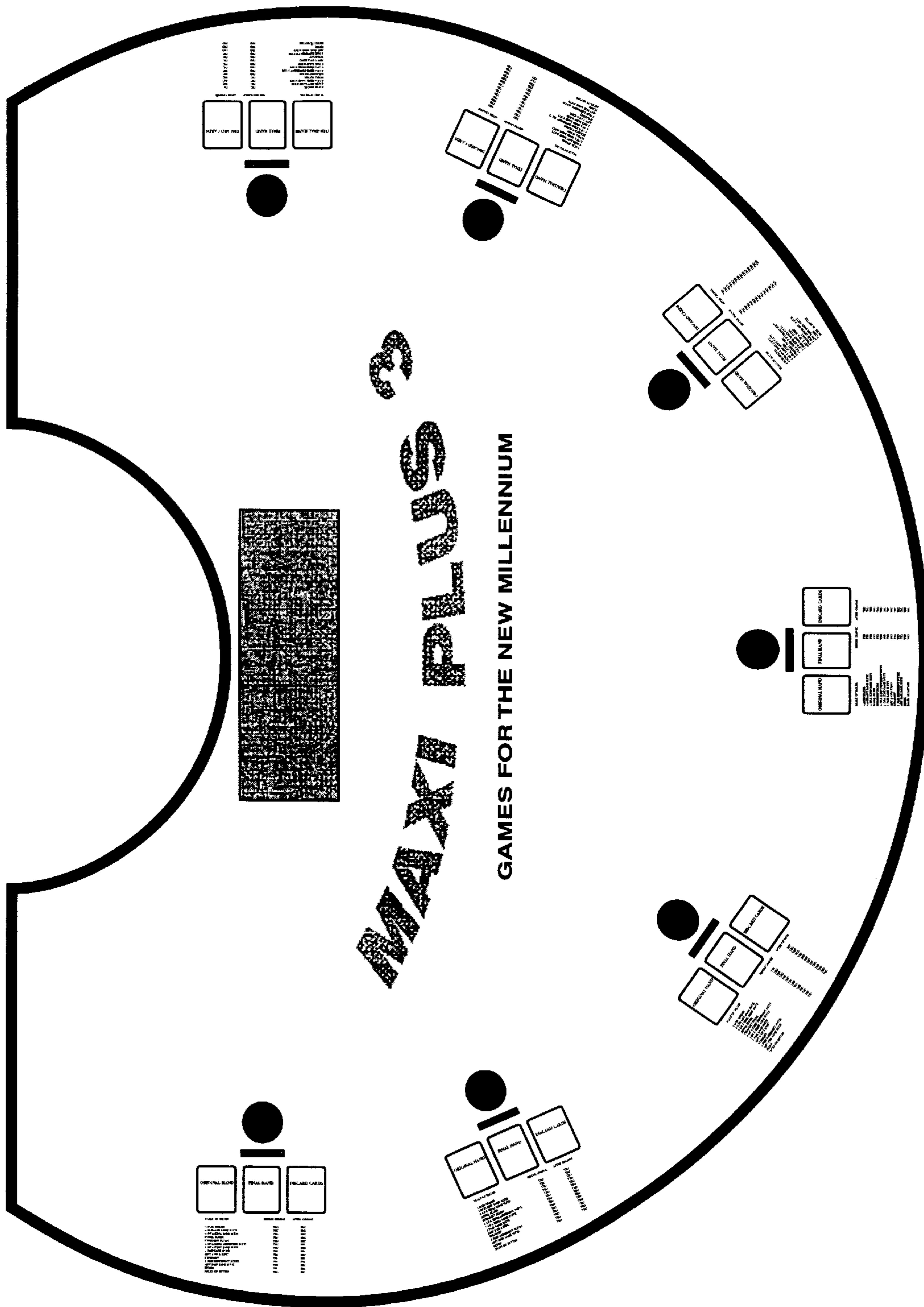

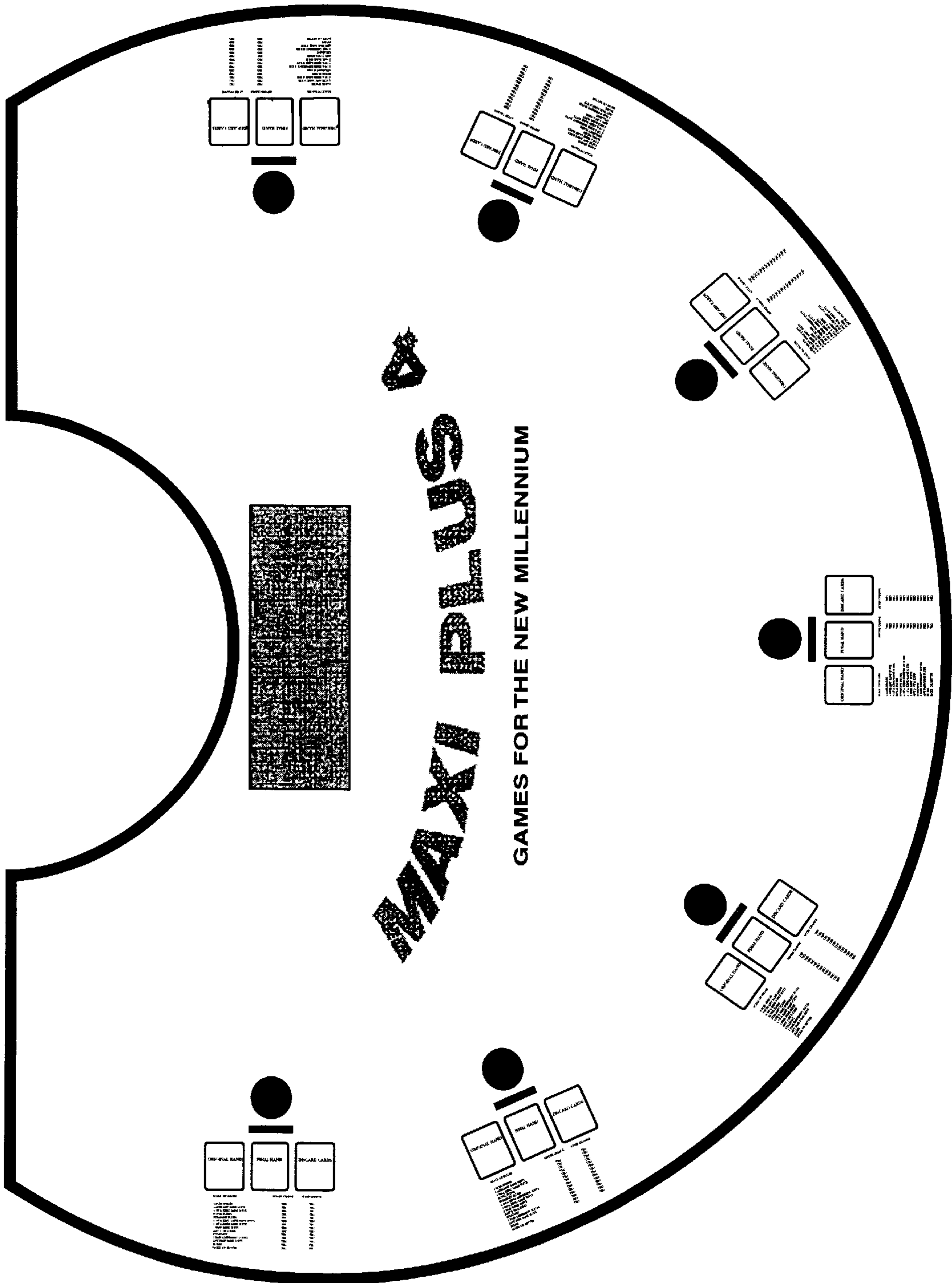
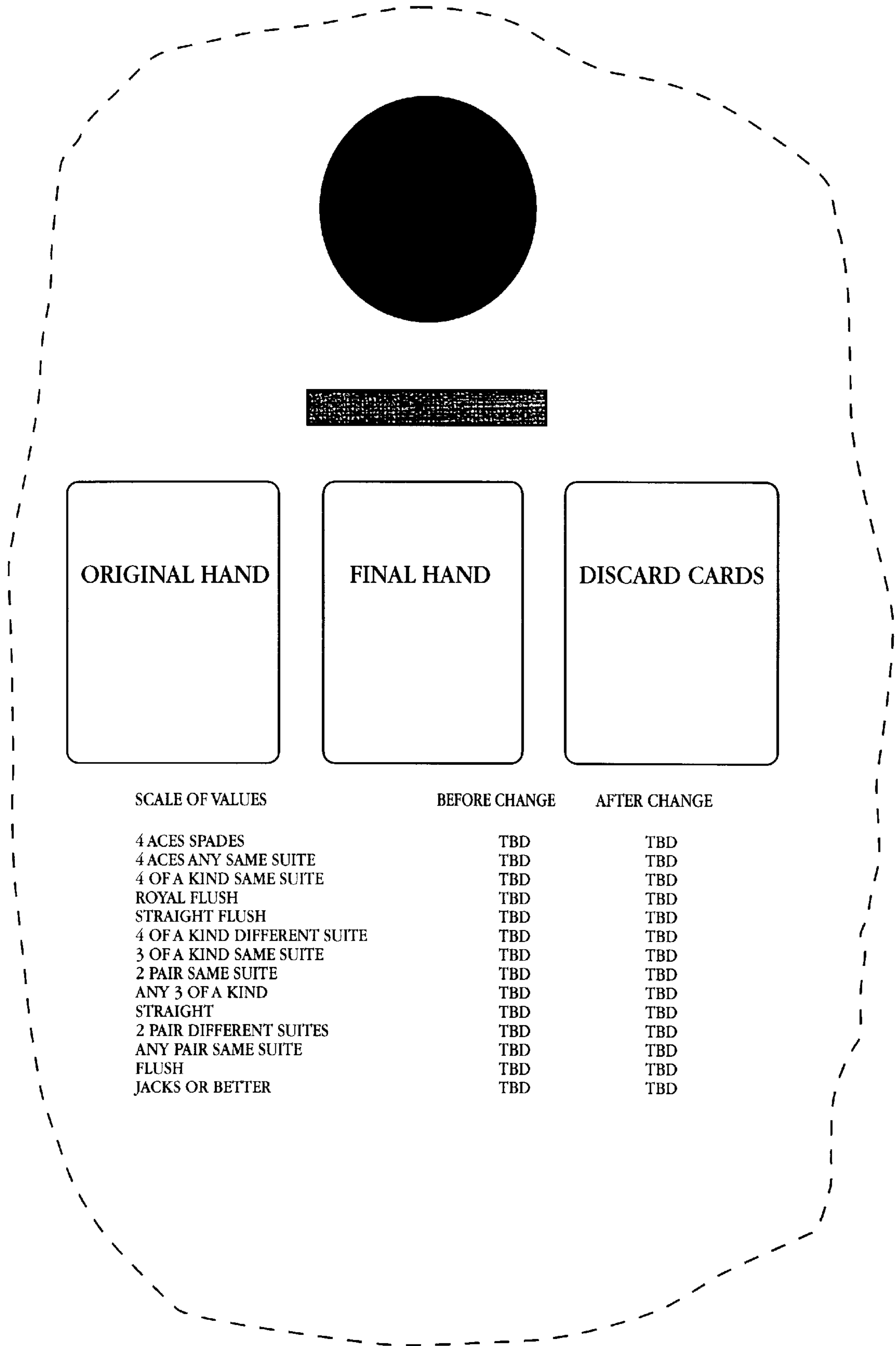
