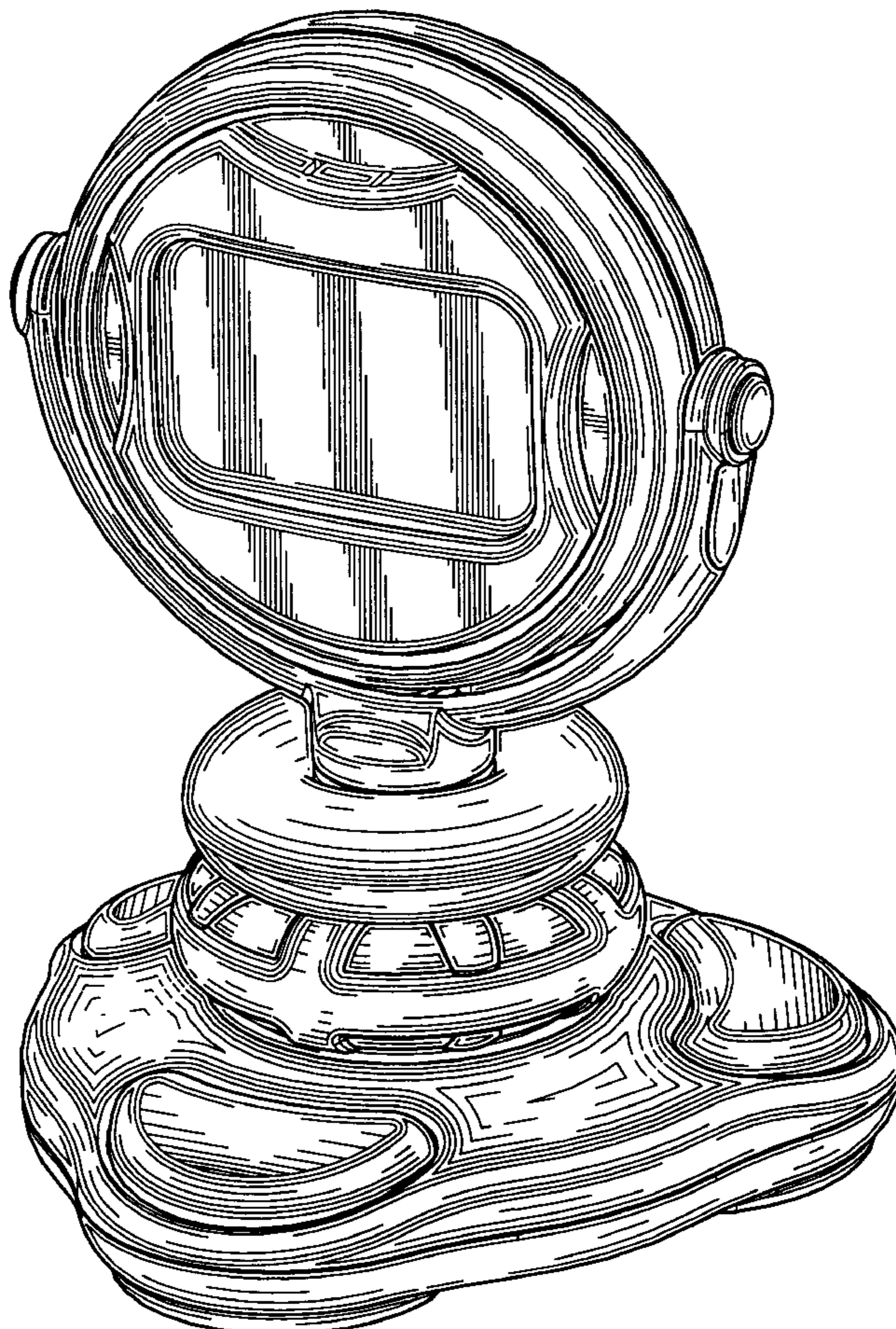
FIG. 1 is a top right front perspective view of a toy mirror showing our new design;

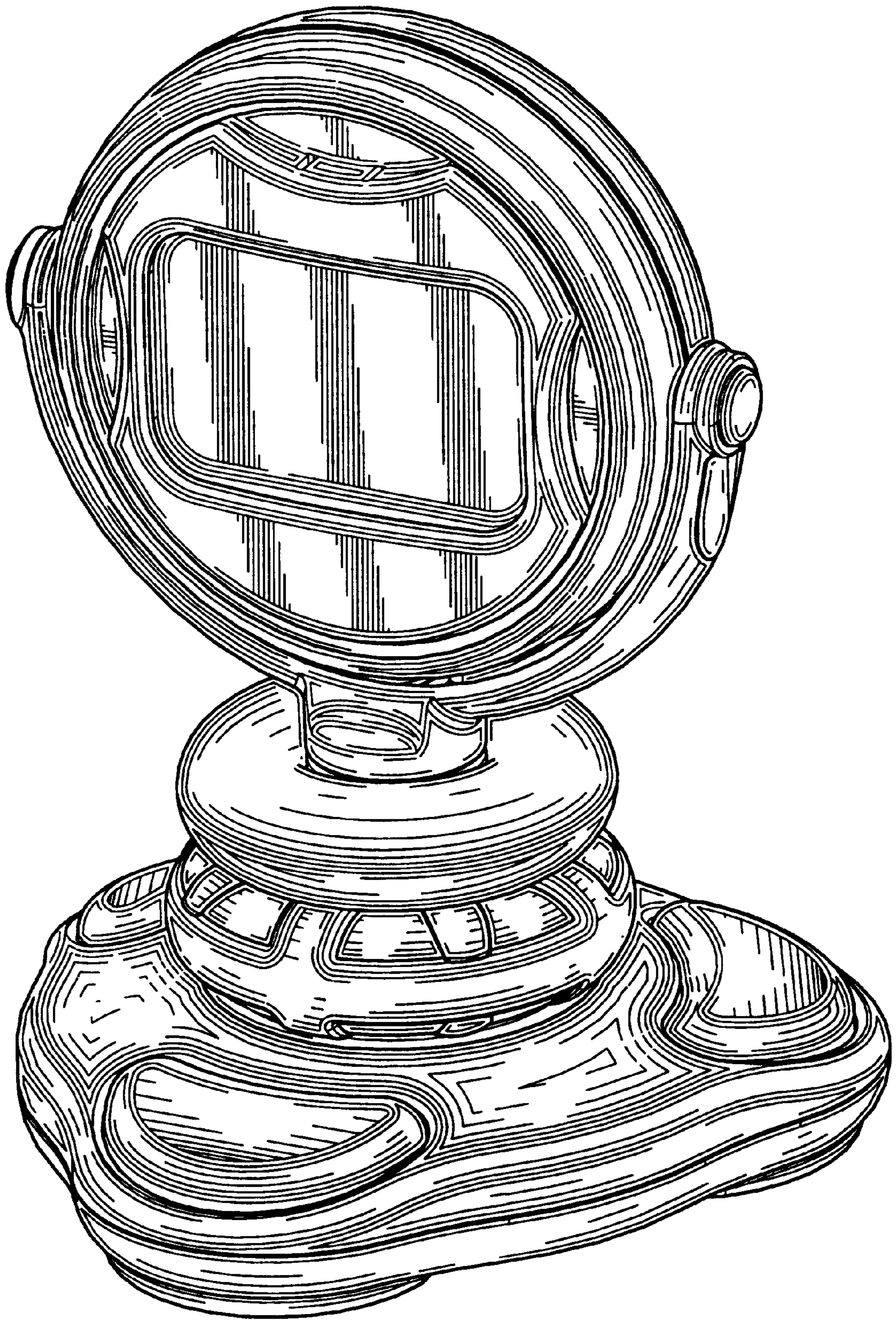

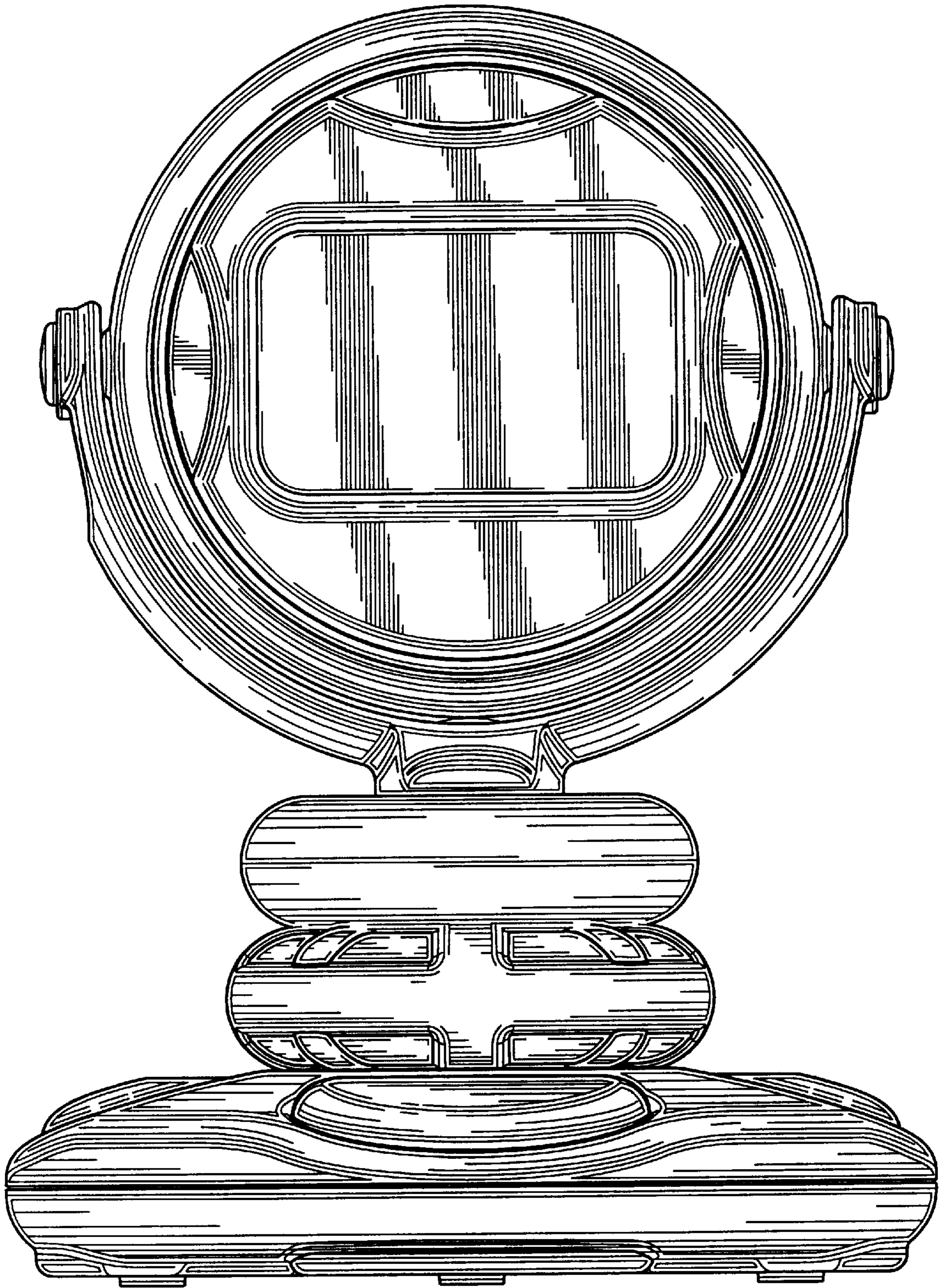

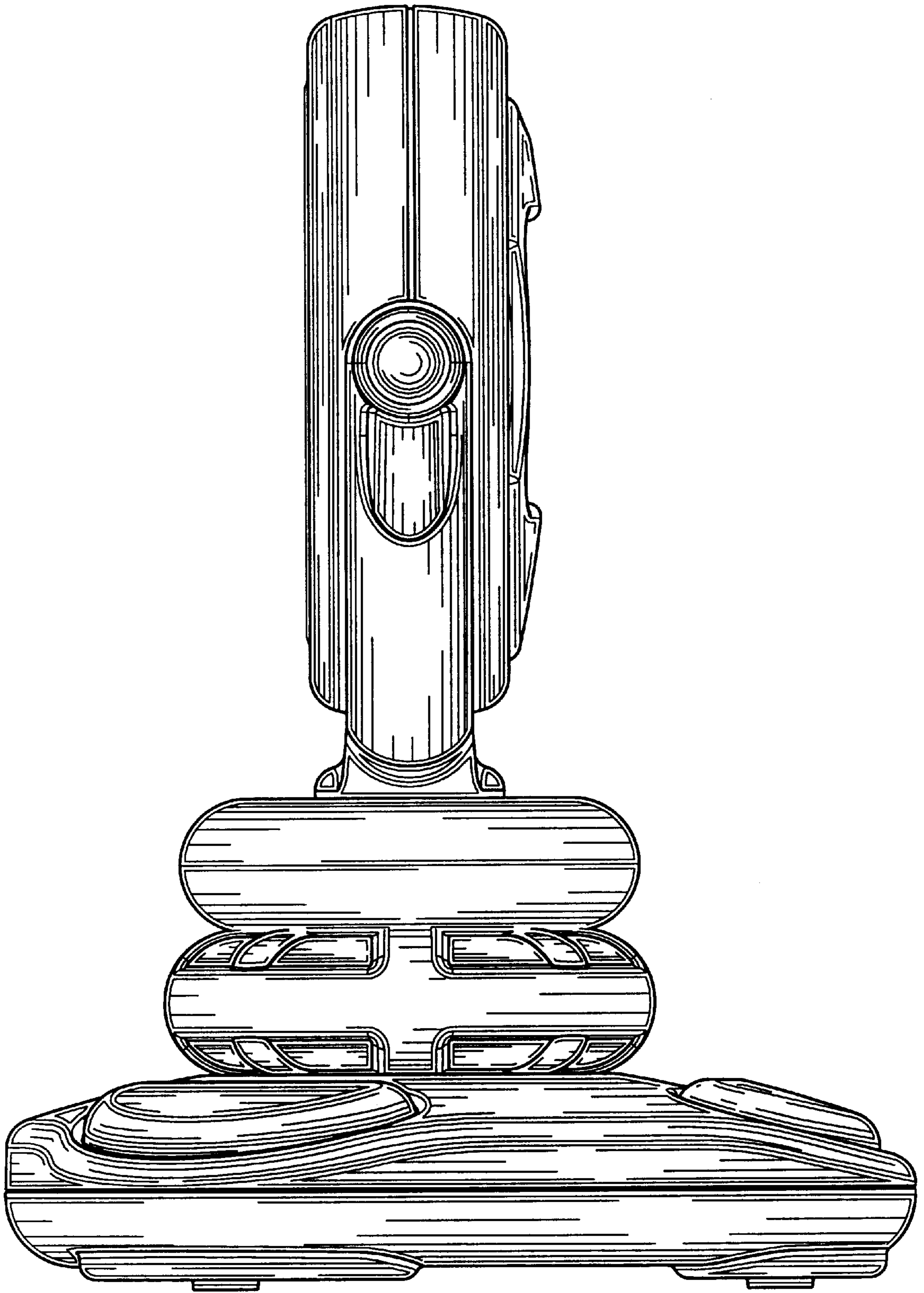

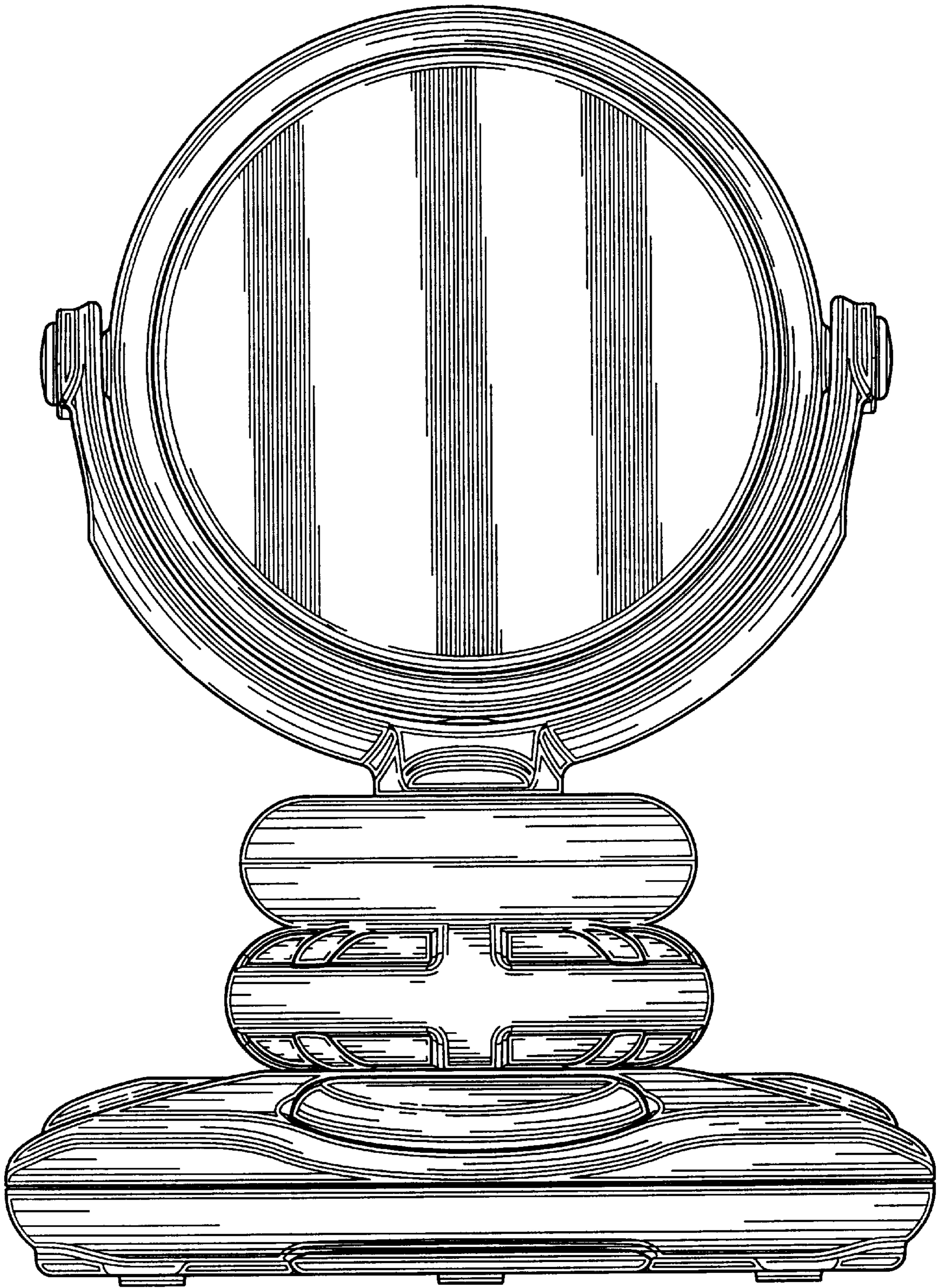

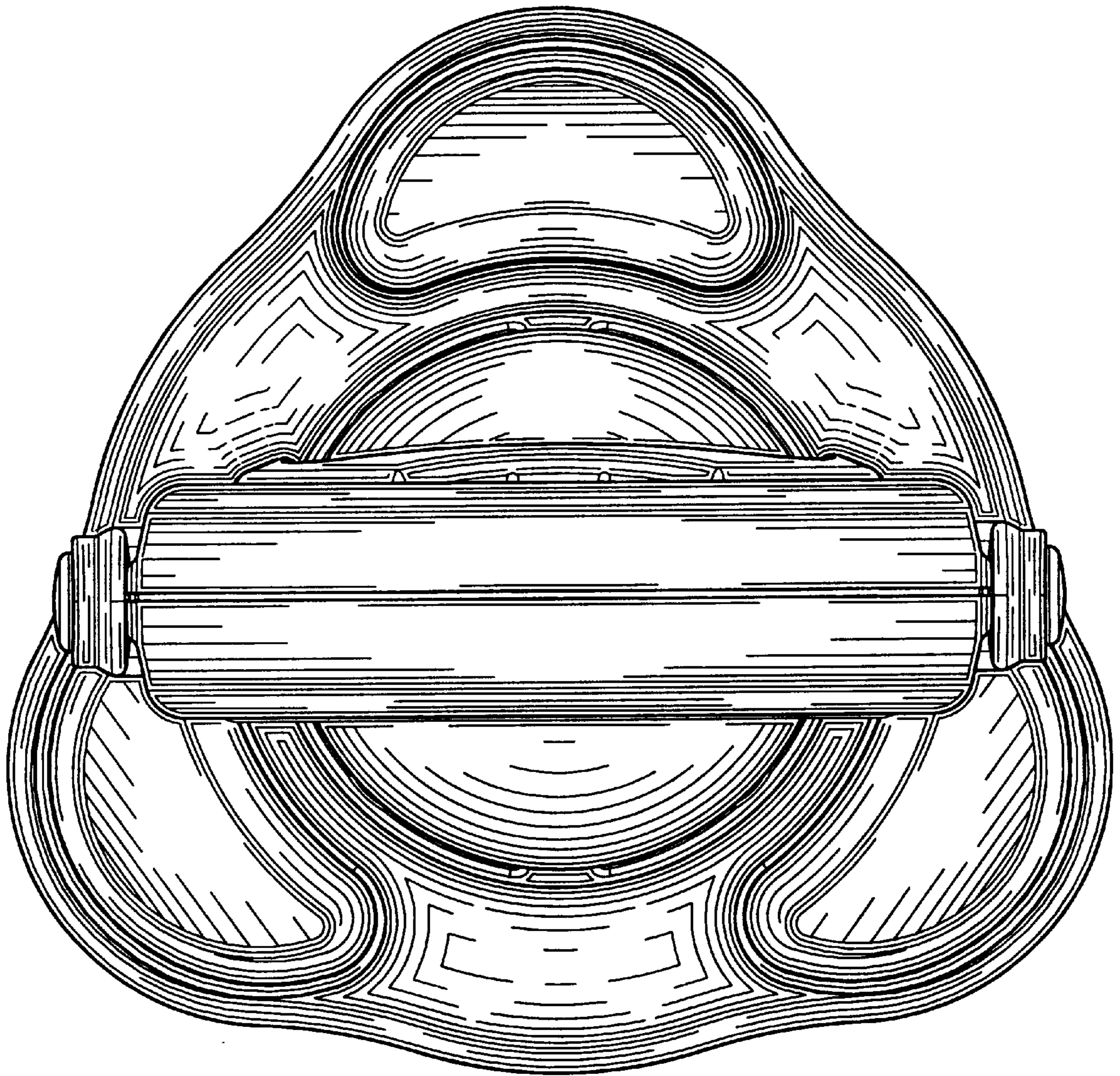

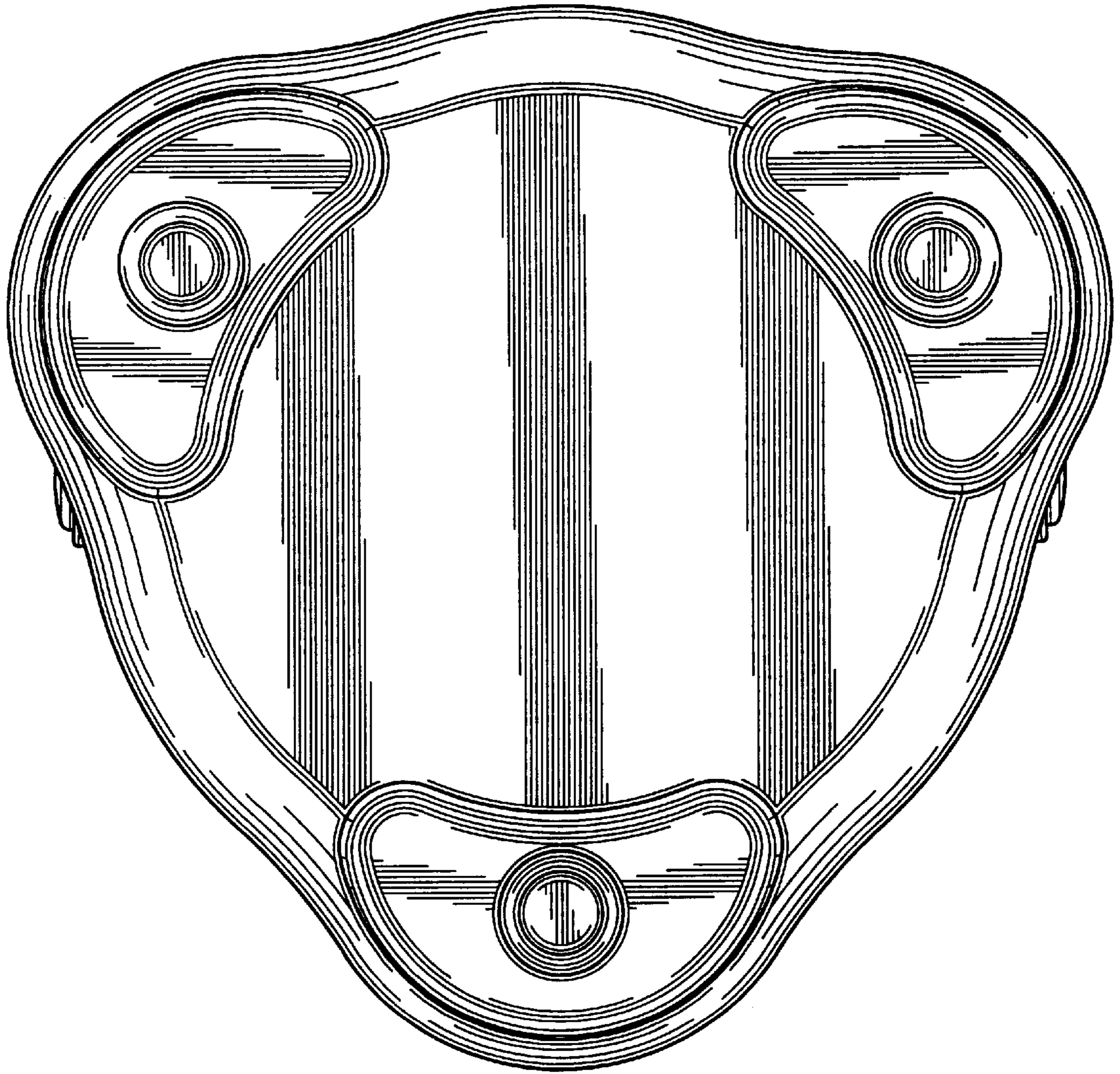
