FIG. 16 is a bottom view of the sleeve coupling of FIG. 13;
FIG. 17 is a side plan view of a fifth embodiment of the sleeve coupling;
FIG. 18 is a front view of the sleeve coupling of FIG. 17;
FIG. 19 is a top view of the sleeve coupling of FIG. 17; and,
FIG. 20 is a bottom view of the sleeve coupling of FIG. 17.

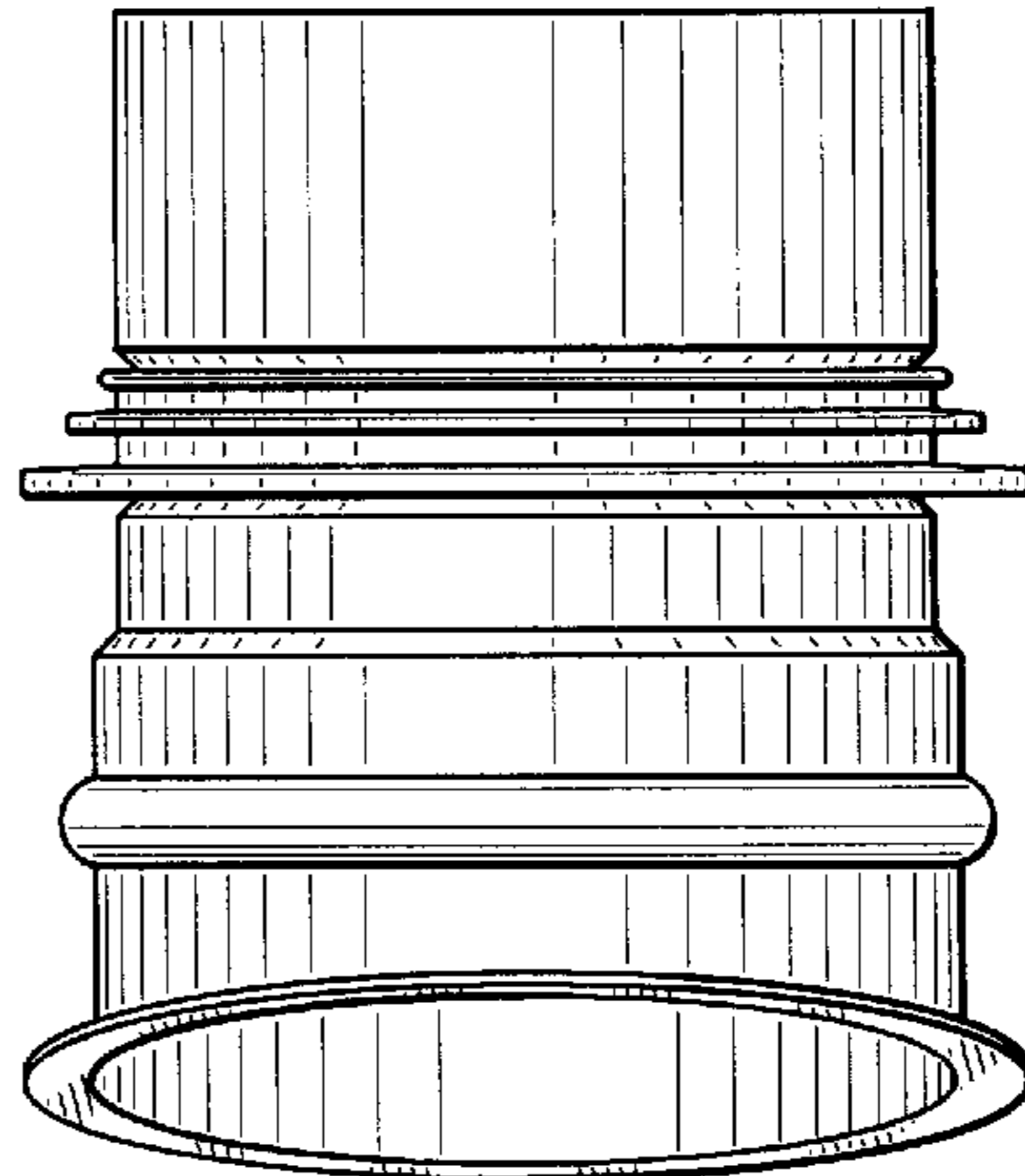
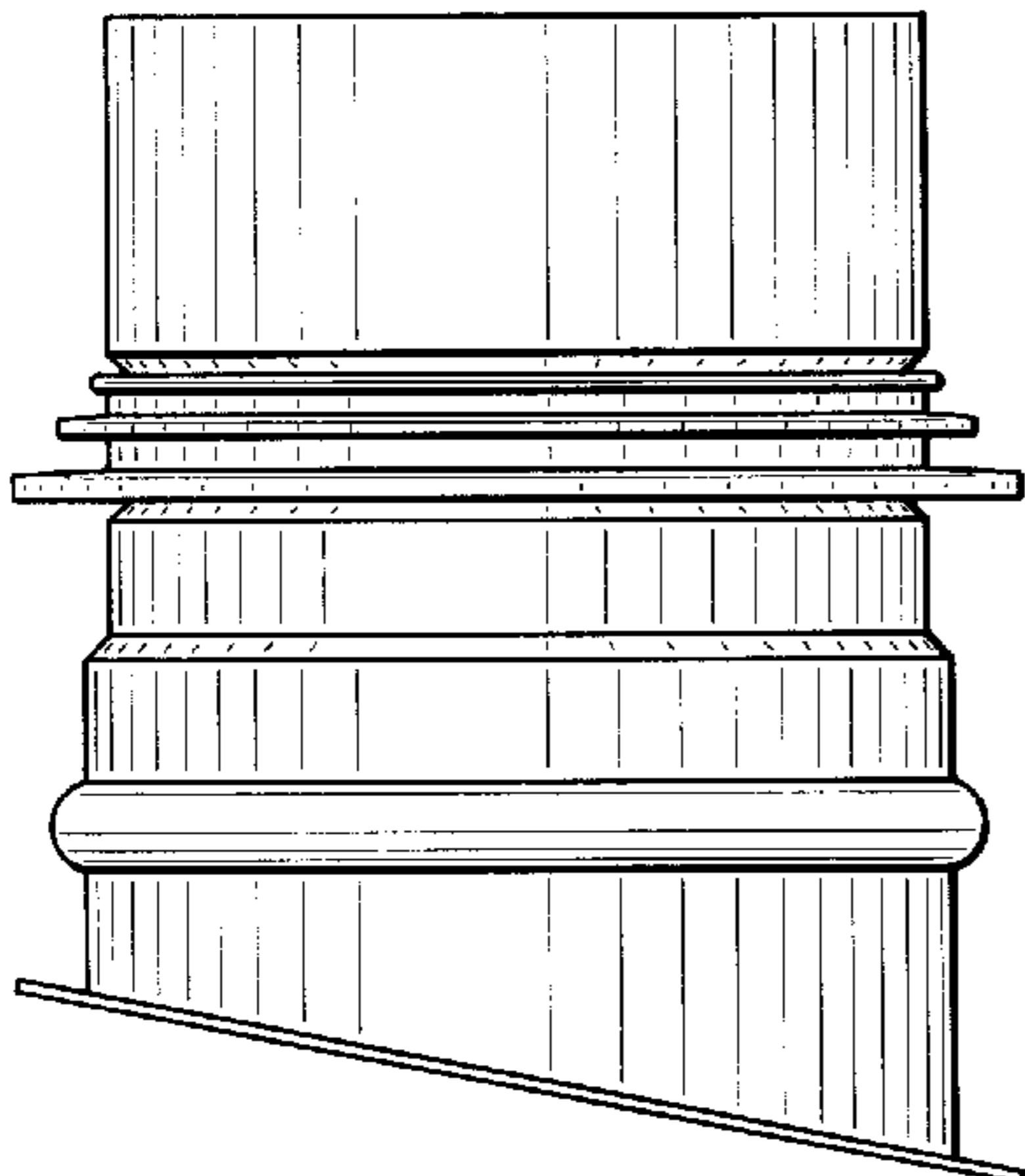

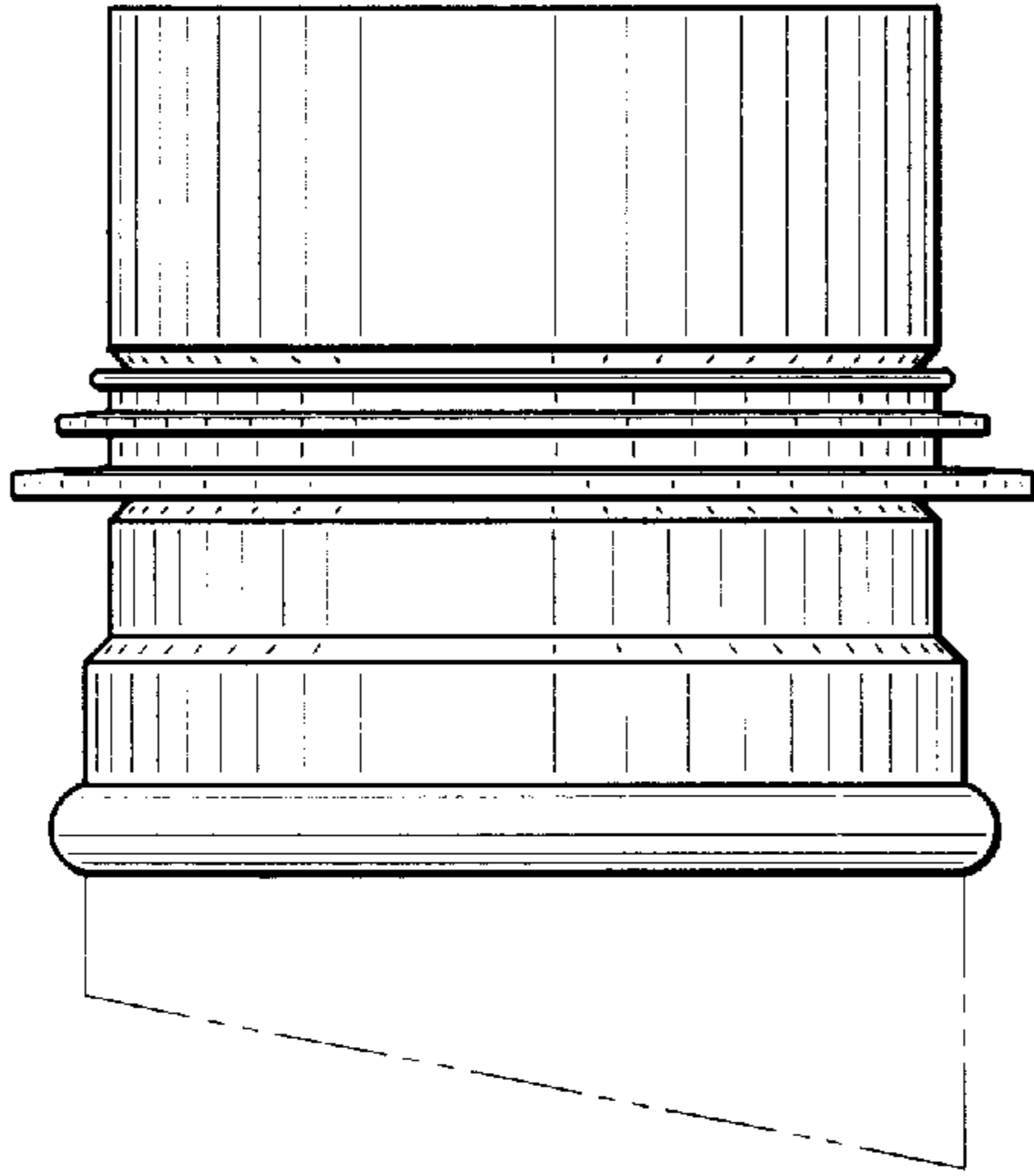

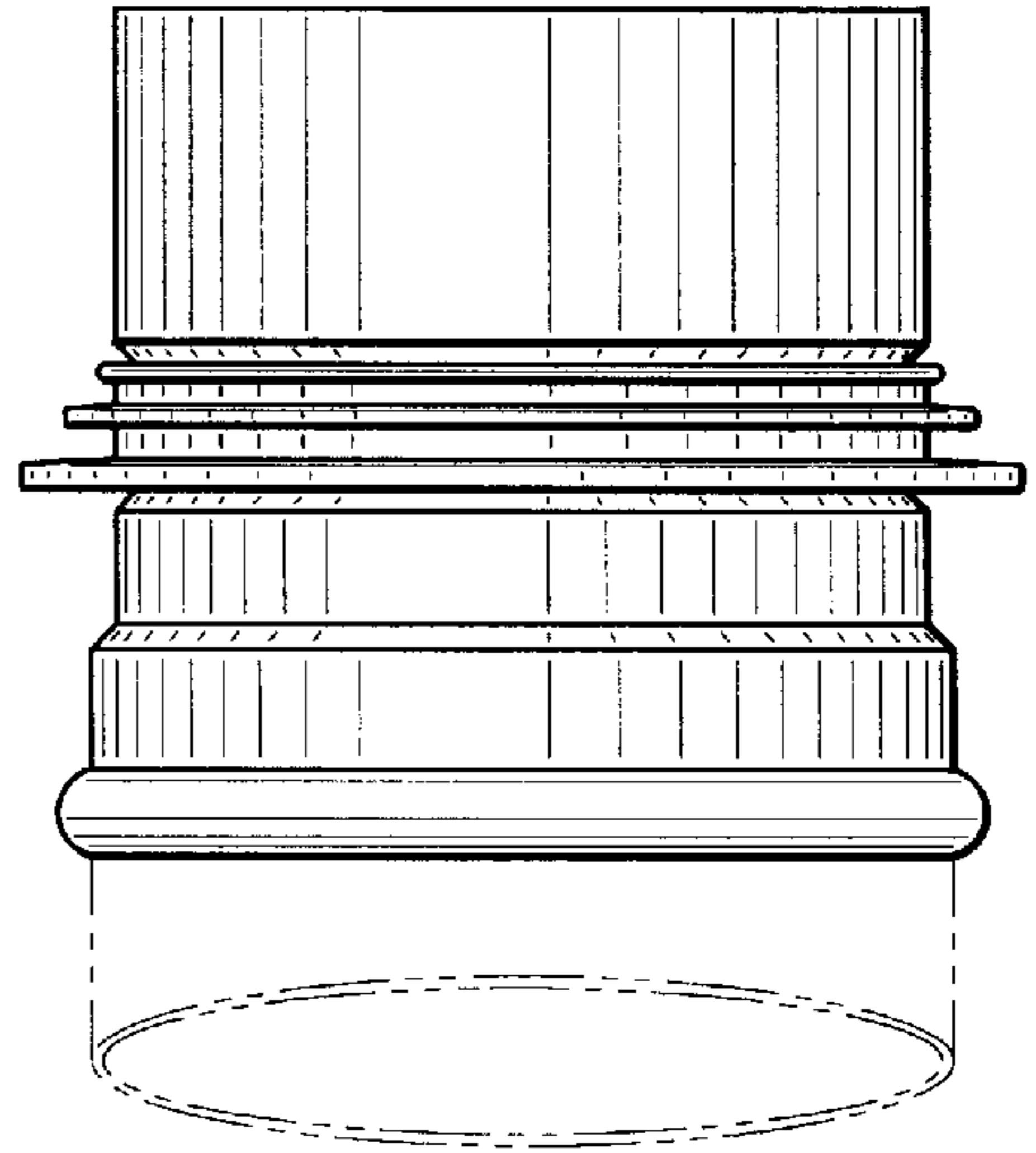

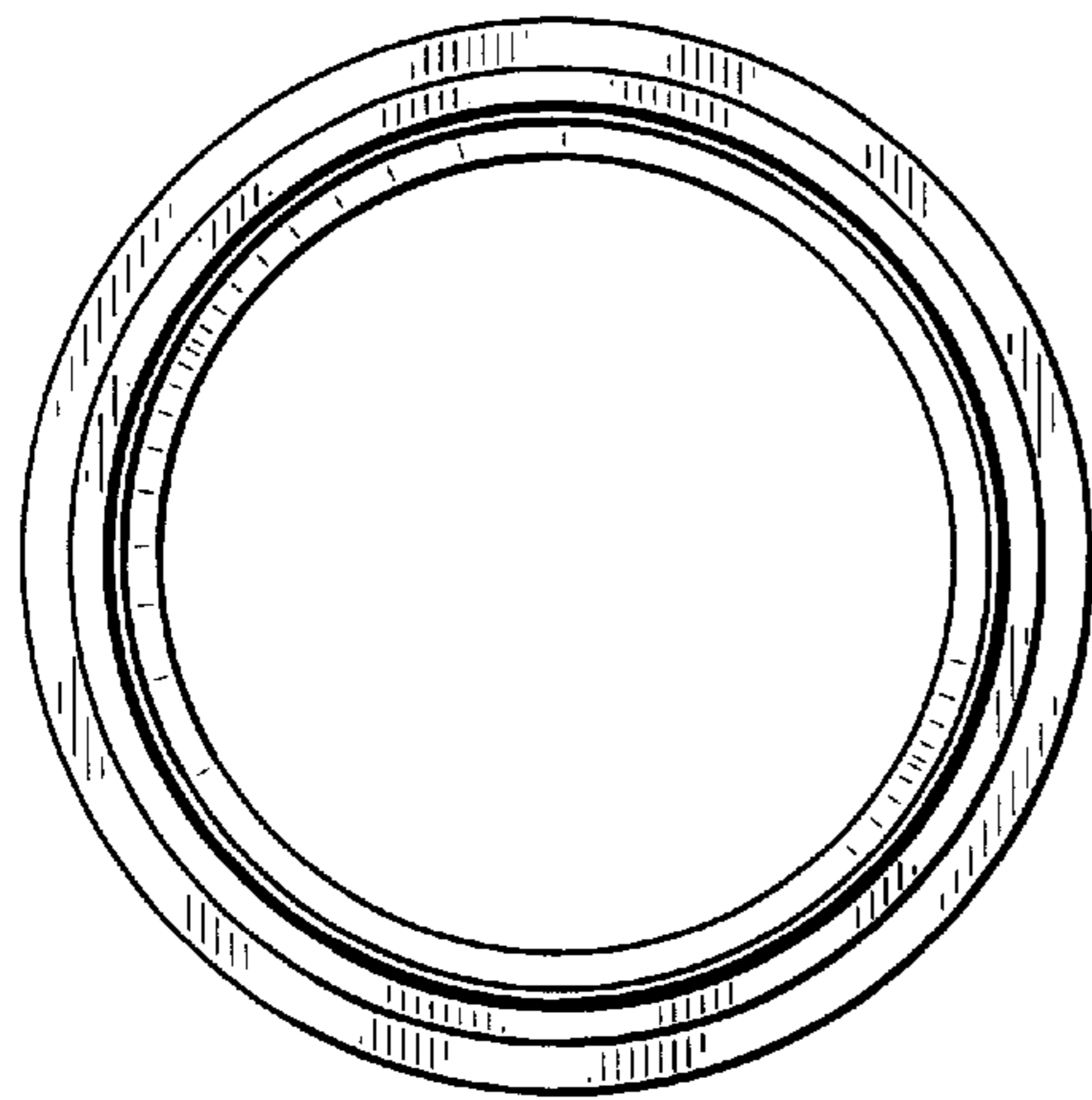

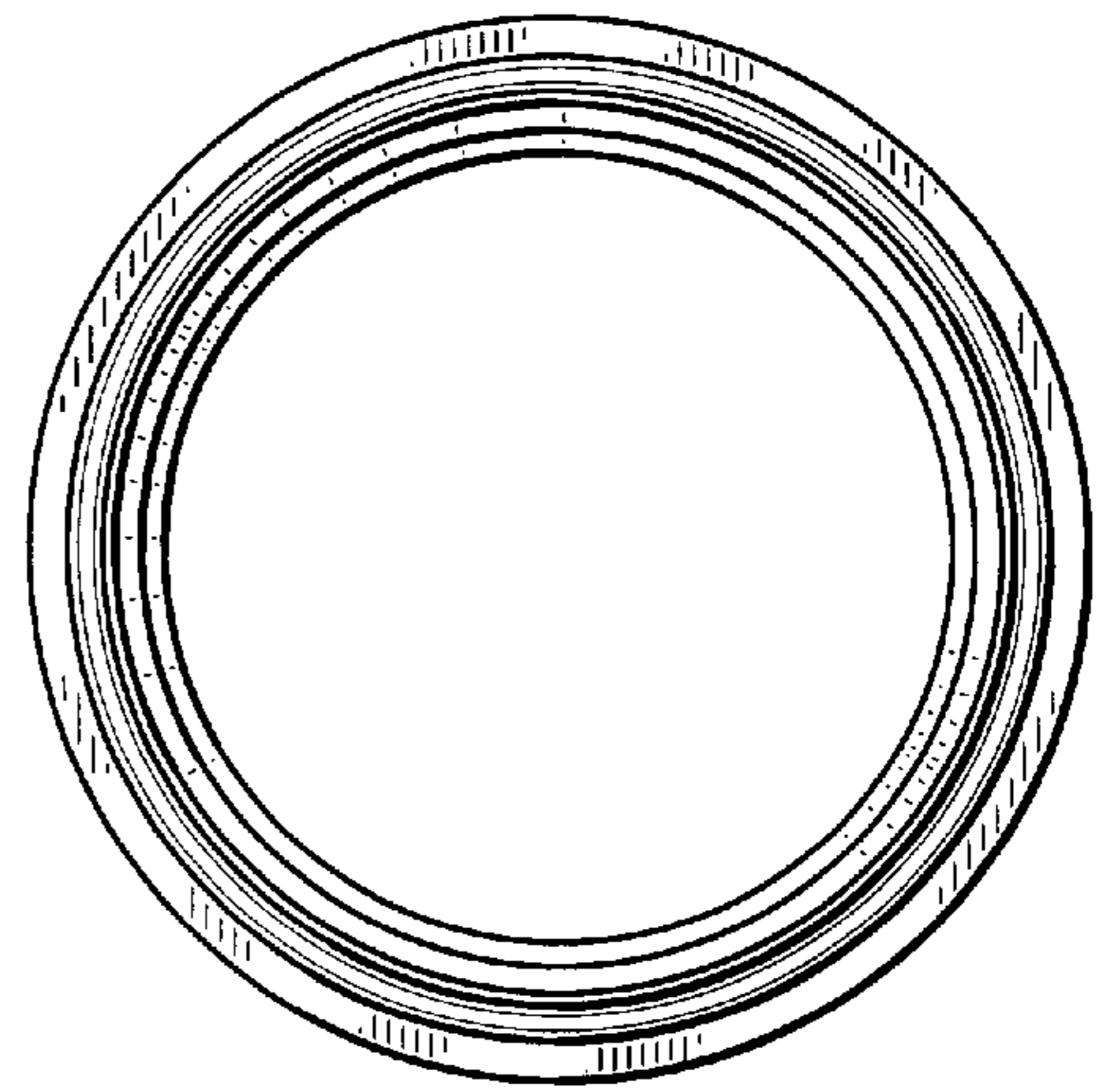

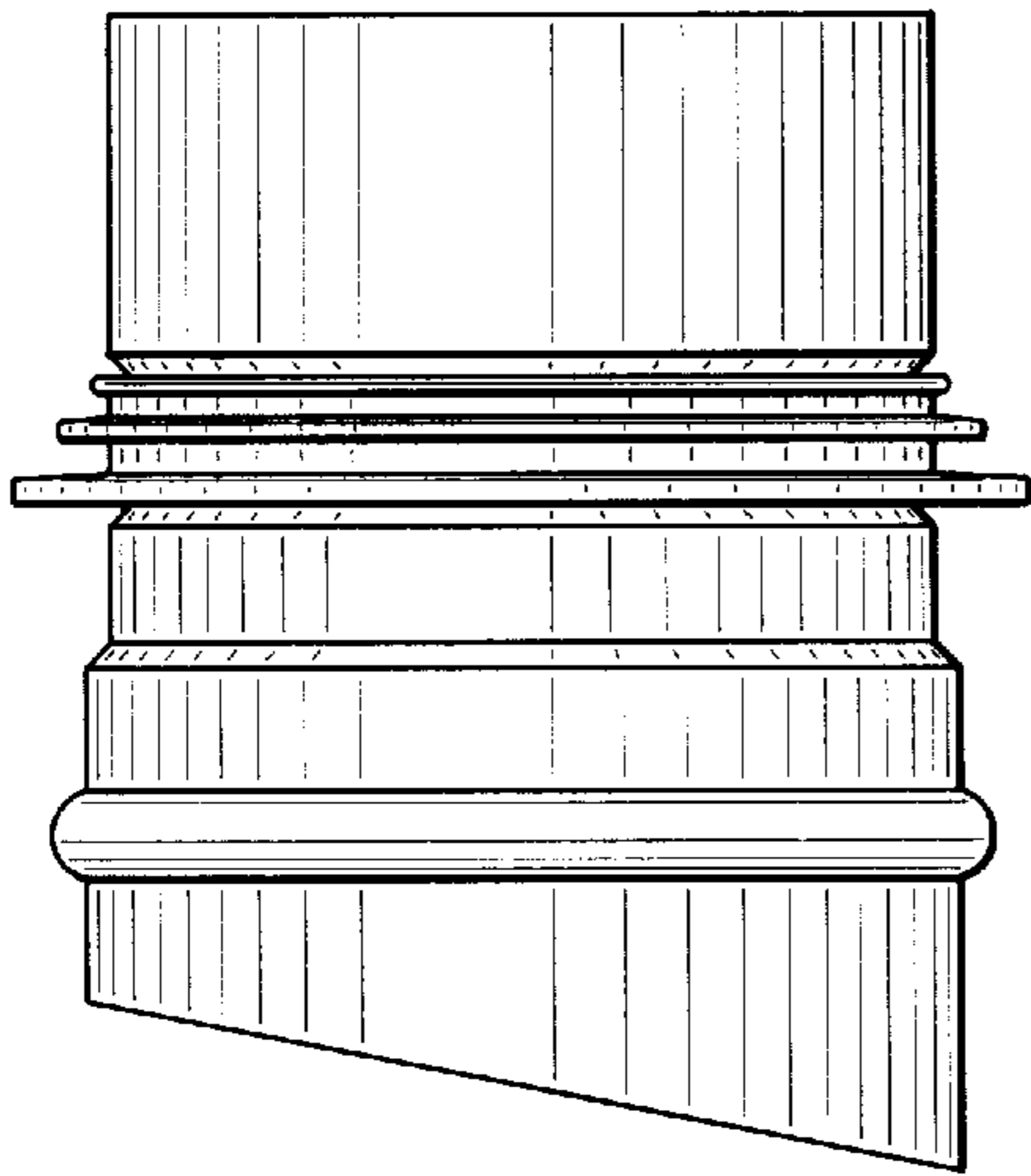

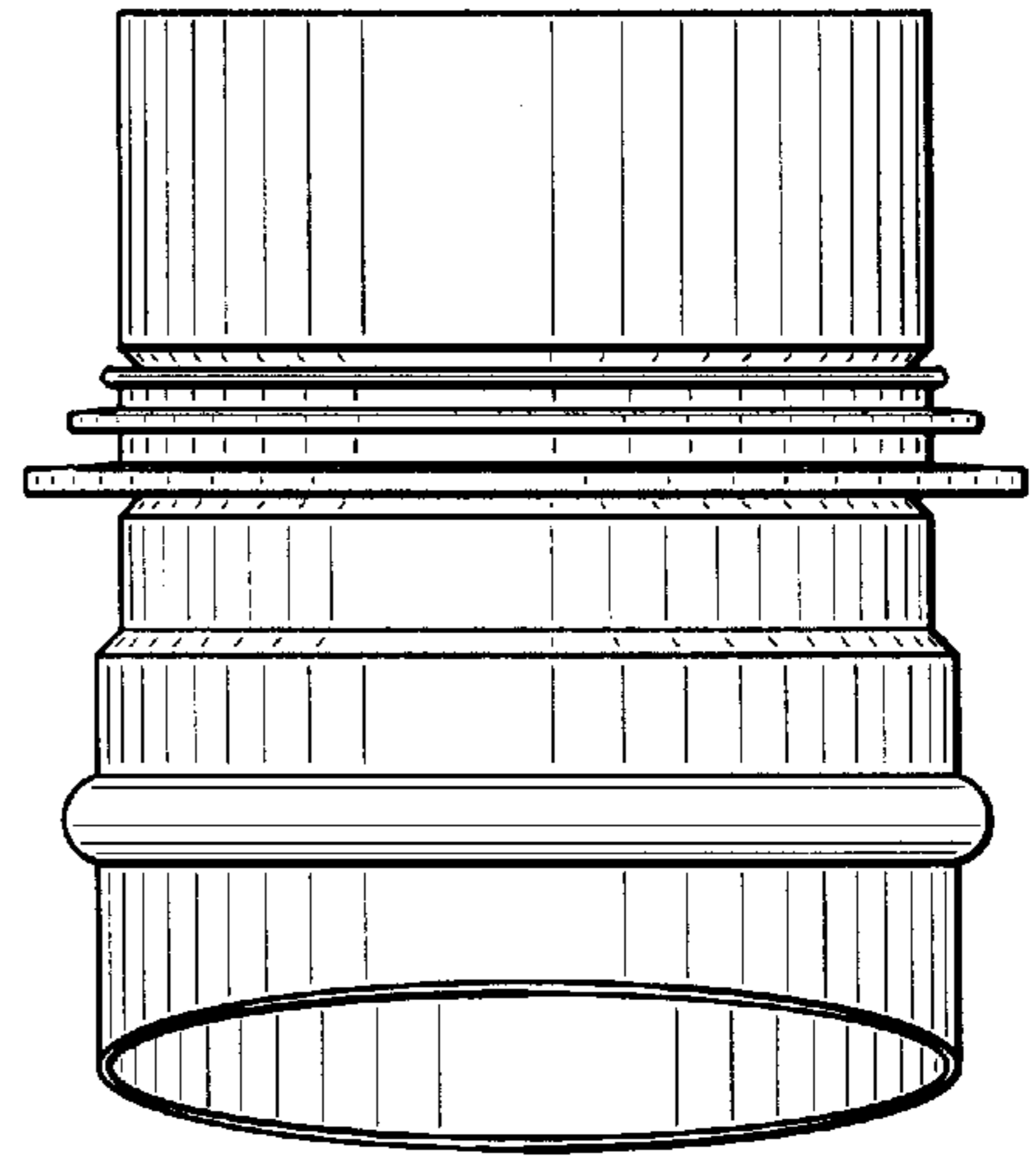

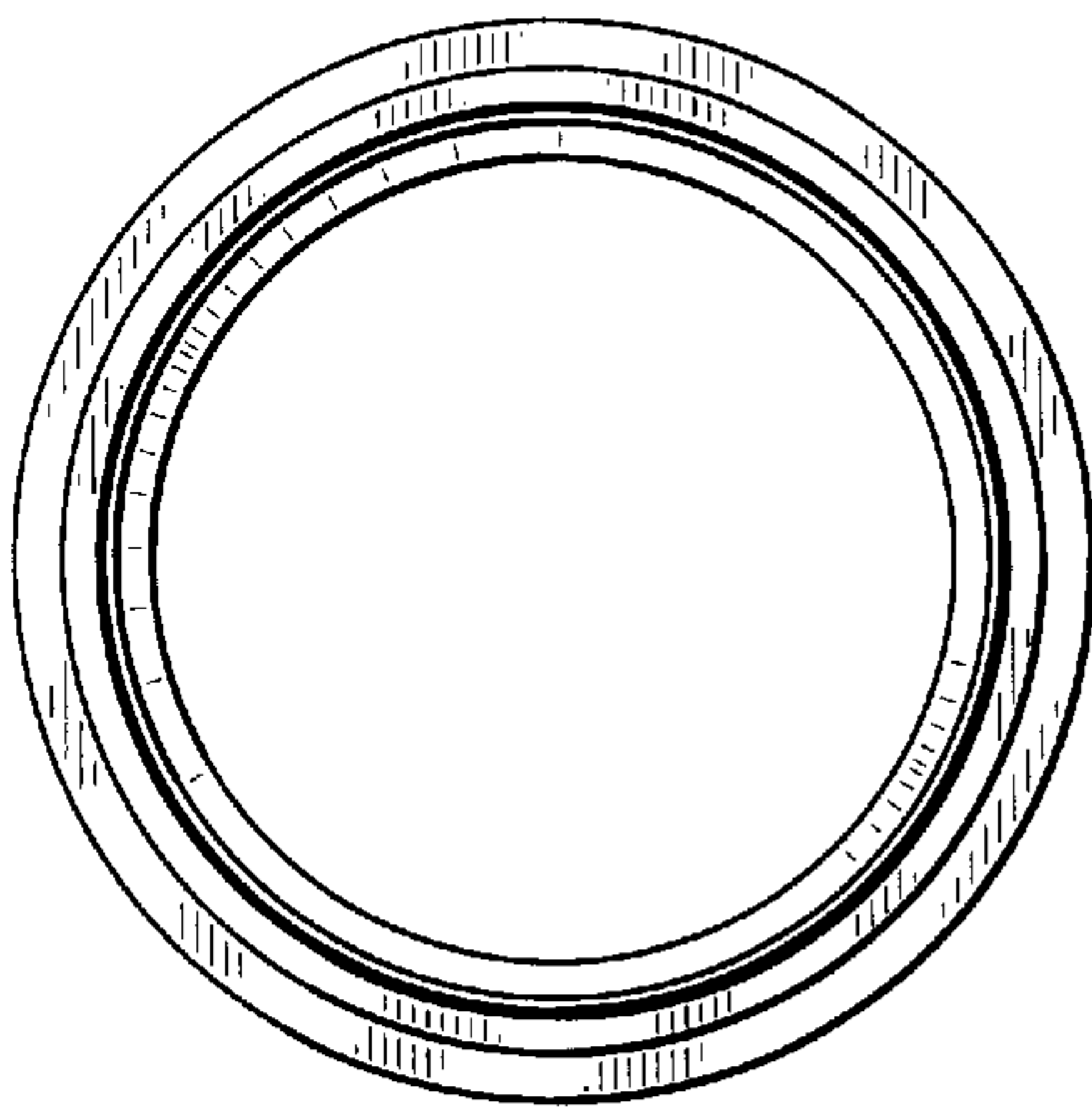

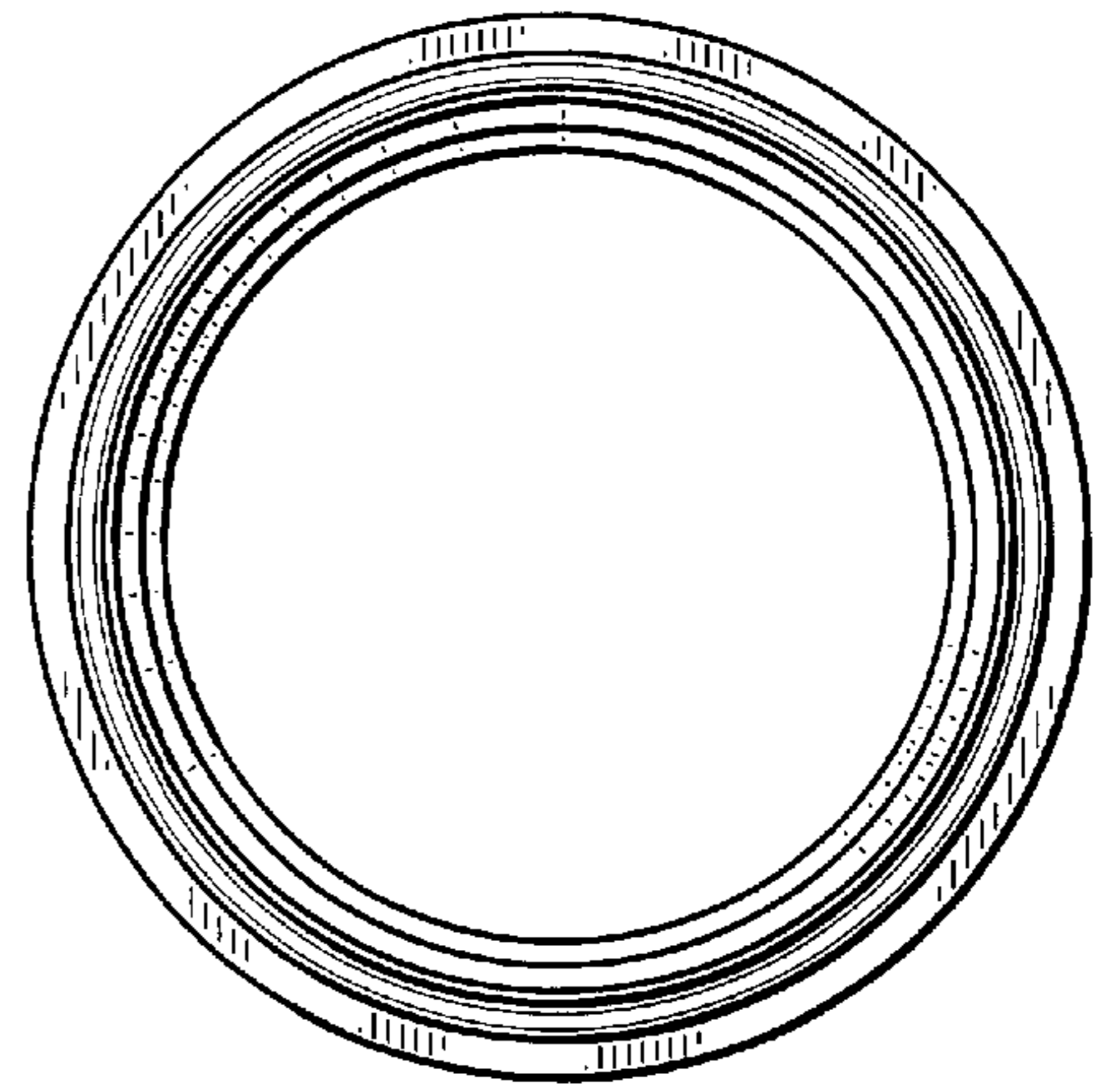

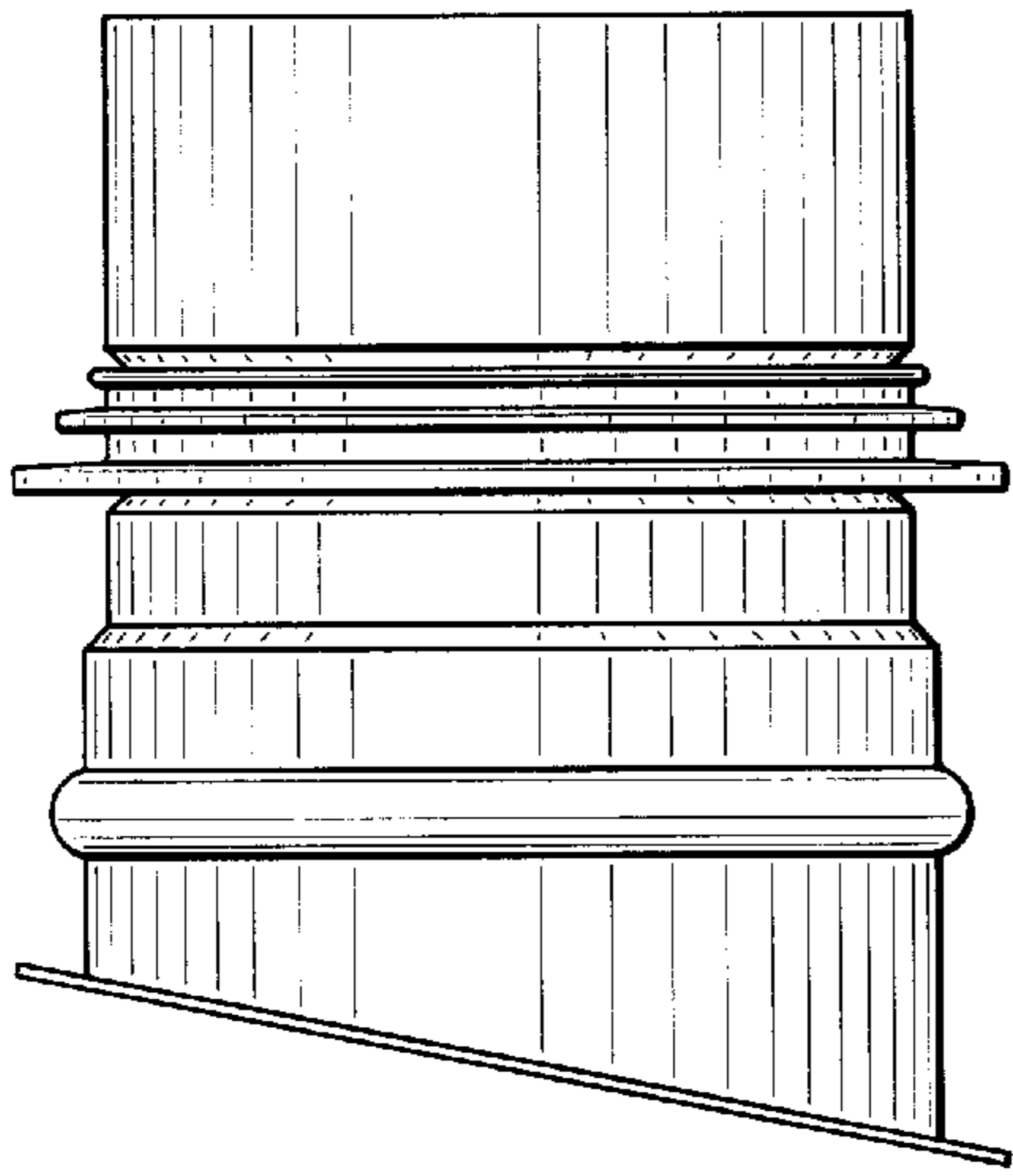

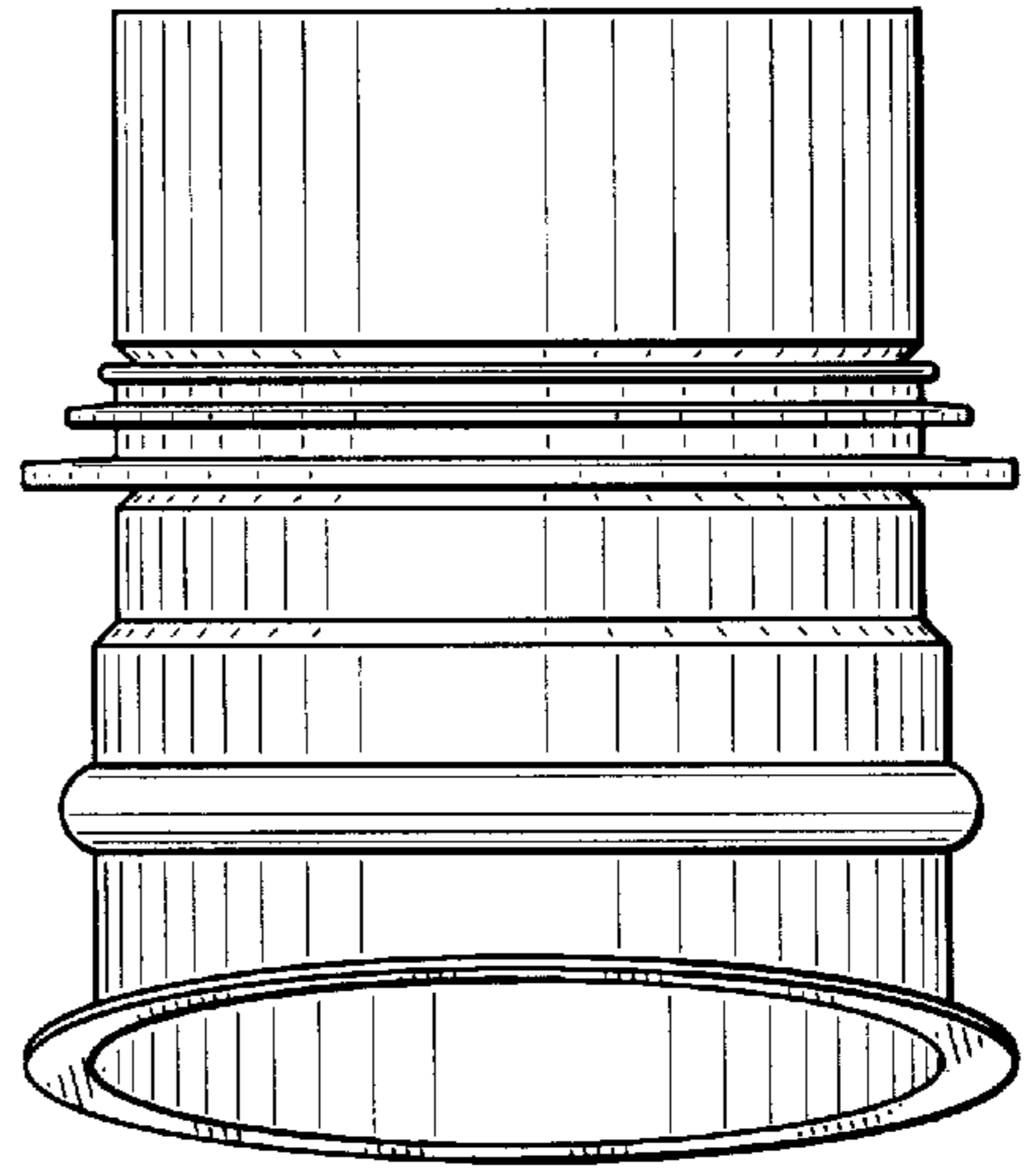

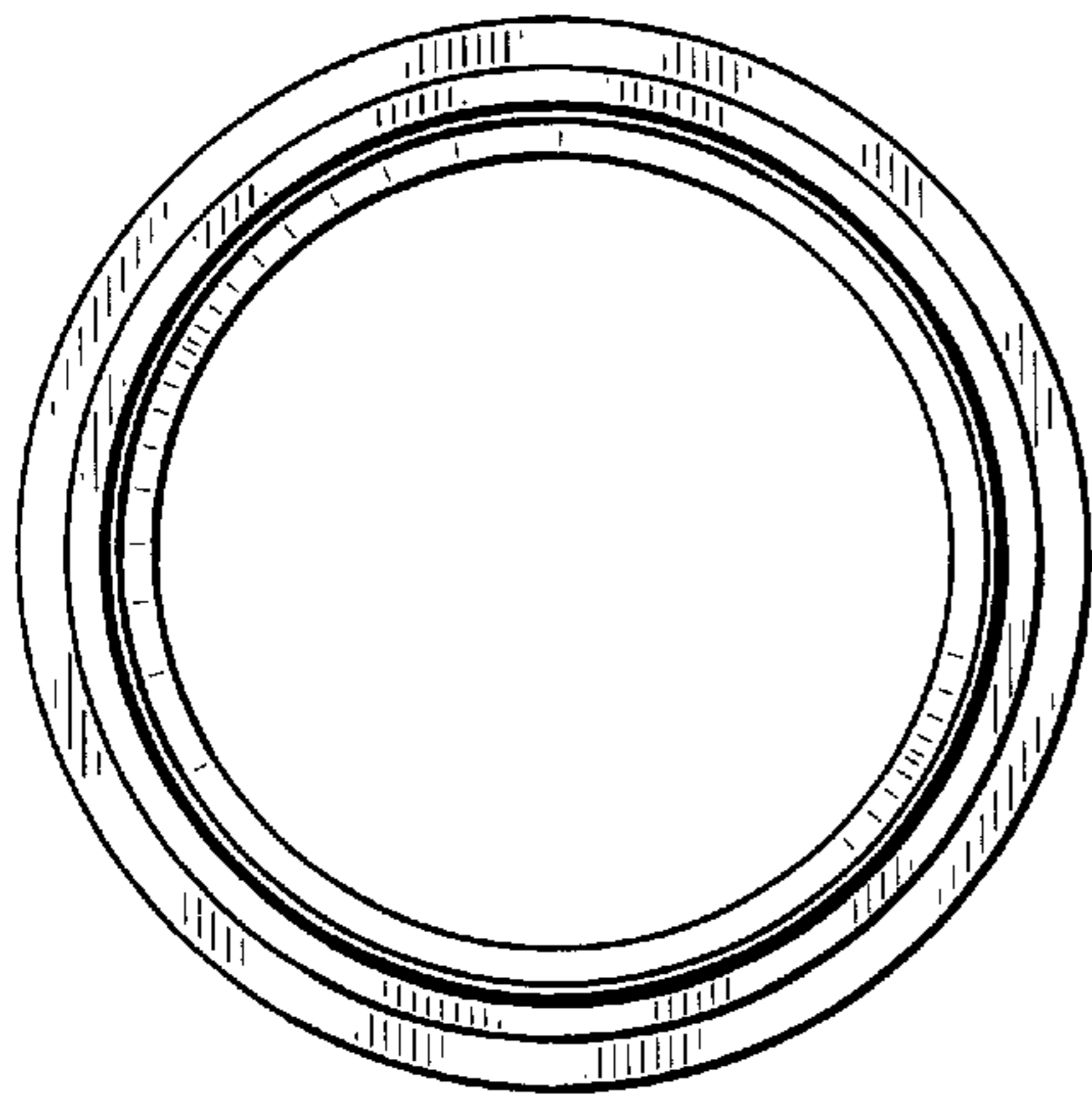

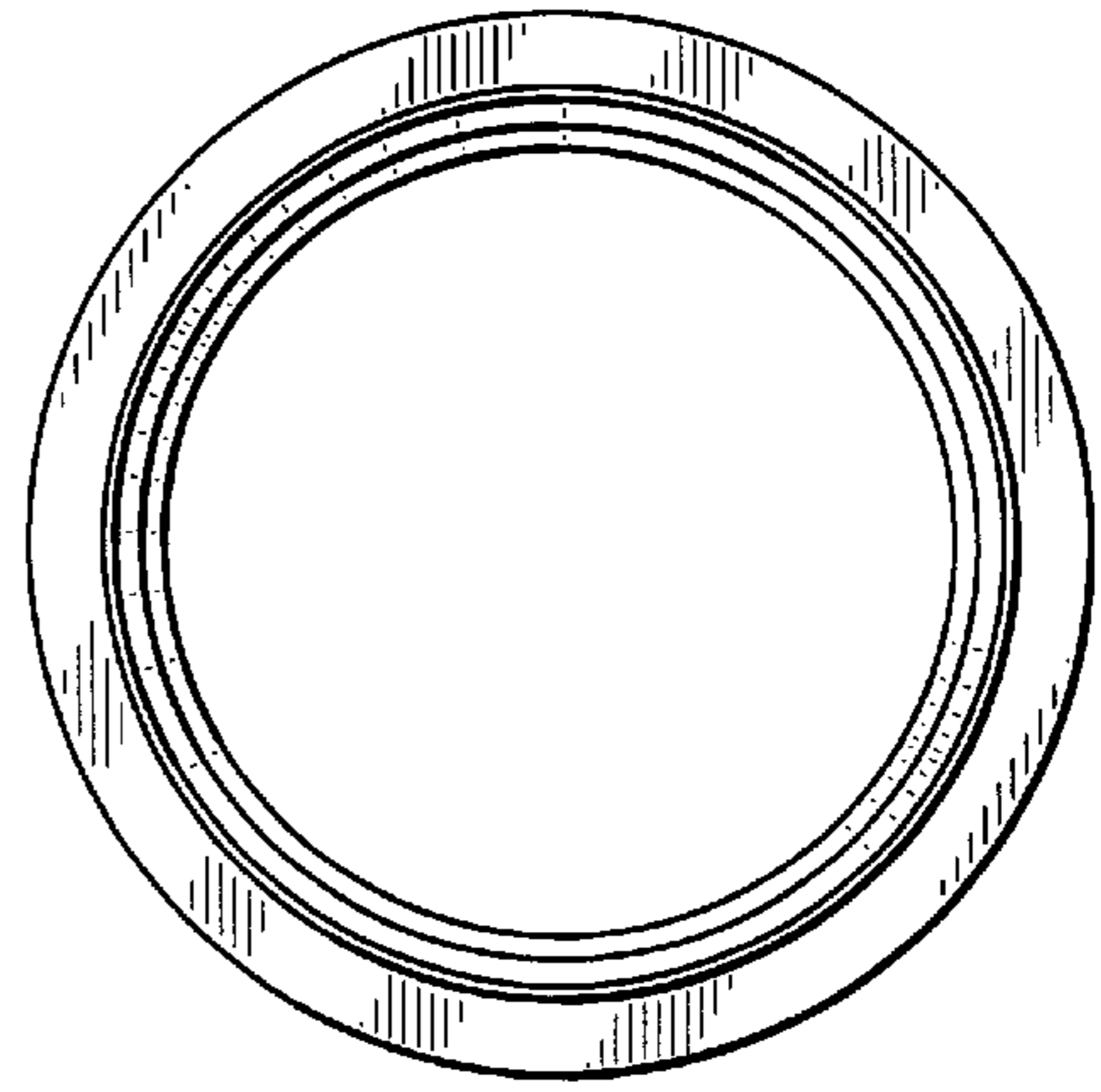

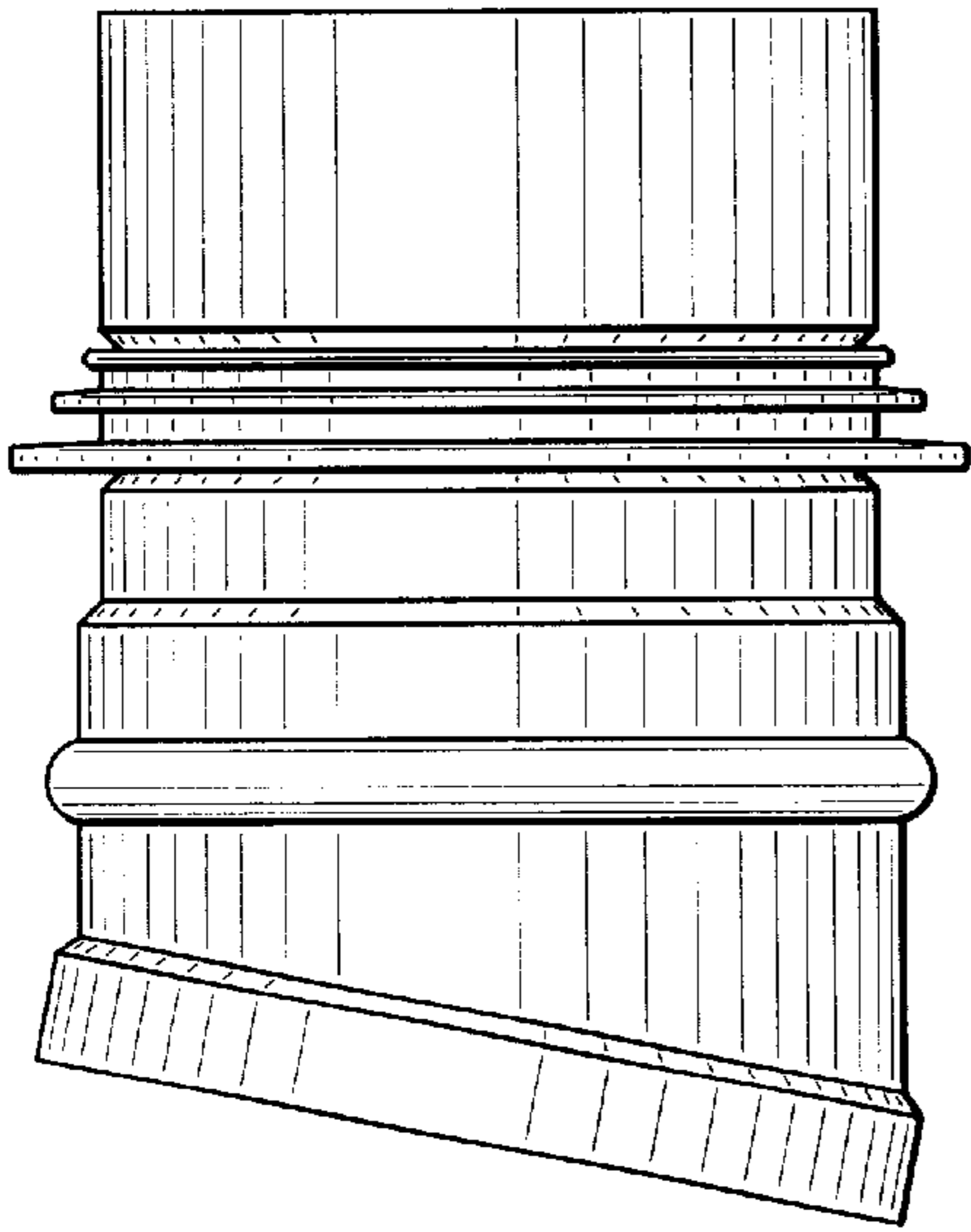

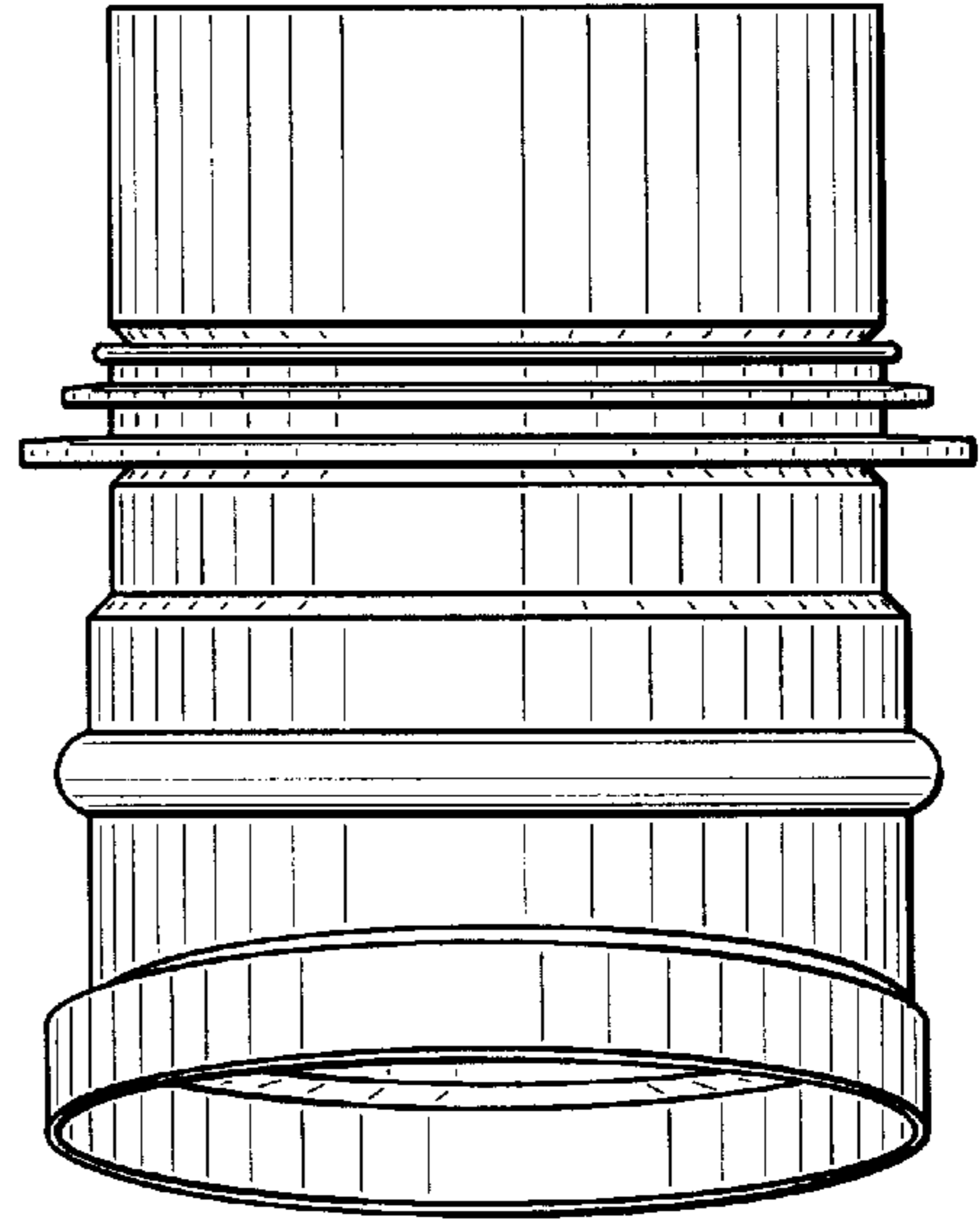

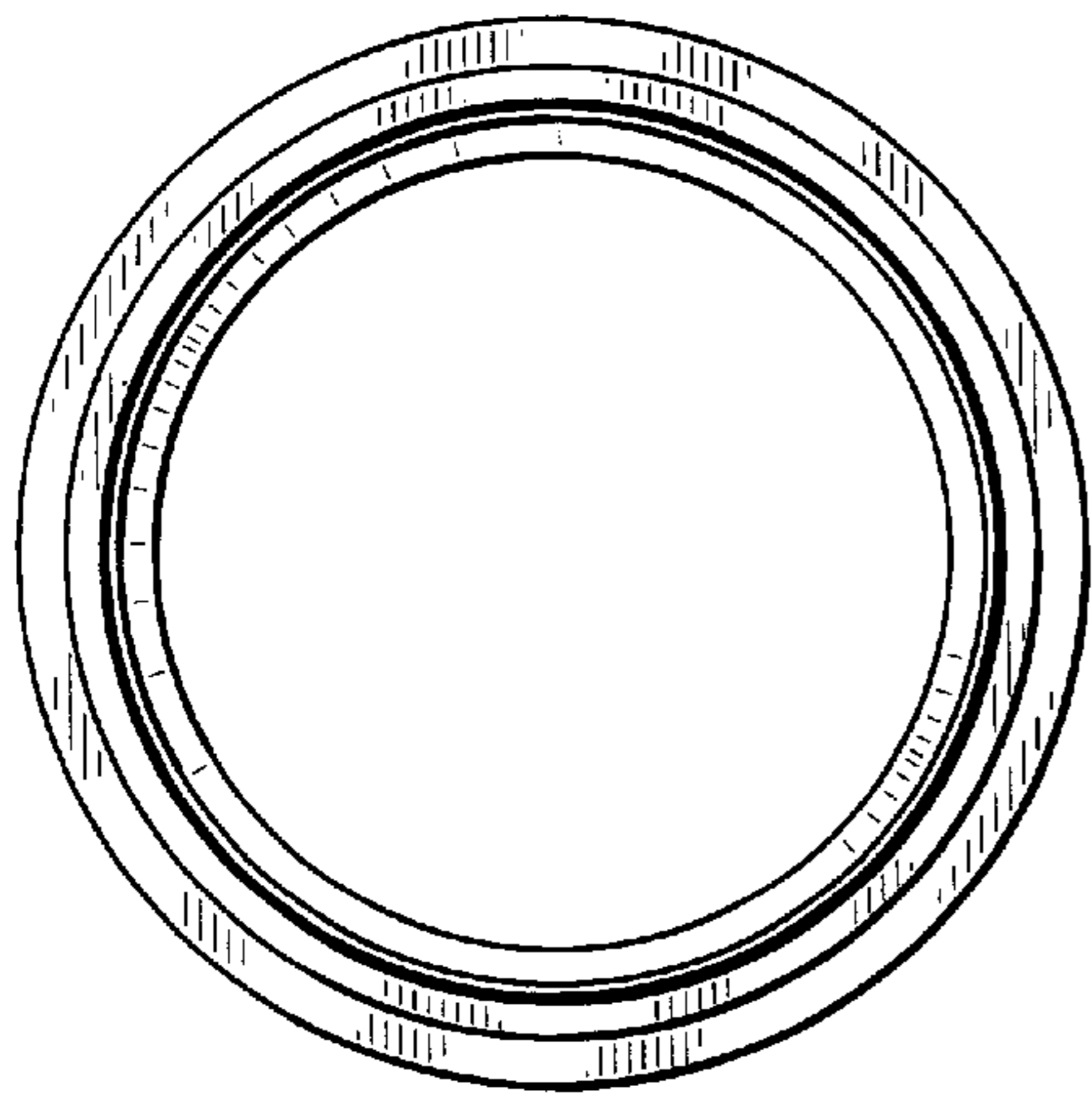

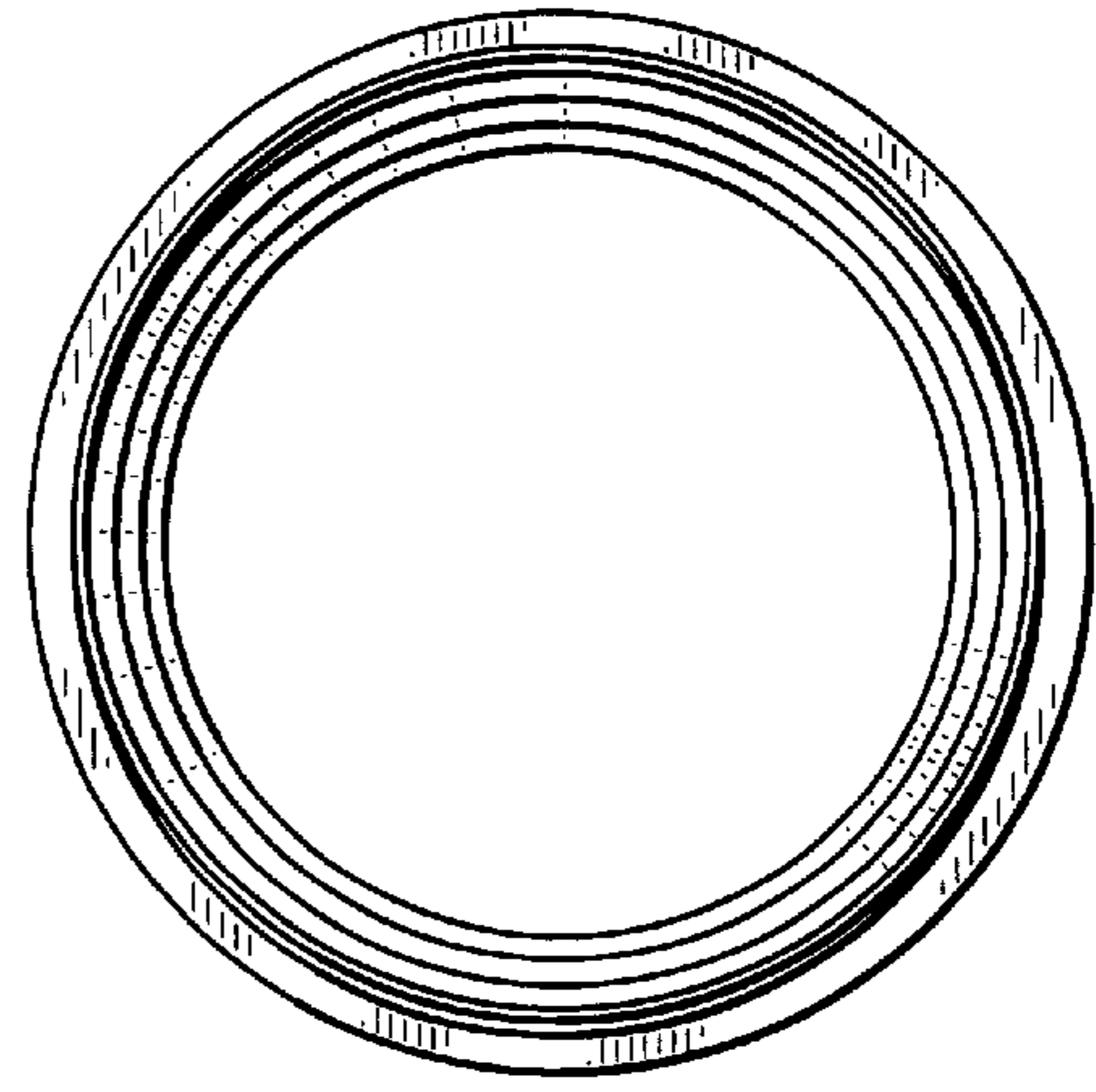

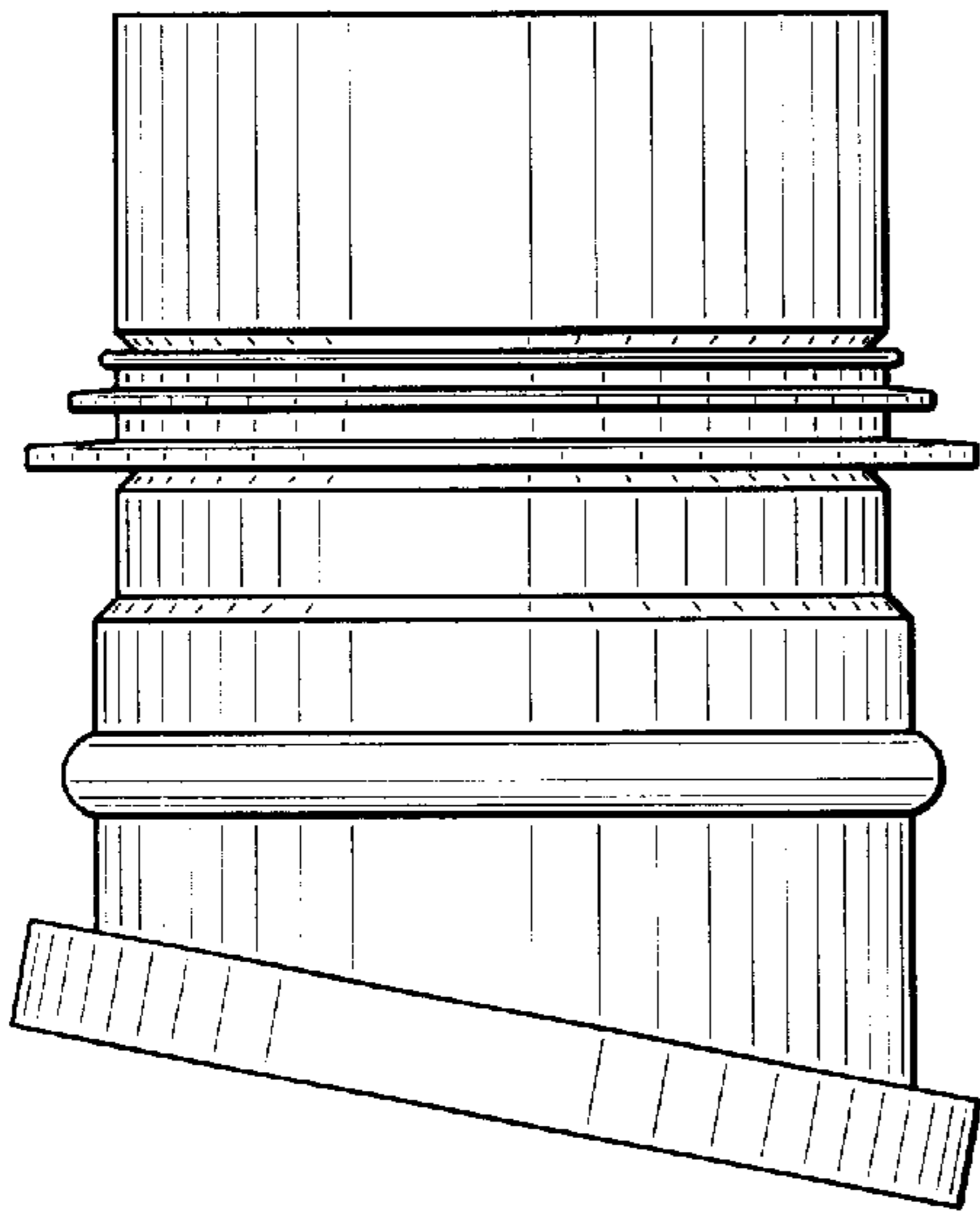

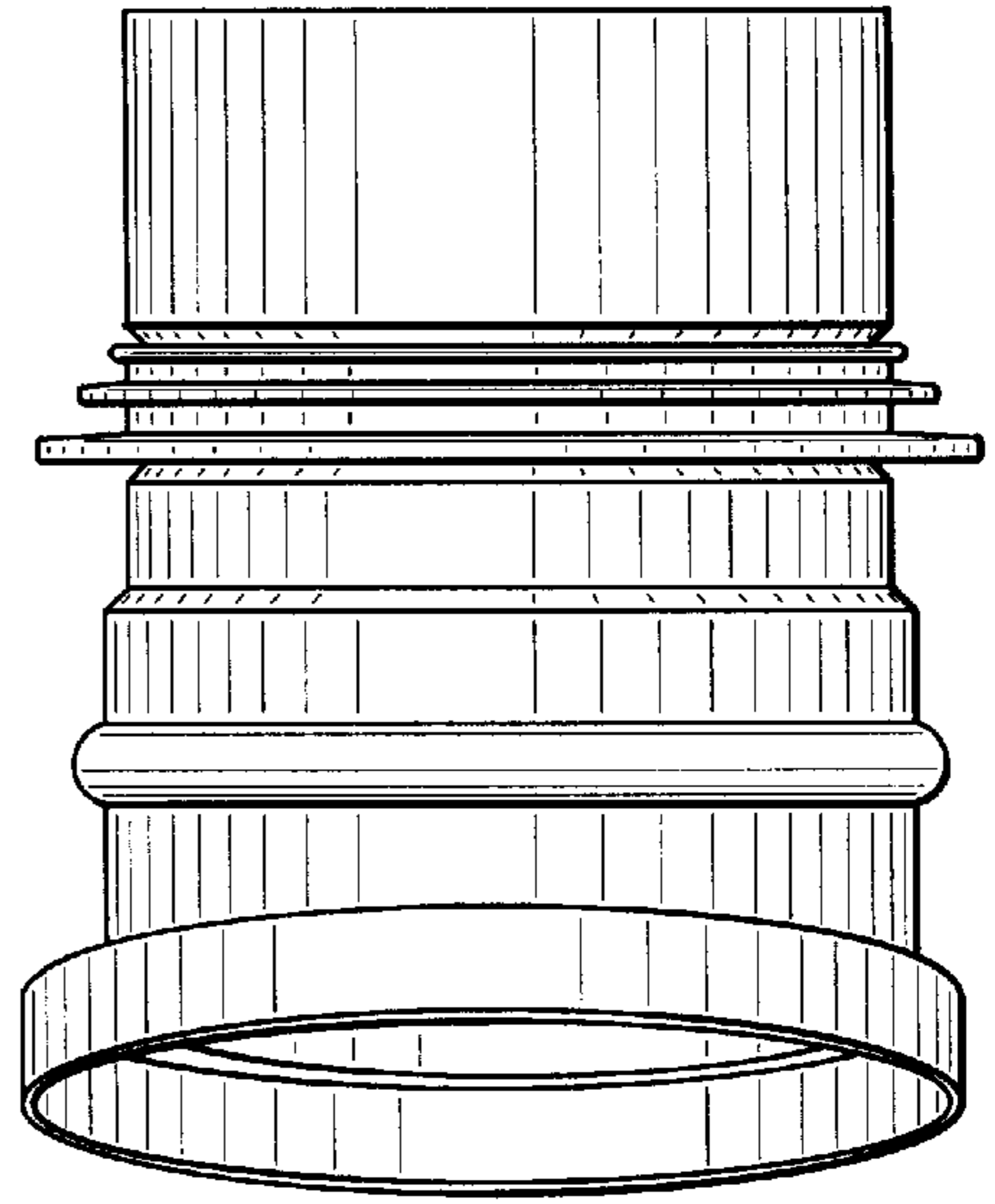

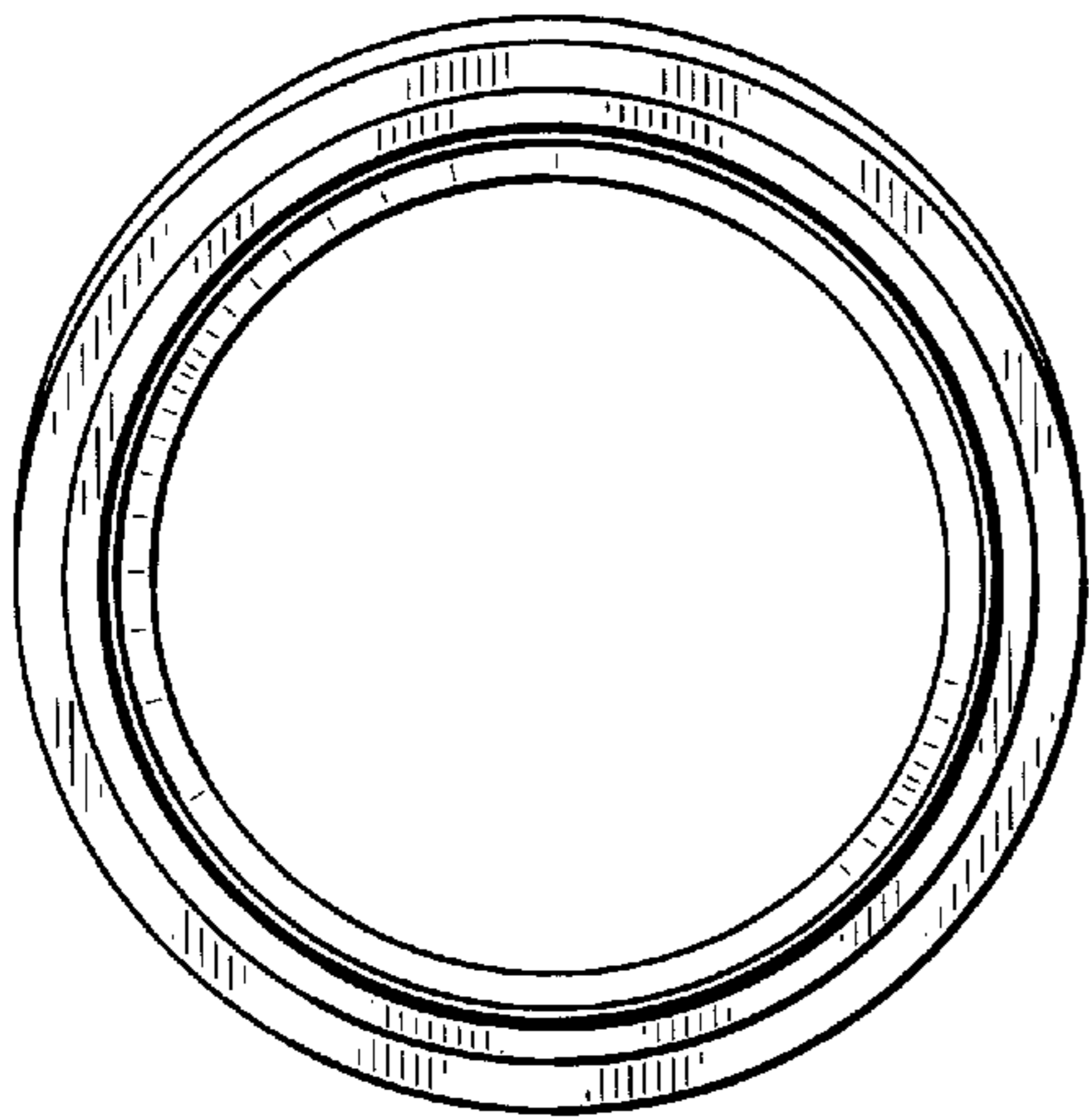

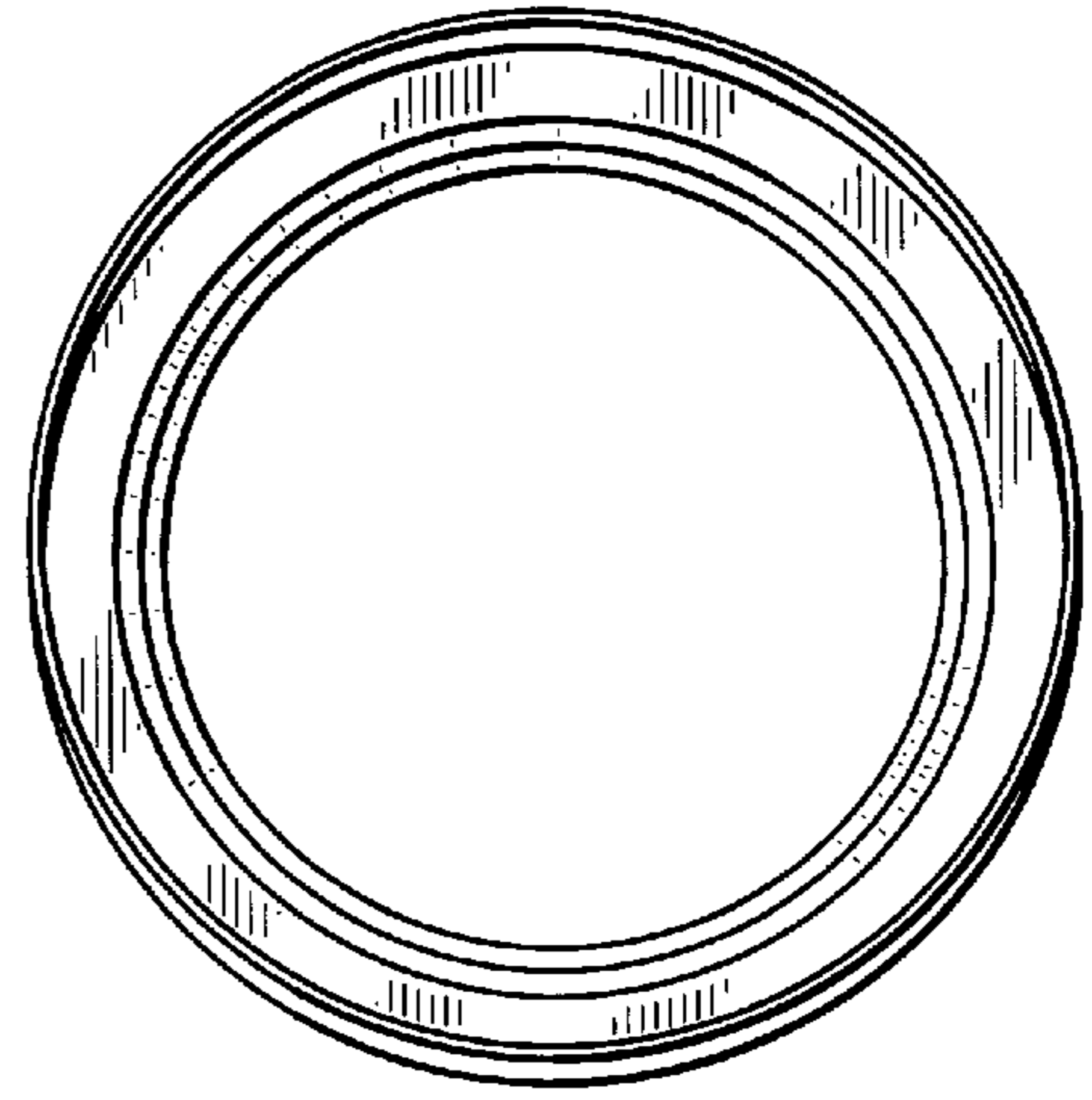
