The ornamental design for a swimming pool frame structure, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view showing my new design for a swimming pool frame structure, the portion shown in dotted lines is included for illustrative purposes only,

FIG. 2 is a bottom view thereof, the portion shown in dotted lines is included for illustrative purposes only, and forms no part of the claimed design

FIG. 3 is a front view thereof, the portion shown in dotted lines is included for illustrative purposes only and forms no part of the claimed design and the rear view is a mirror image thereof,

FIG. 4 is a left side view thereof, the portion shown in dotted lines is included for illustrative purposes only and form no part of the claimed design and the right side view is a mirror image thereof,

FIG. 5 is a top view of an alternative embodiment of a swimming pool frame structure showing my new design, the portion shown in dotted lines is included for illustrative purposes only,

FIG. 6 is a bottom view thereof, the portion shown in dotted lines is included for illustrative purposes only, and forms no part of the claimed design

FIG. 7 is a front view thereof, the portion shown in dotted lines is included for illustrative purposes only and forms no part of the claimed design and the rear view is a mirror image thereof,

FIG. 8 is a left side view thereof, the portion shown in dotted lines is included for illustrative purposes only and forms no part of the claimed design and the right side view is a mirror image thereof,

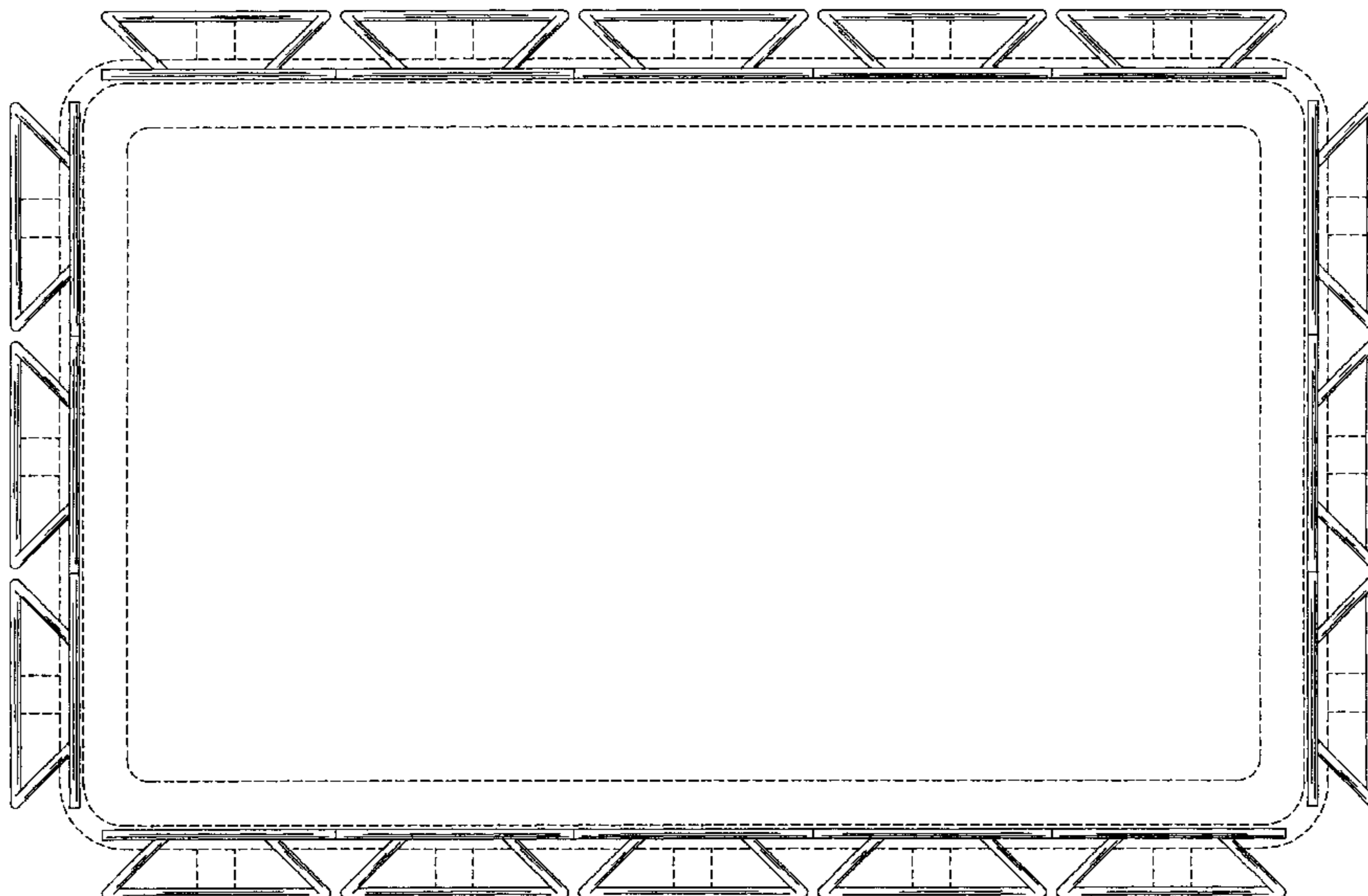

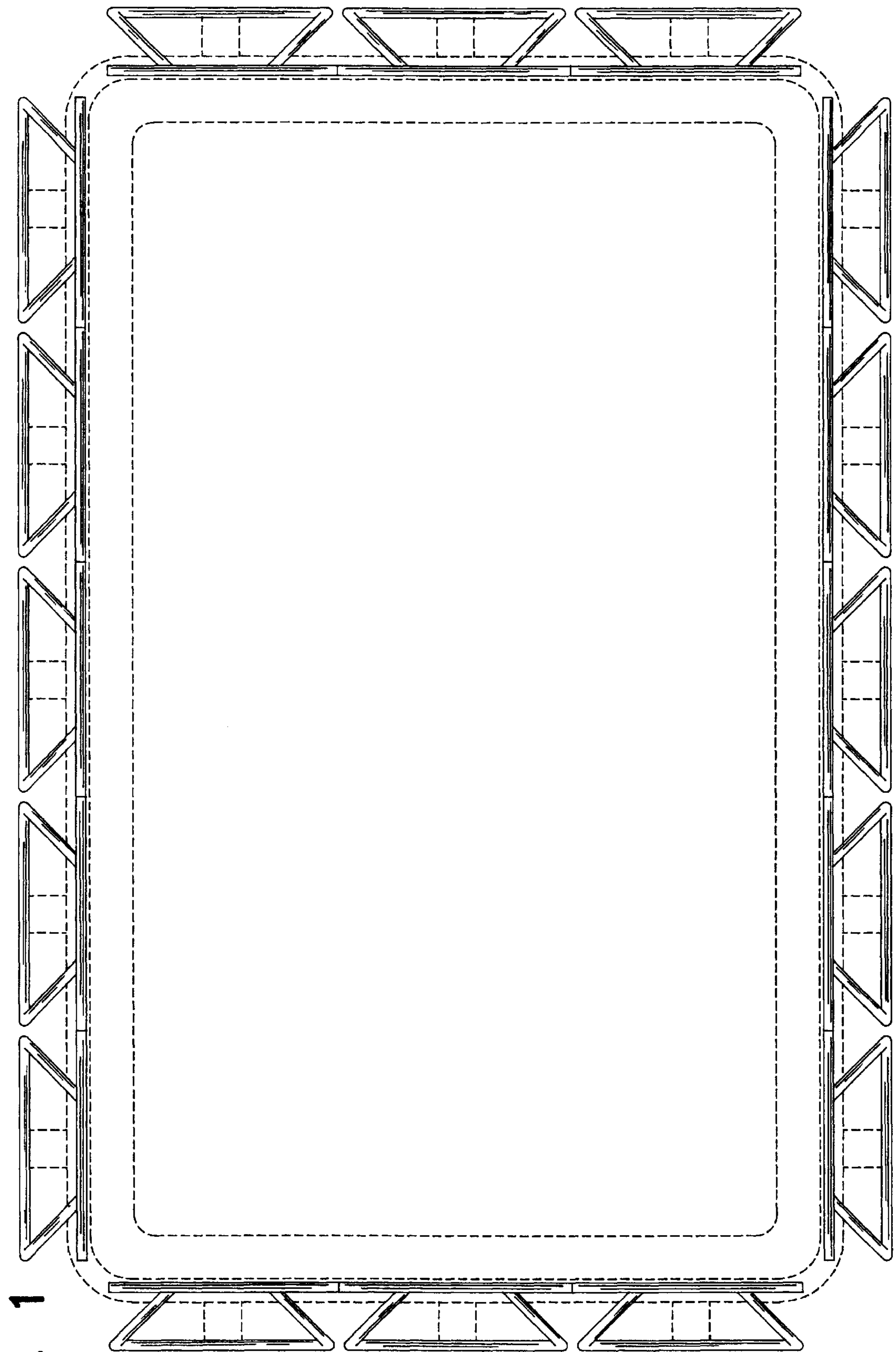

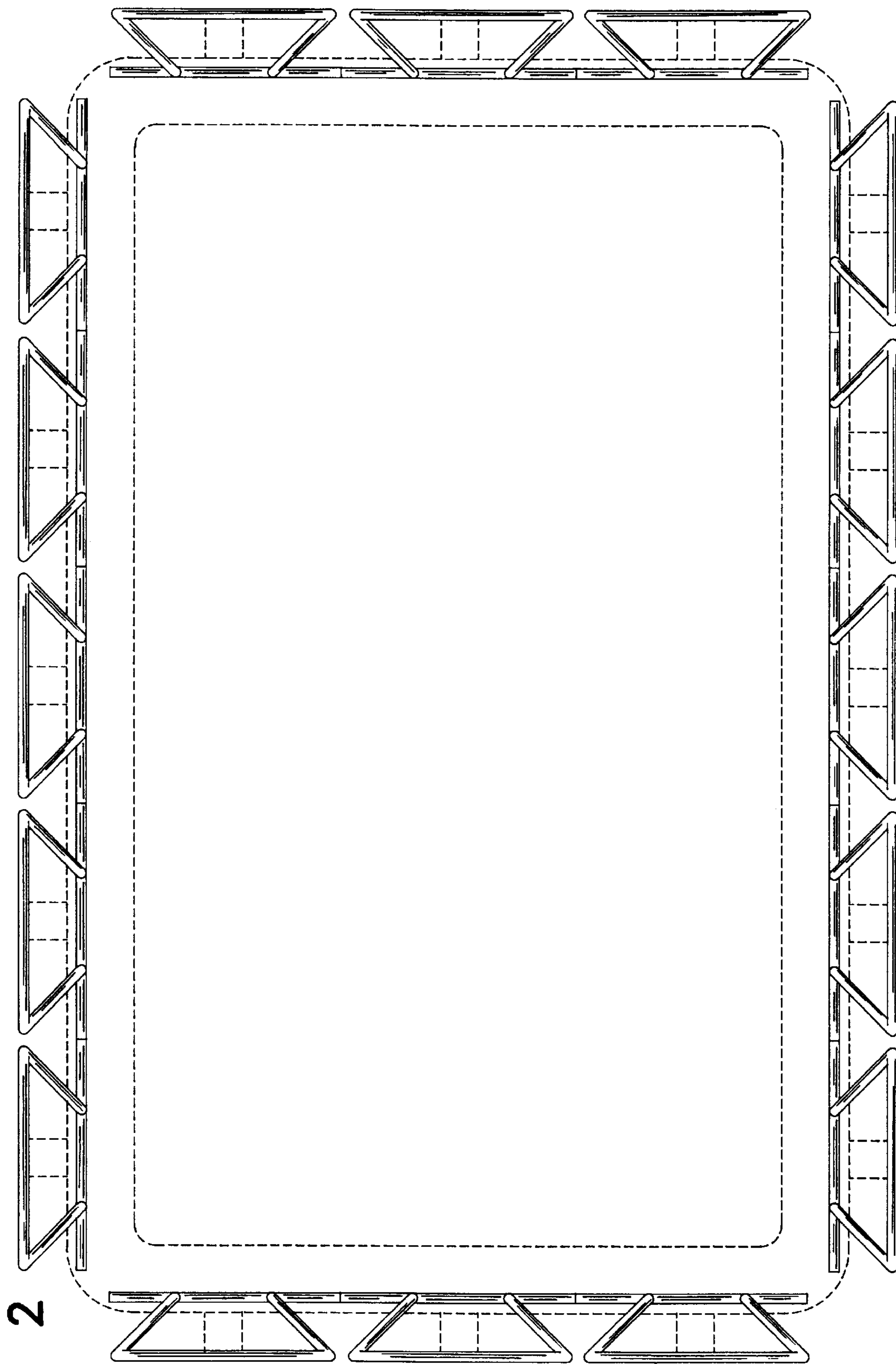

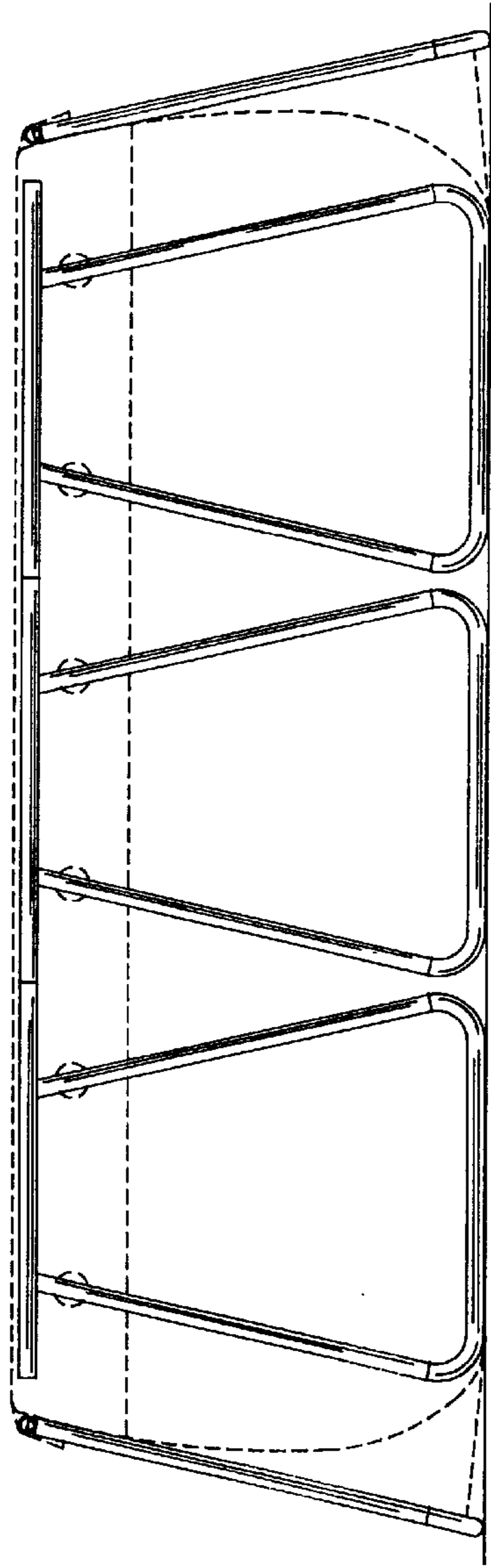
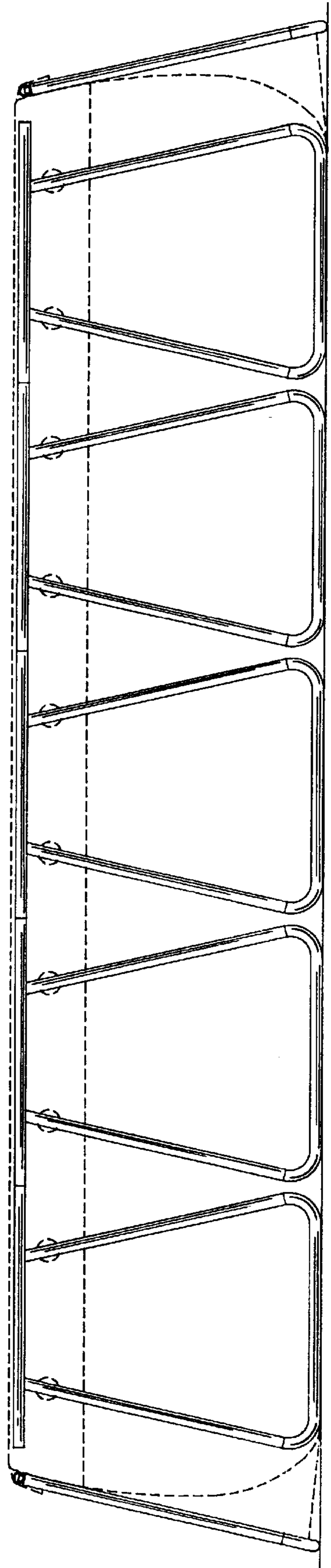

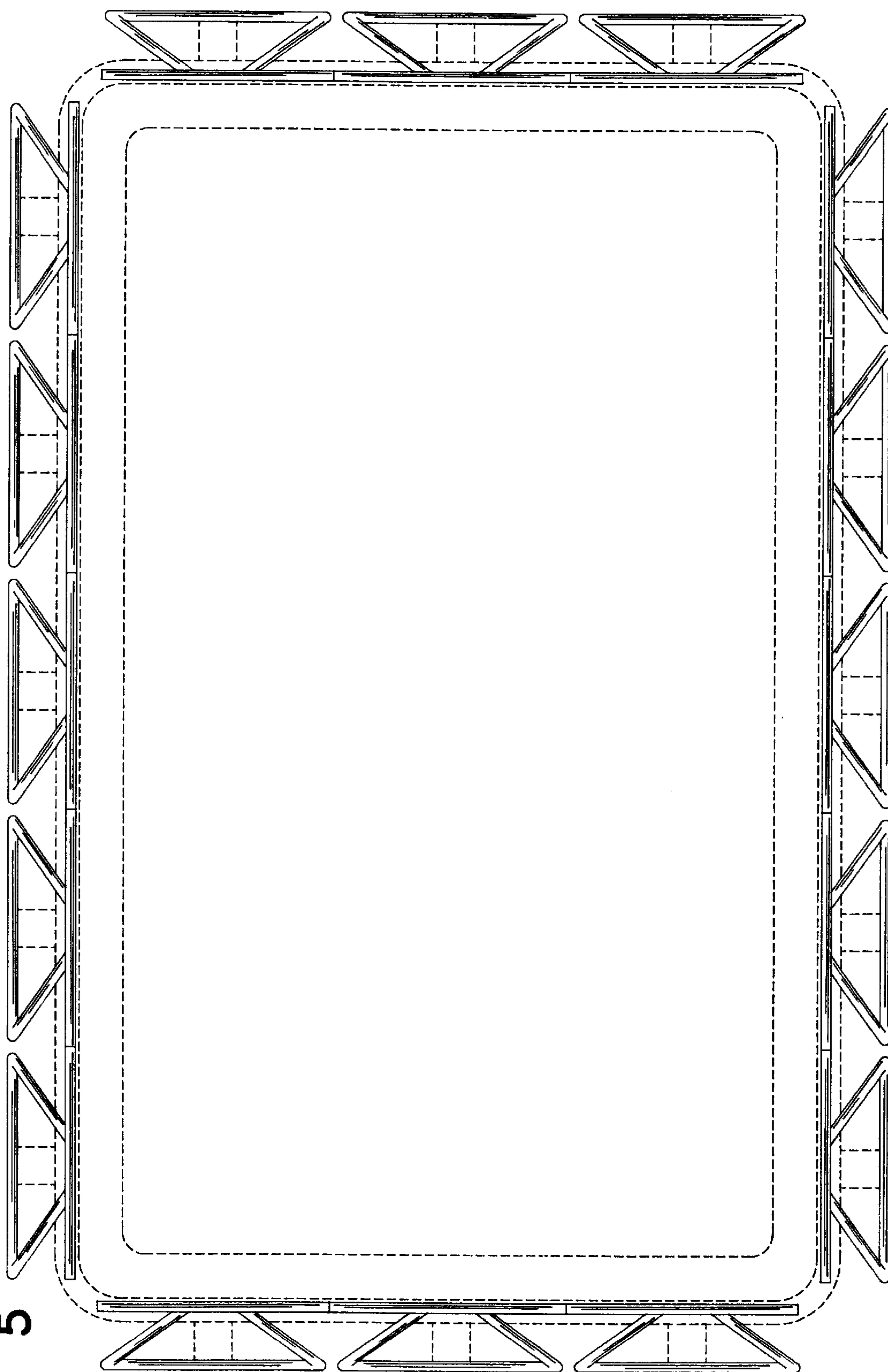

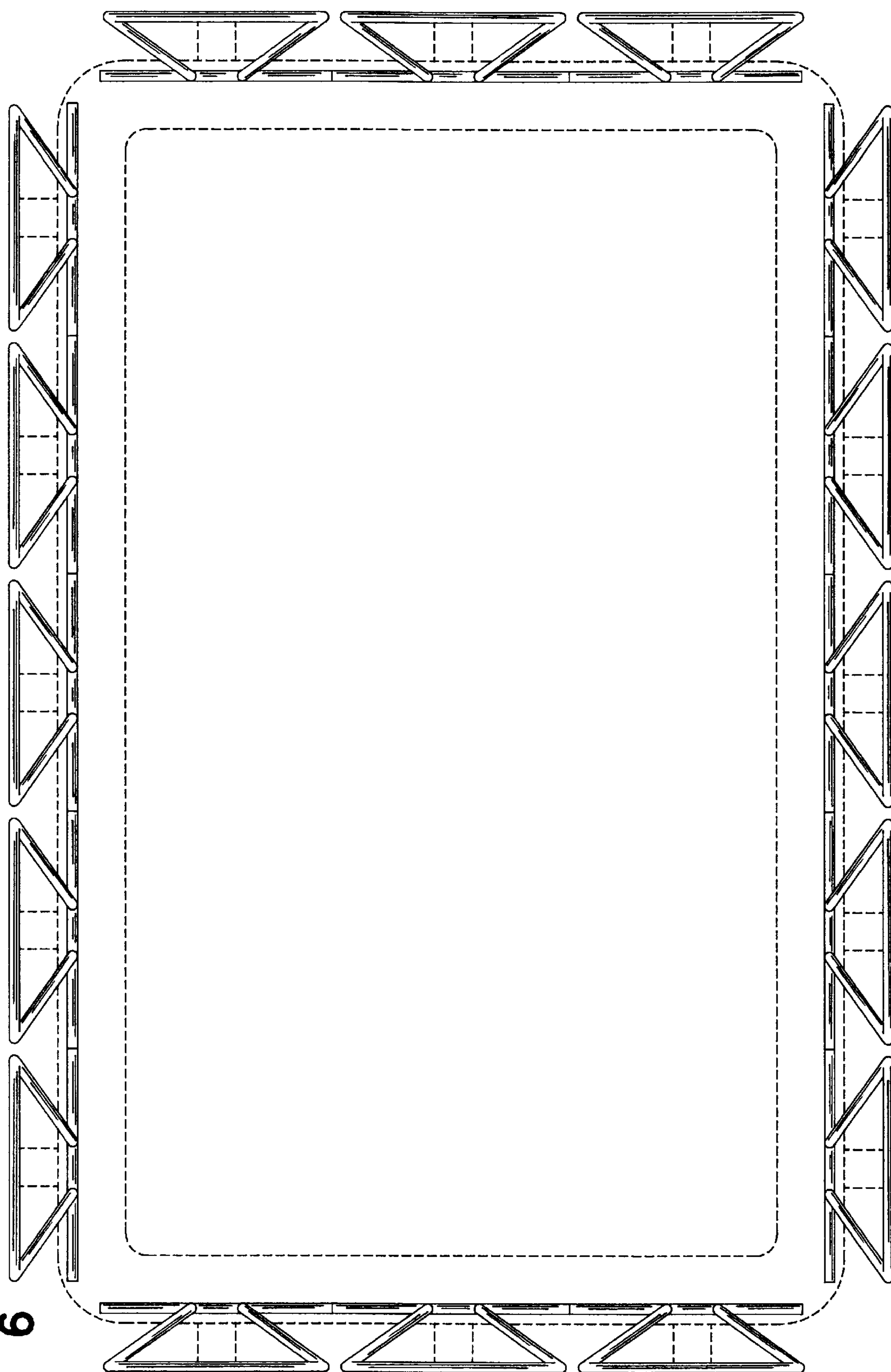

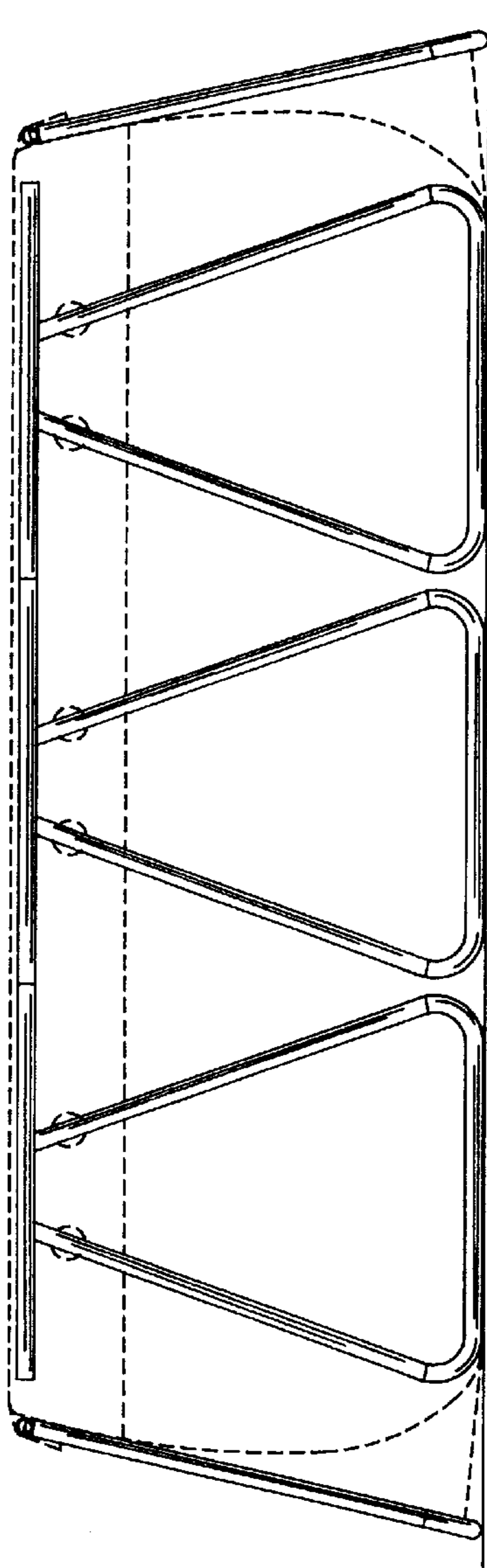
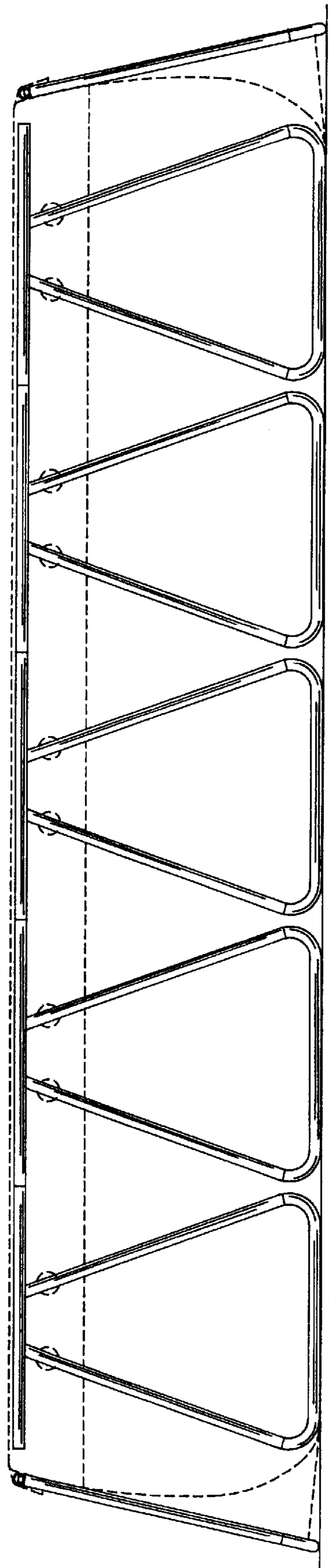

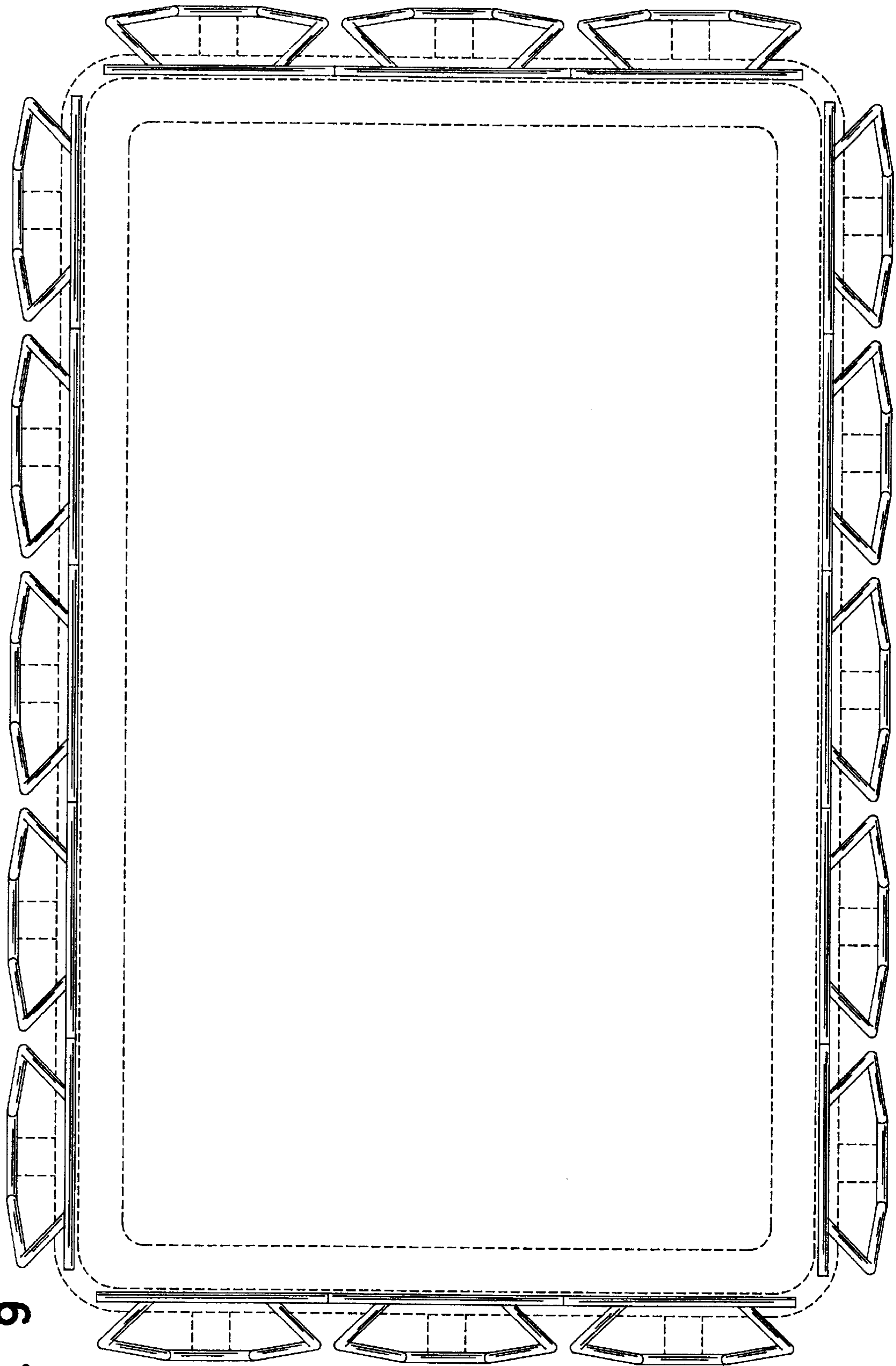

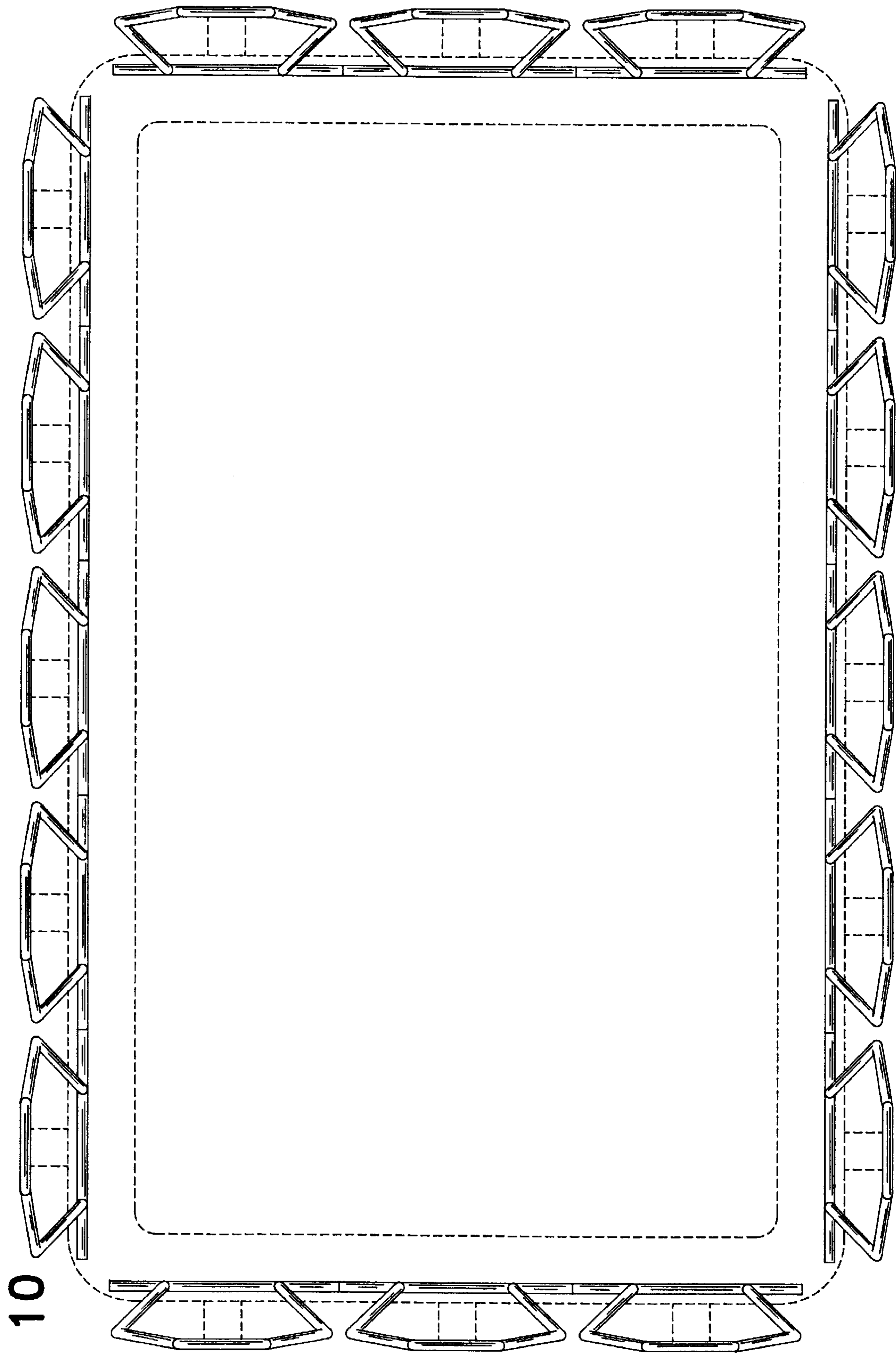

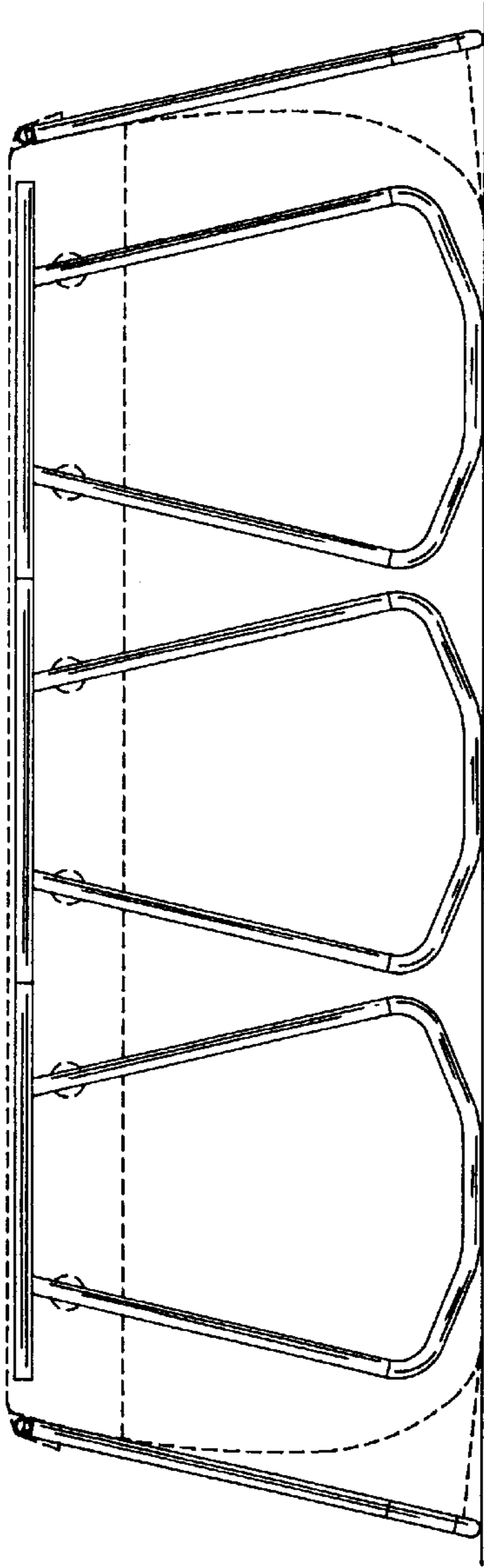
