FIG. 1 is a perspective view of a cosmetic product according to the present invention;

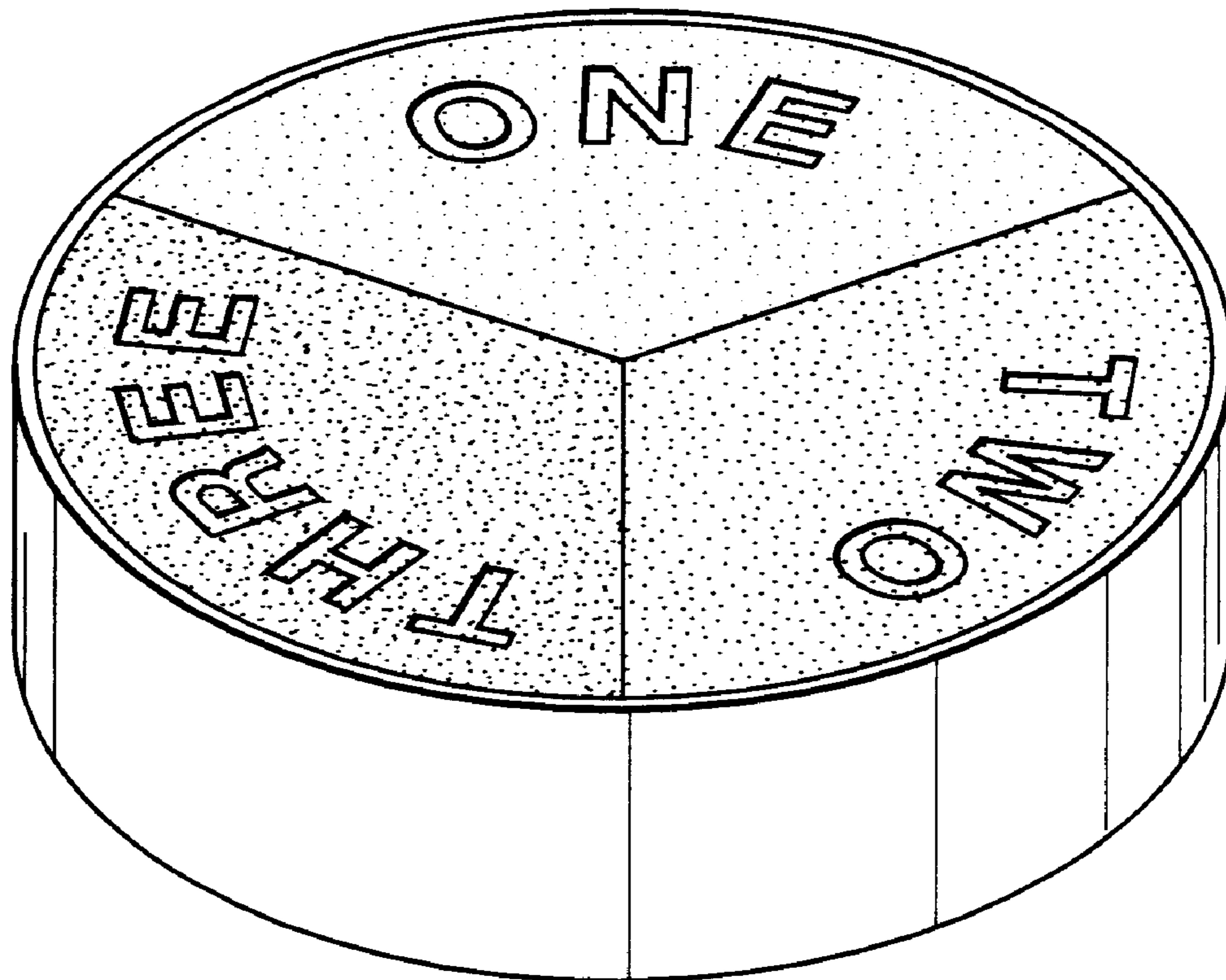
FIG. 2 is a bottom view thereof; and

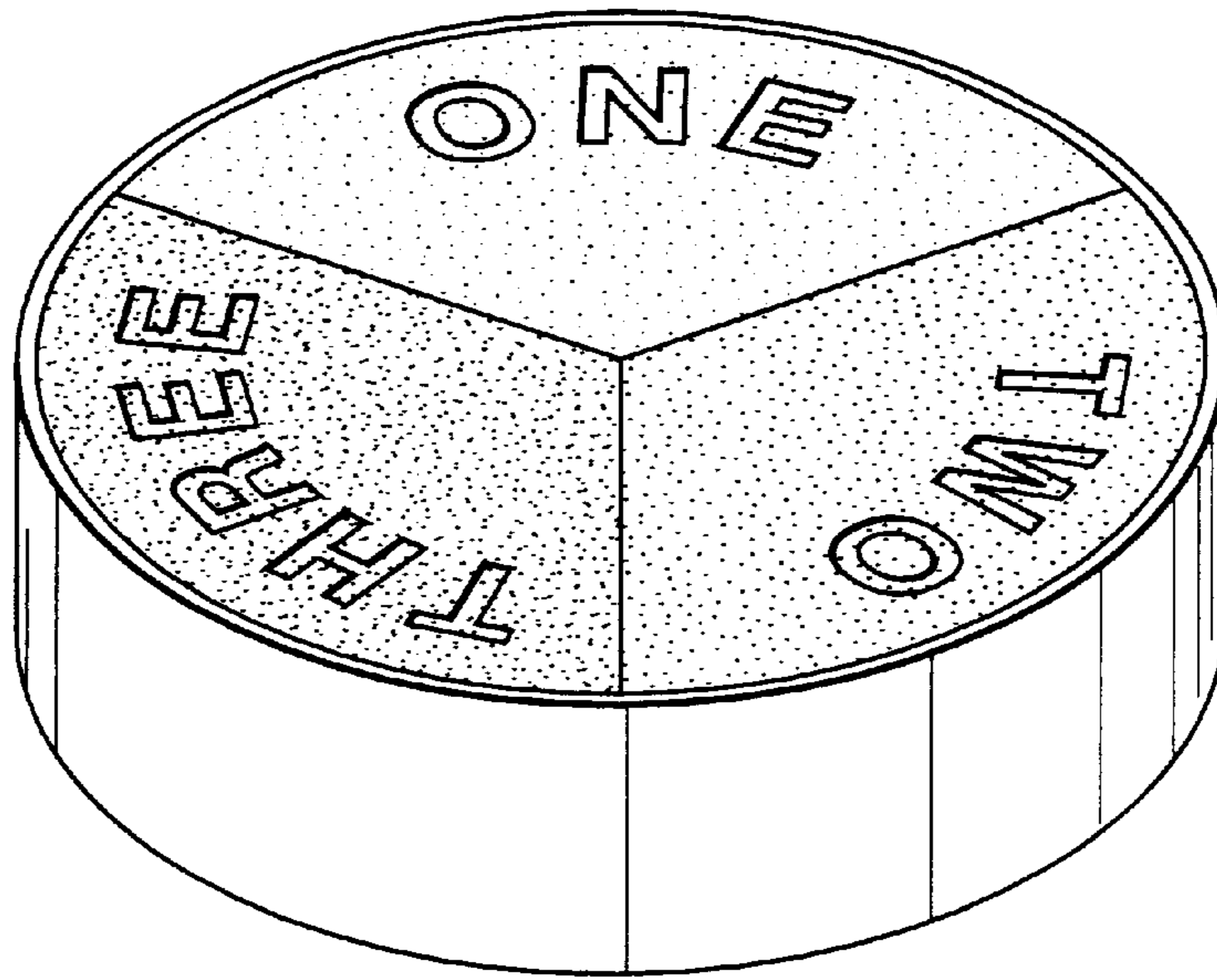

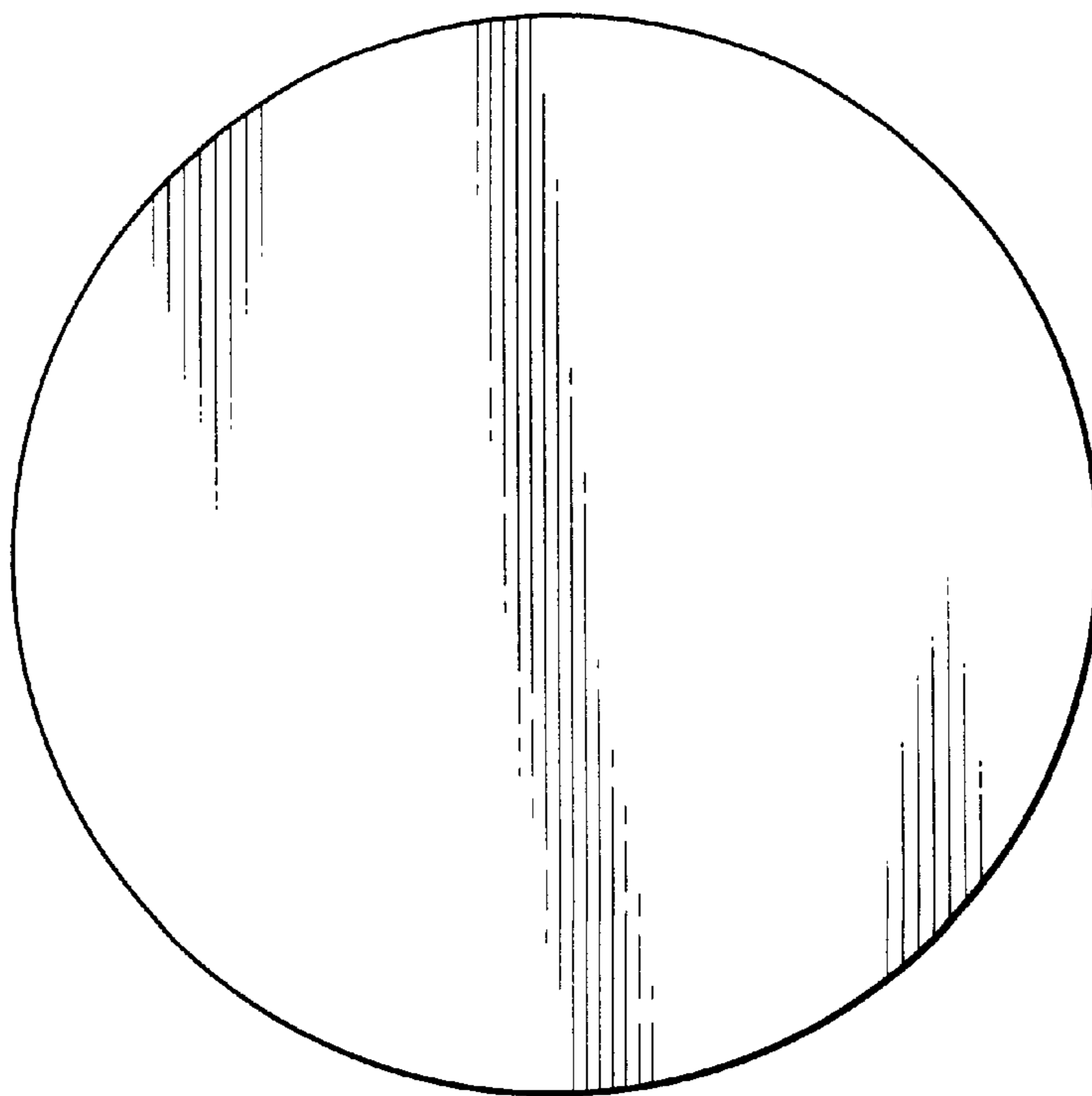

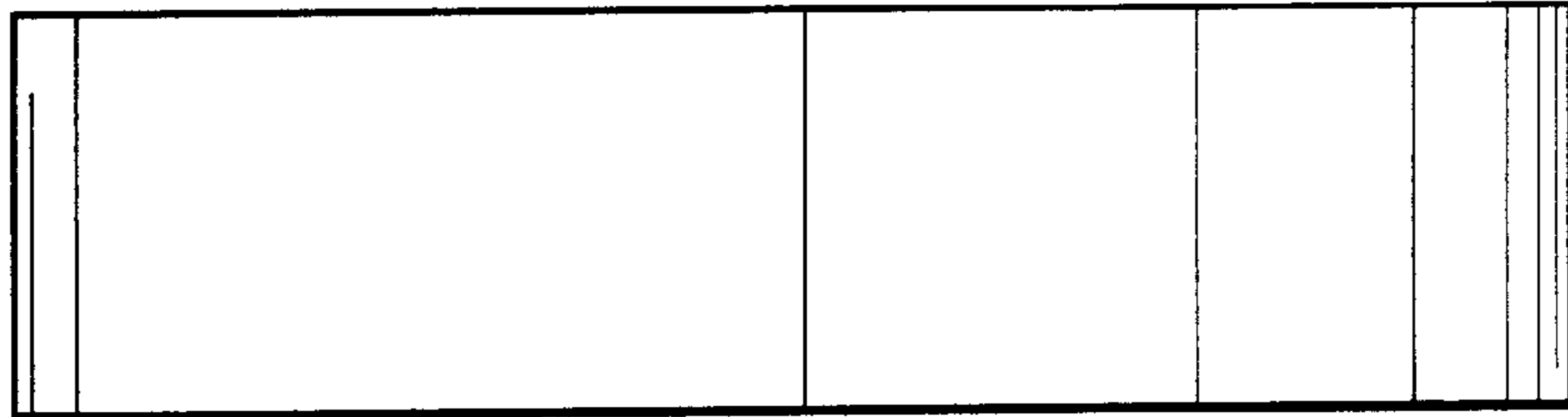

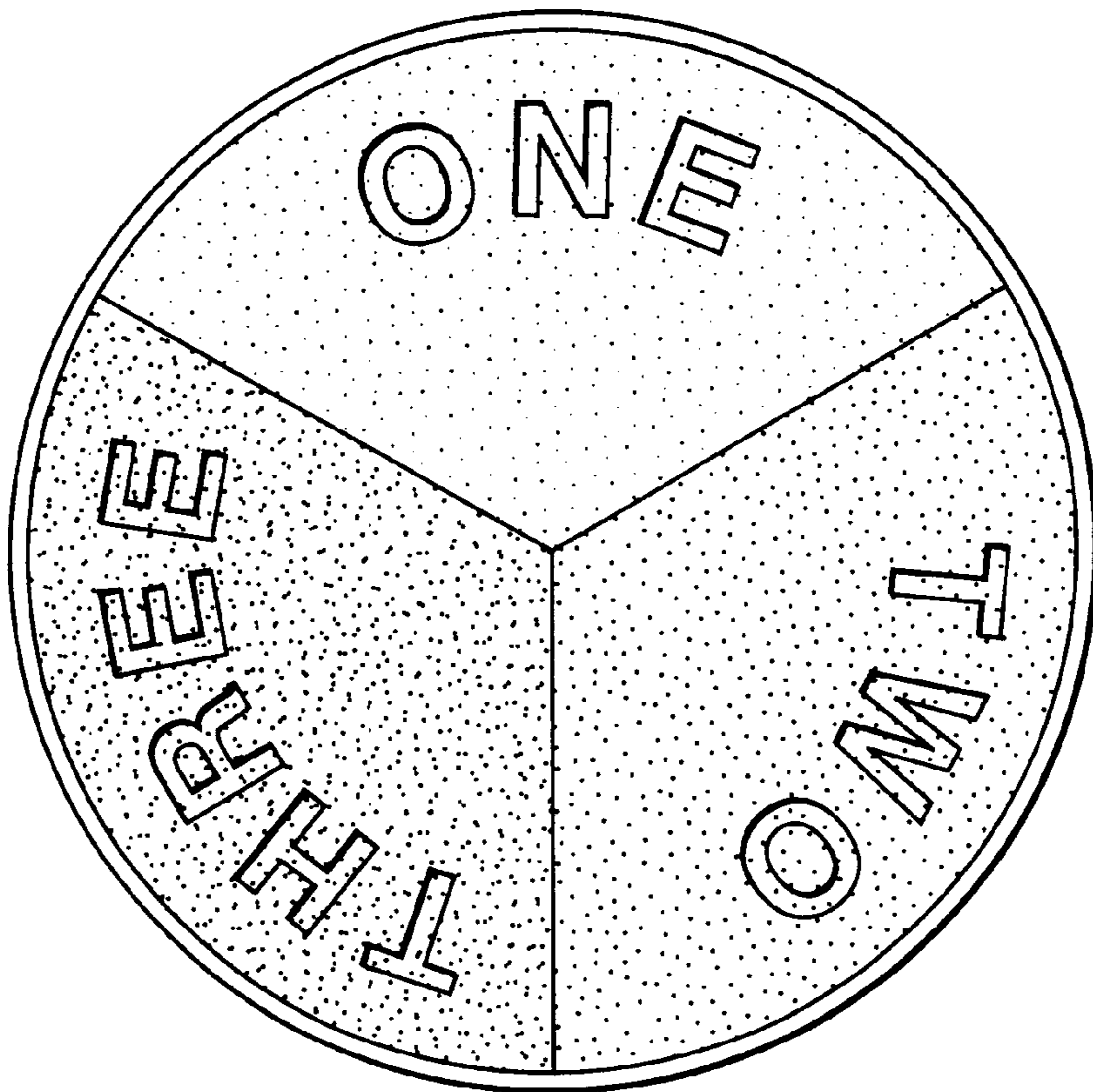
