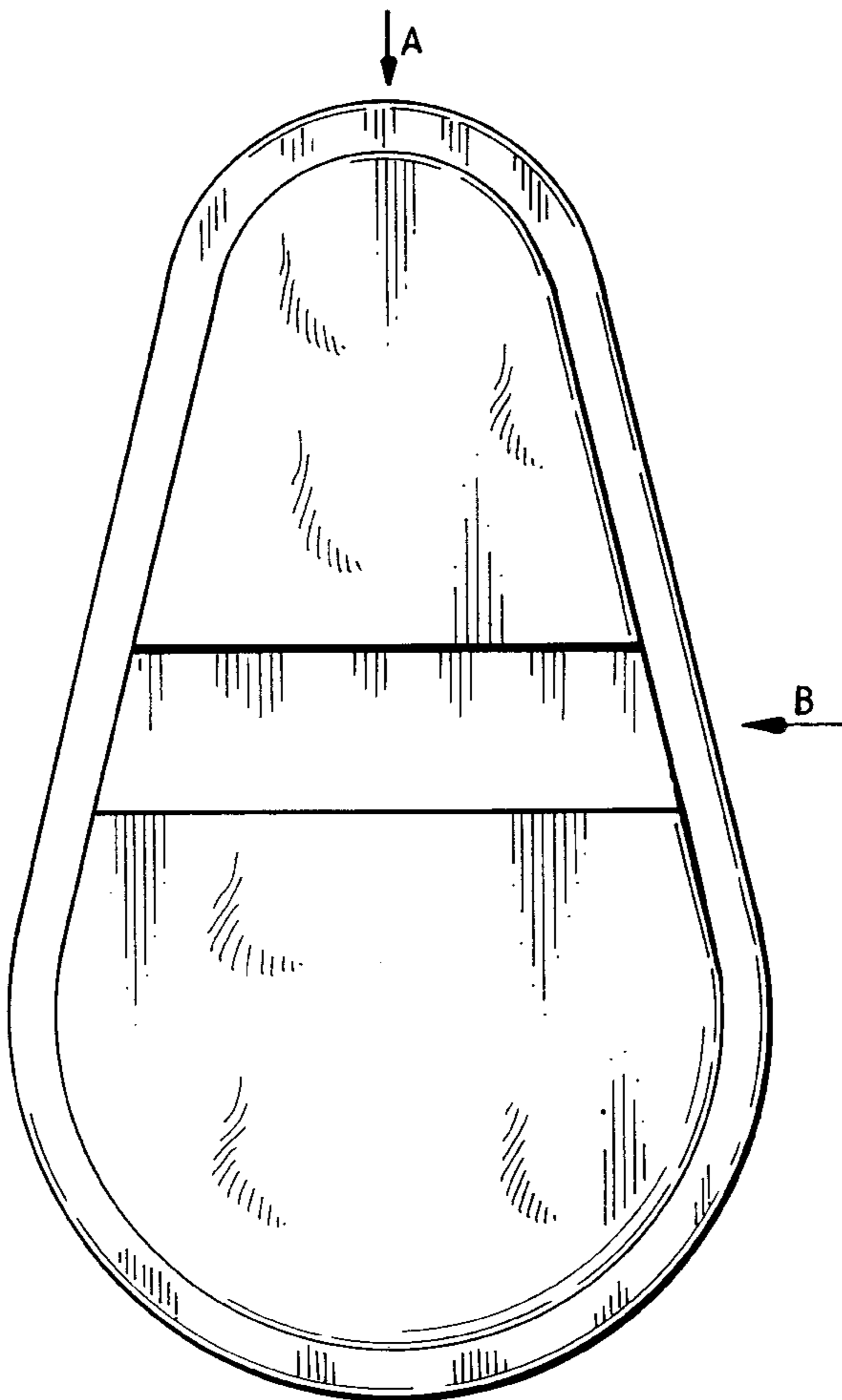

DESCRIPTION

FIG. 1 is a plan view of the mit according to the present design;
FIG. 2 is an end view looking in the direction of arrow A in FIG. 1;
FIG. 3 is a side view looking in the direction of arrow B in FIG. 1 (the other side view corresponds);
FIG. 4 is an inverted plan view of the mit of FIG. 1; and,
FIG. 5 is an end view of the mit looking in the direction of arrow C in FIG. 4.

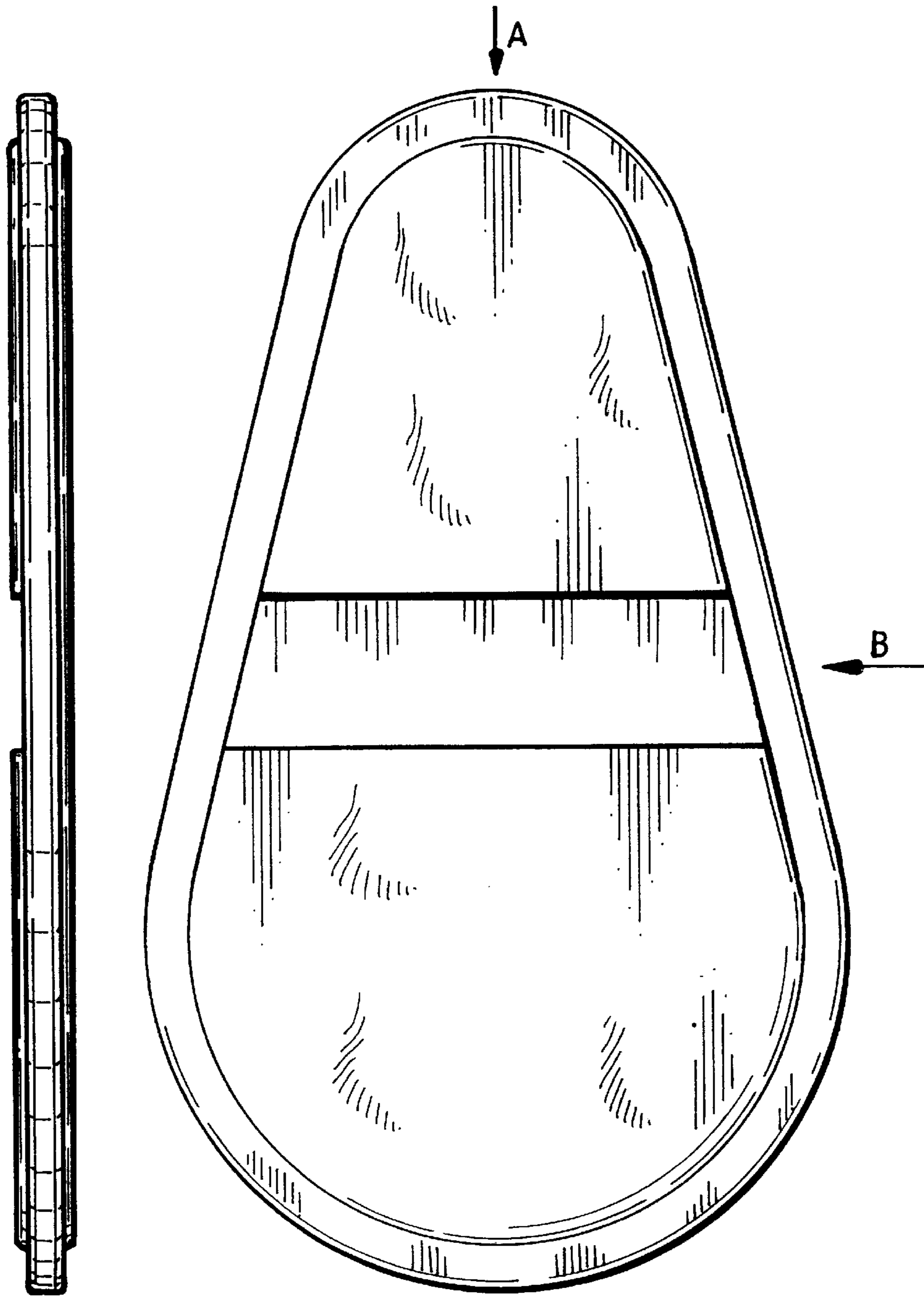

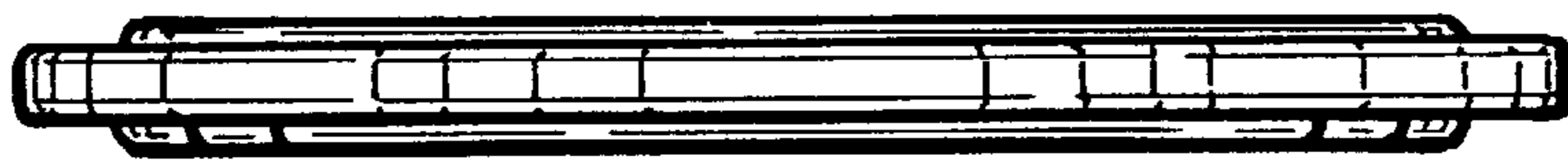
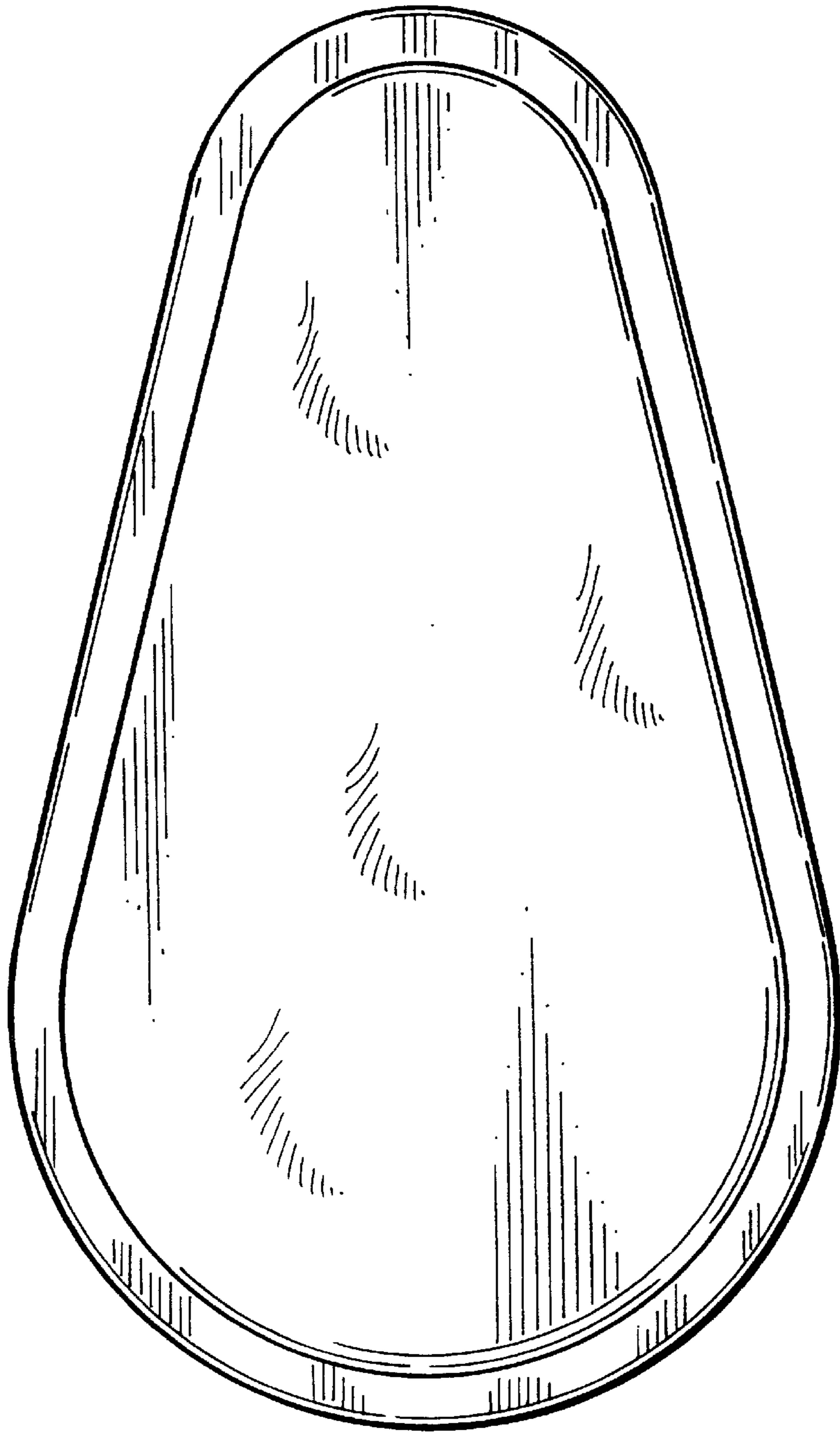

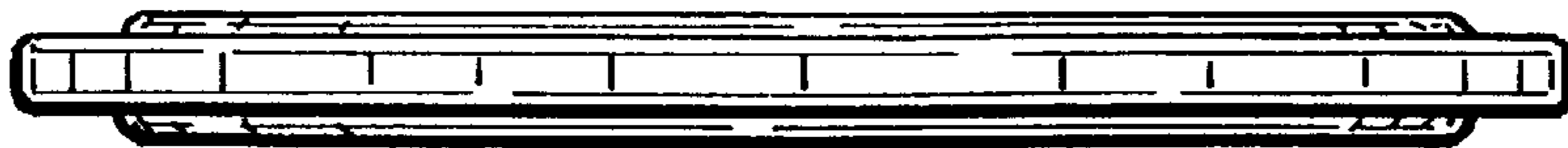
