The ornamental design for a glove attachment strap, as shown and described.

## DESCRIPTION

FIG. 1 is a perspective view of a glove attachment strap shown in condition of use on a human wrist, it being understood that the broken line showing of a human wrist is for illustrative purposes only and form no part of the claimed design;

FIG. 2 is a front elevation view thereof shown in an unwrapped position;

FIG. 3 is a top plan view thereof;



FIG. 4 is a rear view thereof;


FIG. 5 is a bottom plan view thereof;

FIG. 6 is a left side view thereof; and,


FIG. 7 is a right side view thereof.









