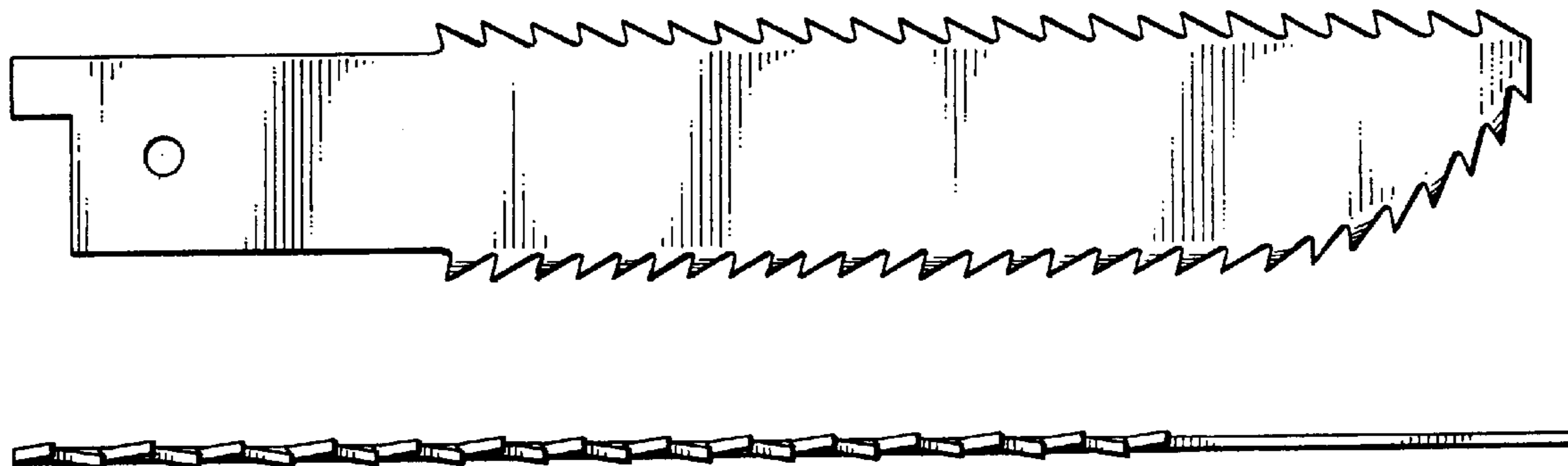
### [57] **CLAIM**

### DESCRIPTION

FIG. 1 is a perspective view of a reciprocating saw blade showing my new design;

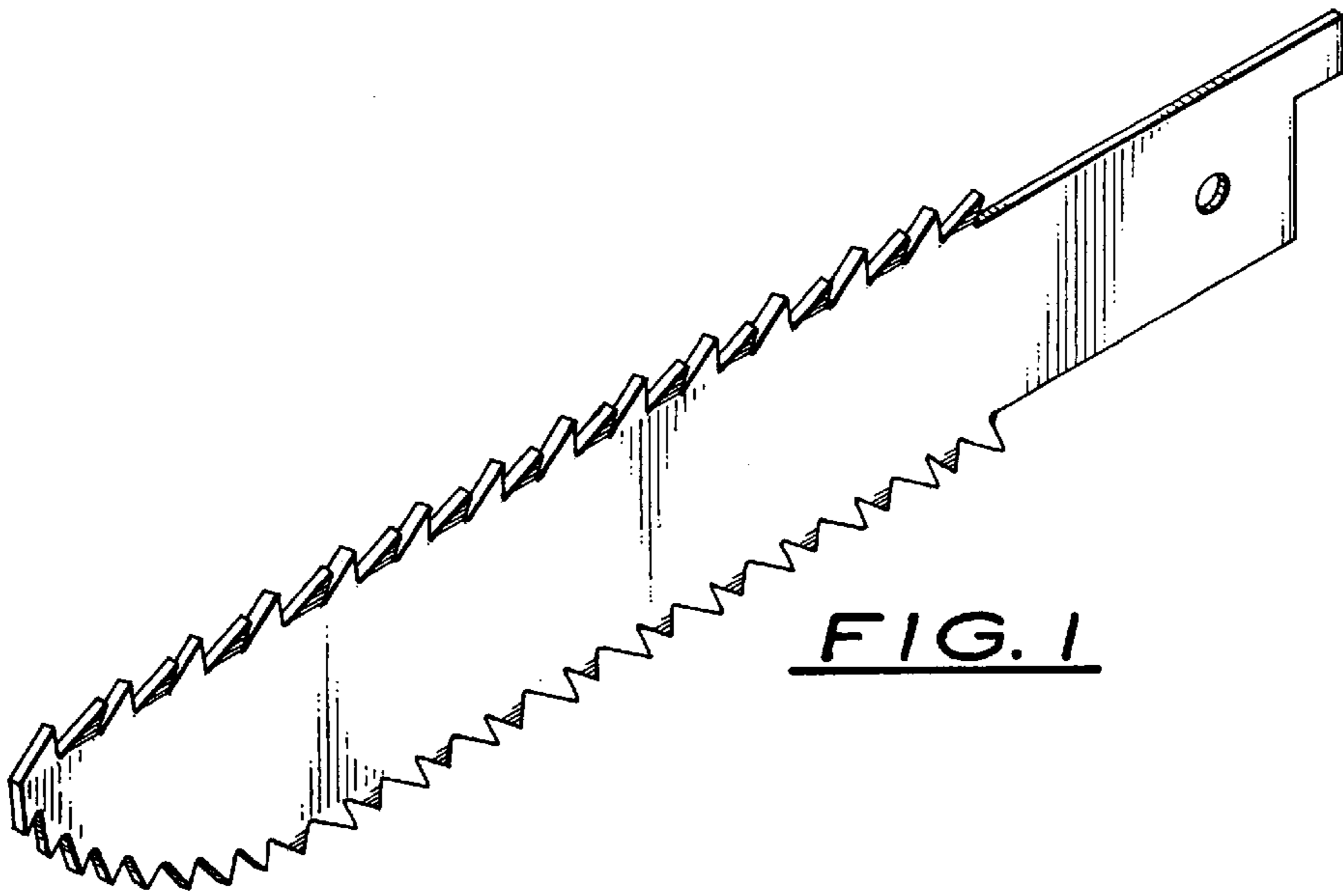

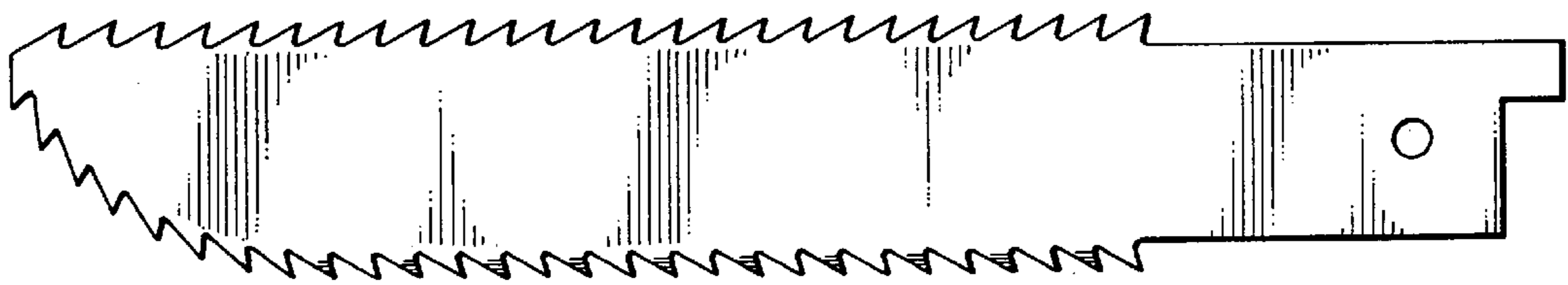

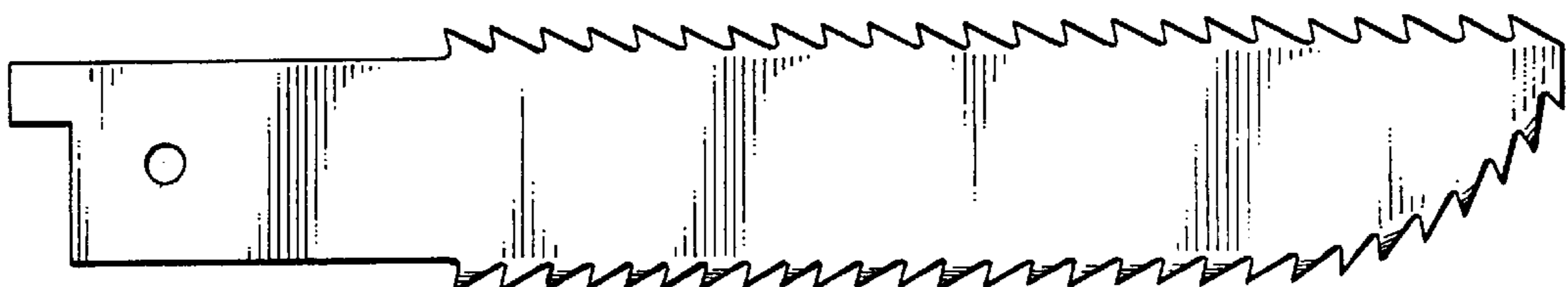

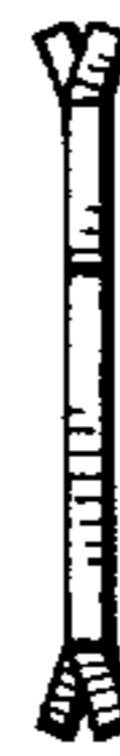
