The ornamental design for a food container, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a food container showing our new design;
FIG. 2 is a top view;
FIG. 3 is a front view;
FIG. 4 is a left side view; the right side view being a mirror image thereof; and,
FIG. 5 is a rear view.

The bottom of the food container forms no part of the claimed design.

Portions of the article depicted in broken lines form no part of the claimed design.

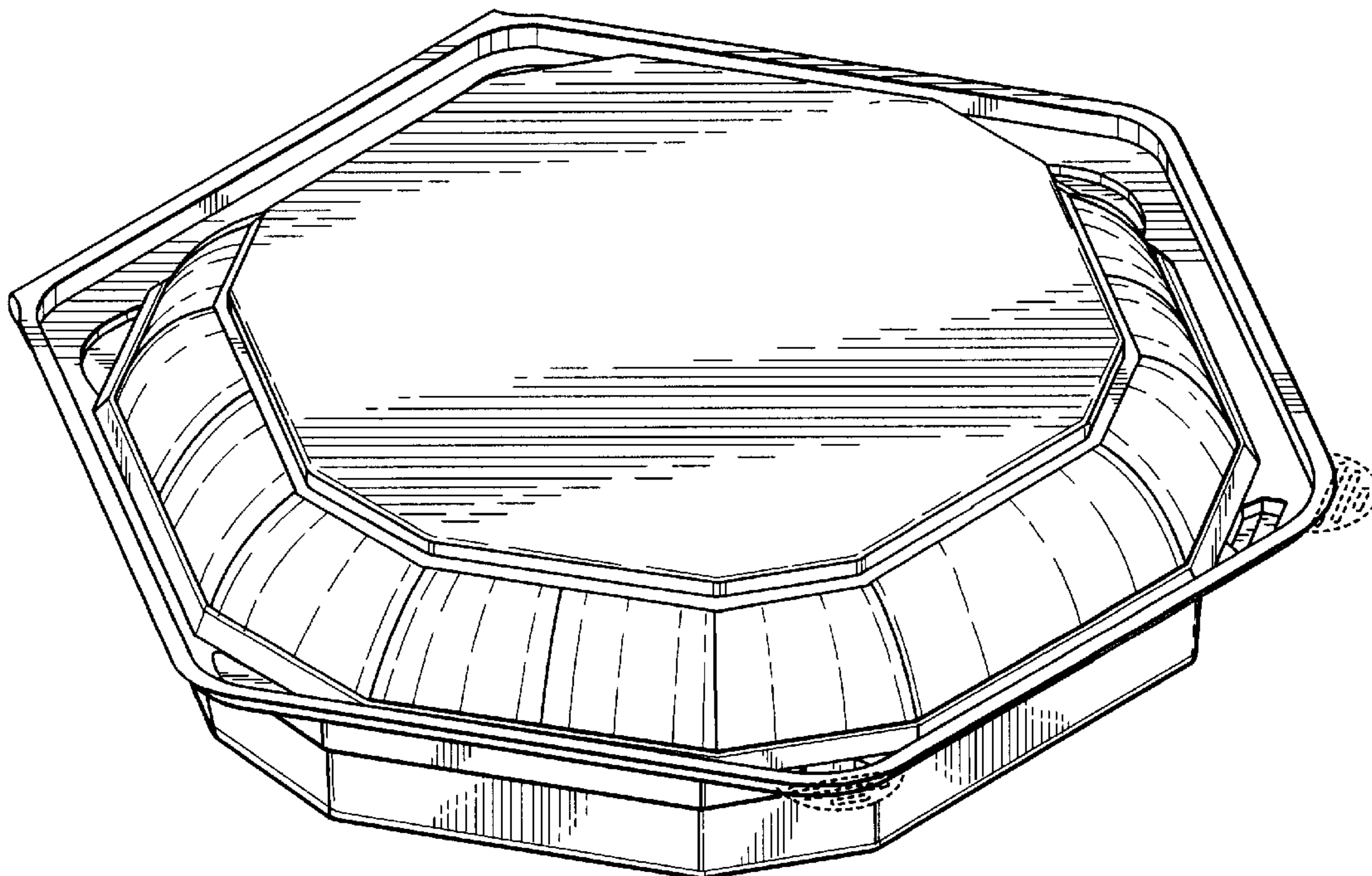

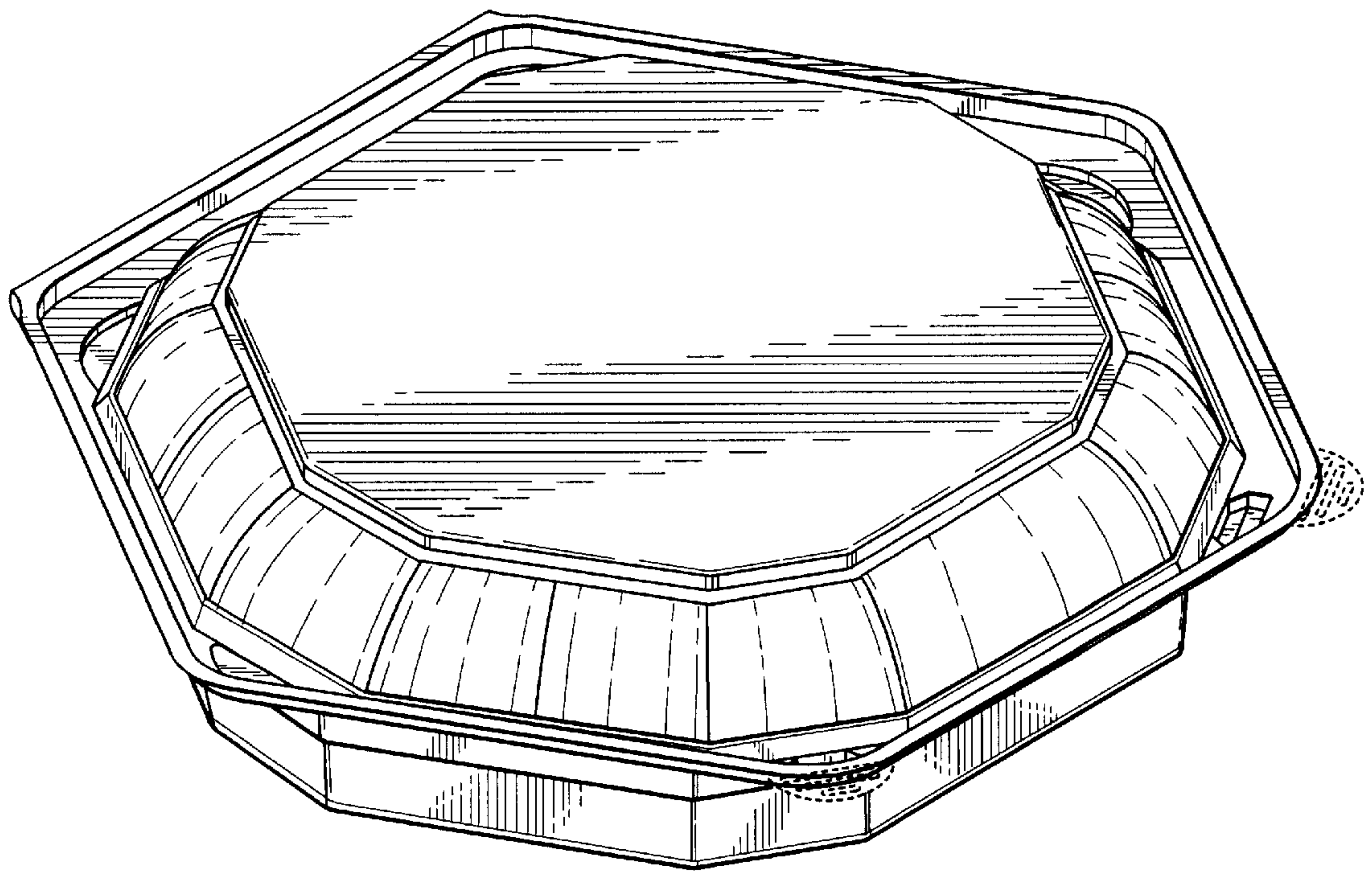

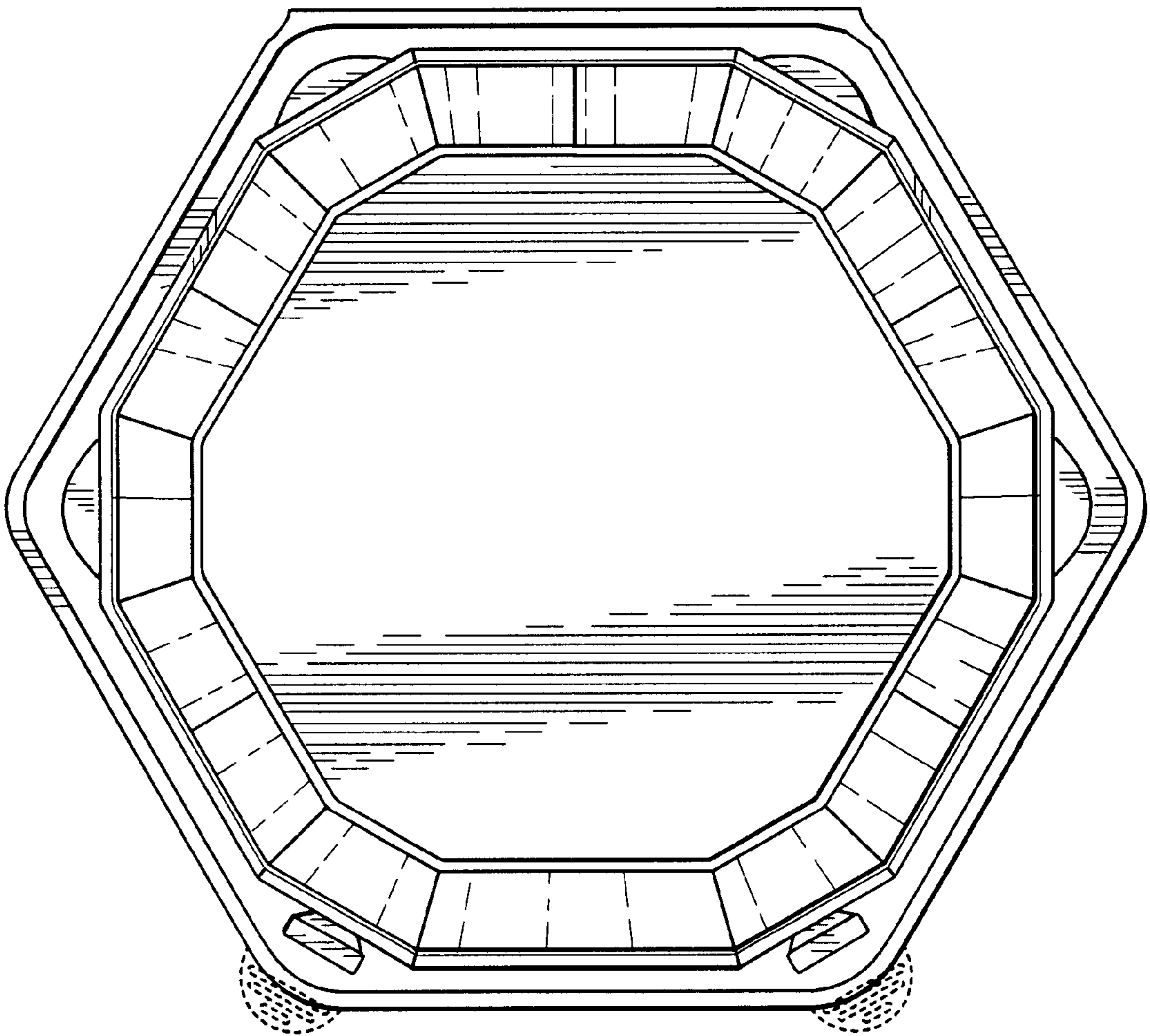

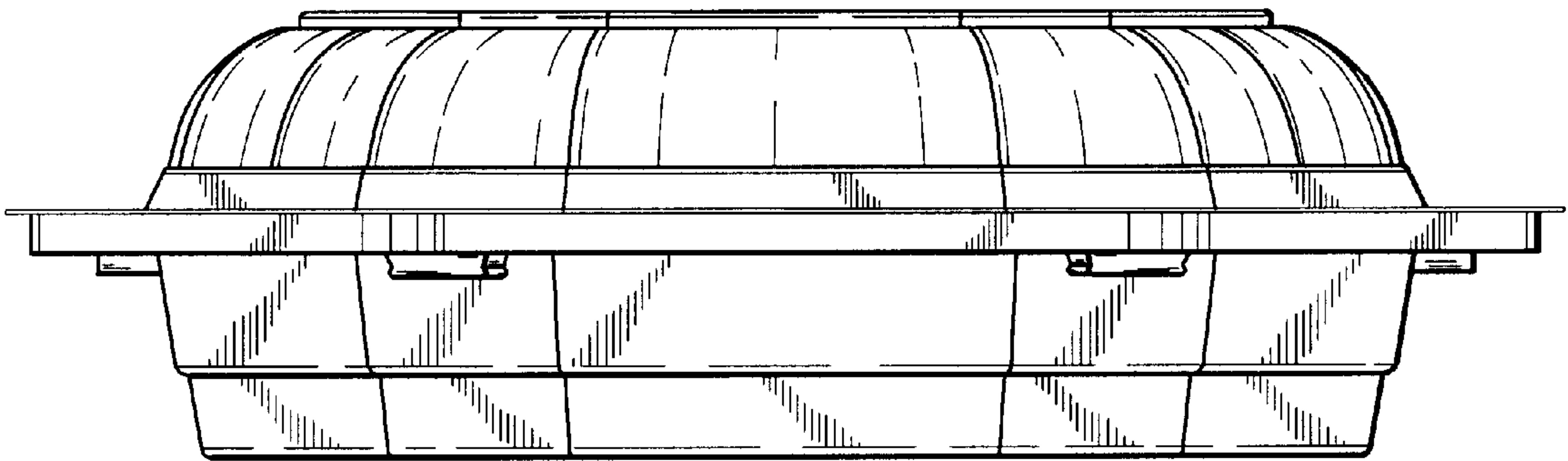

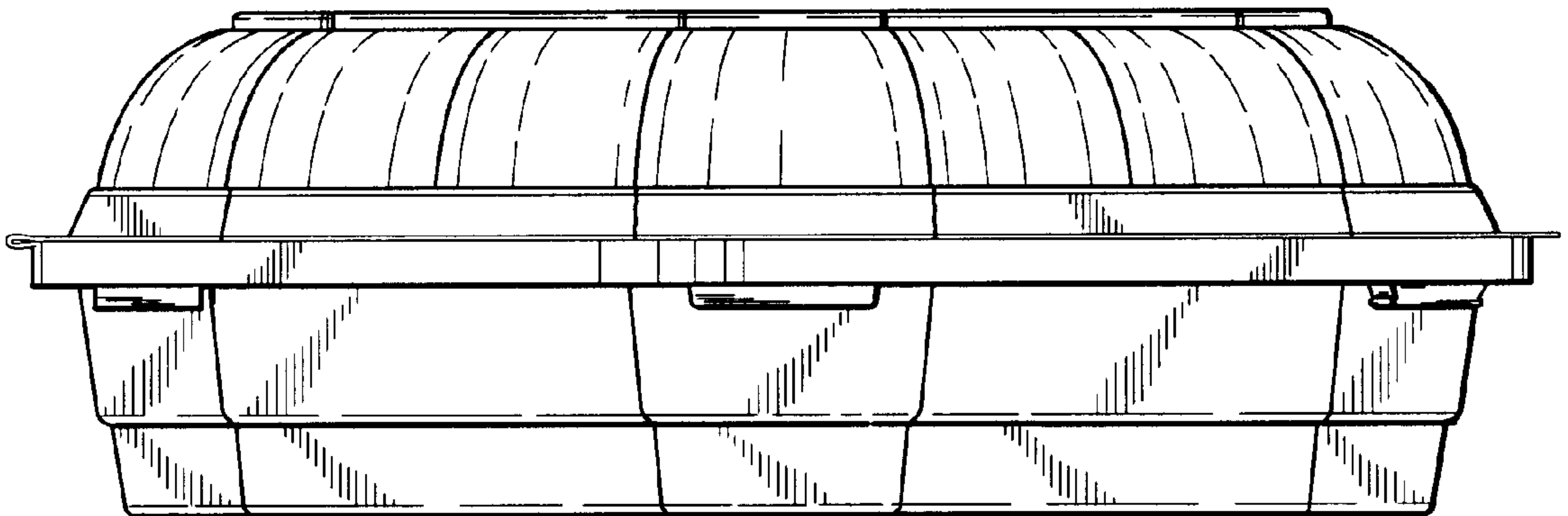
