FIG. 3 is a top plan view;

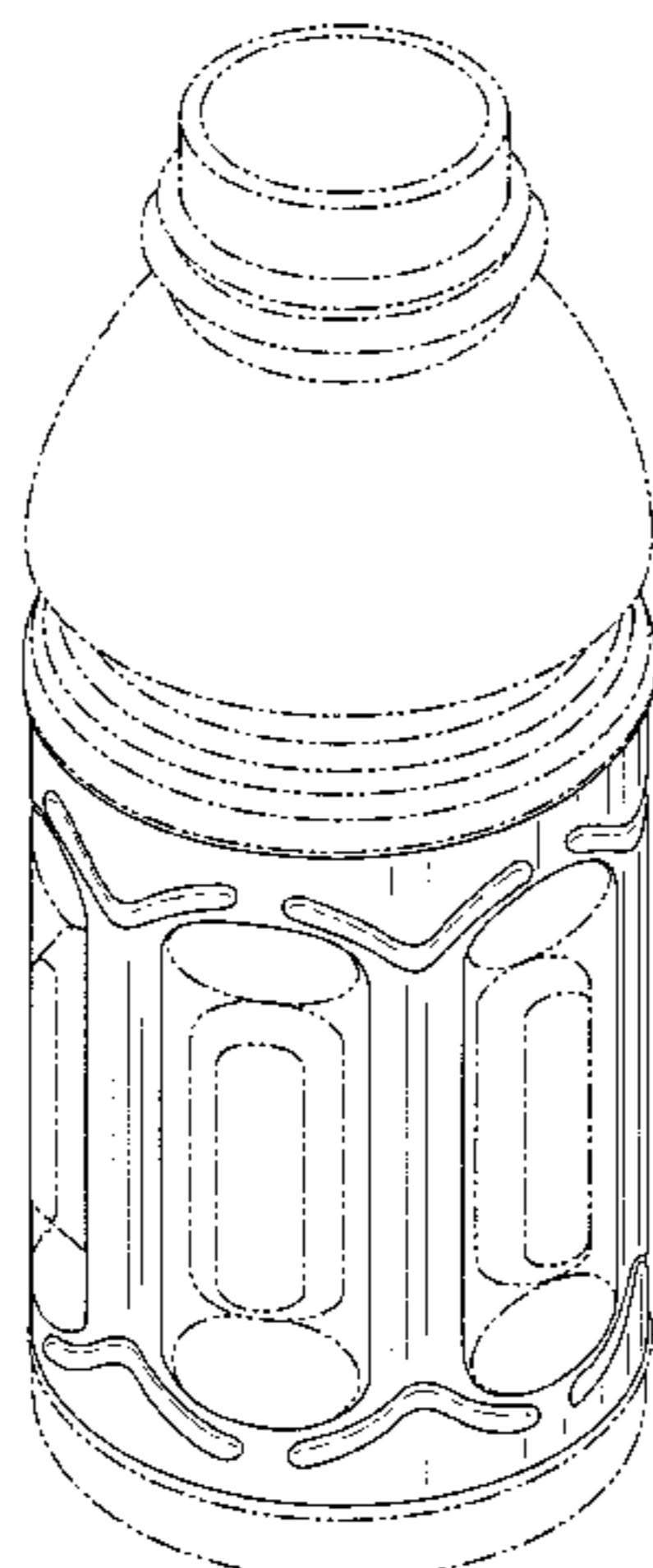
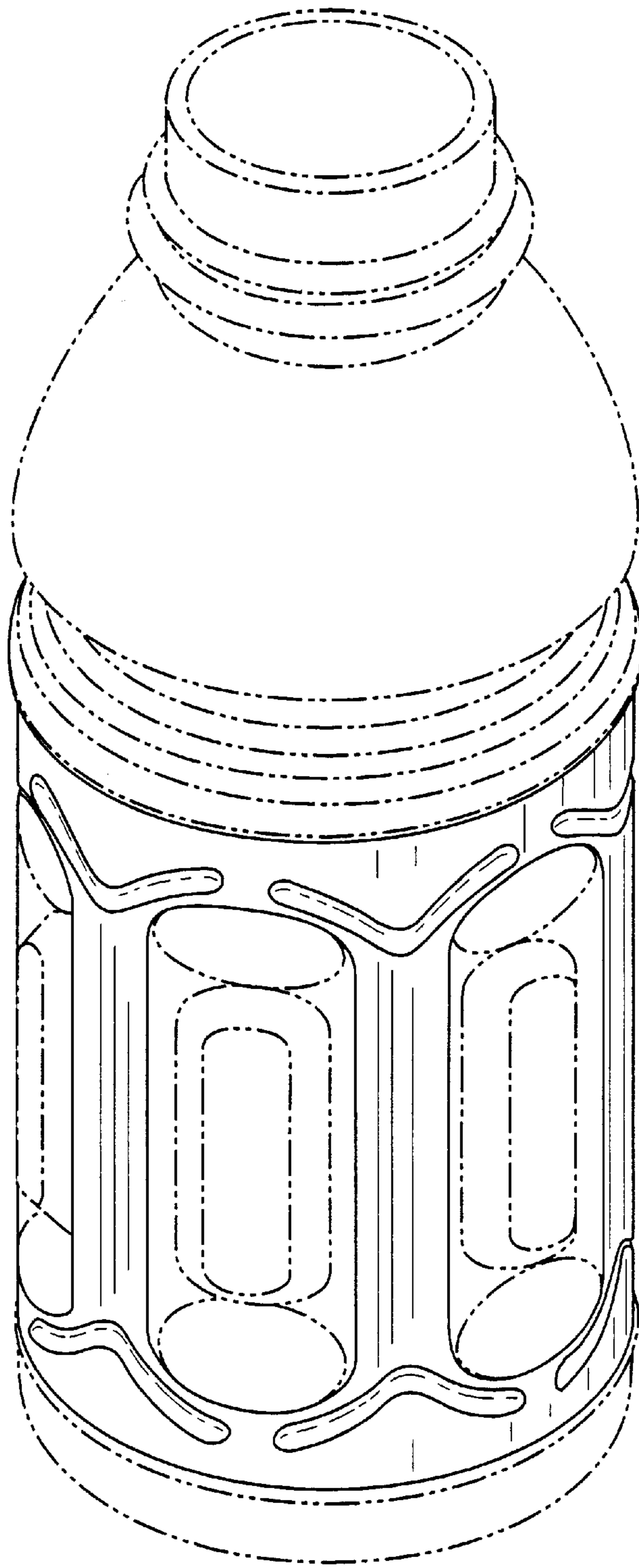


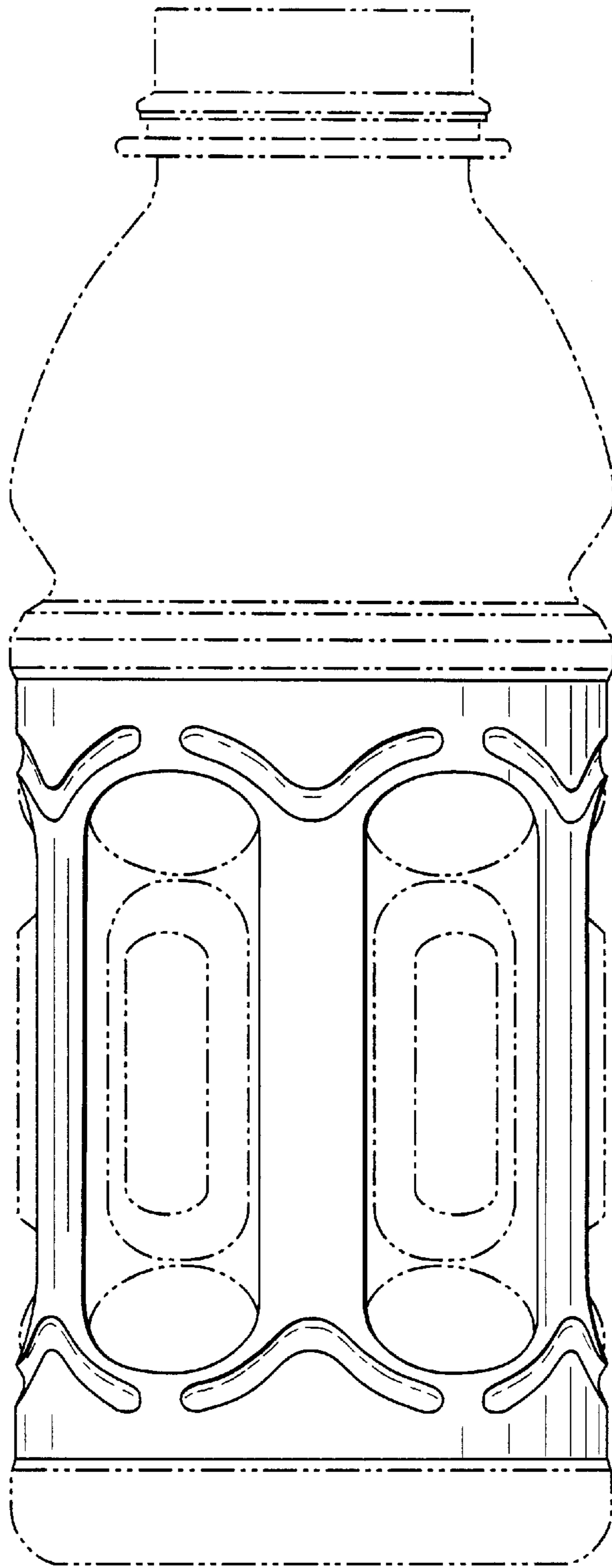
FIG. 4 is a bottom plan view; and,

only and do not form part of the claimed design.

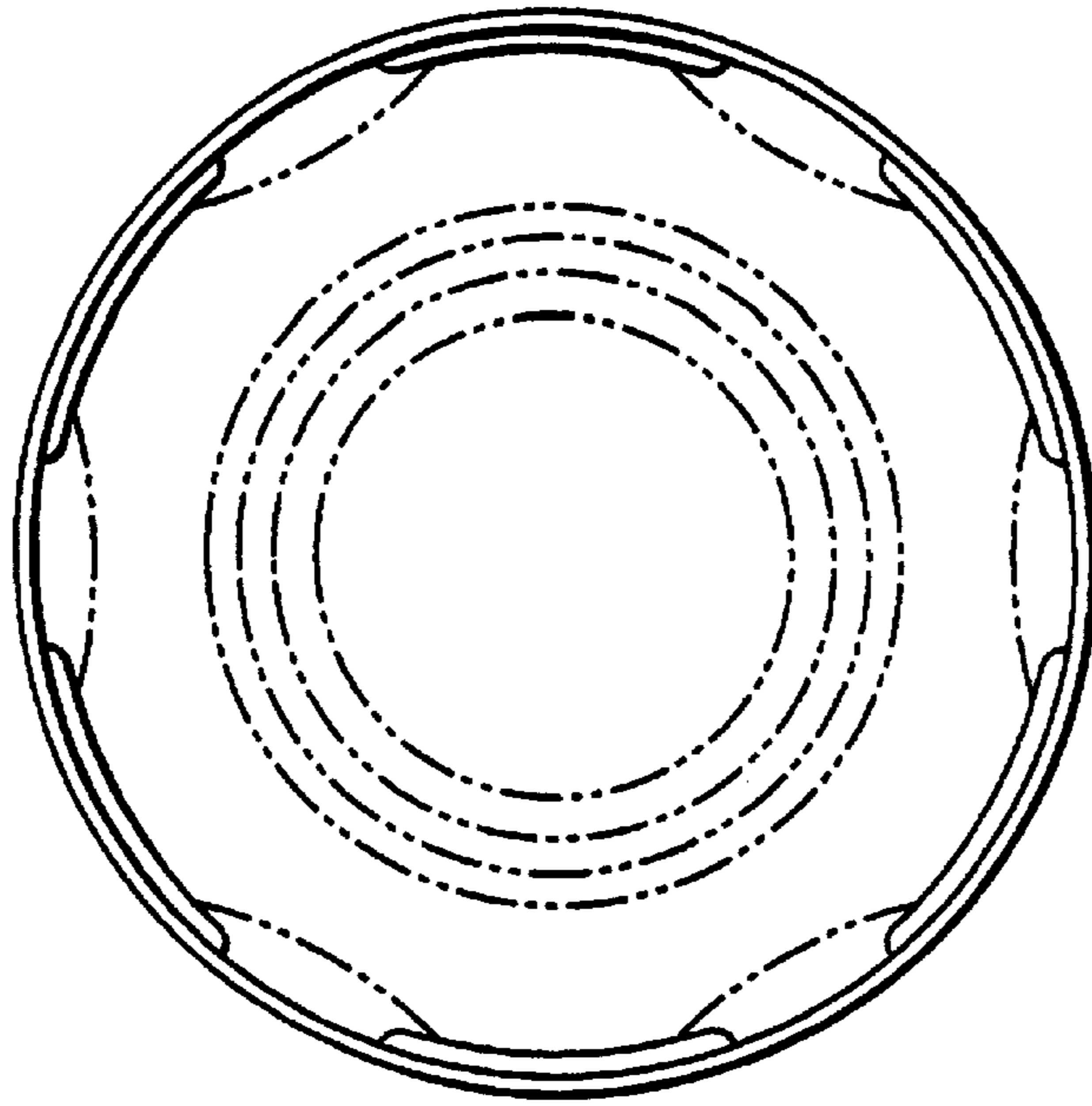

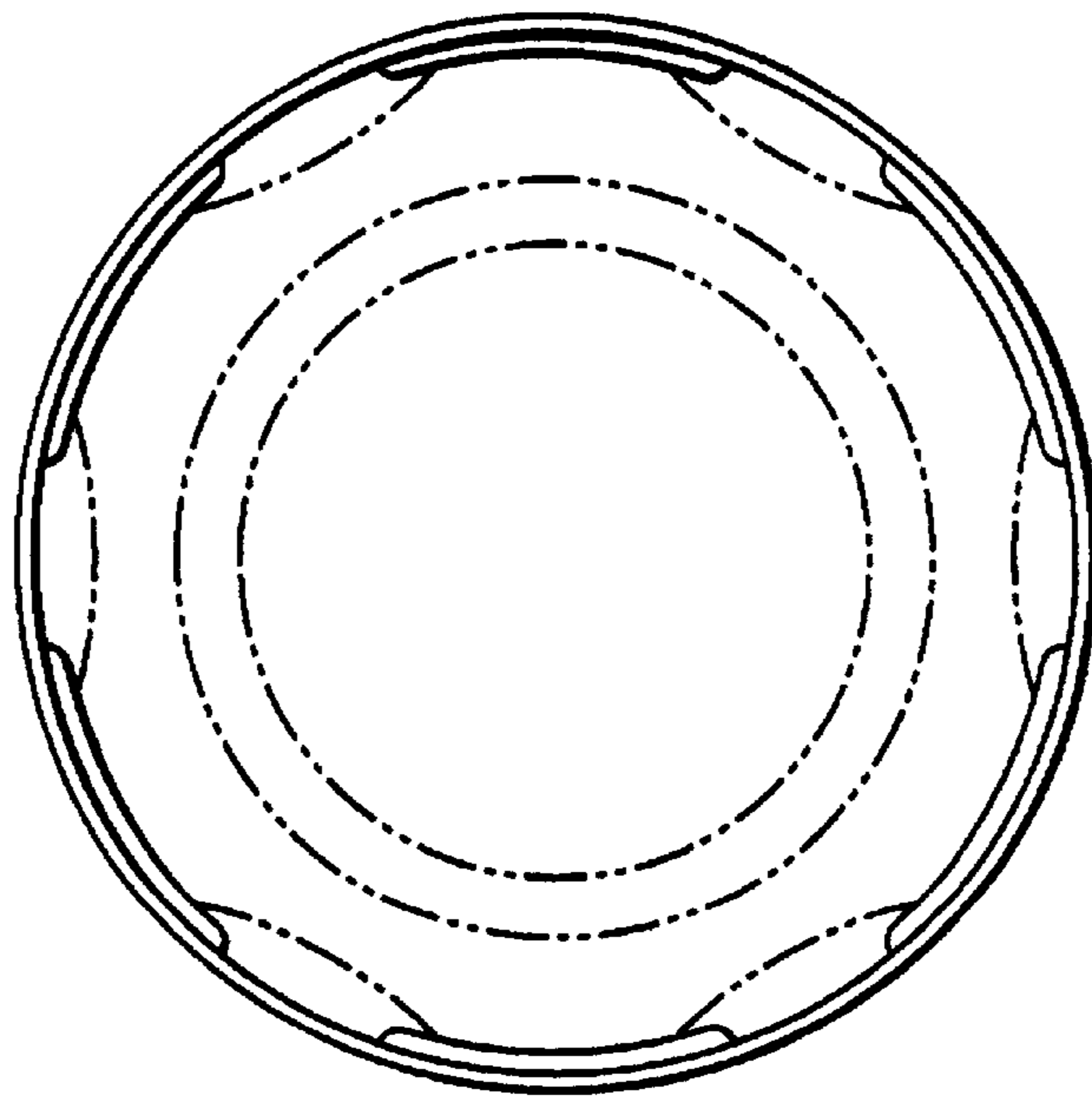

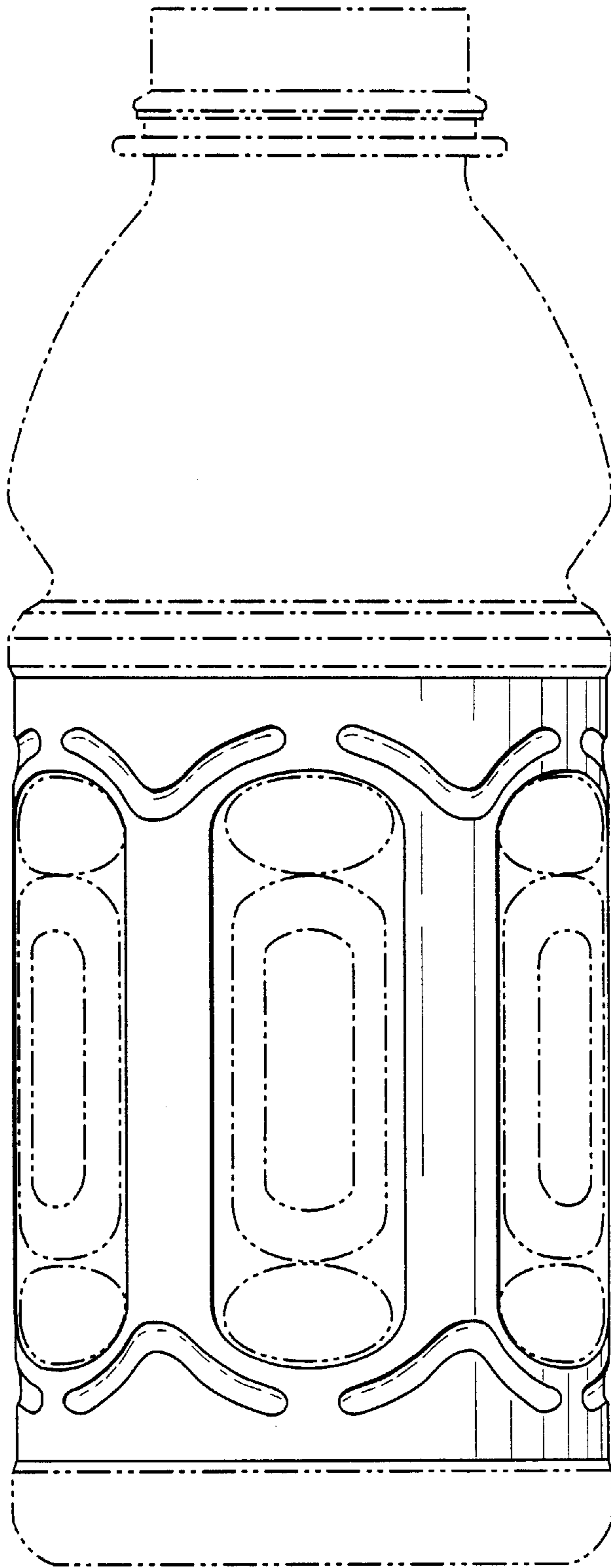
