[57] **CLAIM**

The ornamental design for an article of jewelry, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an article of jewelry showing my new design with the bale and chain shown in broken lines which is for illustrative purposes only and forms no part of the claimed design;

FIG. 2 is a top plan view of the invention;

FIG. 3 is a front elevational view of the invention;

FIG. 4 is a left elevational view, the right side view being identical;

FIG. 5 is a rear elevational view;

FIG. 6 is a bottom plan view;

FIG. 7 is a perspective view of an article of jewelry showing a second embodiment of my new design with the broken lines for the chain and bale being for illustrative purposes only and forming no part of the claimed design;

FIG. 8 is a front elevational view of FIG. 7;

FIG. 9 is a left side elevational view of FIG. 7, the right side view being identical;

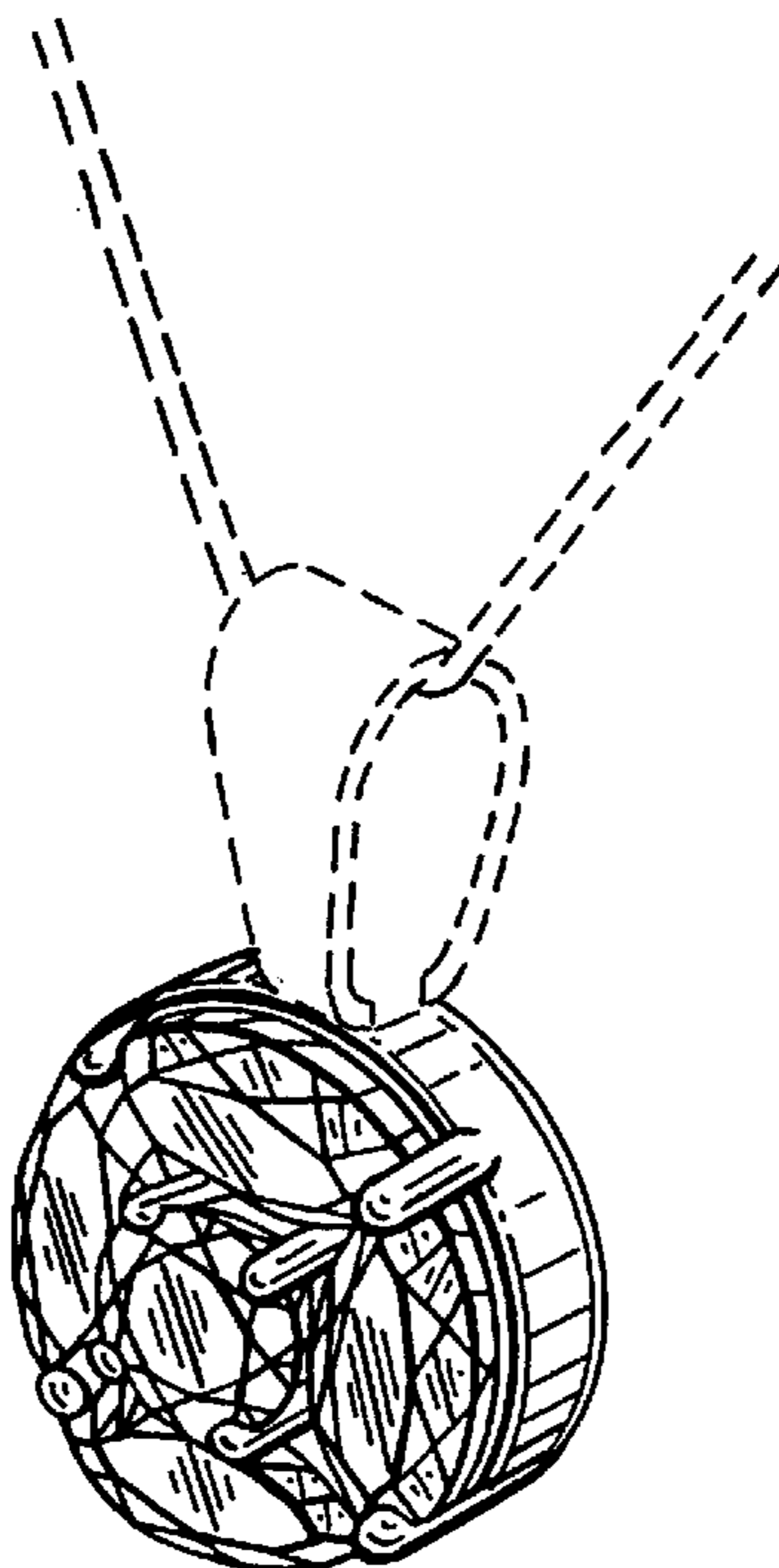
FIG. 10 is a perspective view of an article of jewelry showing a third embodiment of my new design;

FIG. 11 is a front elevational view of FIG. 10; and,

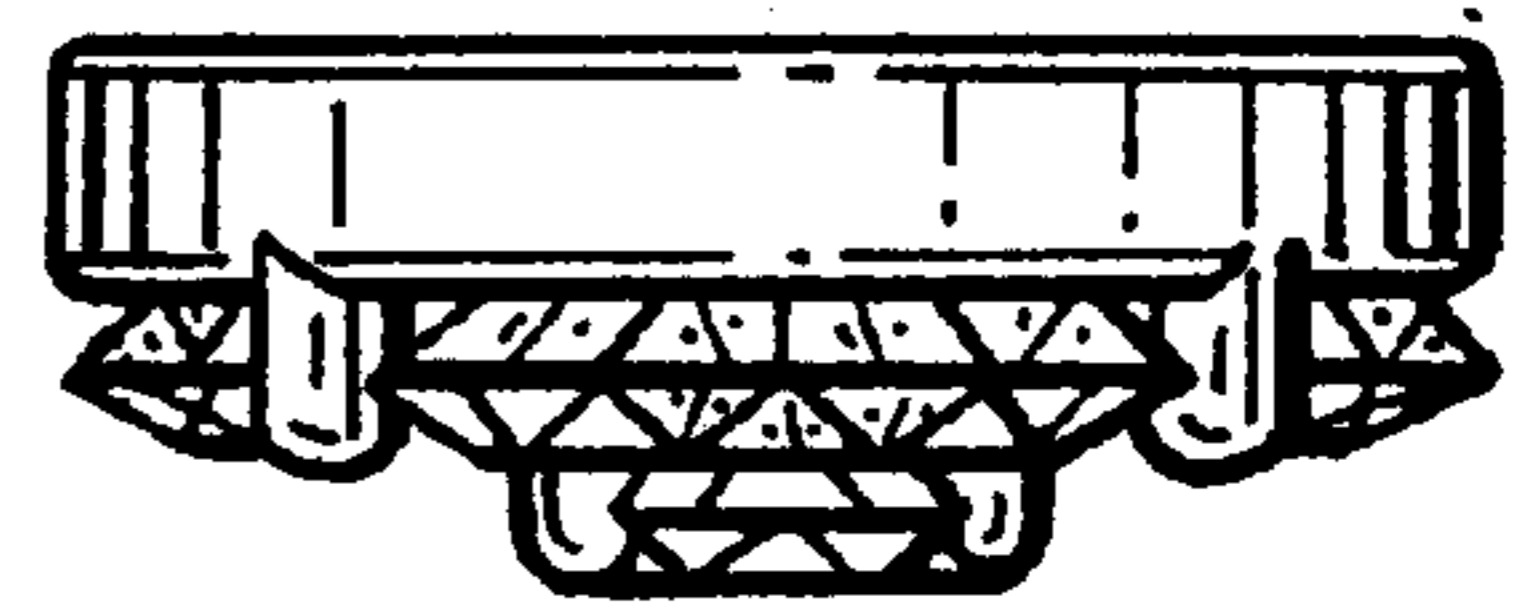
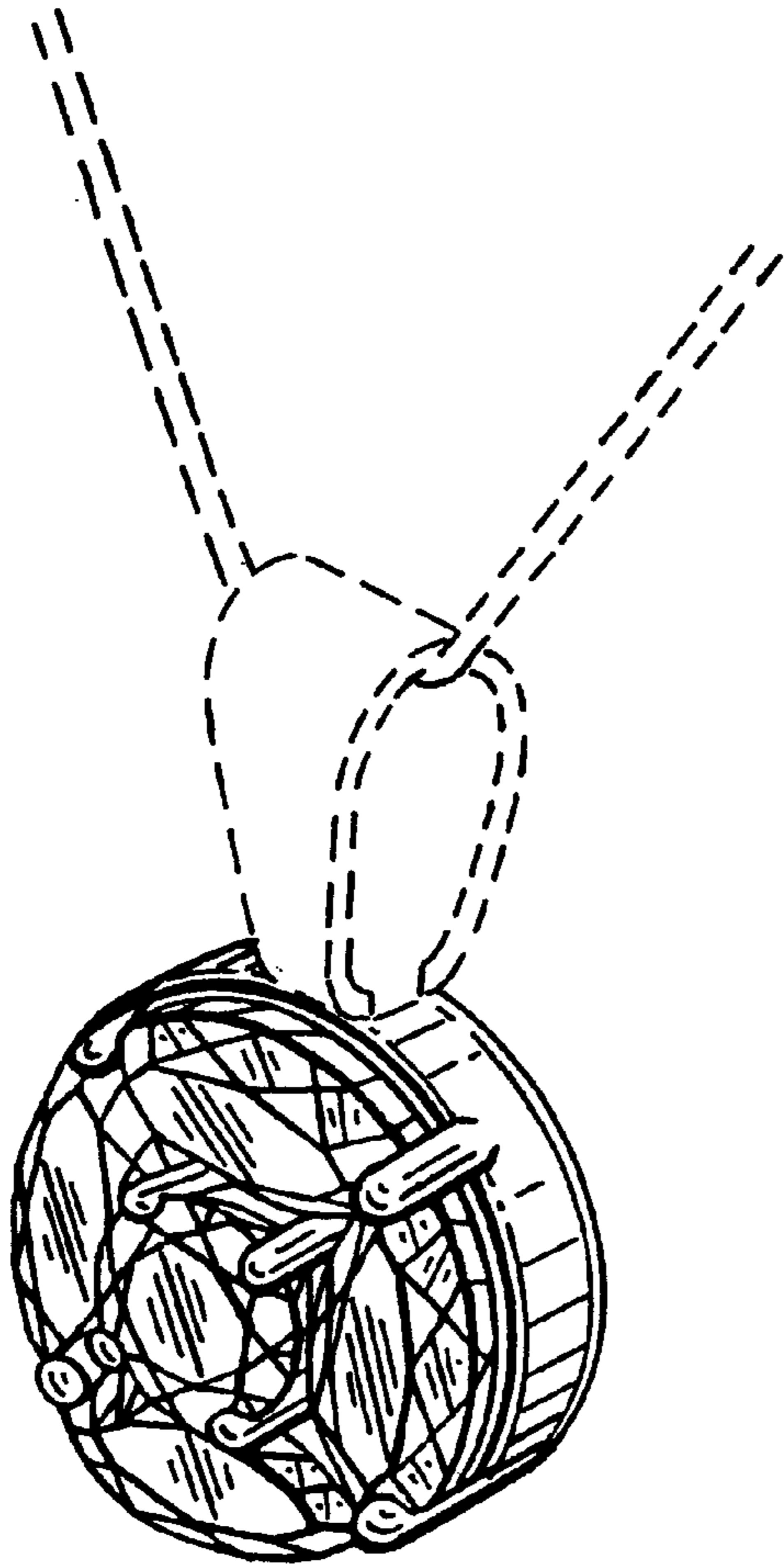
FIG. 12 is a left side elevational view of FIG. 10, the right side view being identical.

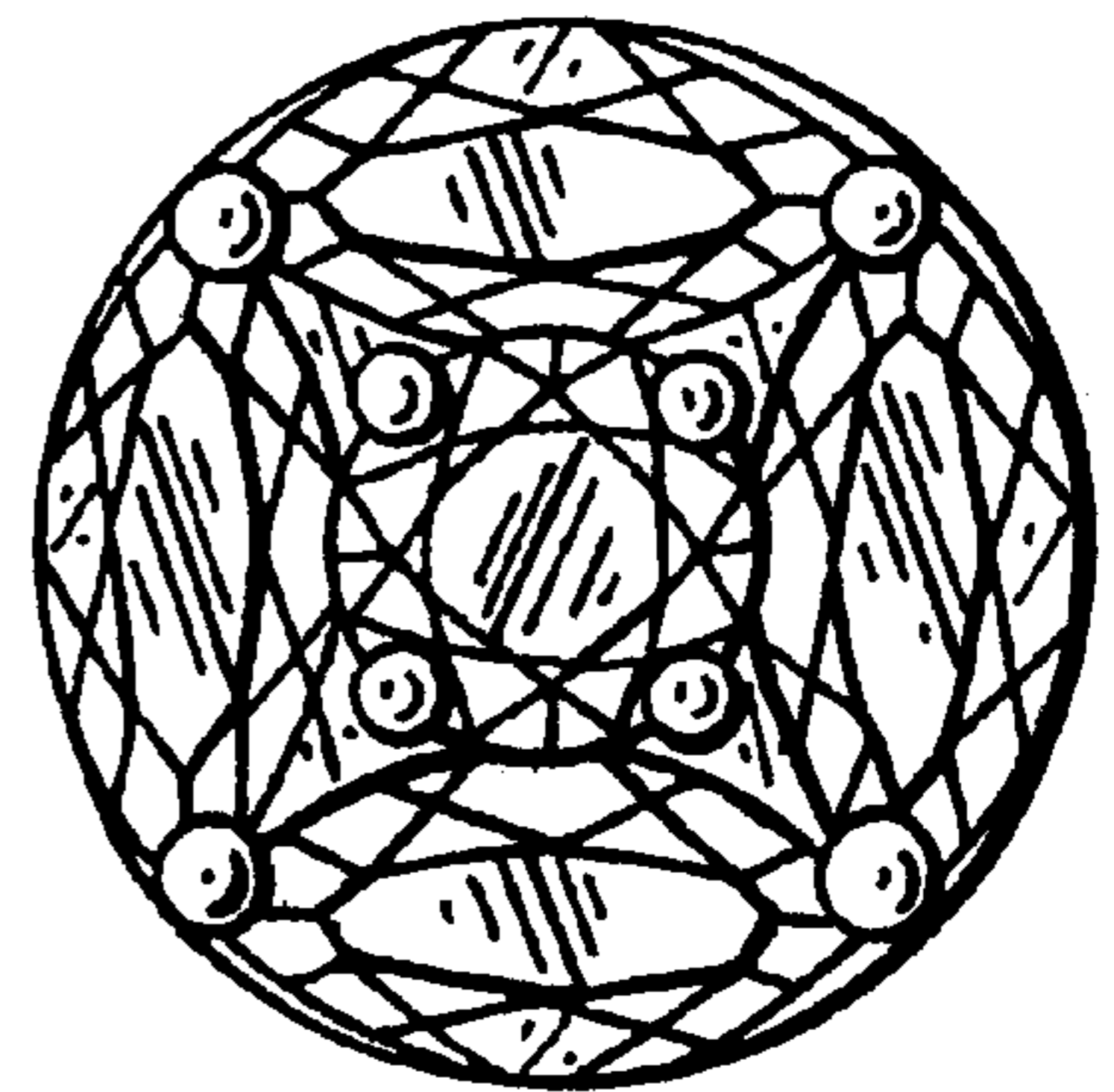

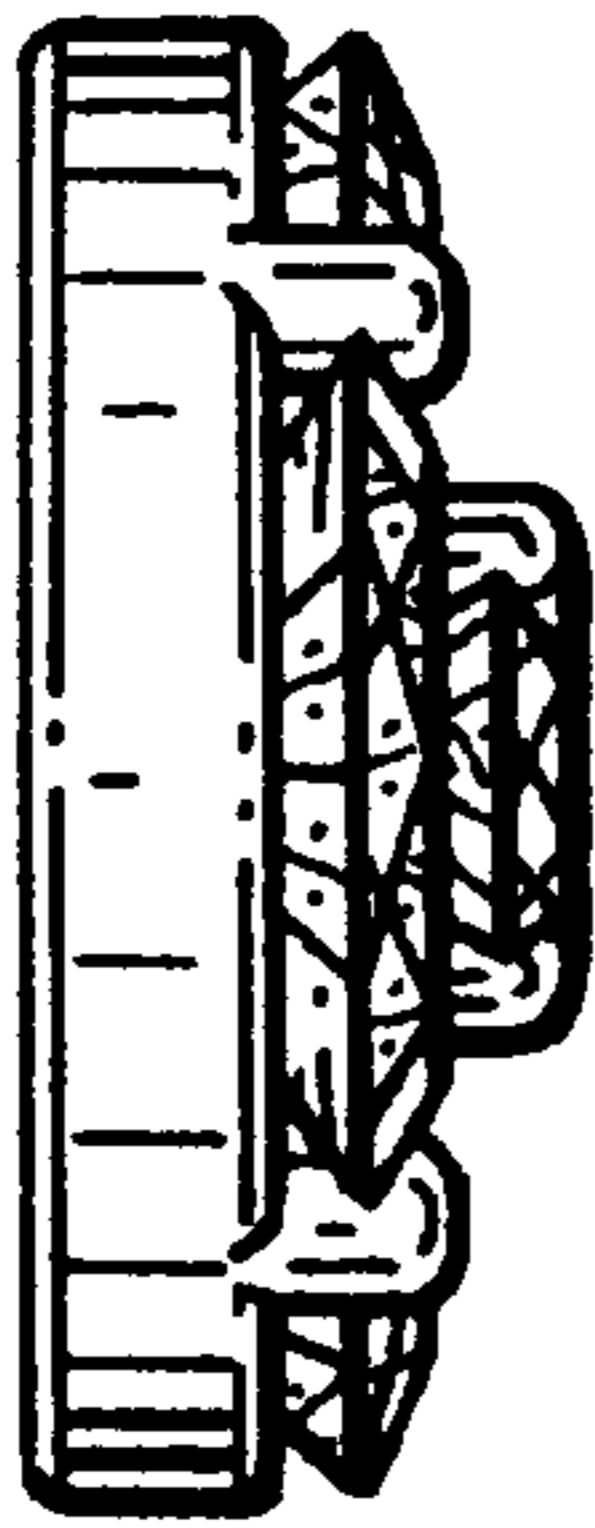

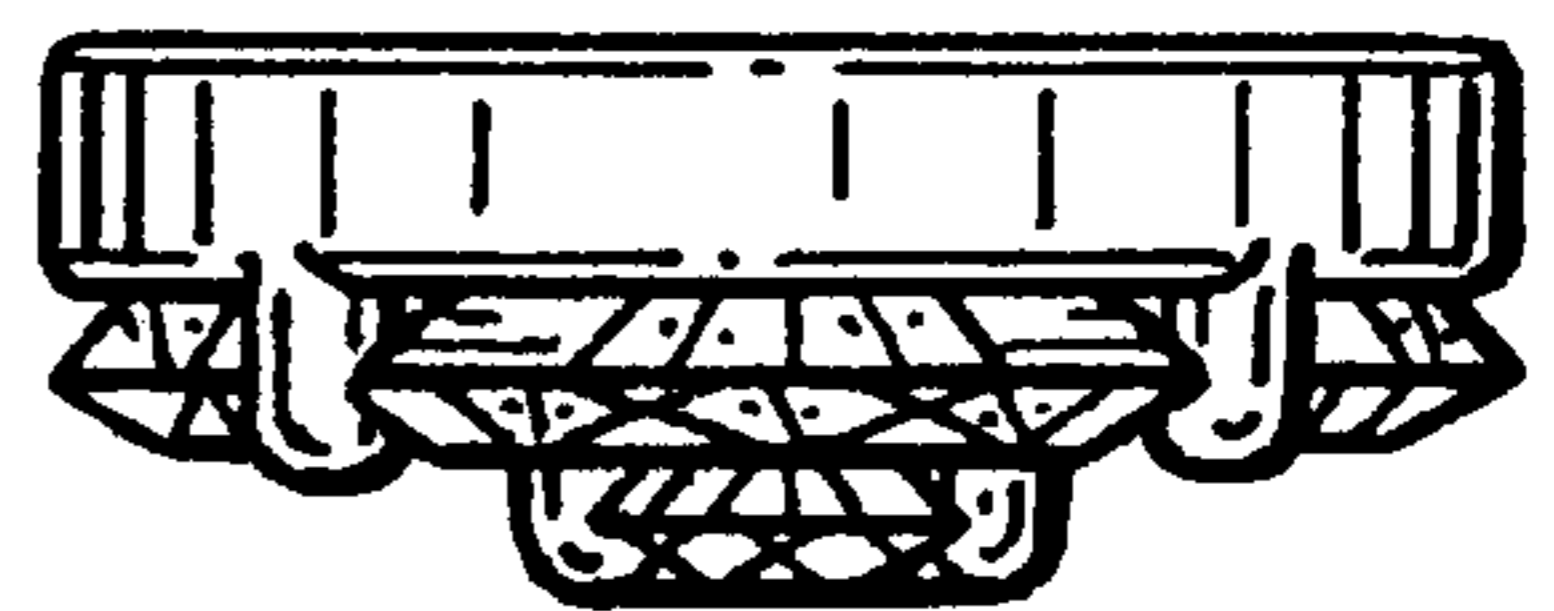

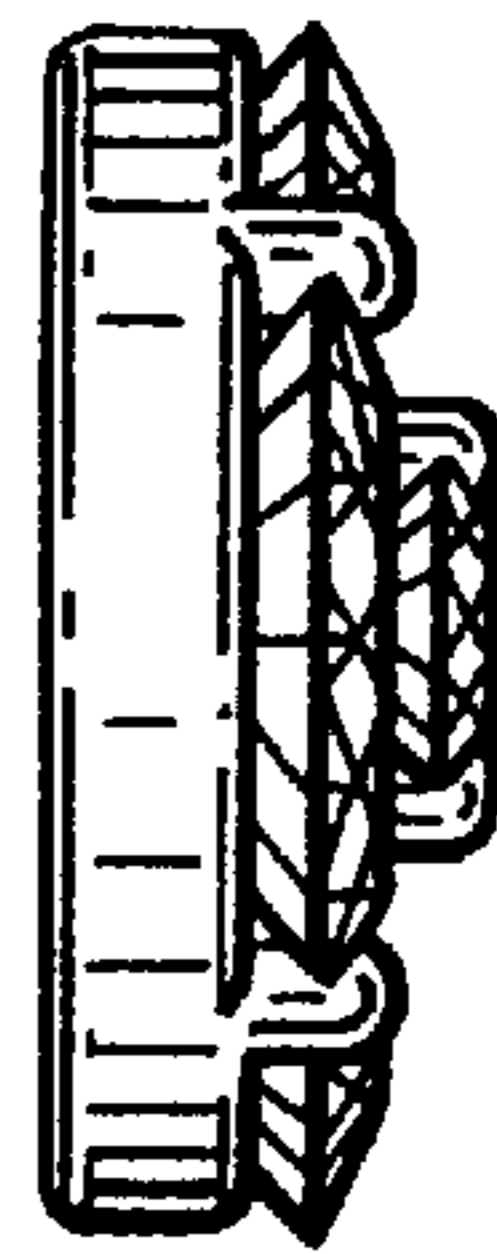
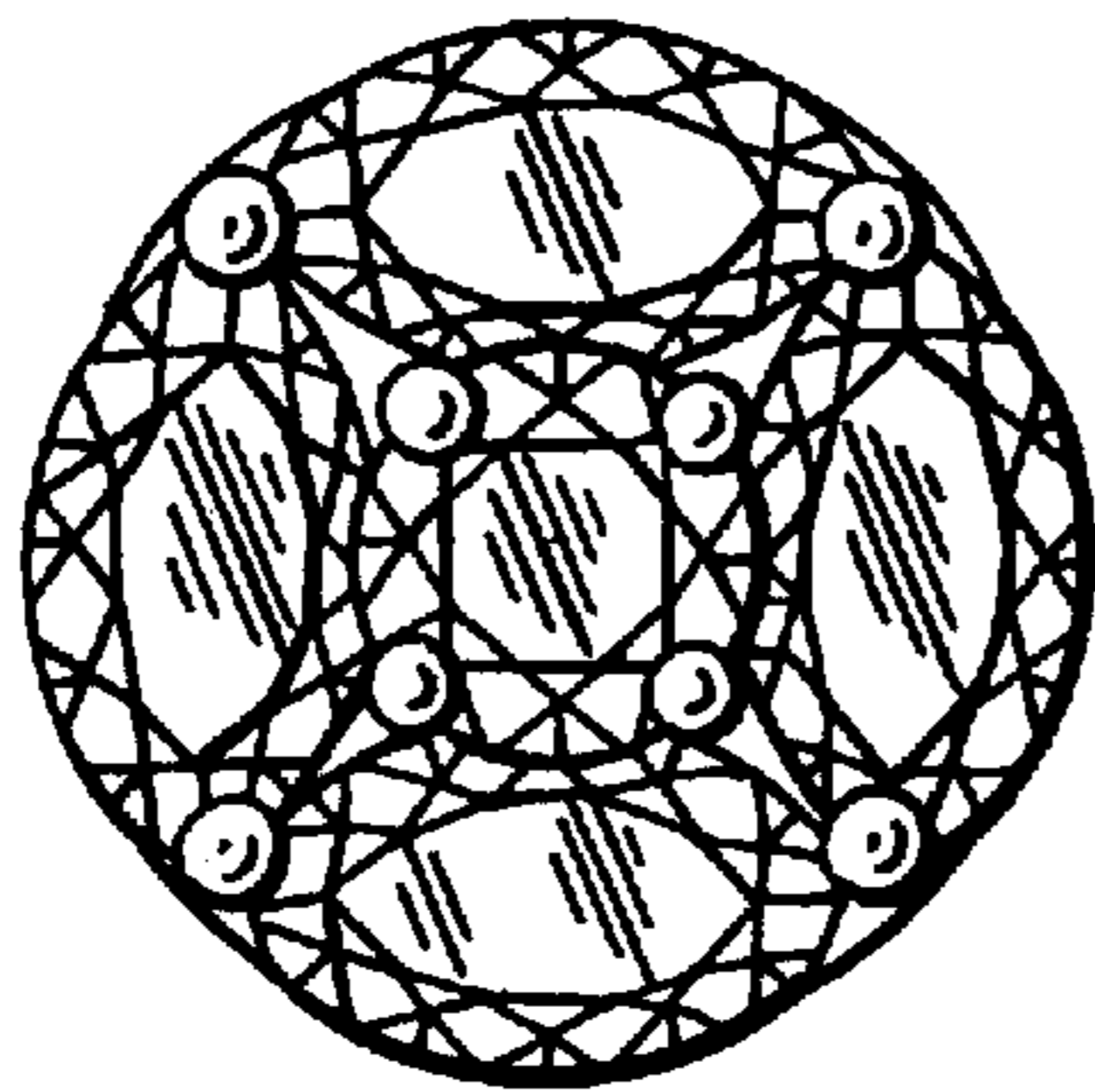
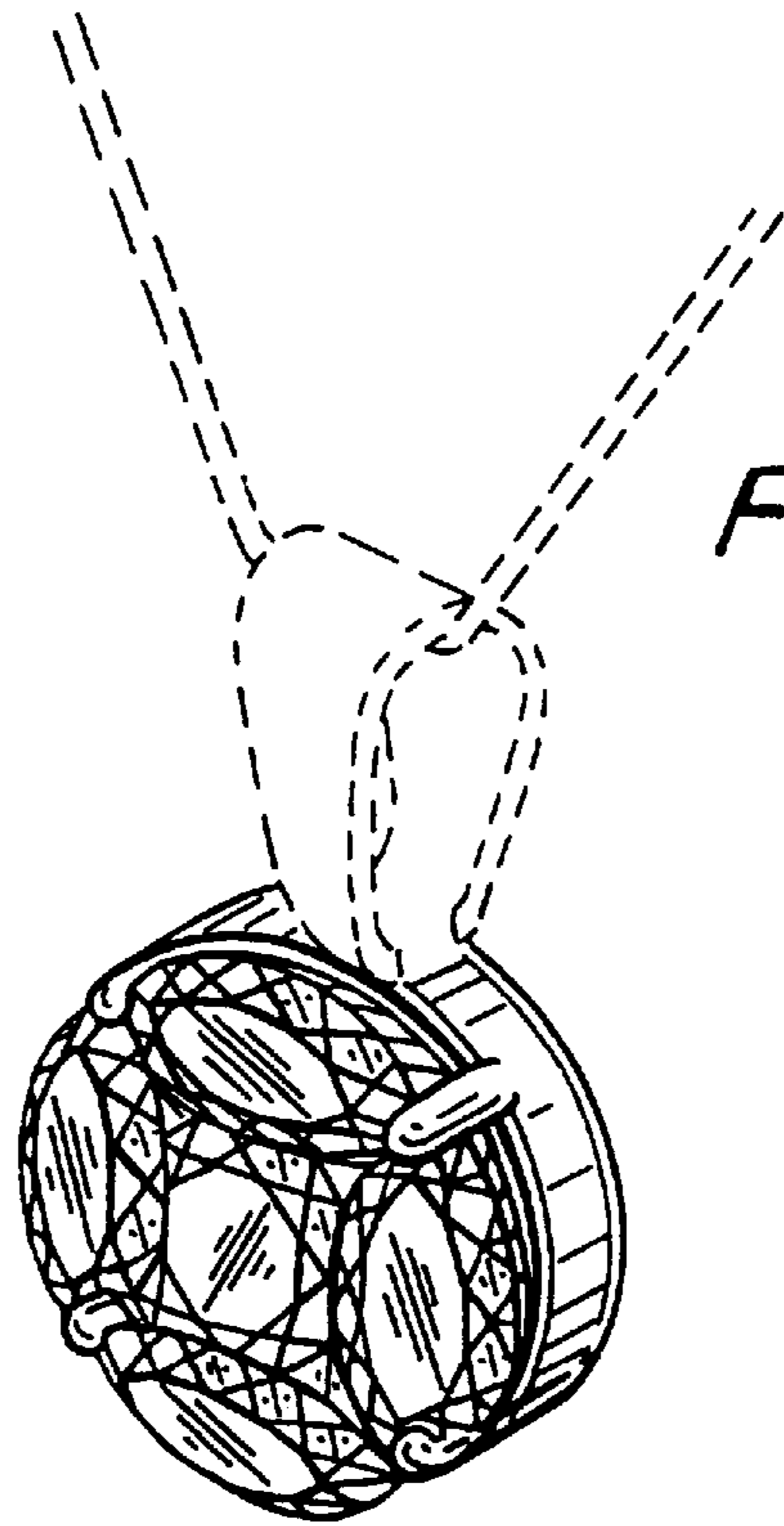


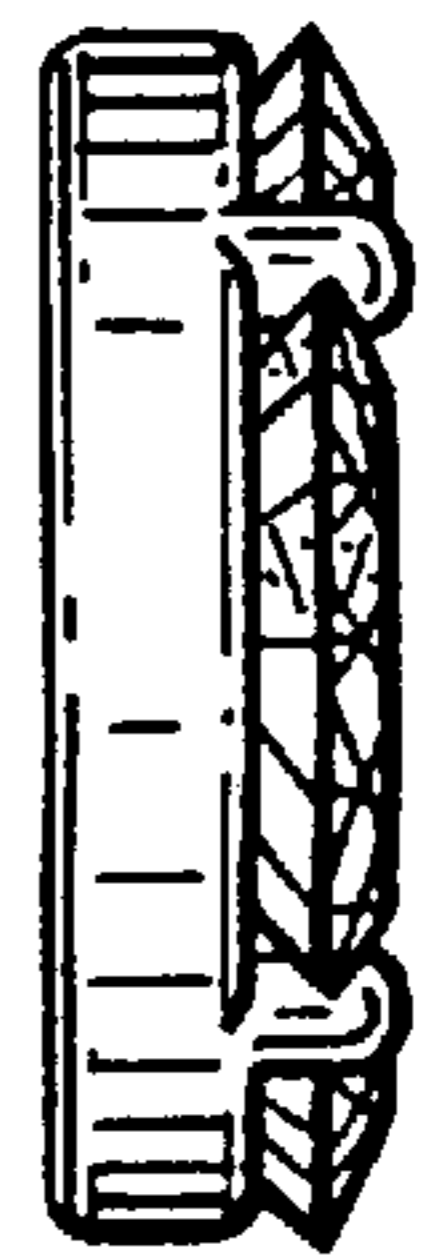
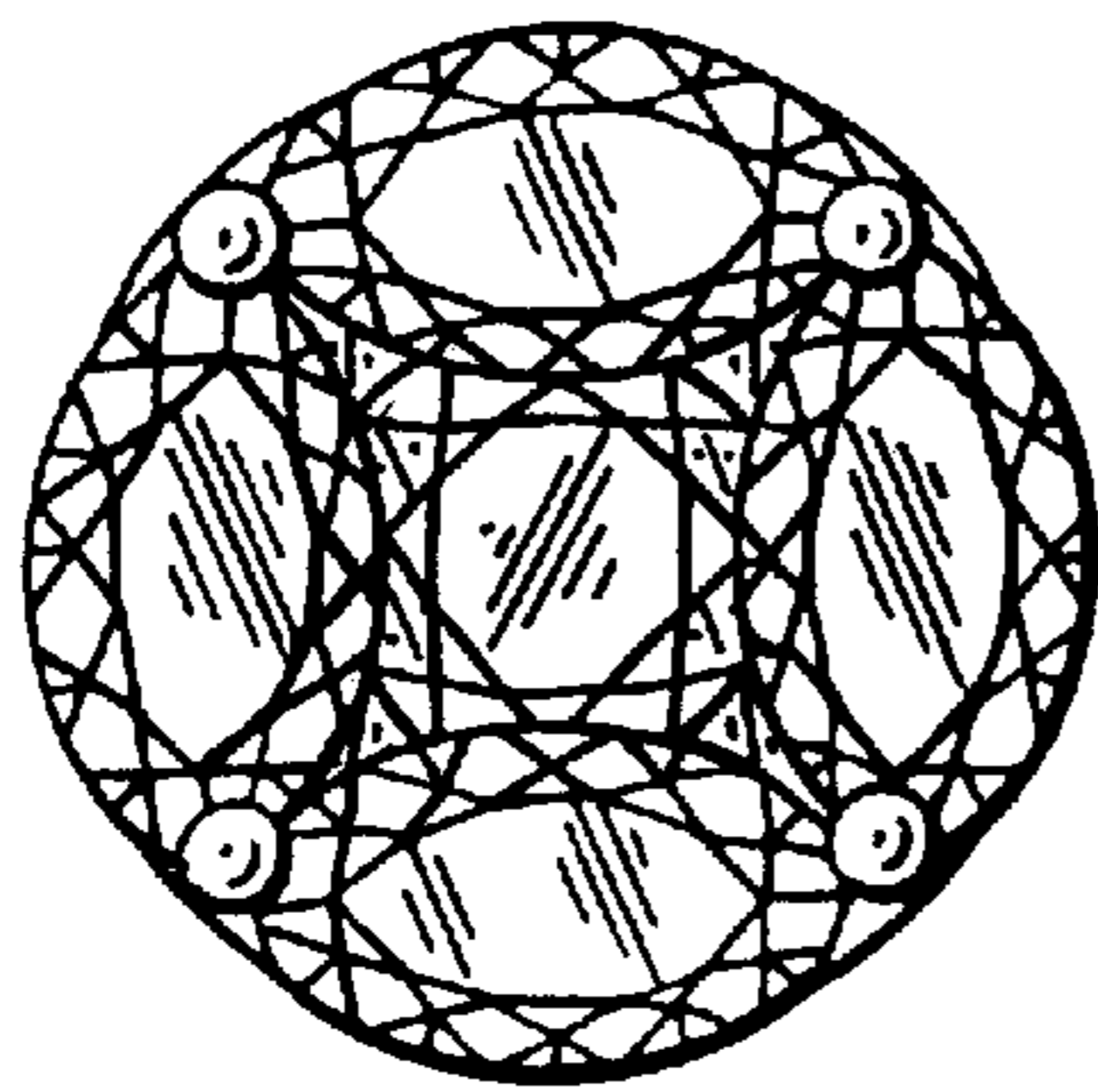
