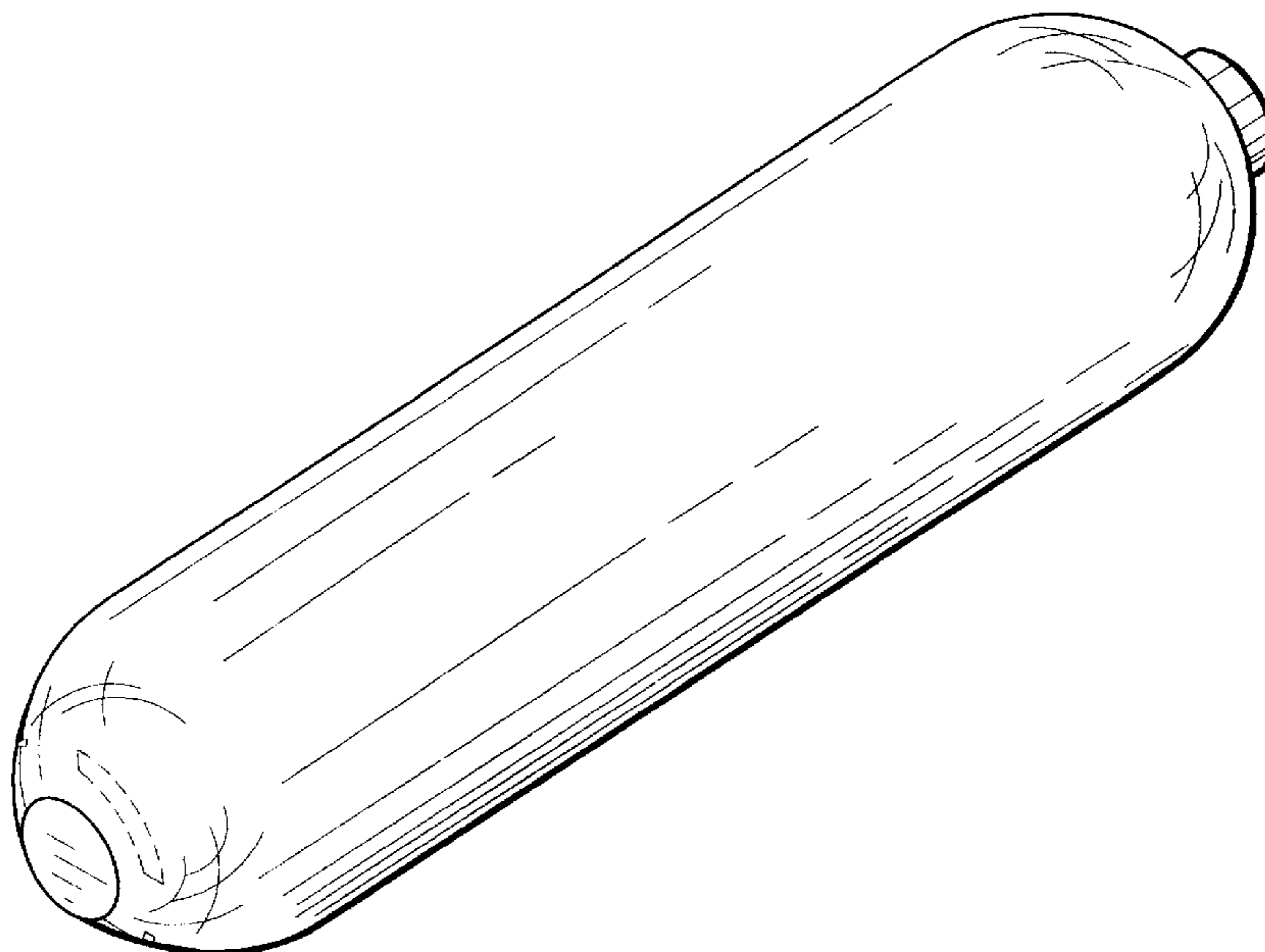
[57] CLAIM

We claim the ornamental design for an electrochemical cell, as shown in the drawing figures and described.

DESCRIPTION

FIG. 1 is a perspective view showing the bottom and one side of the electrochemical cell of the present invention; FIG. 2 is a side elevational view of the electrochemical cell of the present invention; FIG. 3 is a top plan view of the electrochemical cell of the present invention; and, FIG. 4 is a bottom plan view of the electrochemical cell of the present invention. The broken line showing in FIGS. 1, 2 and 4 is included for the purpose of illustrating environmental structure only and forms no part of the claimed design.

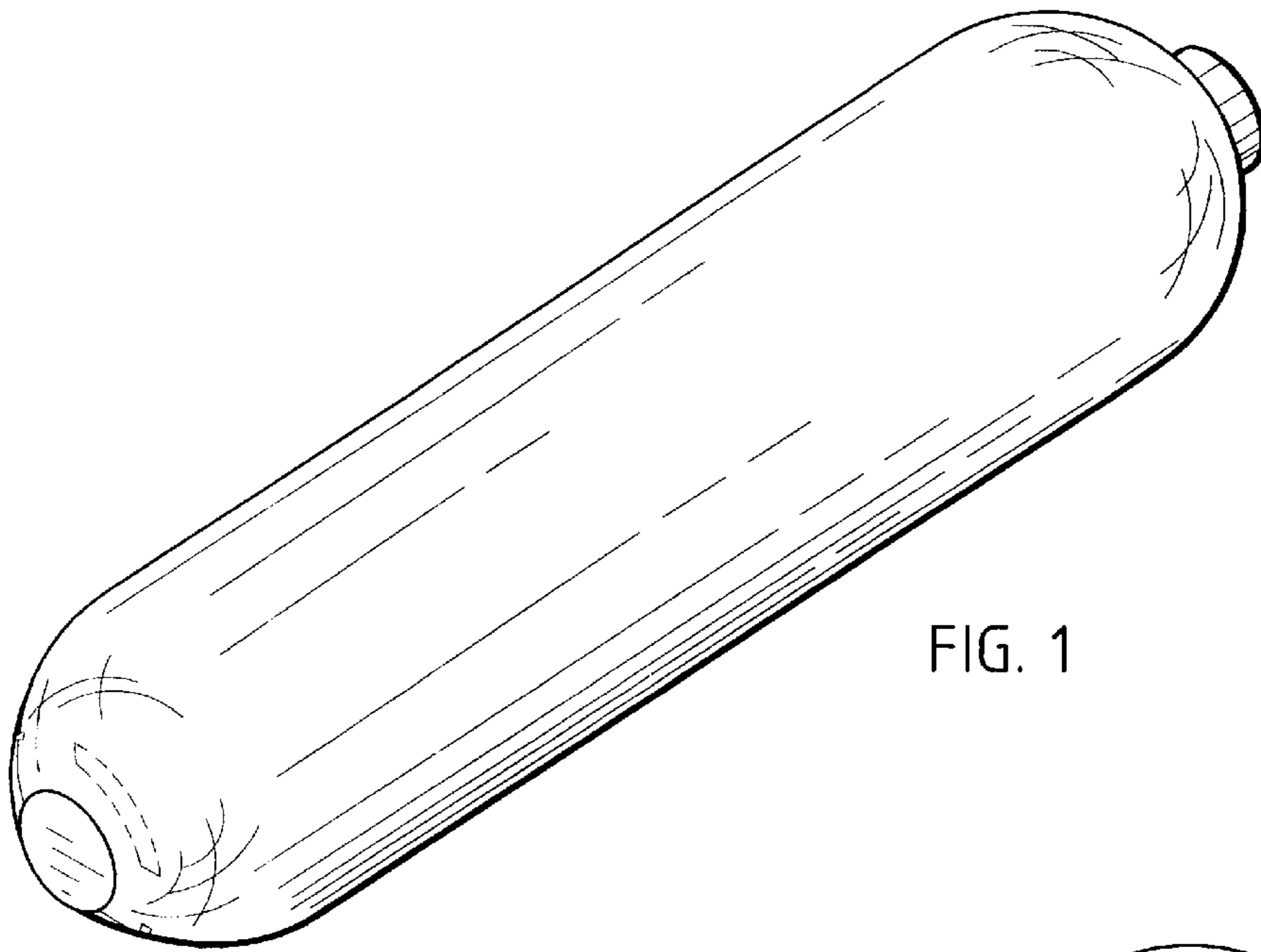

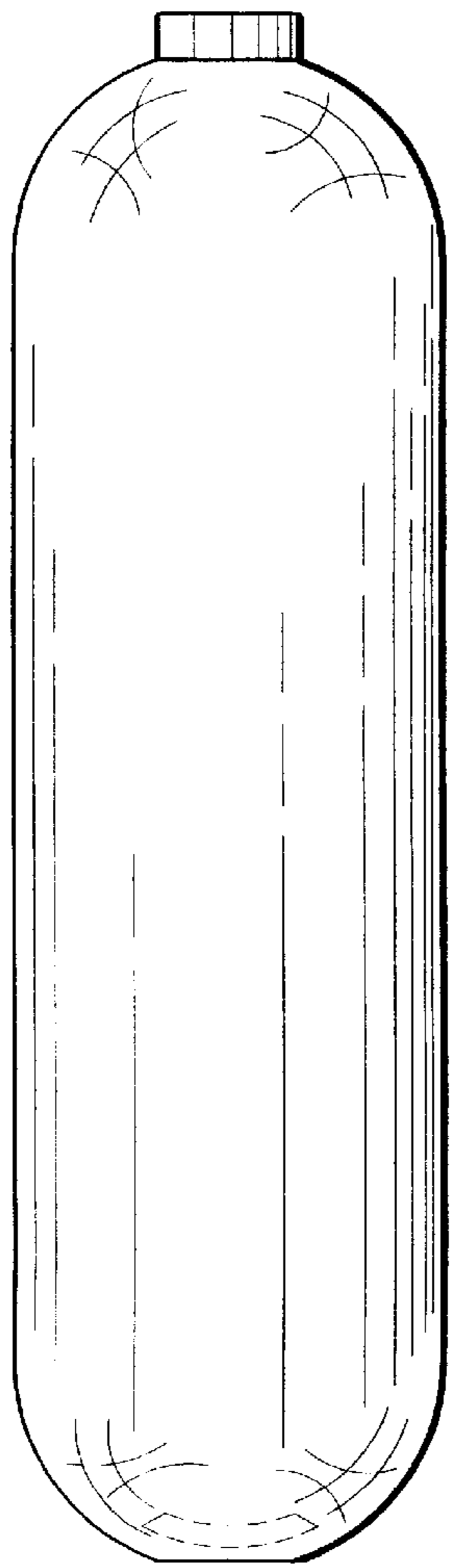

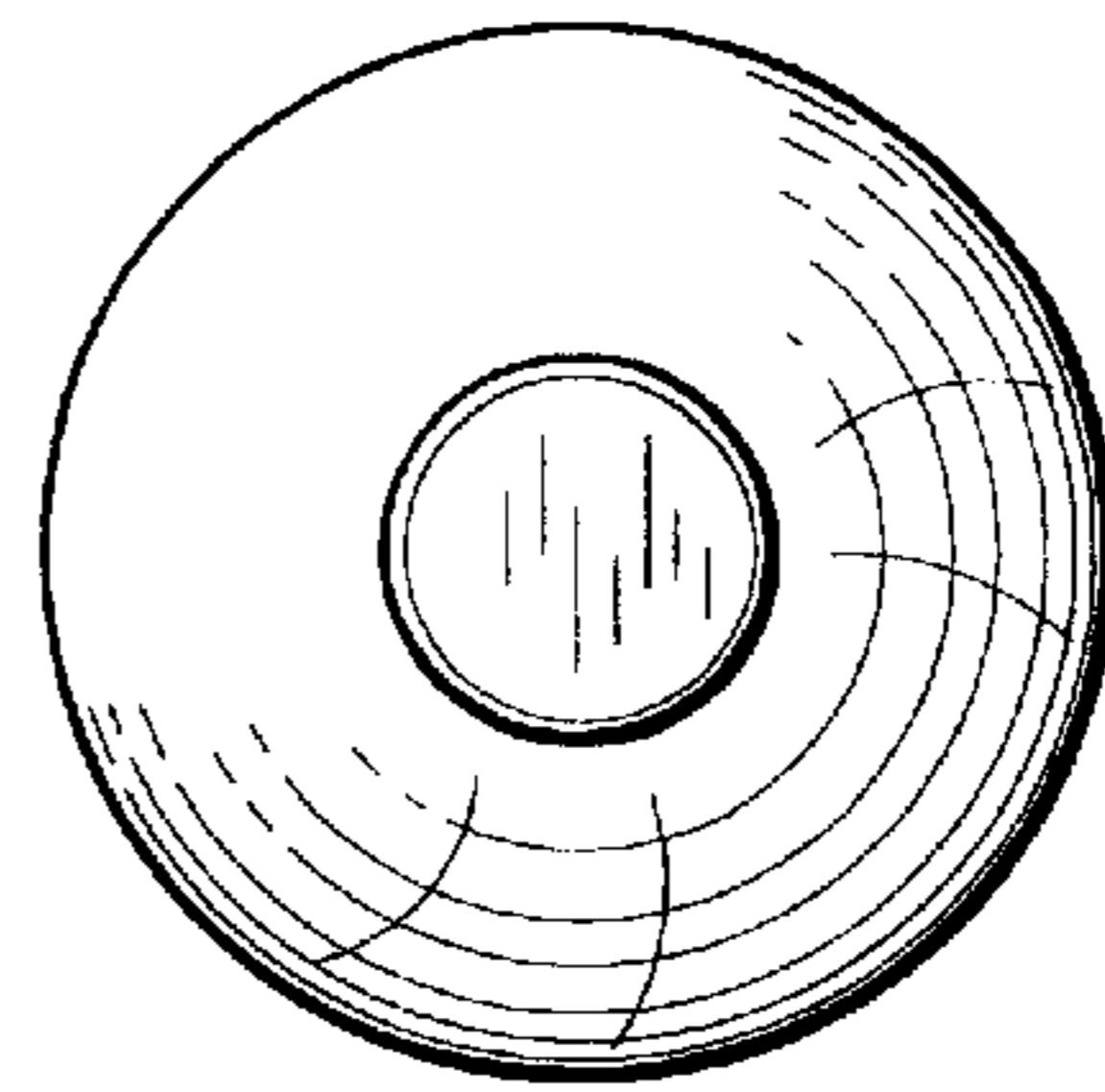

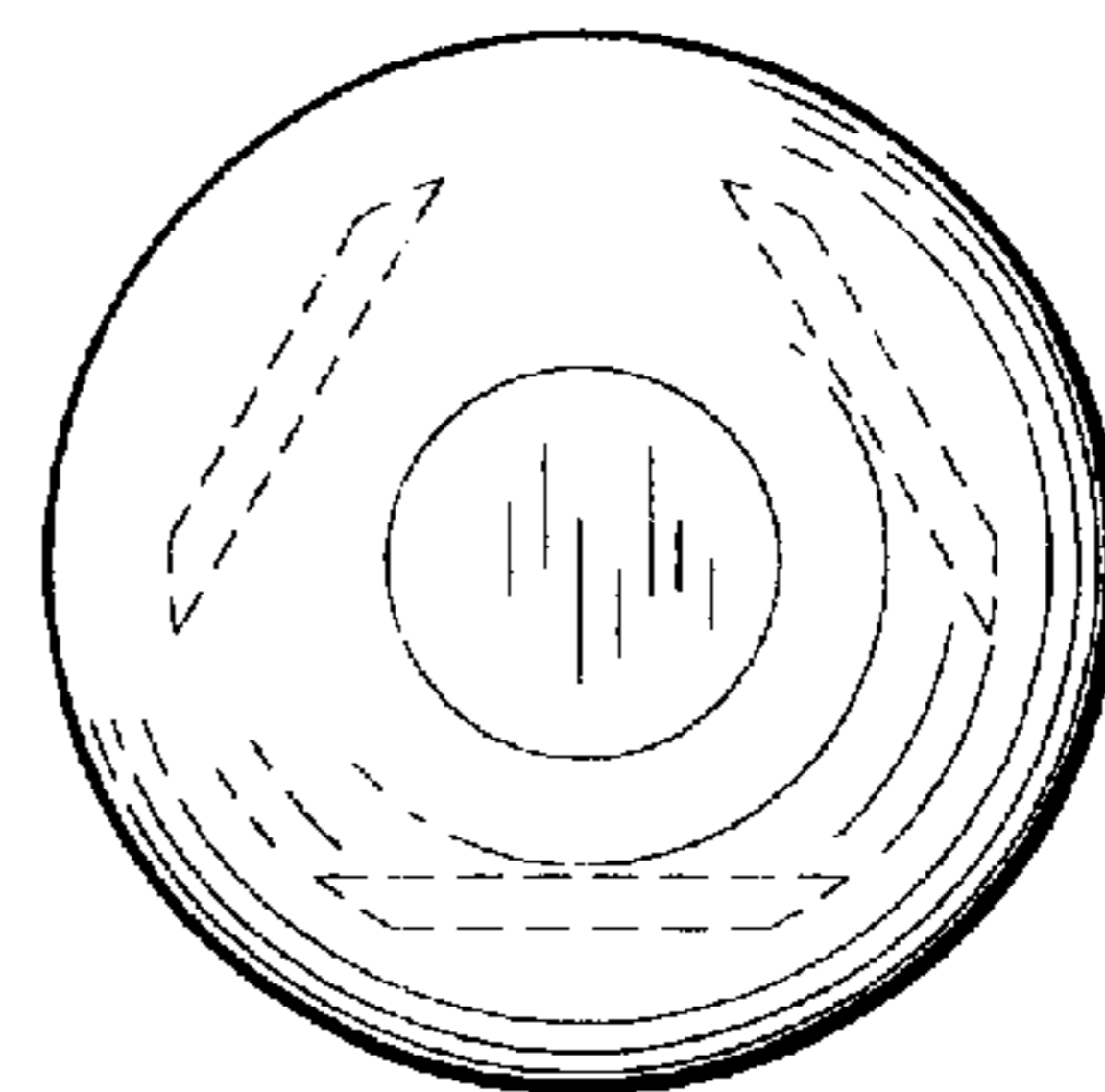
