The ornamental design for a video printer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a video printer showing my new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a left side elevational view thereof;
 FIG. 4 is a front elevational view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a right side elevational view thereof; and
 FIG. 7 is a rear elevational view thereof.
 FIG. 8 is a perspective view of a second embodiment of a video printer showing my new design;
 FIG. 9 is a top plan view of FIG. 8;
 FIG. 10 is a left side elevational view of FIG. 8;

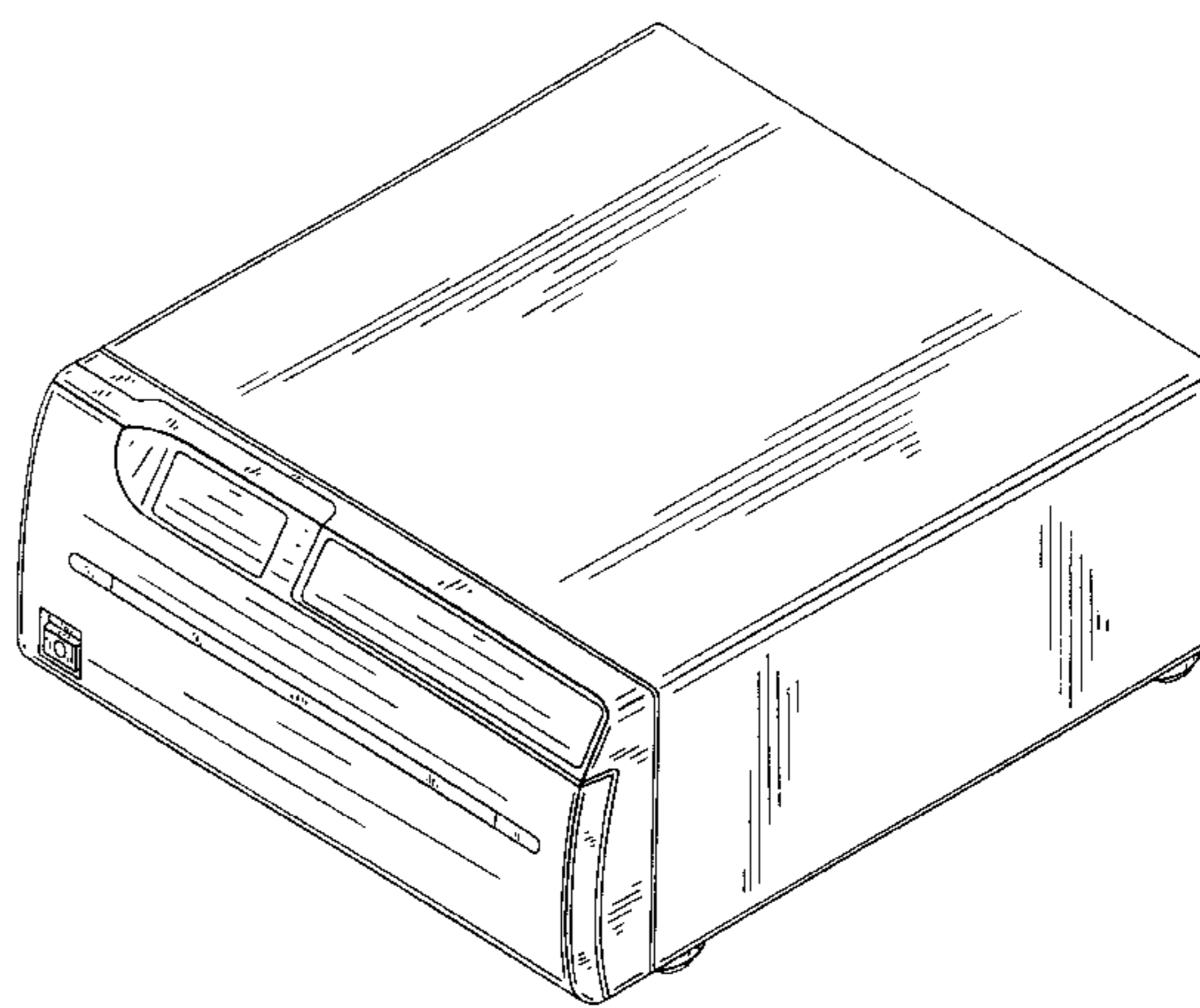
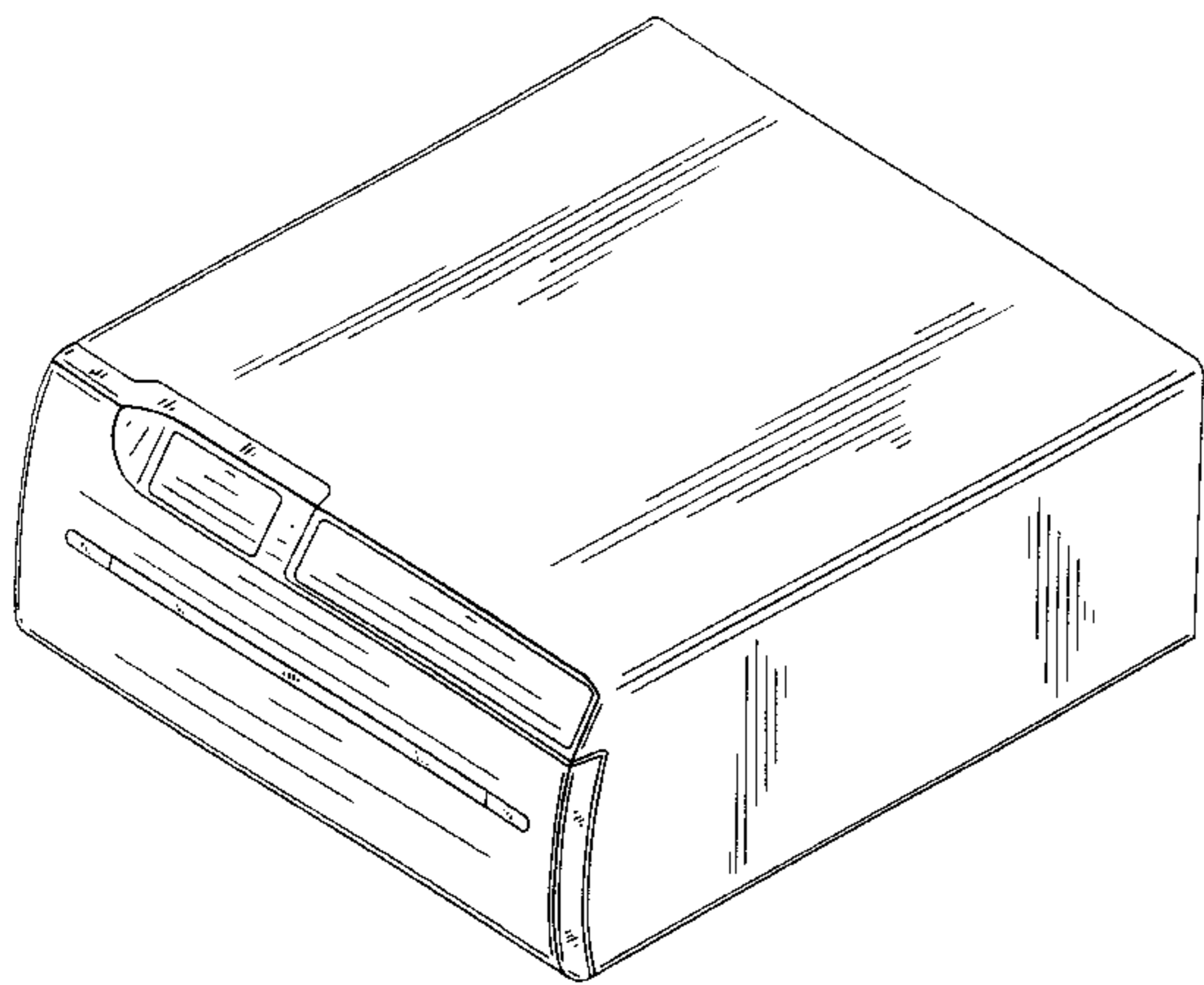

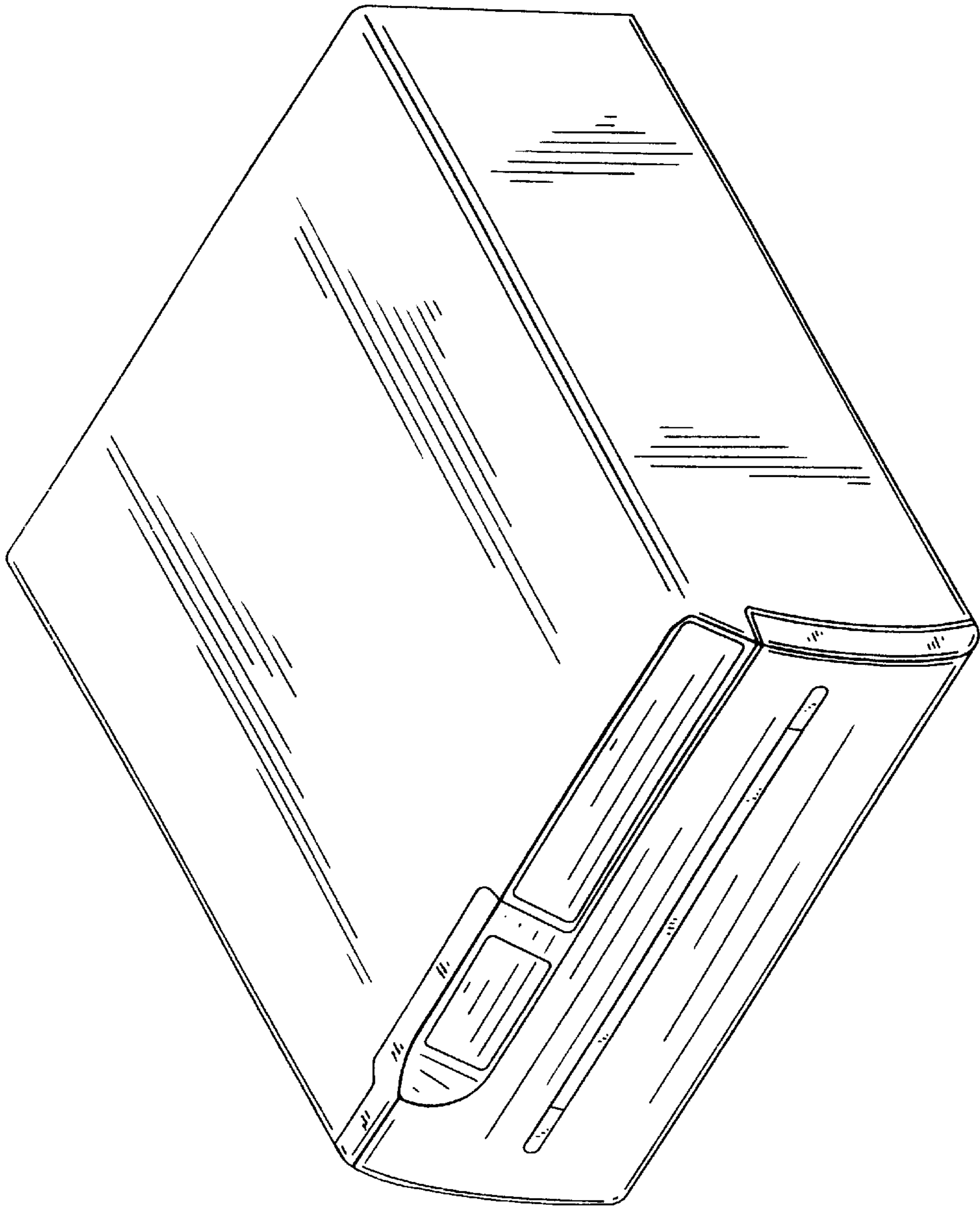

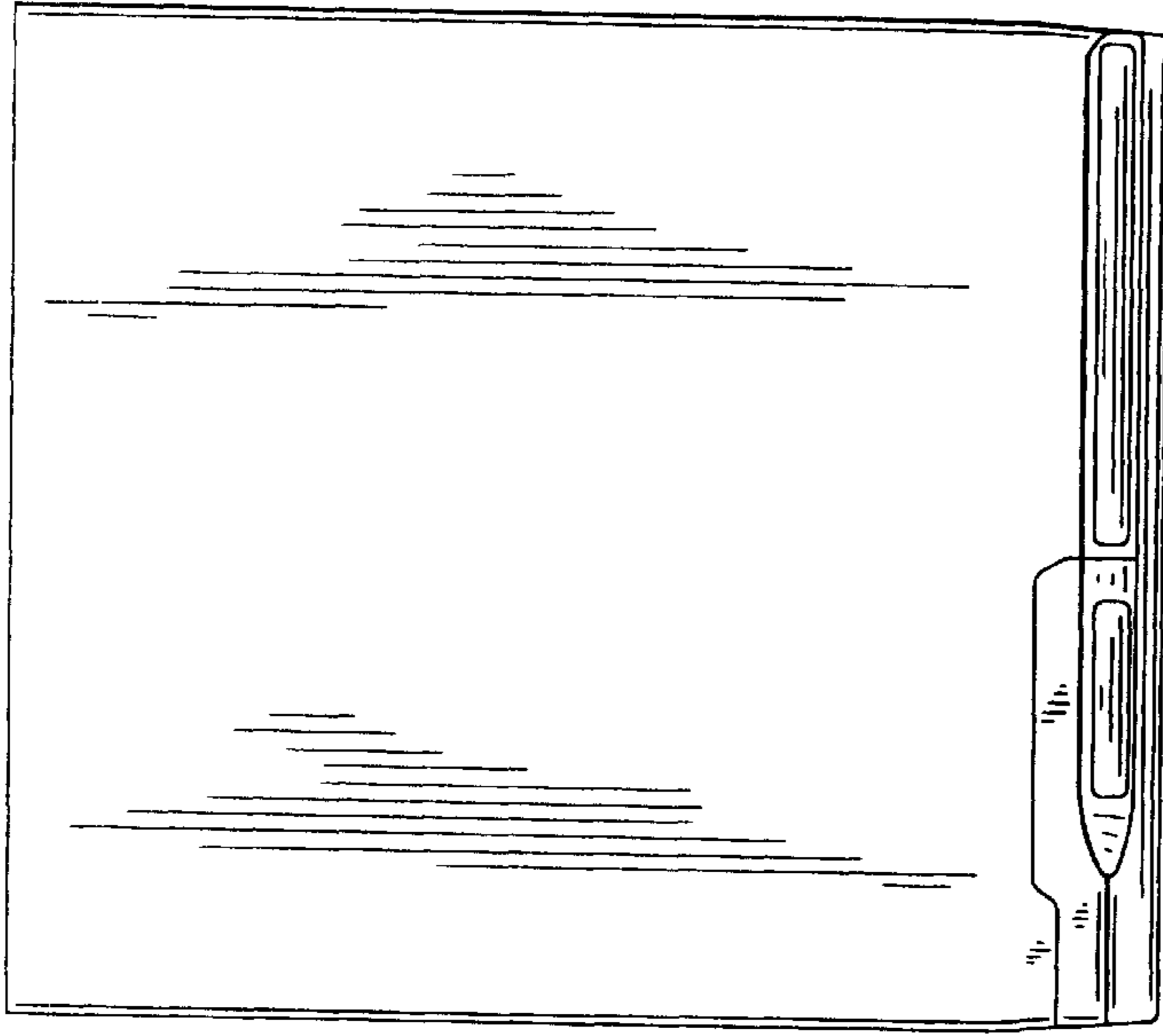

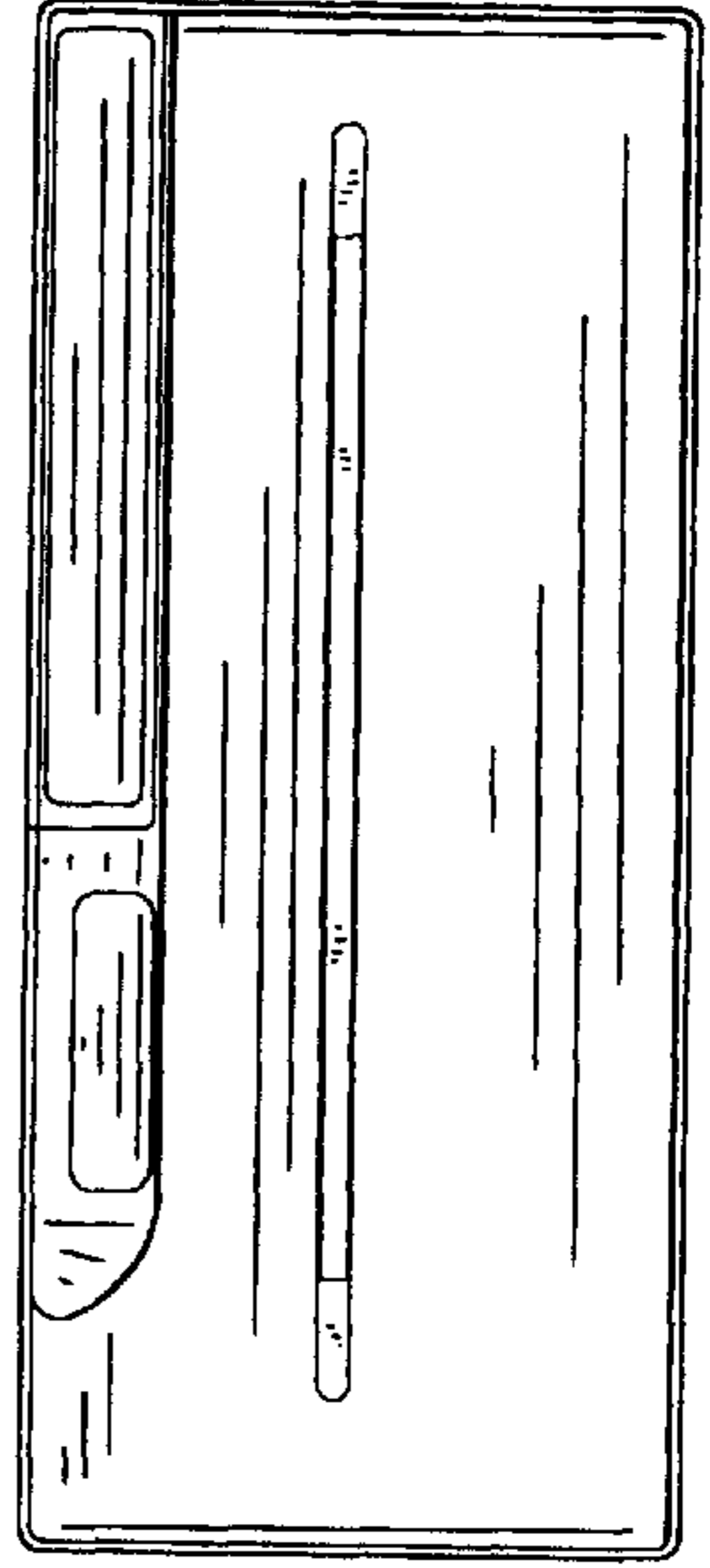

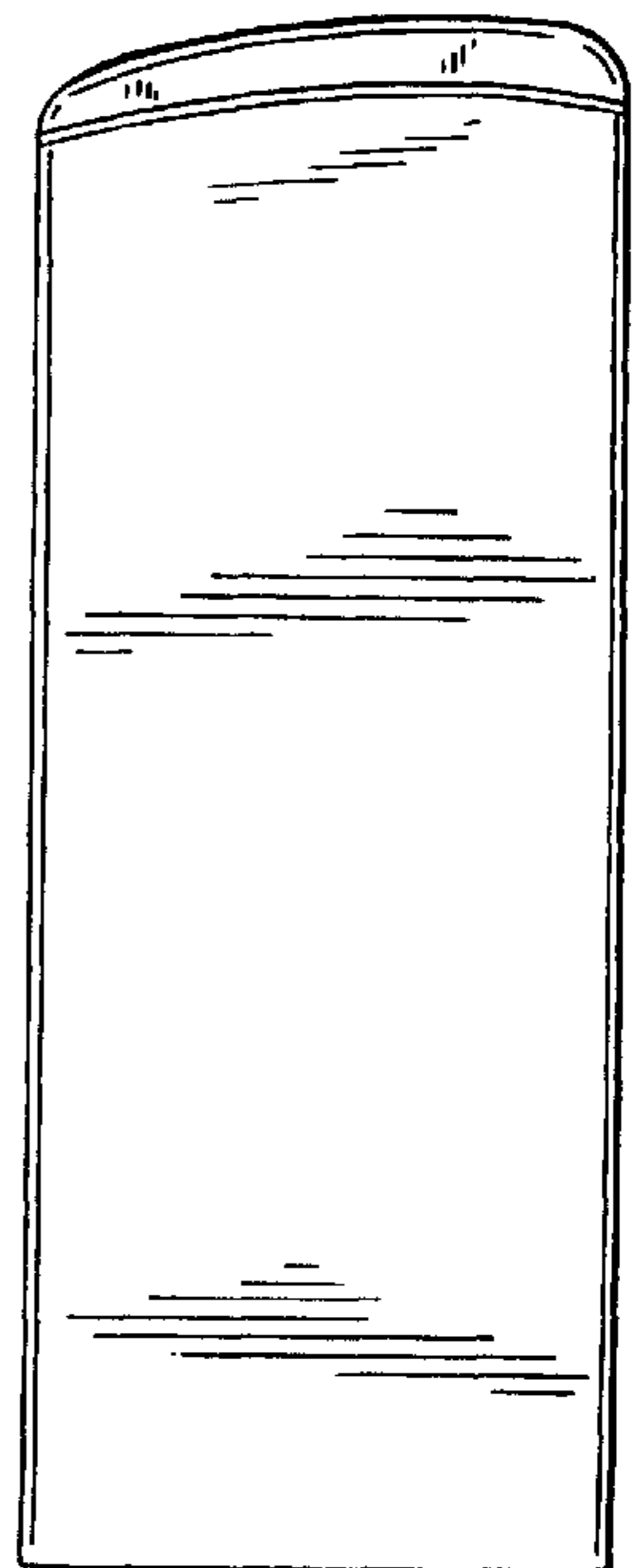

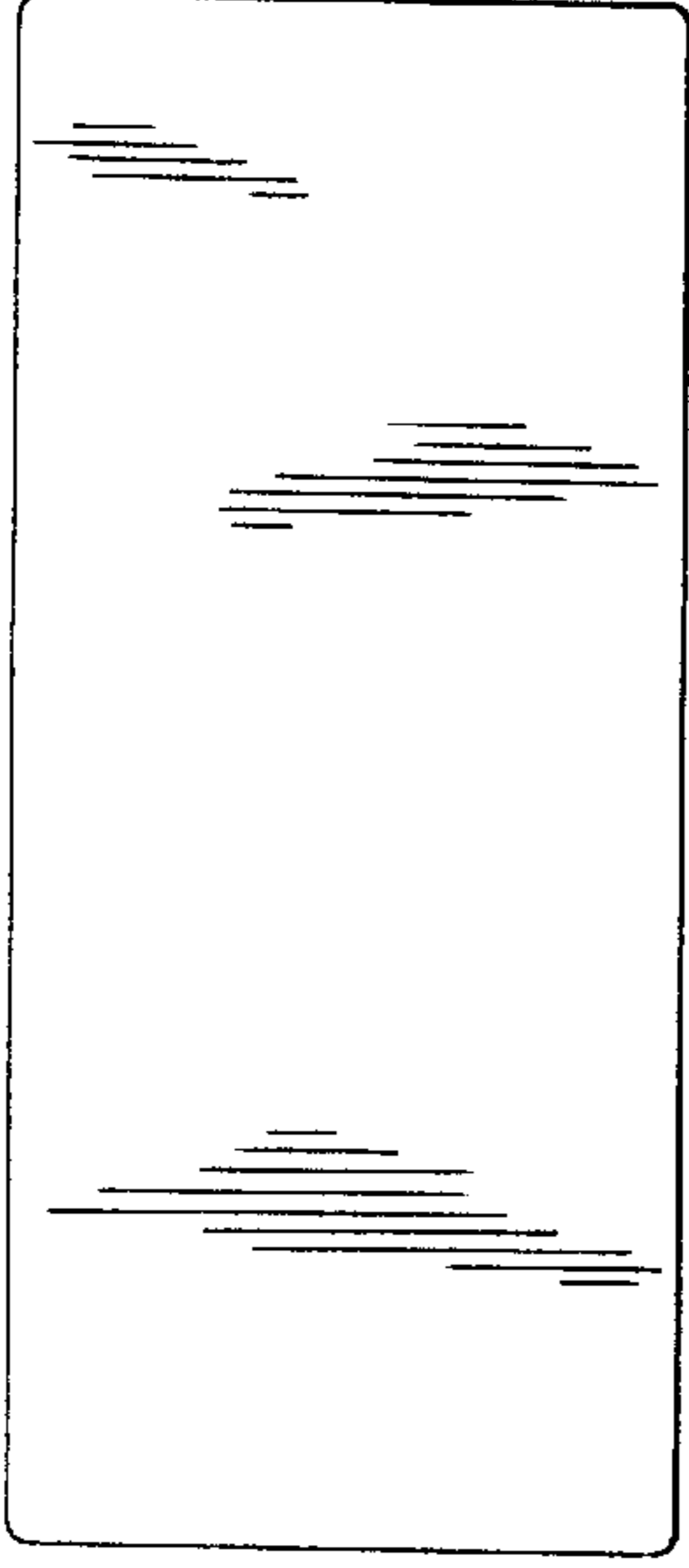

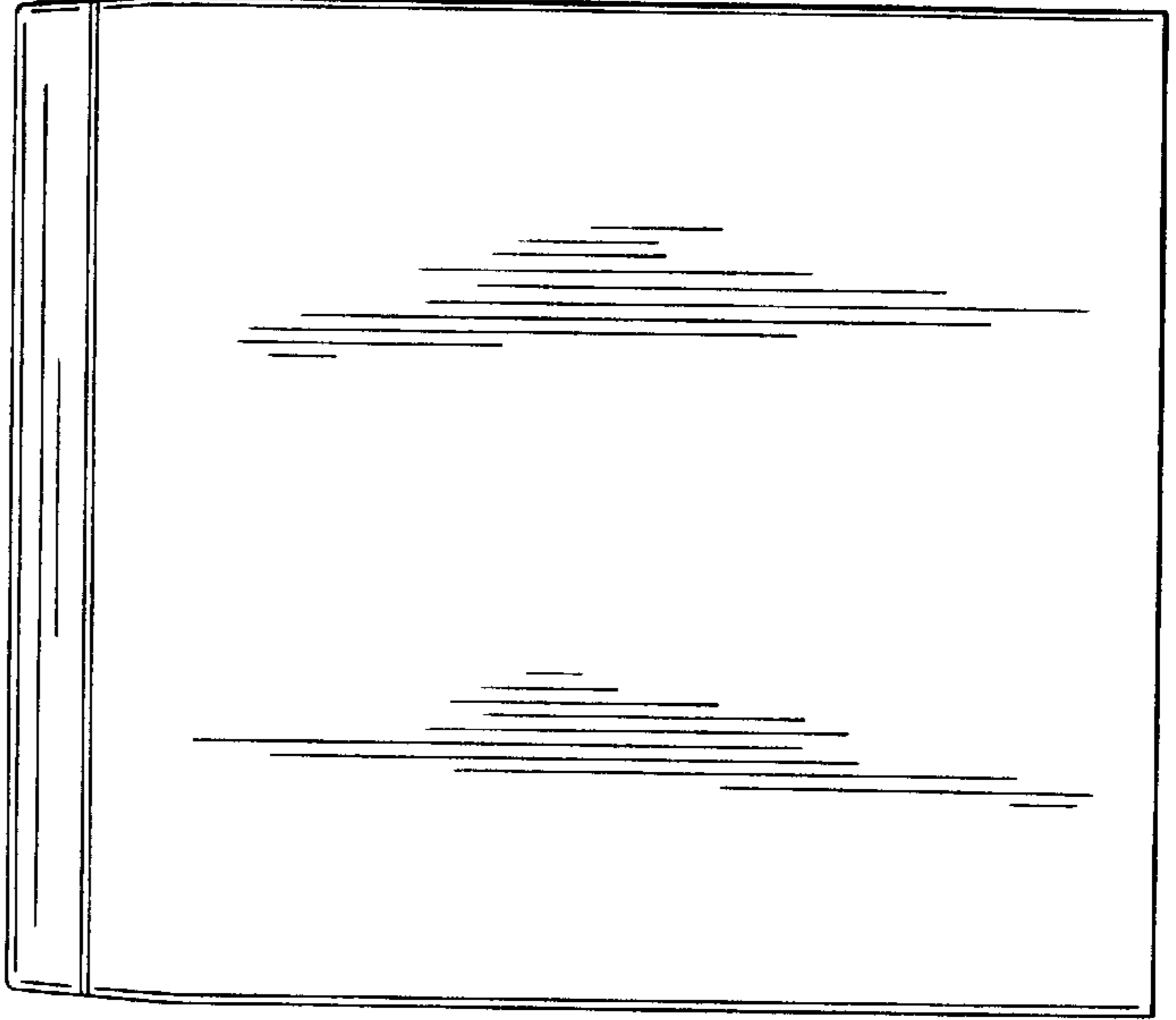

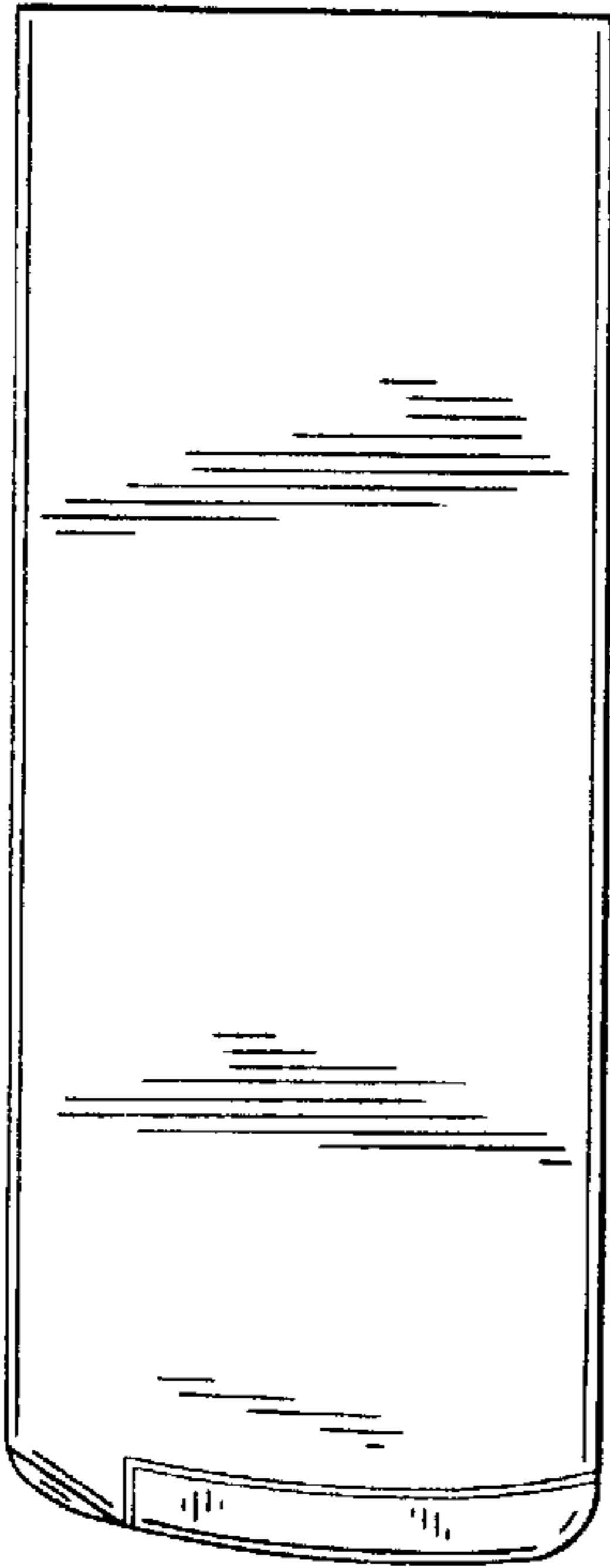

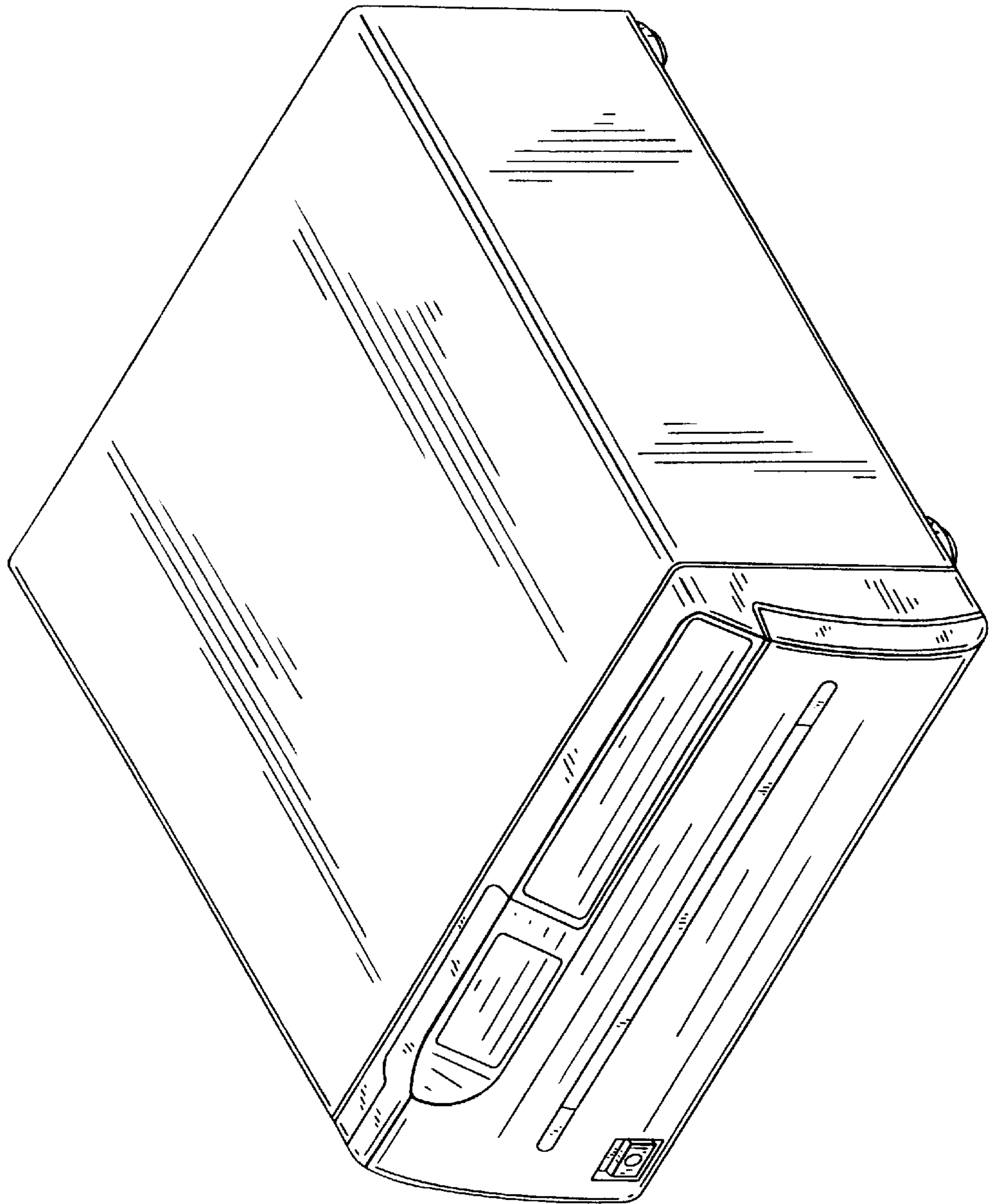

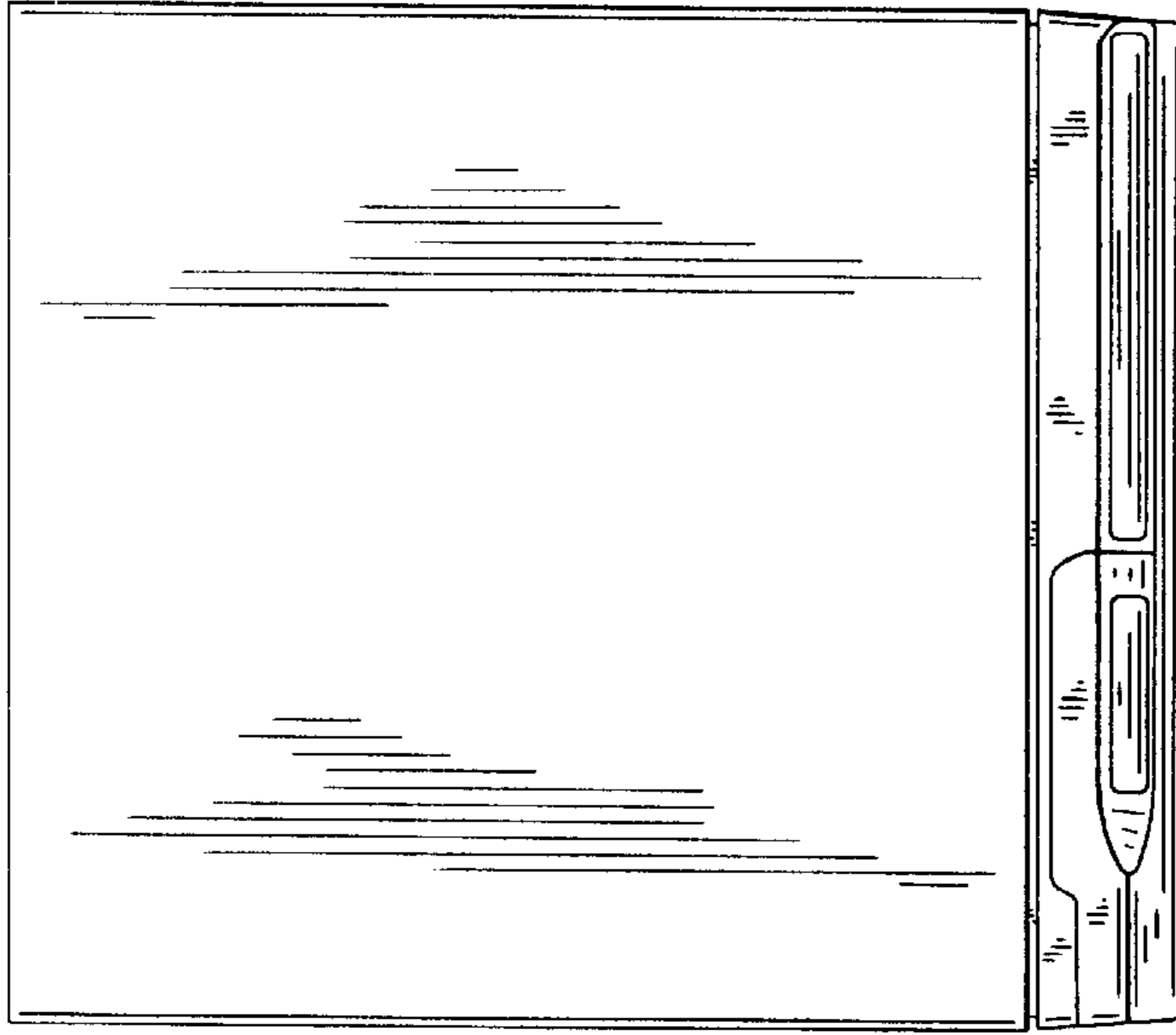

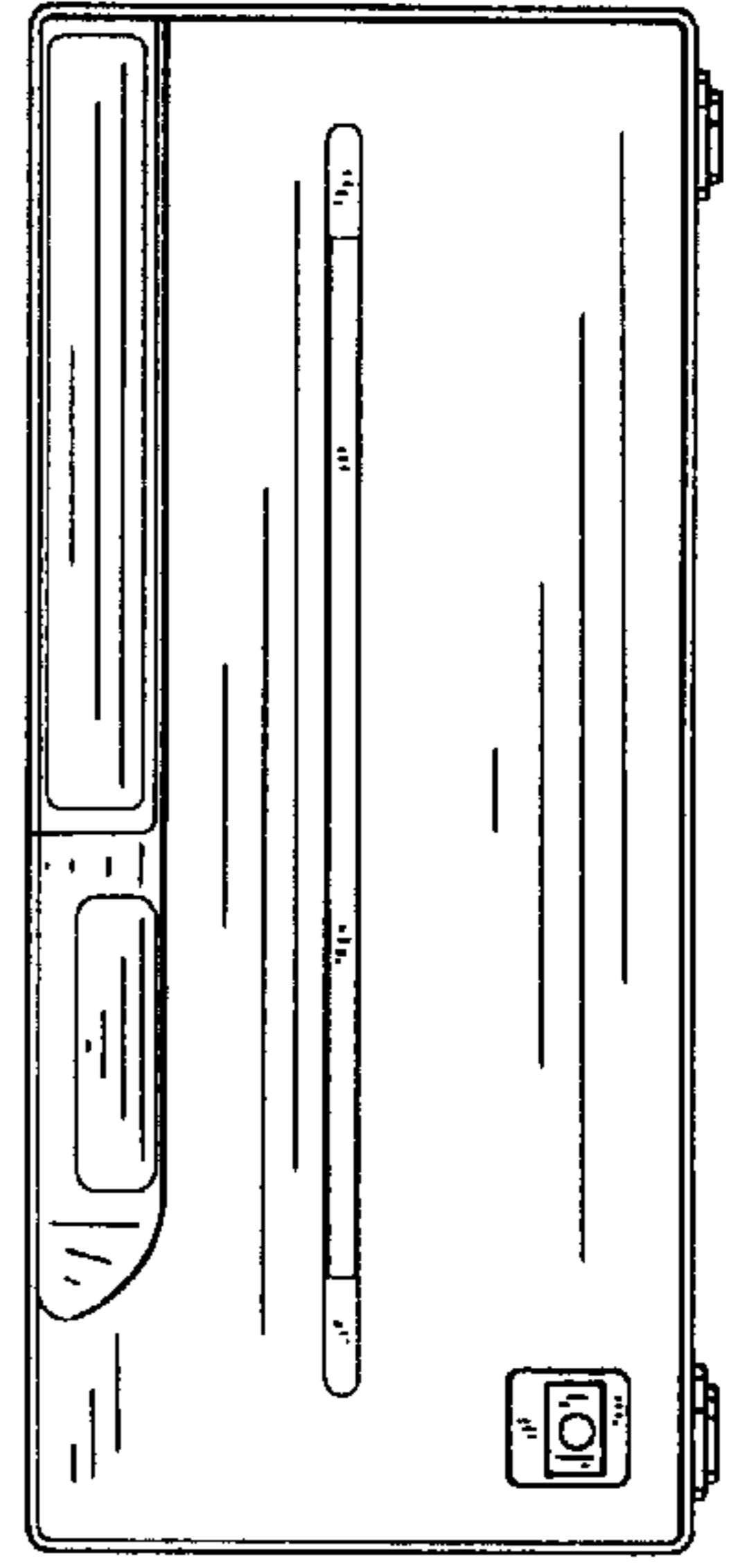

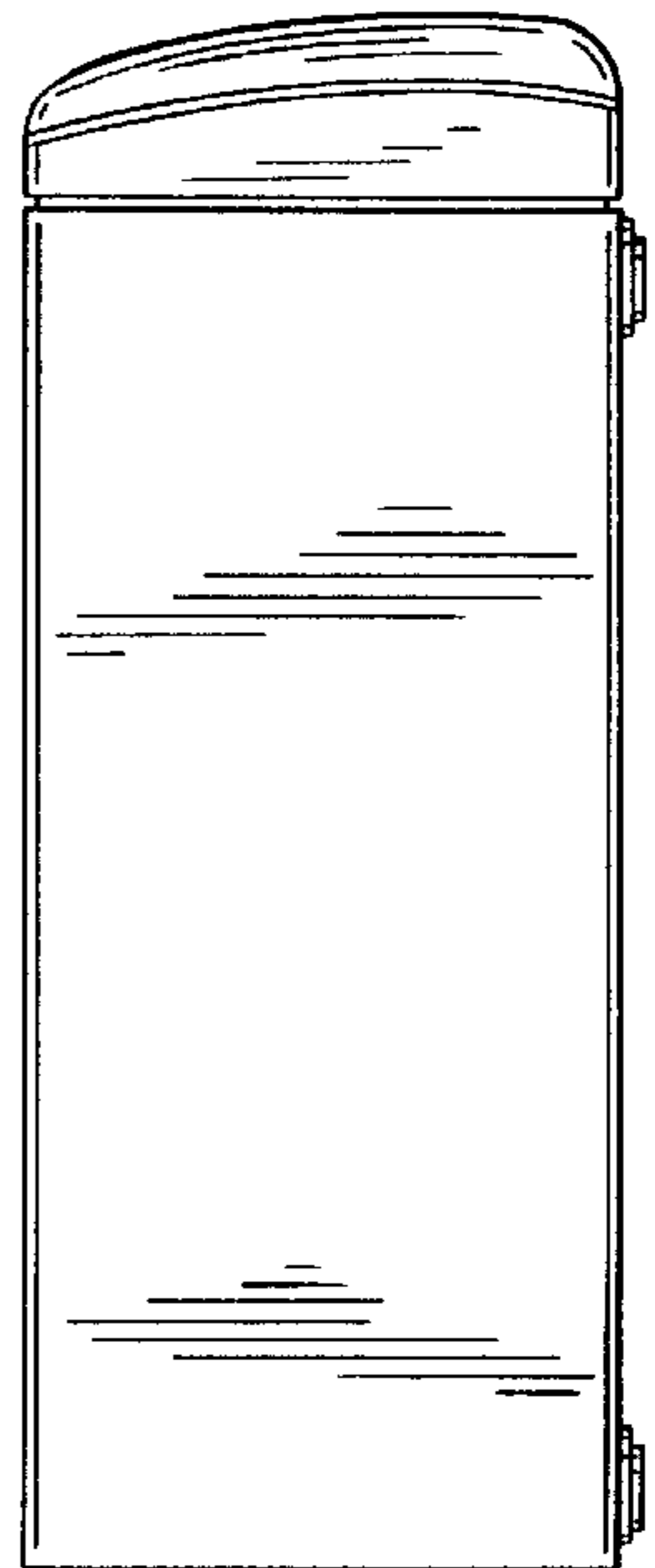

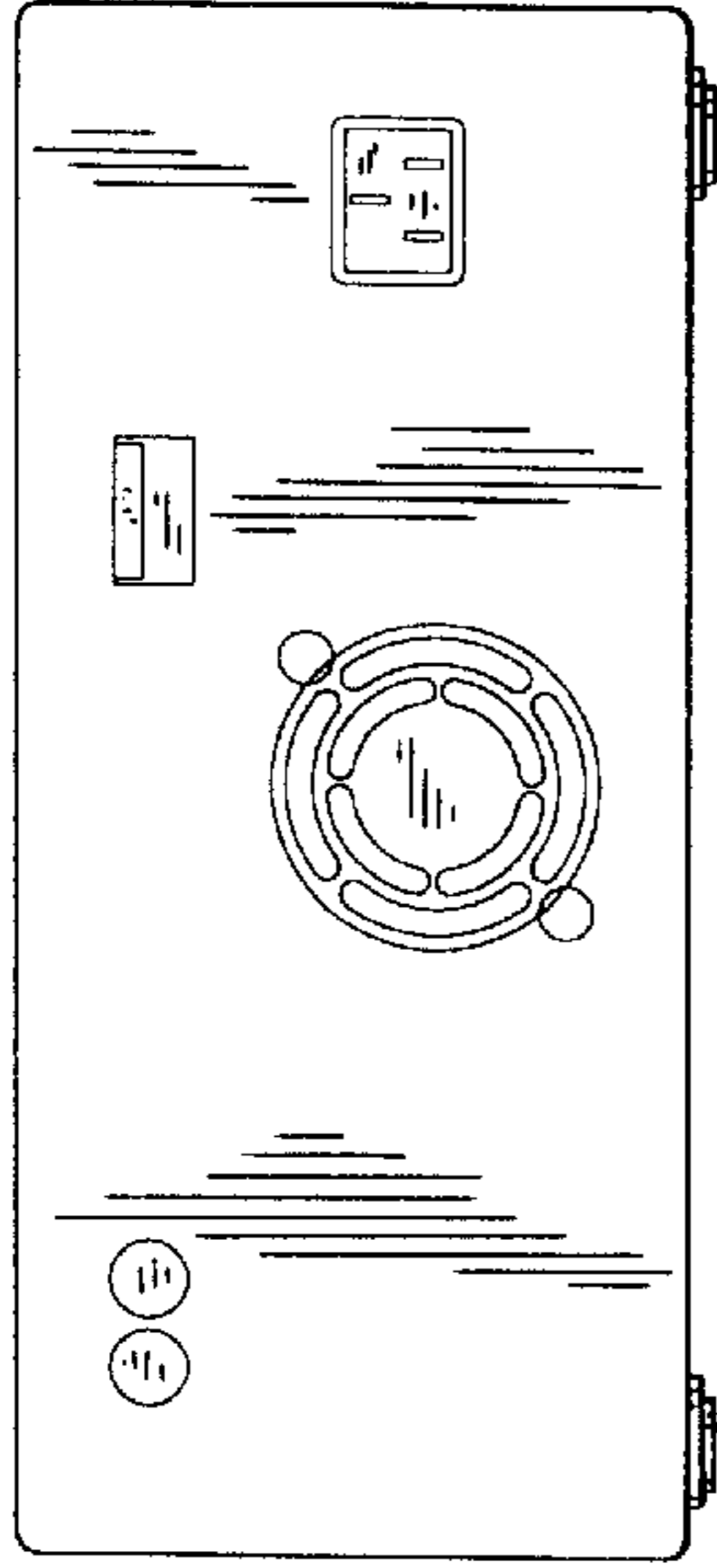

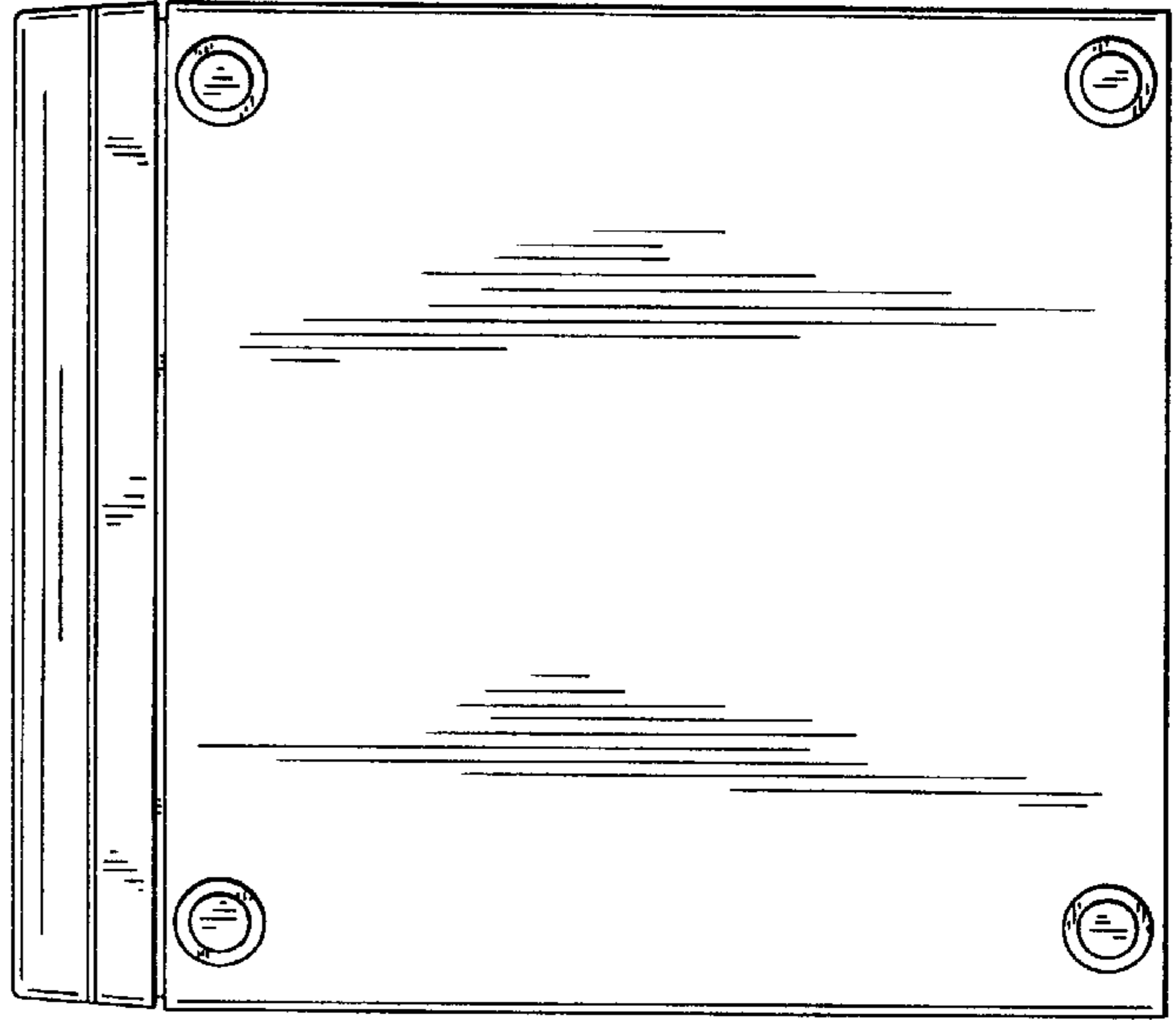
