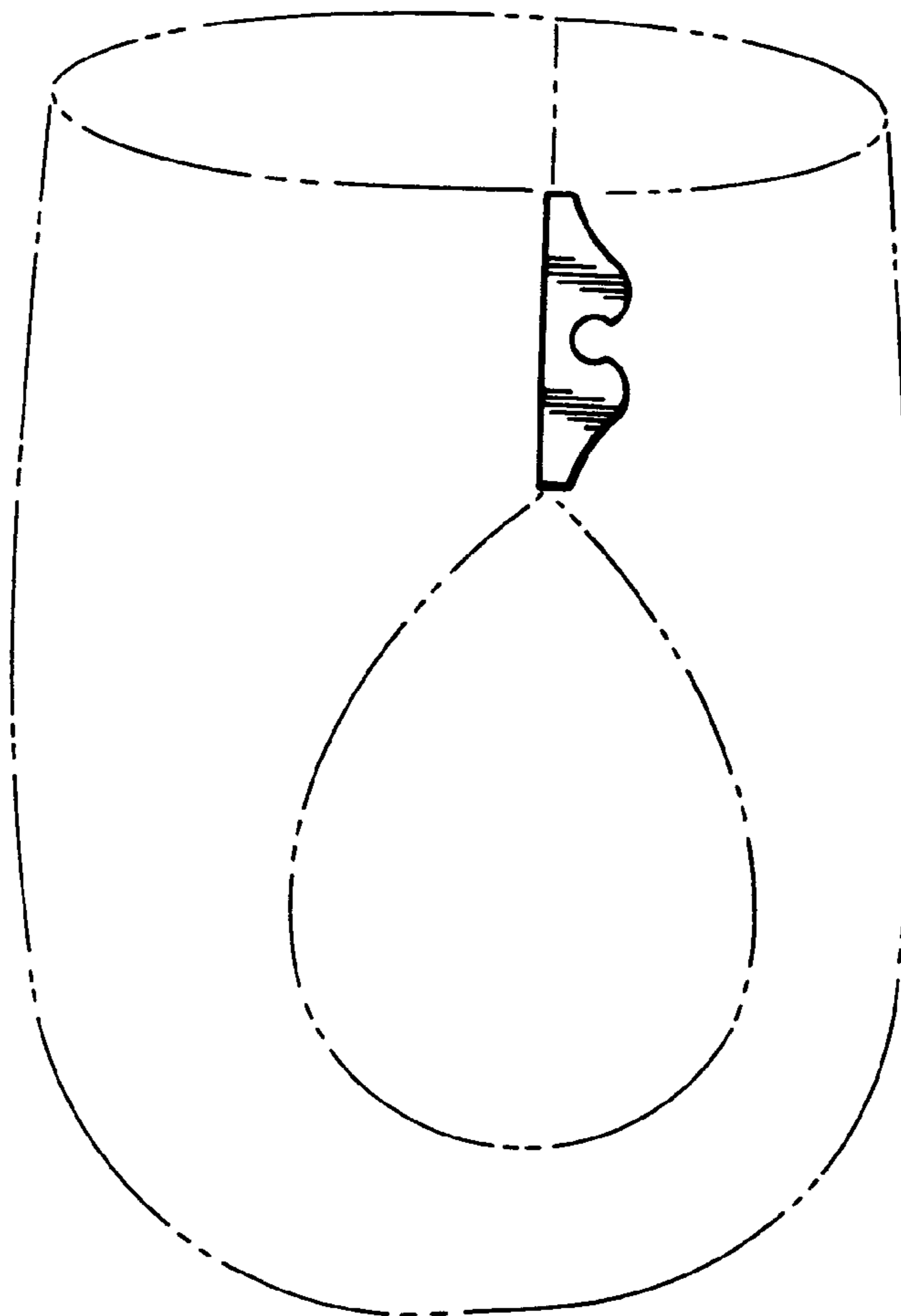
[57] **CLAIM**

We claim the ornamental design for a garment fastener for a disposable absorbent article, as shown and described.

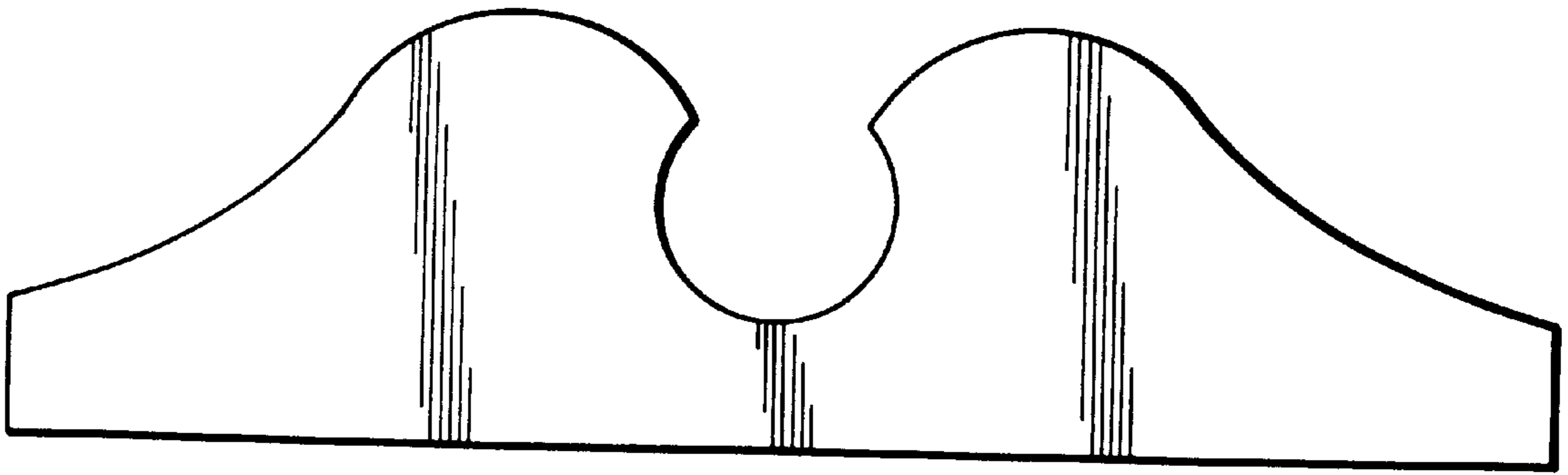

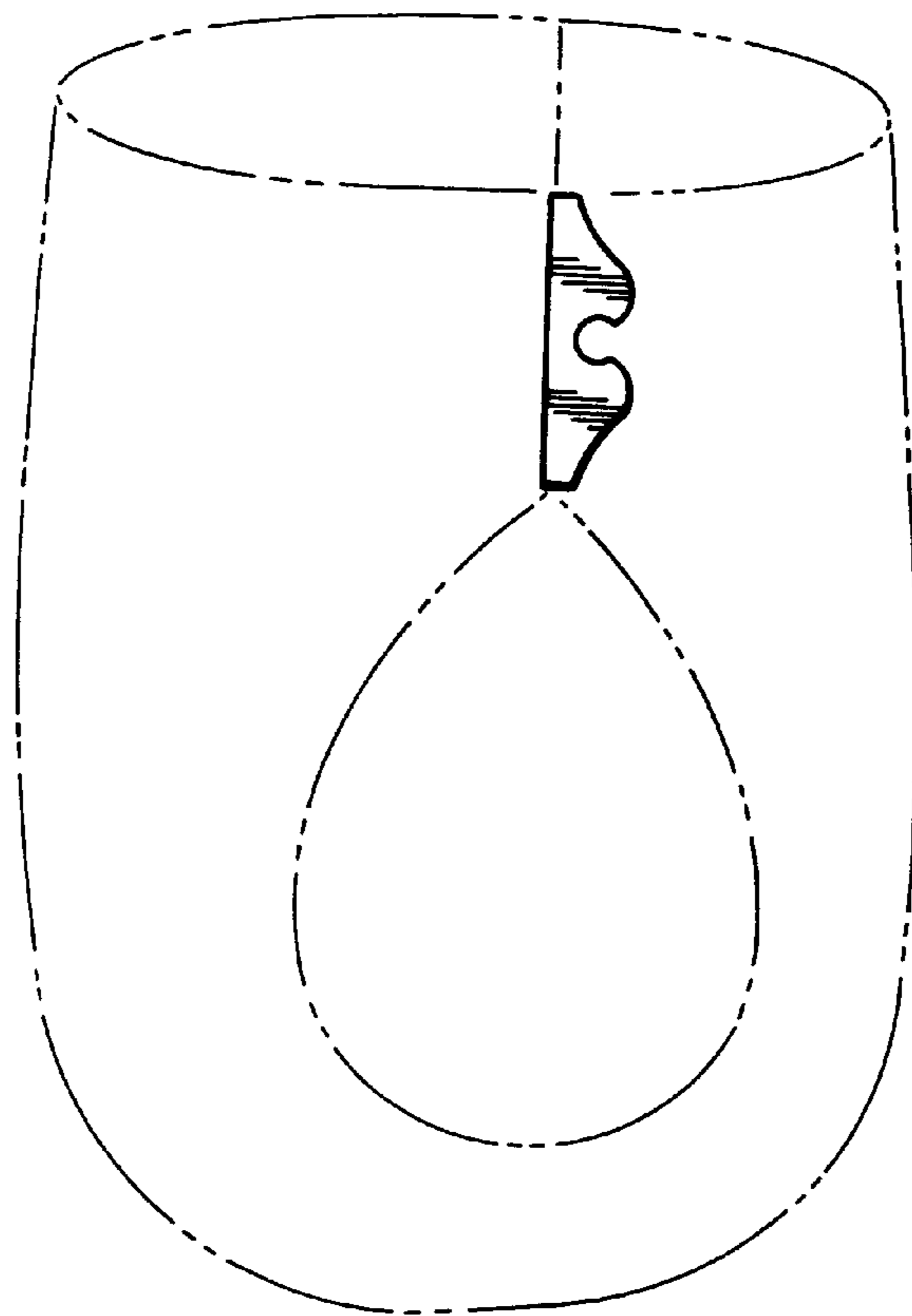
