[57] **CLAIM**

The ornamental design for a food piece, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a food piece showing my new design;

FIG. 2 is a top plan view of the food piece depicted in FIG. 1;

FIG. 3 is a bottom plan view of the food piece depicted in FIG. 2;

FIG. 4 is a front elevational view of the food piece depicted in FIG. 2;

FIG. 5 is a side elevational view of the food piece depicted in FIG. 2;

FIG. 6 is a rear elevational view of the food piece depicted in FIG. 2, said rear elevational view being opposite the front elevational view depicted in FIG. 4;

FIG. 7 is a side elevational view of the food piece depicted in FIG. 2, said side elevational view being opposite the side elevational view depicted in FIG. 5; and,

FIG. 8 is a fragmentary cross-sectional view taken along line 8—8 in FIG. 2.

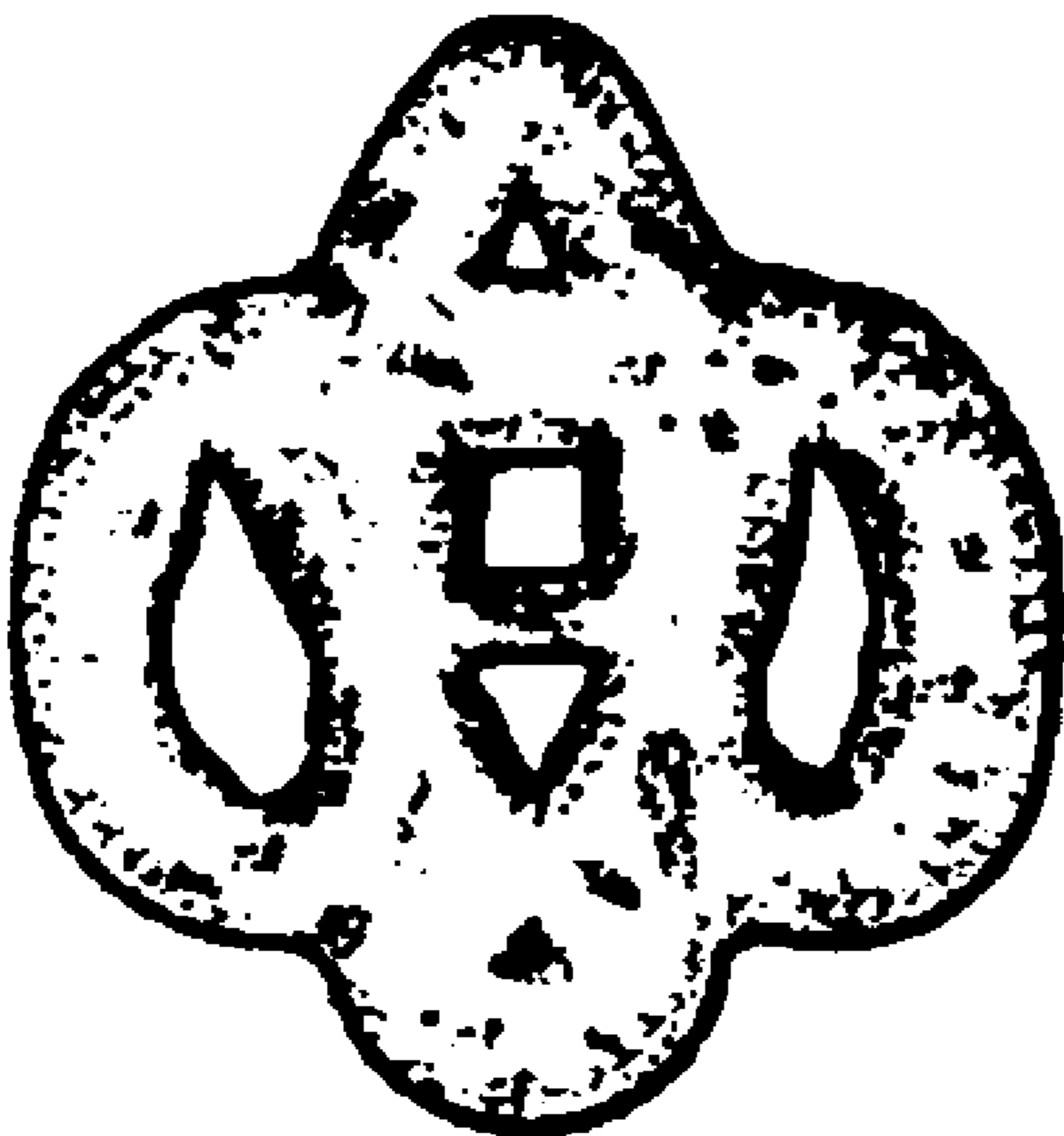

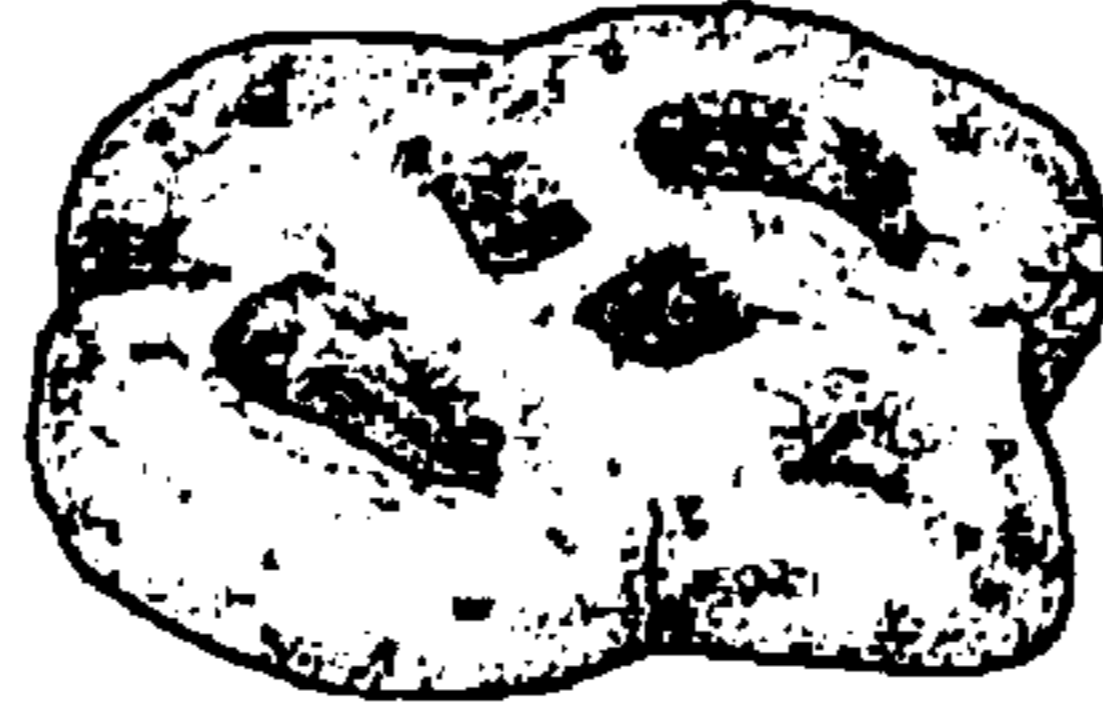

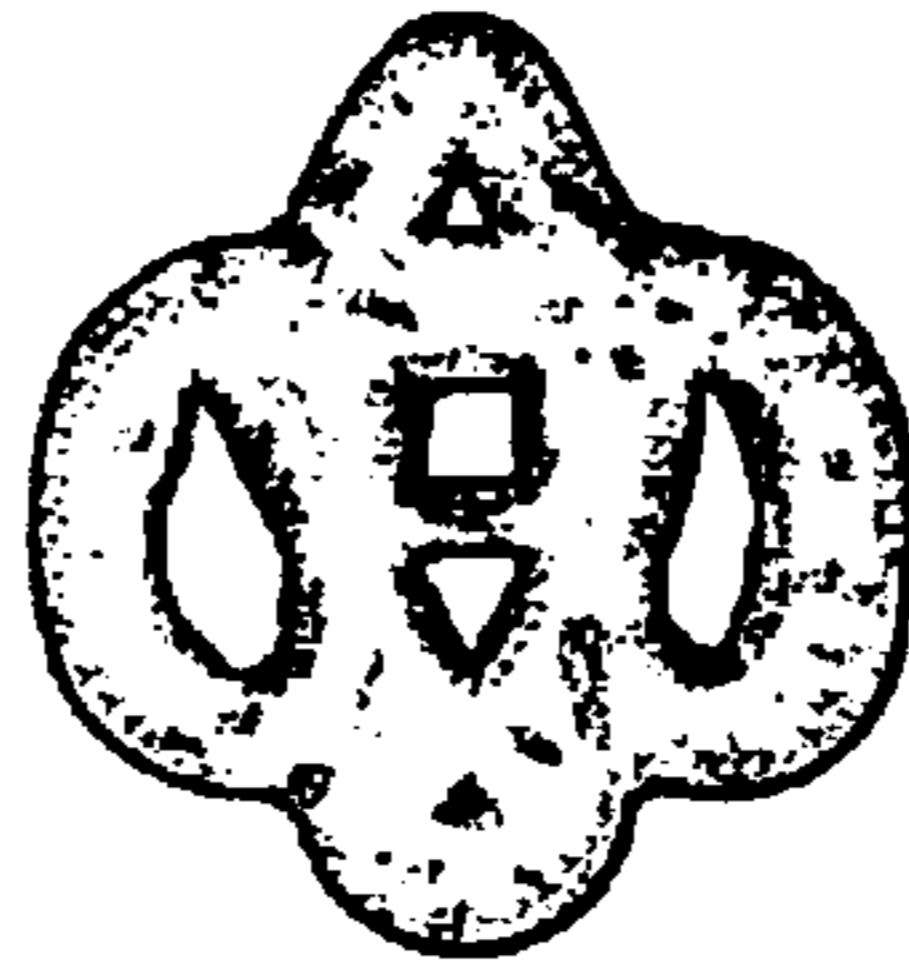

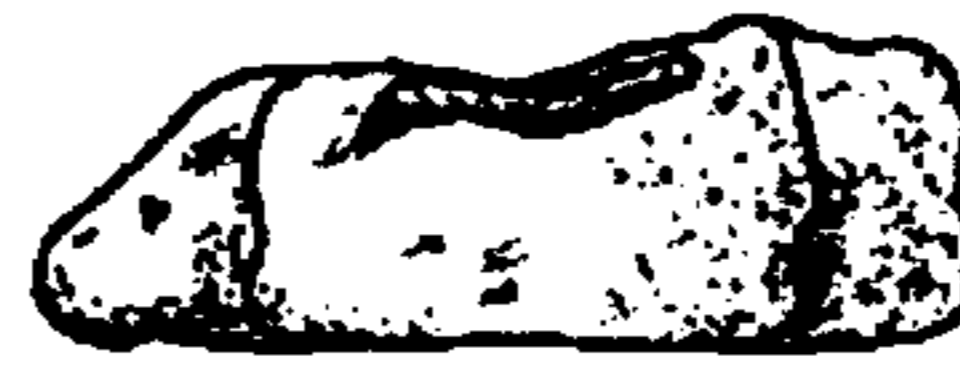
