[57] **CLAIM**

The ornamental design for a bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a first embodiment of a bottle according to the present design; the back elevational view being the same;

FIG. 2 is a right side elevational view thereof; the left side elevational view being the same;

FIG. 3 is a top view thereof;

FIG. 4 is a bottom view thereof;

FIG. 5 is a front elevational view of a second embodiment of the bottle according to the present design; the back elevational view being the same;

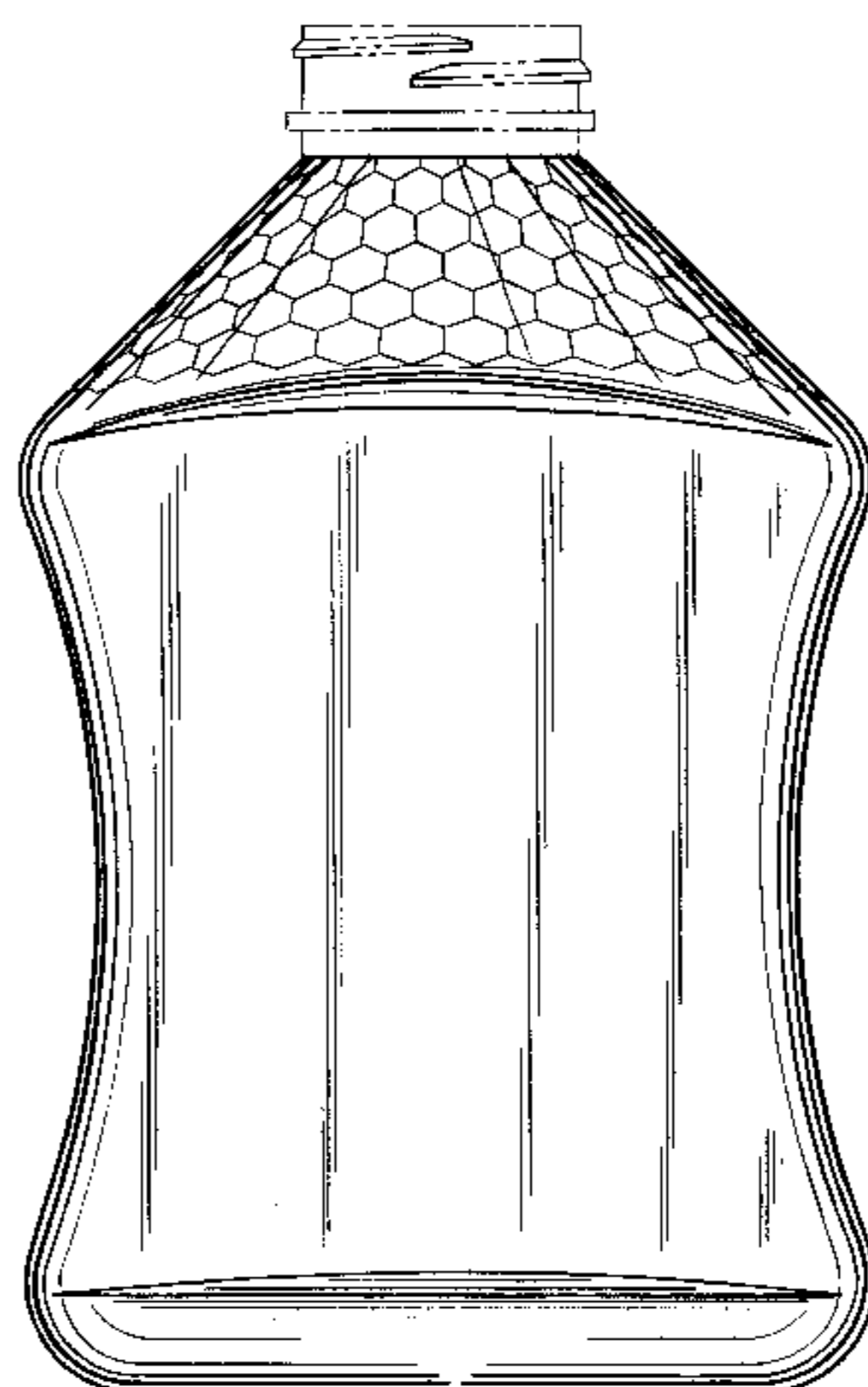
FIG. 6 is a right side elevational view thereof; the left side elevational view being the same;

FIG. 7 is a top view thereof; and,

FIG. 8 is a bottom view thereof.

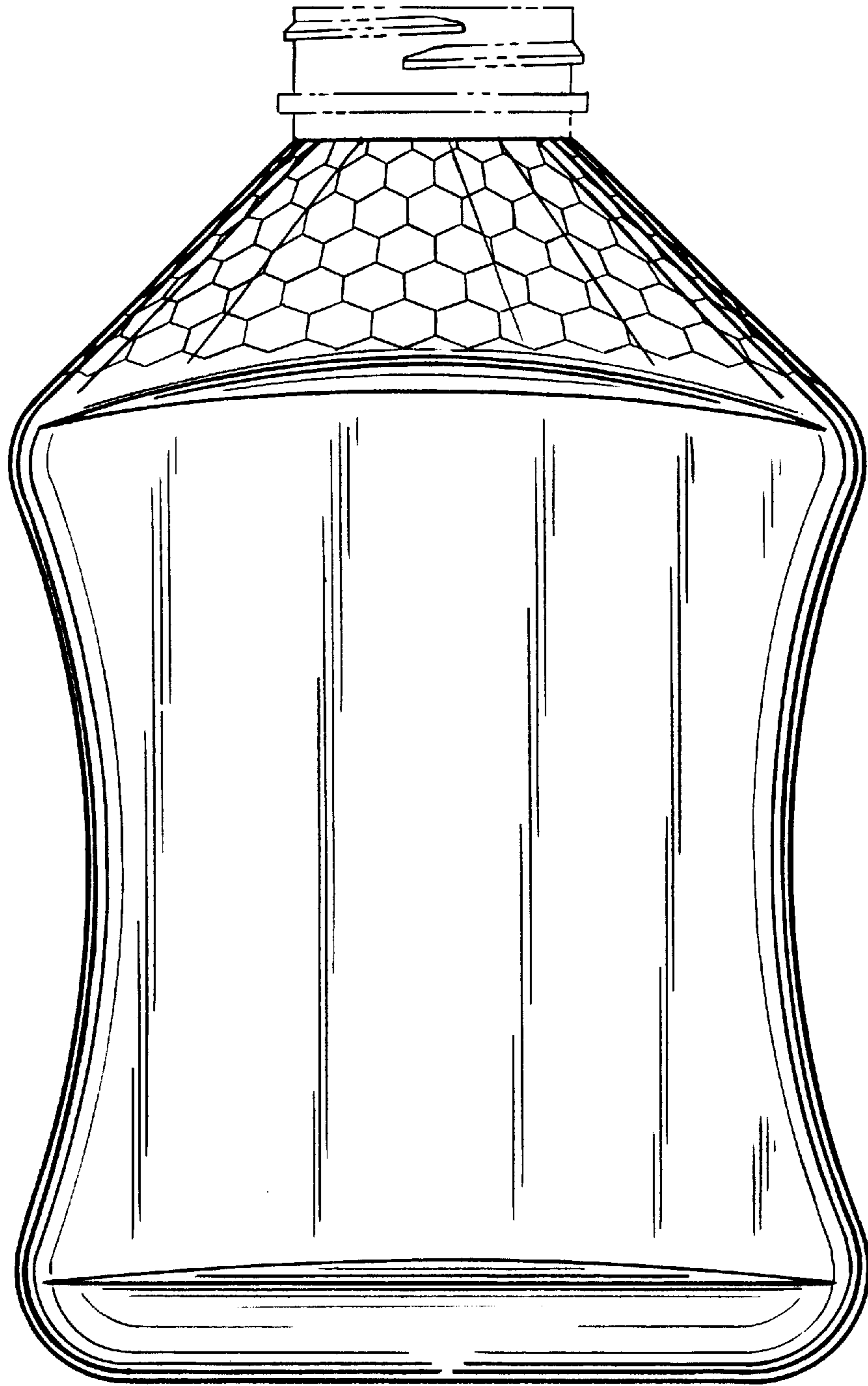

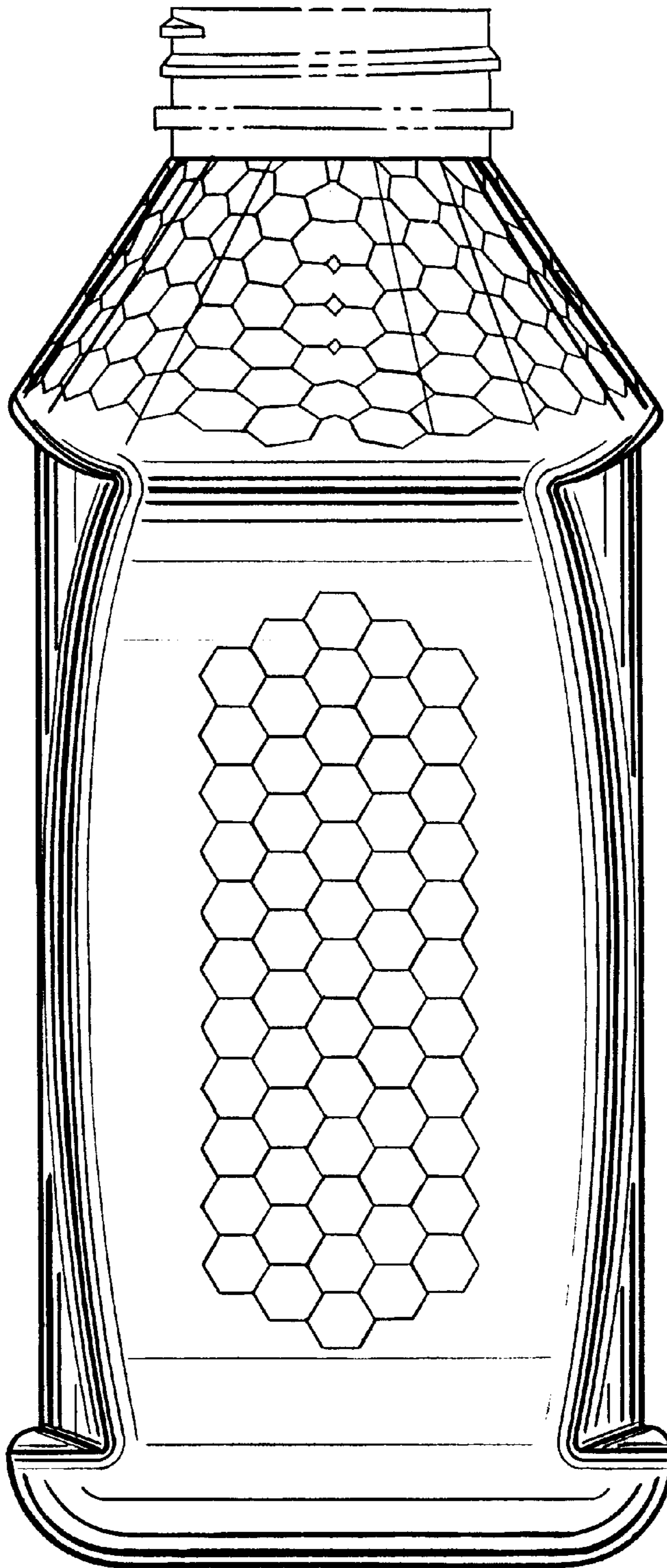

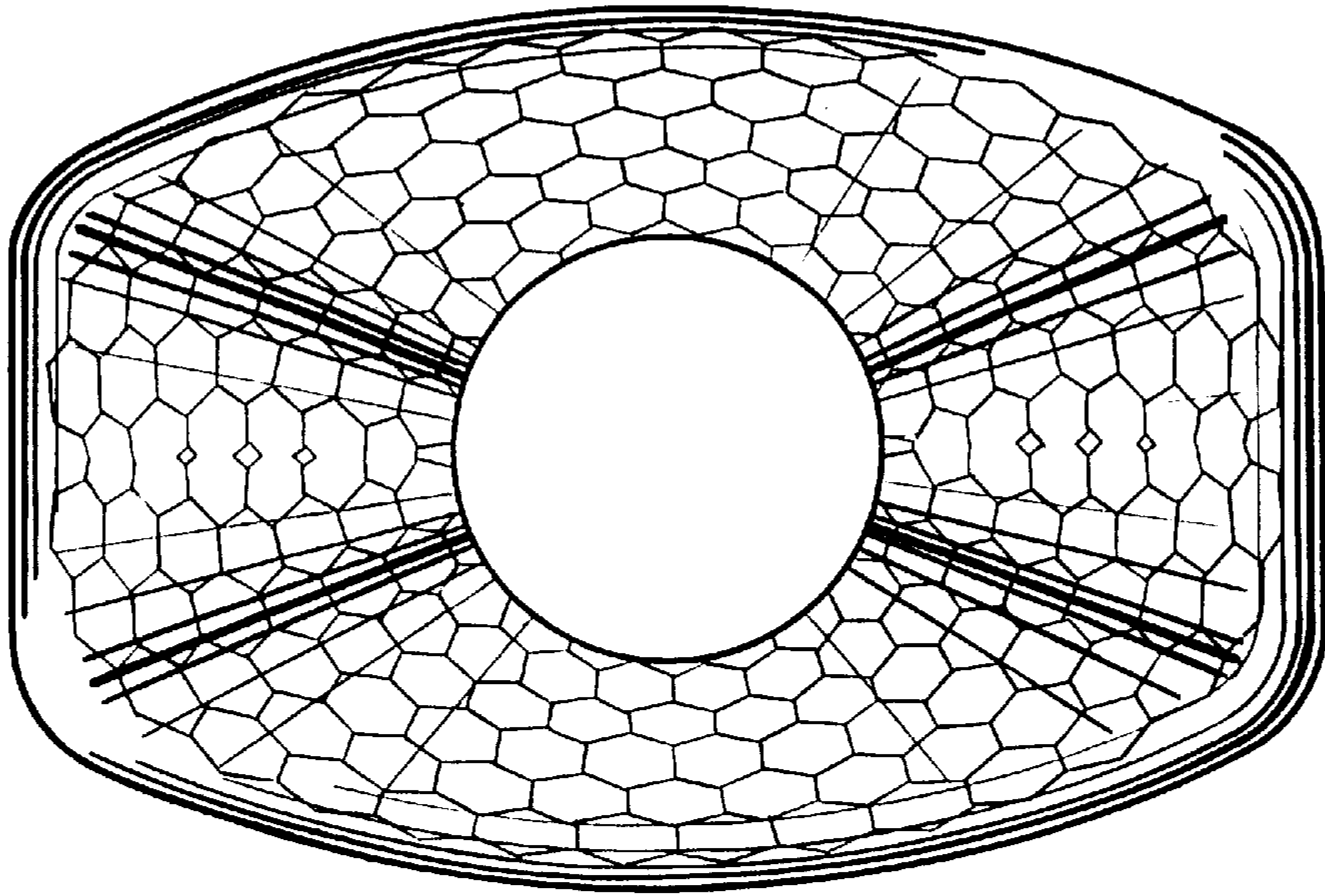

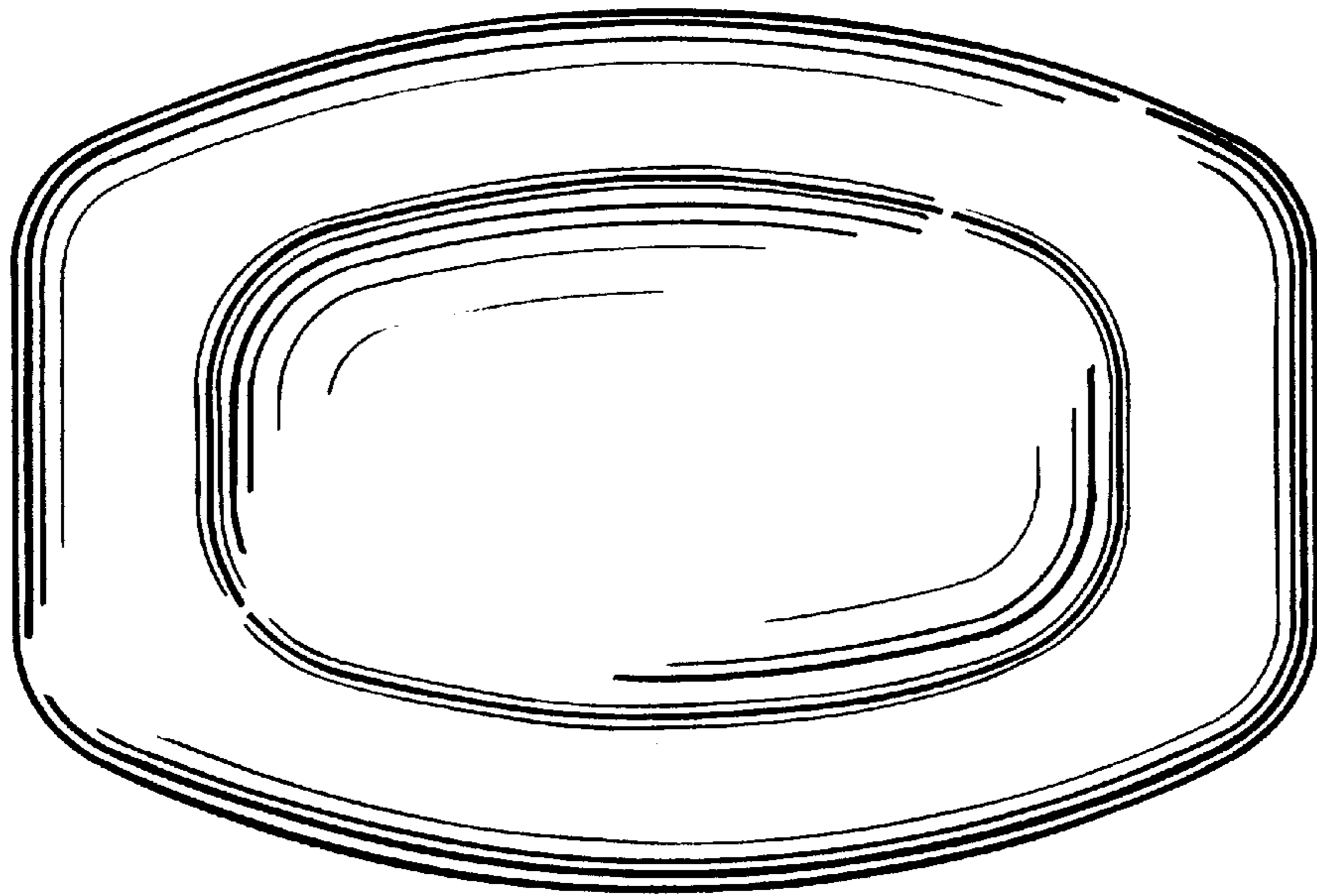

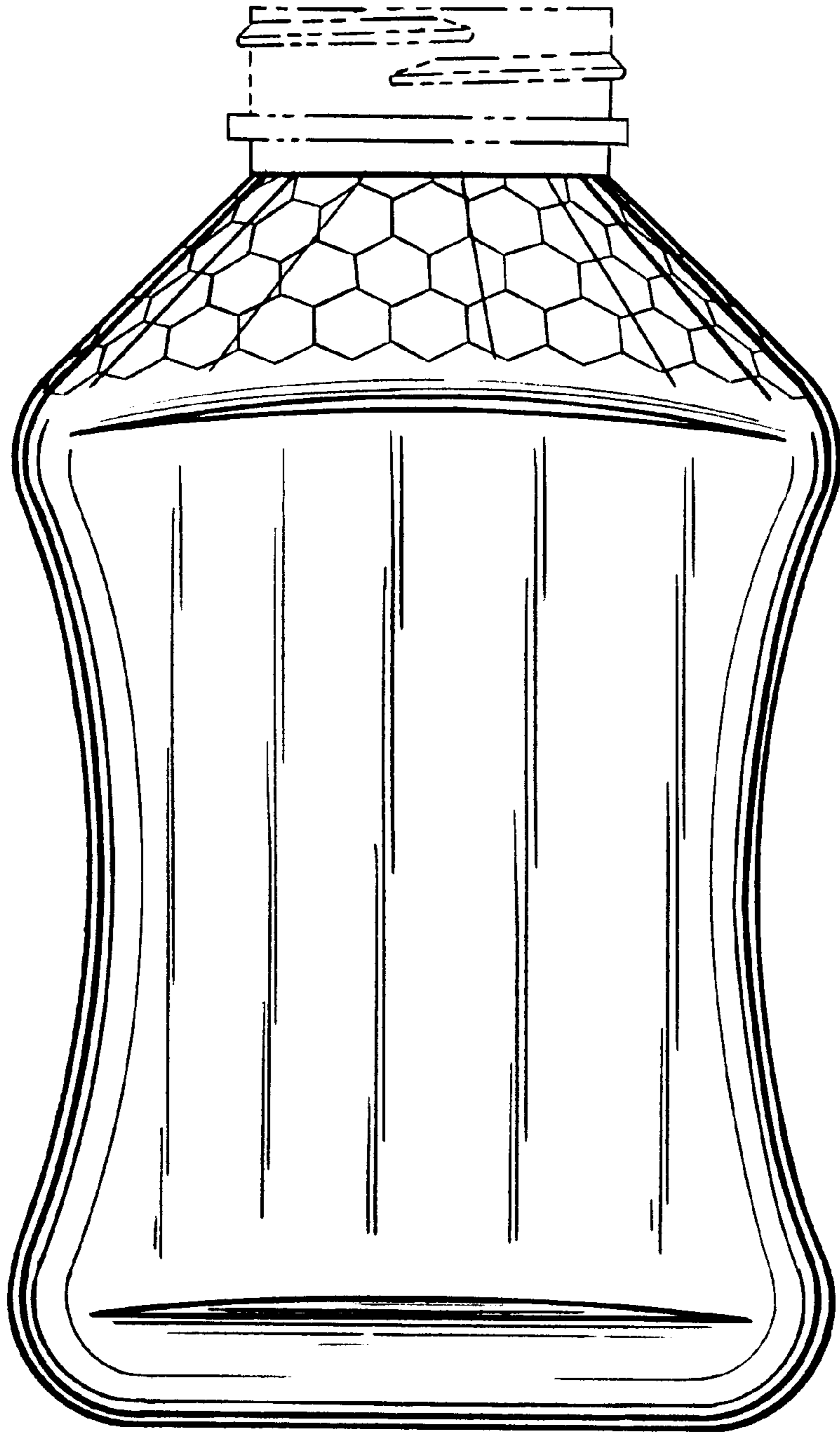

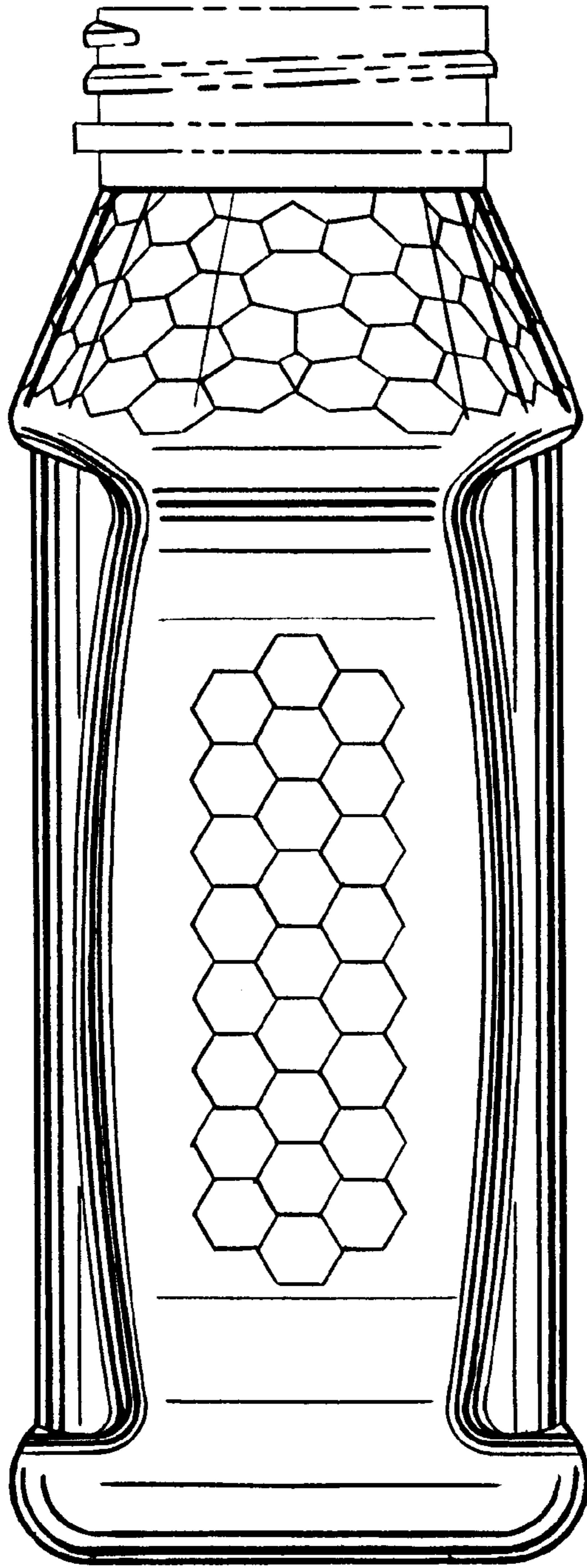

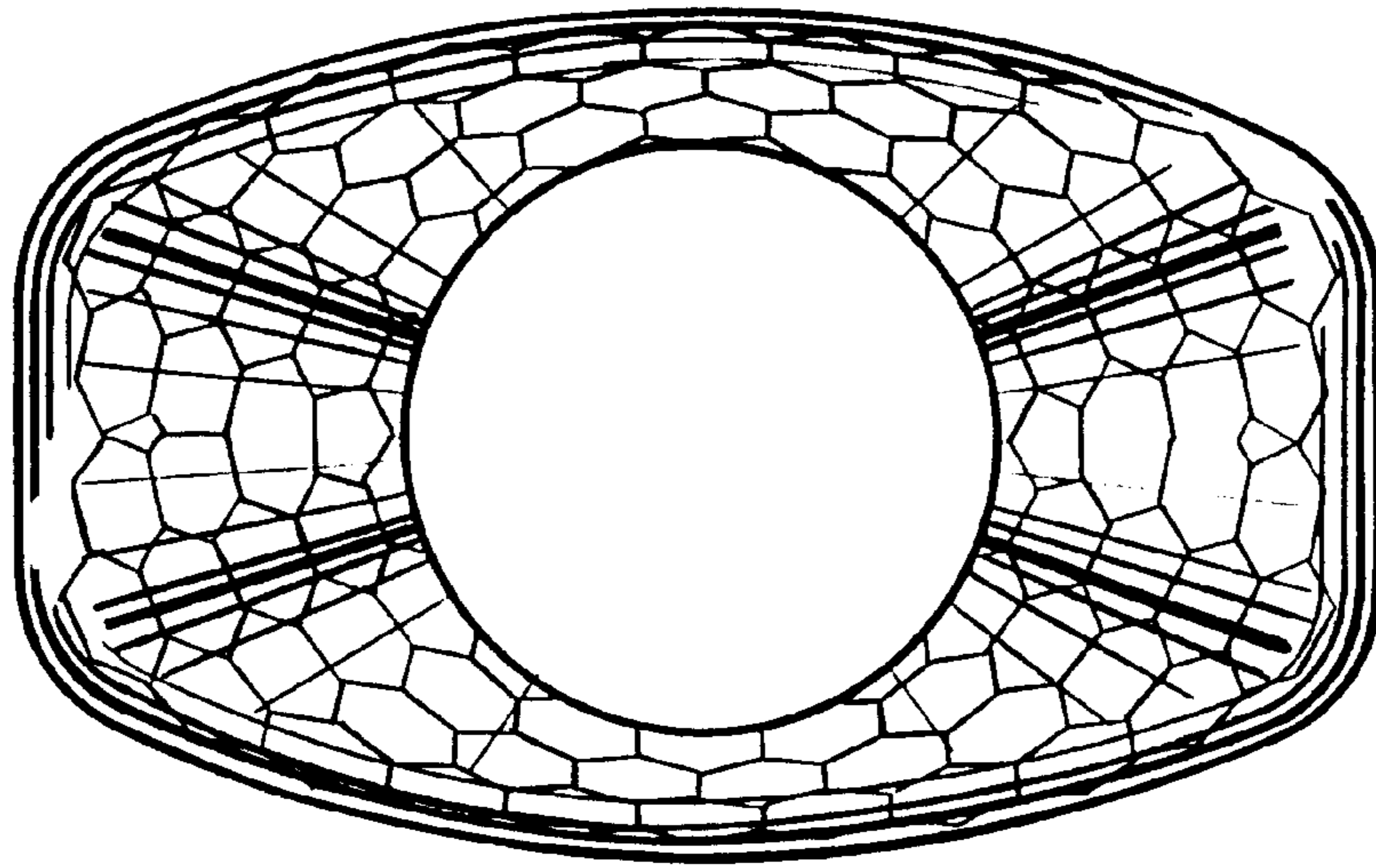

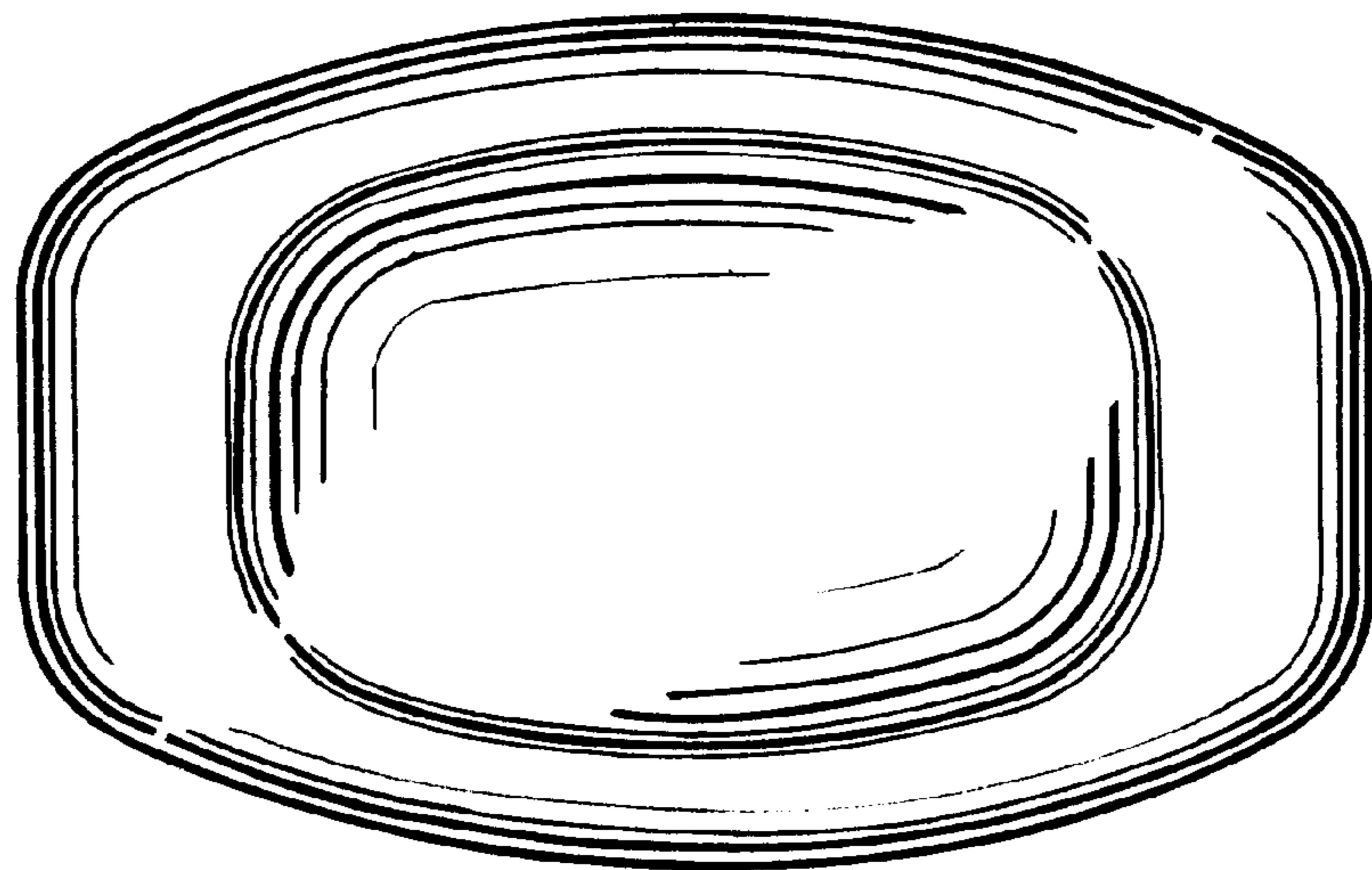
