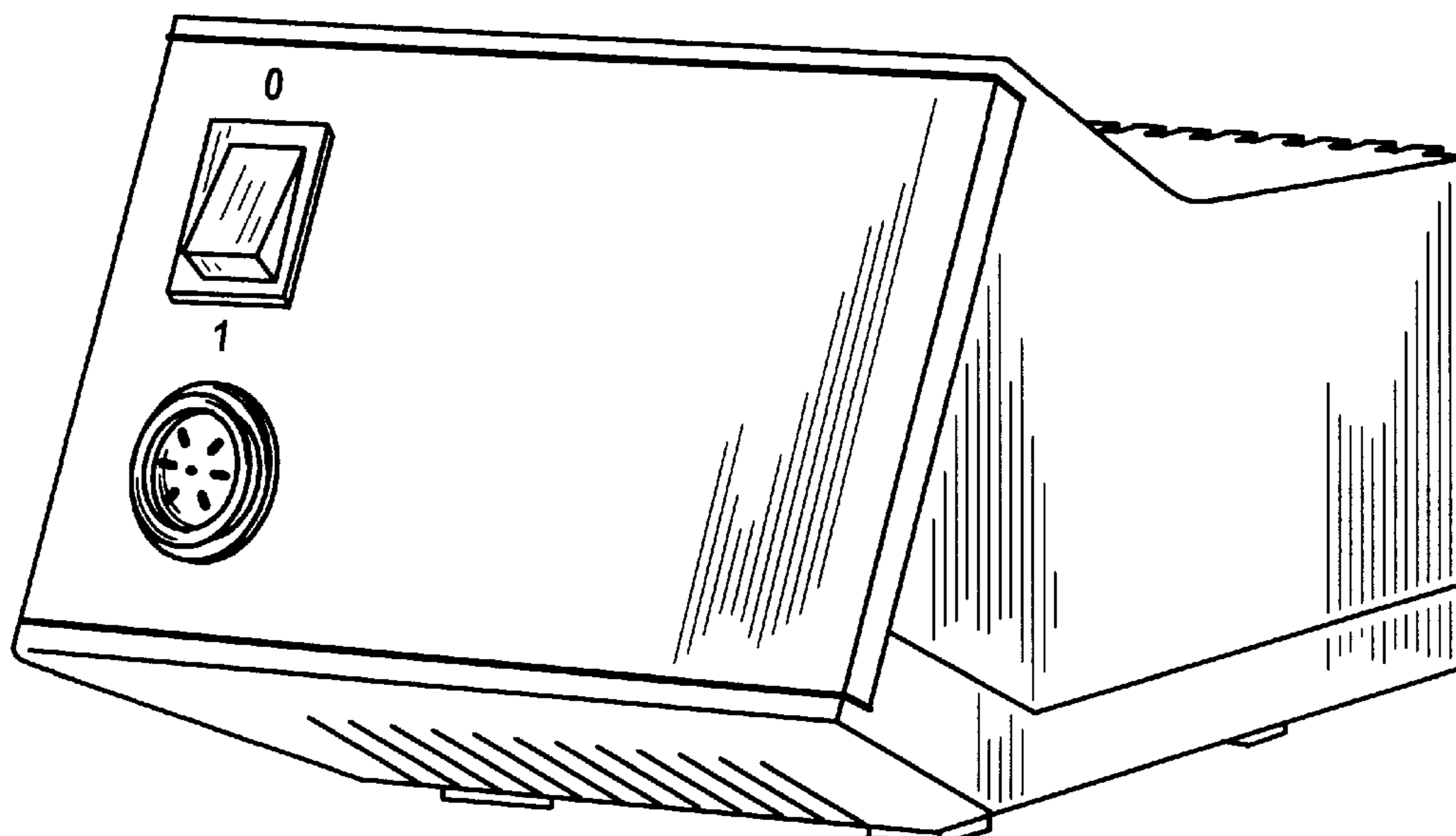
The ornamental design for a soldering station, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a soldering station showing a first embodiment of my new design;

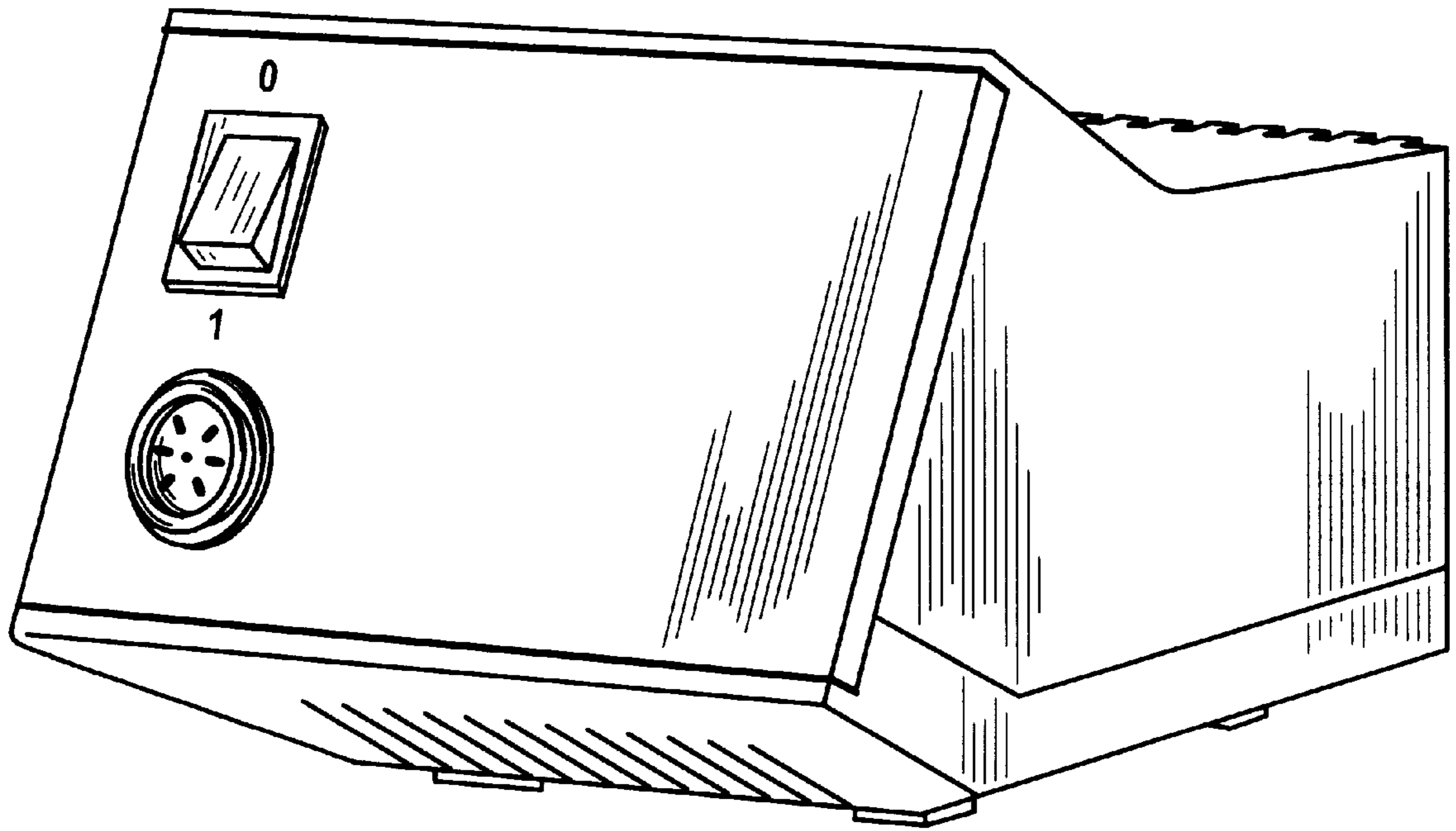

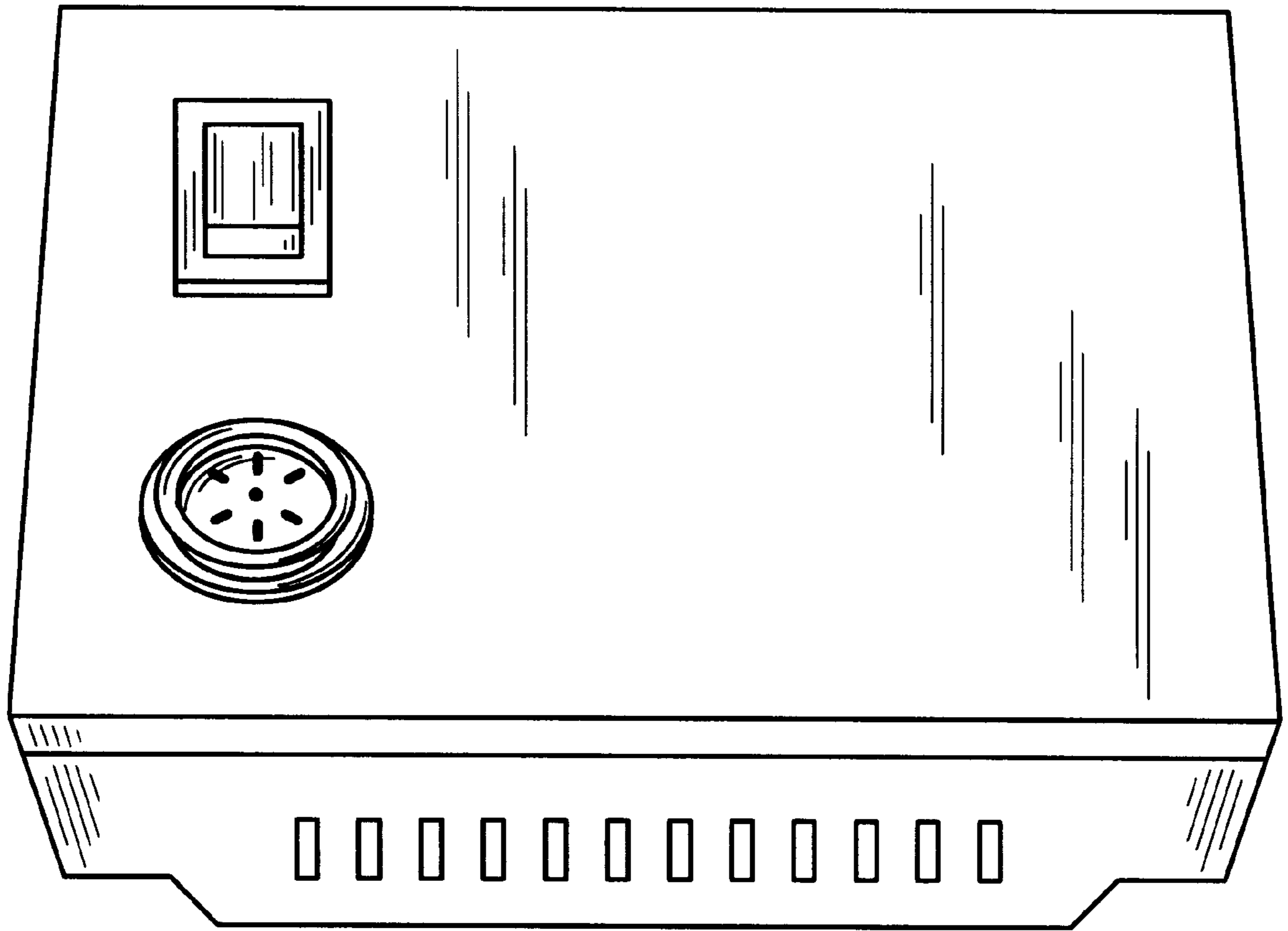

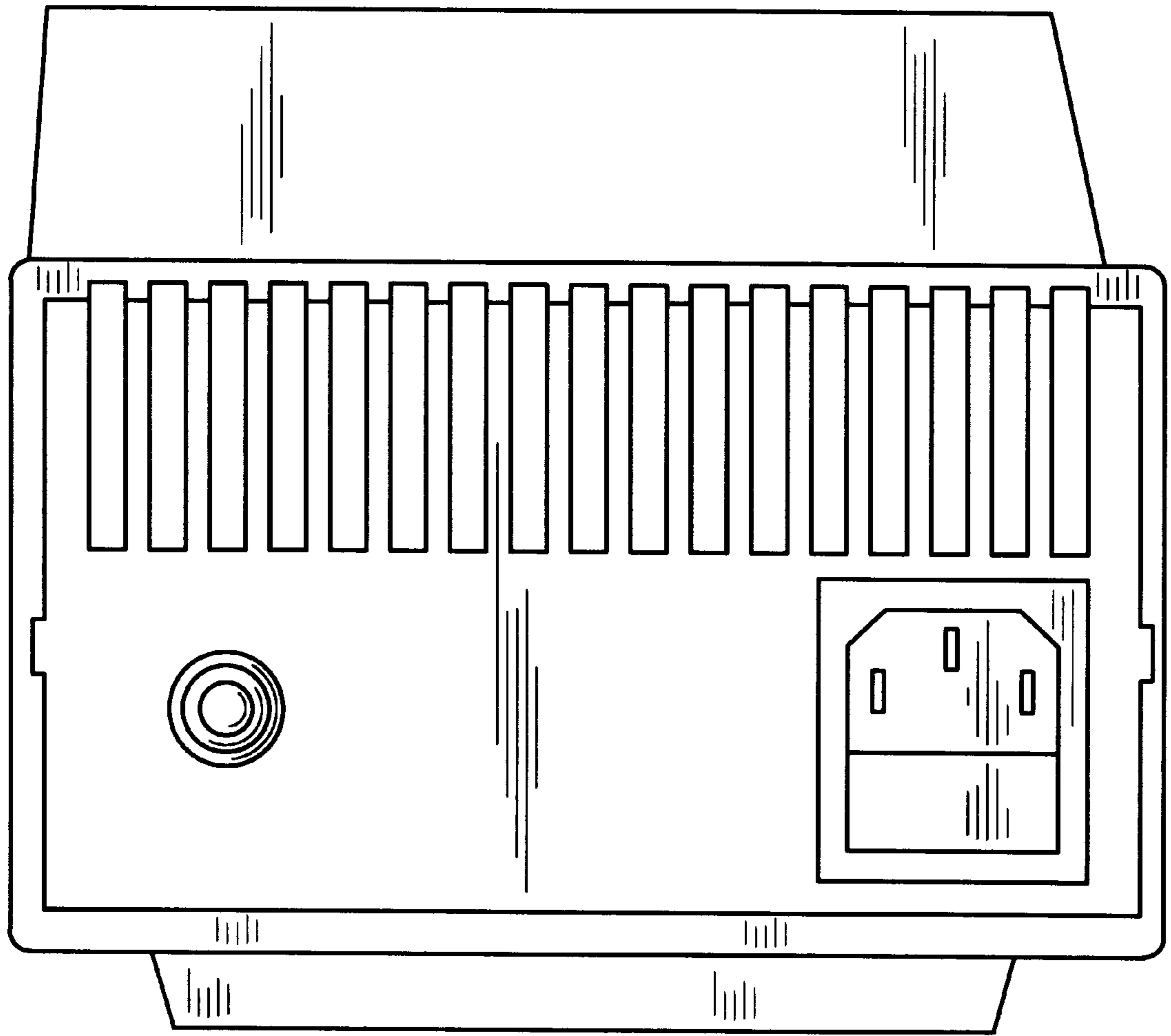

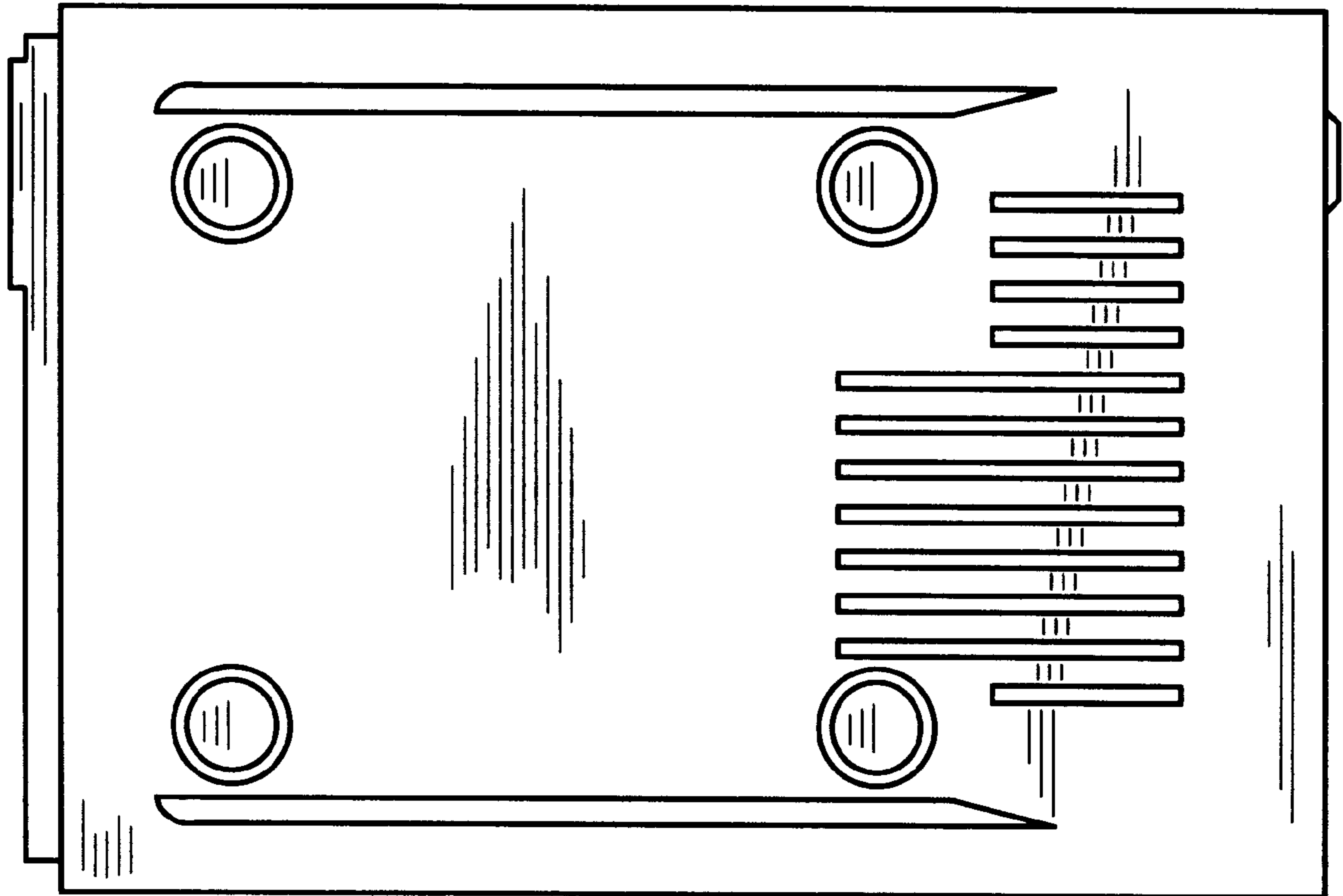

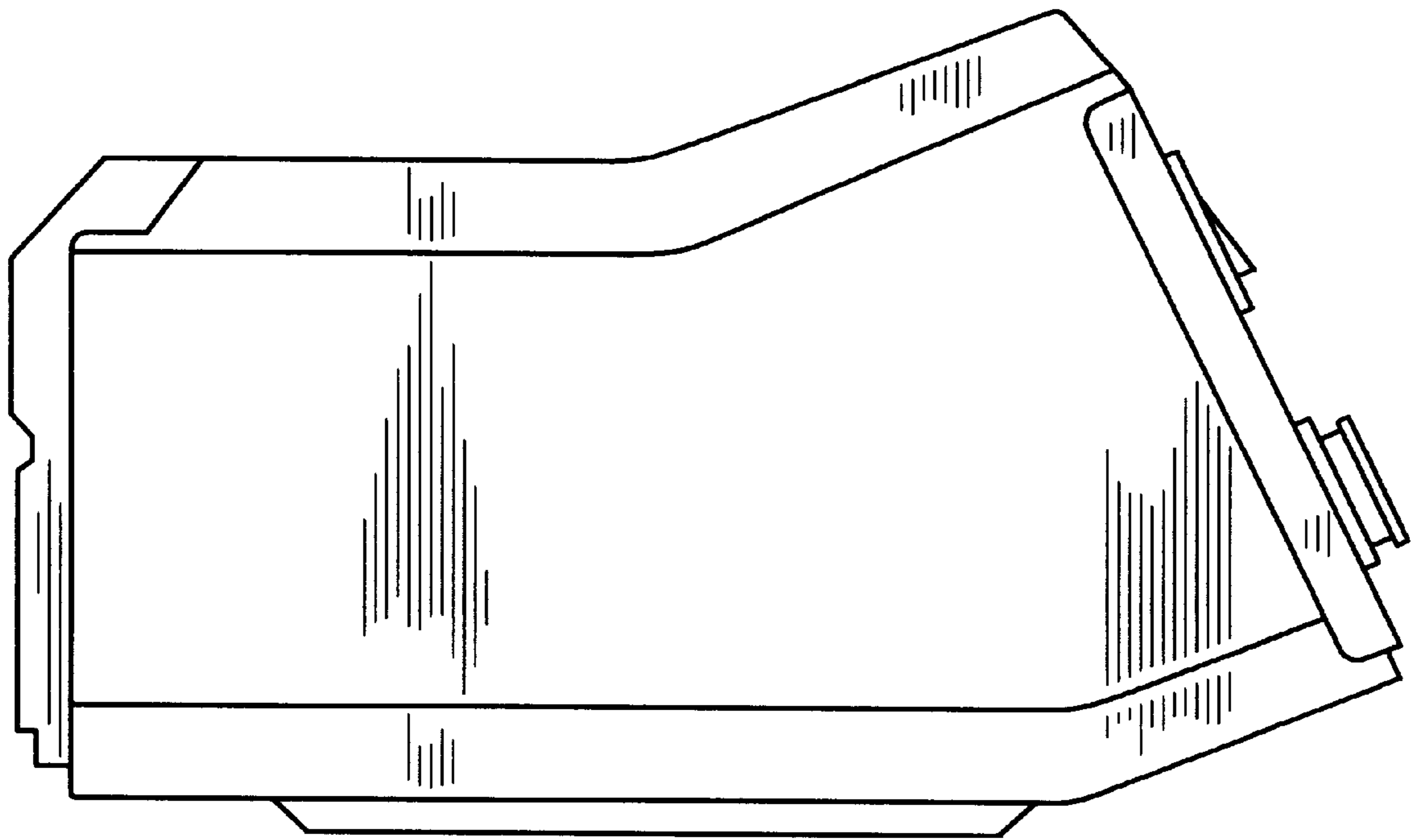

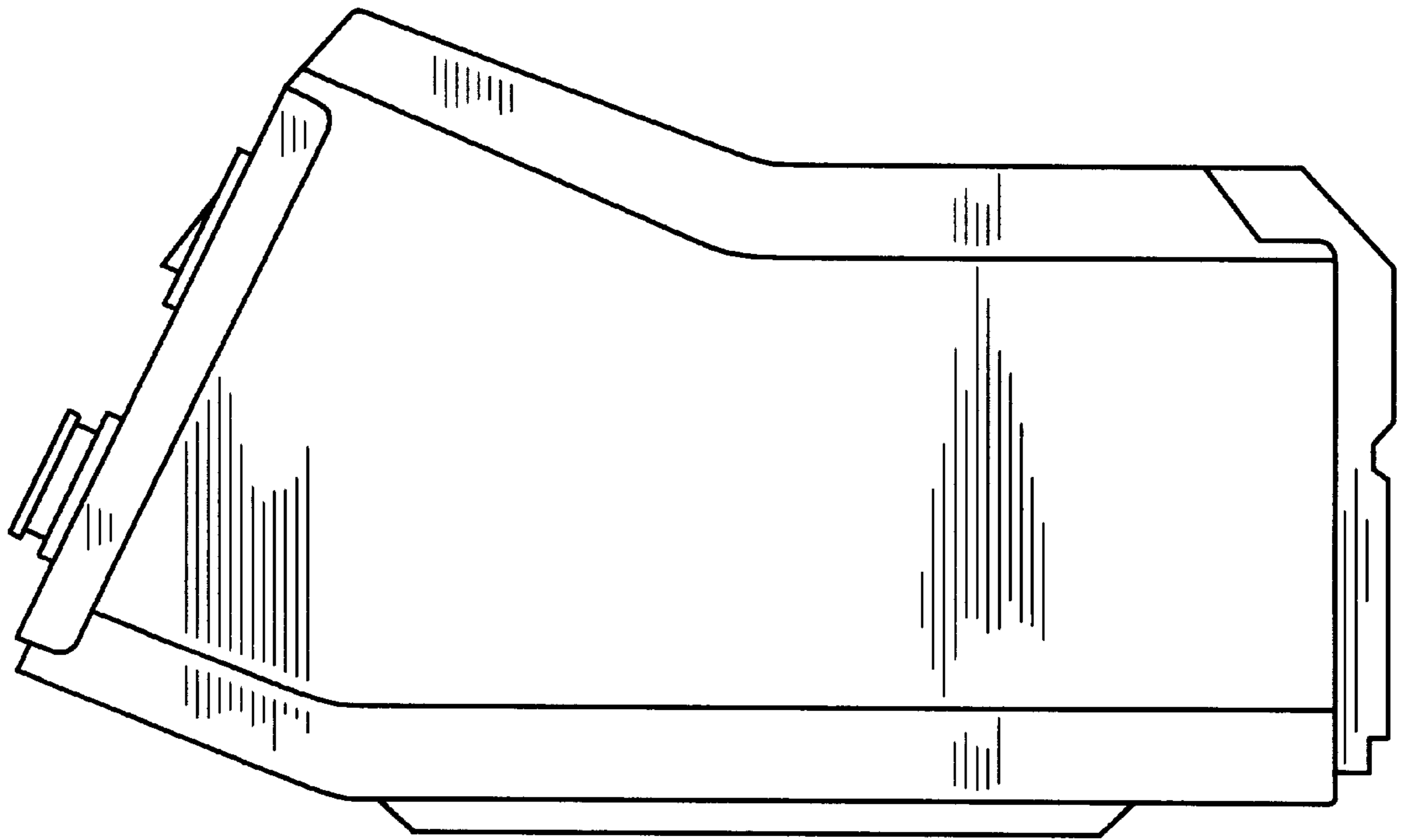

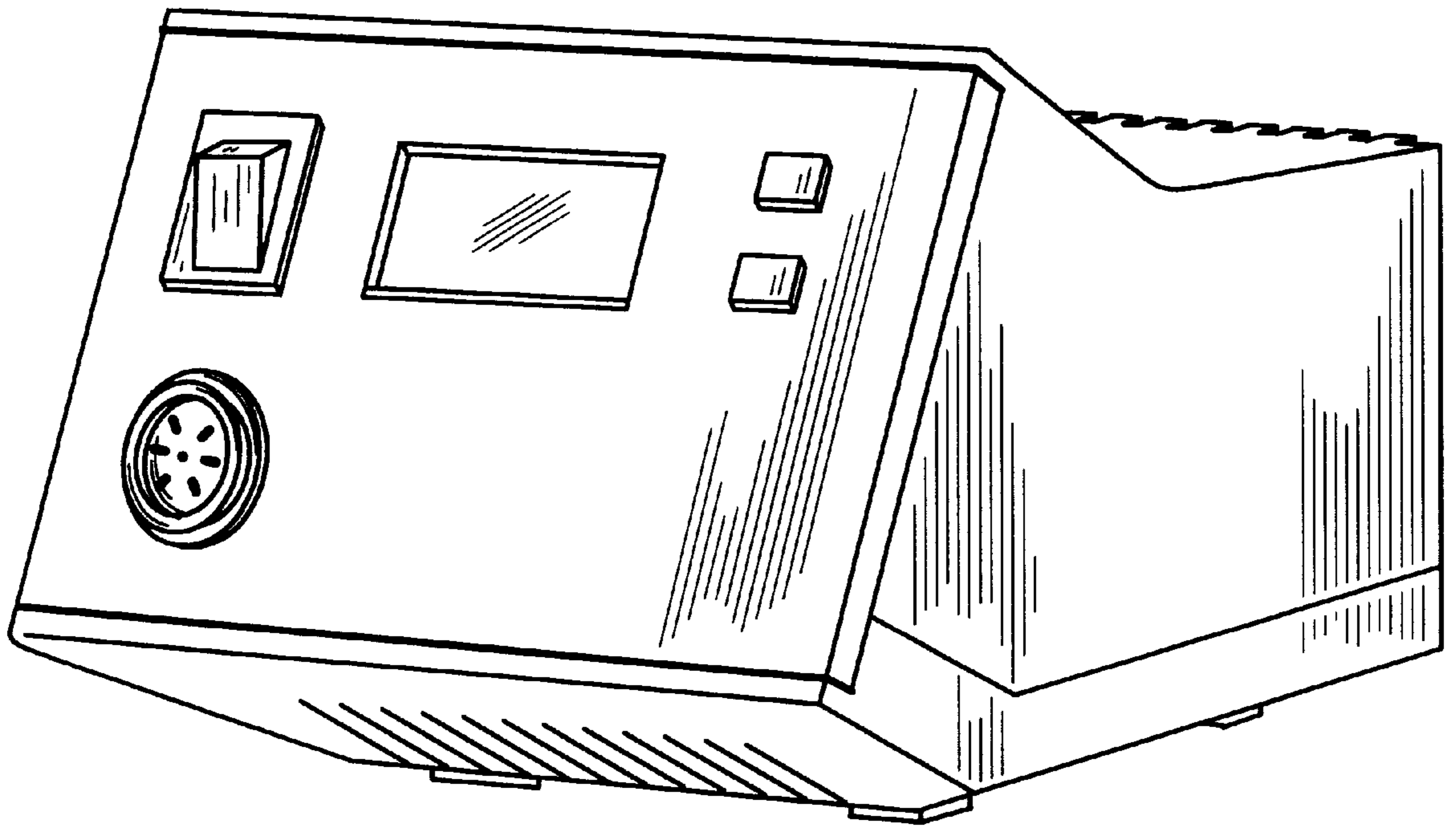

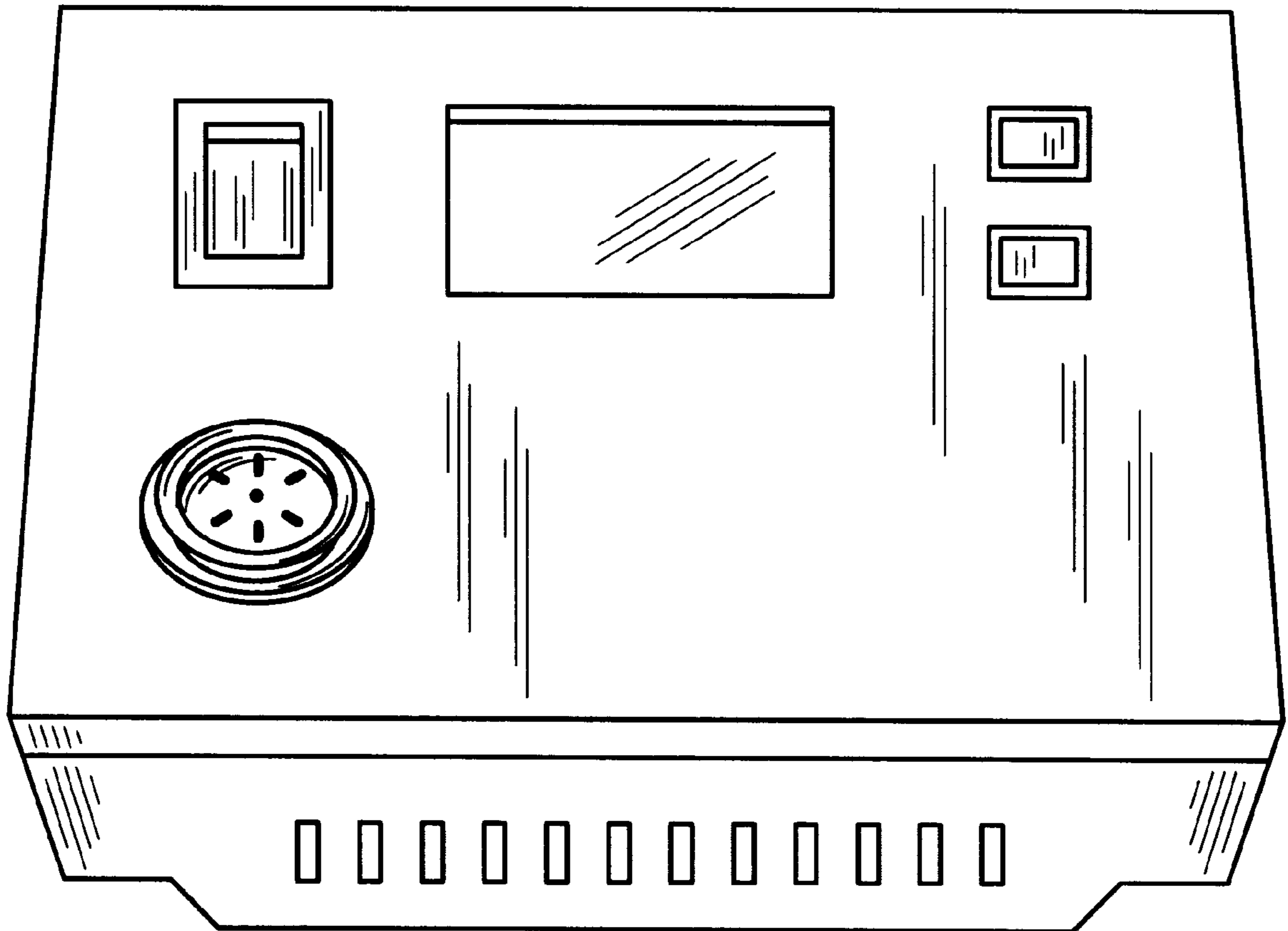

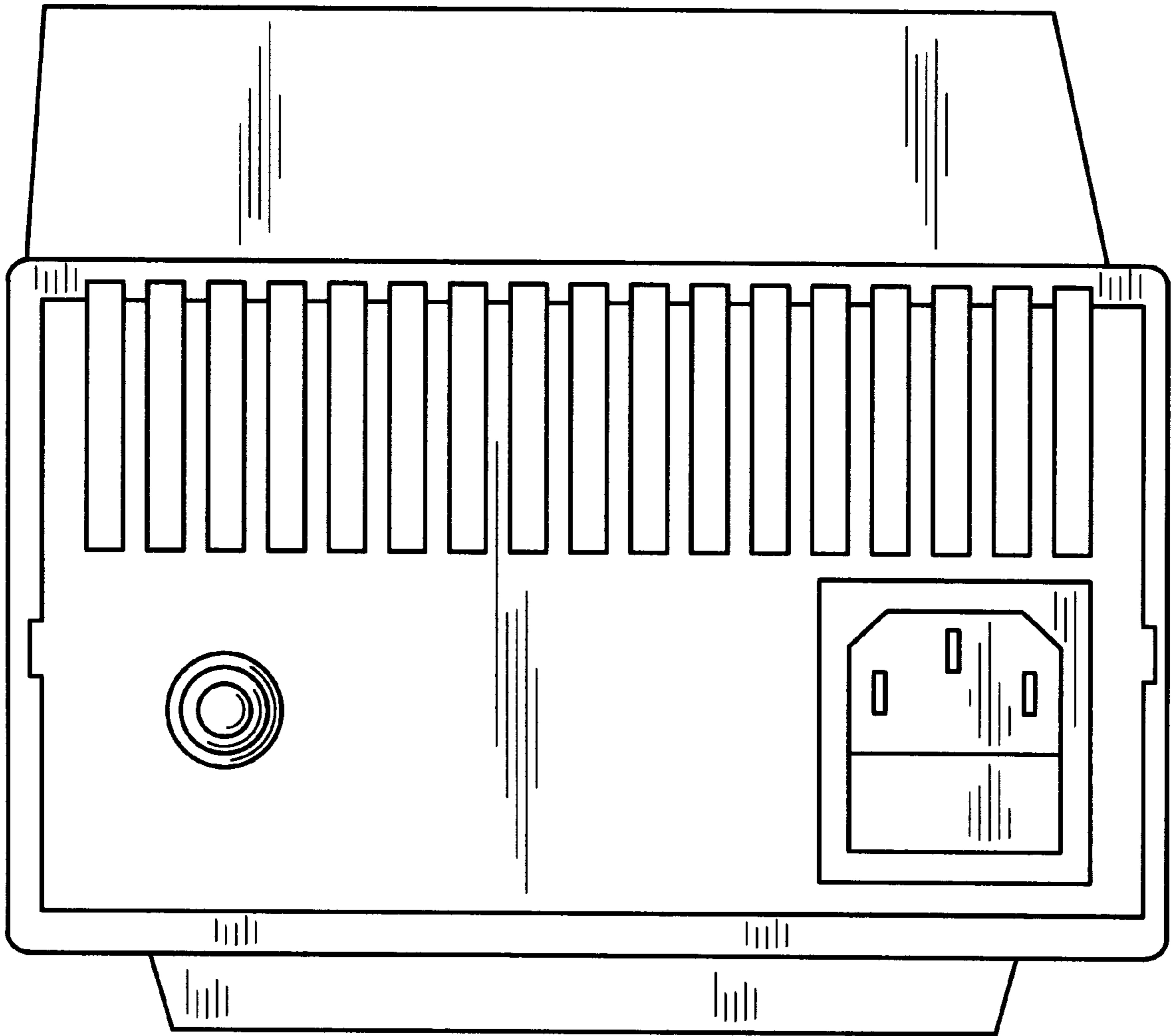

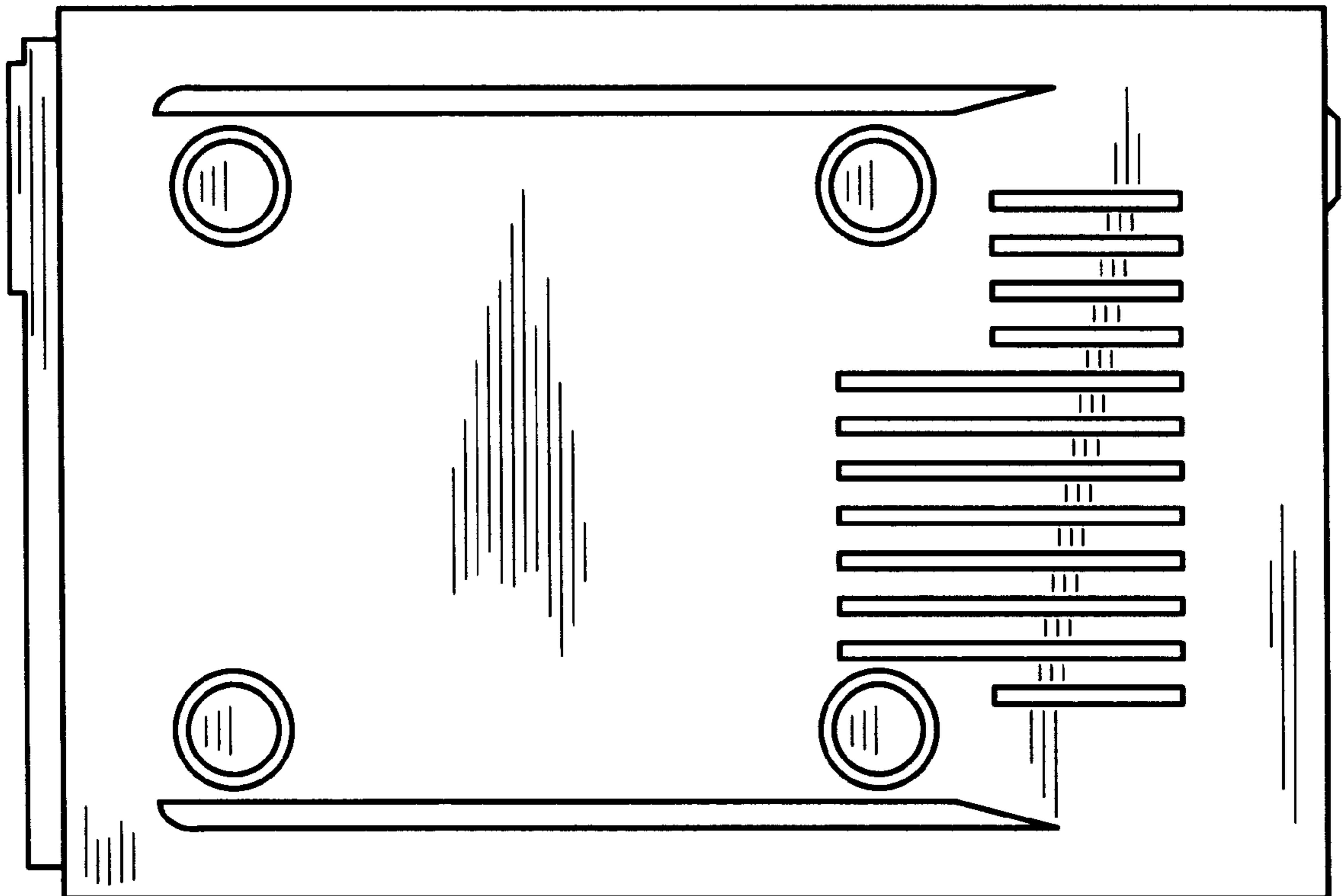

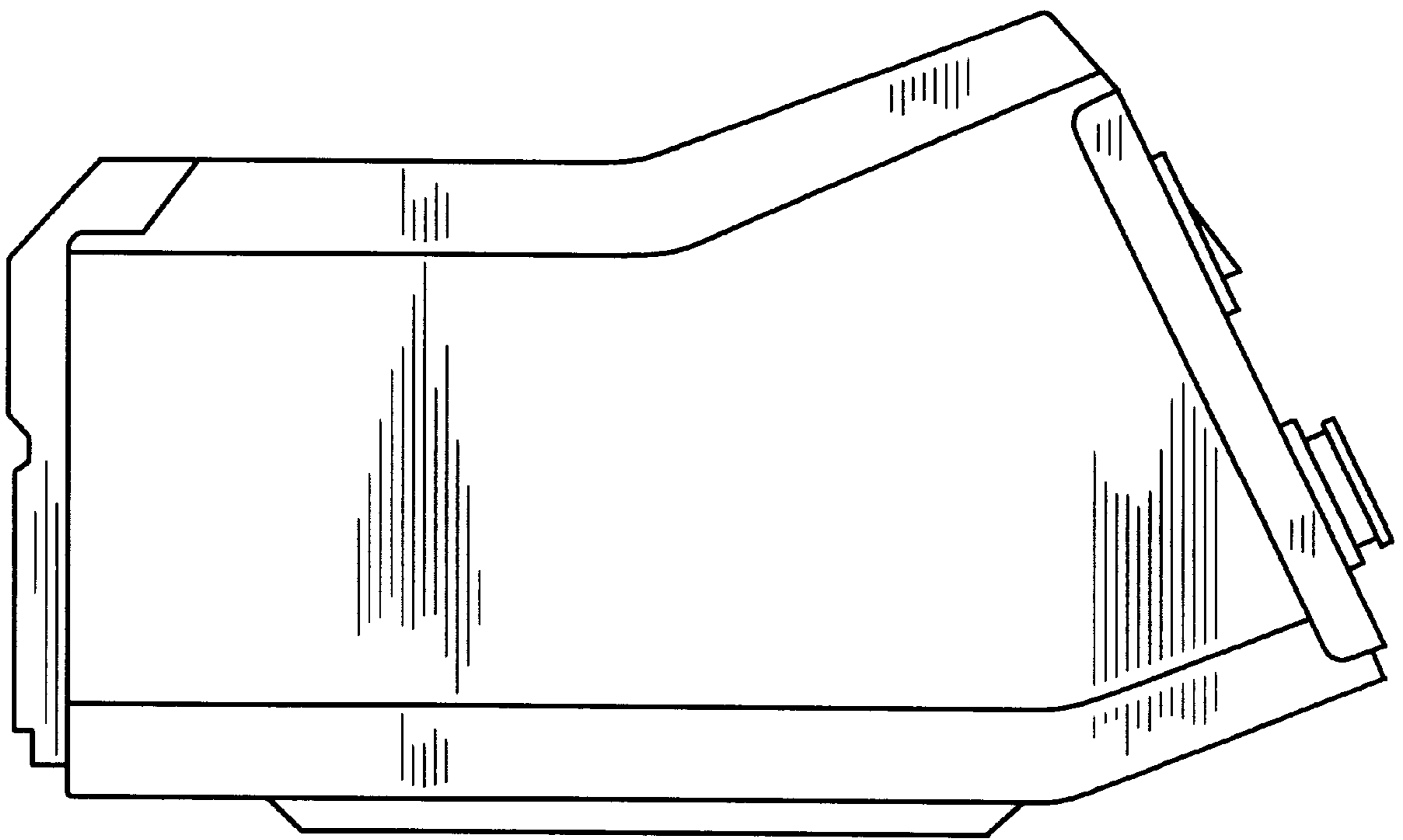

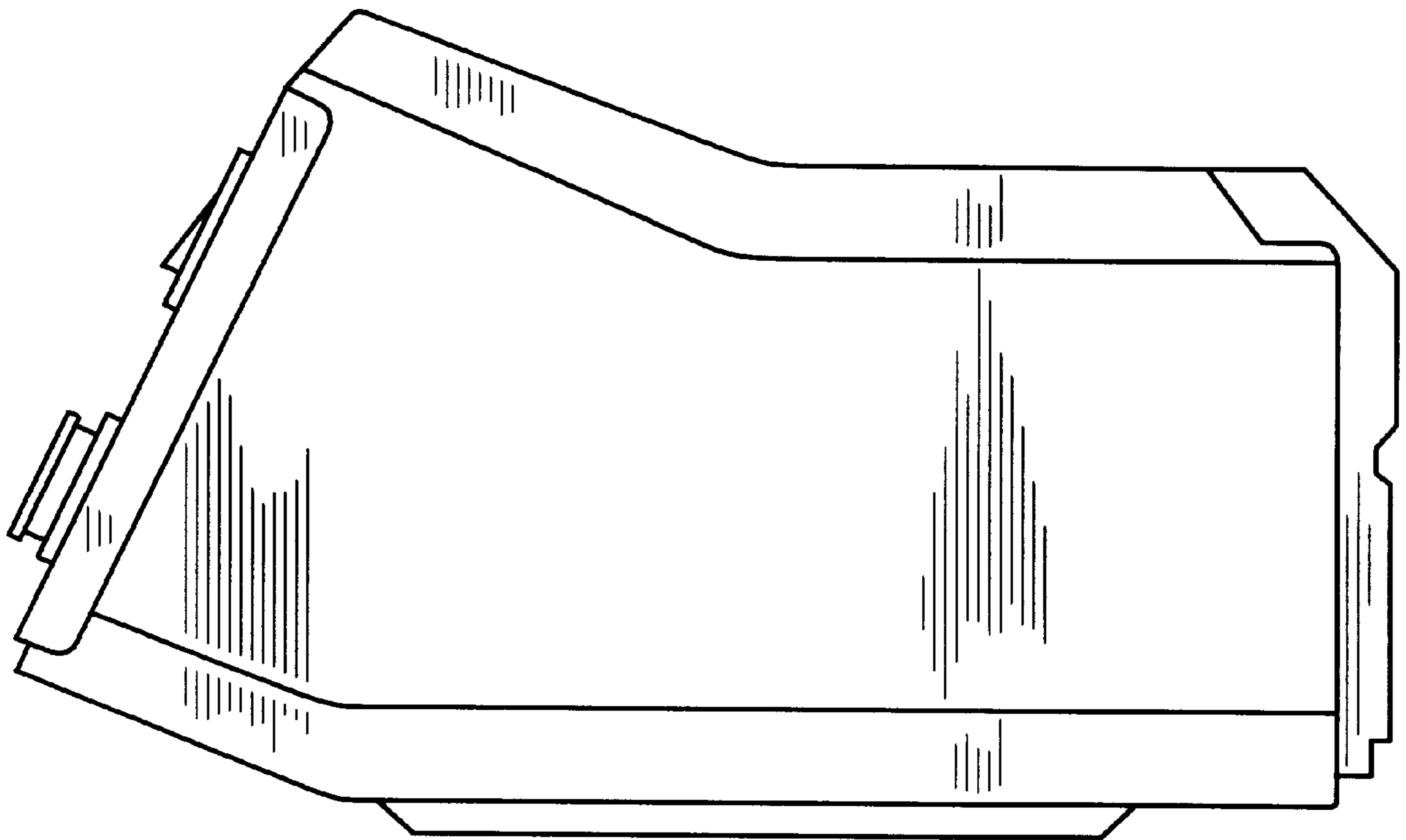

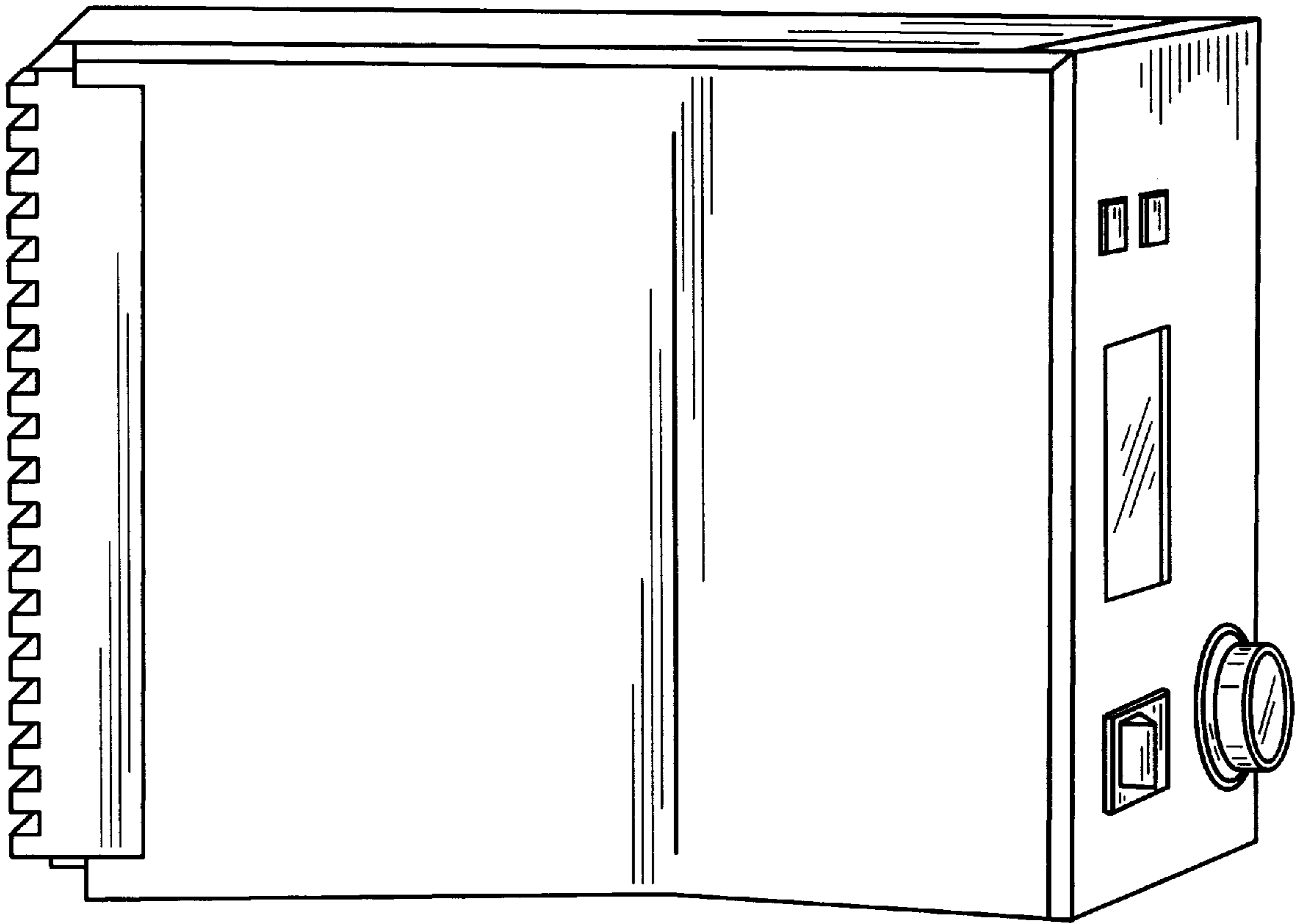

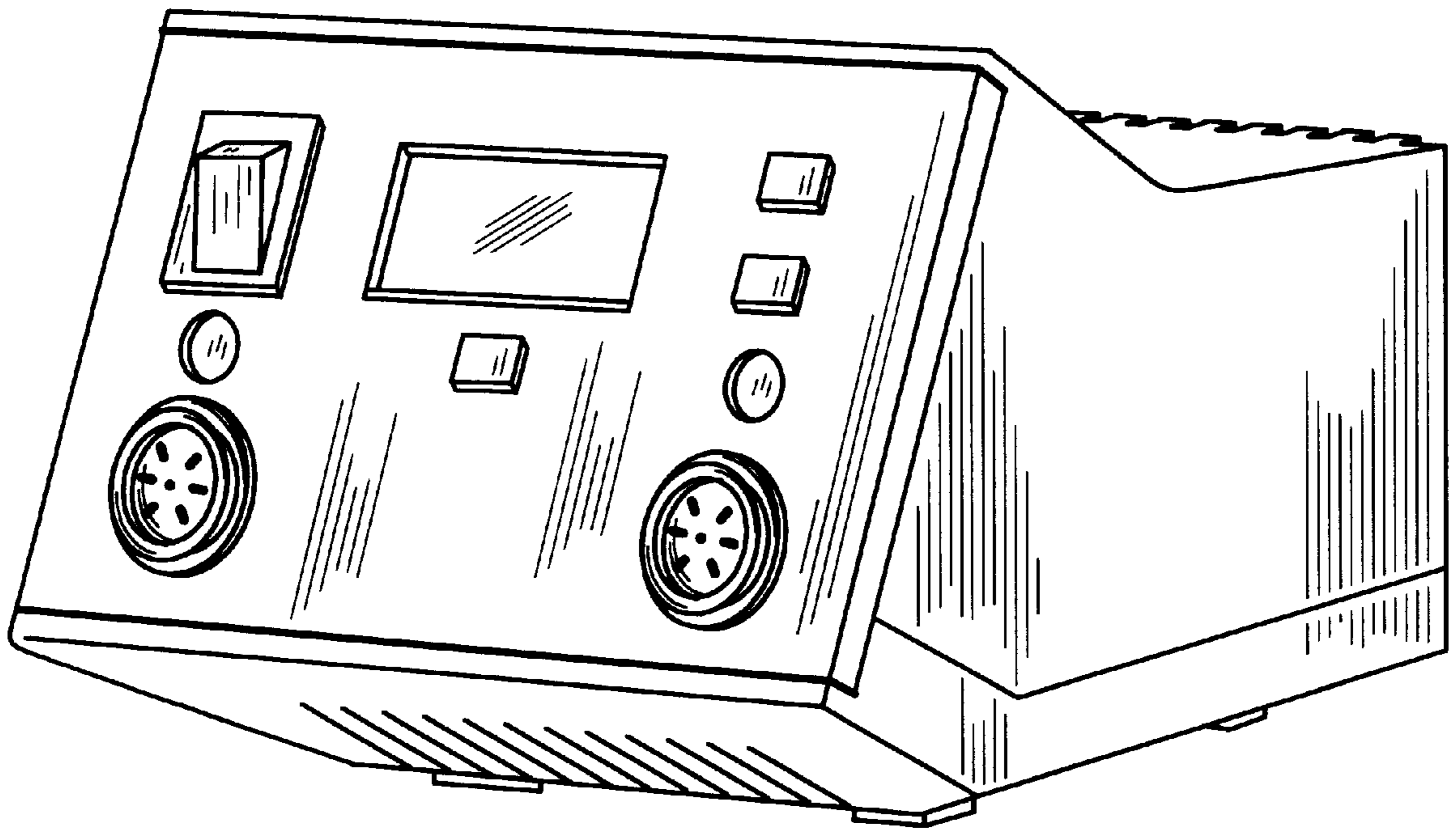

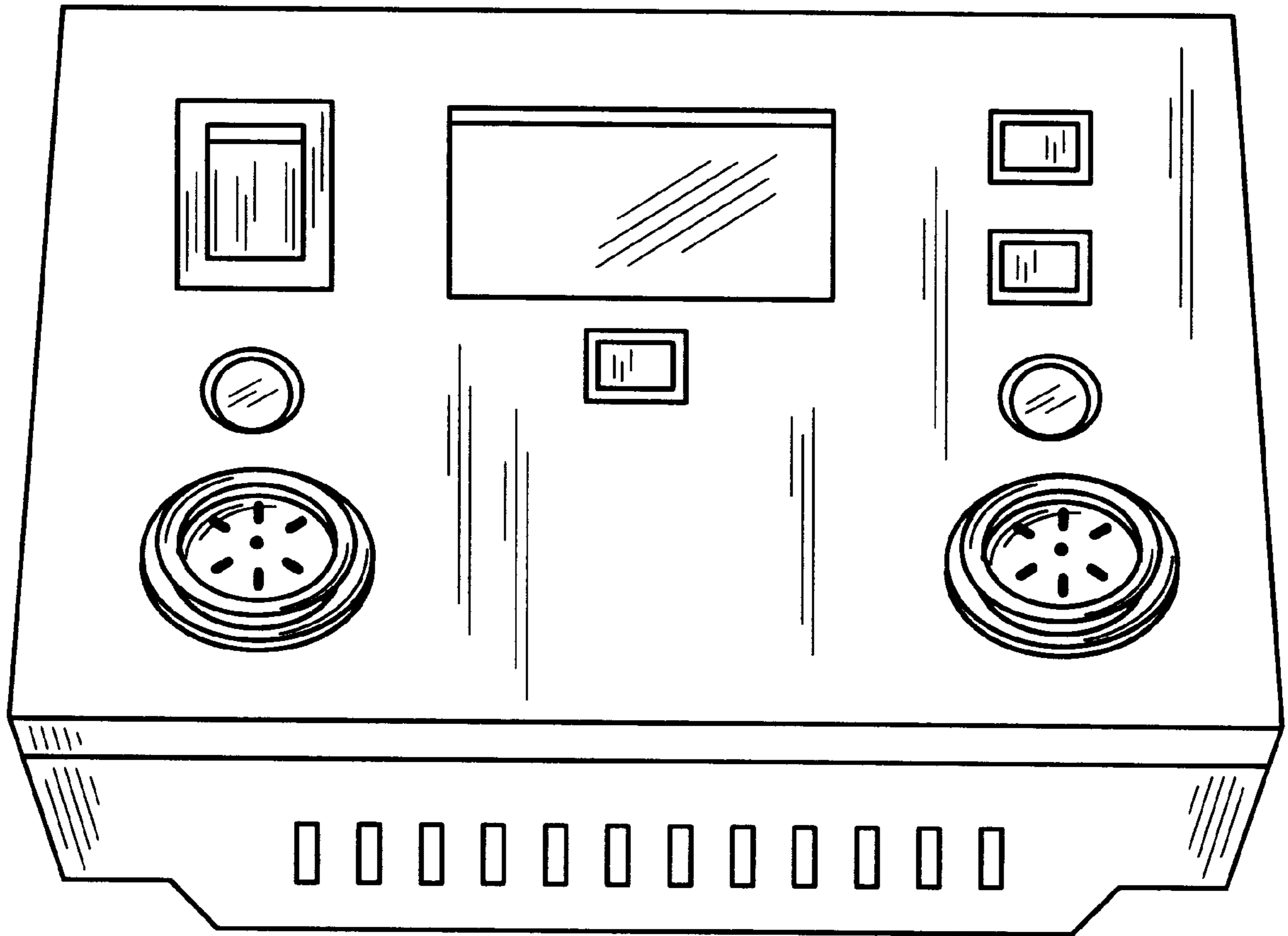

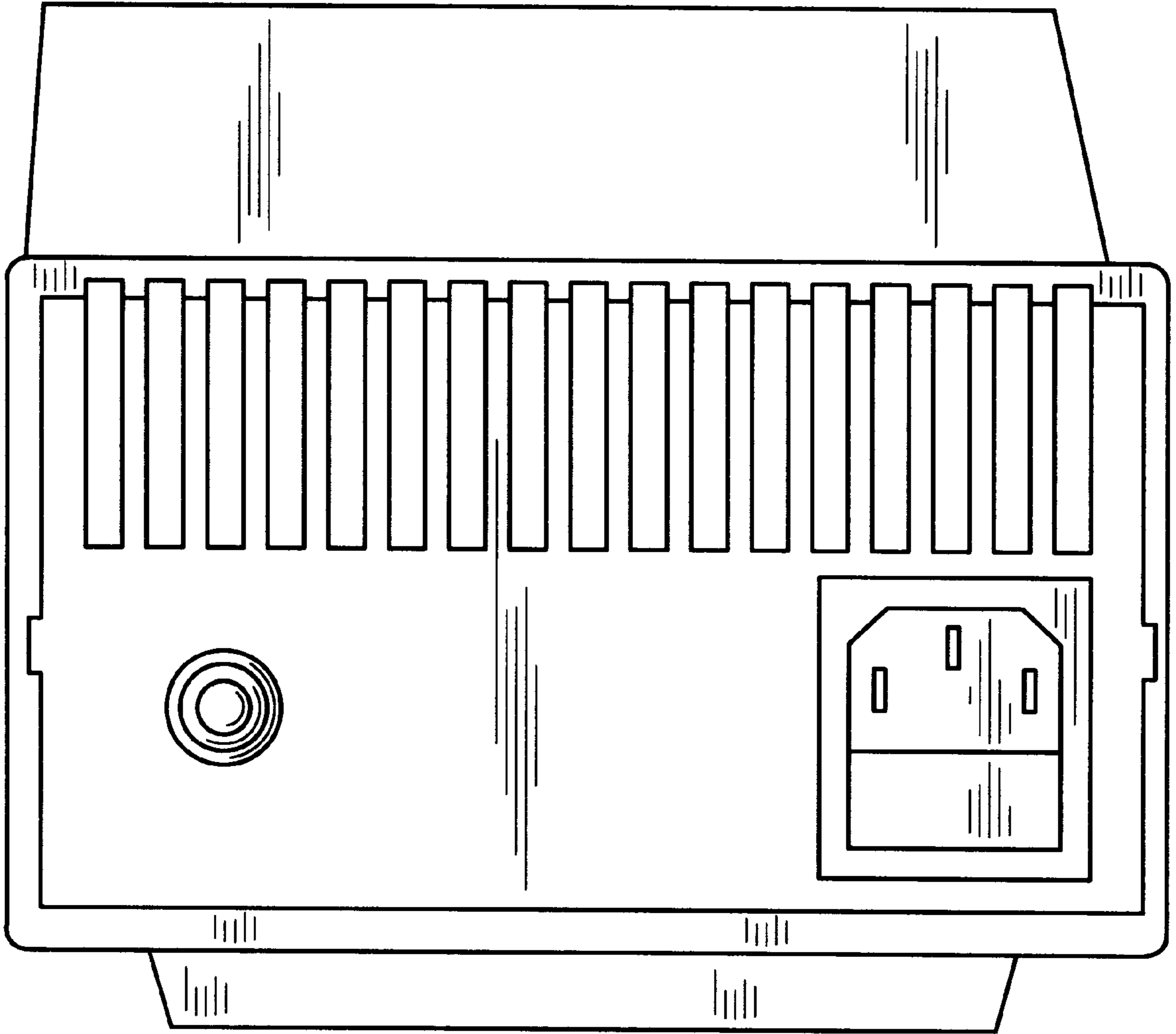

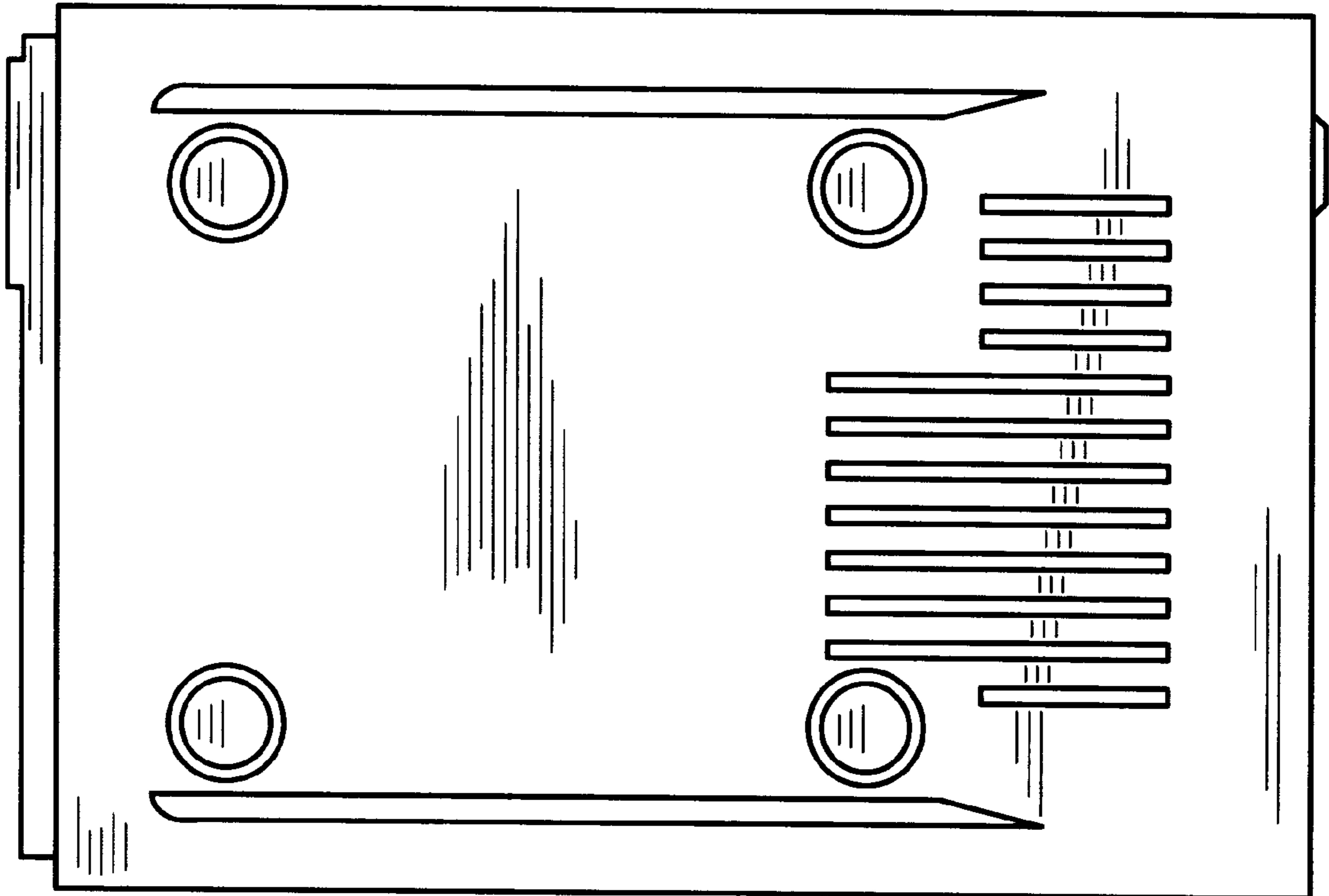

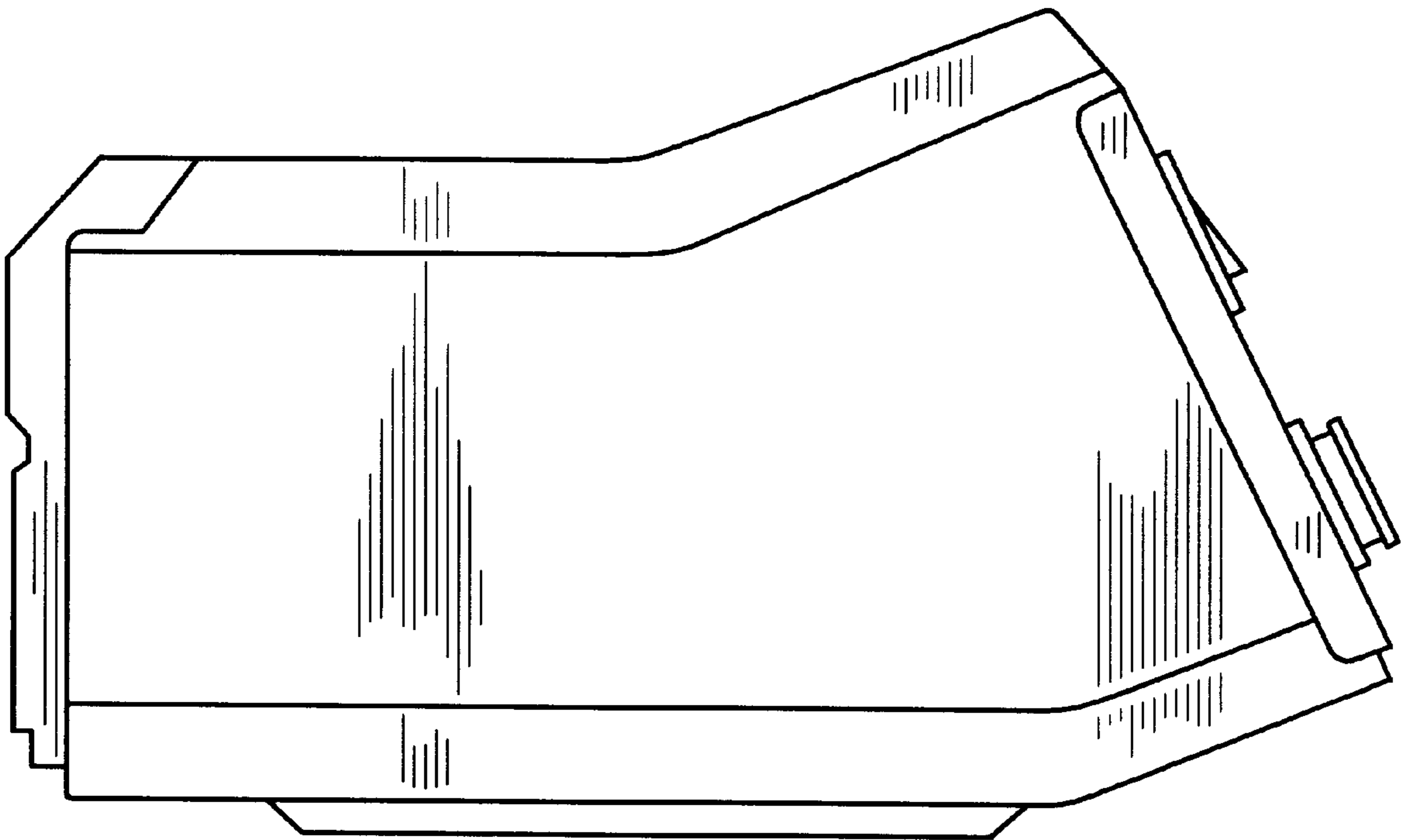

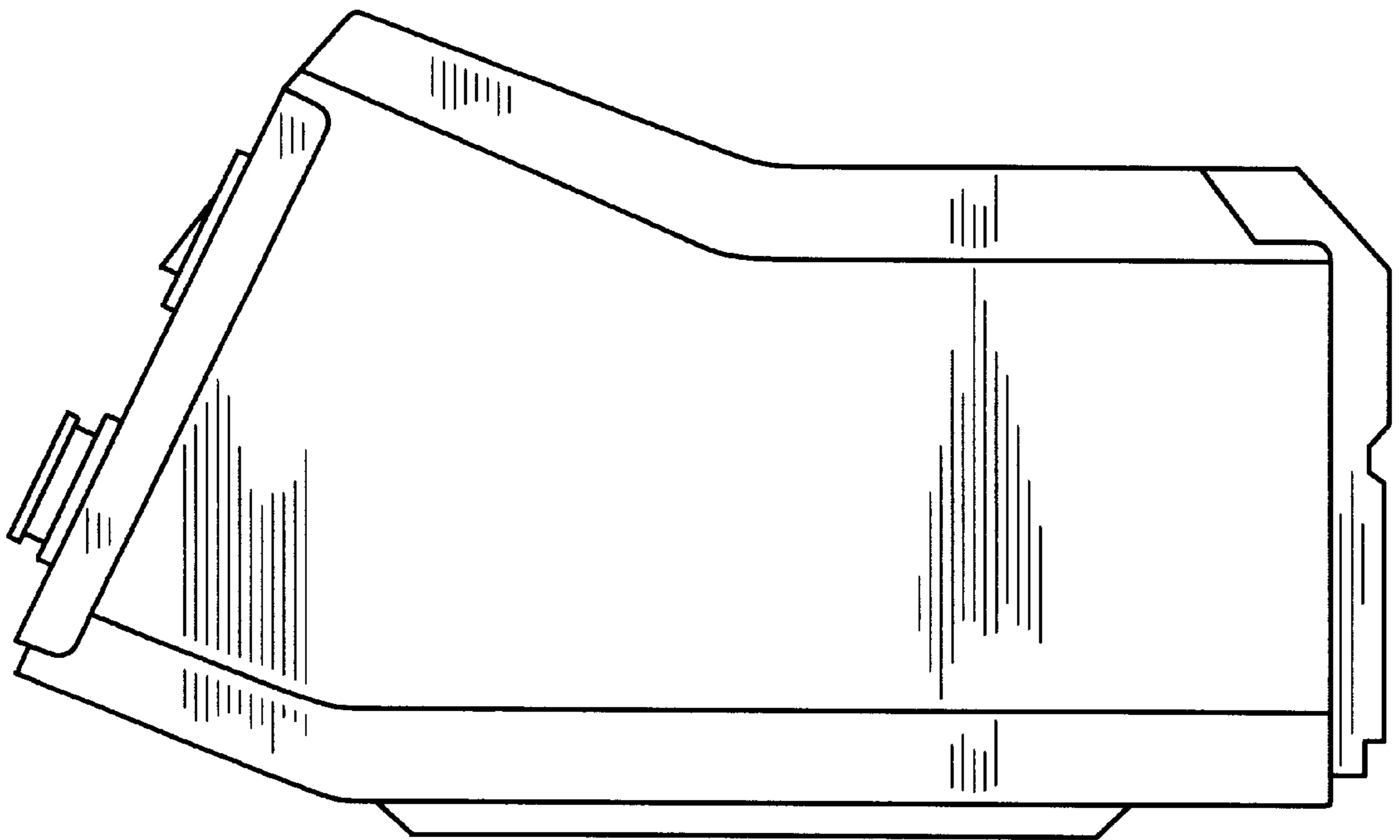

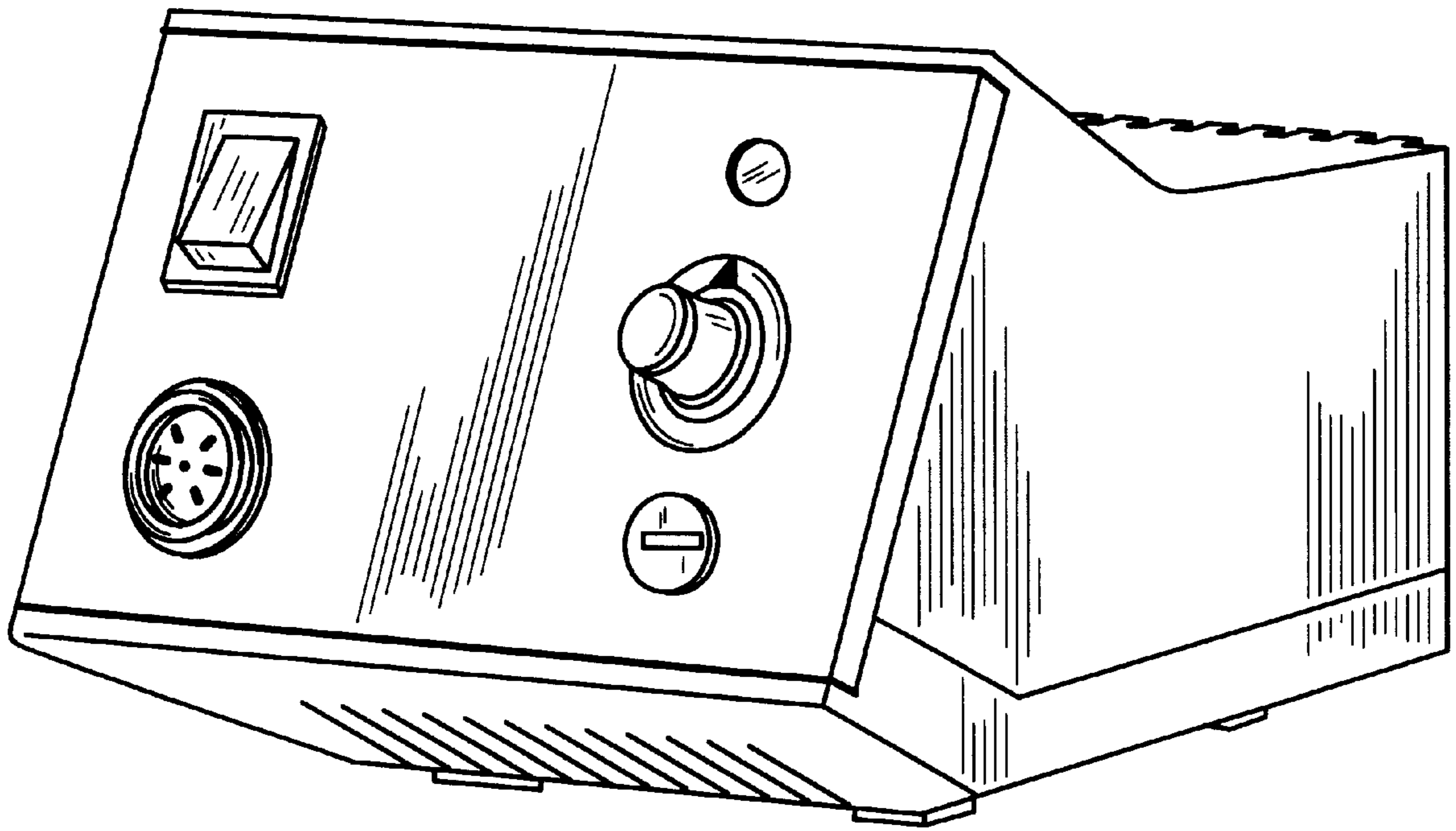

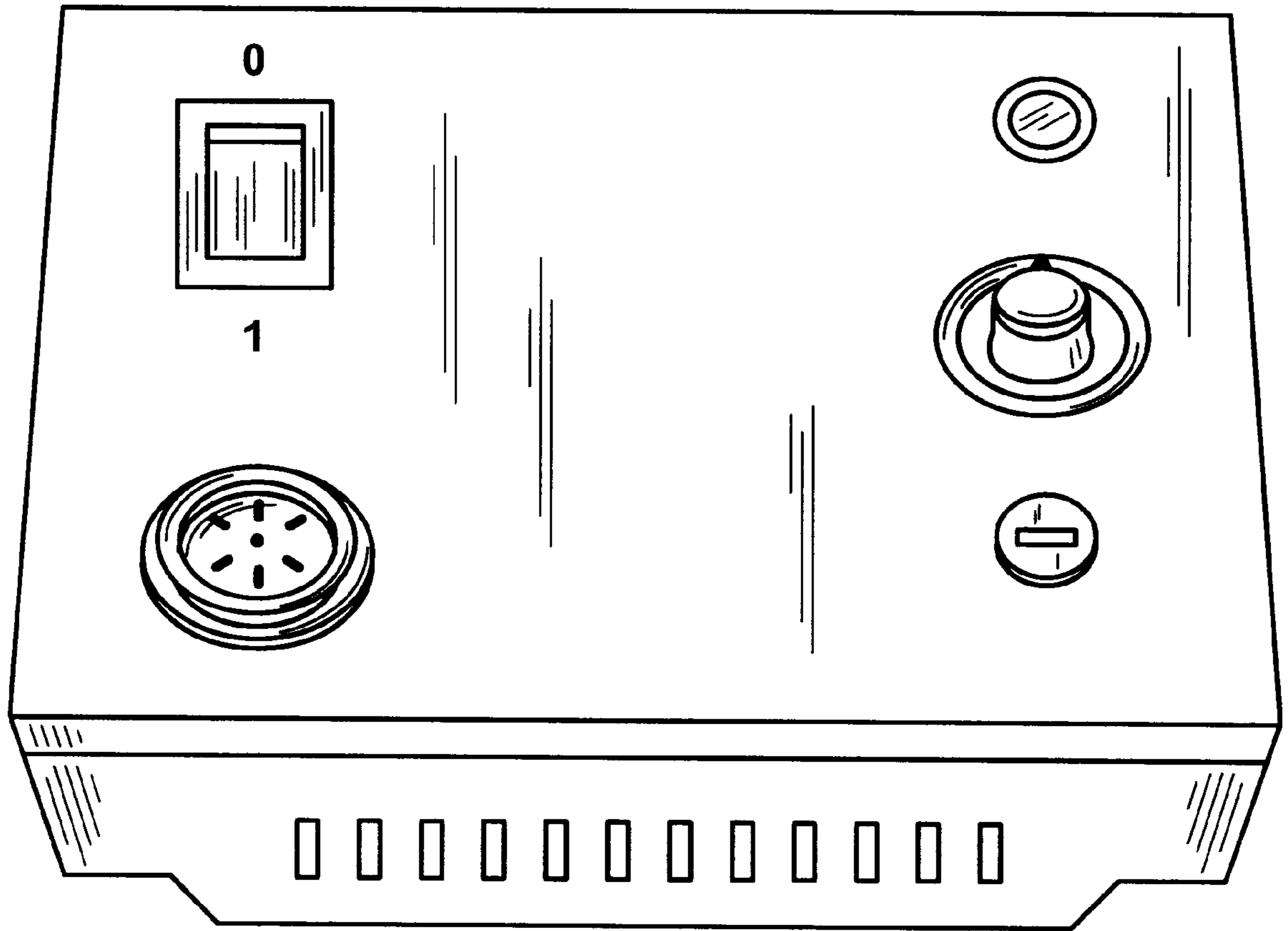

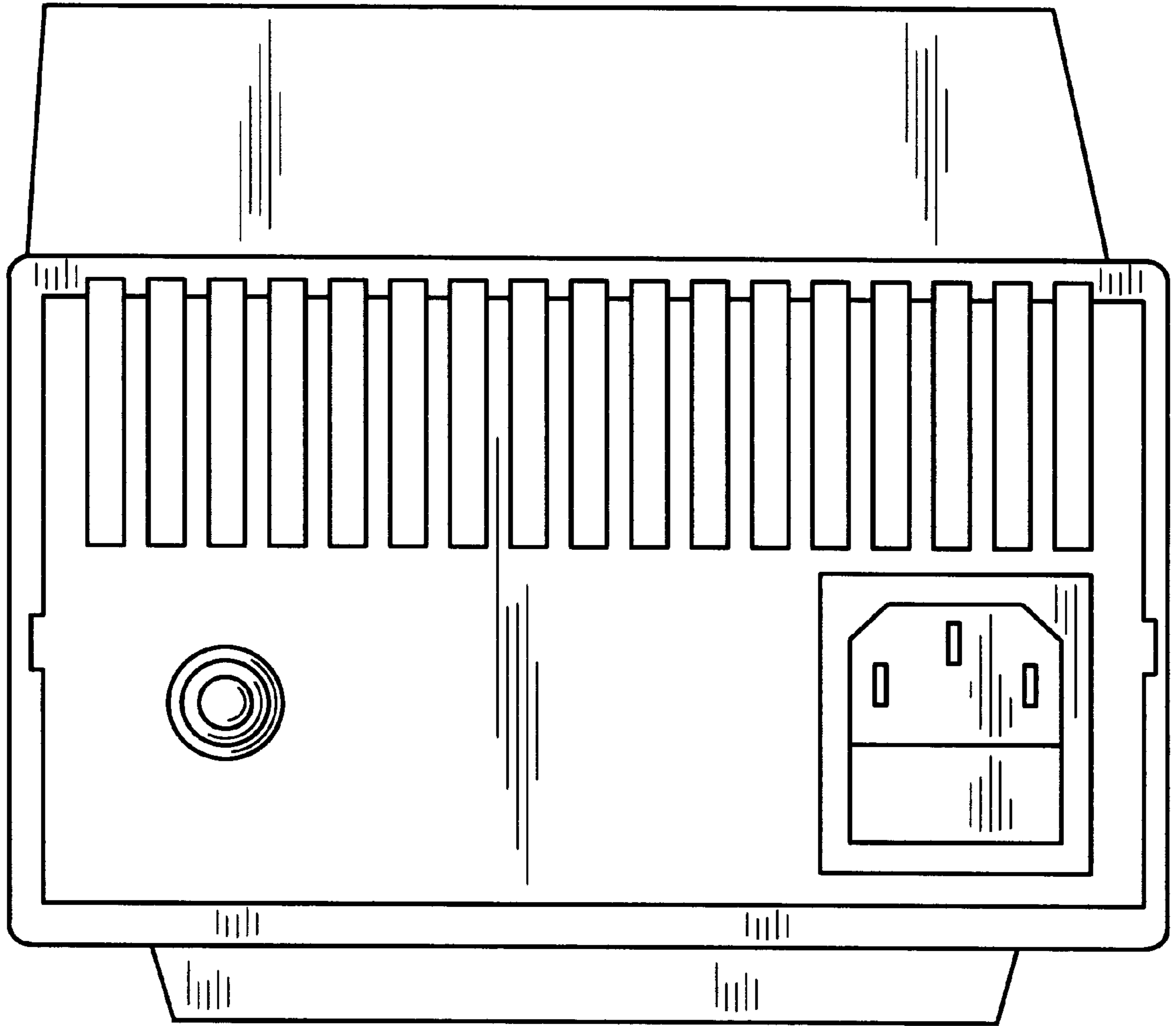

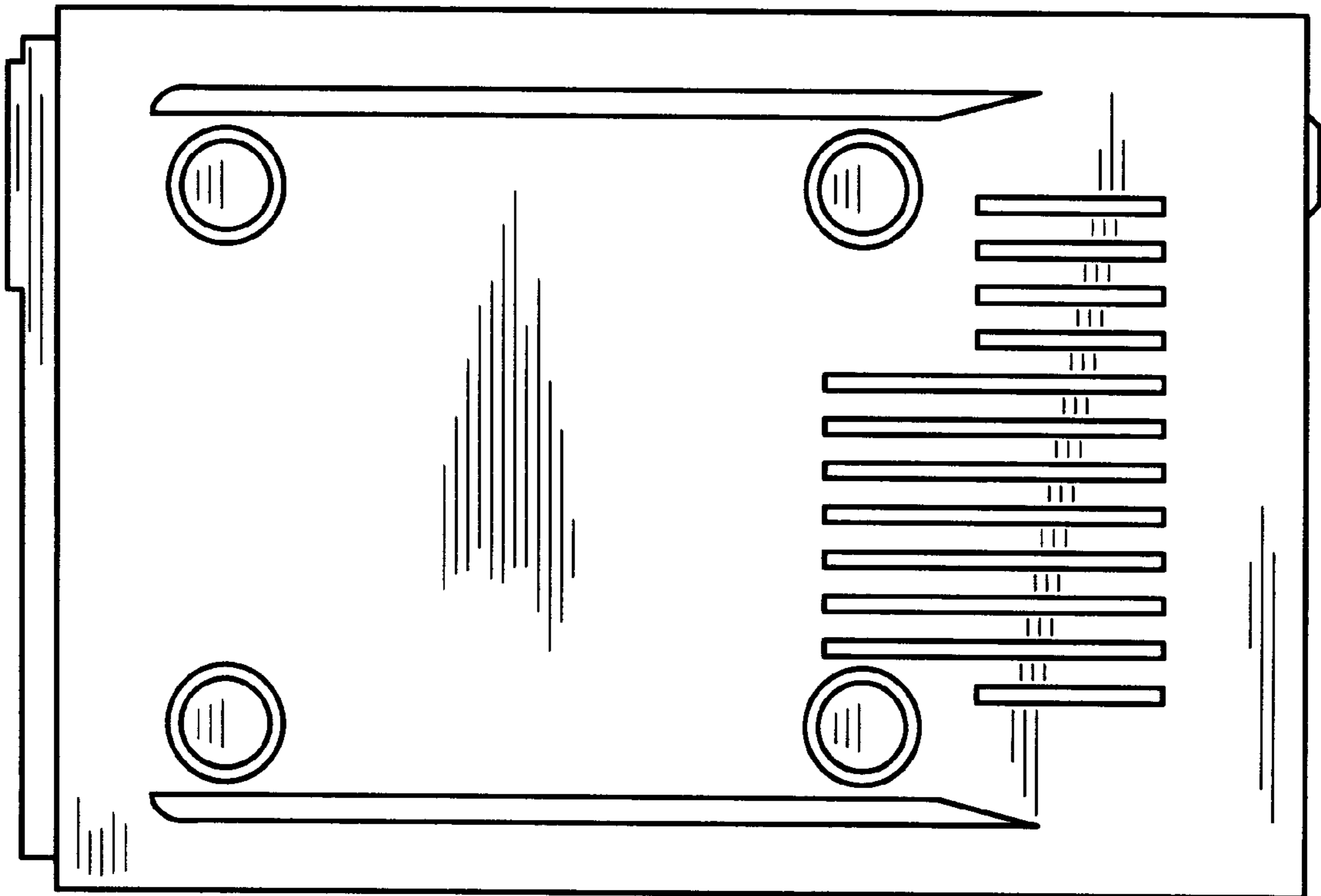

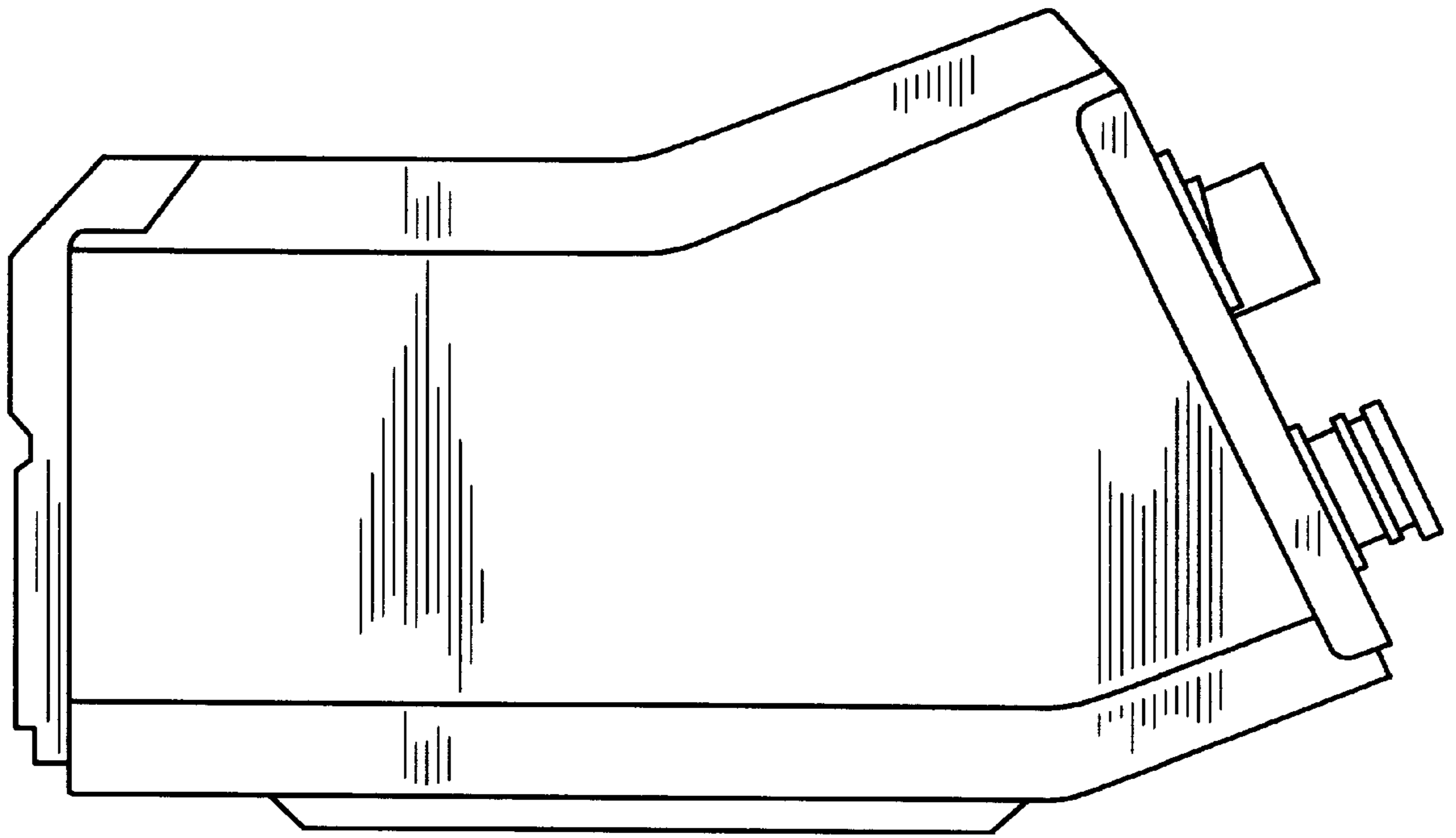

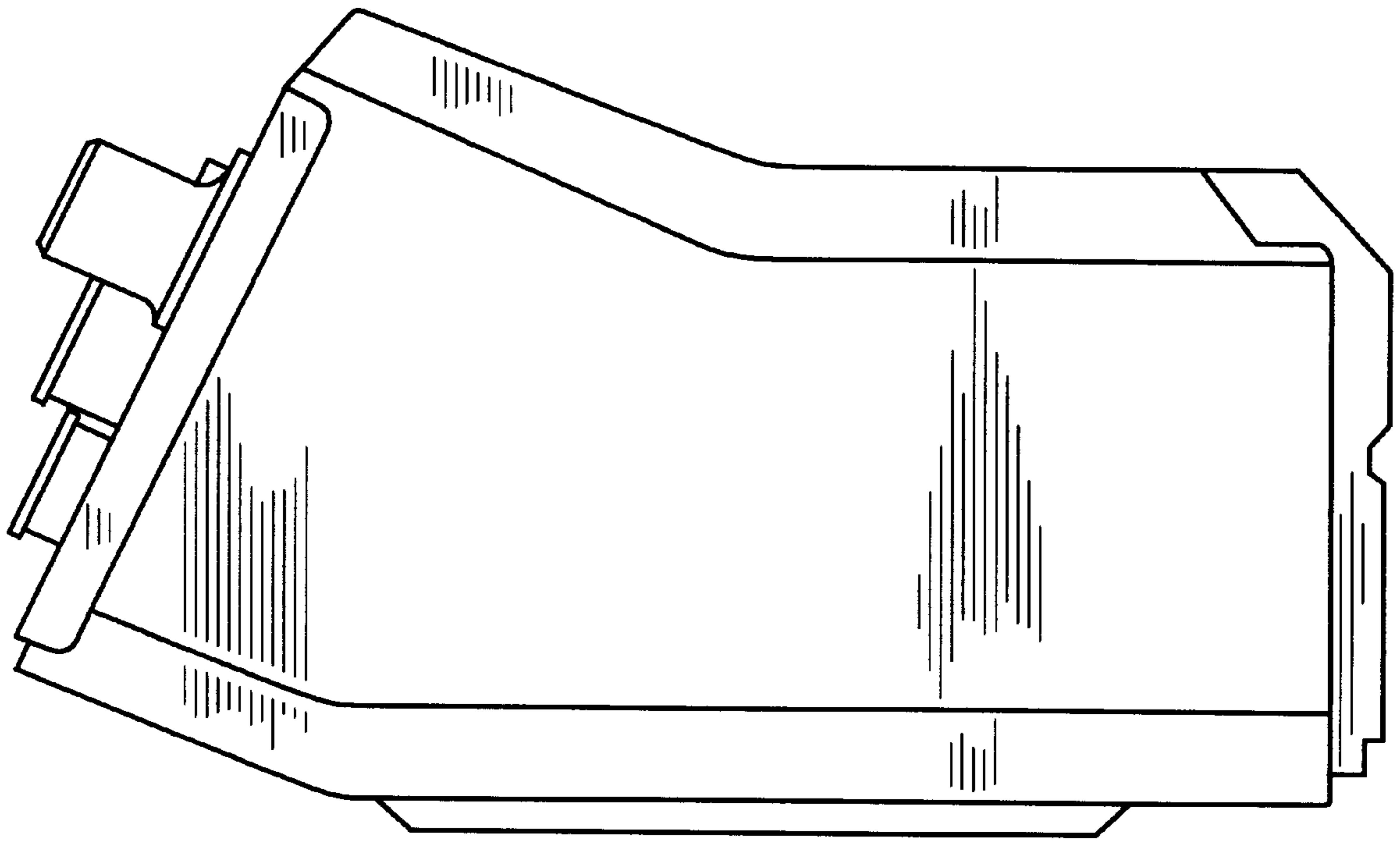

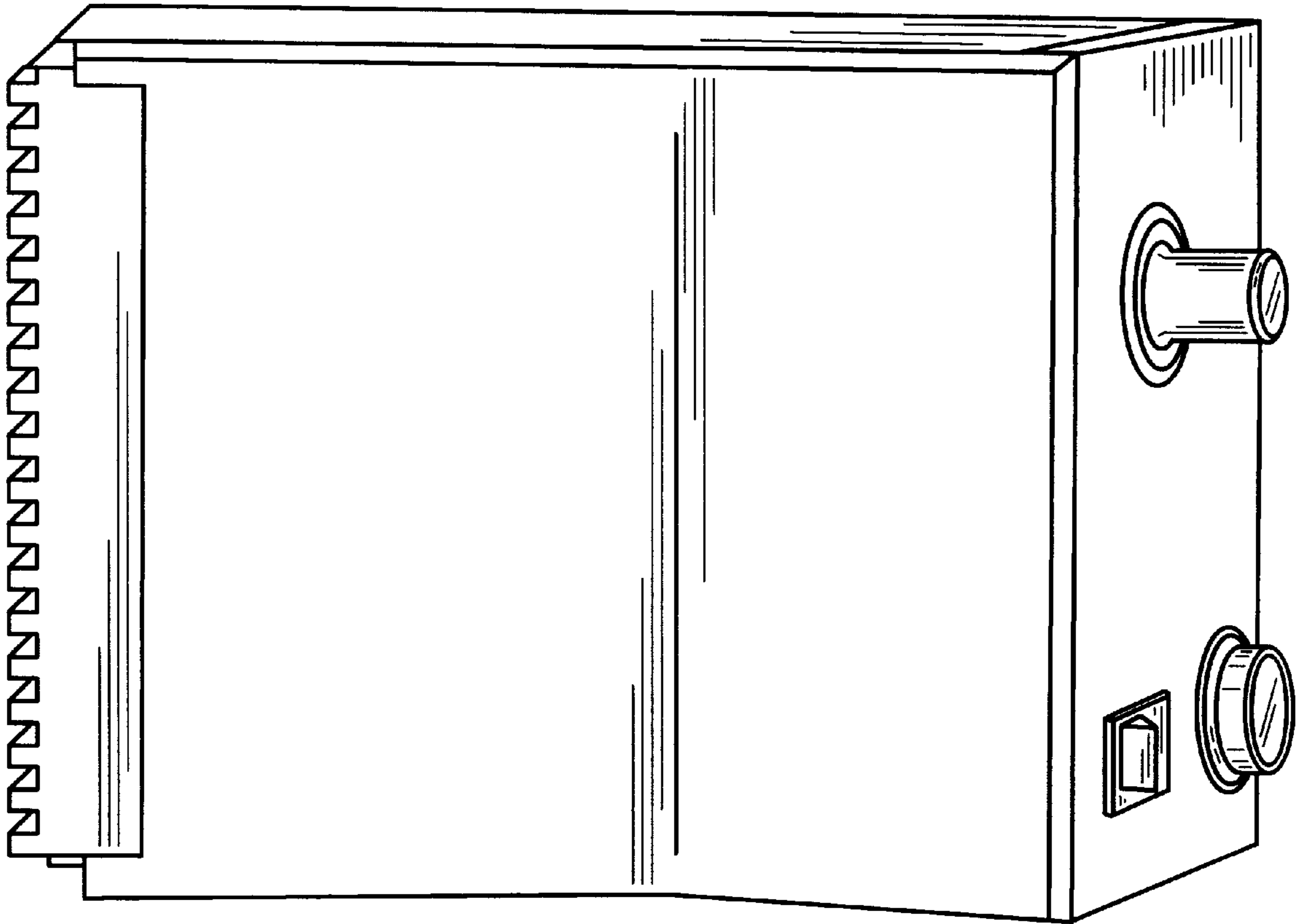
