CLAIM

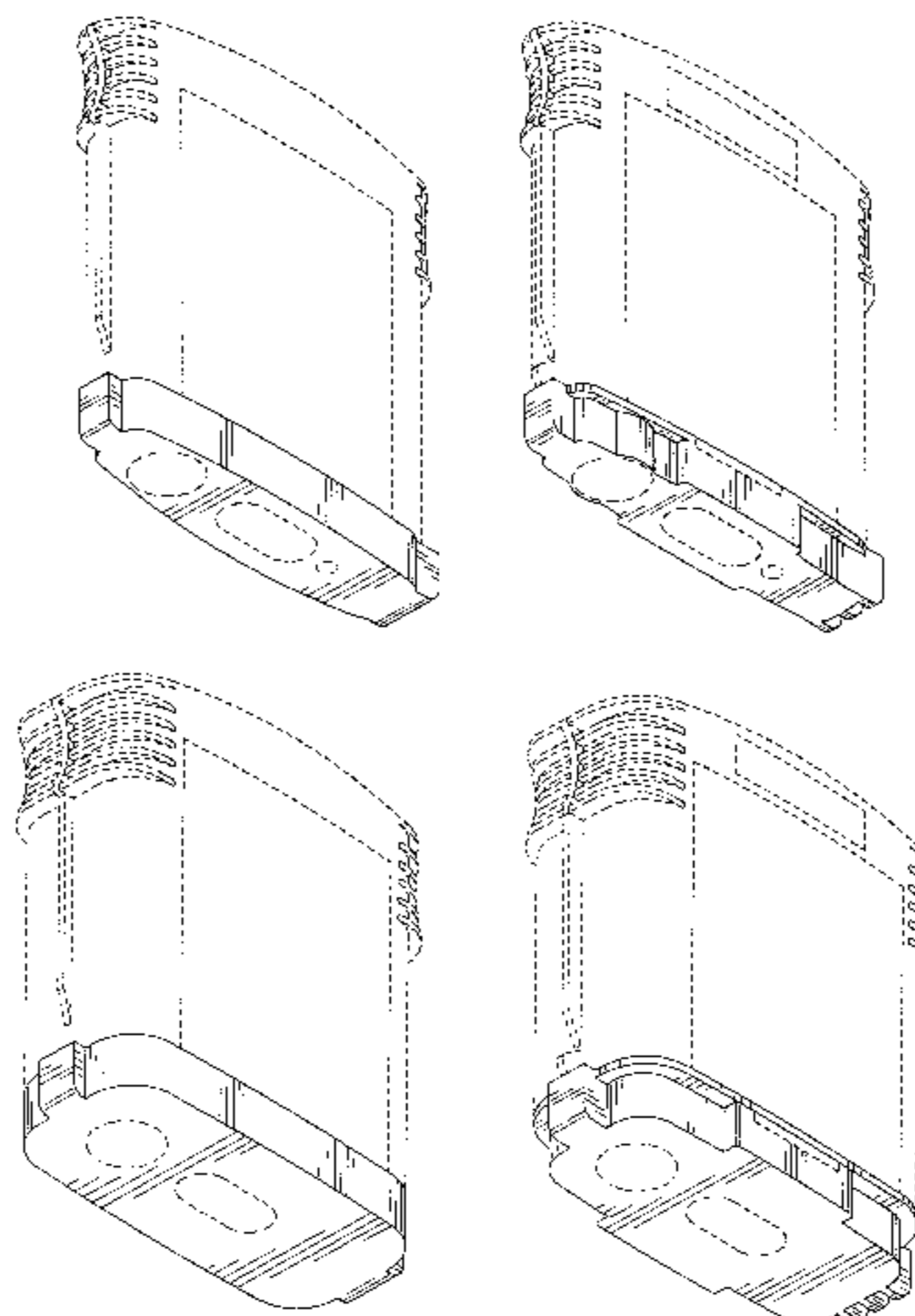
We claim the ornamental design for a fluid container cap, as
shown and described.

DESCRIPTION

FIG. 1 is bottom, front, and left side perspective view of a

fluid container cap showing our new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a left side elevation view thereof;
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a rear elevation view thereof;
FIG. 7 is a bottom, front and left side perspective view of a
second embodiment of FIG. 1;
FIG. 8 is a front elevation view of FIG. 7;
FIG. 9 is a left side elevation view of FIG. 7;
FIG. 10 is a right side elevation view of FIG. 7;
FIG. 11 is a bottom plan view of FIG. 7;
FIG. 12 is a rear elevation of FIG. 7;
FIG. 13 is a left side elevation view of a third embodiment
of FIG. 1;
FIG. 14 is a bottom plan view of FIG. 13, all other elevation
views being identical to FIGS. 2, 4 and 6;
FIG. 15 is a left side elevation view of a fourth embodiment
of FIG. 1;
FIG. 16 is a bottom plan view of FIG. 15, all other elevation
views being identical to FIGS. 2, 4 and 6.
FIG. 17 is a bottom, front and left side perspective view of
a fifth embodiment of FIG. 1;
FIG. 18 is a front elevation view of FIG. 17, the rear
elevation view being a mirror image of the front view;
FIG. 19 is a left side elevation view of FIG. 17;
FIG. 20 is a right side elevation view of FIG. 17;
FIG. 21 is a bottom plan view of FIG. 17;
FIG. 22 is a bottom, front, and left side perspective view of
a sixth embodiment of FIG. 1;
FIG. 23 is a front elevation view of FIG. 22, the rear
elevation view being mirror image of the front view;
FIG. 24 is a left side elevation view of FIG. 22;
FIG. 25 is a right side elevation view of FIG. 22;
FIG. 26 is a bottom plan view of FIG. 22;
FIG. 27 is a left side elevation view of a seventh embodi-
ment of FIG. 1;
FIG. 28 is a bottom plan view of FIG. 27, all other elevation
views being identical to FIGS. 18, 19, and 20;
FIG. 29 is a left side elevation view of an eighth embodiment
of FIG. 1; and,
FIG. 30 is a bottom plan view of FIG. 29, all other elevation
views being identical to FIGS. 23 and 25.
Broken lines in FIGS. 1 through 30 are for illustrative
purposes only and form no part of the claimed design.

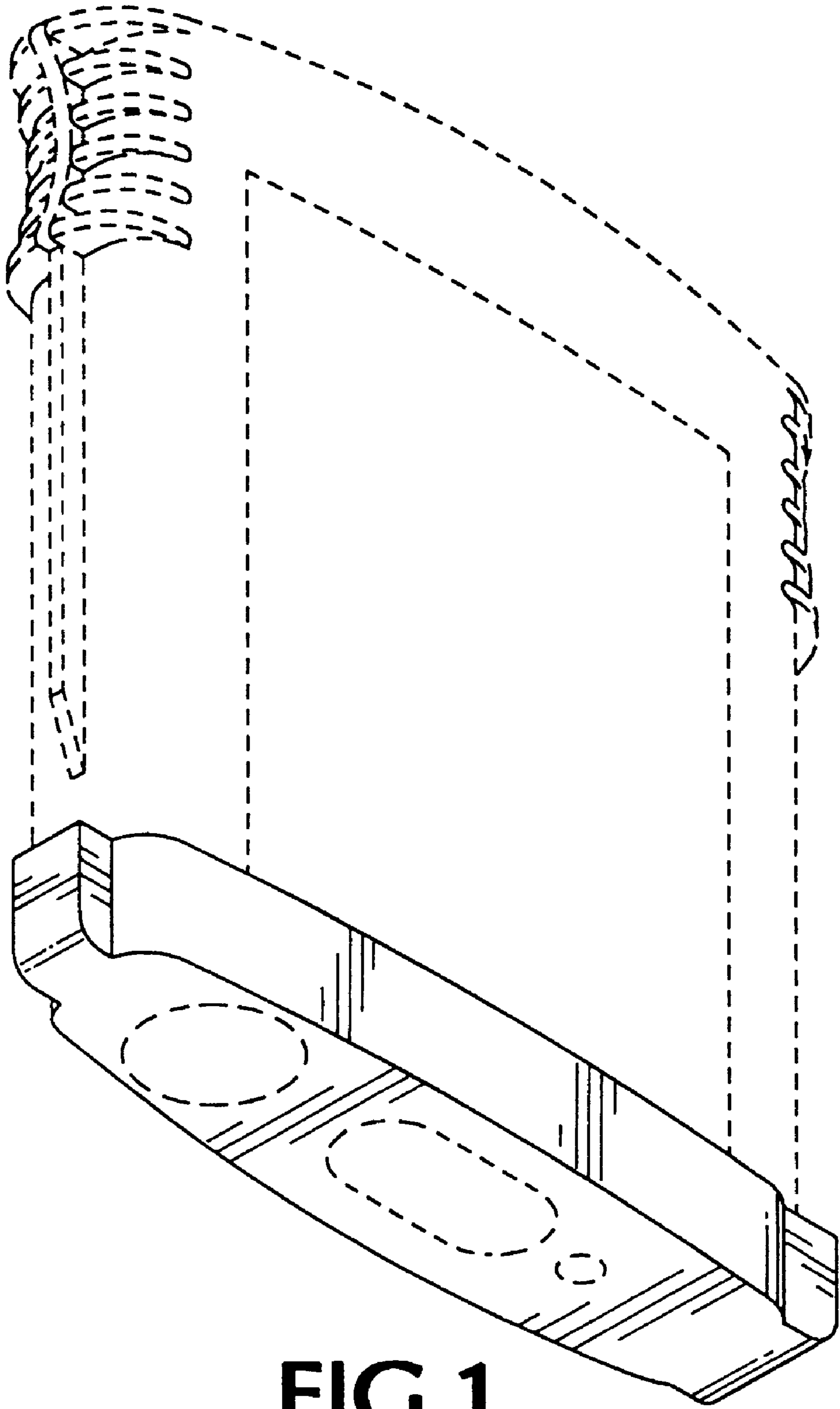

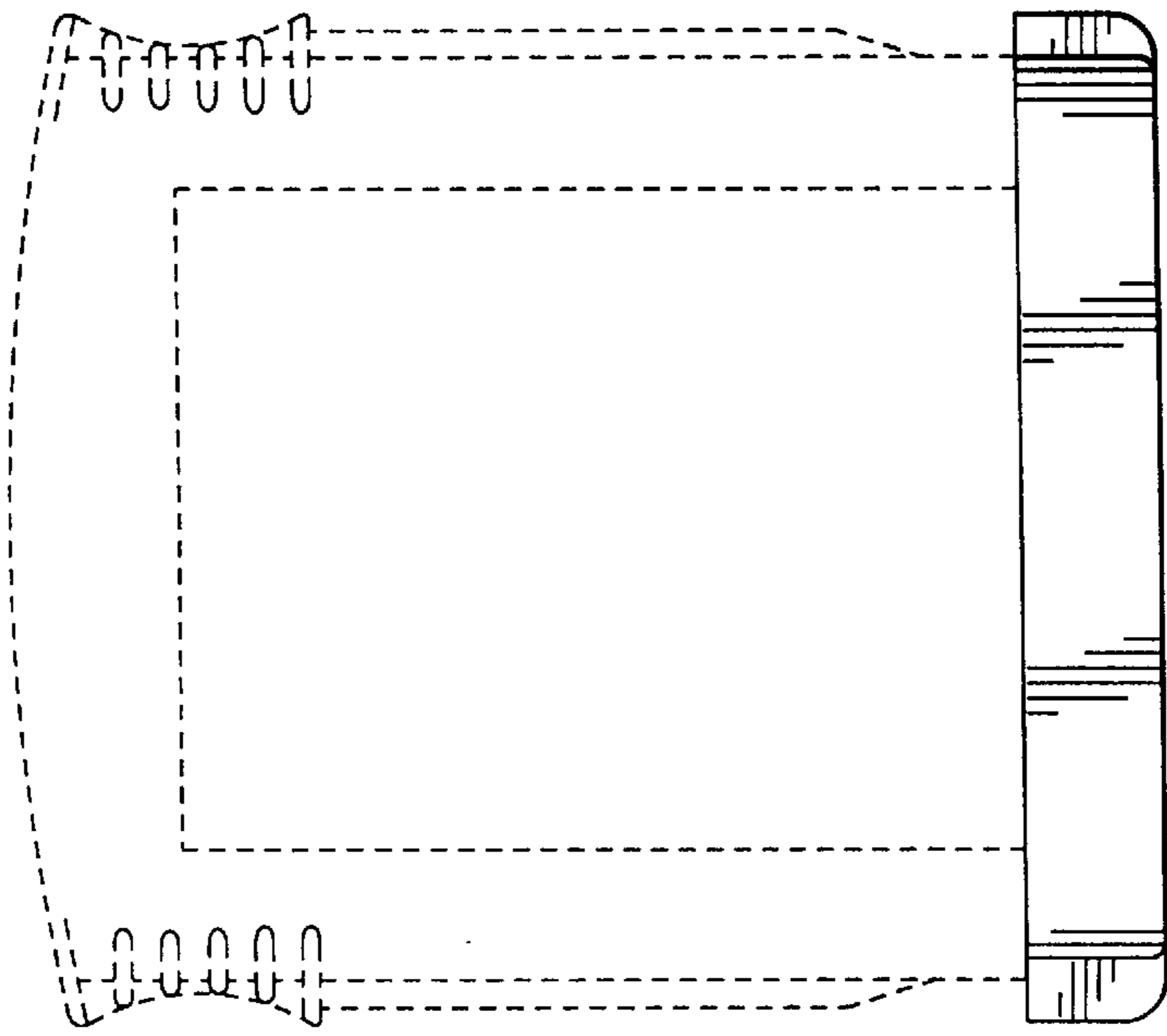

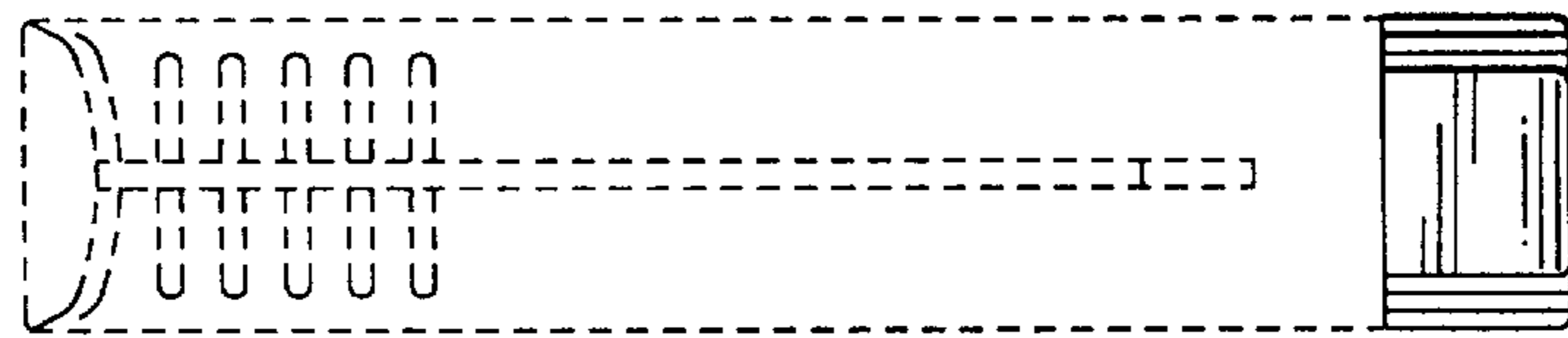

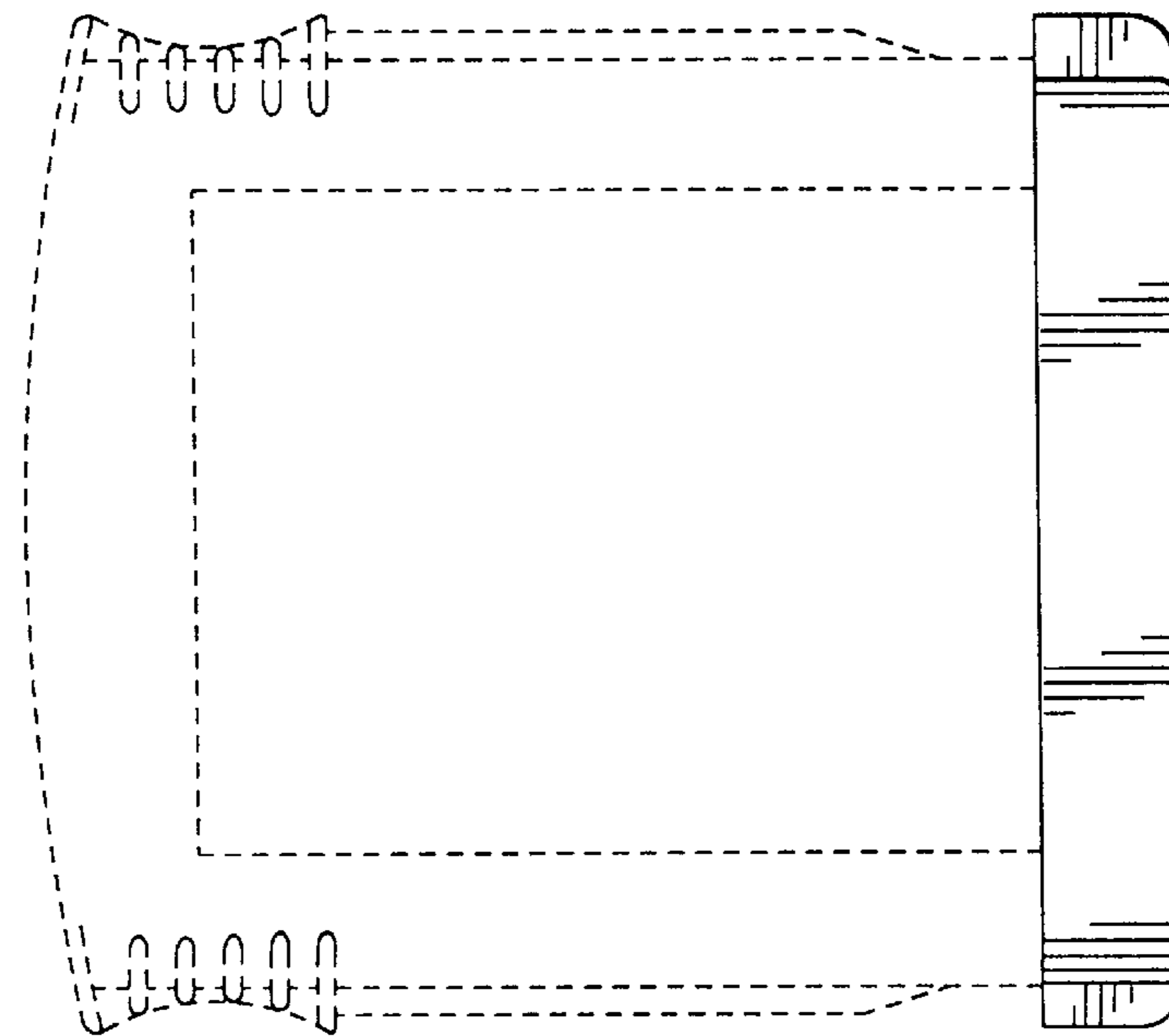

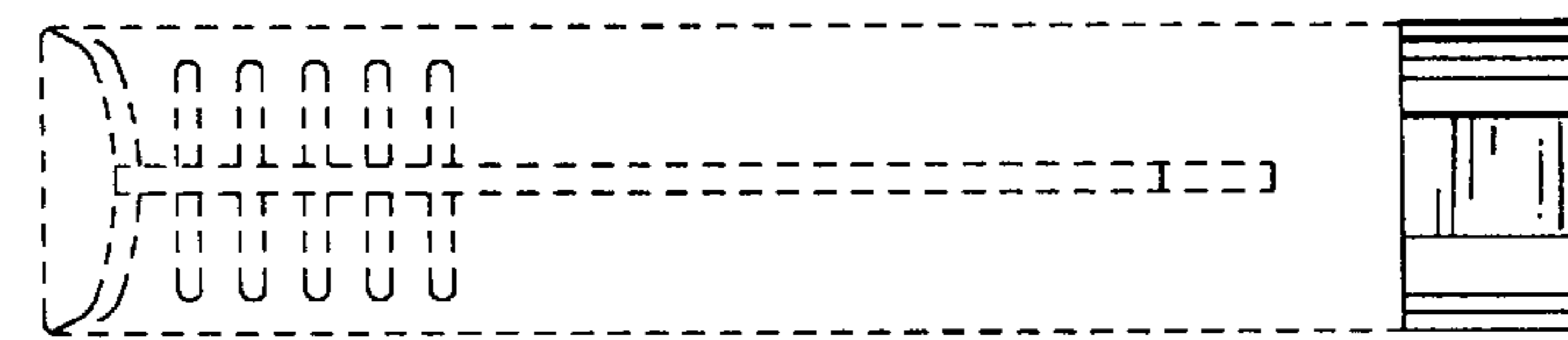

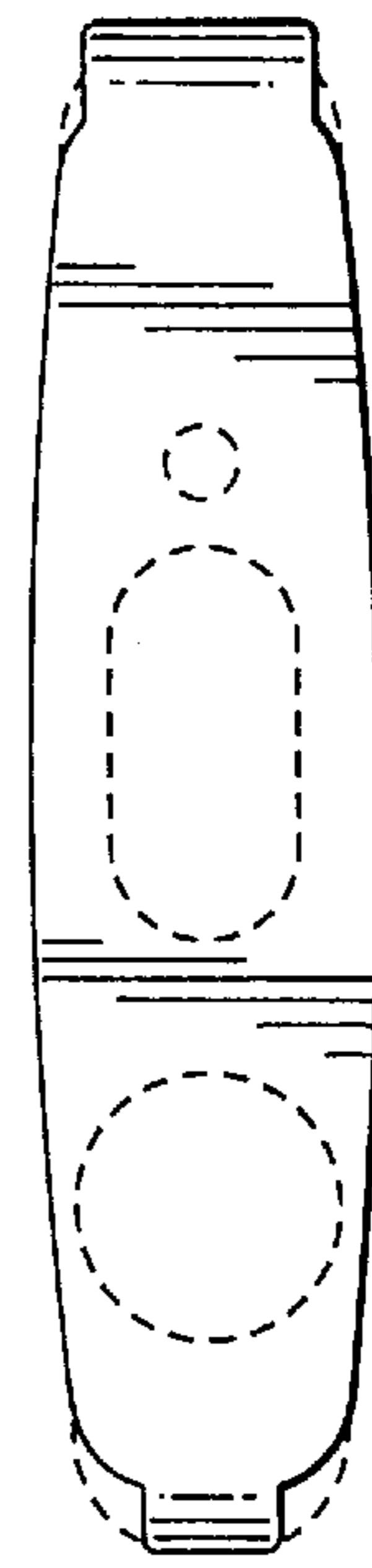

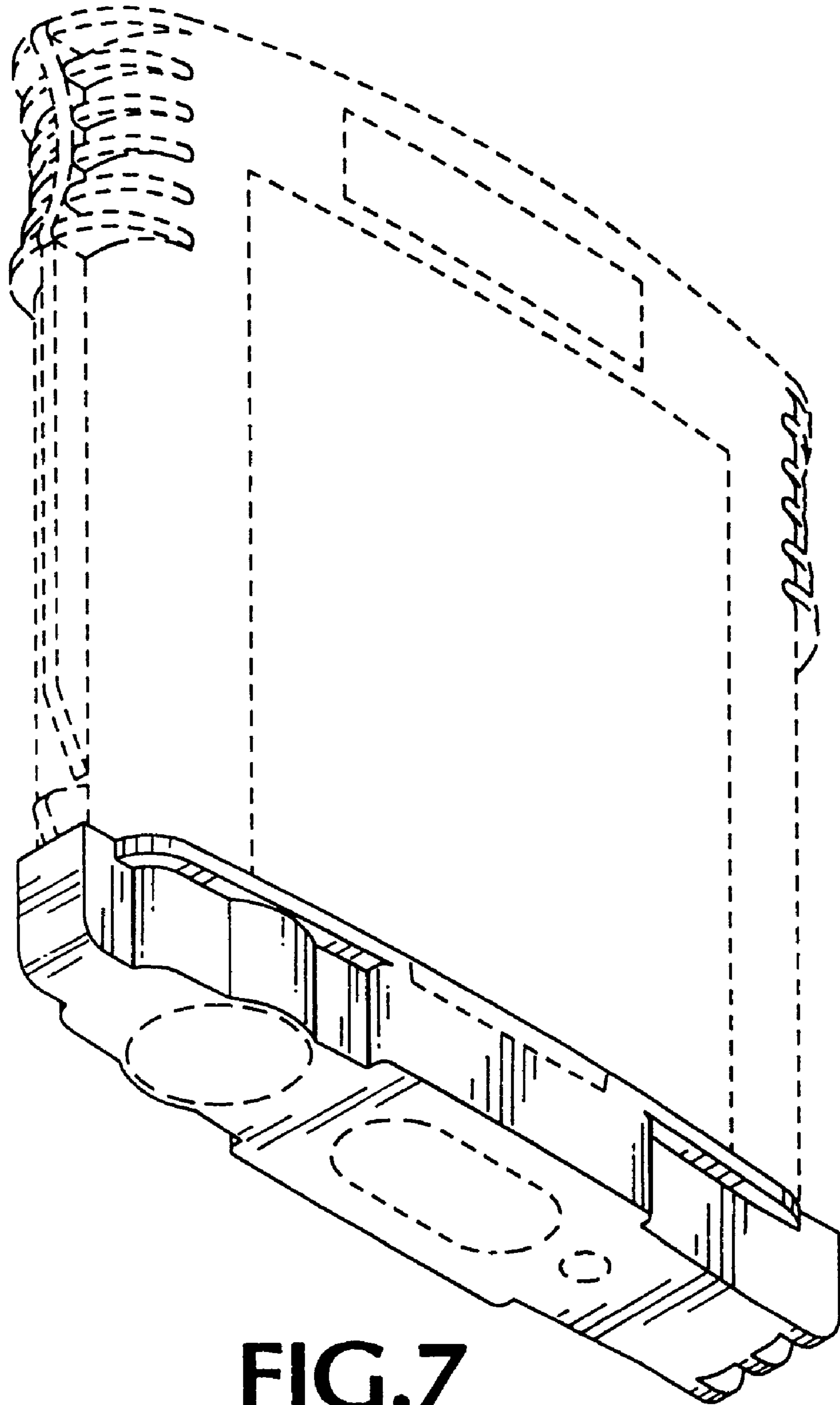

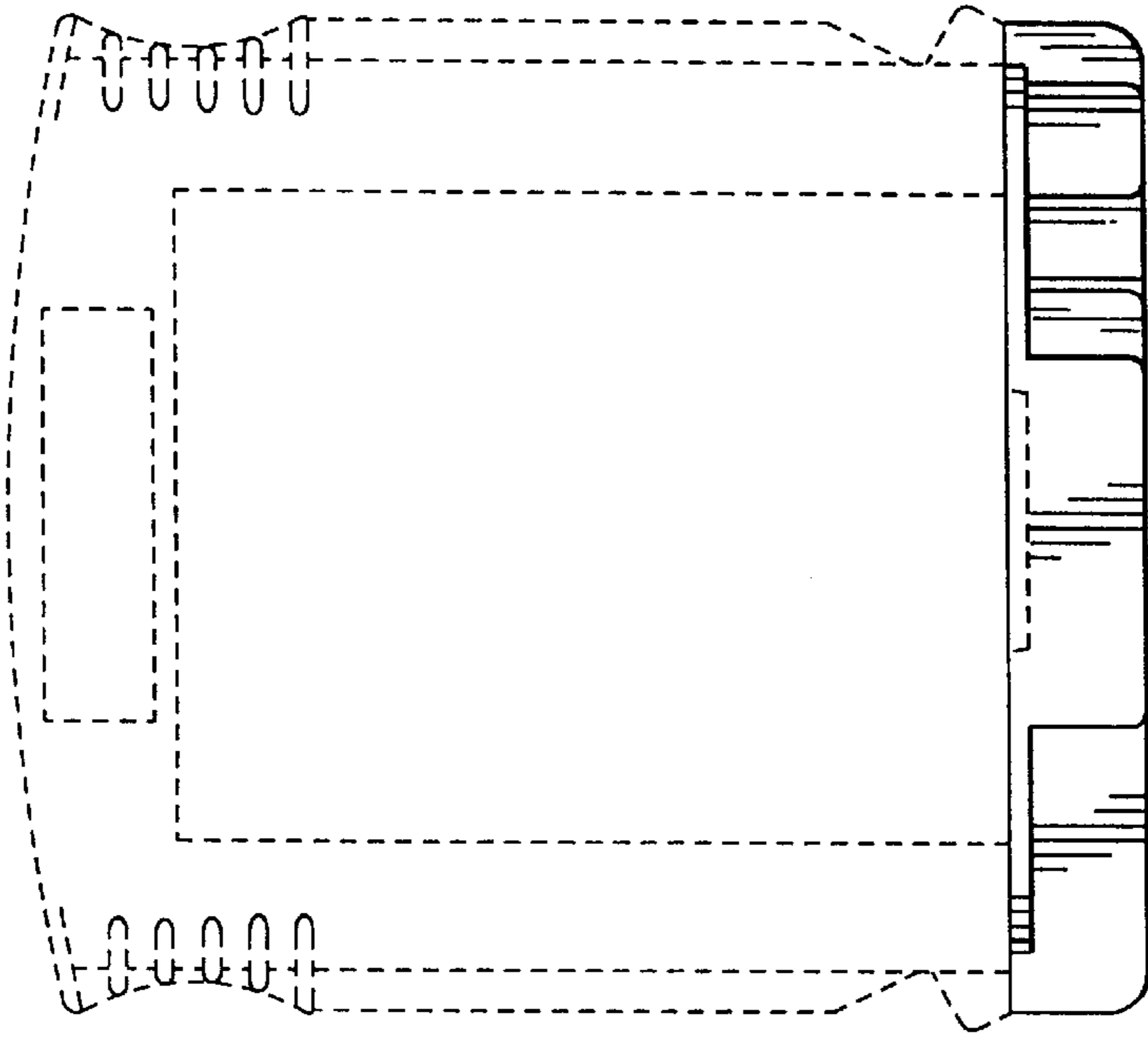

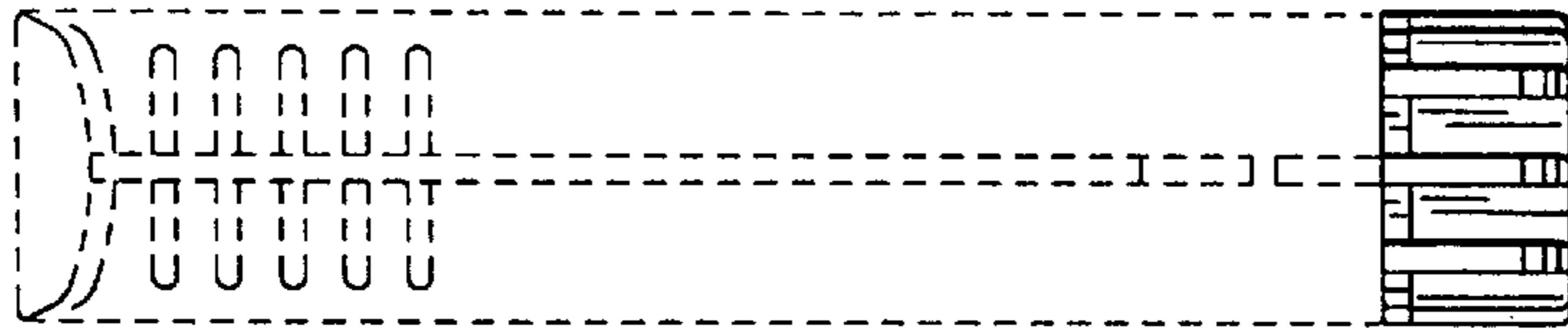

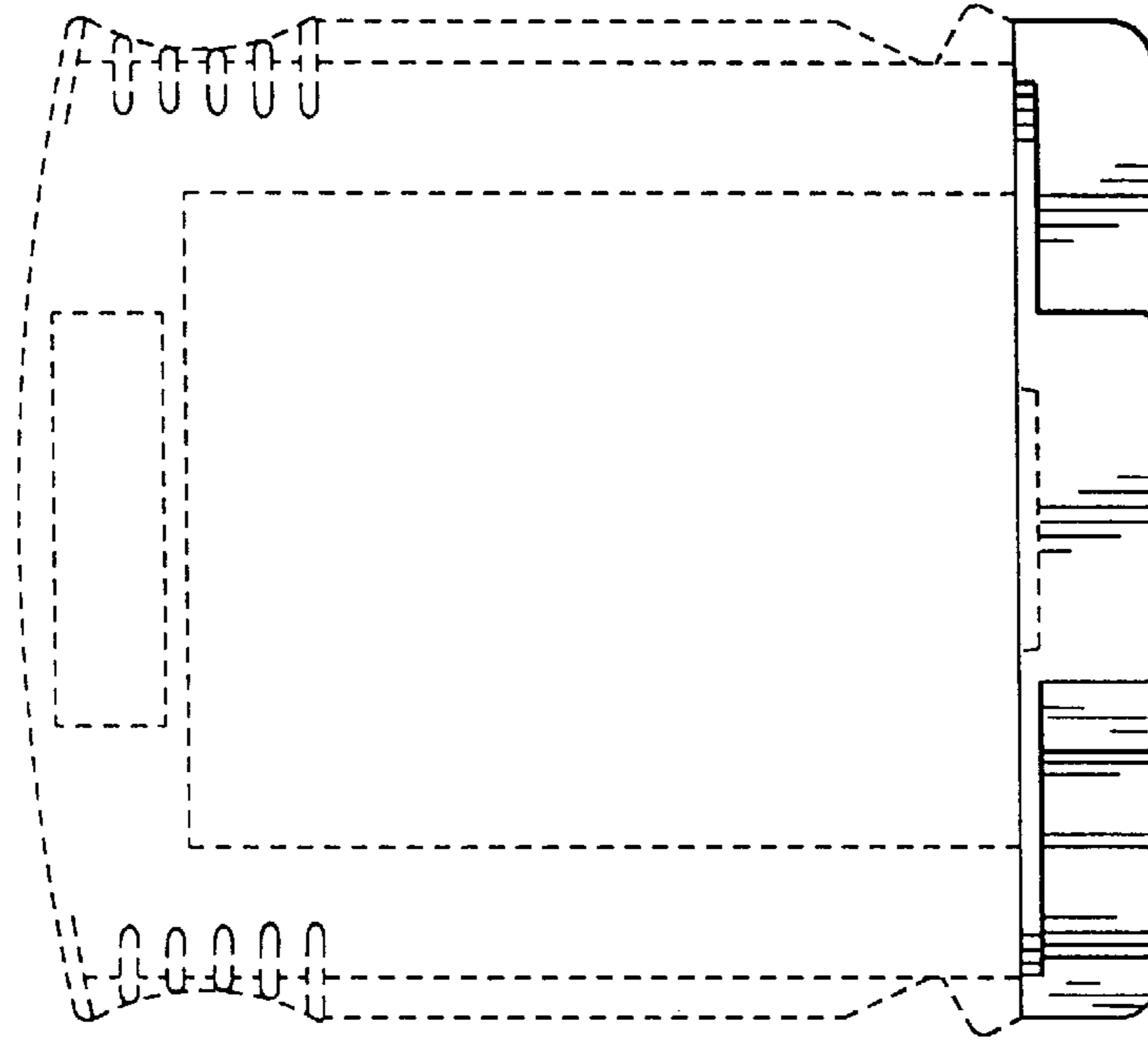

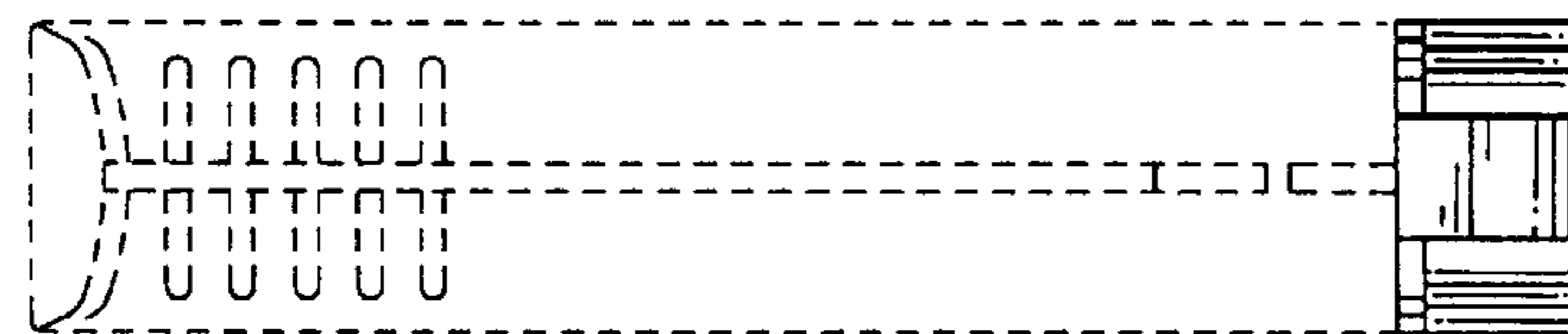

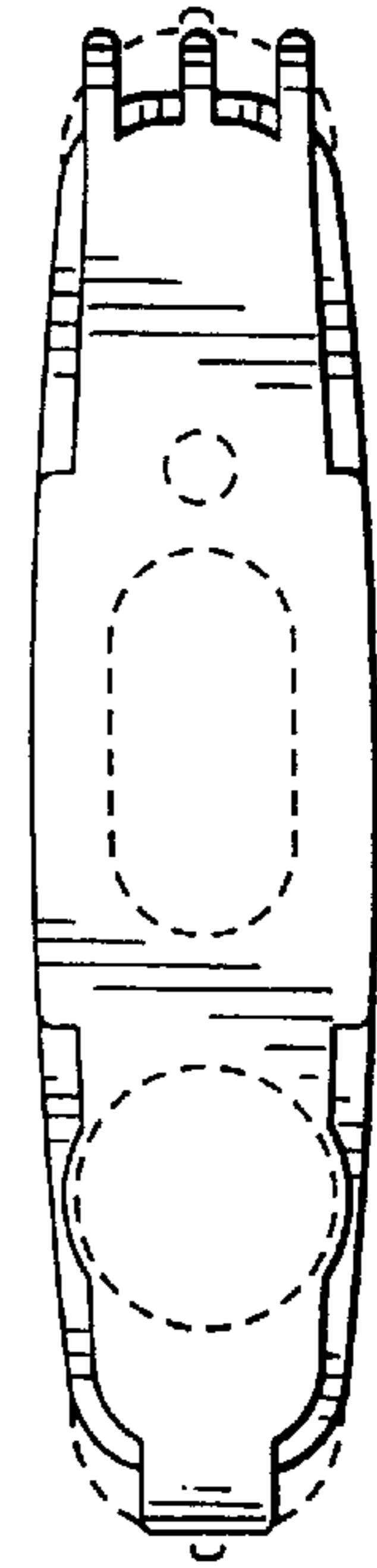

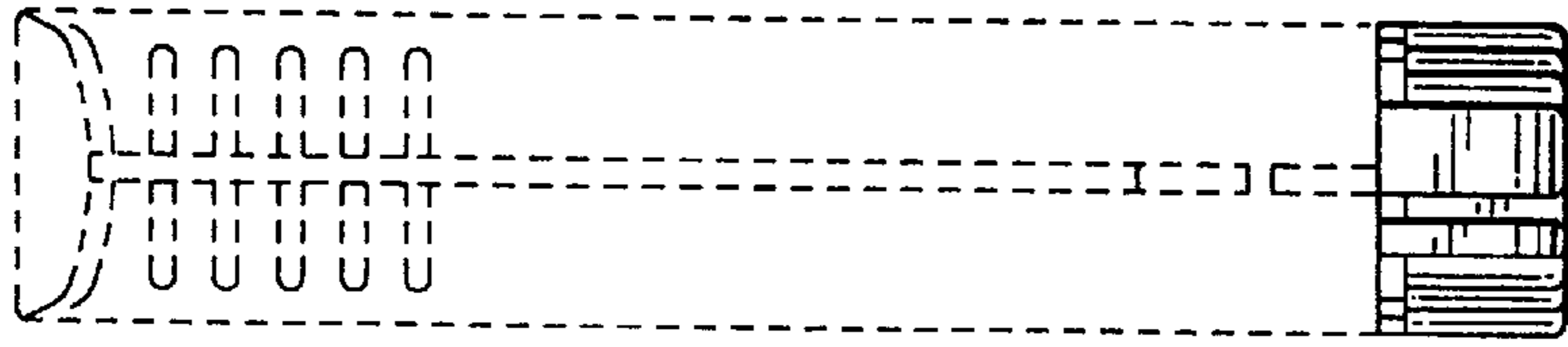

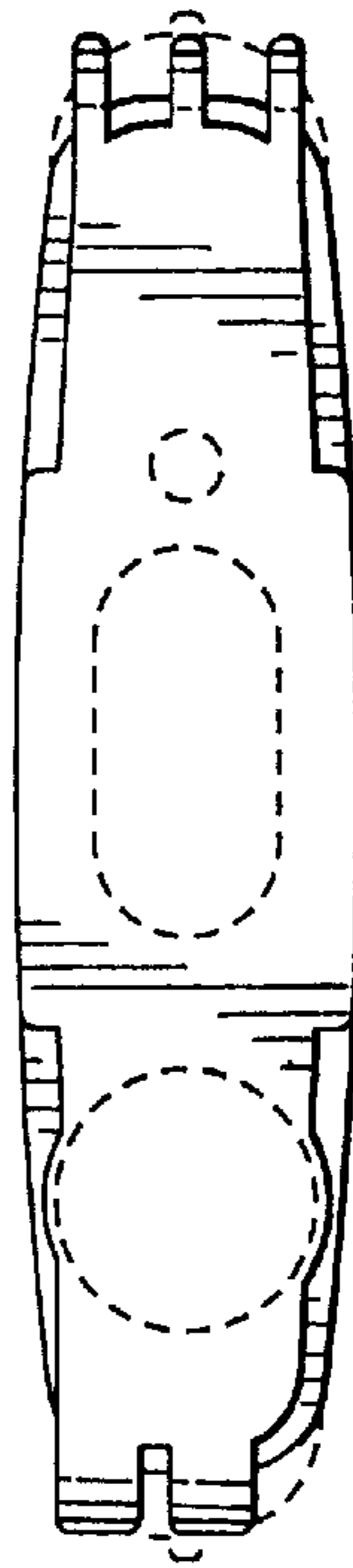

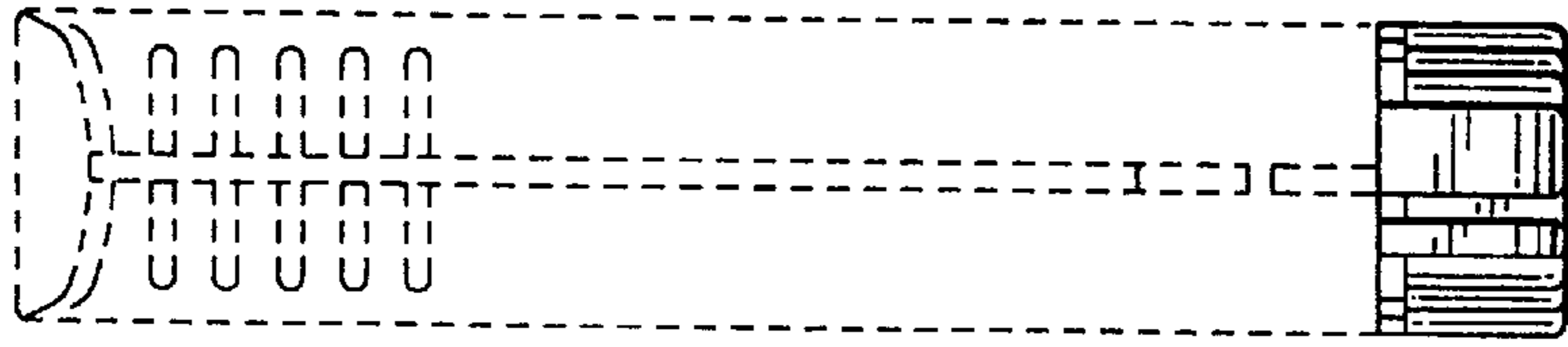

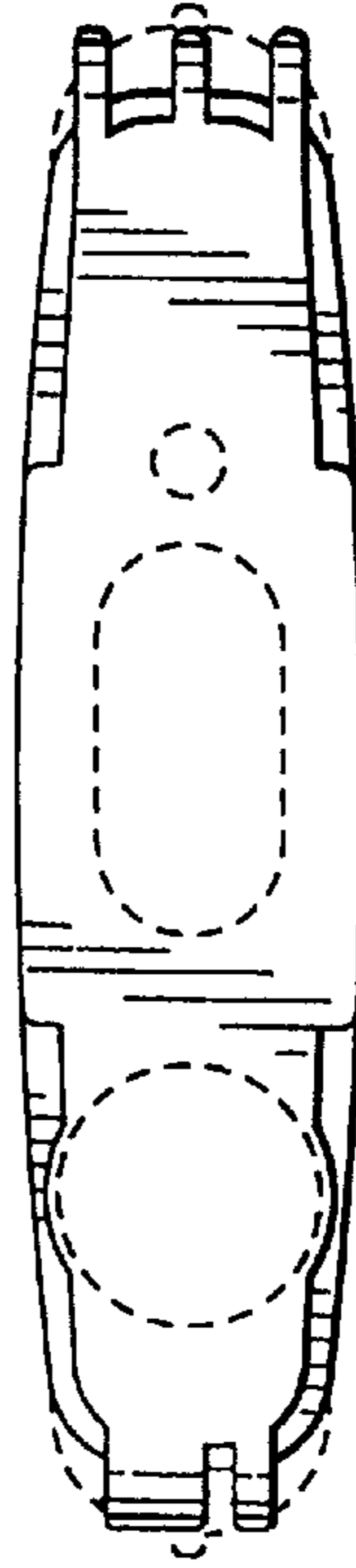

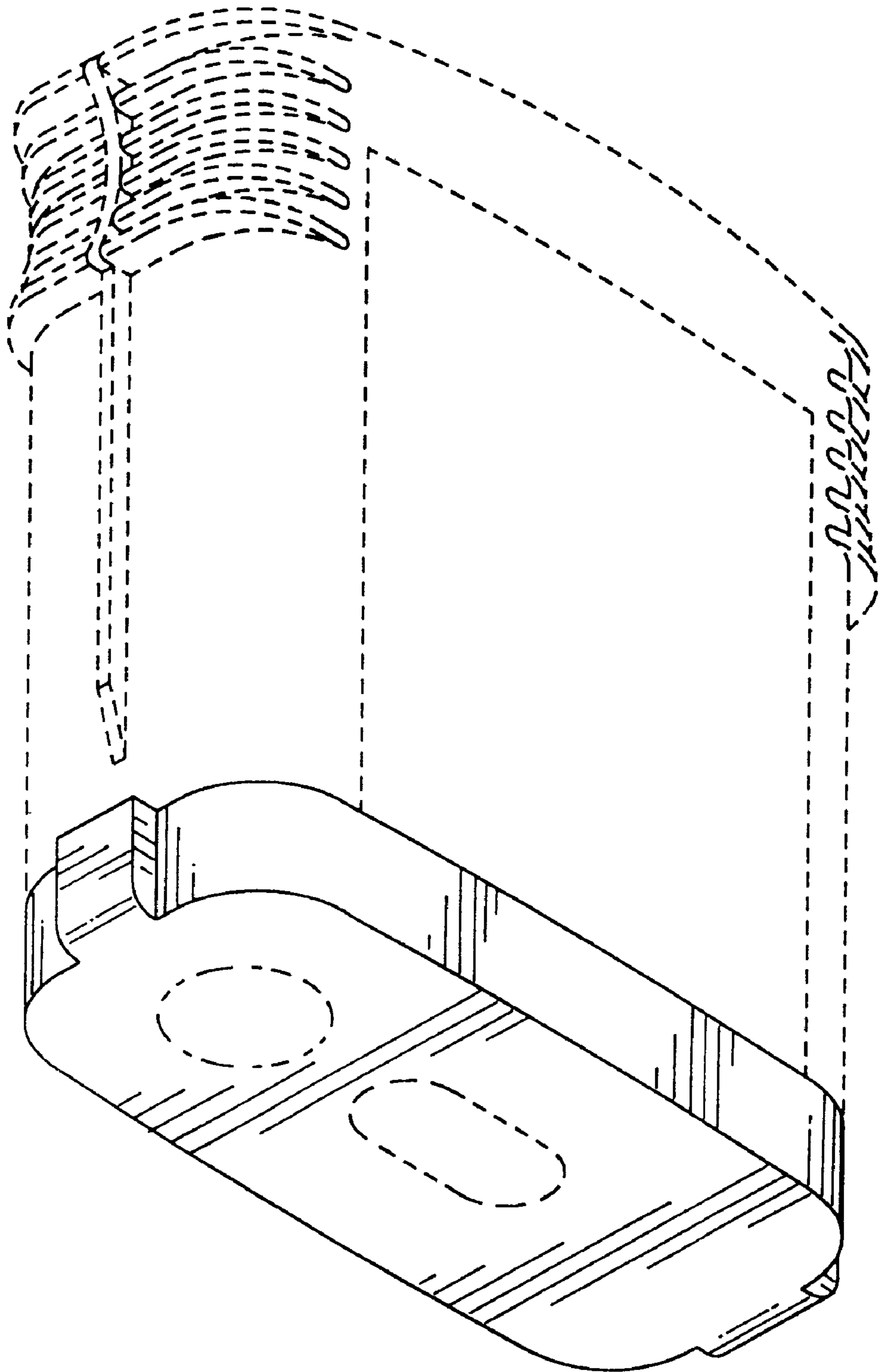

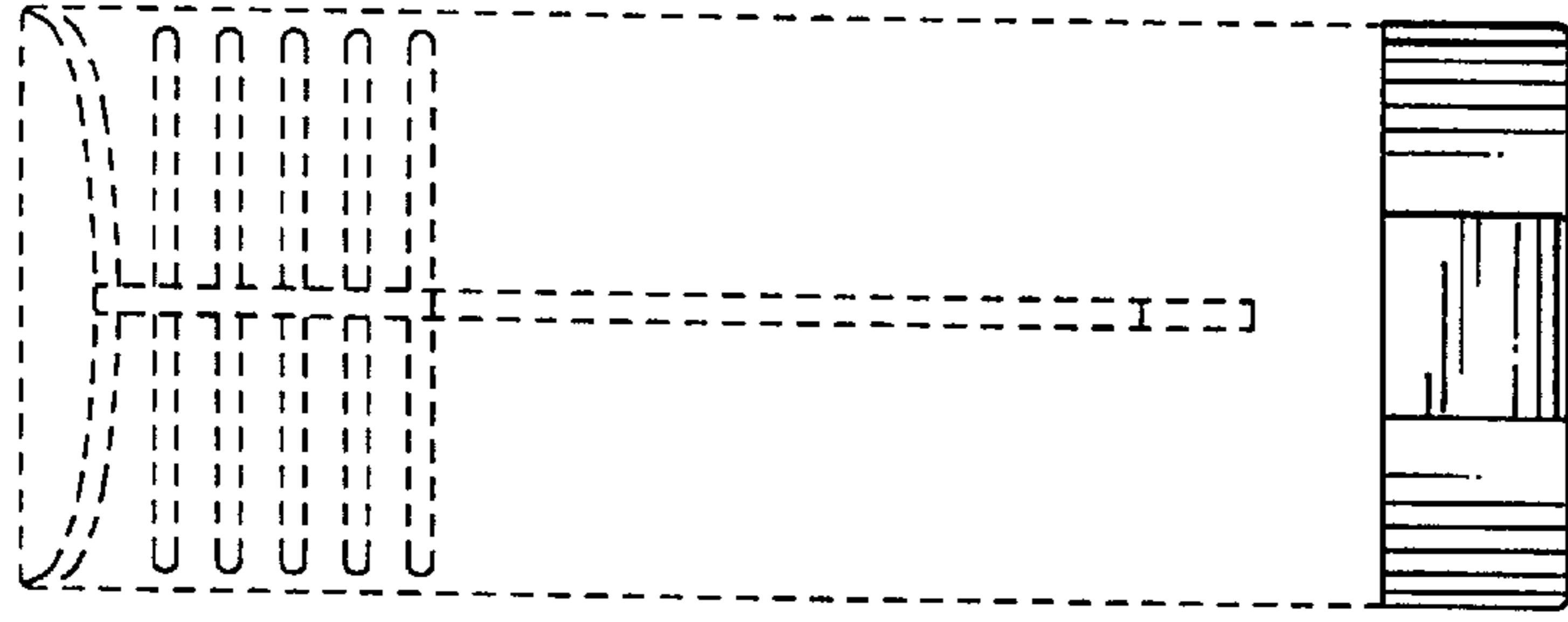

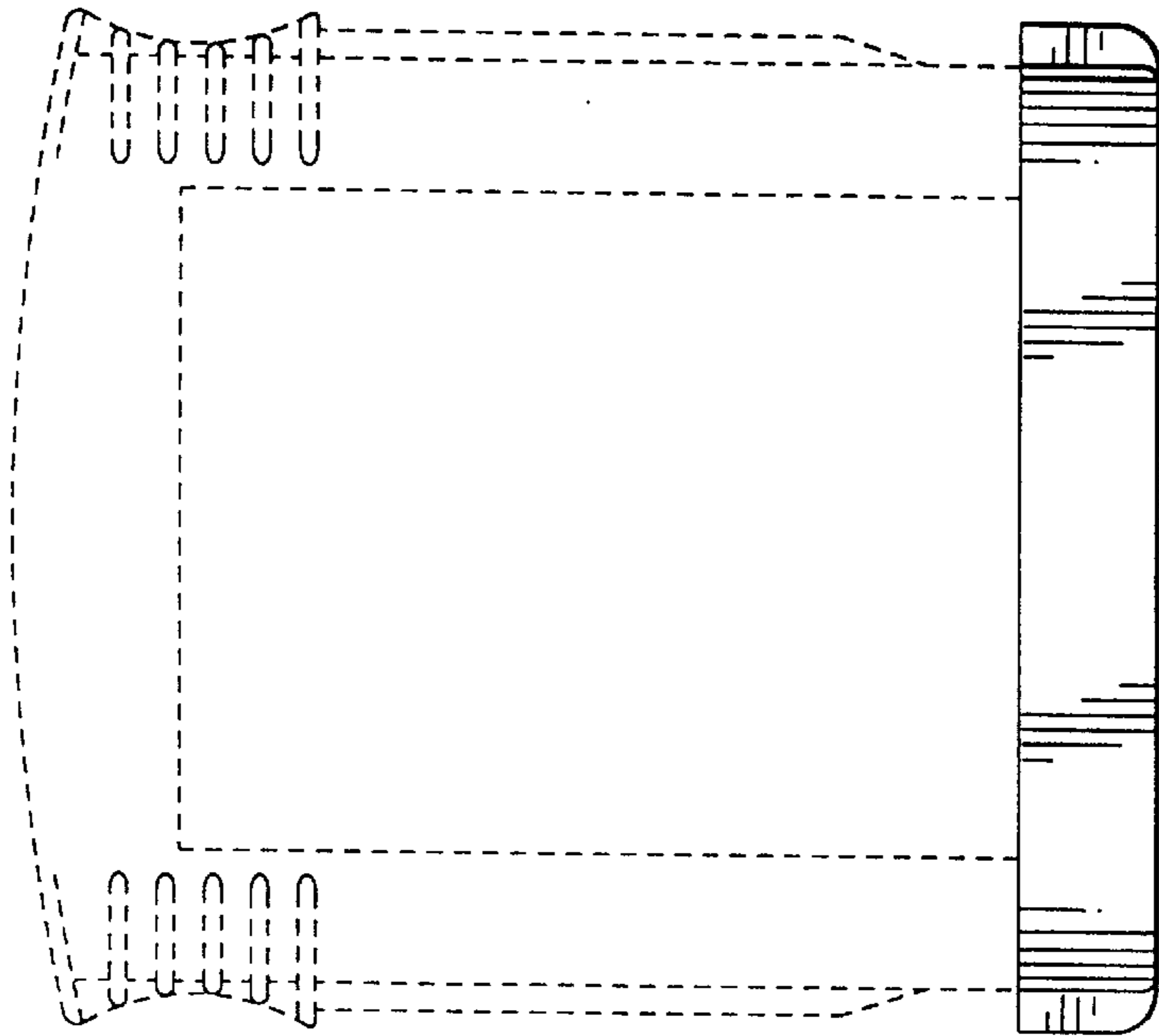

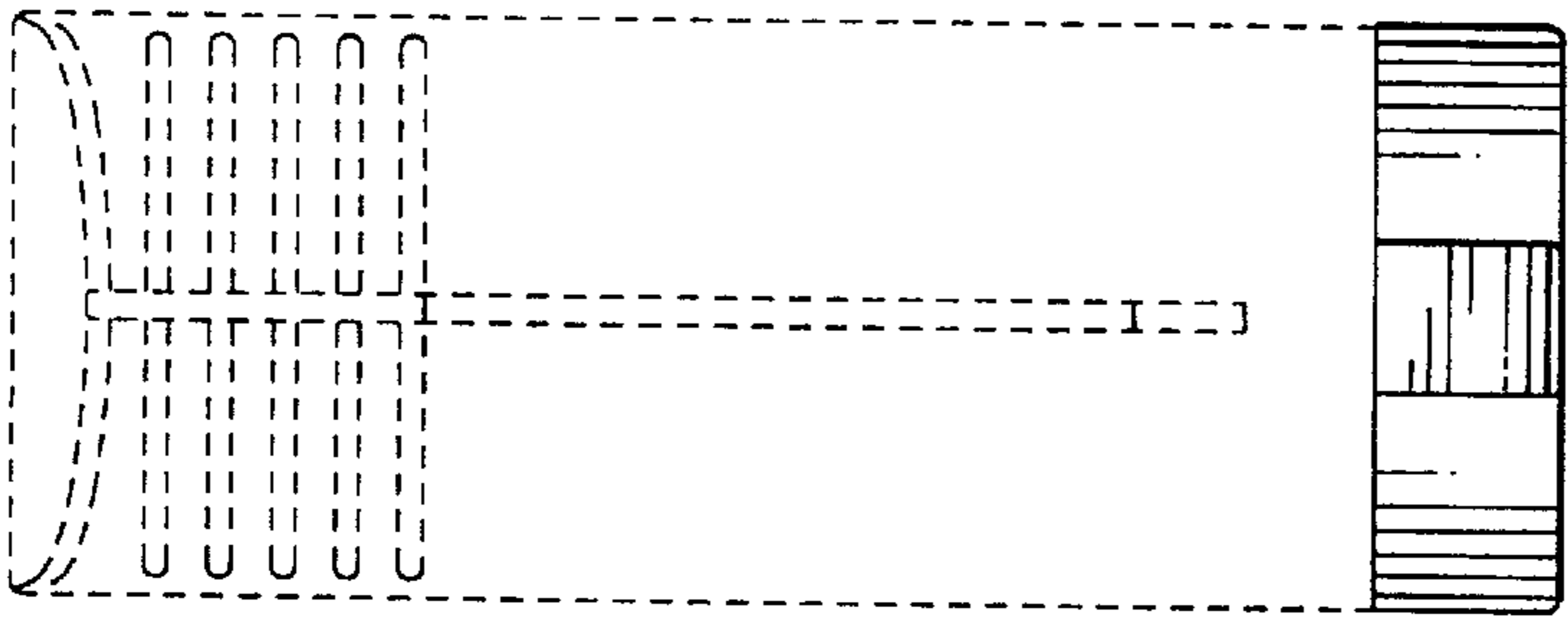

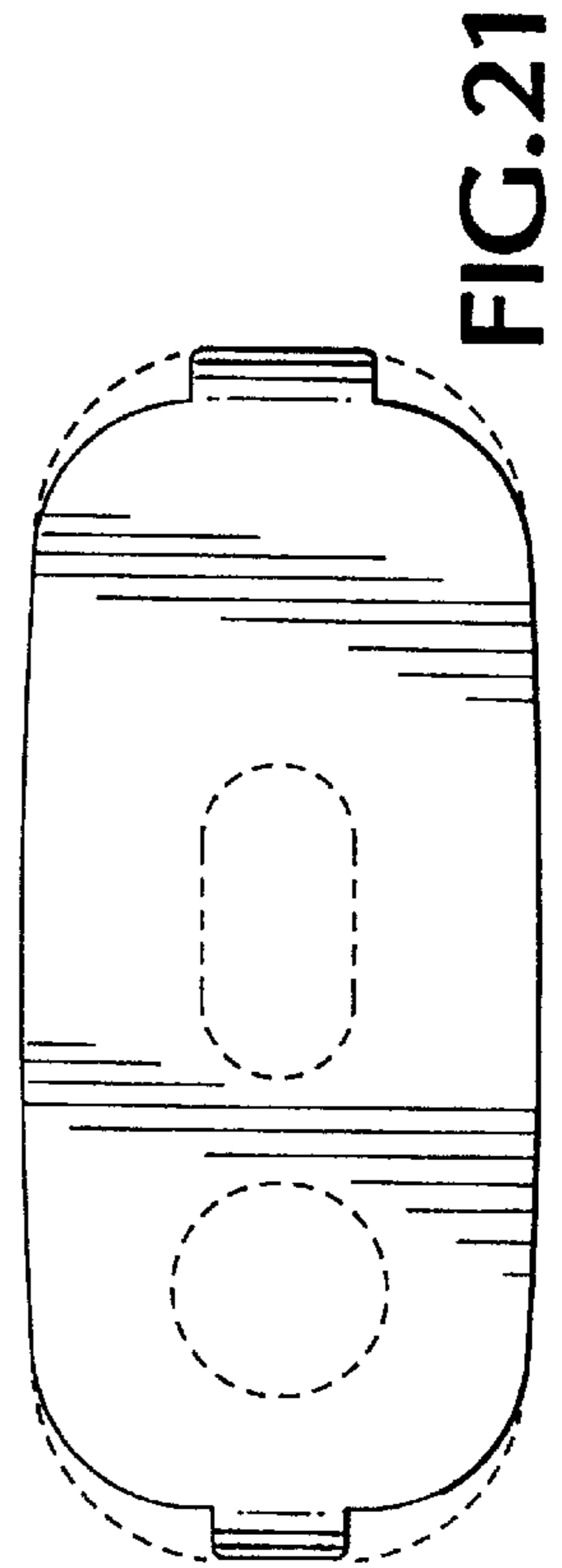

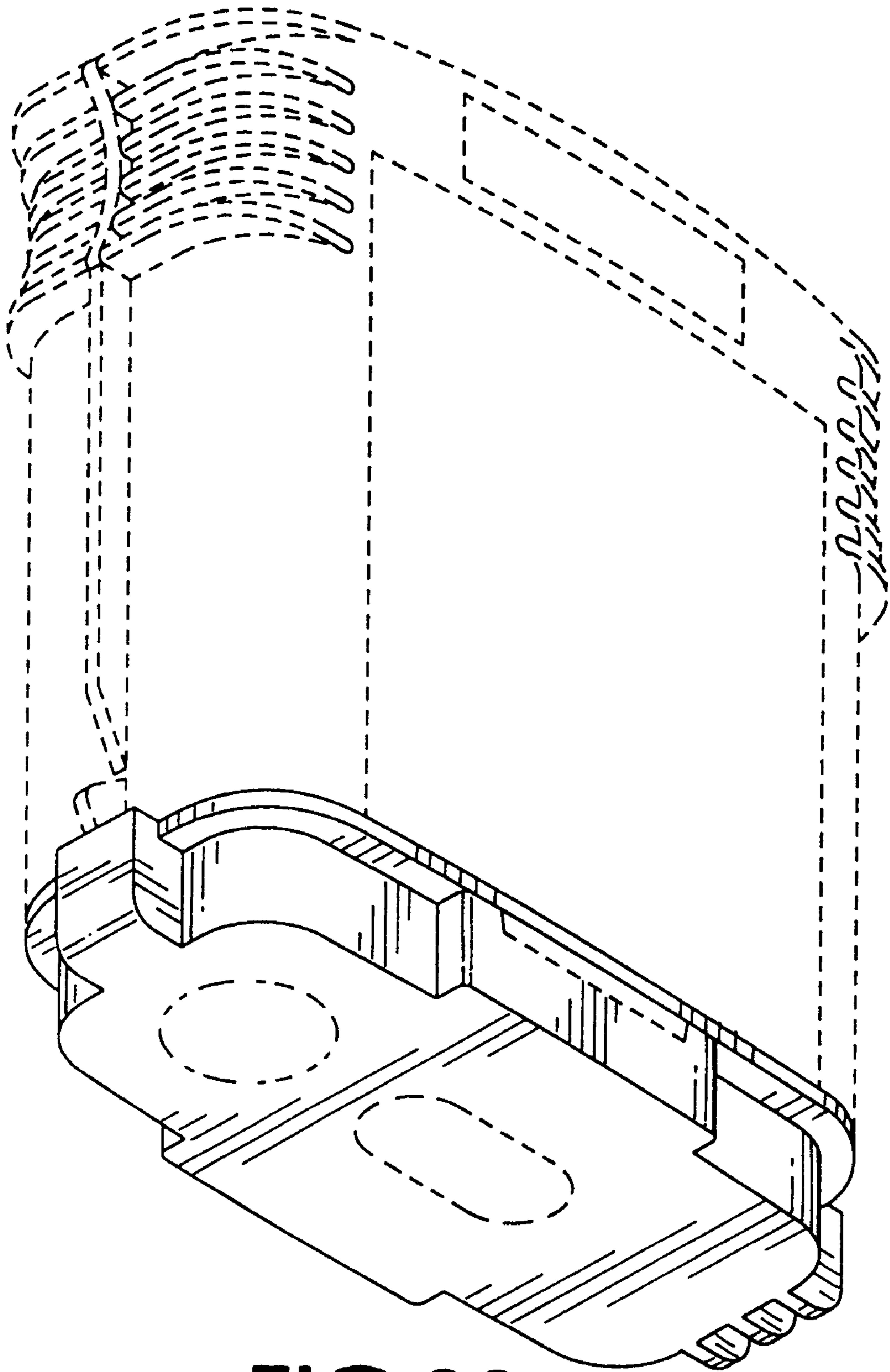

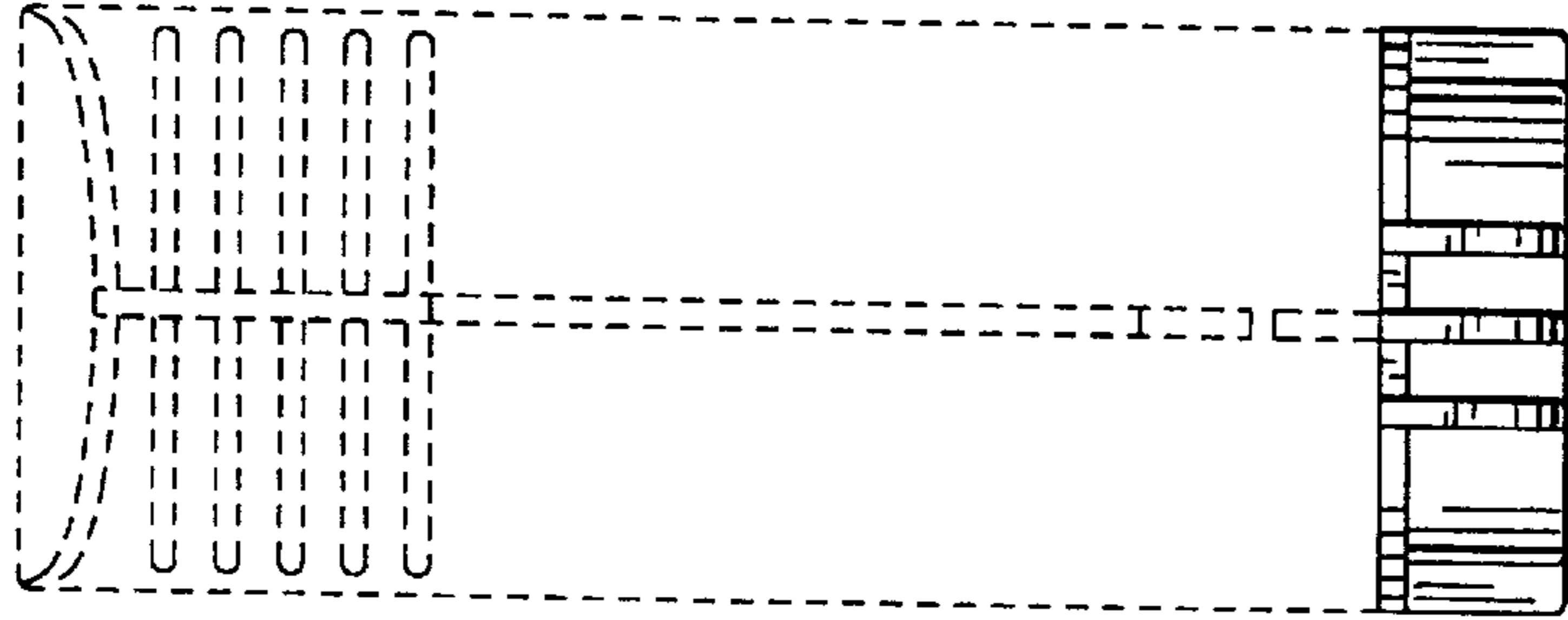

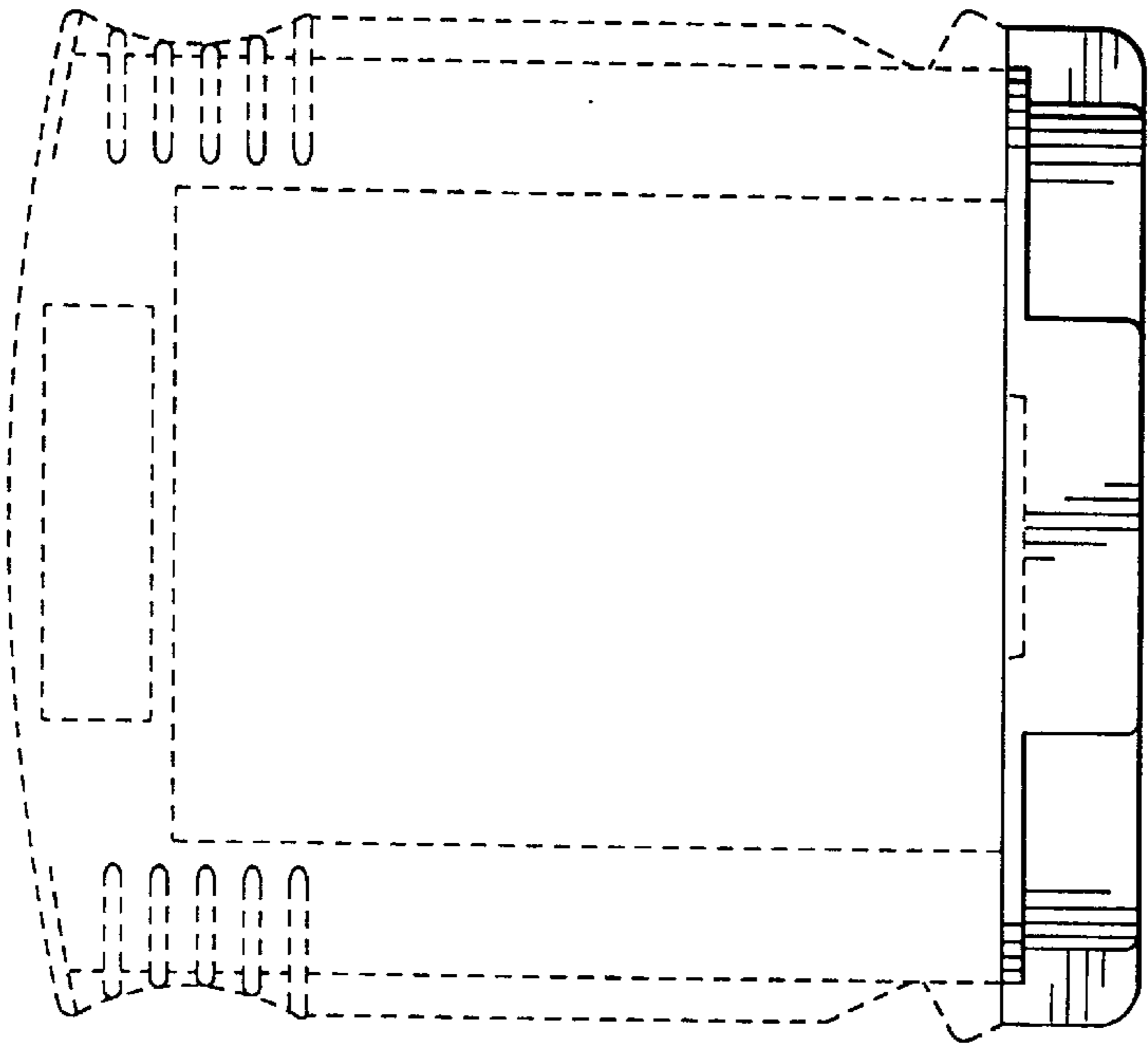

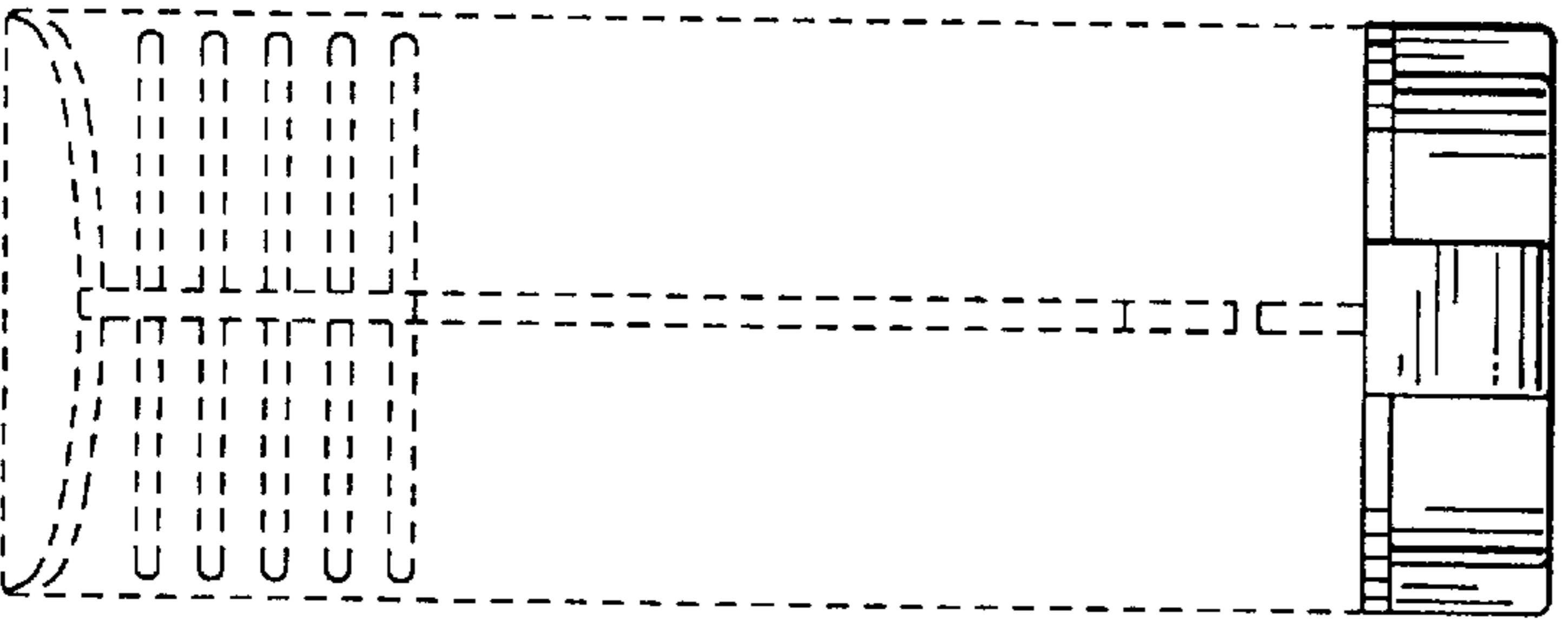

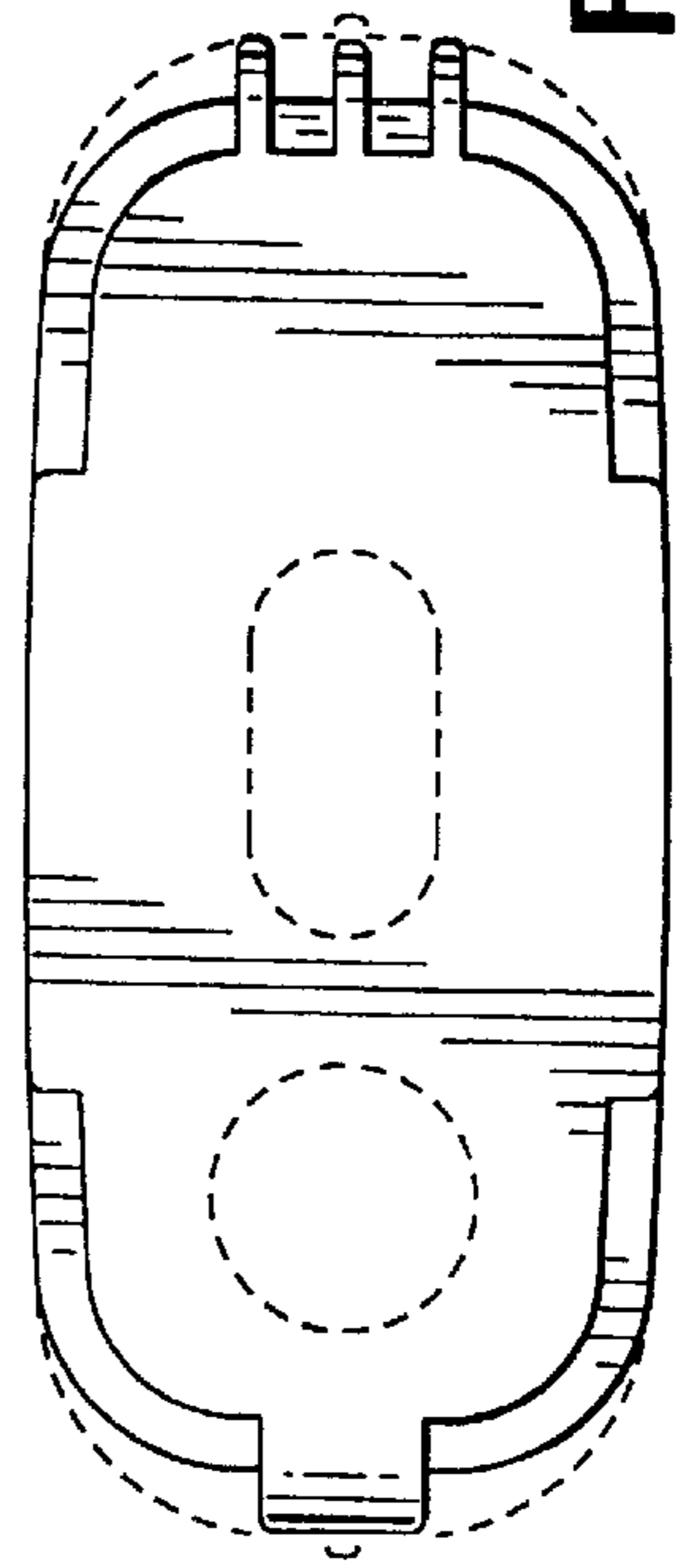

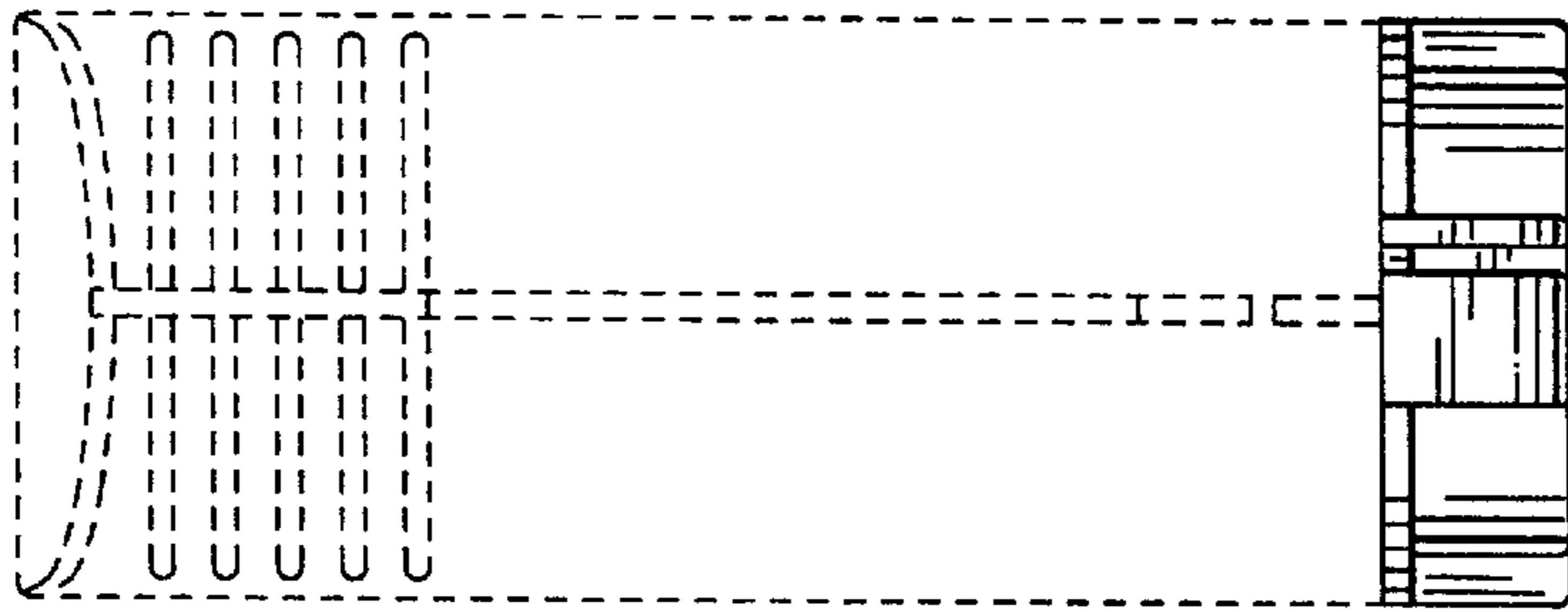

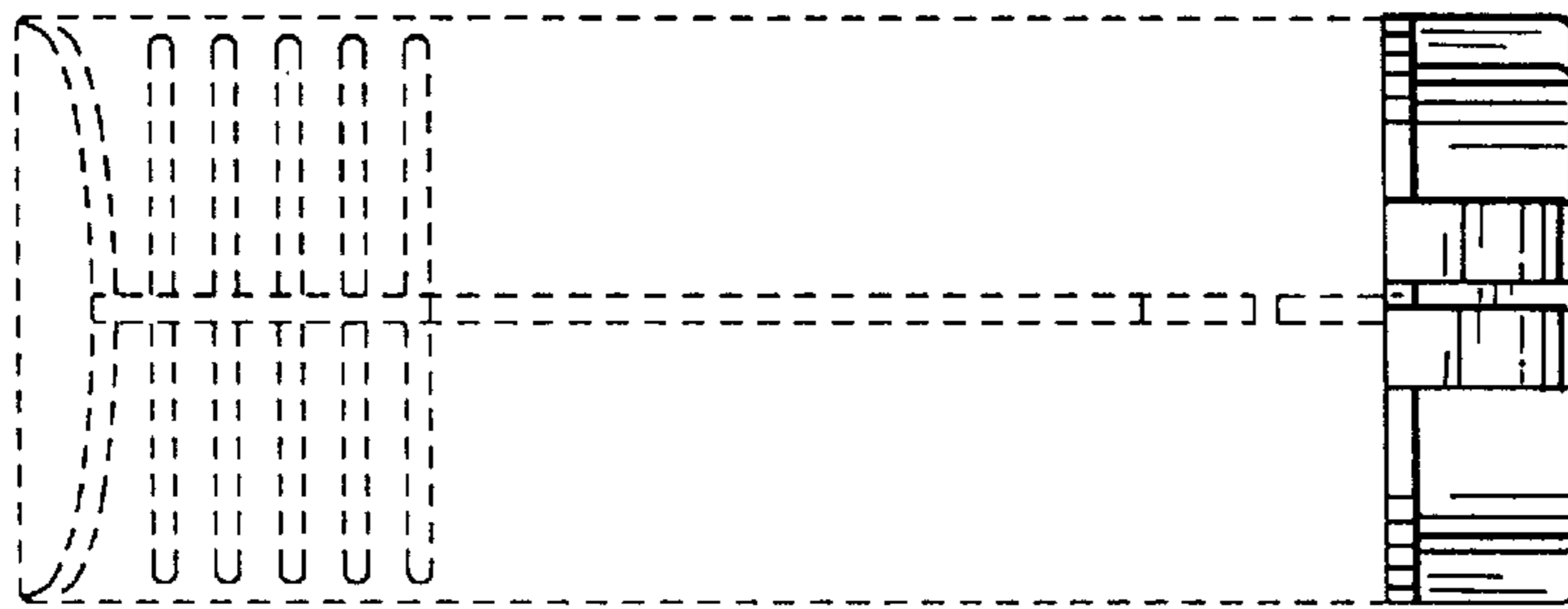

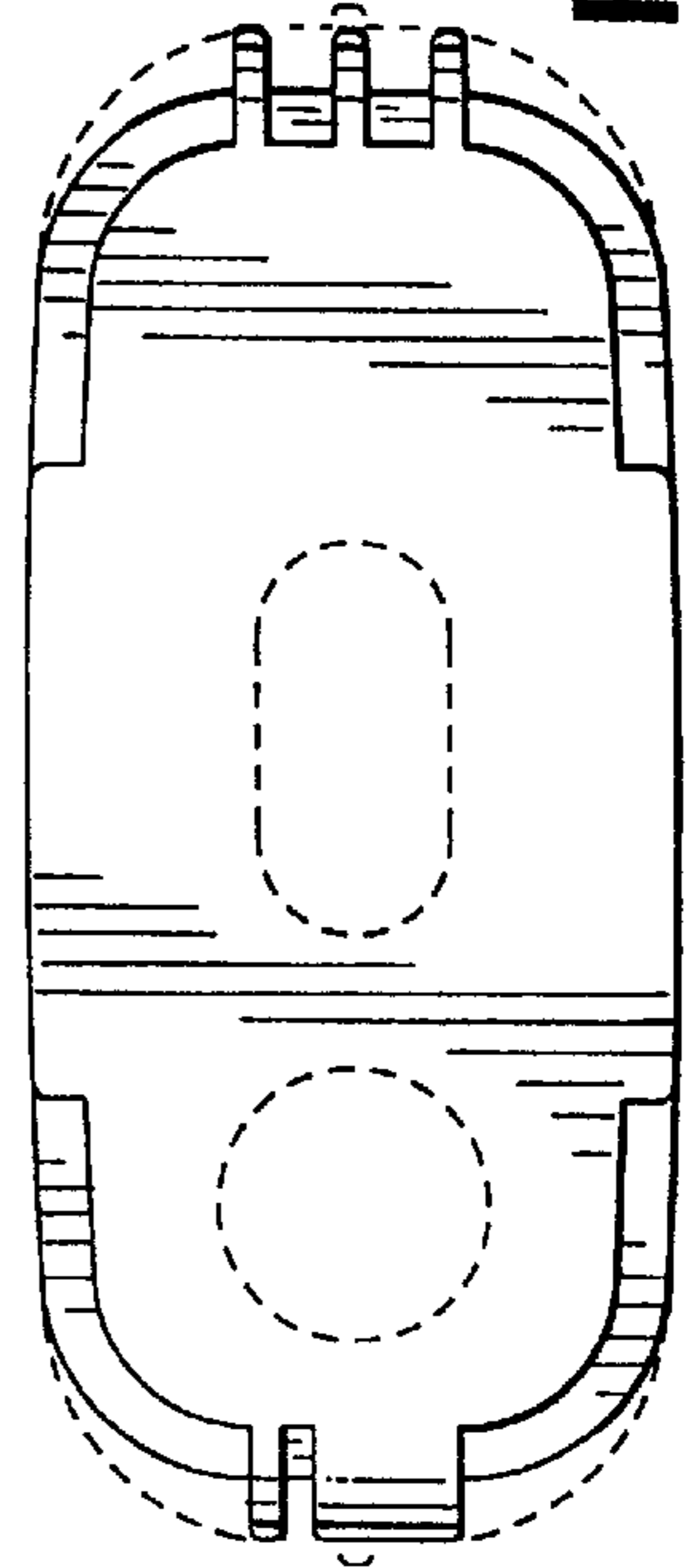

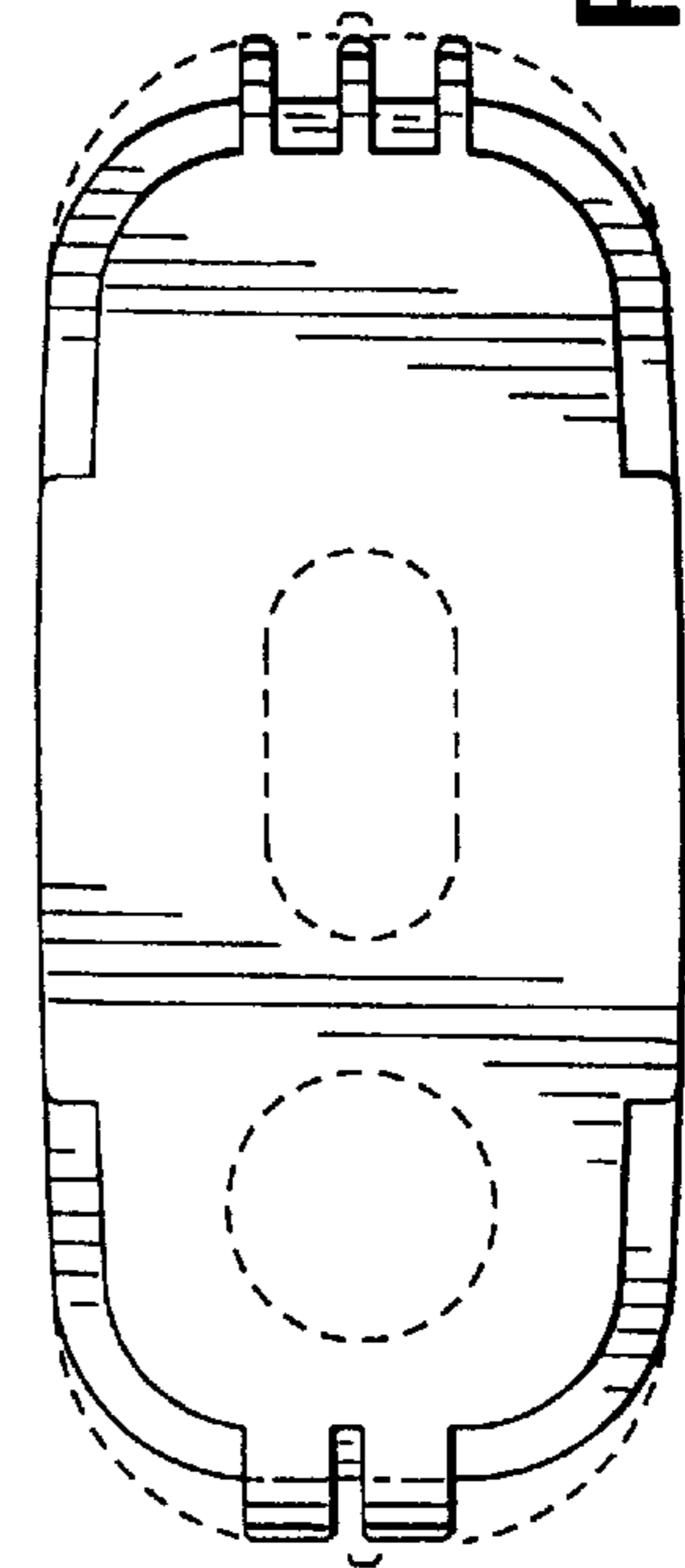
