[57] **CLAIM**

I claim the ornamental design for a hand held game machine, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of an embodiment of a hand held game machine embodying the new design.

FIG. 2 is a right side view of the embodiment depicted in FIG. 1.

FIG. 3 is a left side view of the embodiment depicted in FIG. 1.

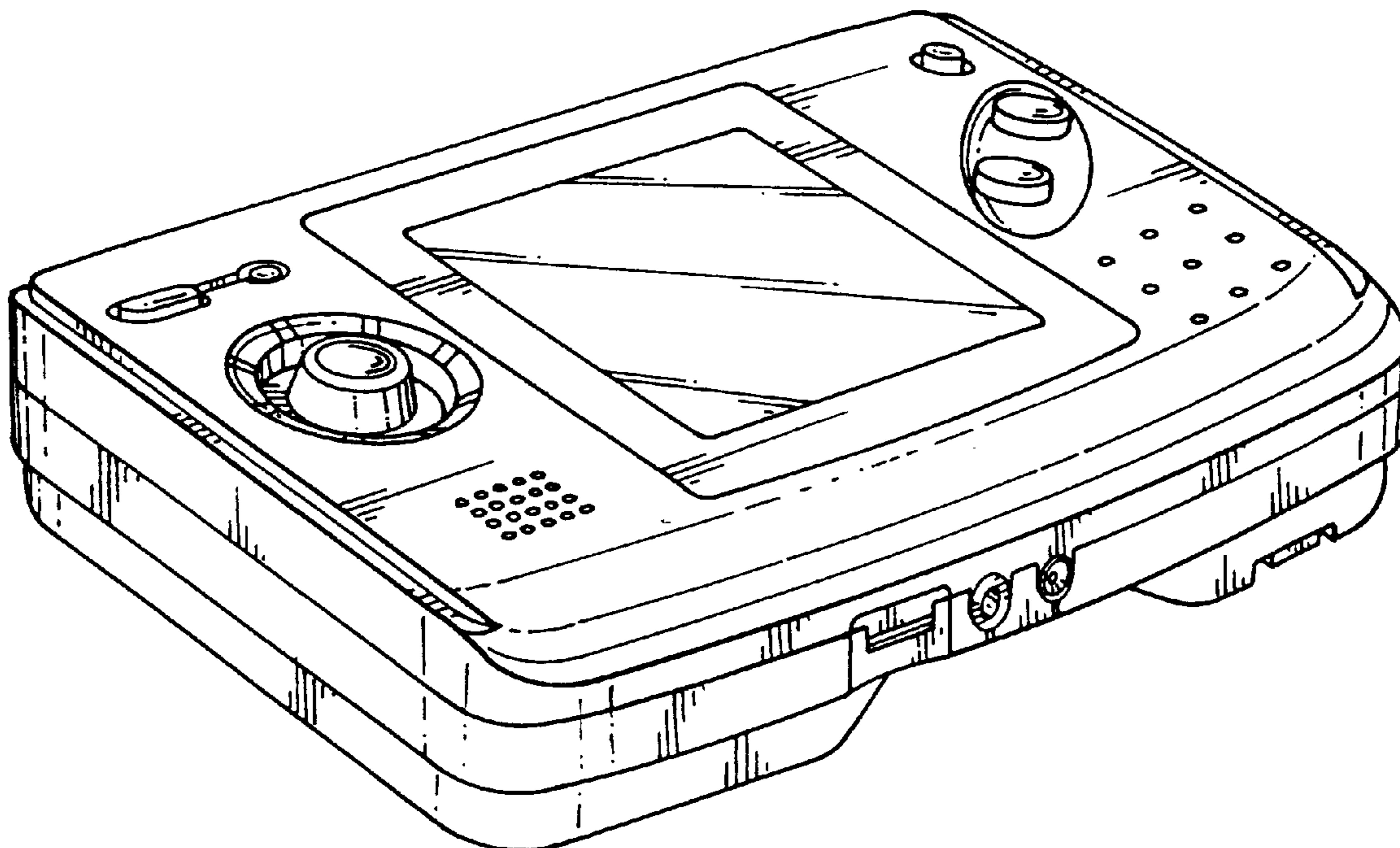
FIG. 4 is a front elevational view of the embodiment depicted in FIG. 1.

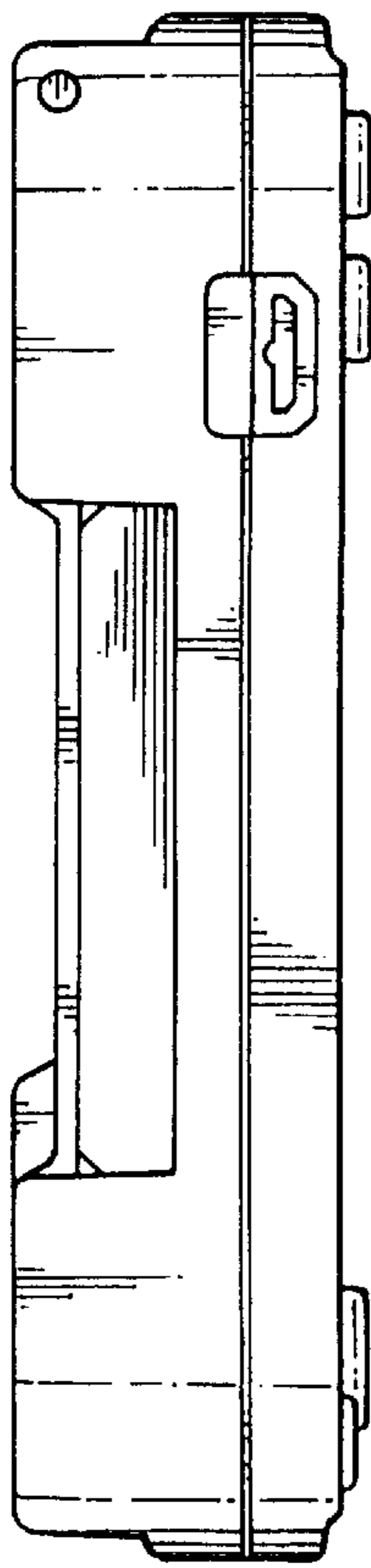

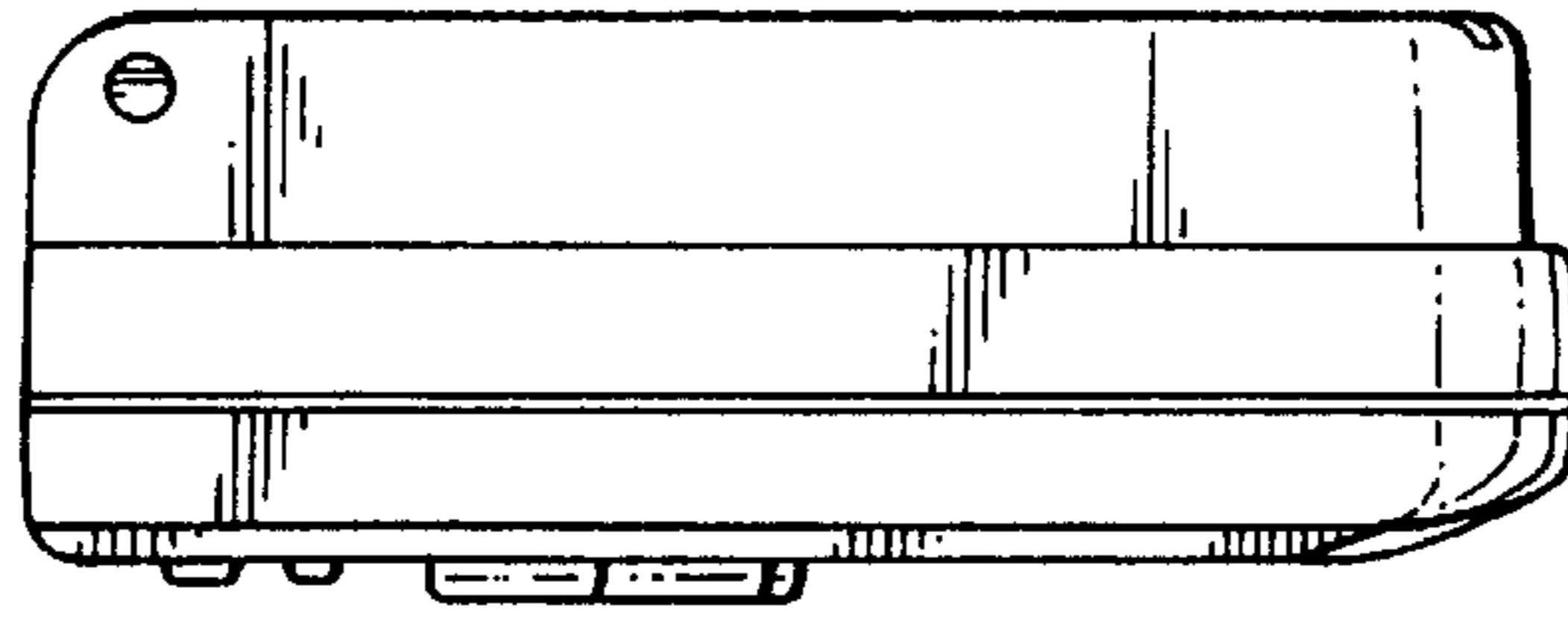

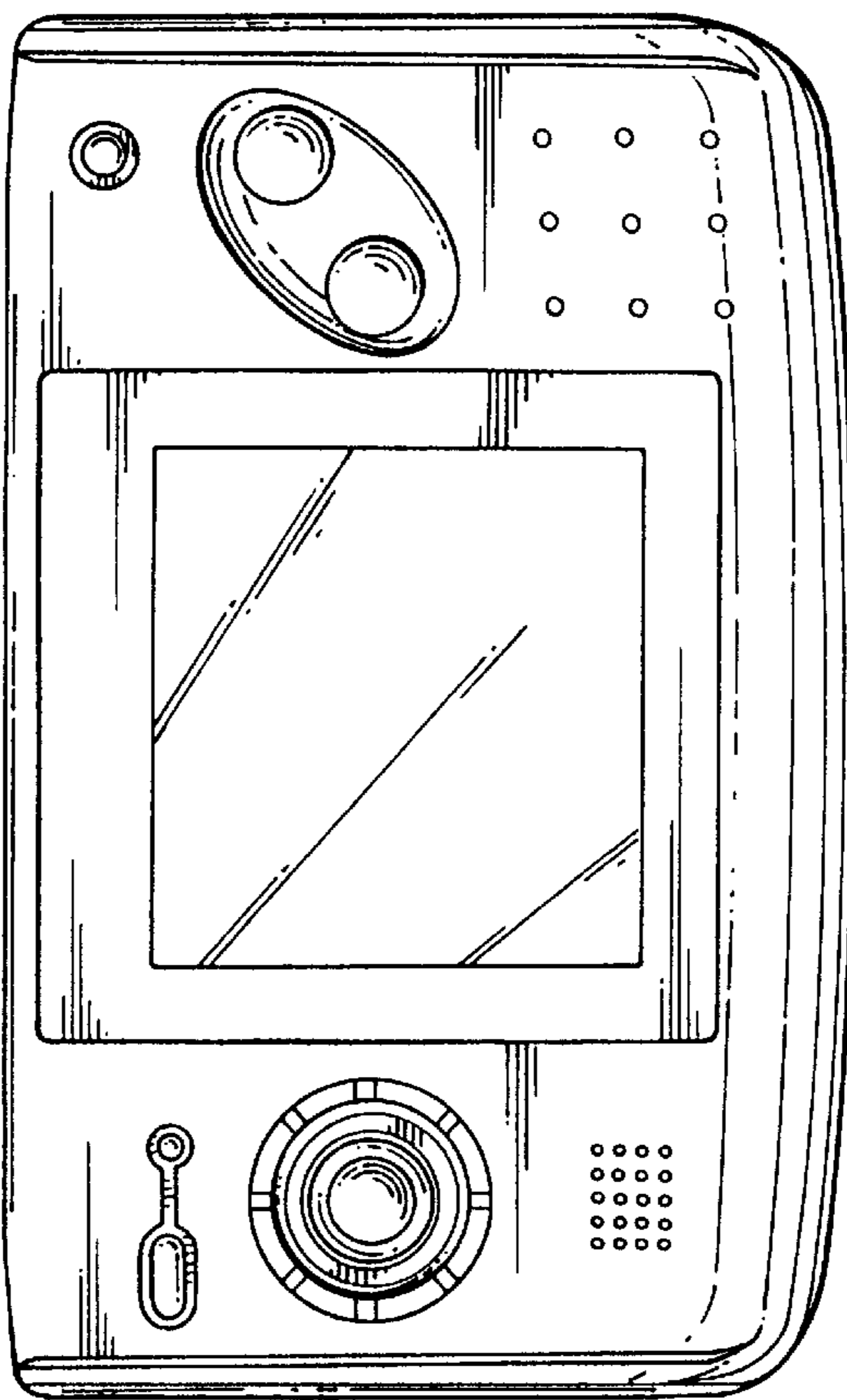

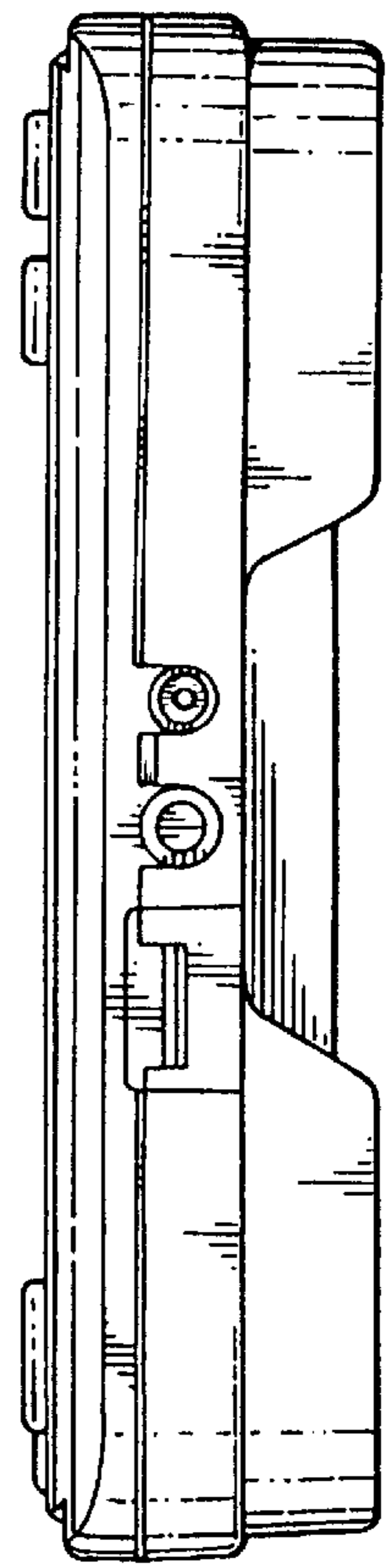

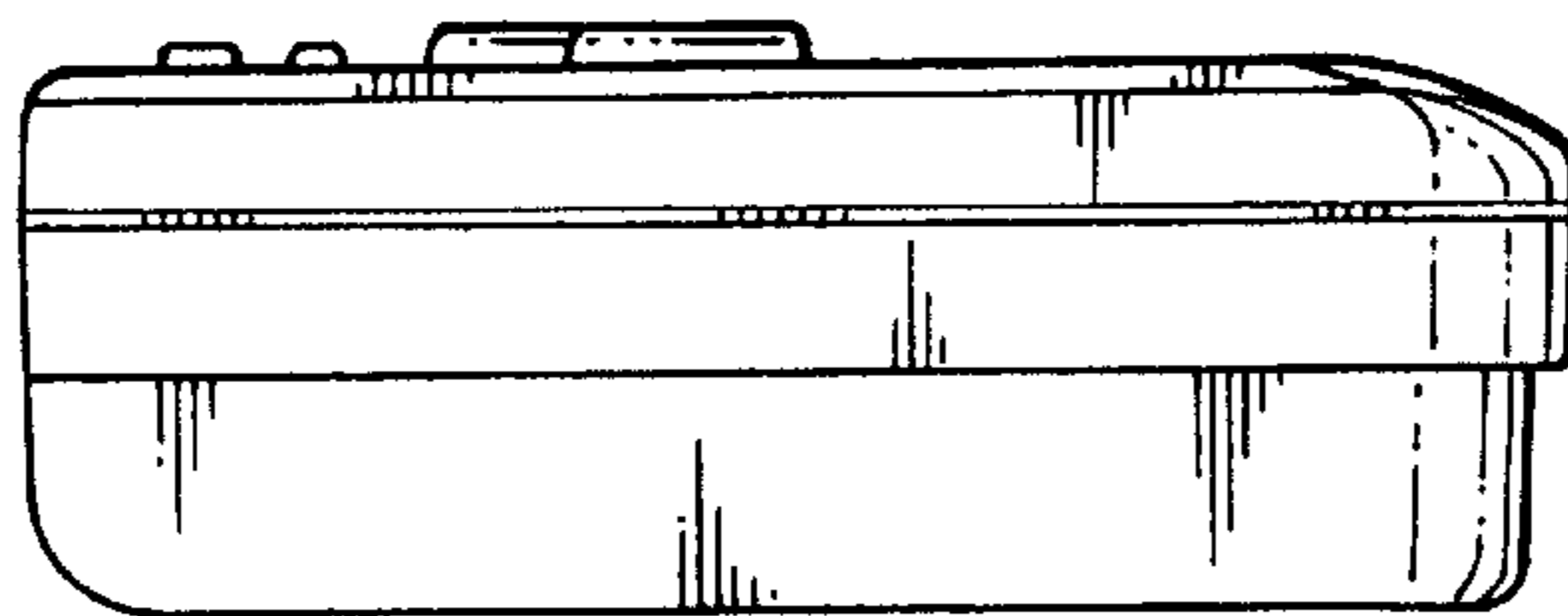

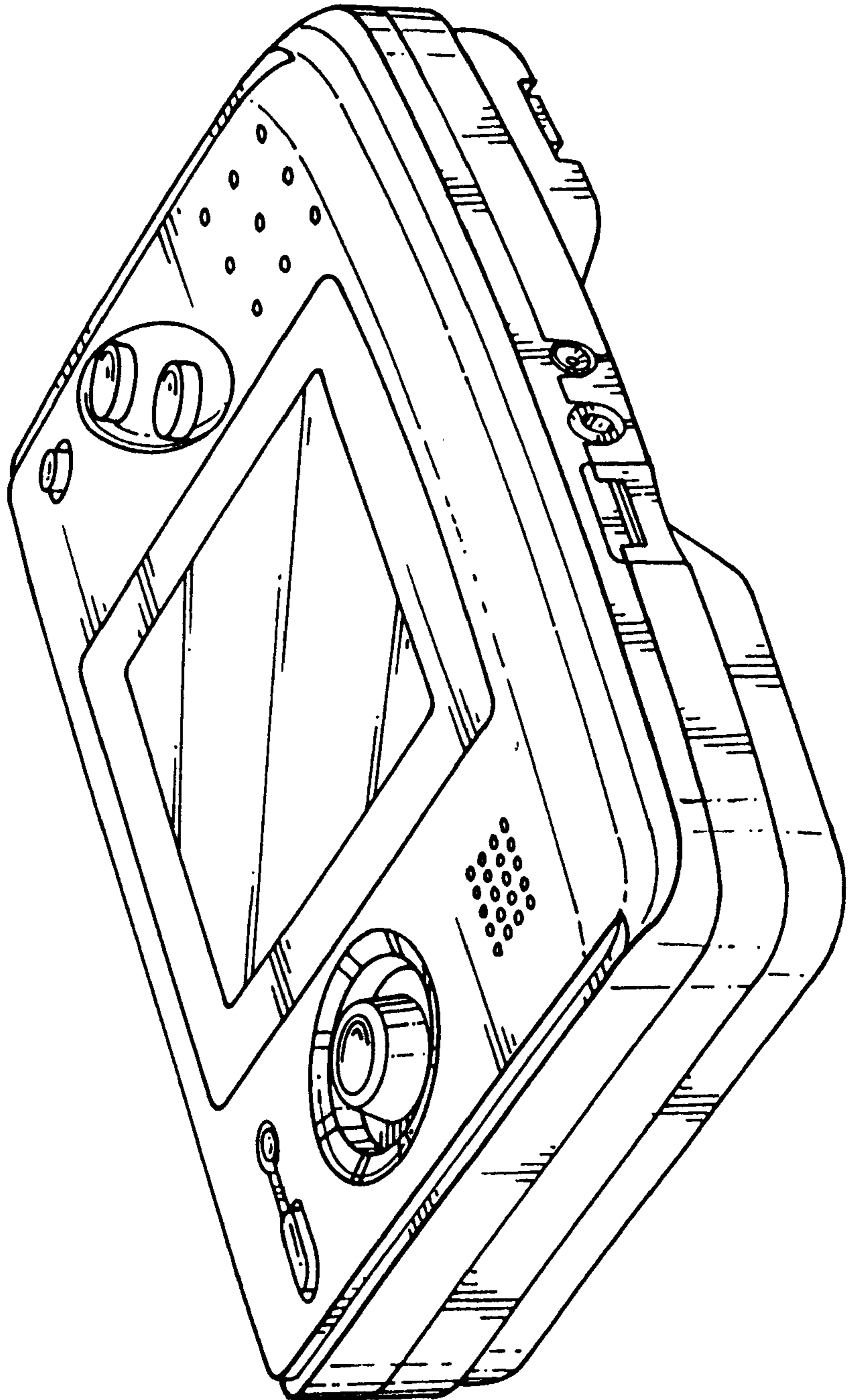
