FIG. 2 is a front elevation view, the rear elevation view being a mirror image thereof;

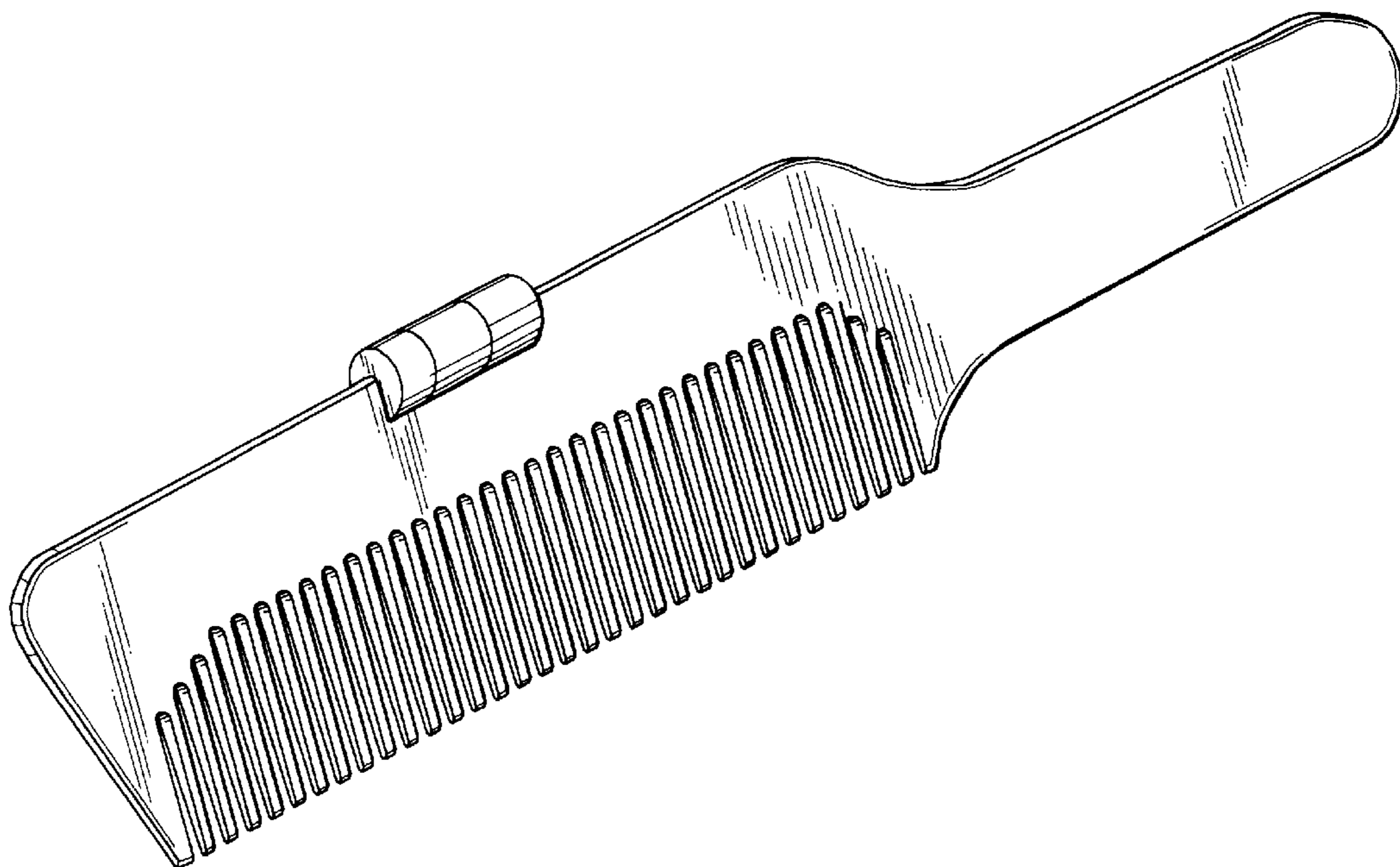
FIG. 3 is a top plan view;

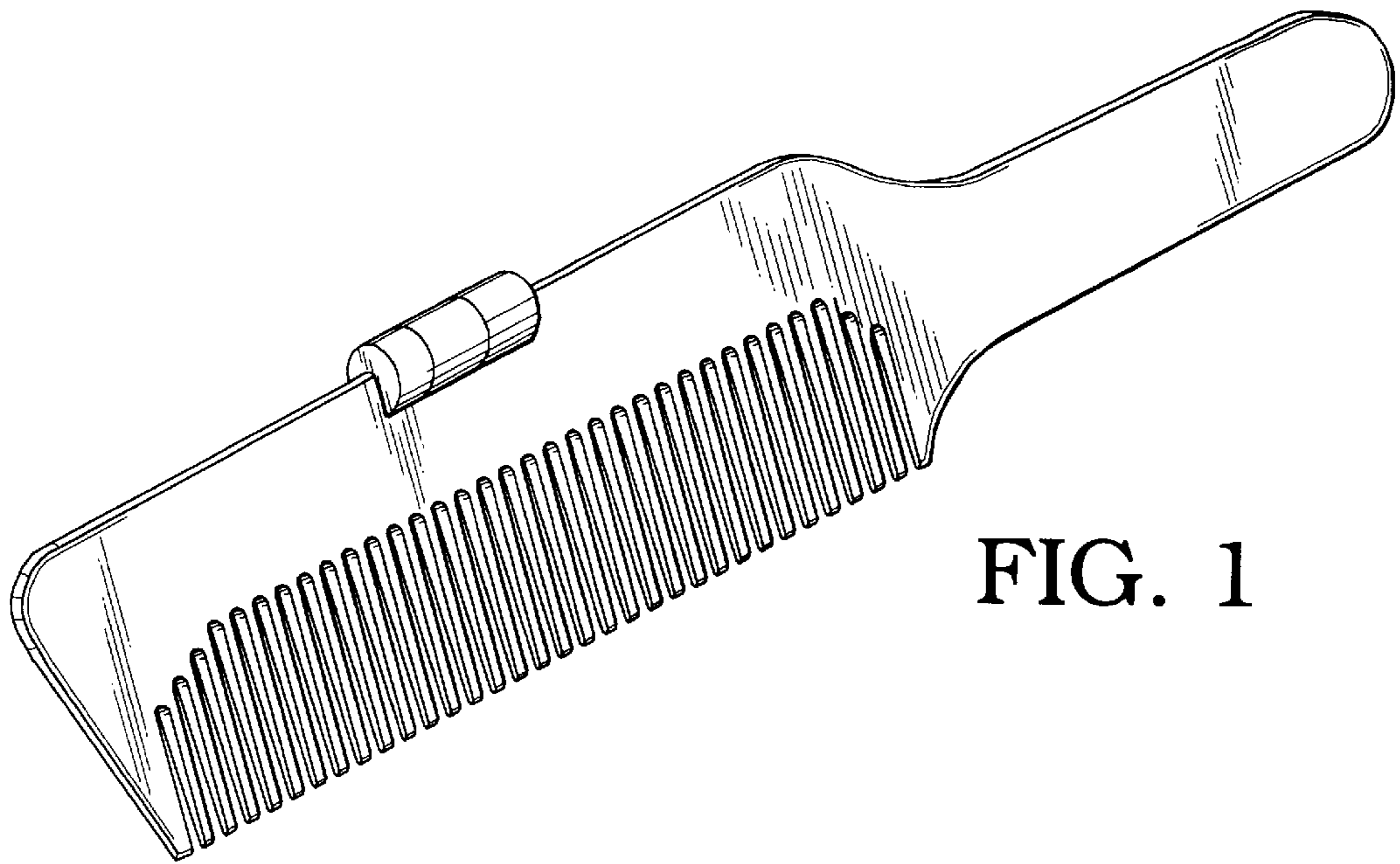

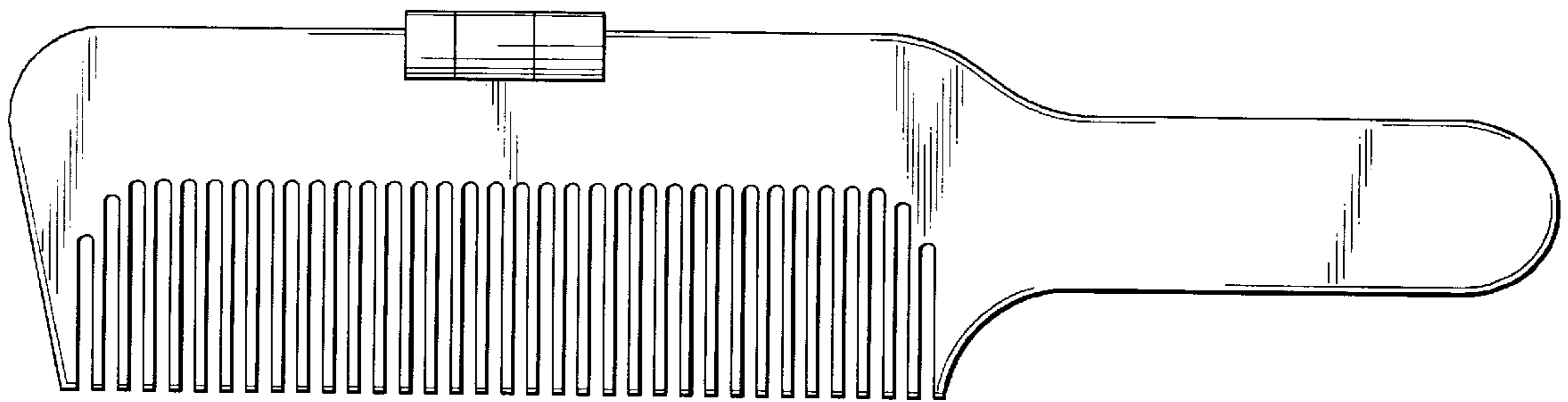

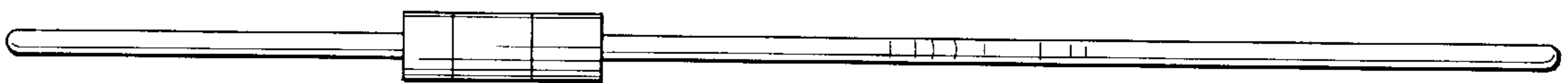

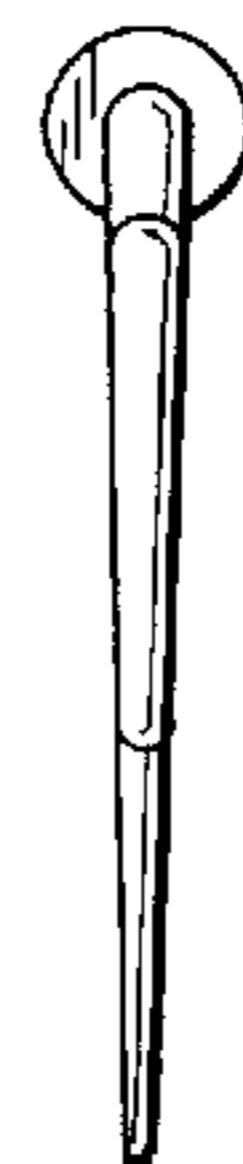
