[57] **CLAIM**

The ornamental design for a hair bow organizer, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of a hair bow organizer showing
a first embodiment of my new design;
FIG. 2 is a top plan view of the hair bow organizer shown
in FIG. 1, the bottom plan view being the same;
FIG. 3 is a front elevational view of the hair bow organizer
shown in FIG. 1, the rear elevational view being the same;
FIG. 4 is a left side elevational view of the hair bow
organizer shown in FIG. 1;
FIG. 5 is a right side elevational view of the hair bow
organizer shown in FIG. 1;
FIG. 6 is a perspective view of a hair bow organizer showing
a second embodiment of my new design;
FIG. 7 is a top plan view of the hair bow organizer shown
in FIG. 6, the bottom plan view being the same;
FIG. 8 is a front elevational of the hair bow organizer shown
in FIG. 6, the rear elevational view being the same;
FIG. 9 is a left side elevational view of the hair bow
organizer shown in FIG. 6;

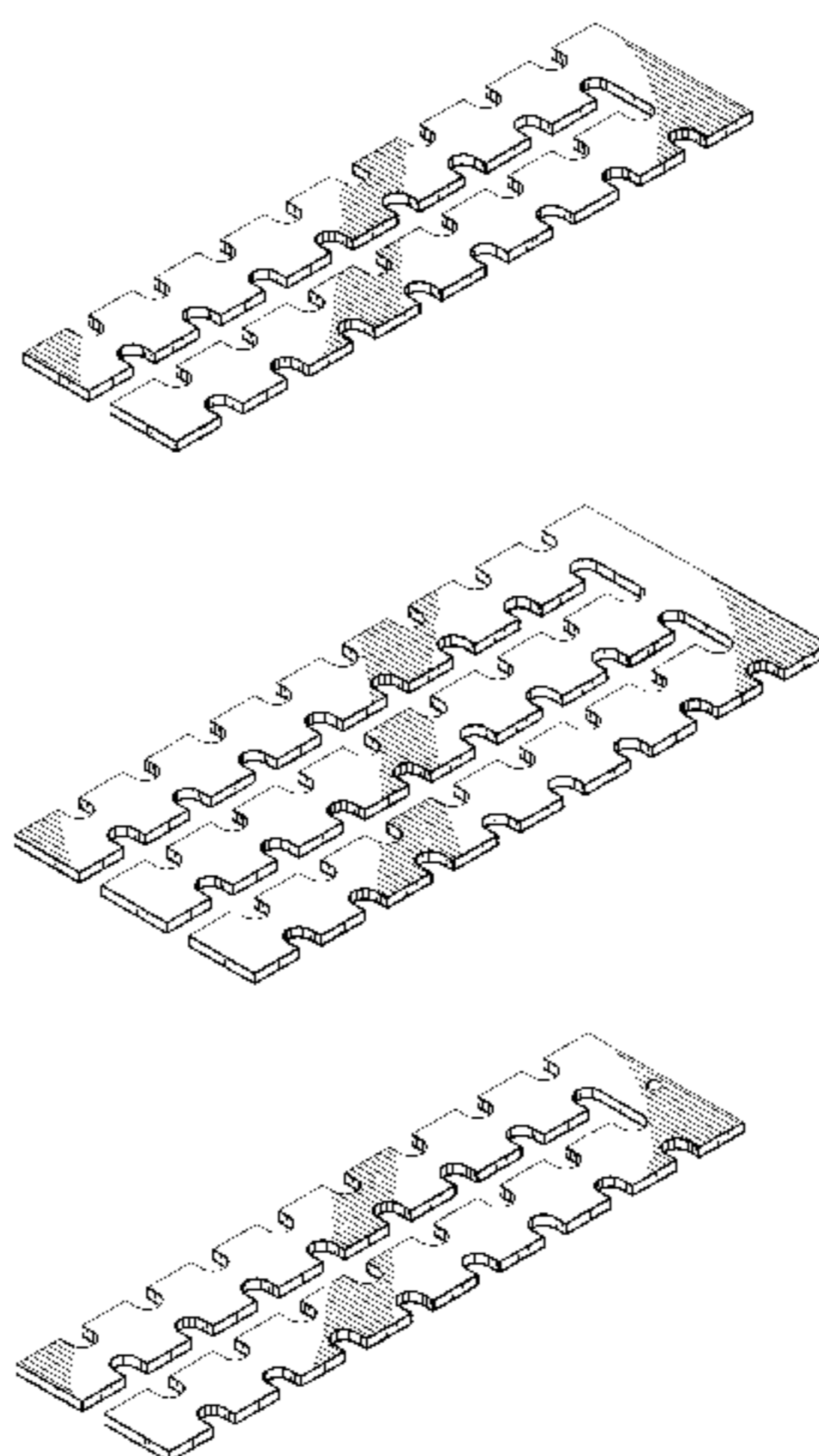


FIG. 10 is a right side elevational view of the hair bow organizer shown in FIG. 6;

FIG. 12 is a top plan view of the hair bow organizer shown in FIG. 11;

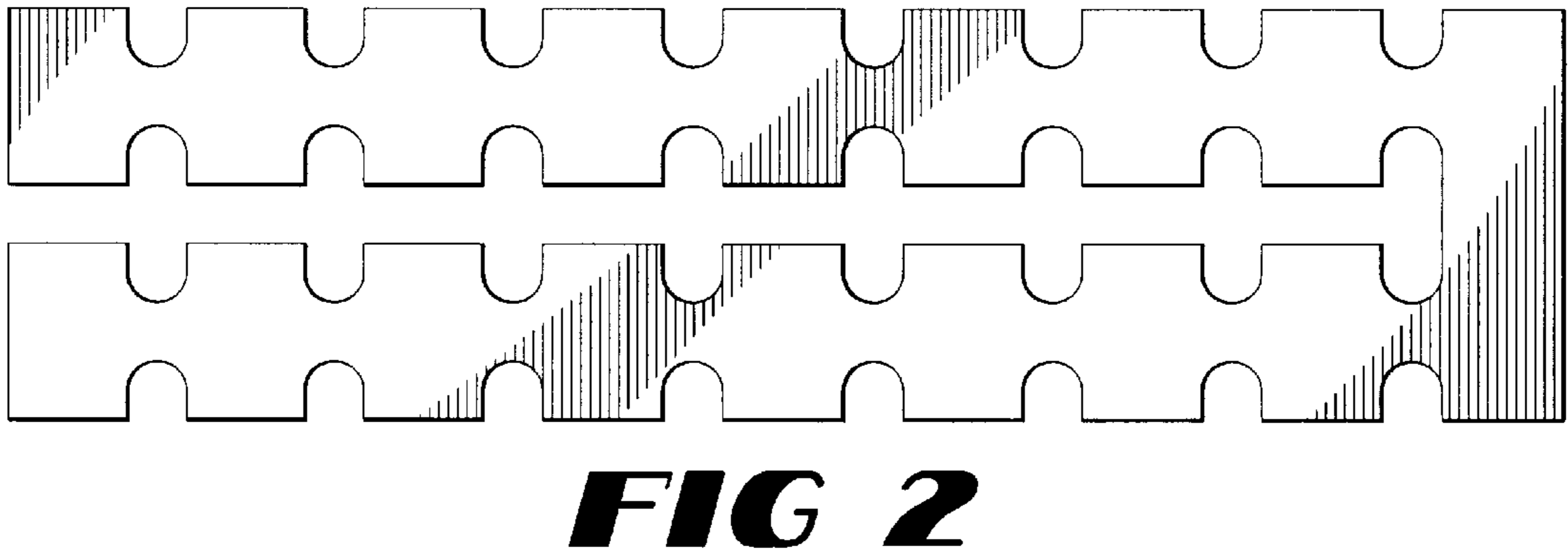
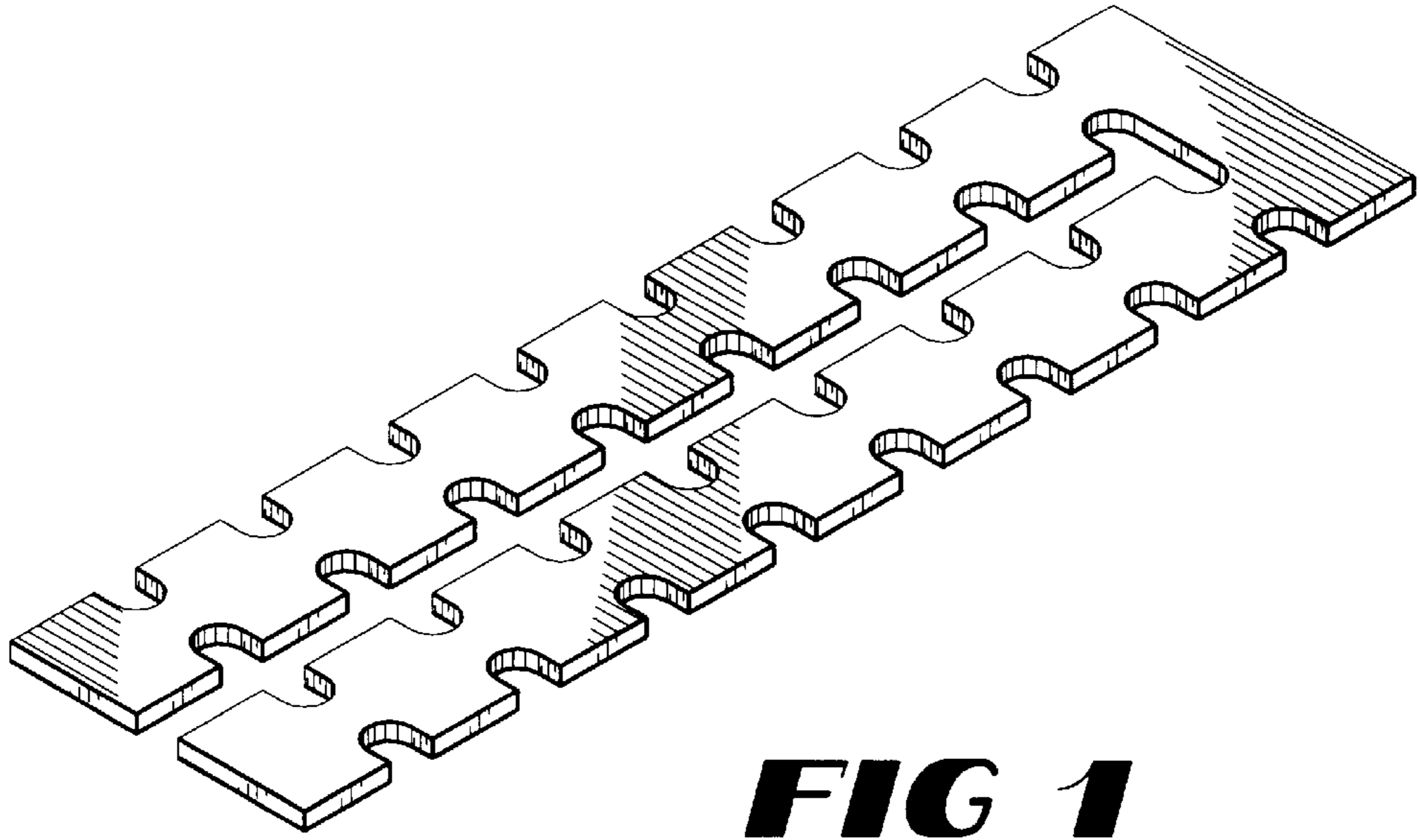
FIG. 13 is a bottom plan view of the hair bow organizer shown in FIG. 11;

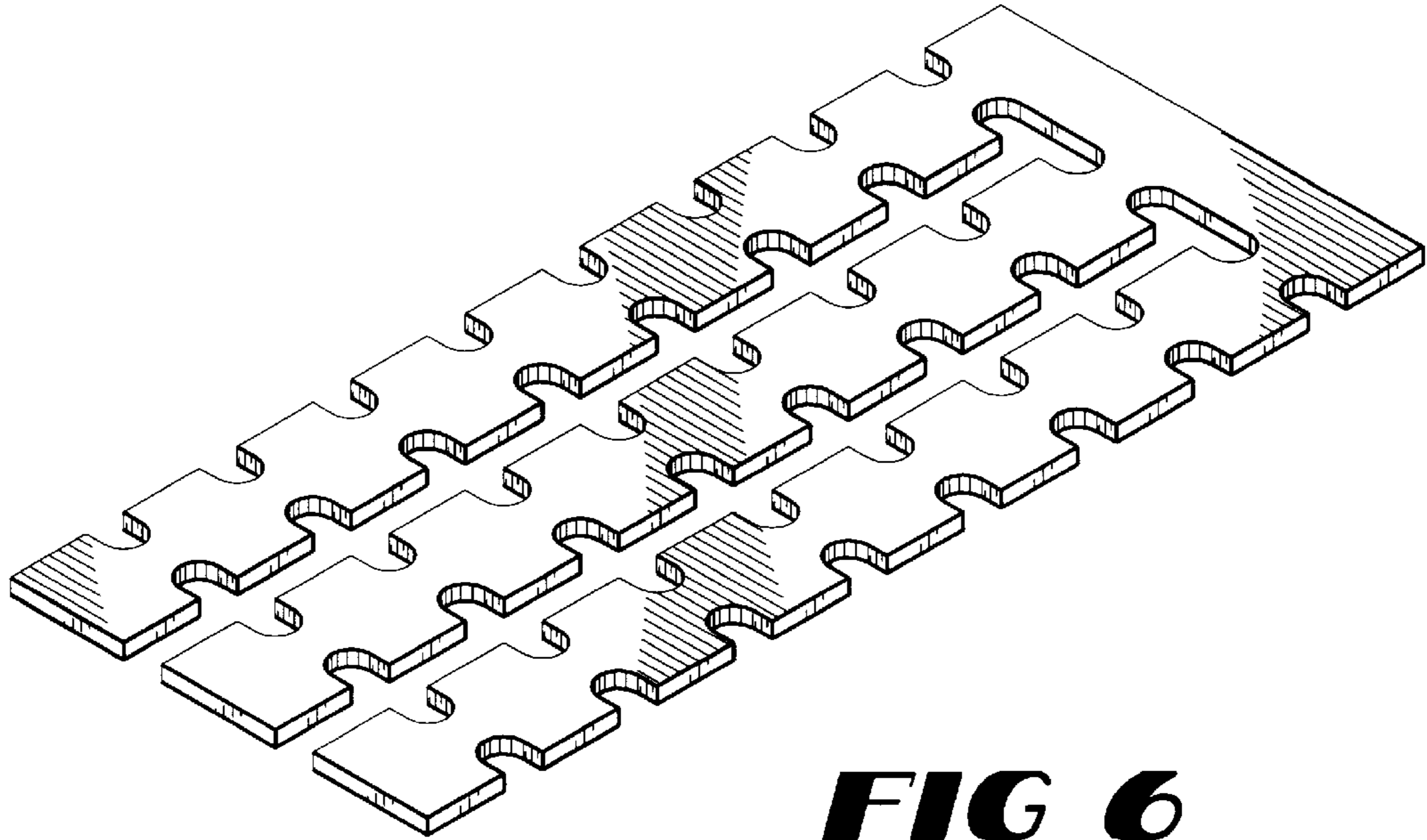

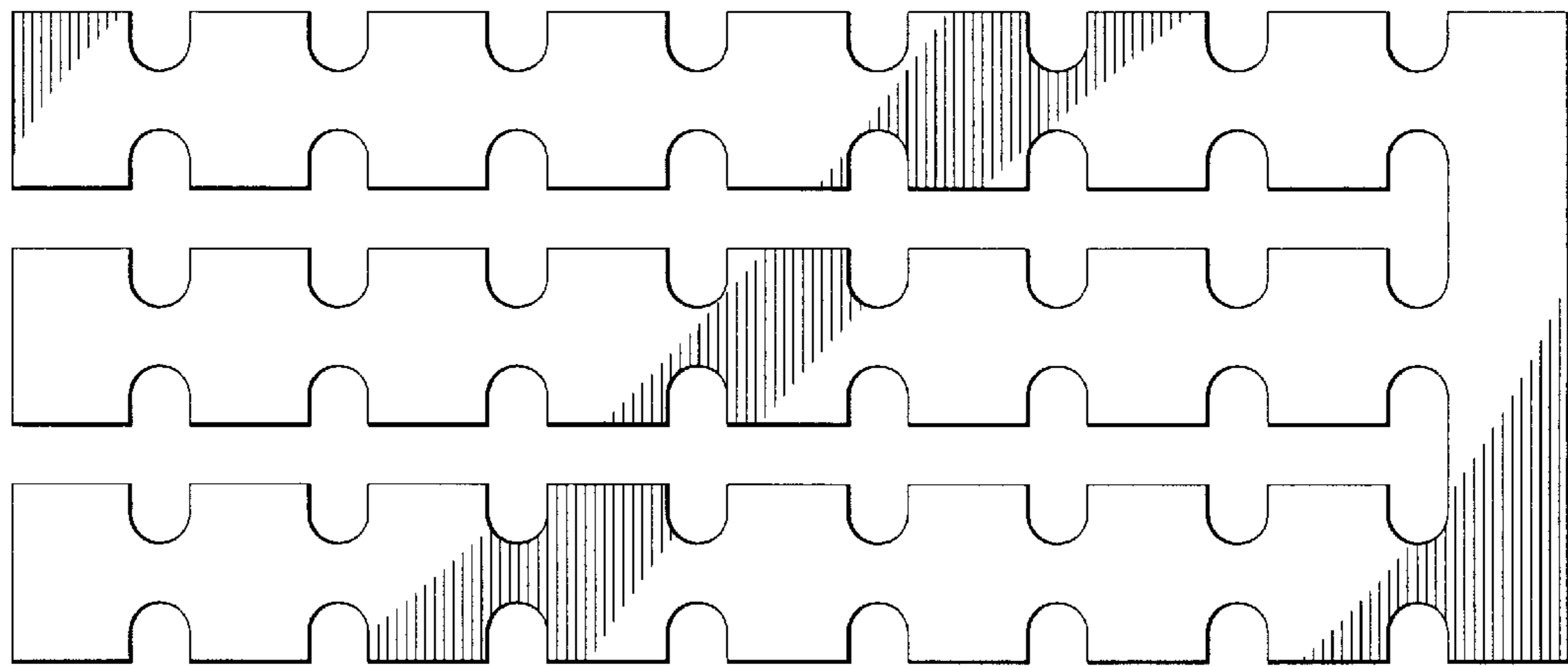

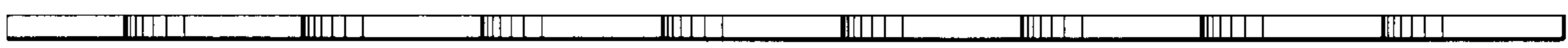

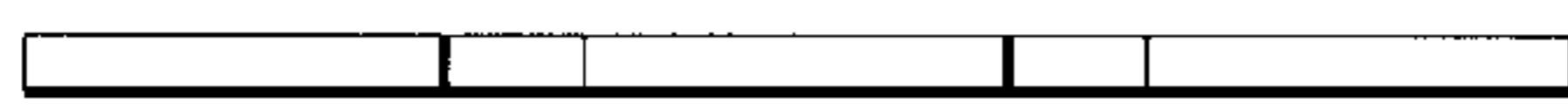

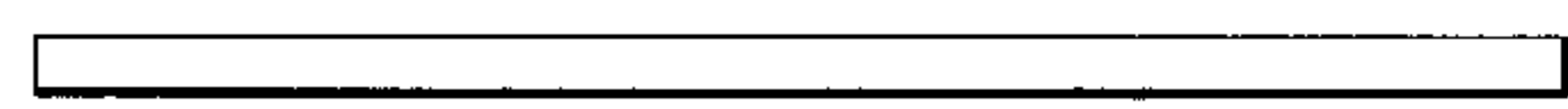

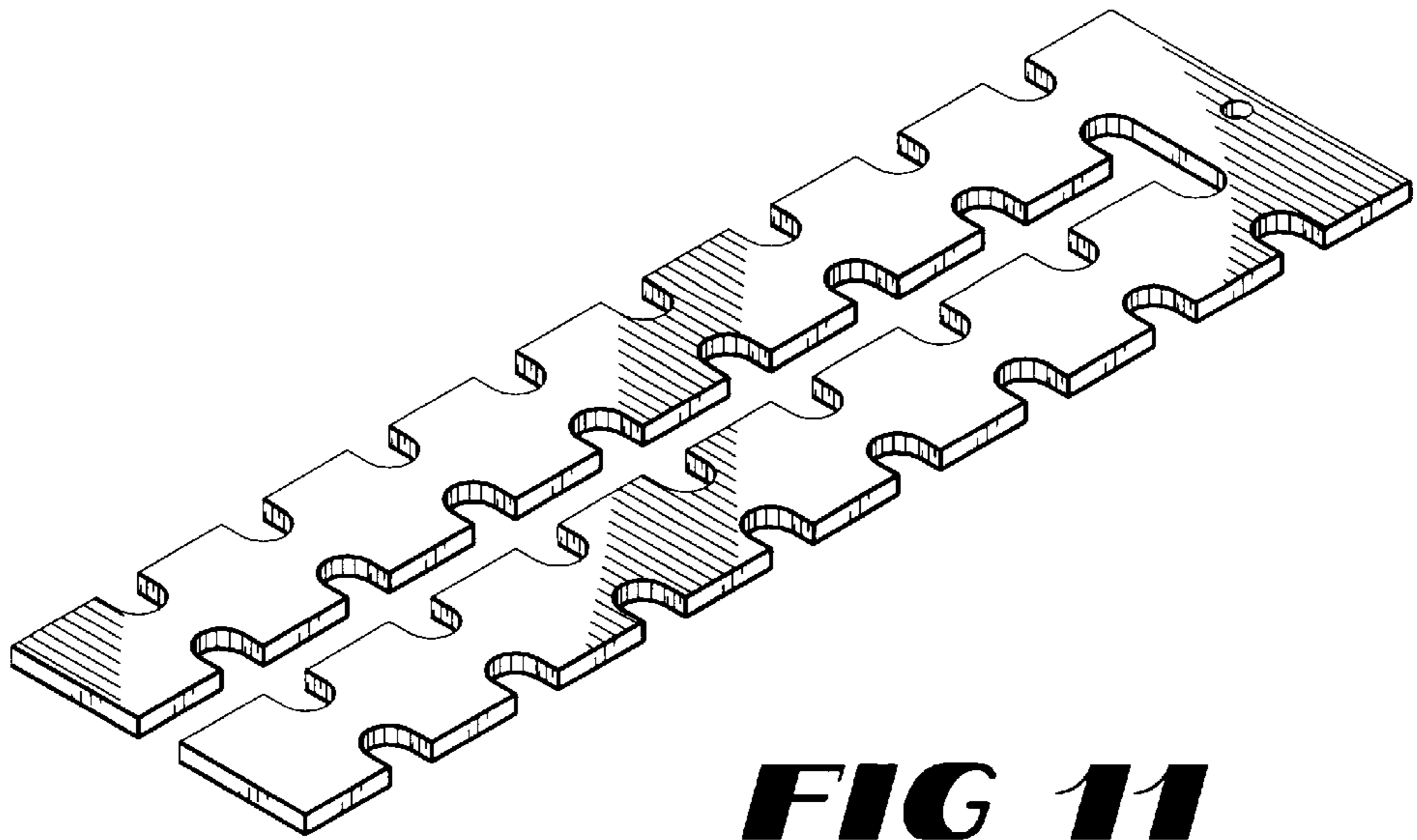

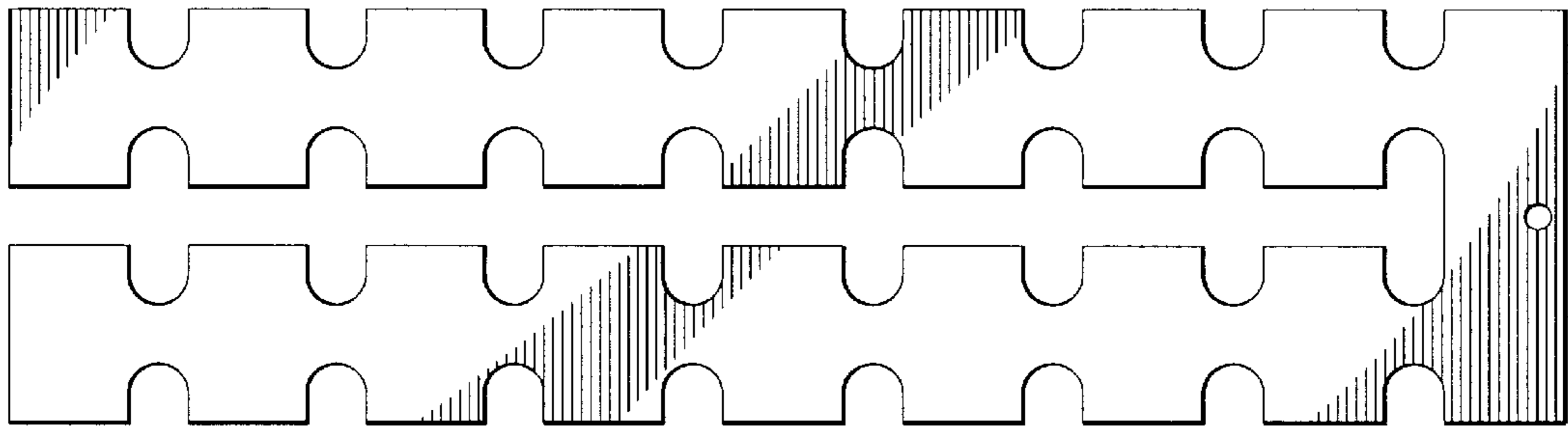

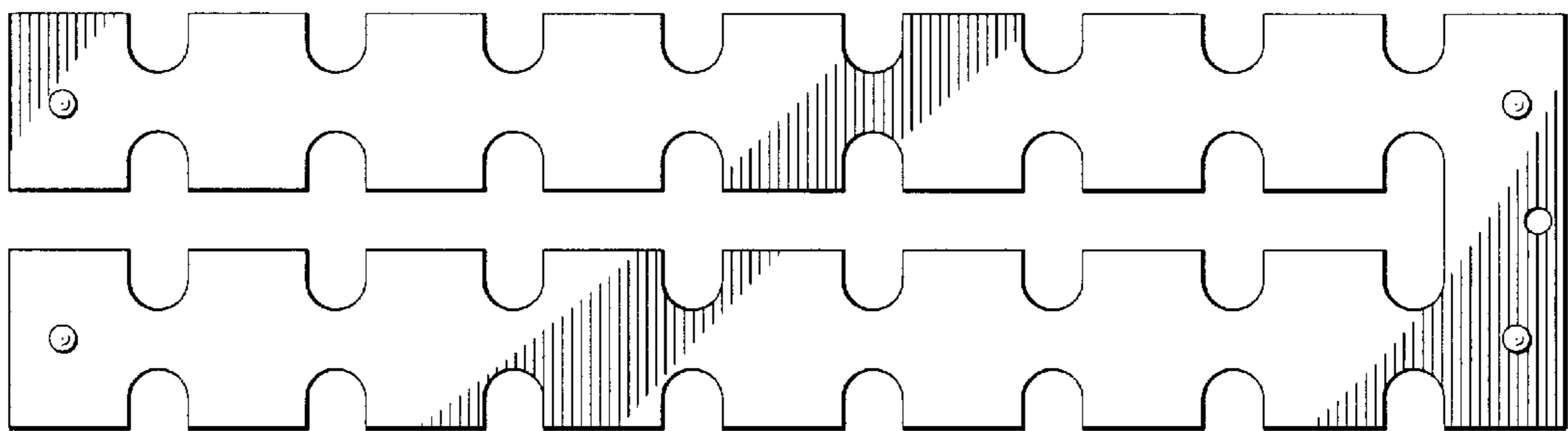

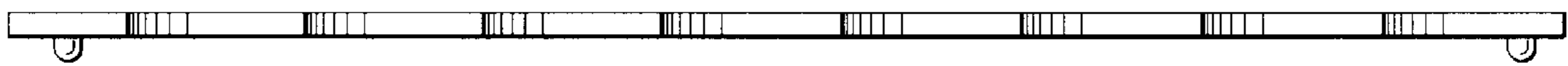

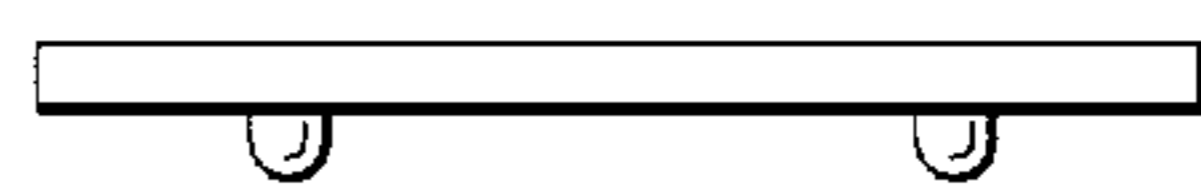
