### DESCRIPTION

FIG. 1 is a front elevational view of a steering wheel showing our new design;  
 FIG. 2 is a side elevational view thereof;  
 FIG. 3 is a perspective elevational view thereof; and,  
 FIG. 4 is a rear elevational view thereof.  
 The top, bottom and opposite side surfaces are clearly understood and fully disclosed in the perspective view, and therefore are not illustrated separately.

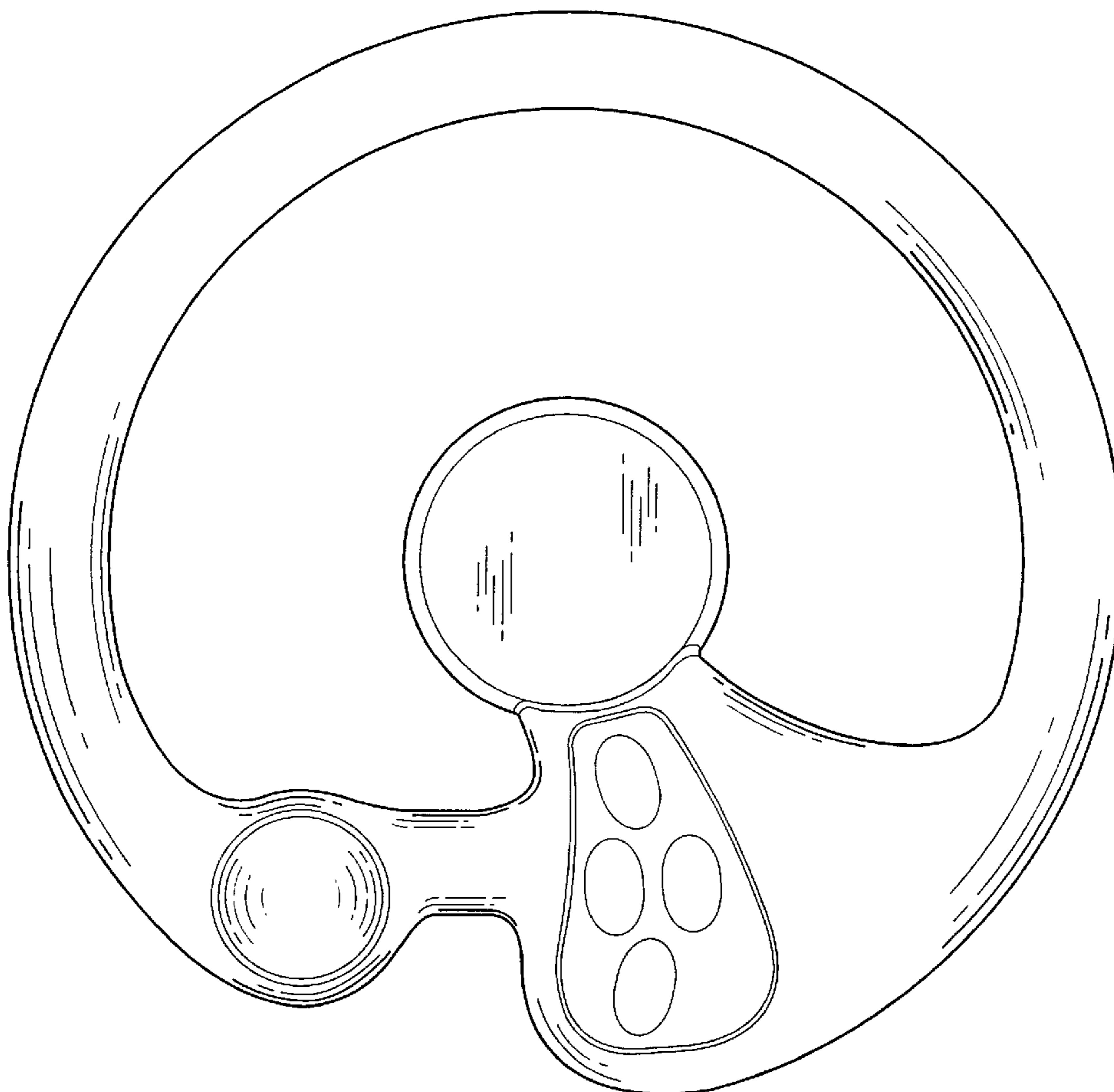
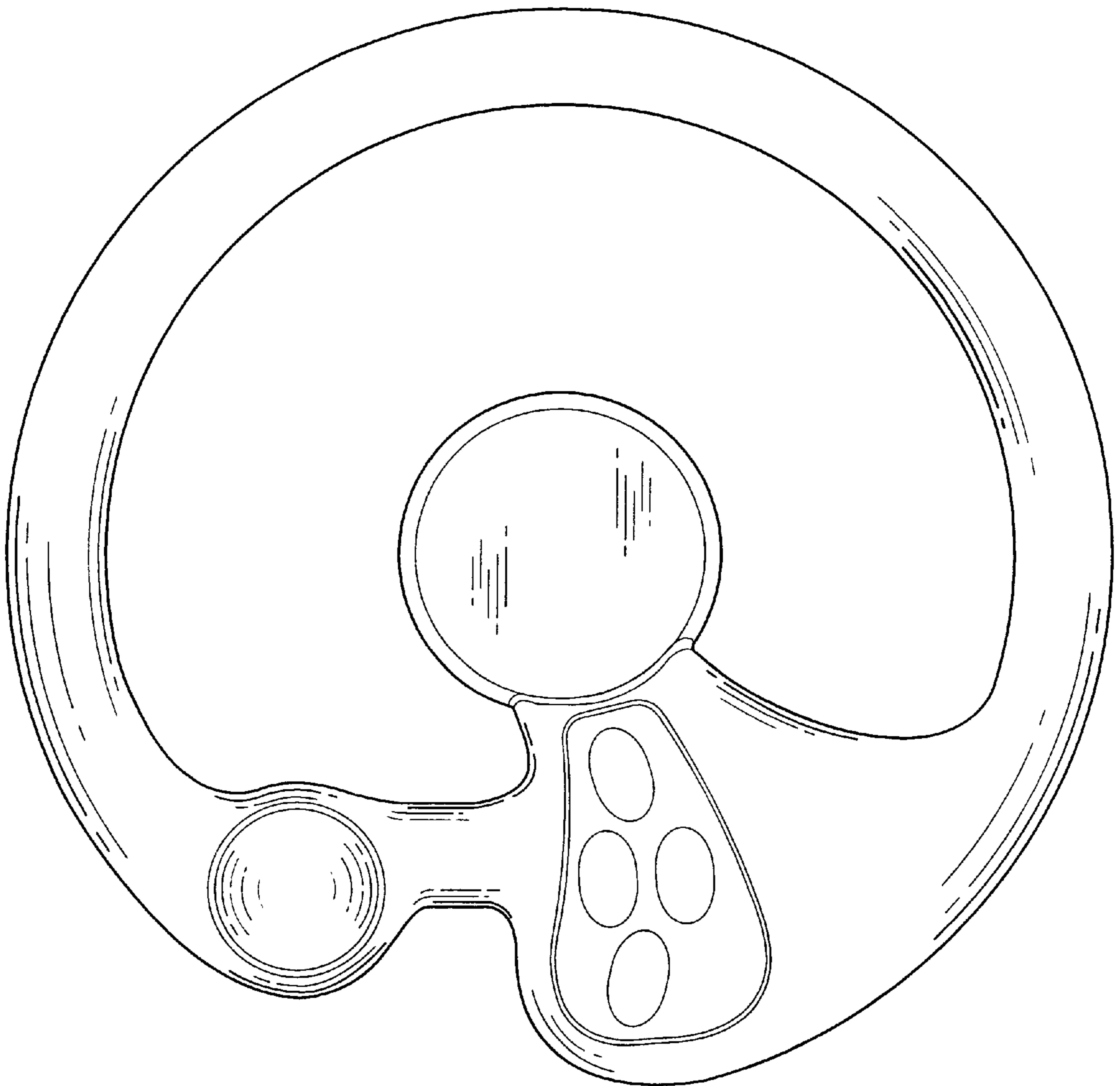

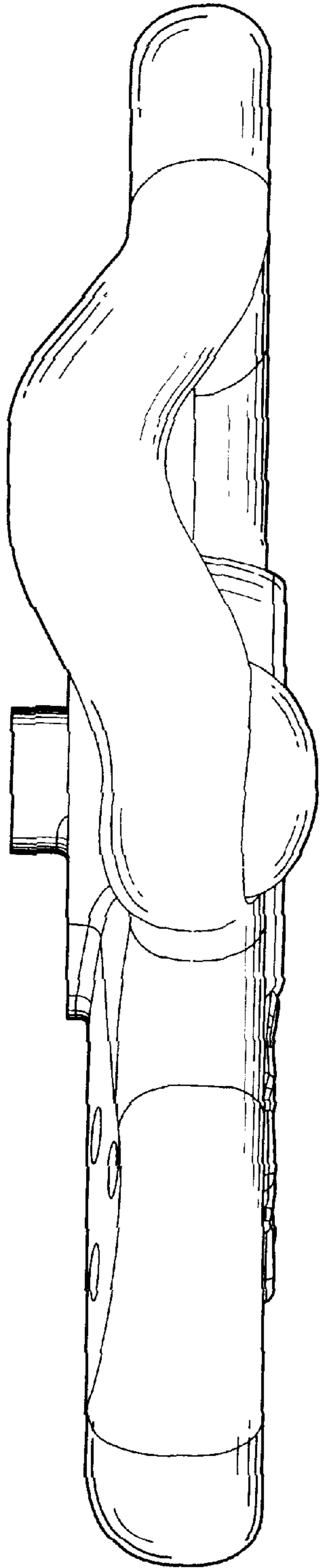
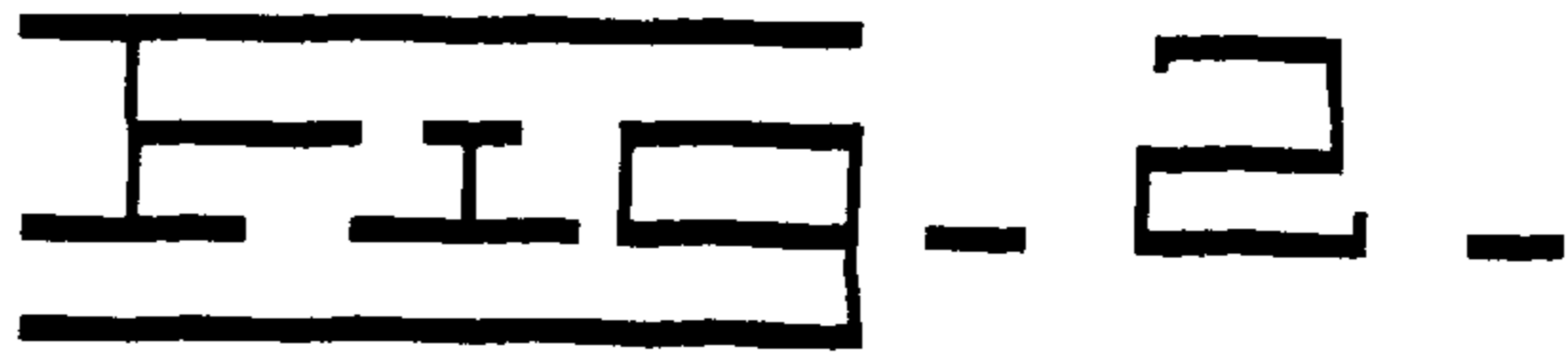

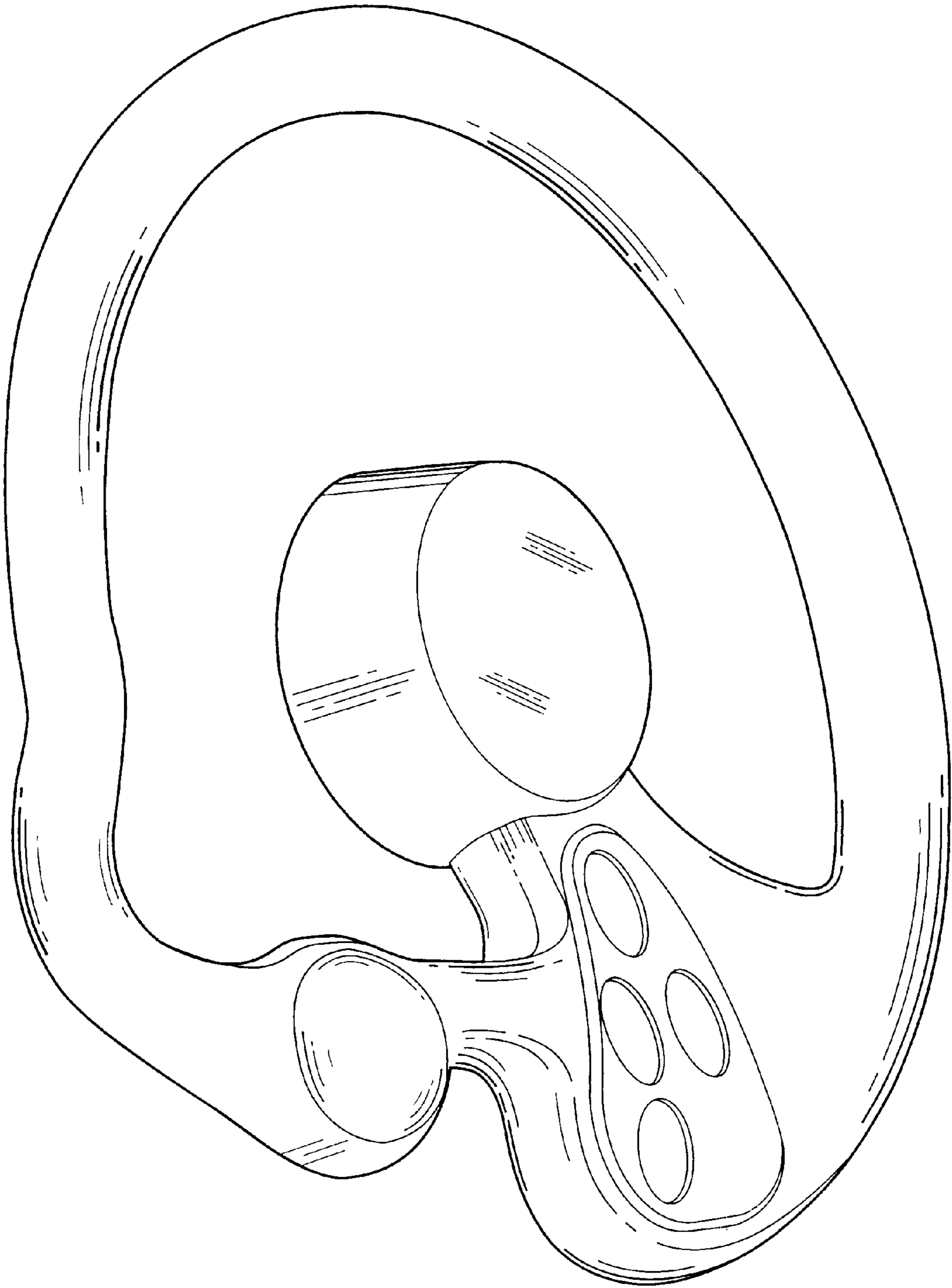
