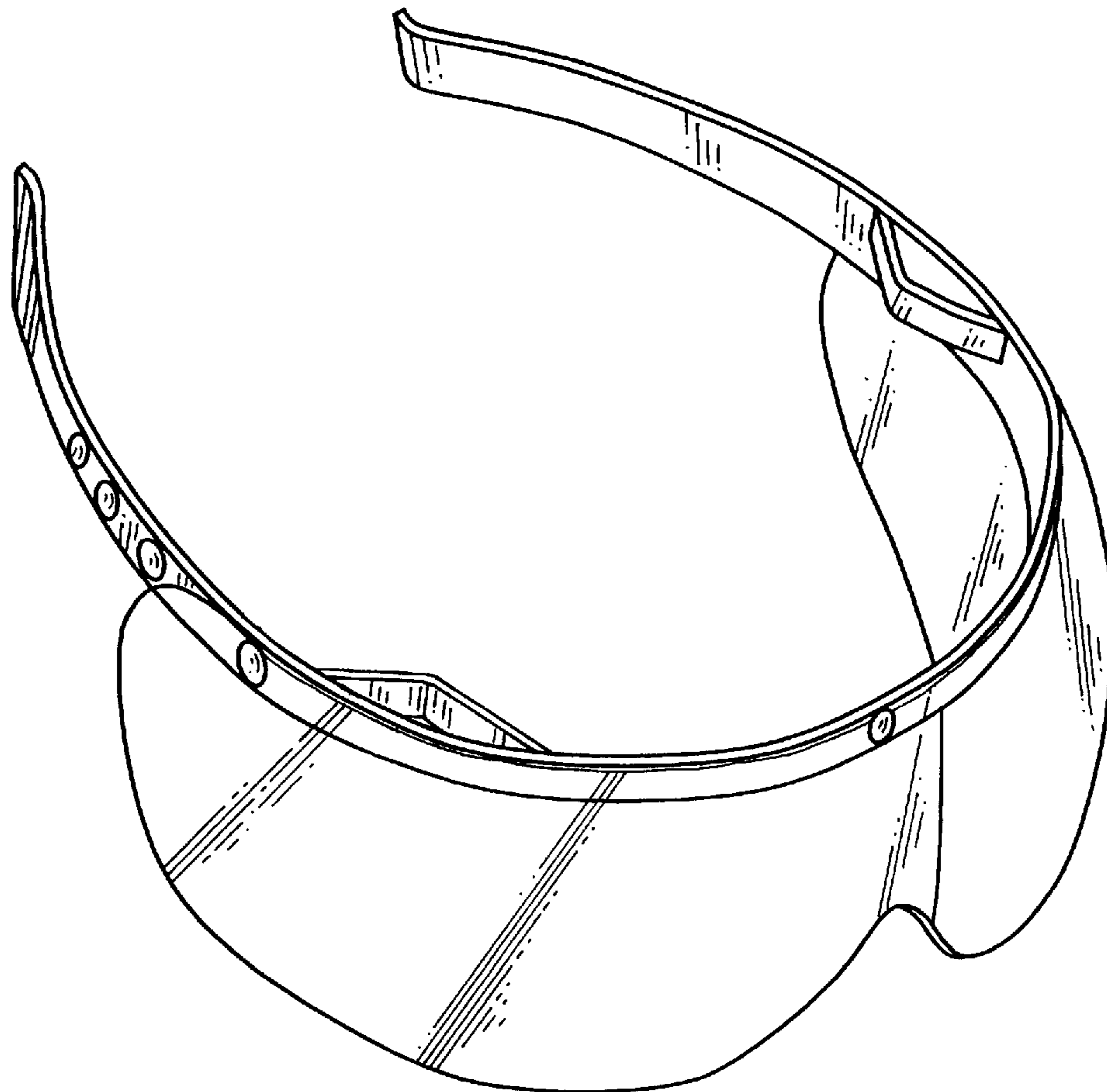

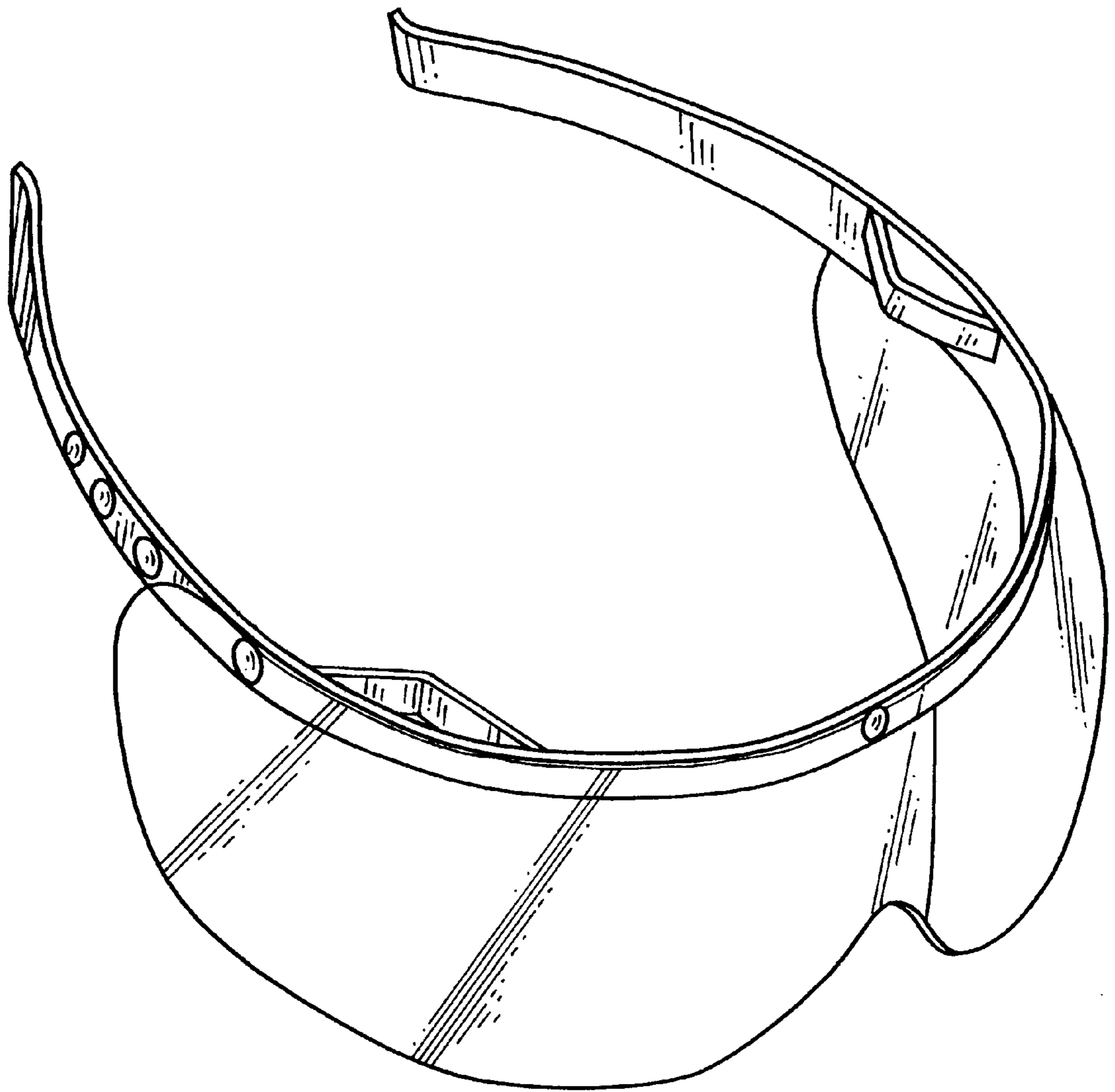
The ornamental design for an eye shield, as shown and described.

**DESCRIPTION**

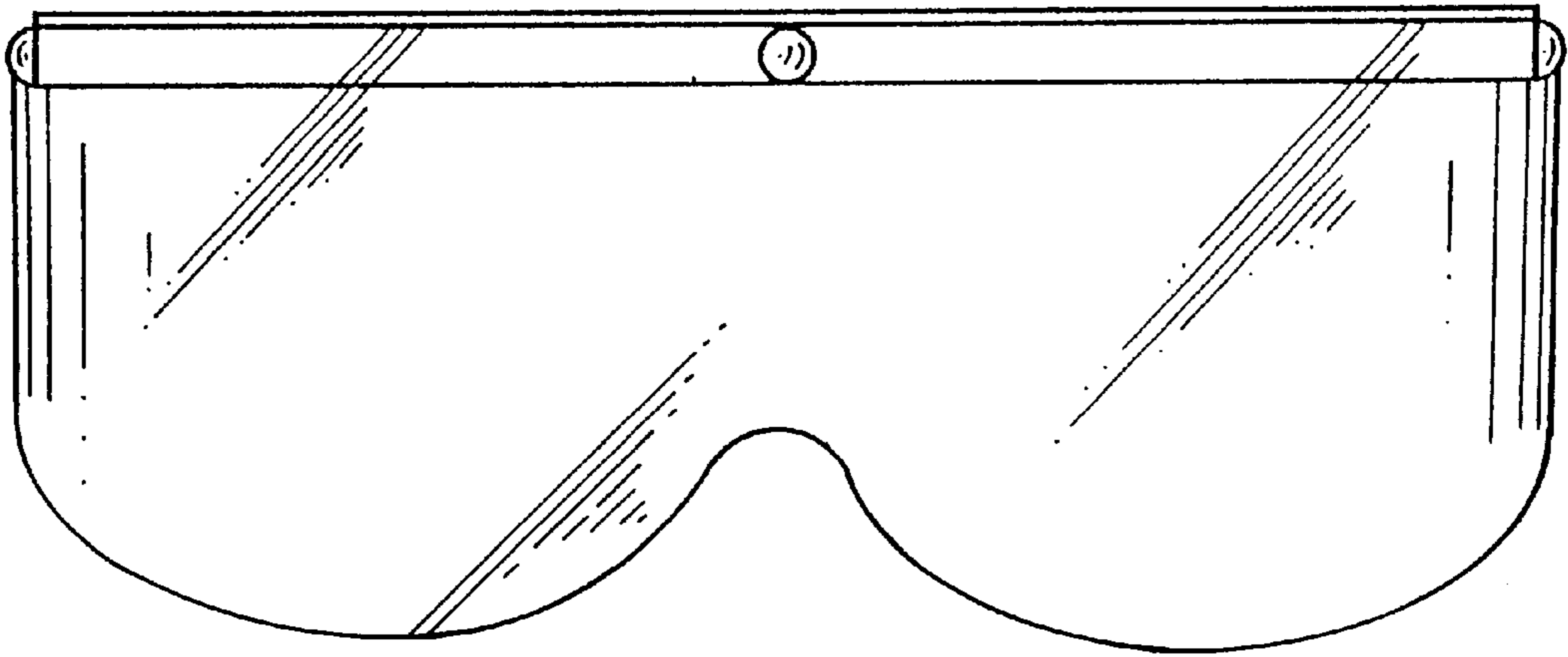
FIG. 1 is a perspective view of an eye shield showing my new design;

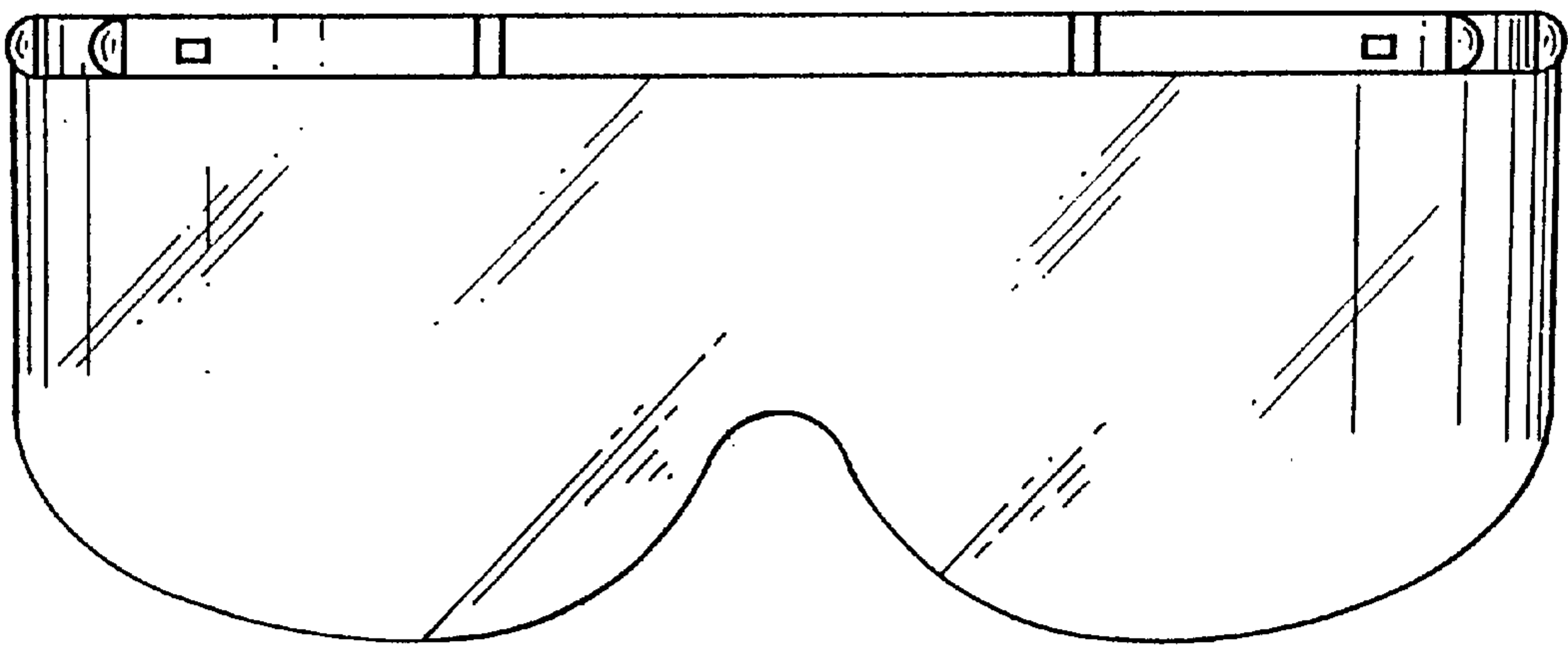

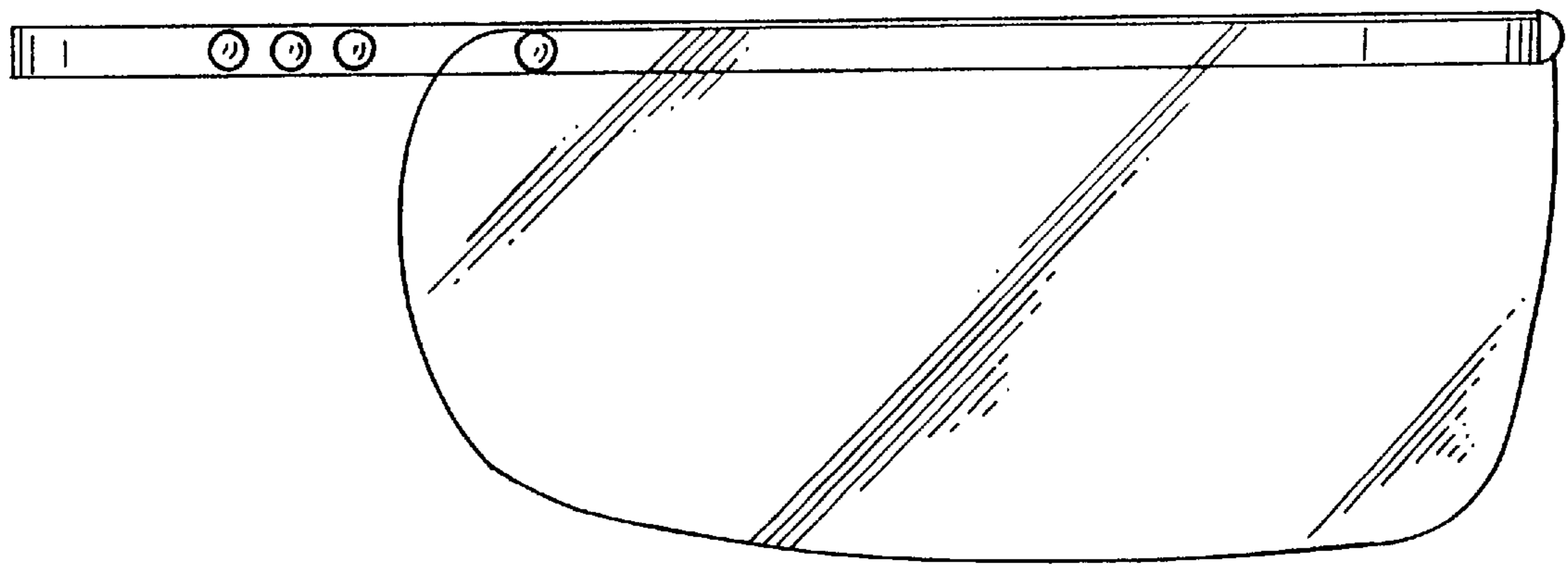
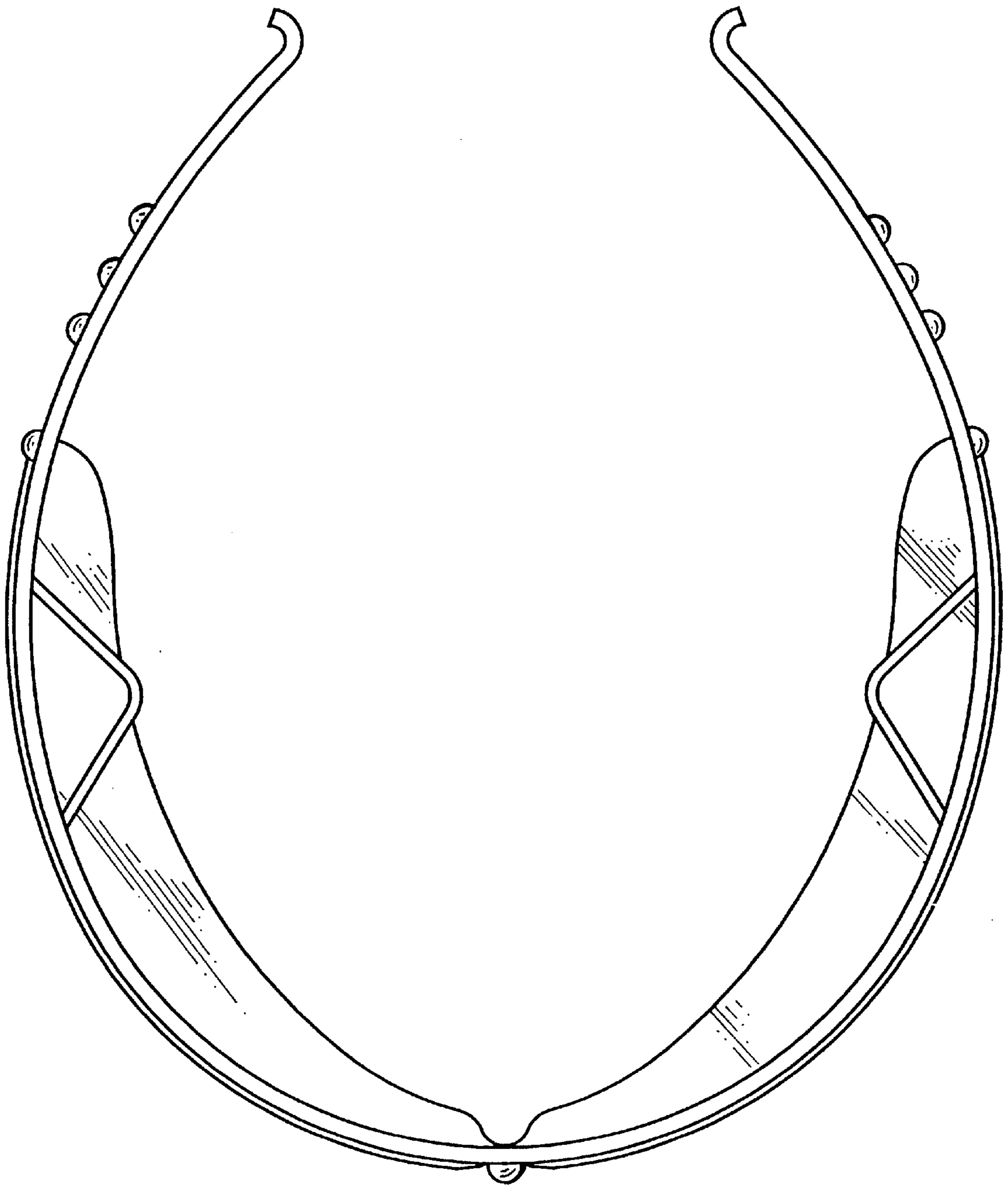

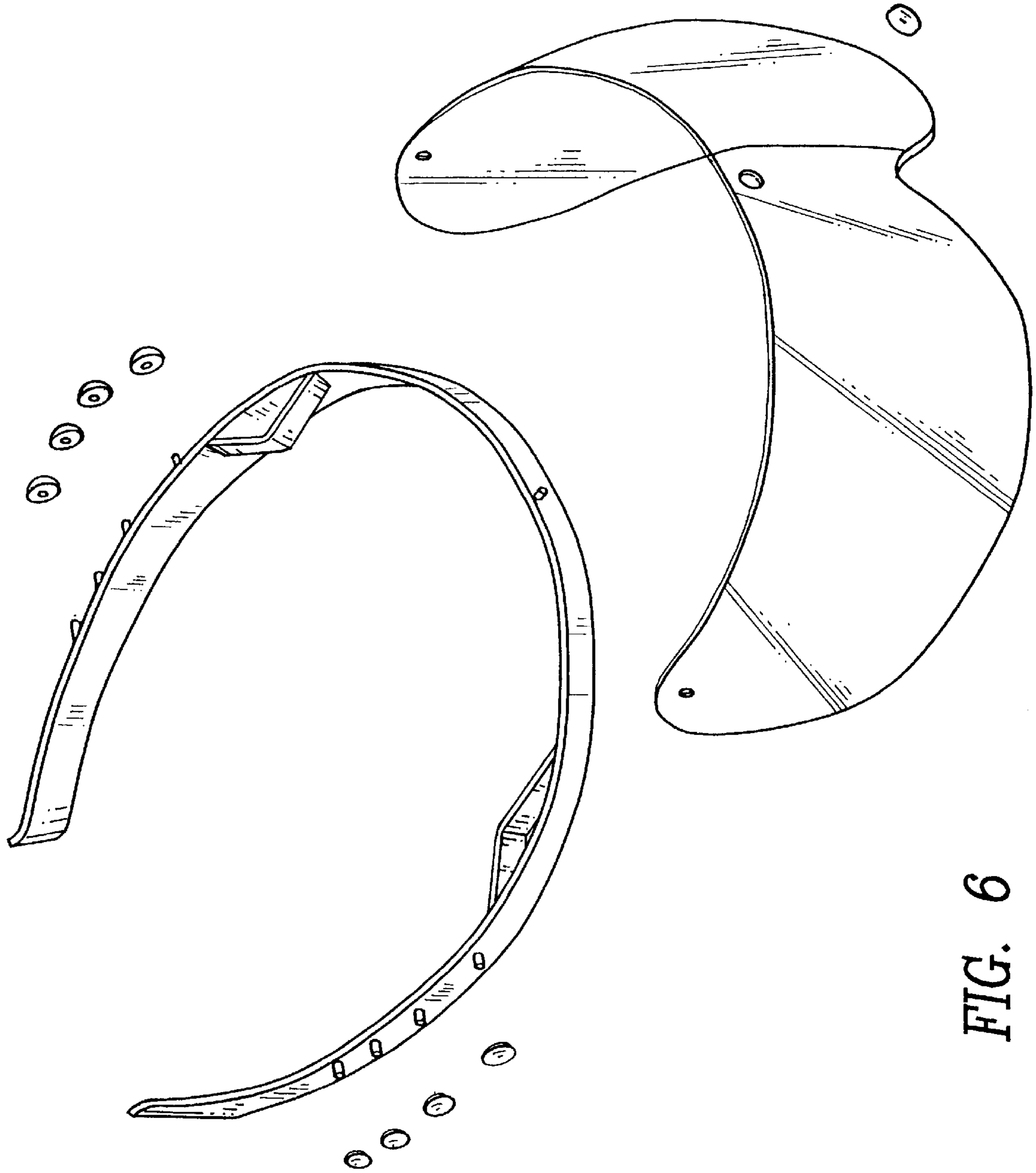


FIG. 6
