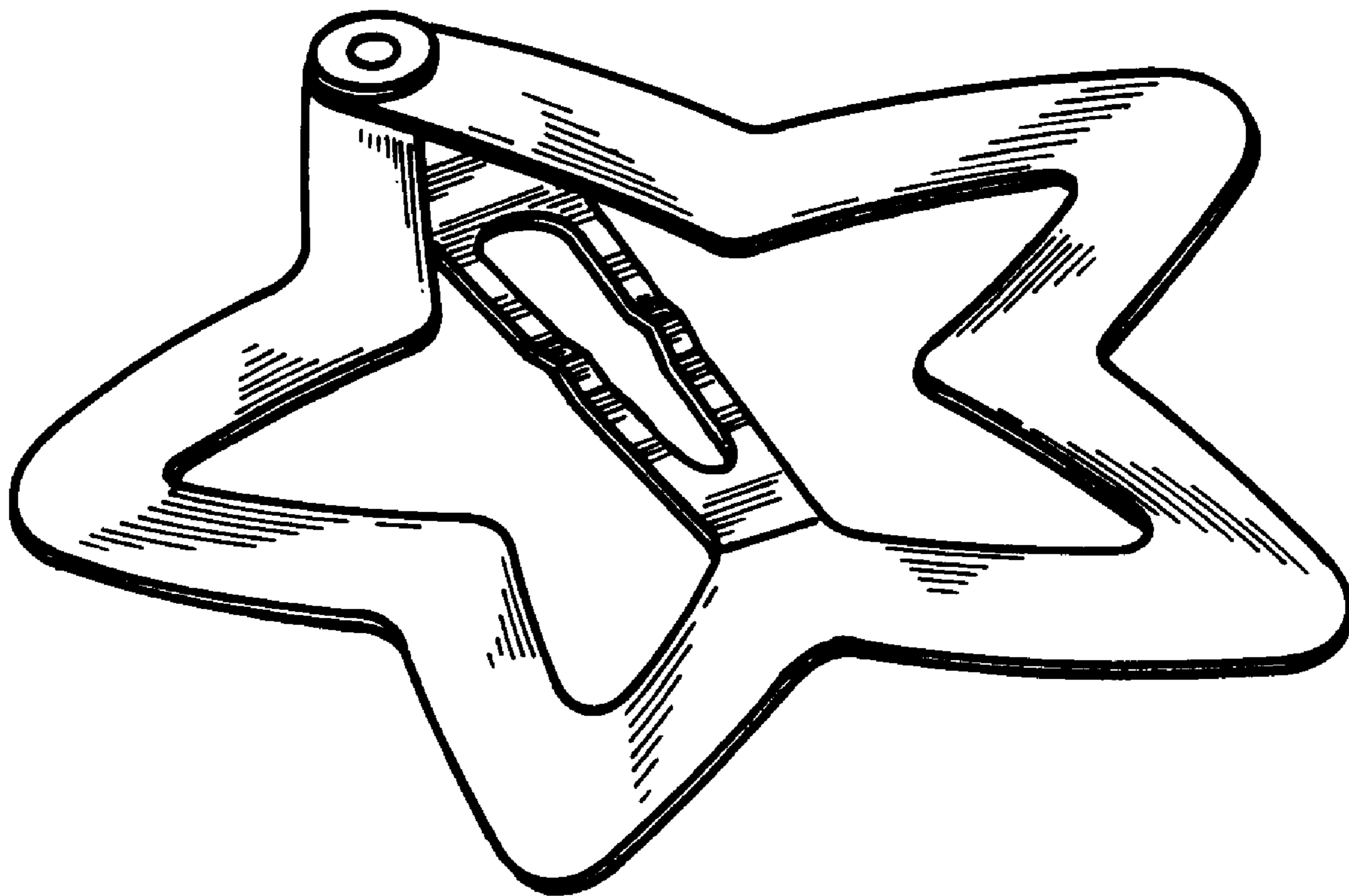
[57] **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a star-shape hair clip showing  
my new design;

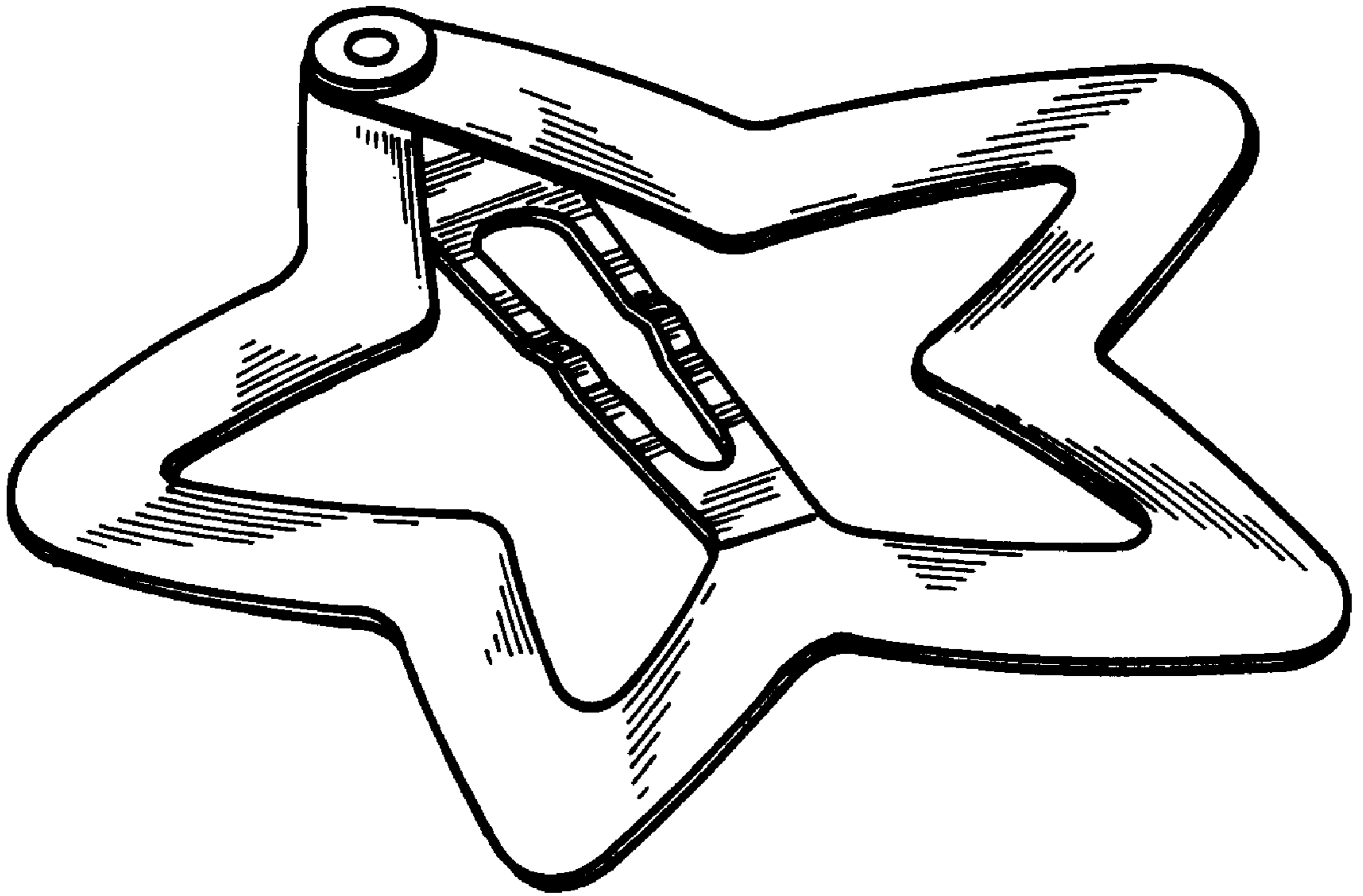

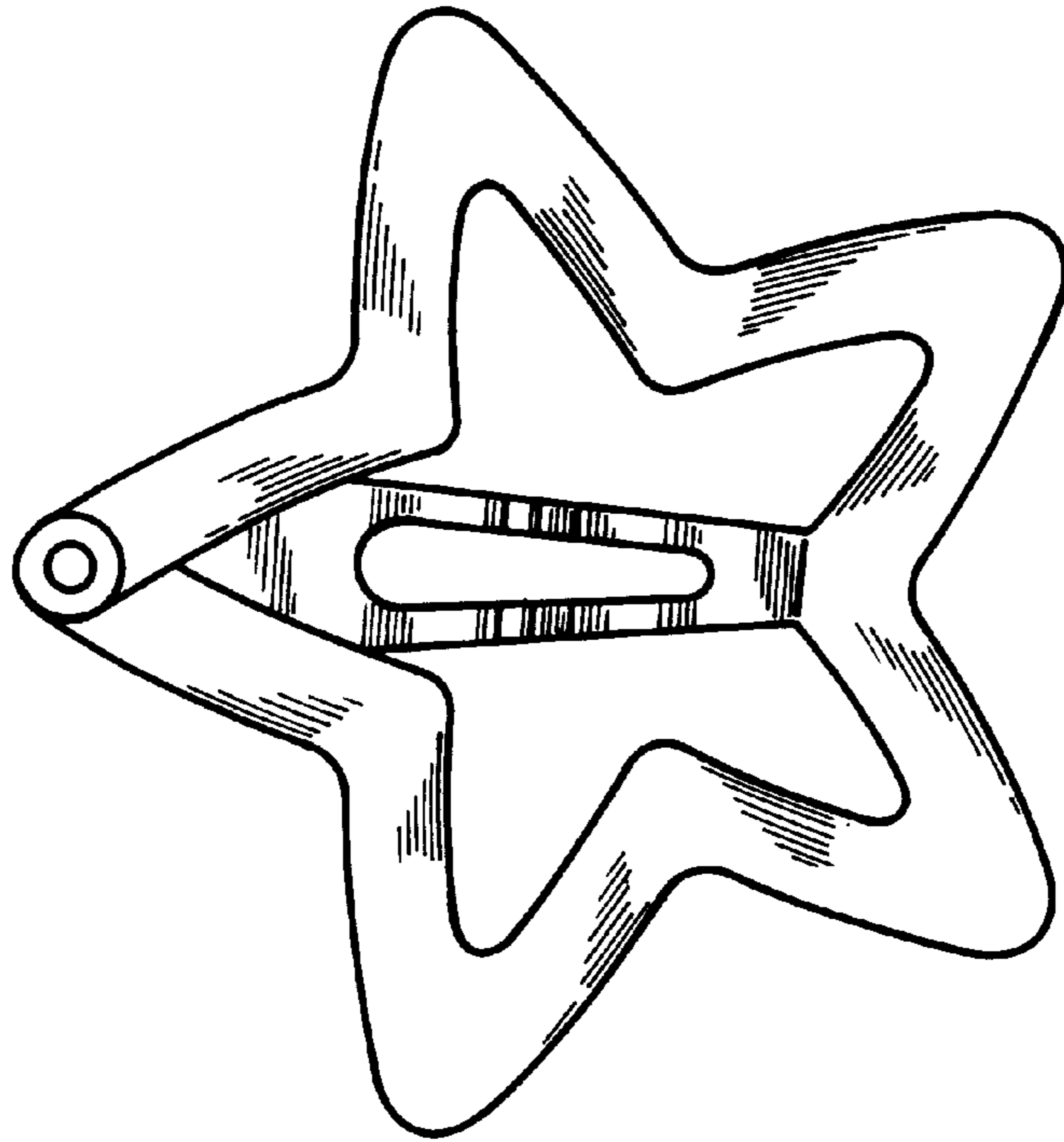

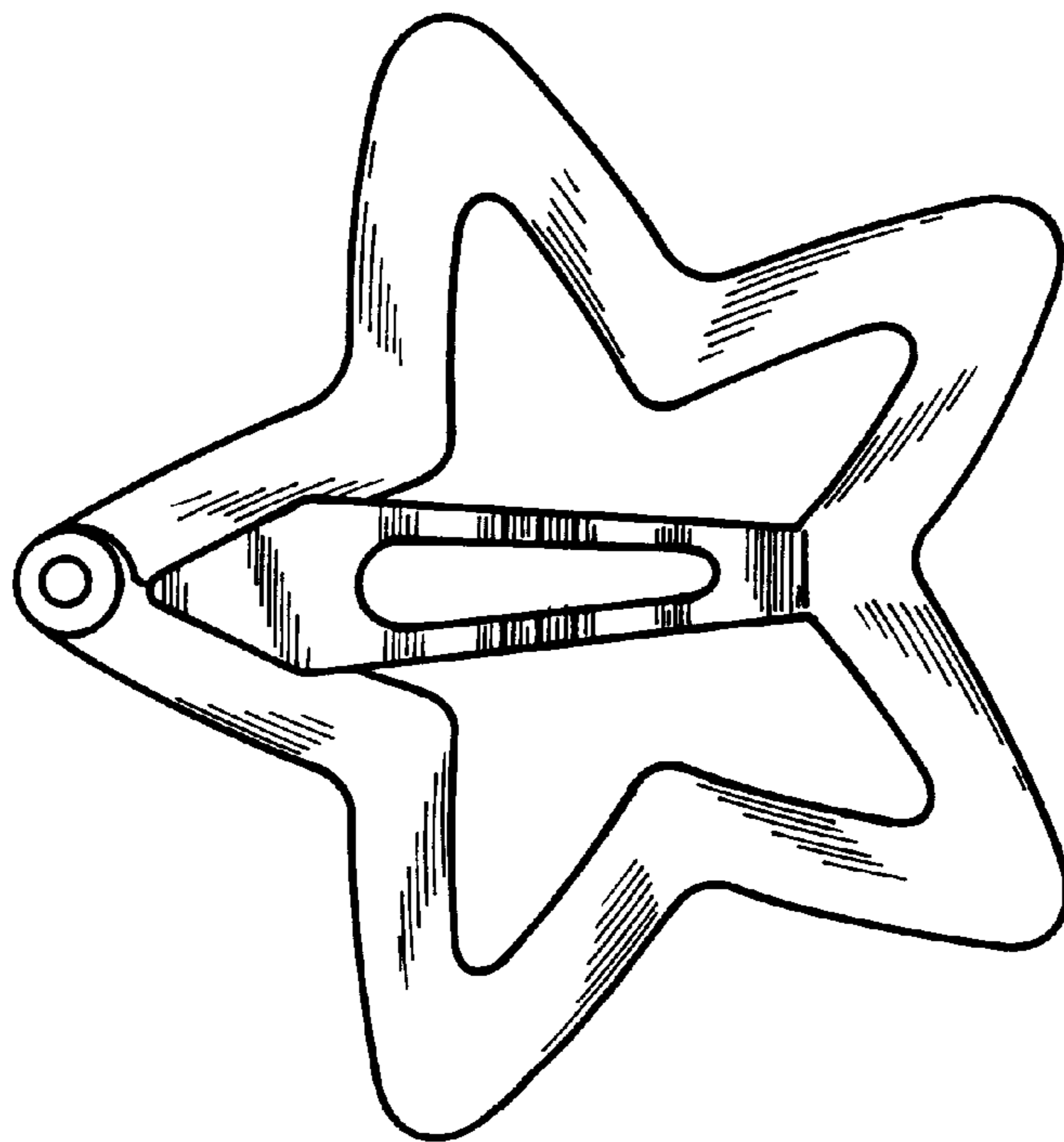
