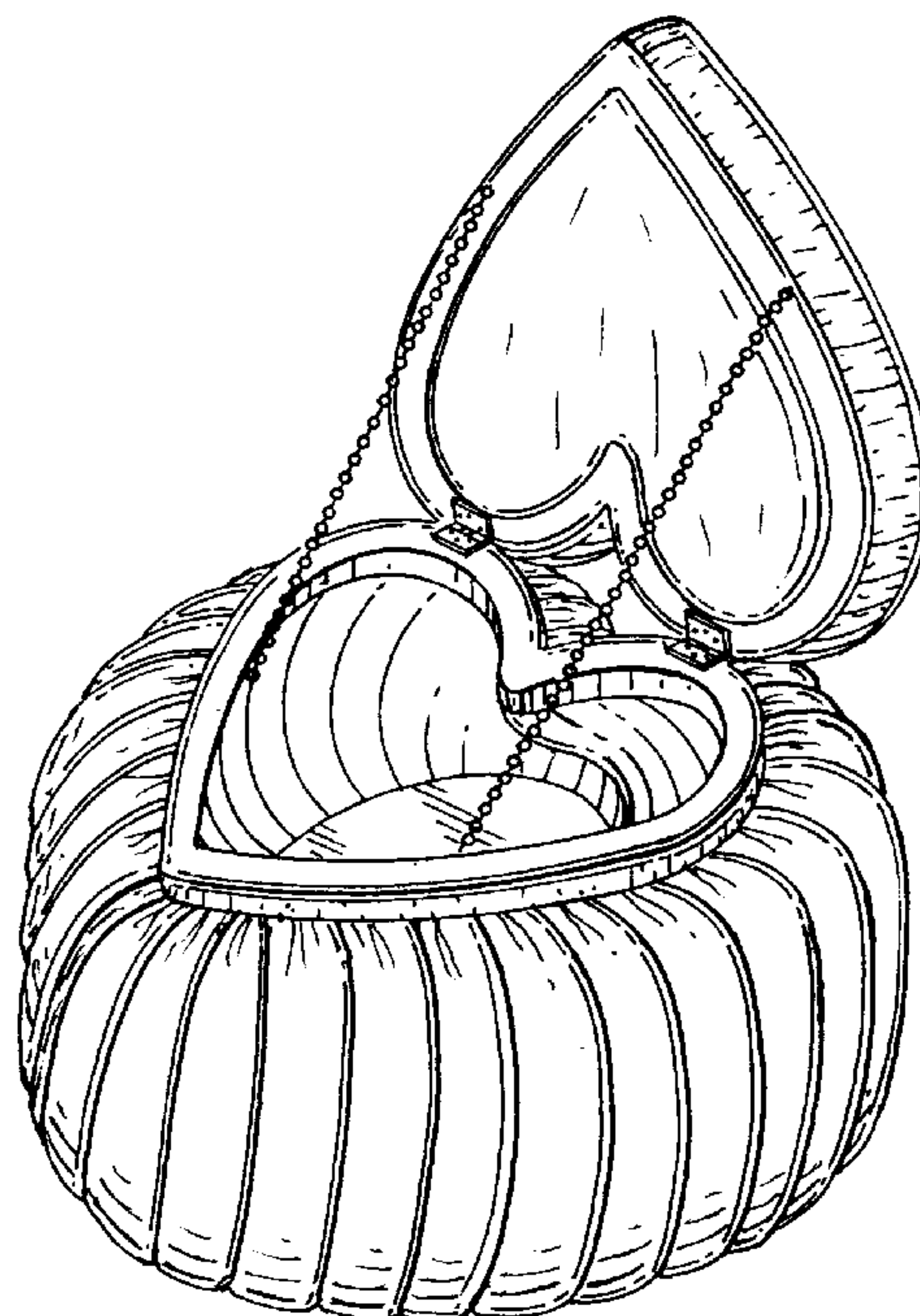
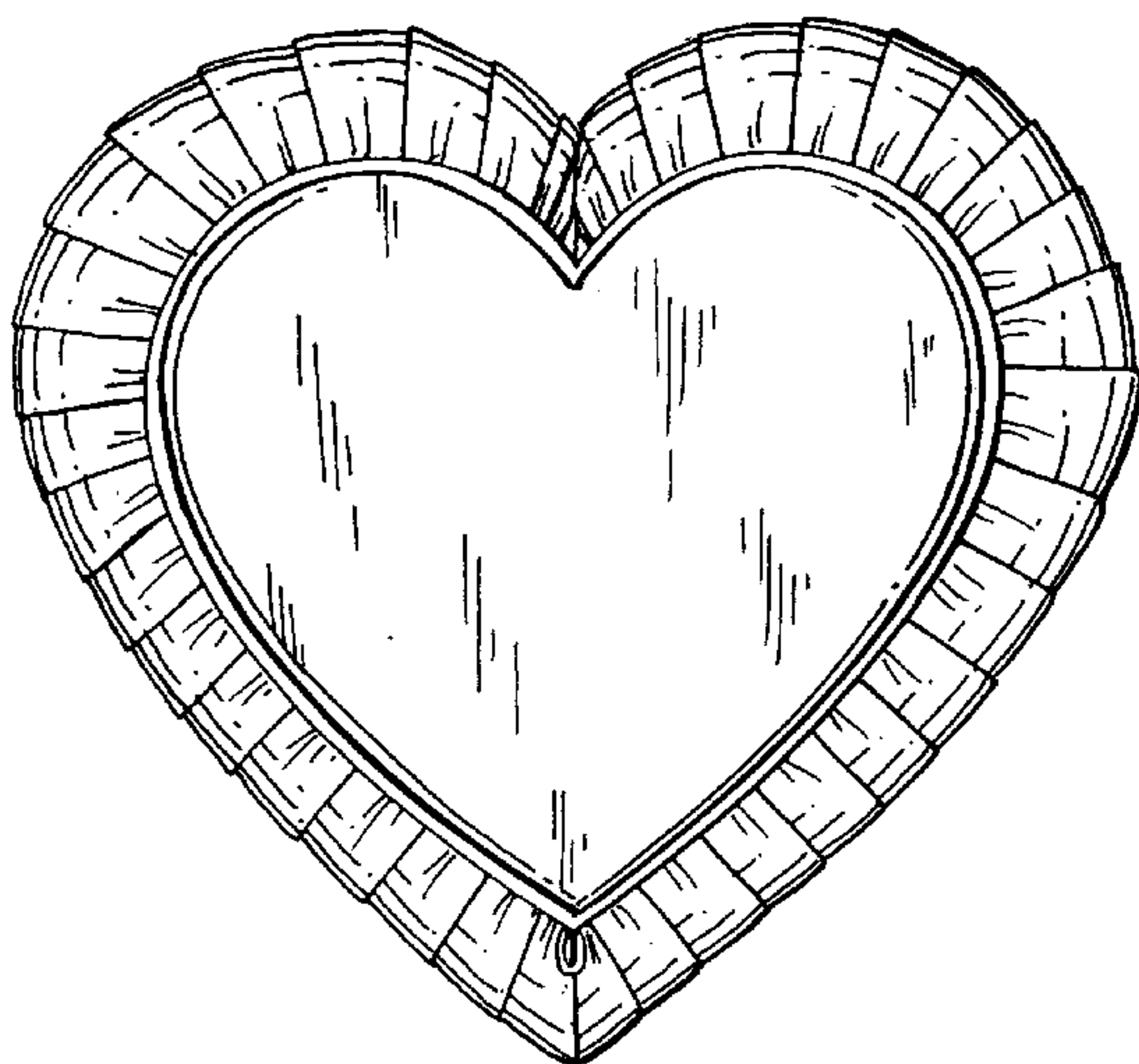
[57] **CLAIM**

**DESCRIPTION**

FIG. 1 is a top plan view of a seat with interior compartment showing my new design;

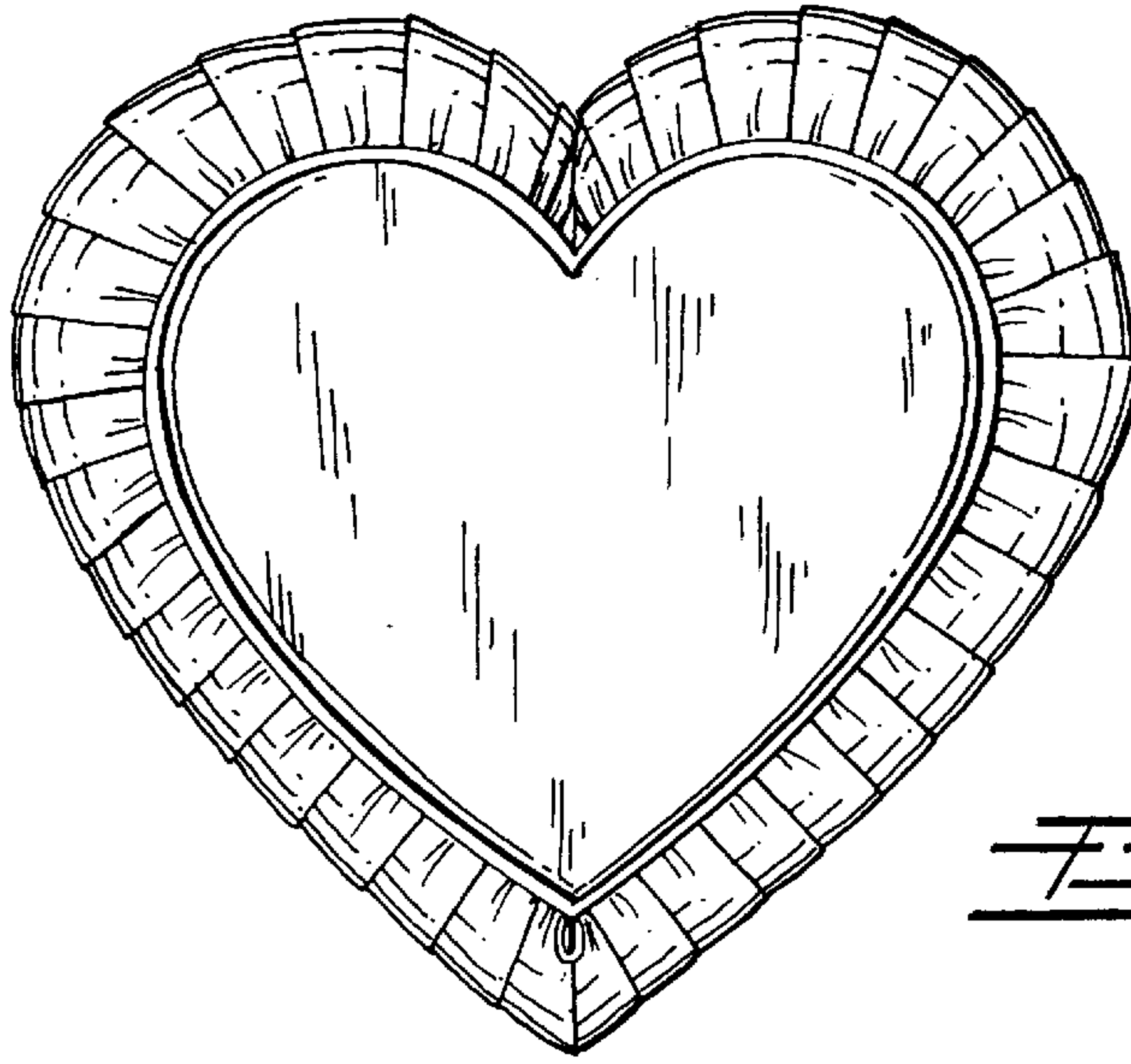

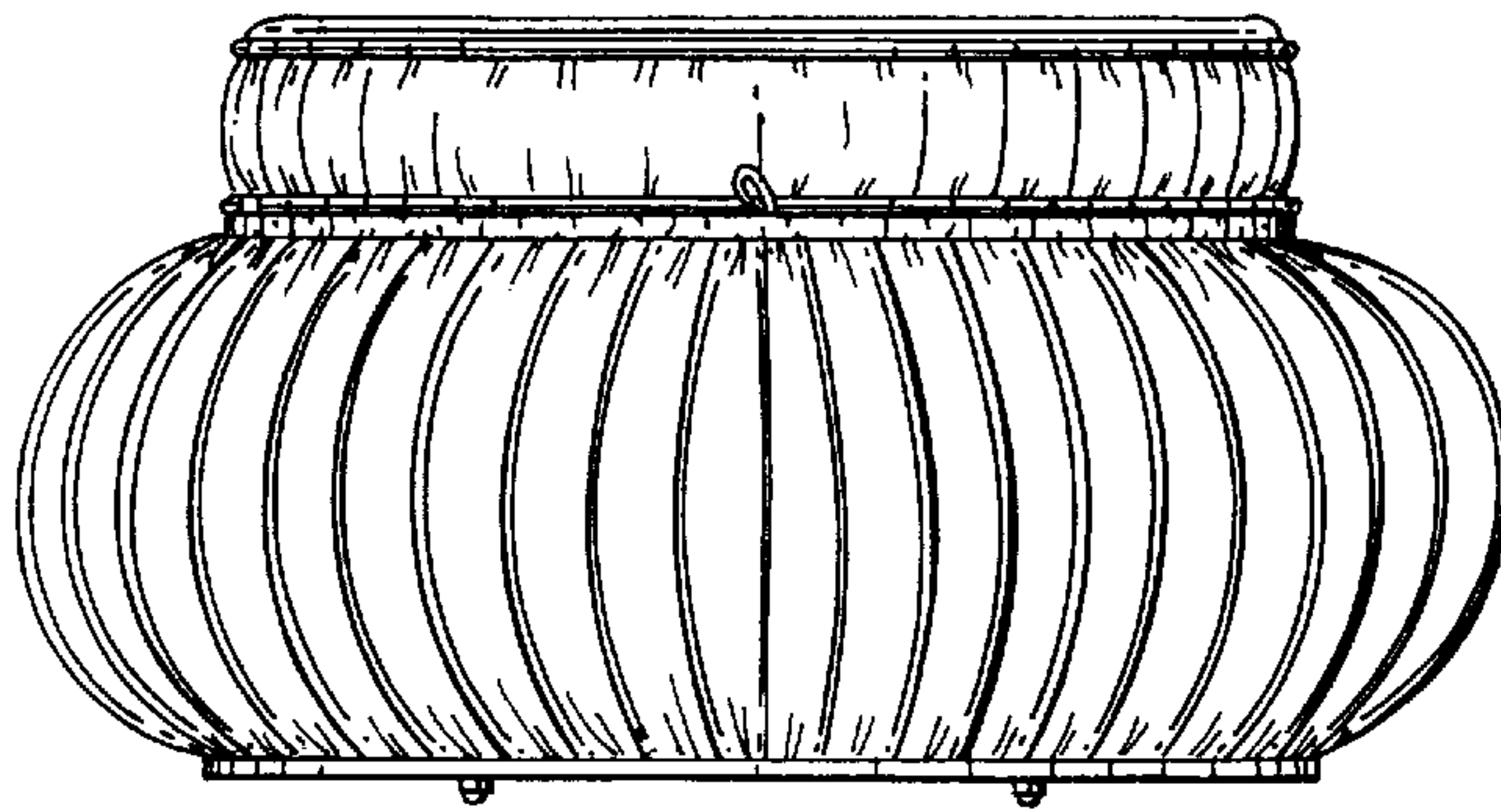

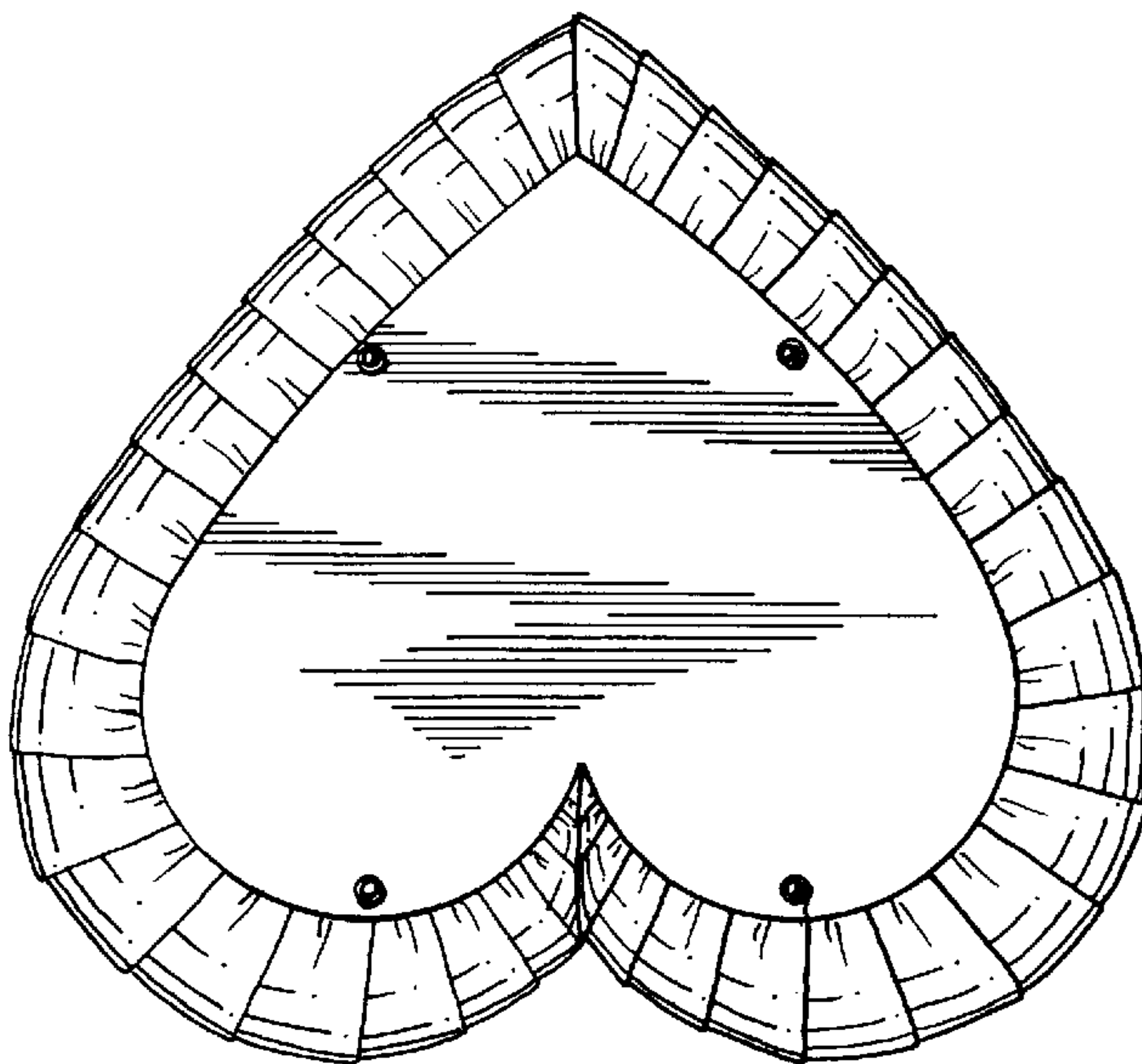

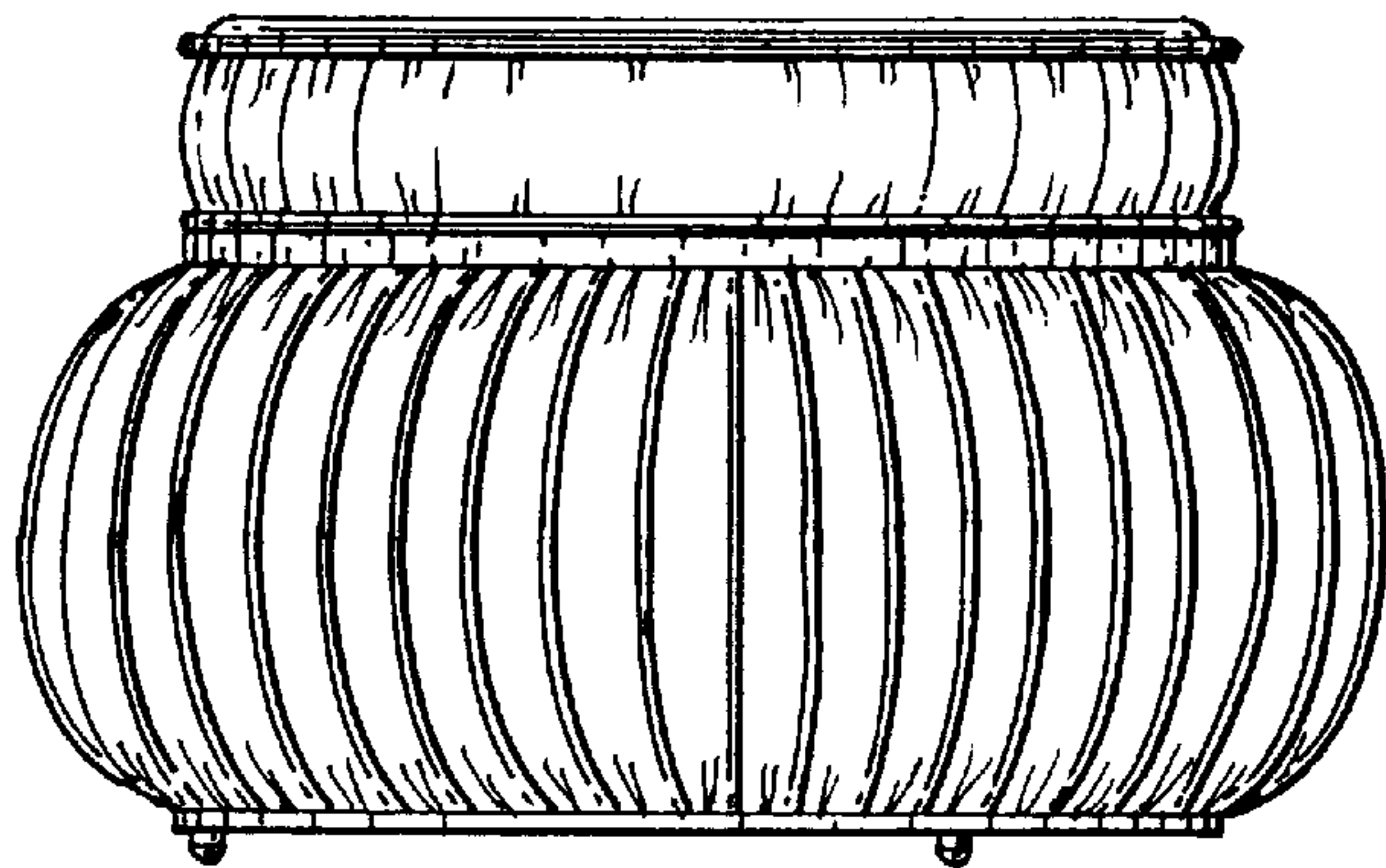

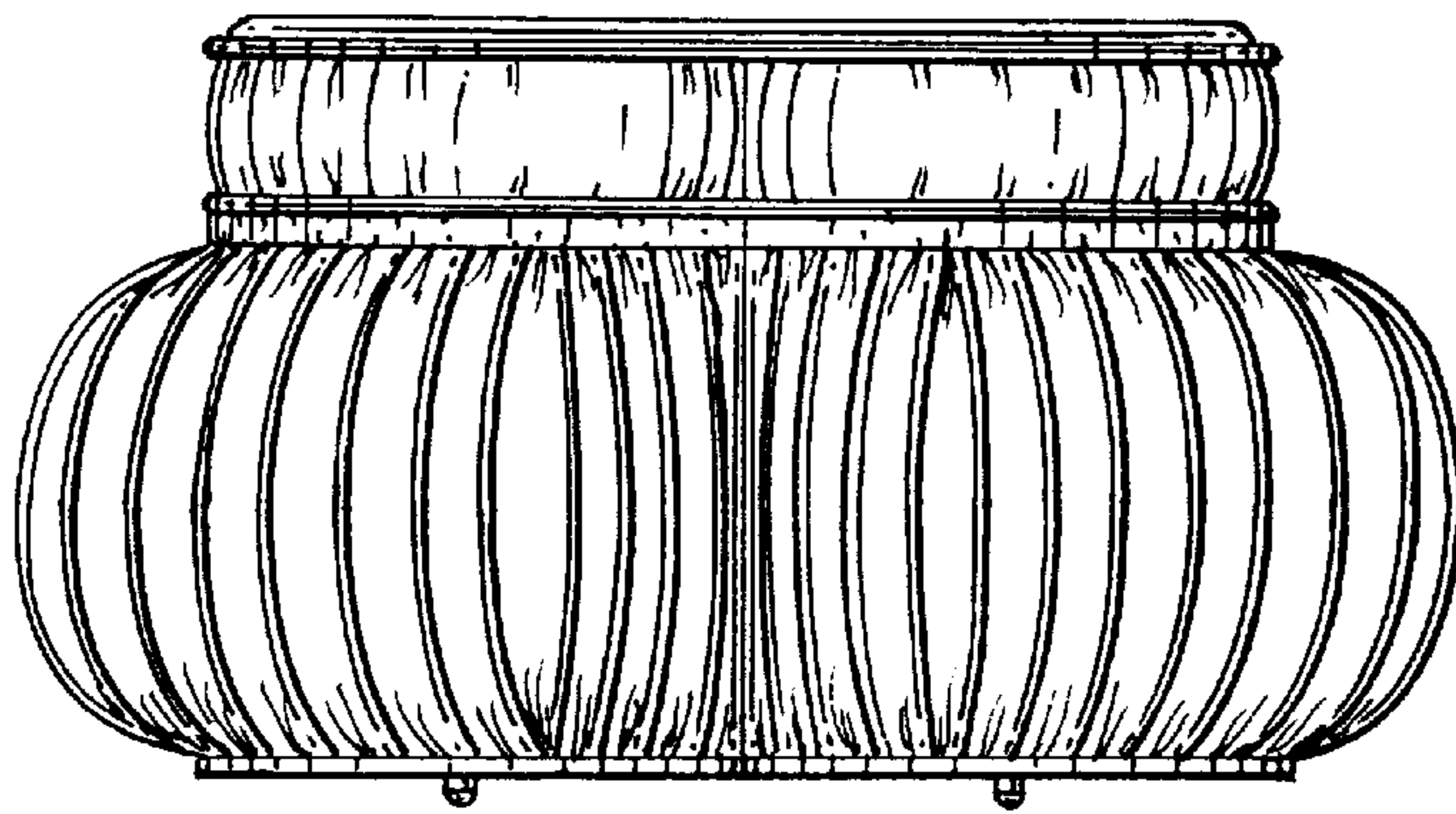

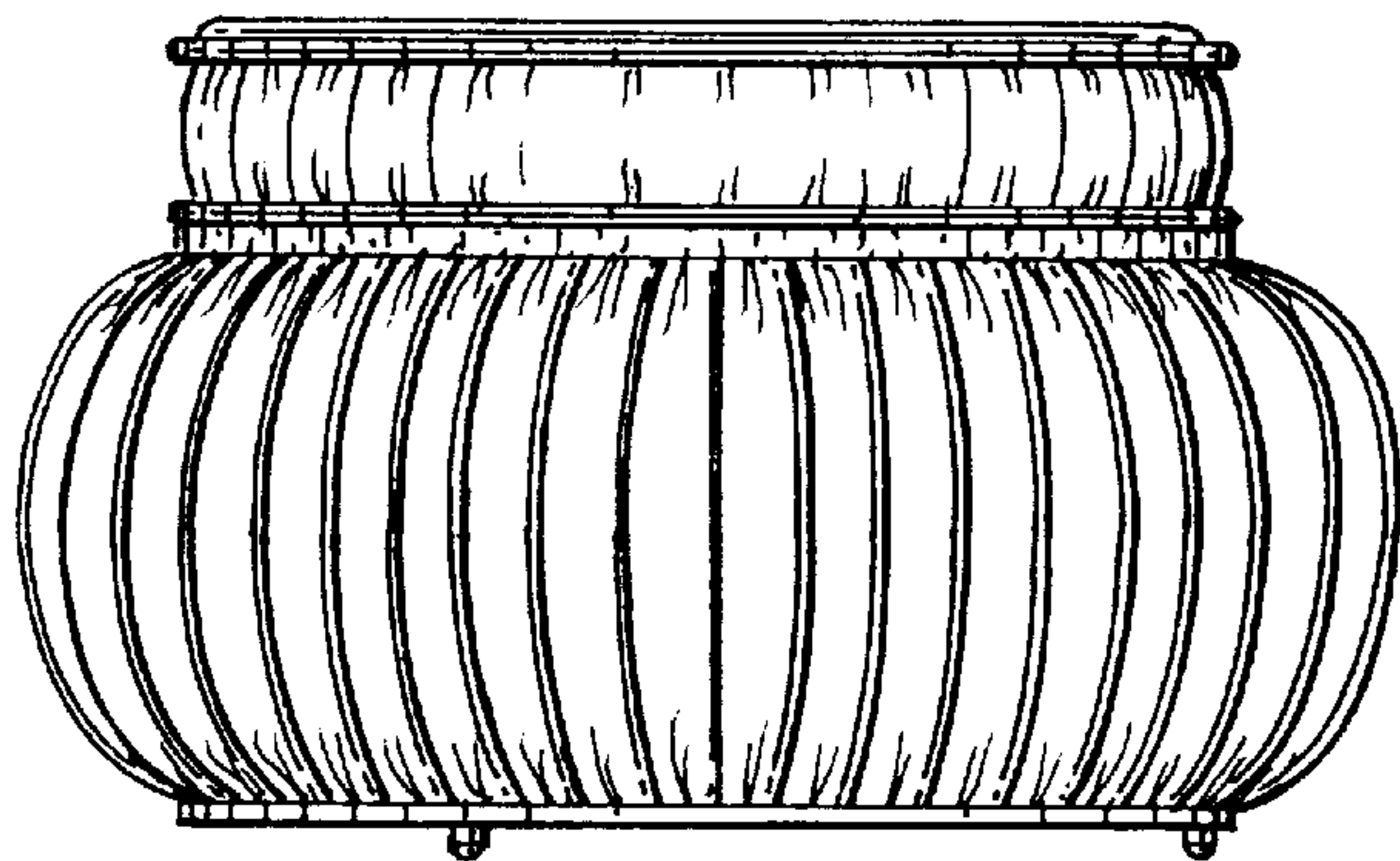

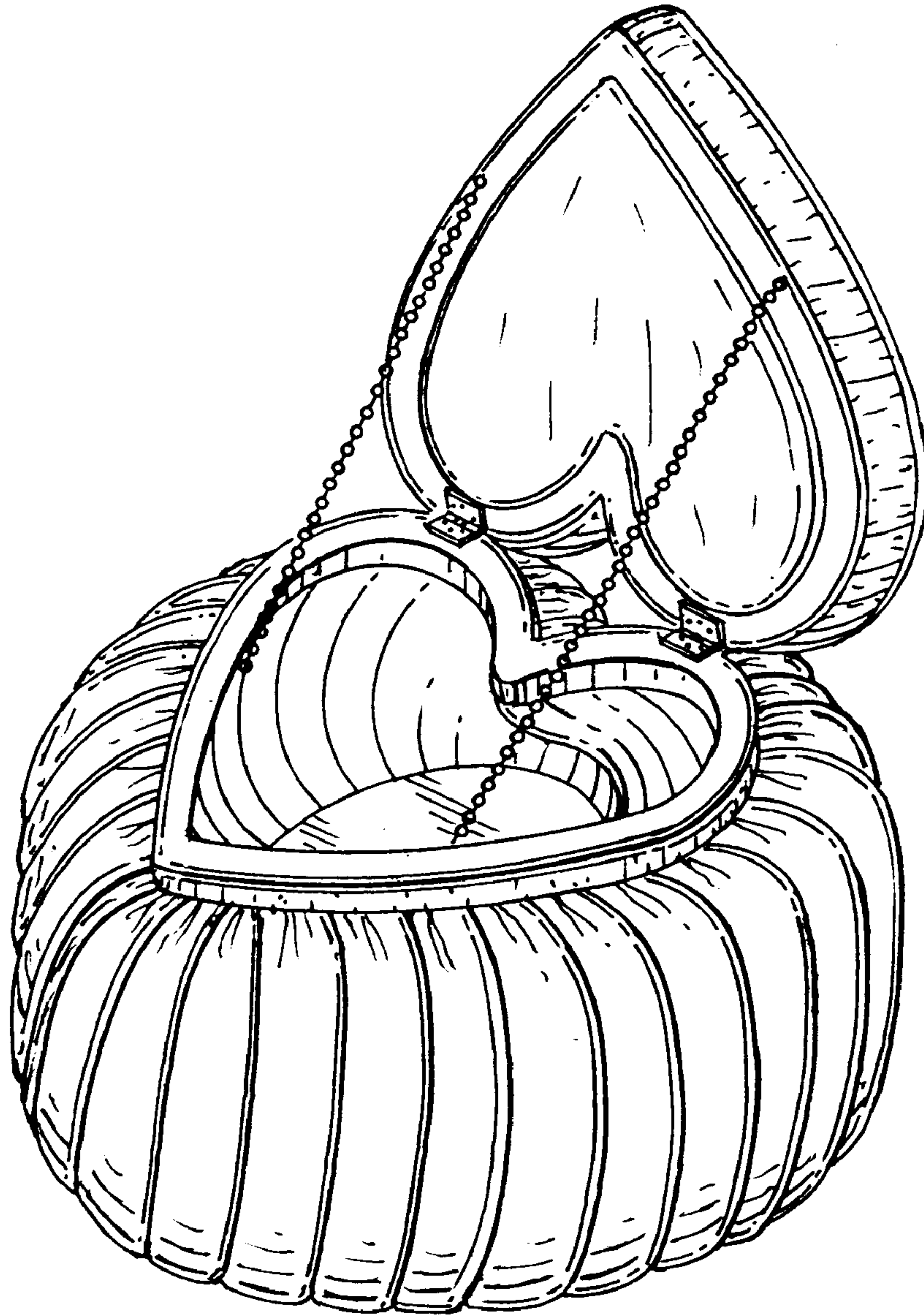
