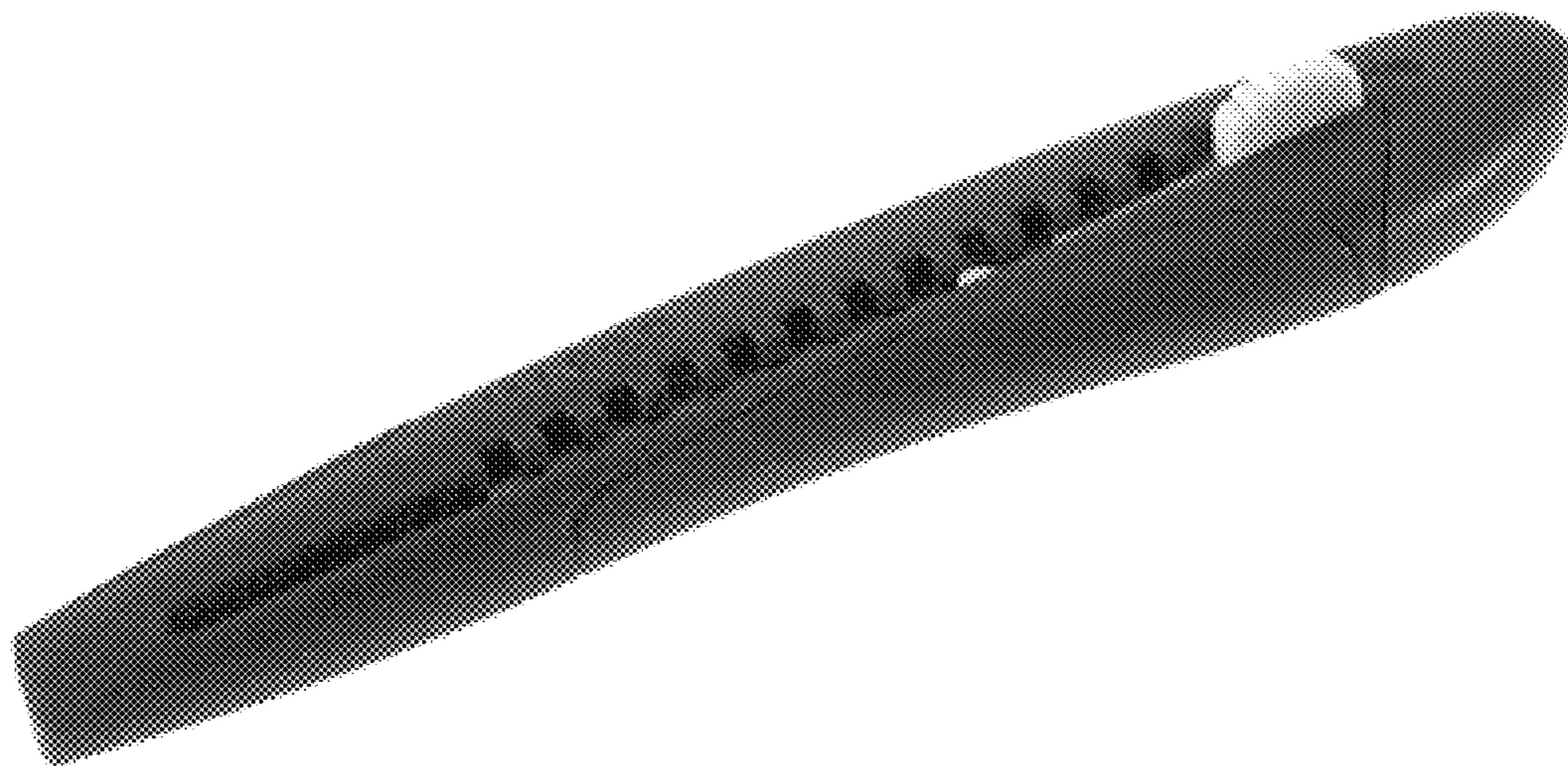

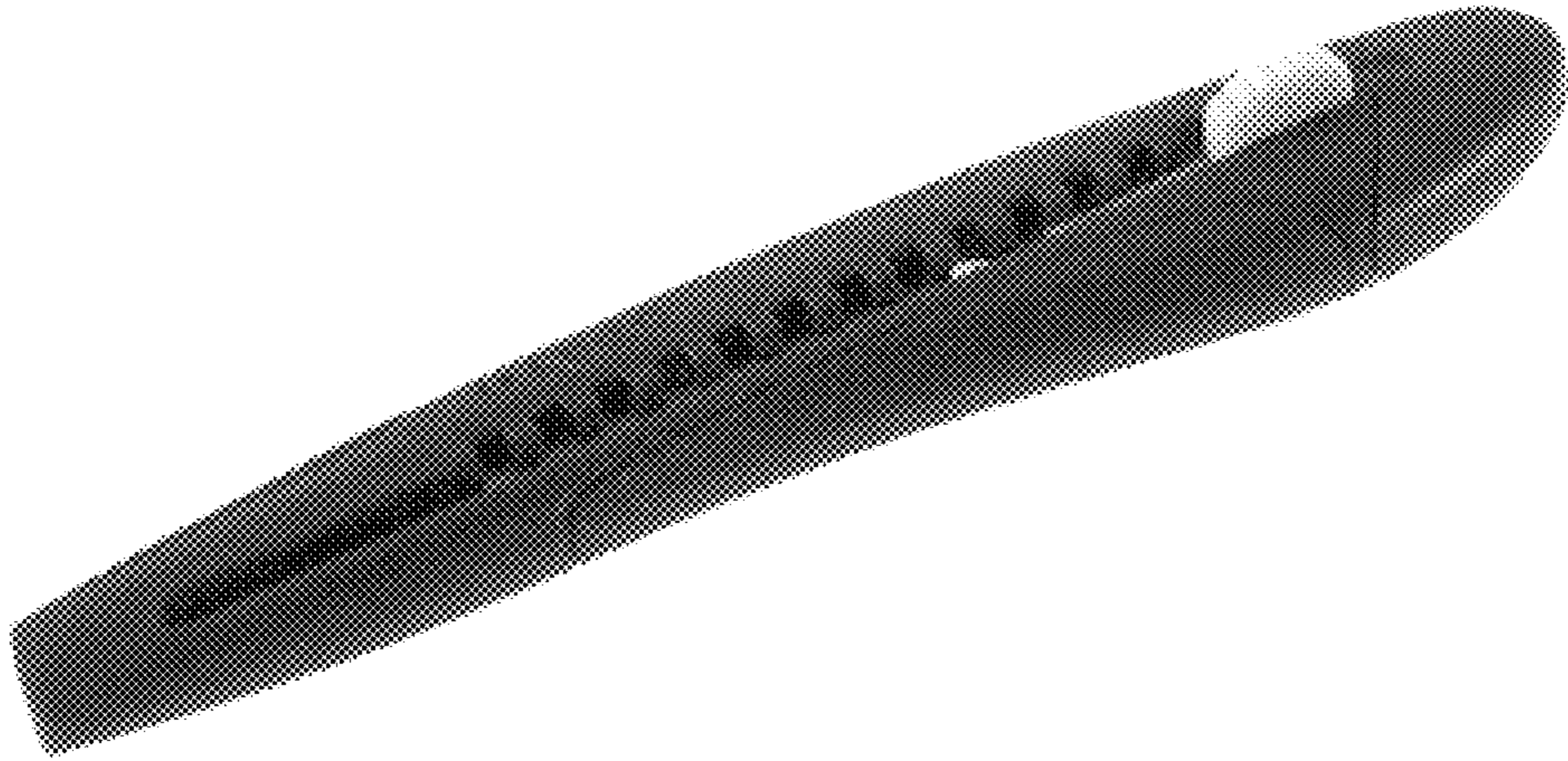
The ornamental design for a retractable and snappable cutting blade knife, as shown and described.

**DESCRIPTION**

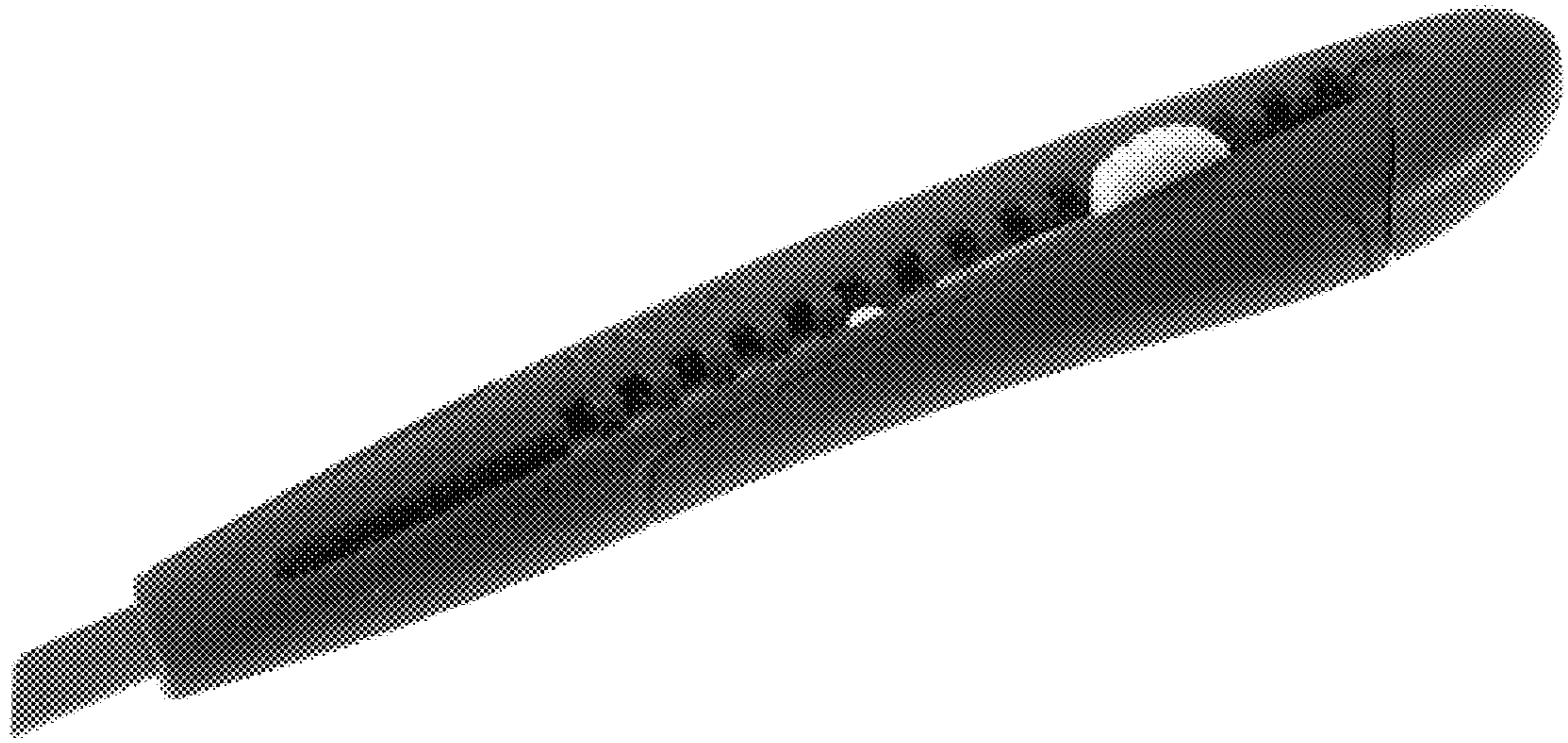
FIG. 1 is a front and side perspective view of a retractable and snappable cutting blade knife, showing my new design; FIG. 2 is a front and side perspective view thereof, the blade being in a projected position thereof; FIG. 3 is a side elevational view thereof; FIG. 4 is a side elevational view thereof, from the side opposite that shown in FIG. 3; FIG. 5 is a front elevational view thereof; FIG. 6 is a rear elevational view thereof; FIG. 7 is an end elevational view thereof, taken from the left of FIG. 4; and, FIG. 8 is an end elevational view thereof, taken from the right of FIG. 4.

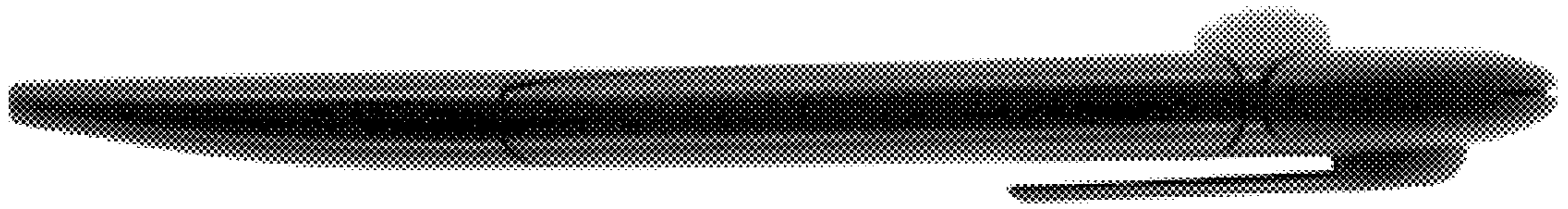

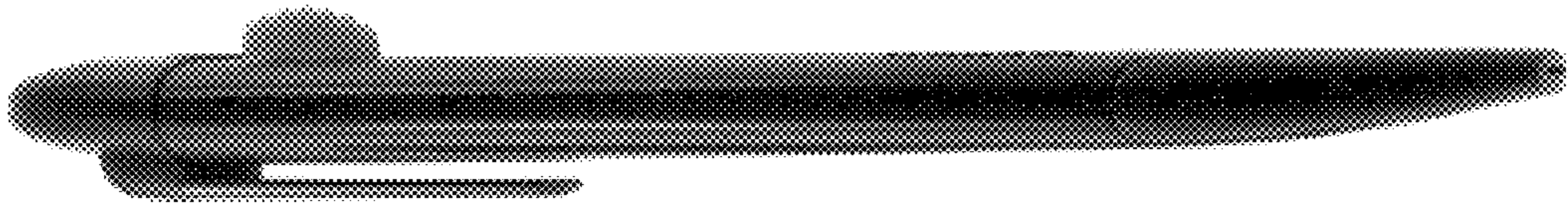

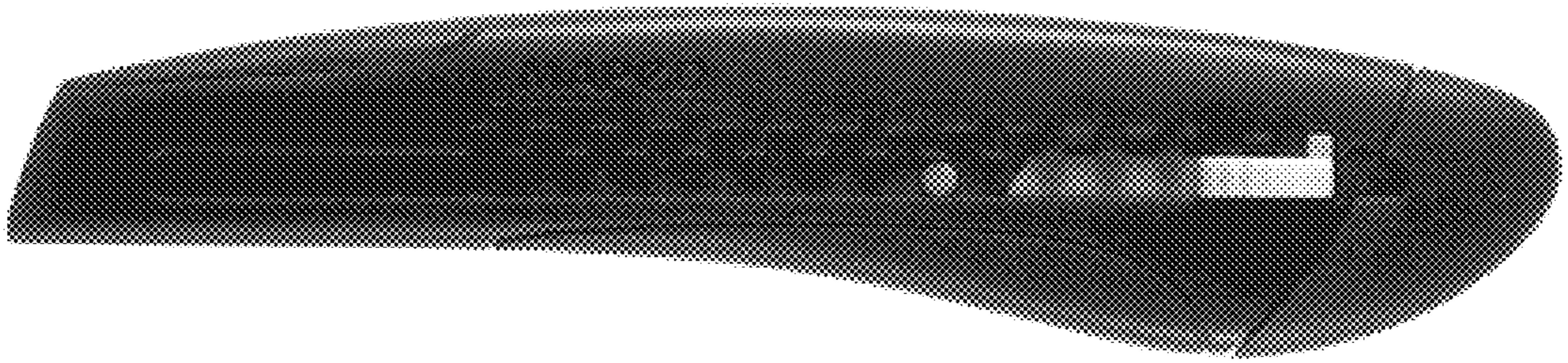




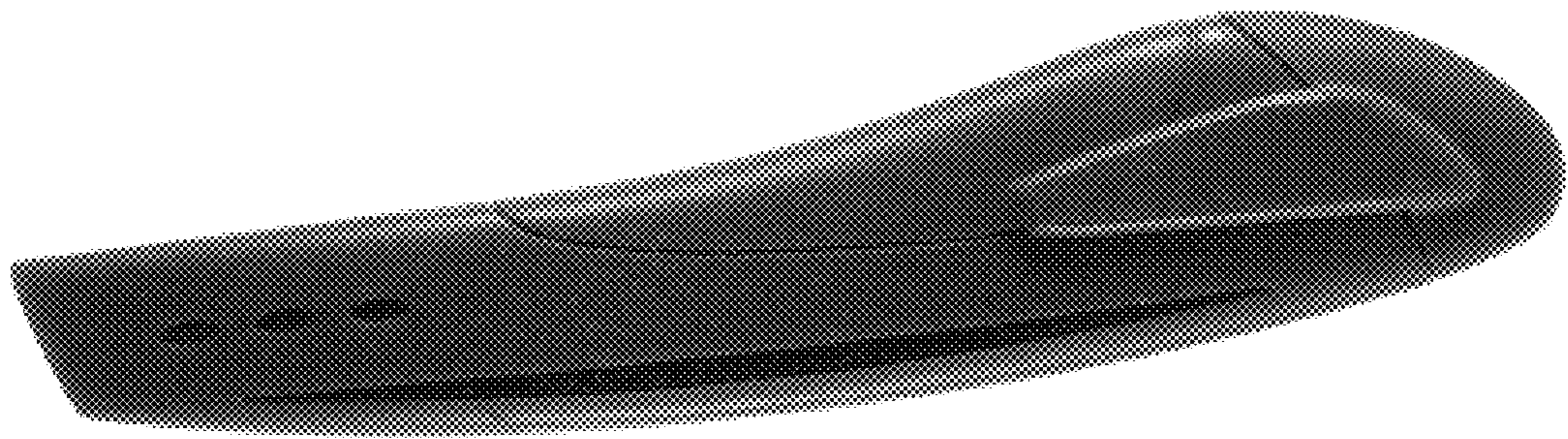

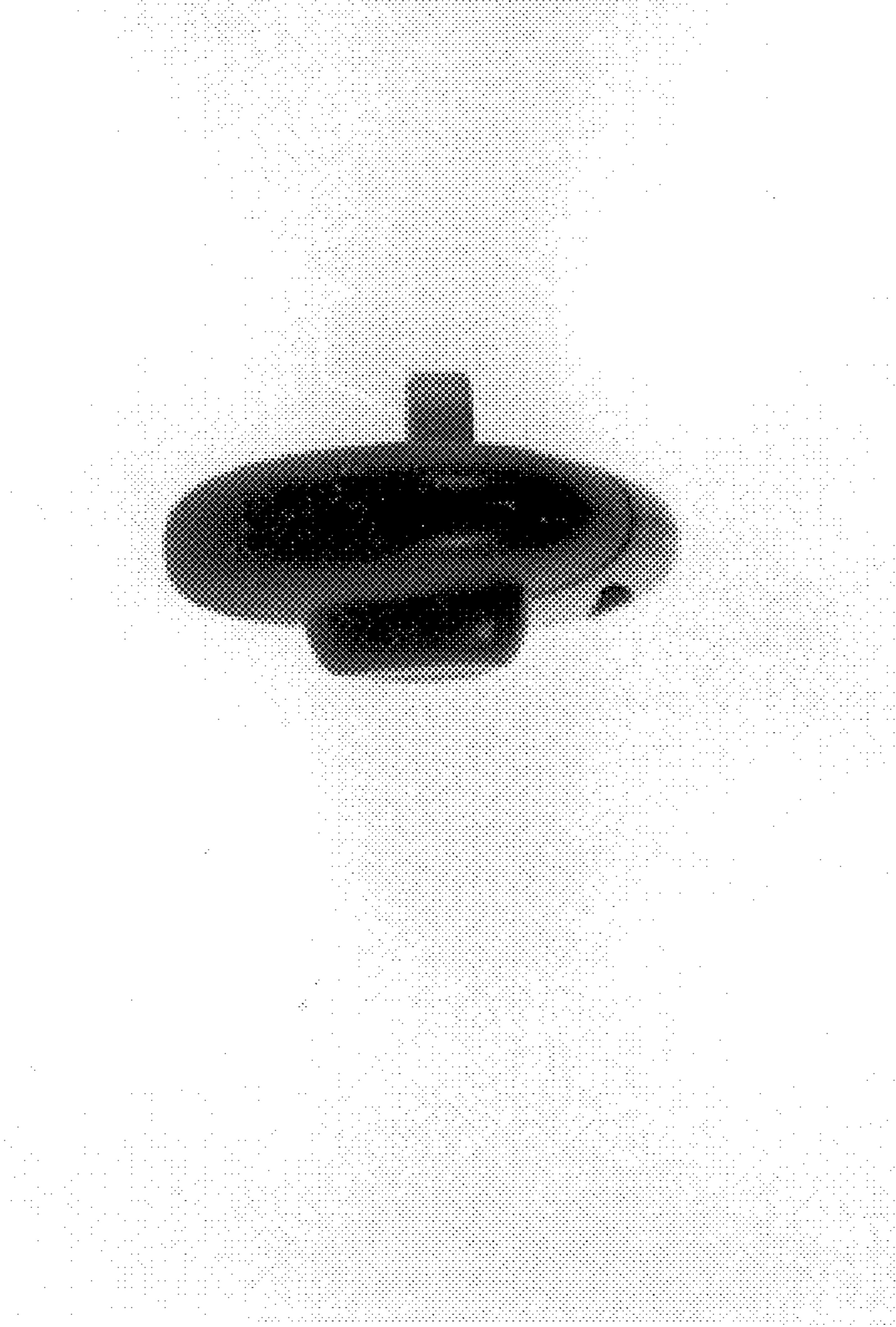
