The ornamental design for a covering profile system, as shown and described.

**DESCRIPTION**

FIG. 1 is an isometric view of a first profile component of

a system according to the invention;

FIG. 2 is a front view of the profile component as seen in FIG. 1;

FIG. 3 is a rear view of the first profile component as seen in FIG. 1;

FIG. 4 is a left view of the first profile component as seen in FIG. 1;

FIG. 5 is a right view of the first profile component as seen in FIG. 1;

FIG. 6 is a top view of the first profile component as seen in FIG. 1;

FIG. 7 is a bottom view of the first profile component as seen in FIG. 1;

FIG. 8 is an isometric view of a second profile component of the system according to the invention;

FIG. 9 is a front view of the second profile component as seen in FIG. 8;

FIG. 10 is a rear view of the second profile component as seen in FIG. 8;

FIG. 11 is a left view of the second profile component as seen in FIG. 8;

FIG. 12 is a right view of the second profile component as seen in FIG. 8;

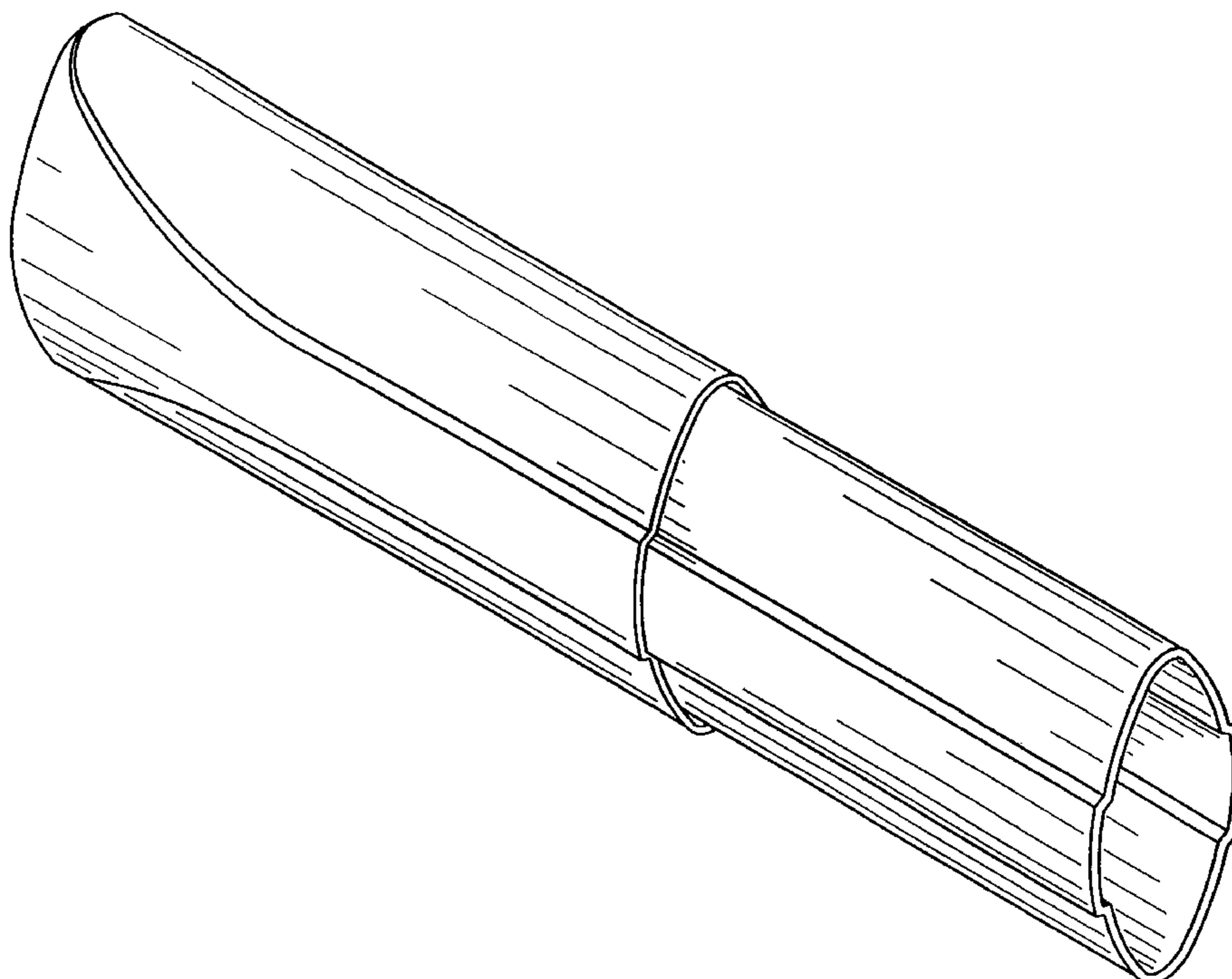
FIG. 13 is a top view of the second profile component as seen in FIG. 8;

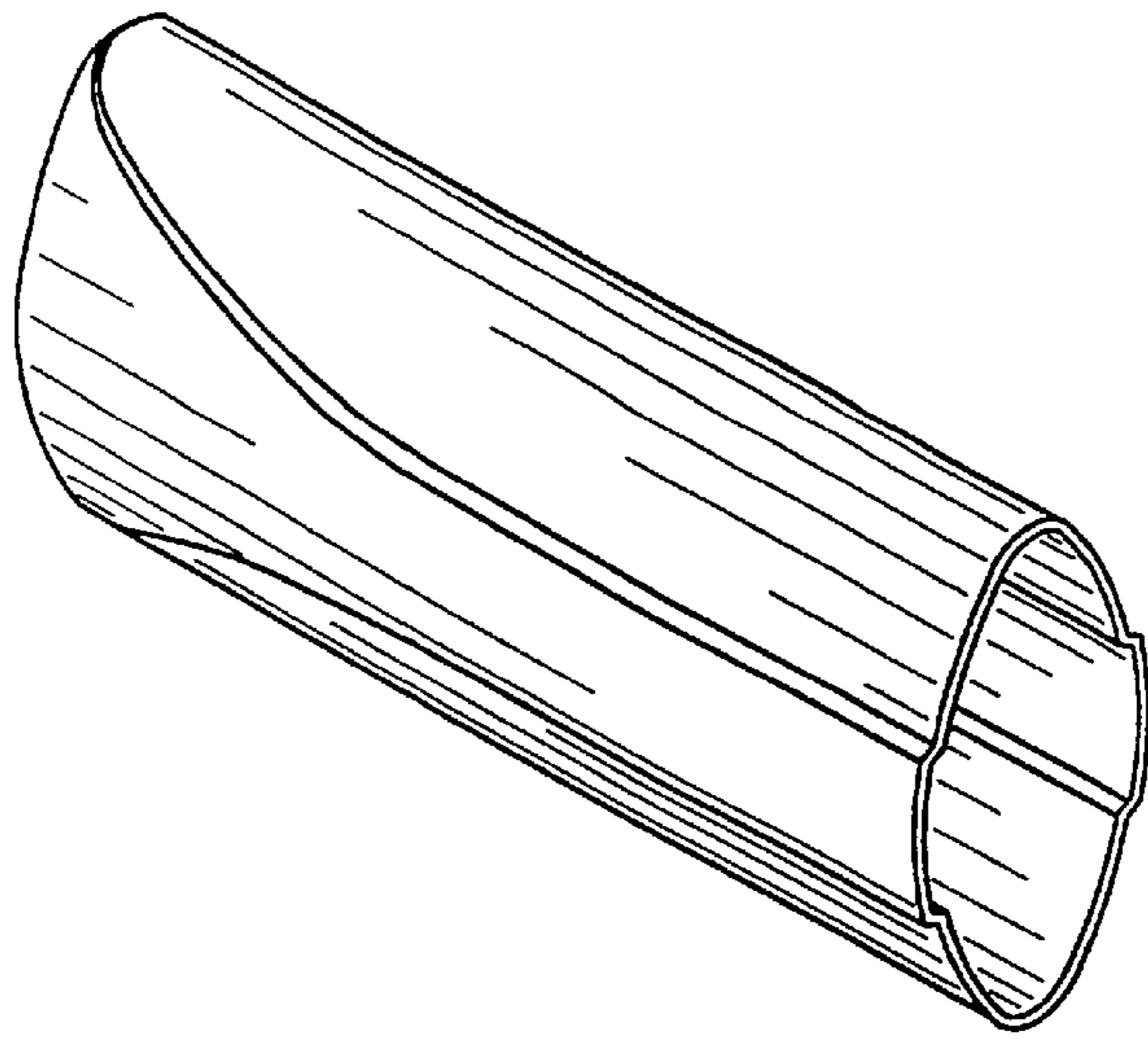

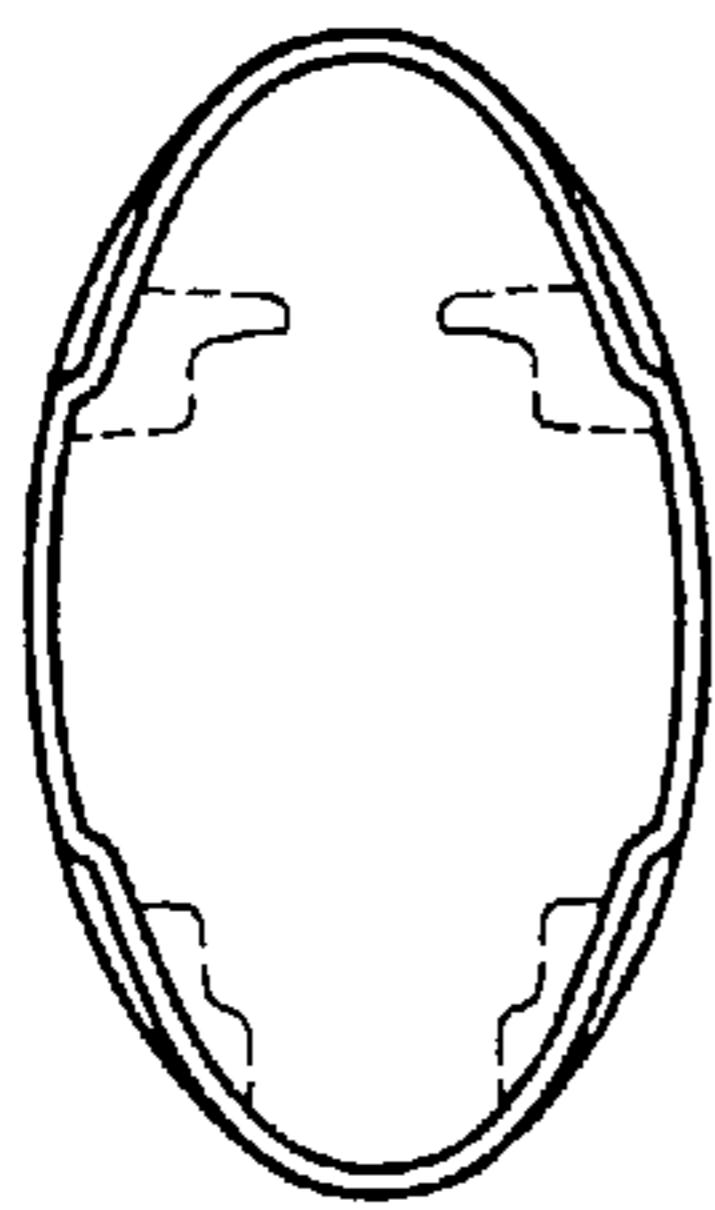

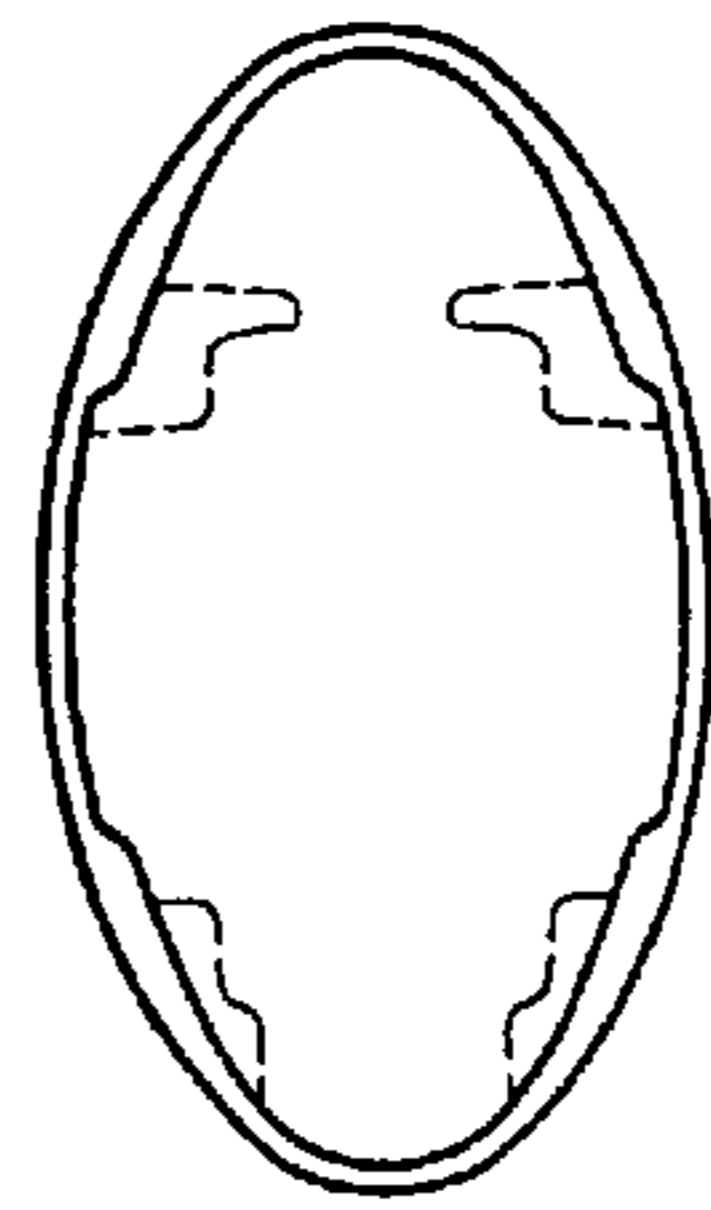

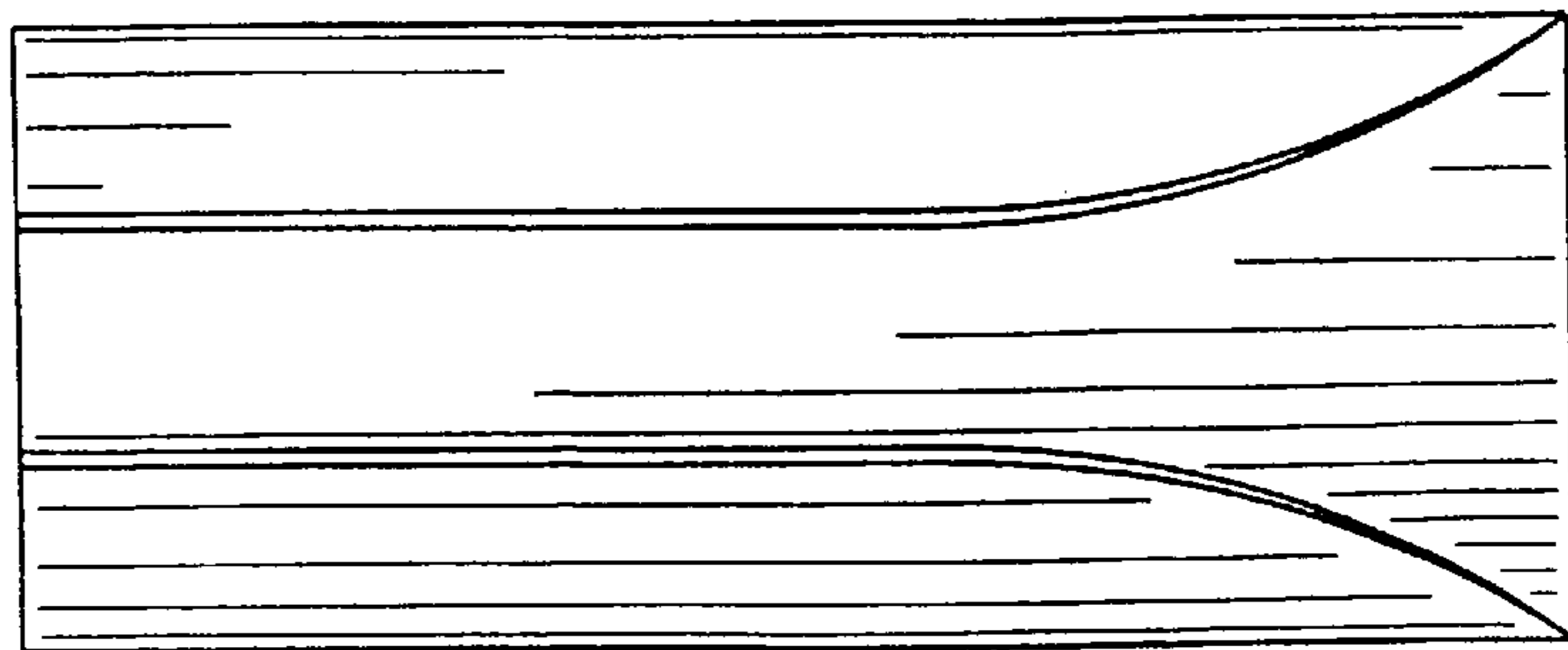

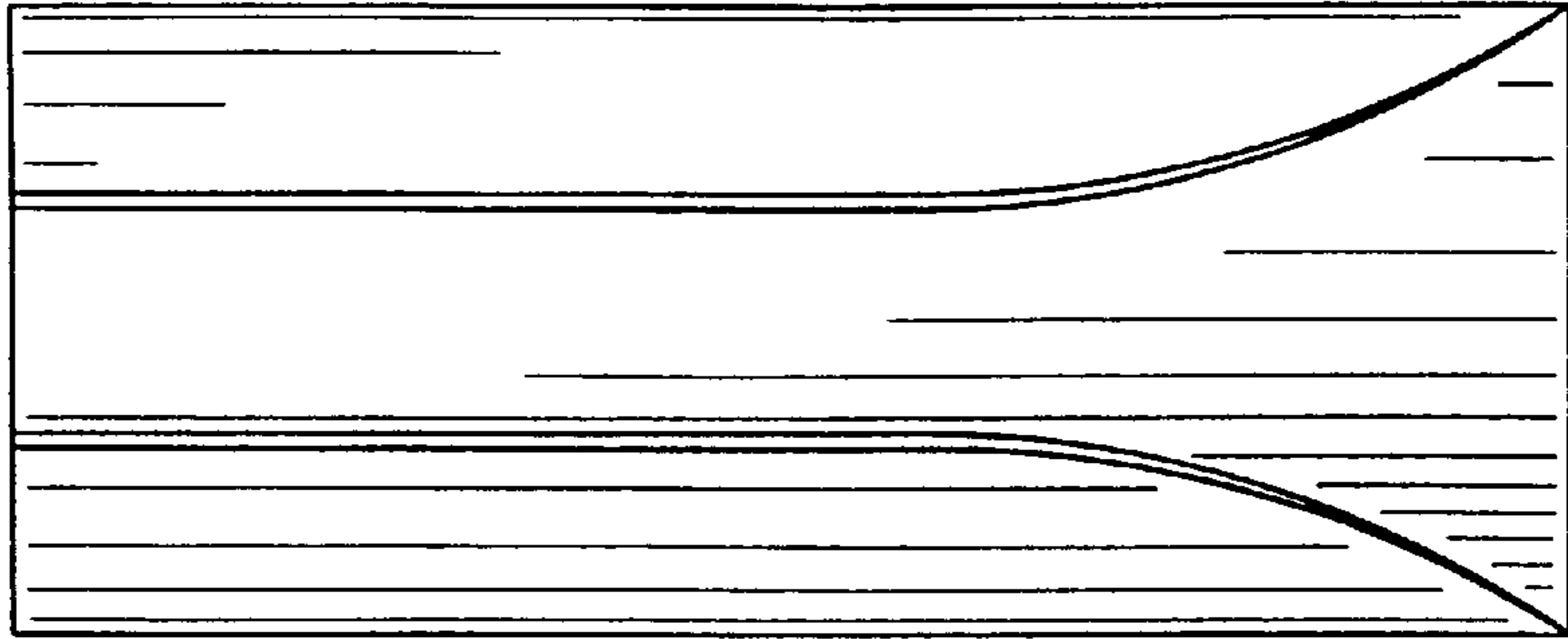

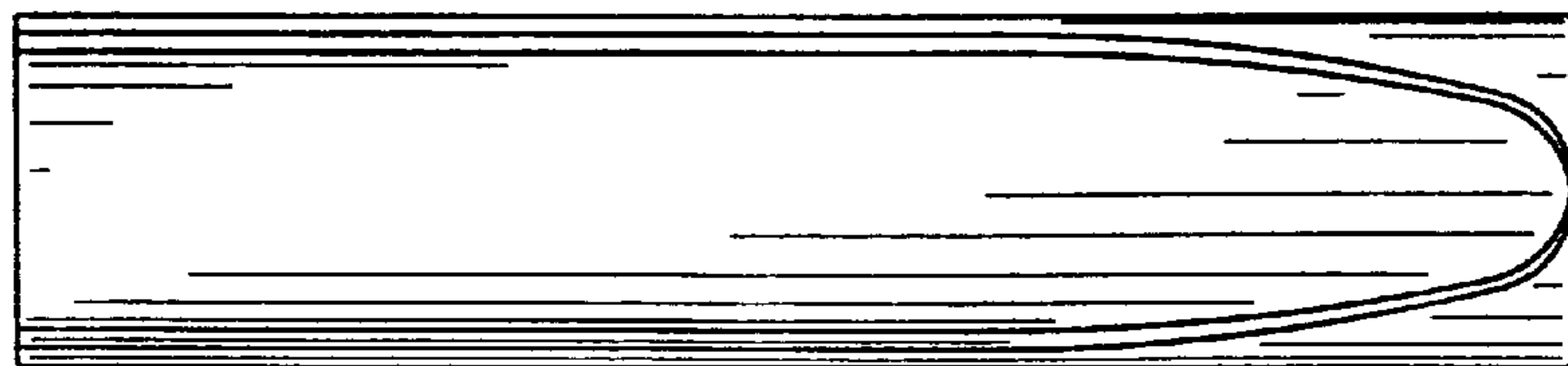

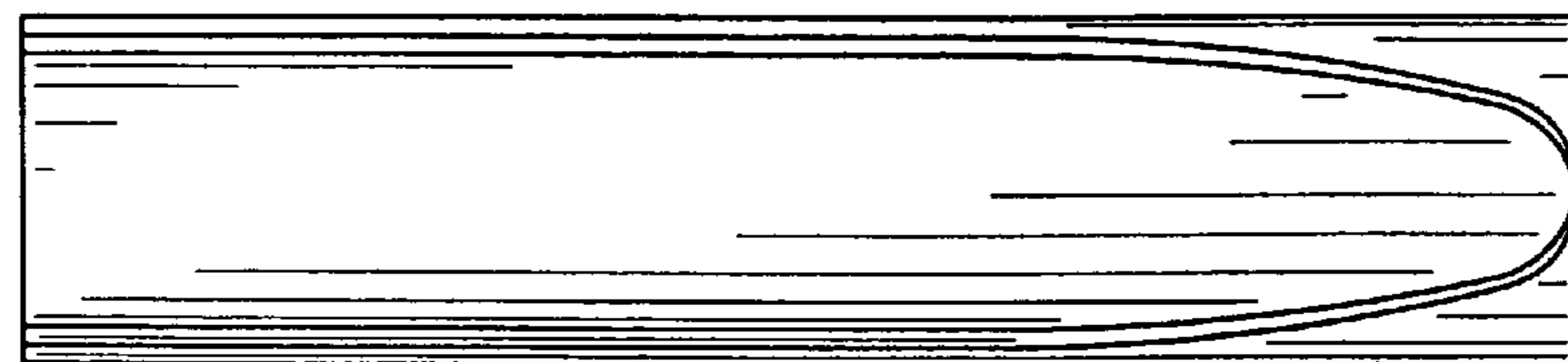

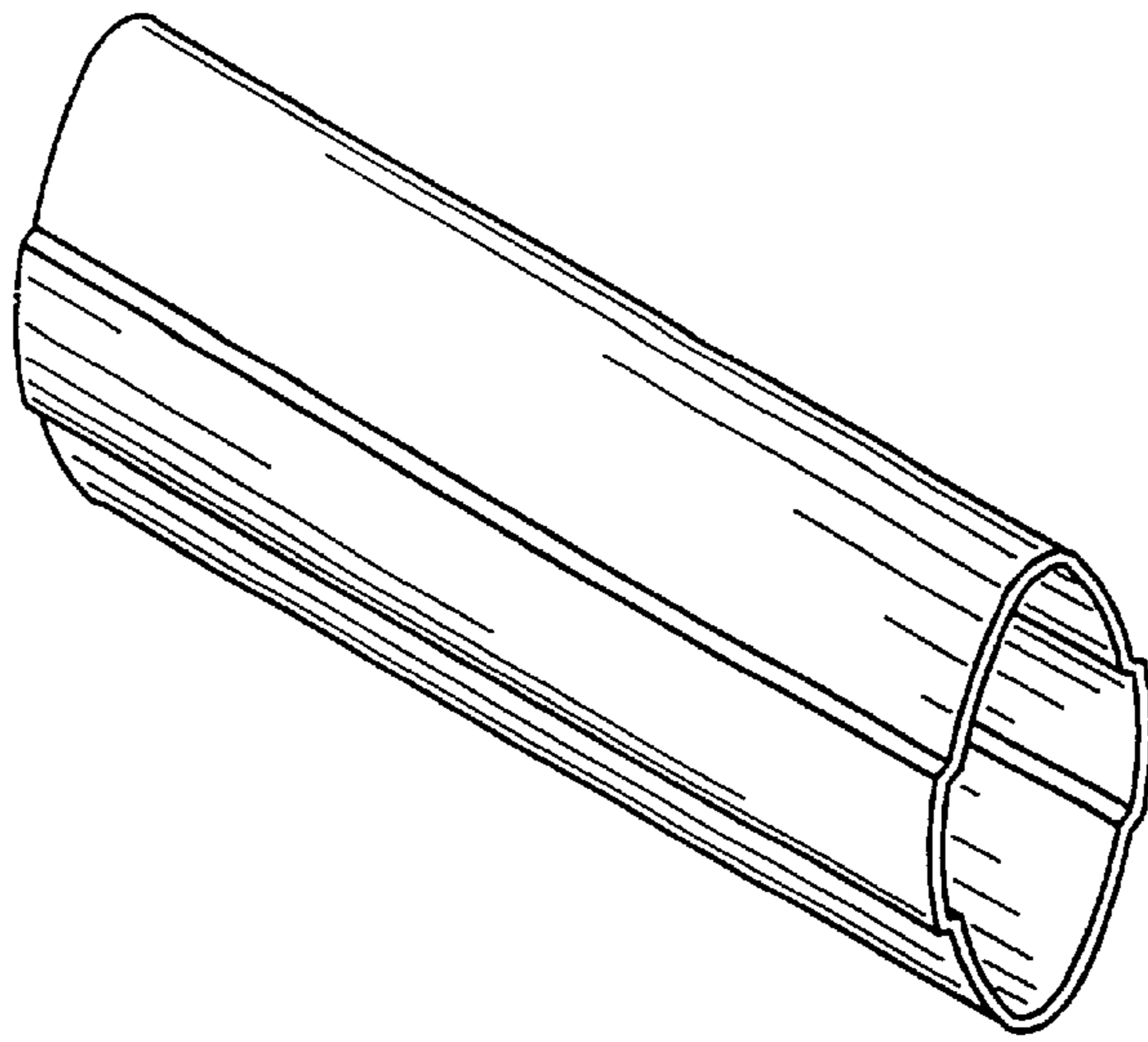

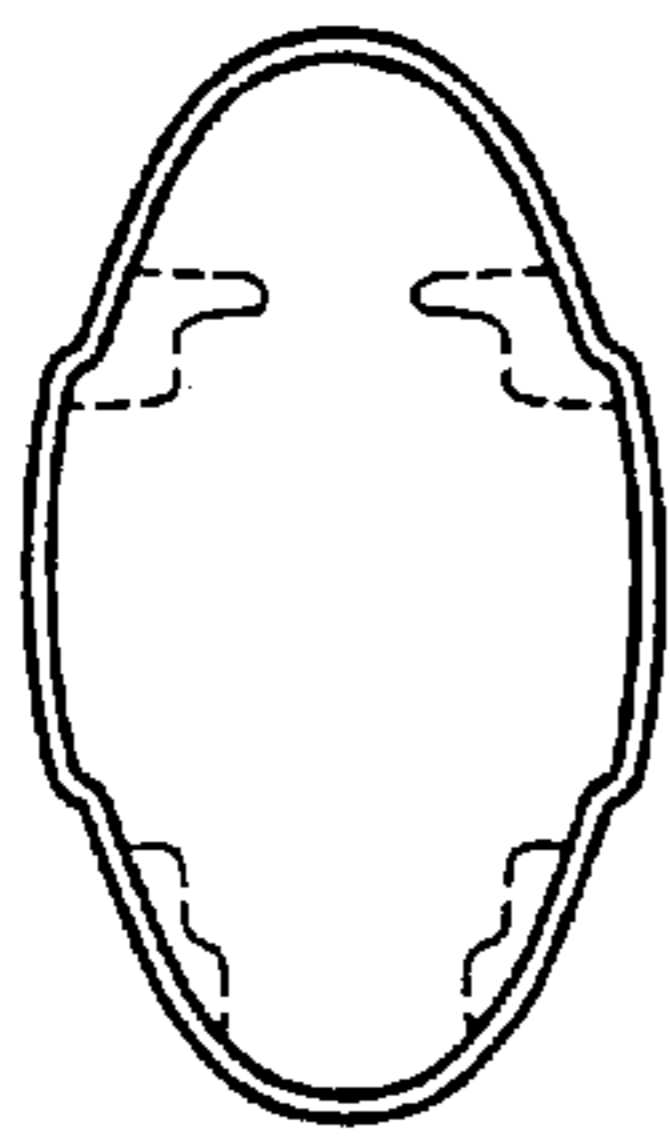

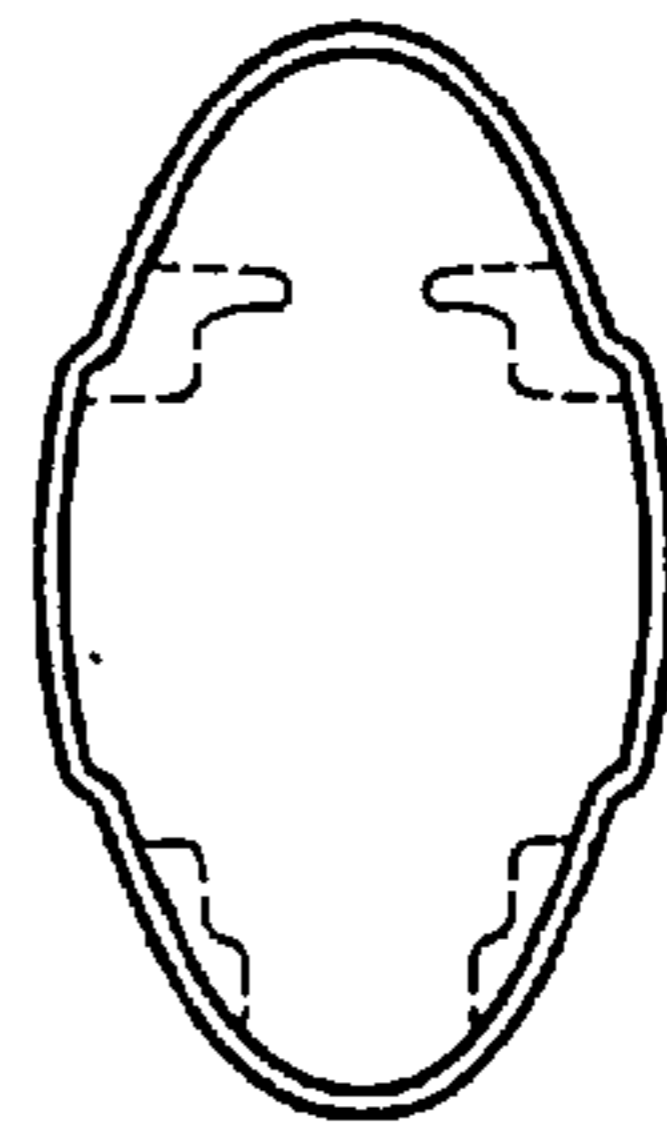

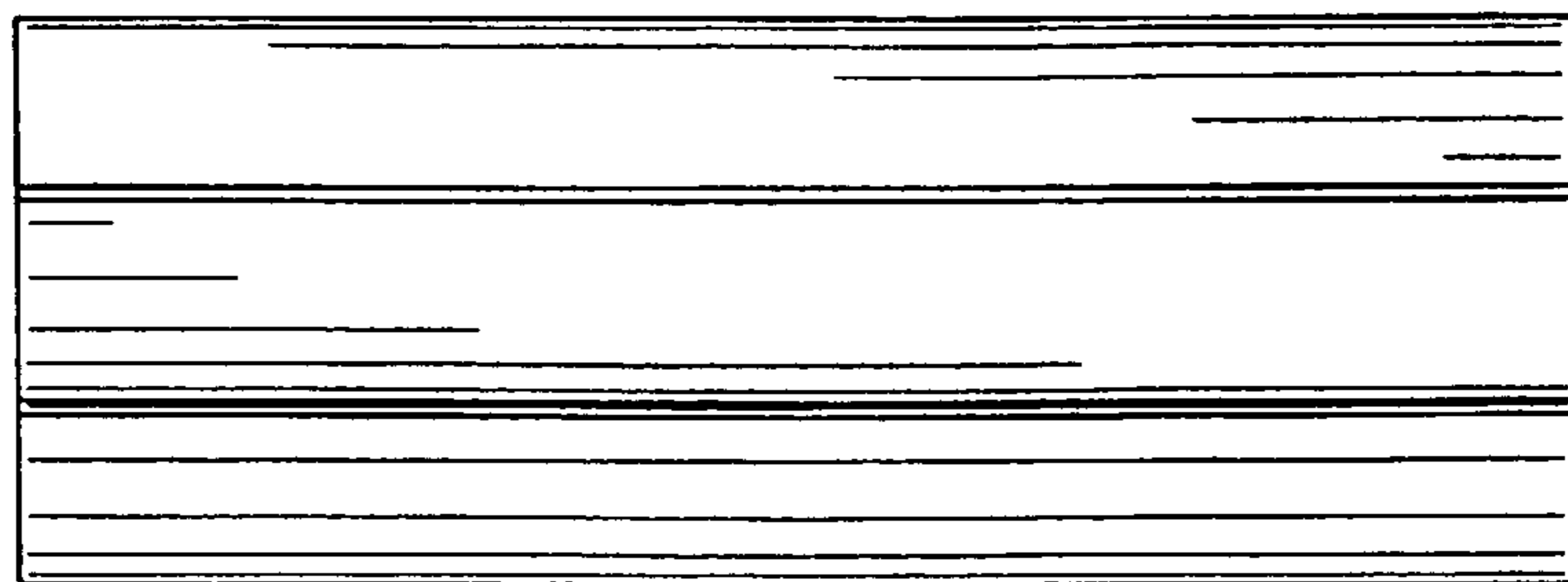

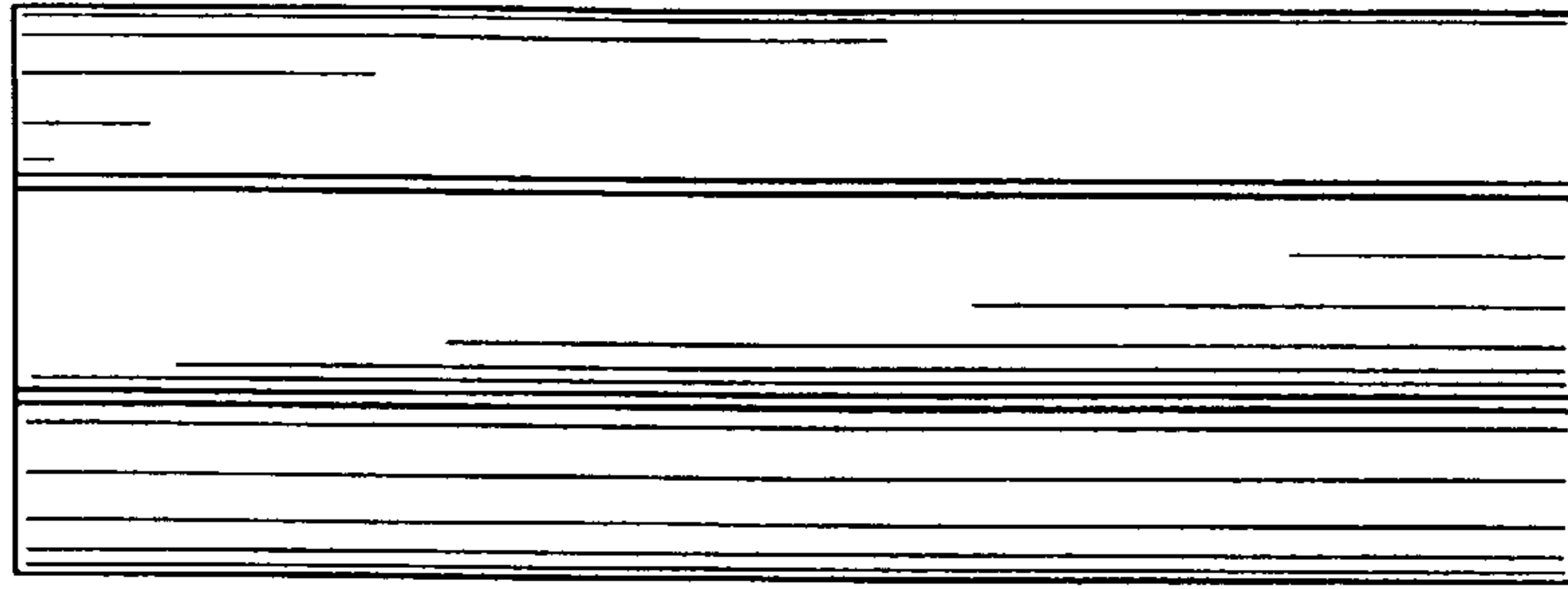

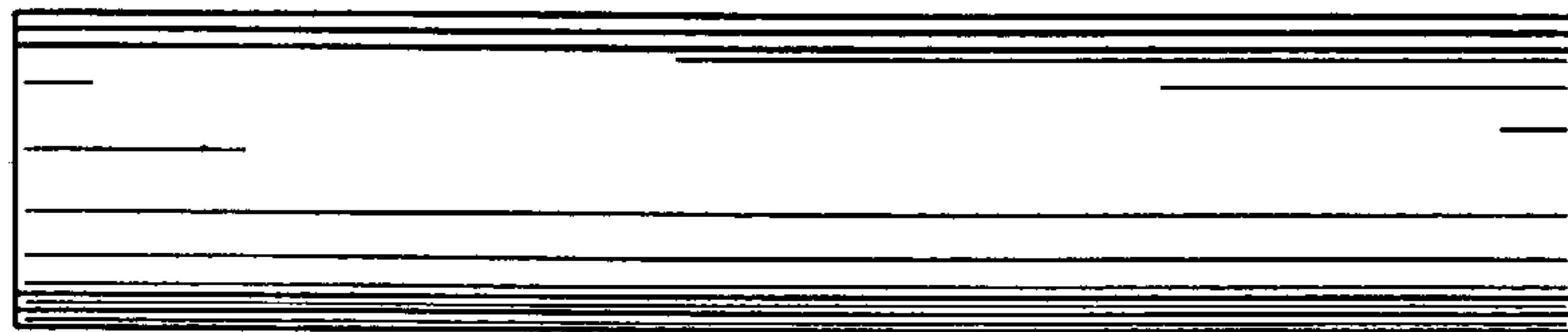

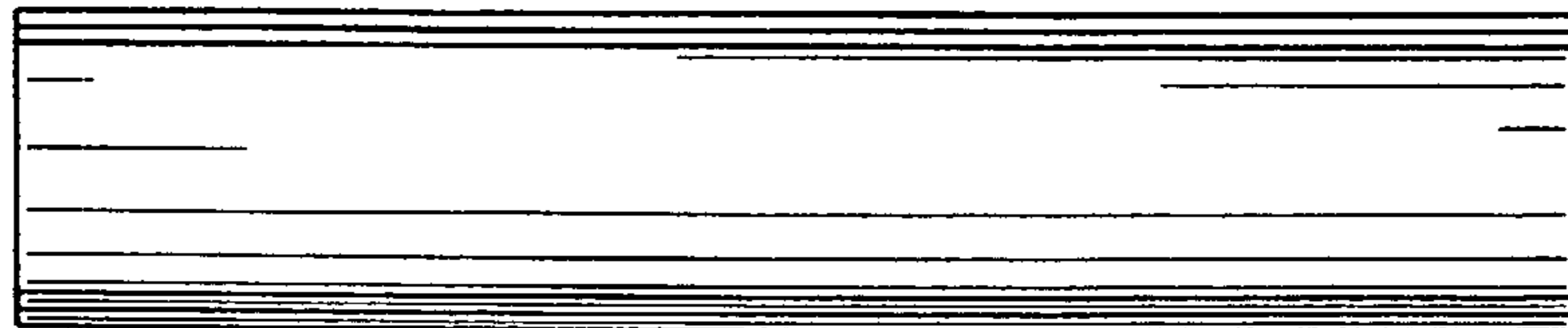

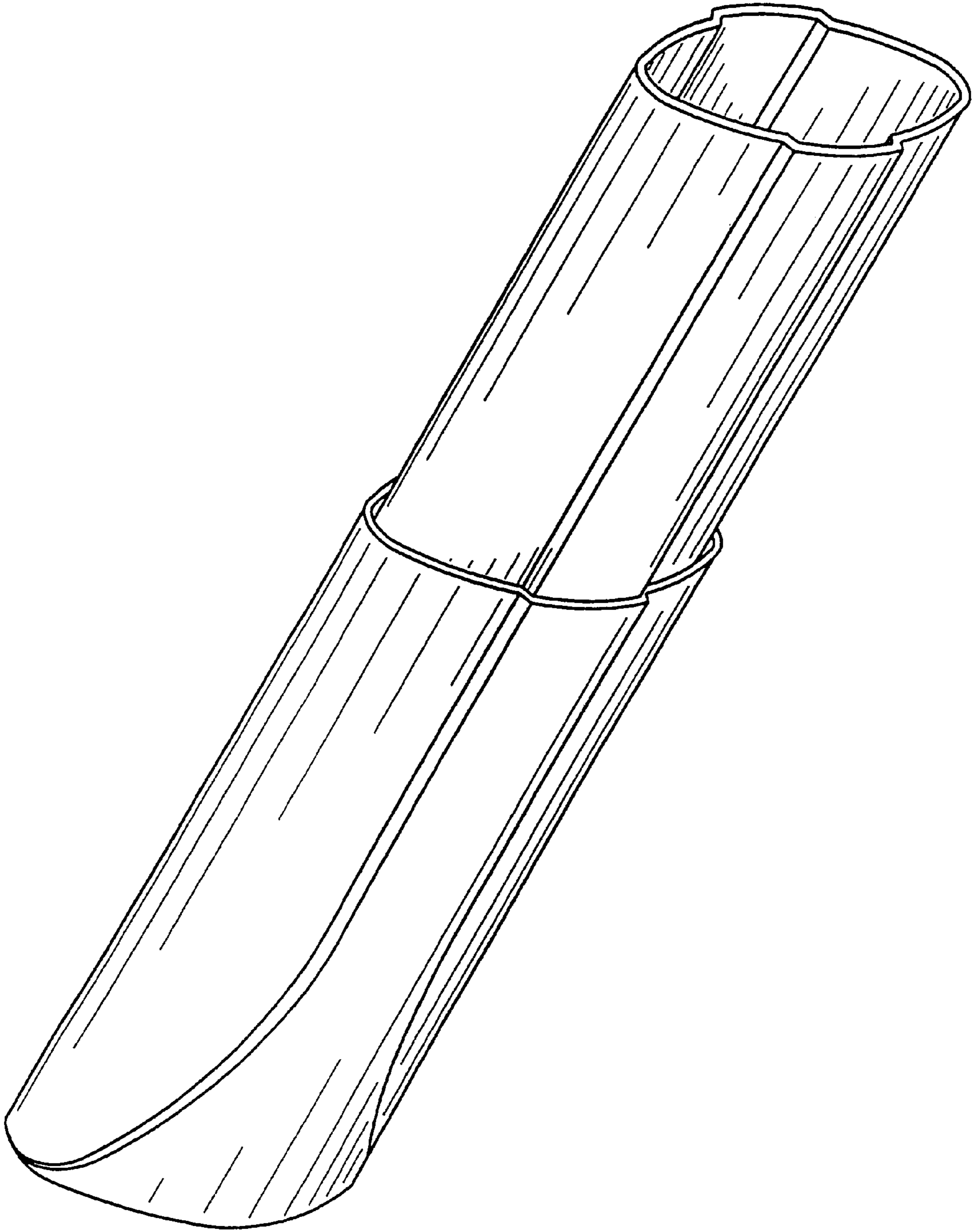
