CLAIM

The ornamental design for a modular planter, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the modular planter, showing my design;

FIG. 2 is a front elevational view;

FIG. 3 is a rear elevational view;

FIG. 4 is a side elevational view when viewed from the left side;

FIG. 5 is a side elevational view when viewed from the right side;

FIG. 6 is a top plan view;

FIG. 7 is a bottom plan view;

FIG. 8 is a perspective view of an alternative embodiment of the modular planter;

FIG. 9 is a front elevational view of an alterative embodiment of the modular planter;

FIG. 10 is a rear elevational view of an alterative embodiment of the modular planter;

FIG. 11 is a side elevational view of an alterative embodiment of the modular planter when viewed from the left side;

FIG. 12 is a side elevational view of an alterative embodiment of the modular planter when viewed from the right side;





Fig. 13***Fig. 14***

FIG. 13 is a top plan view of an alterative embodiment of the modular planter; and,

FIG. 14 is a bottom plan view of an alterative embodiment of the modular planter.

























