## DESCRIPTION

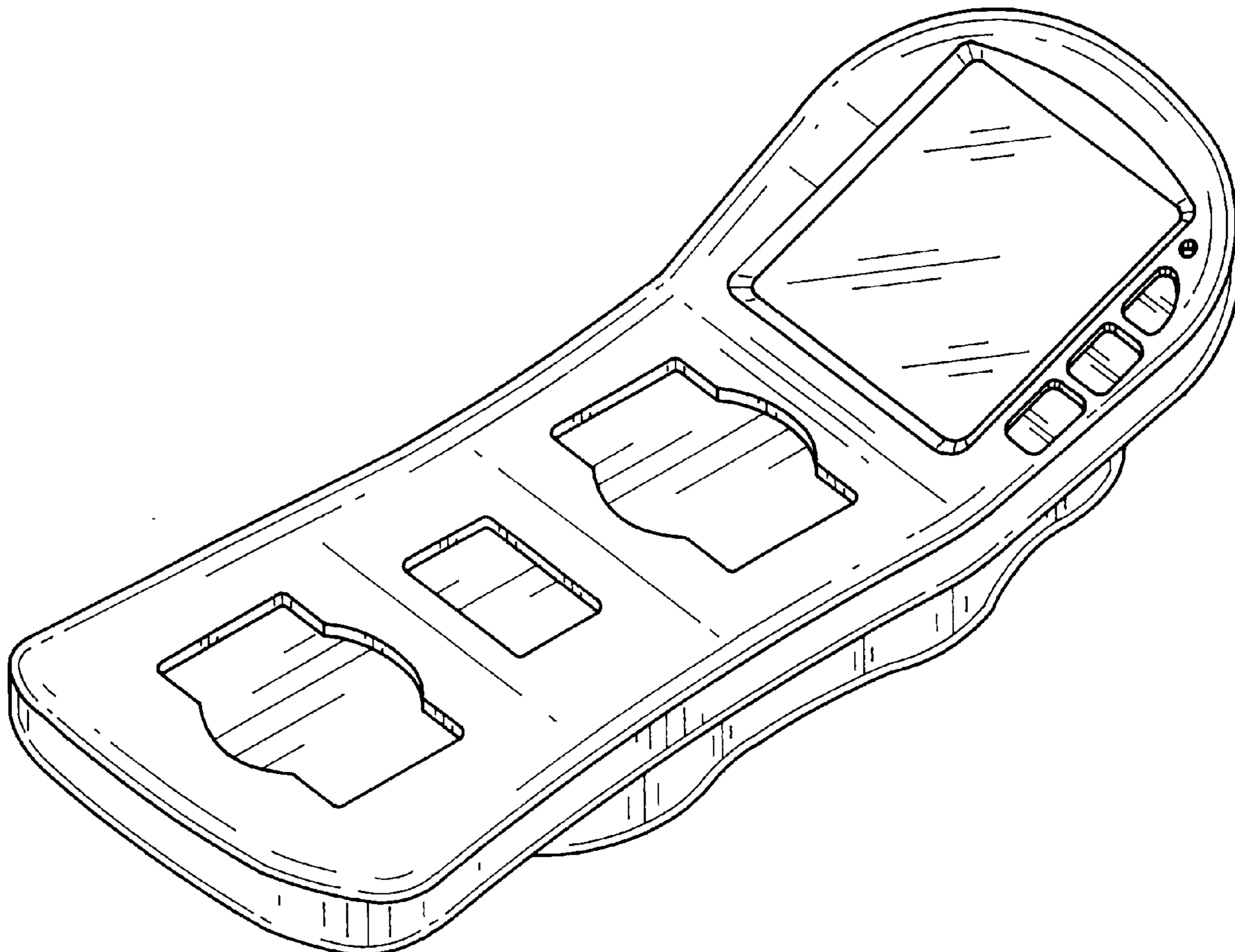

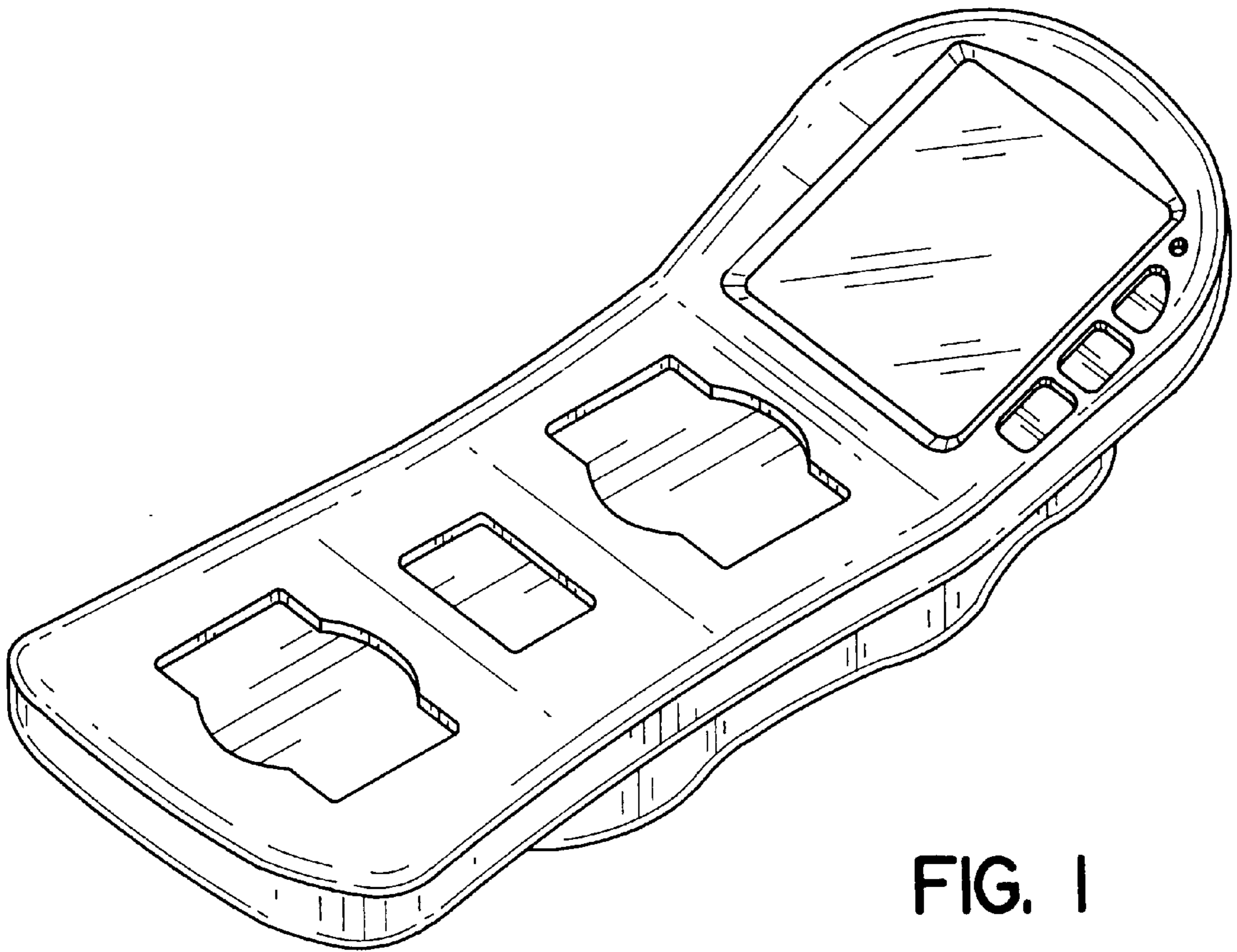

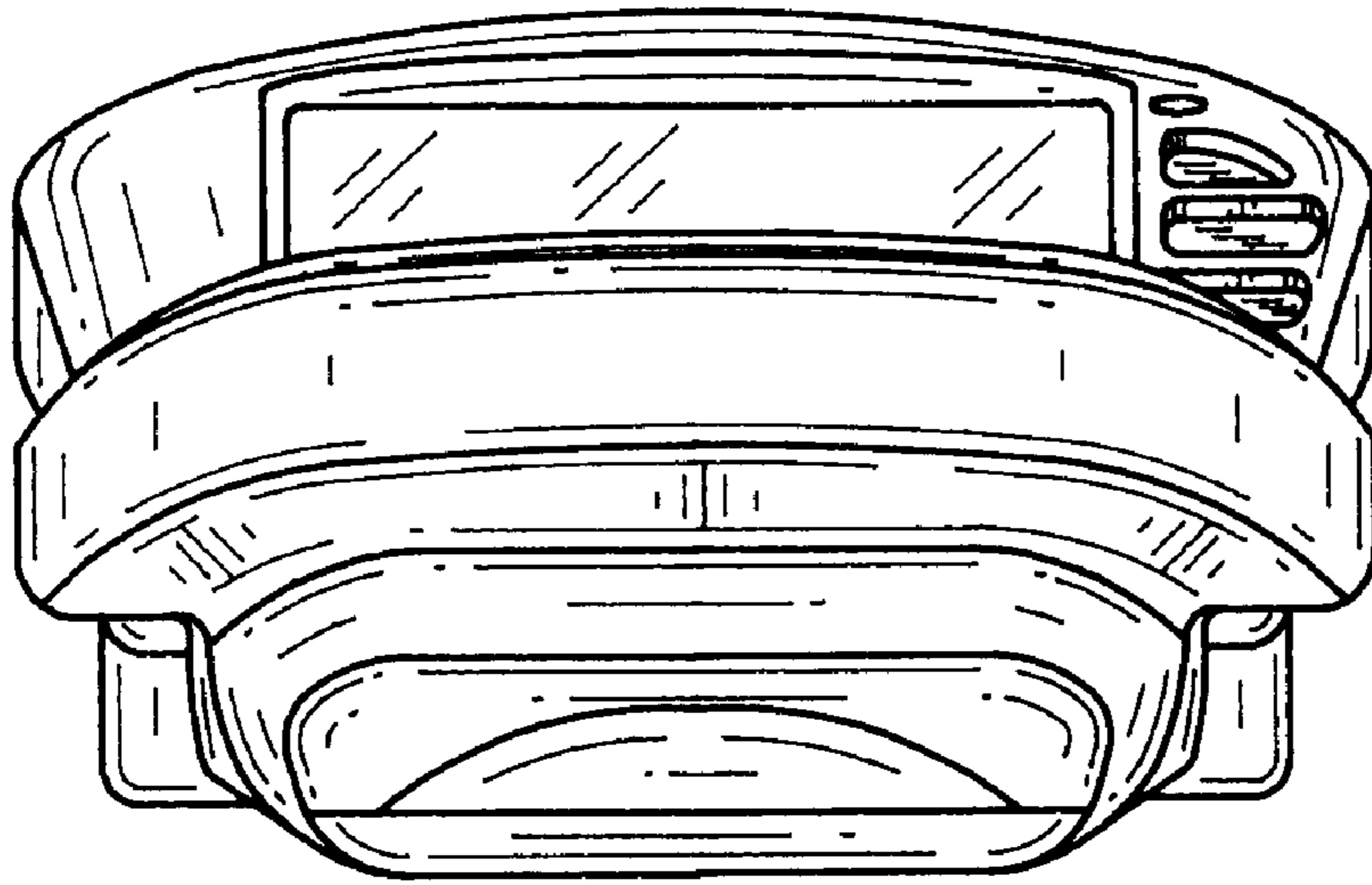

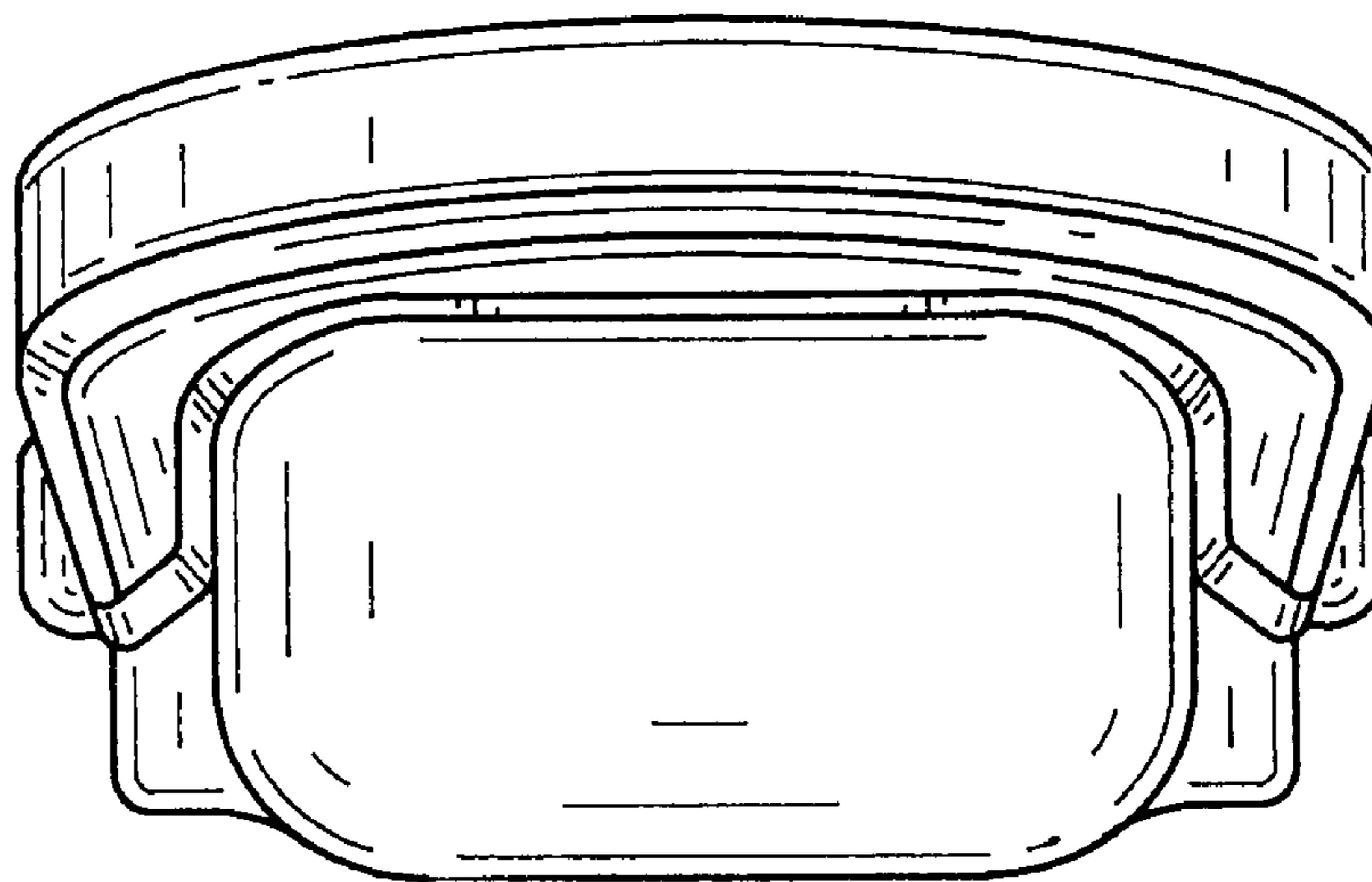

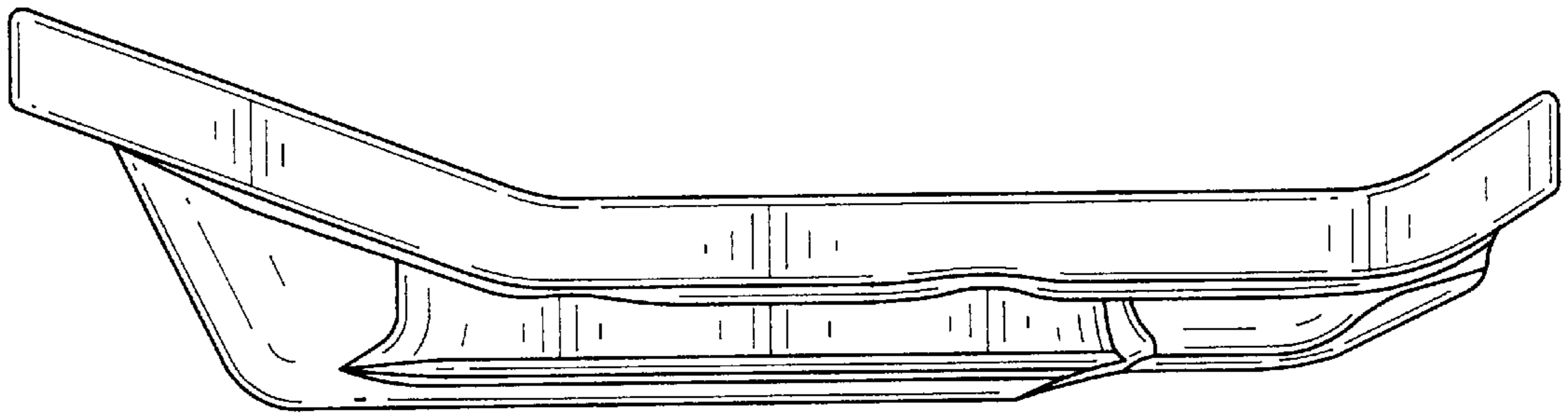

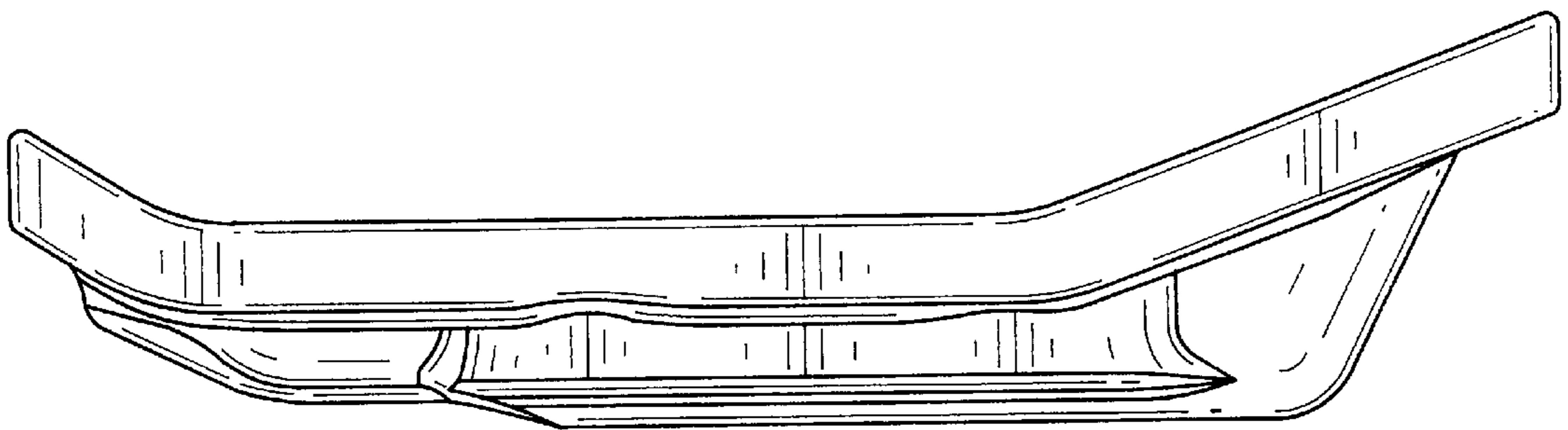

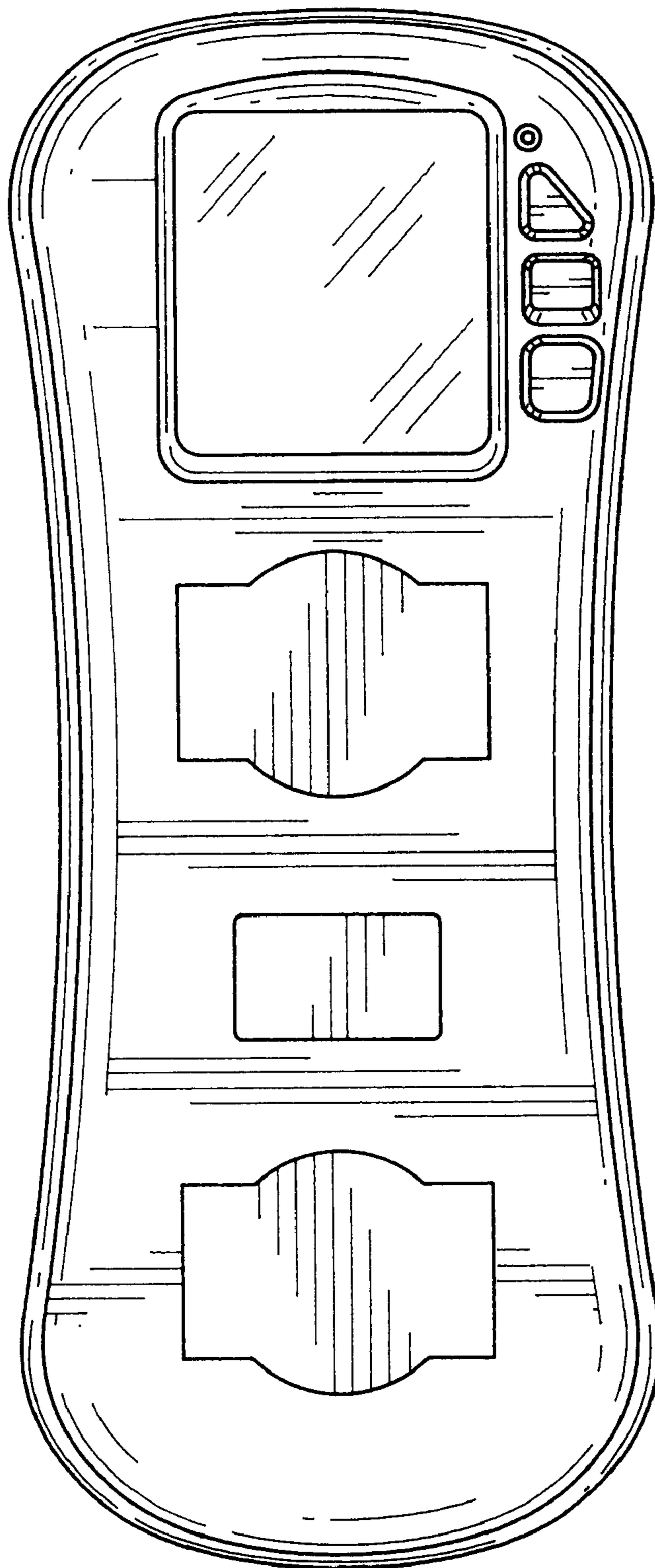

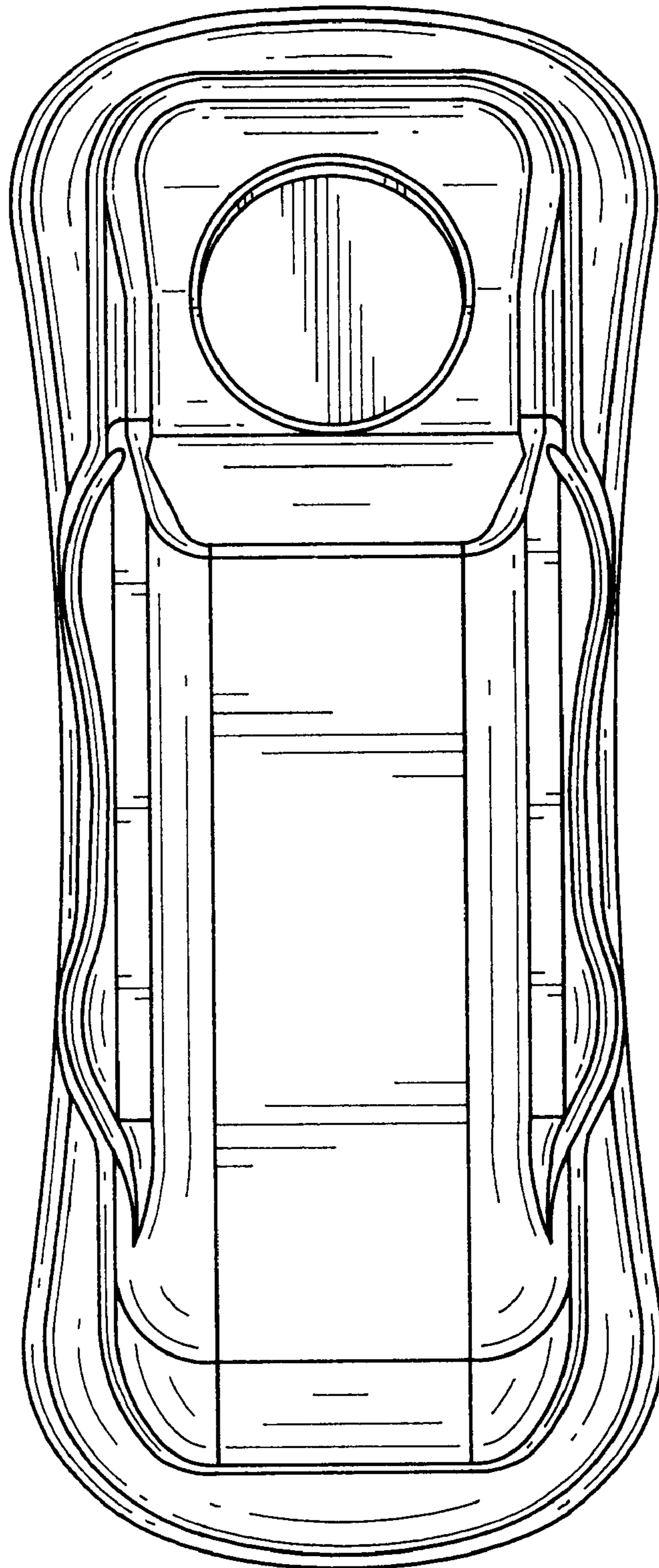
