### [57] CLAIM

The ornamental design for a faucet body, as shown and described.

### DESCRIPTION

FIG. 1 is a front perspective view of the faucet body showing my new design;  
FIG. 2 is a rear perspective view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a front elevational view thereof;  
FIG. 5 is a left side elevational view thereof, the right side being a mirror image of the left side;  
FIG. 6 is a rear elevational view thereof; and,  
FIG. 7 is a bottom plan view thereof.  
The broken line showing of the handle in FIG. 2 is for purposes of illustration only and forms no part of the claimed design.

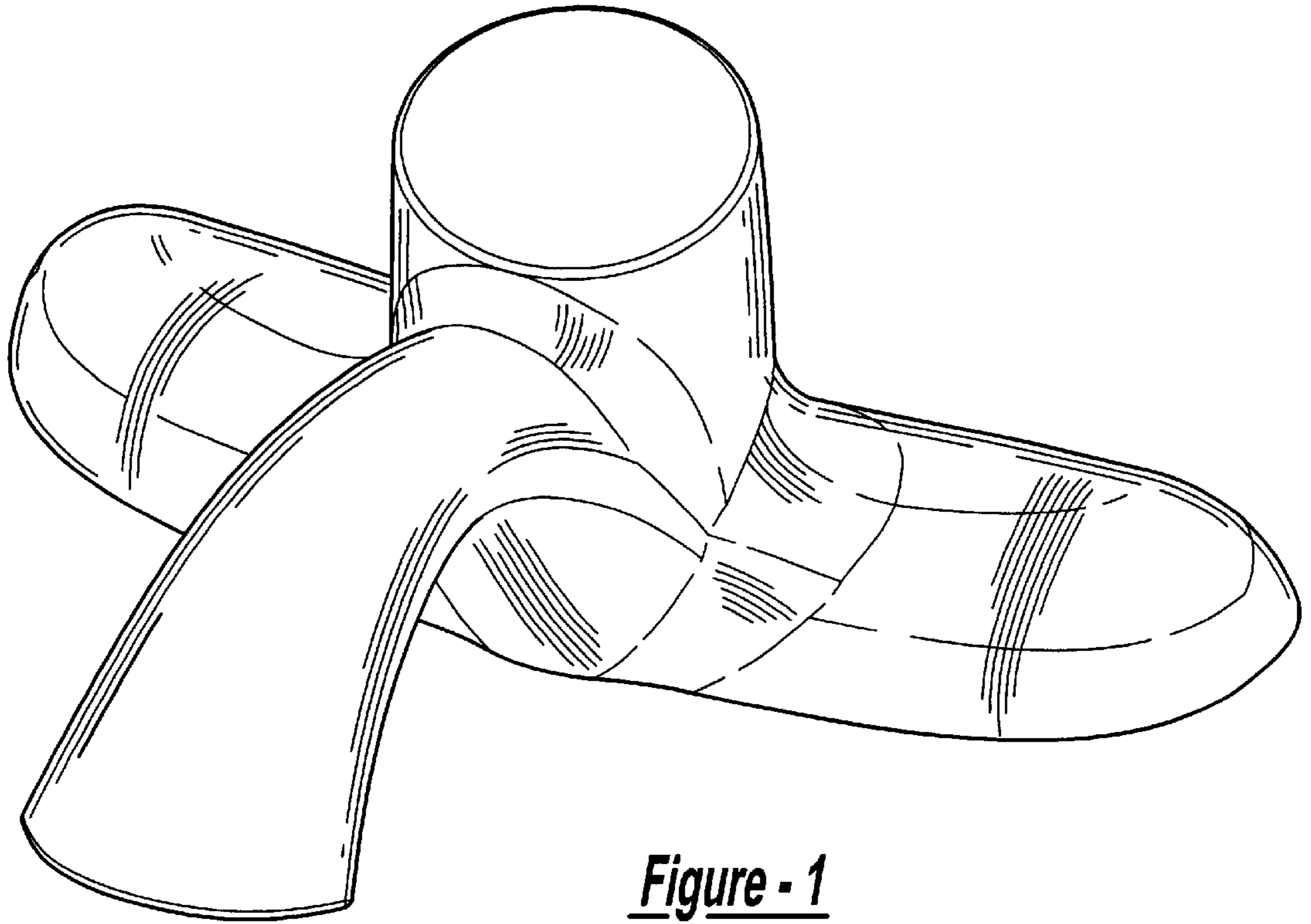

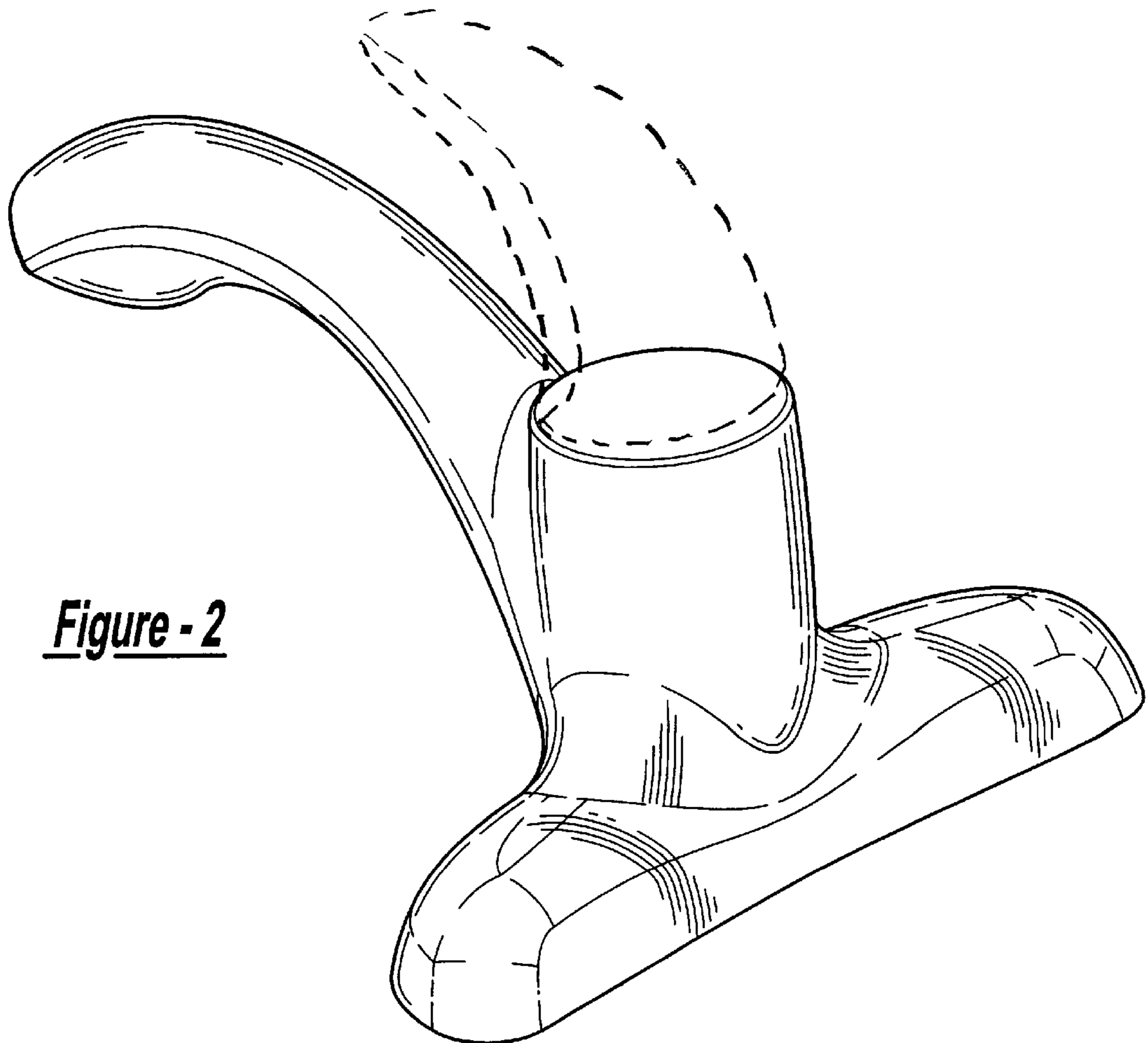

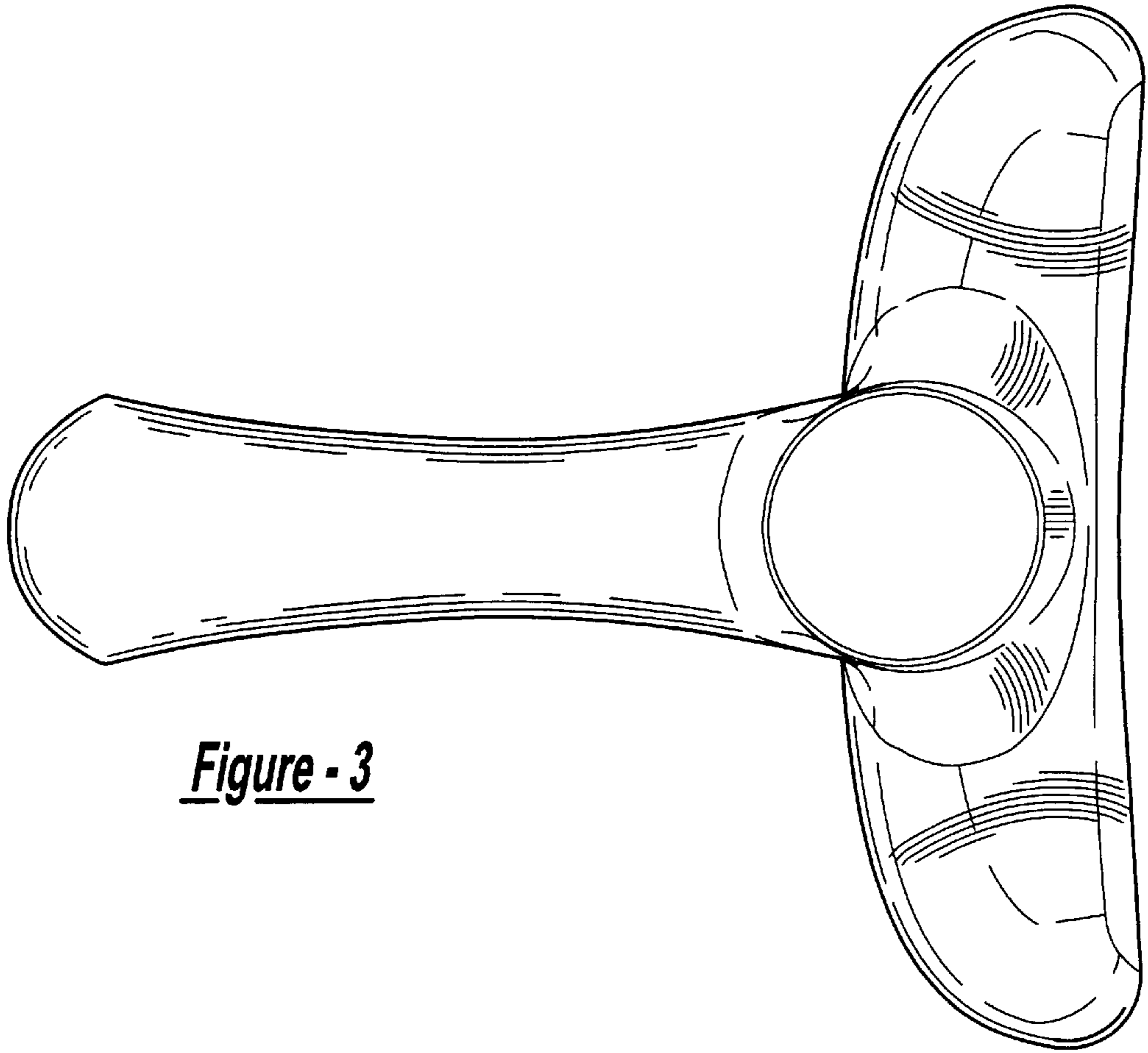

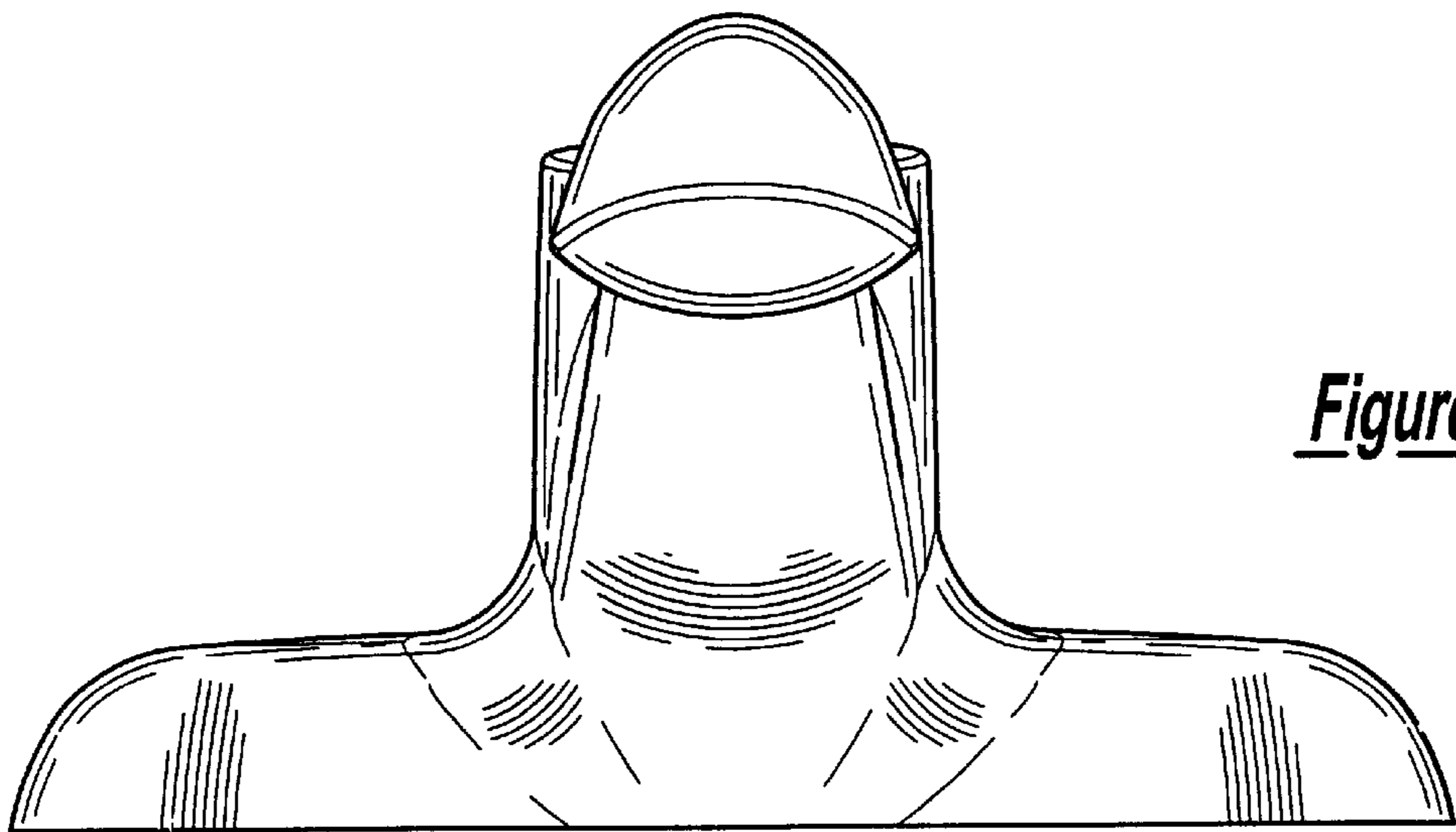

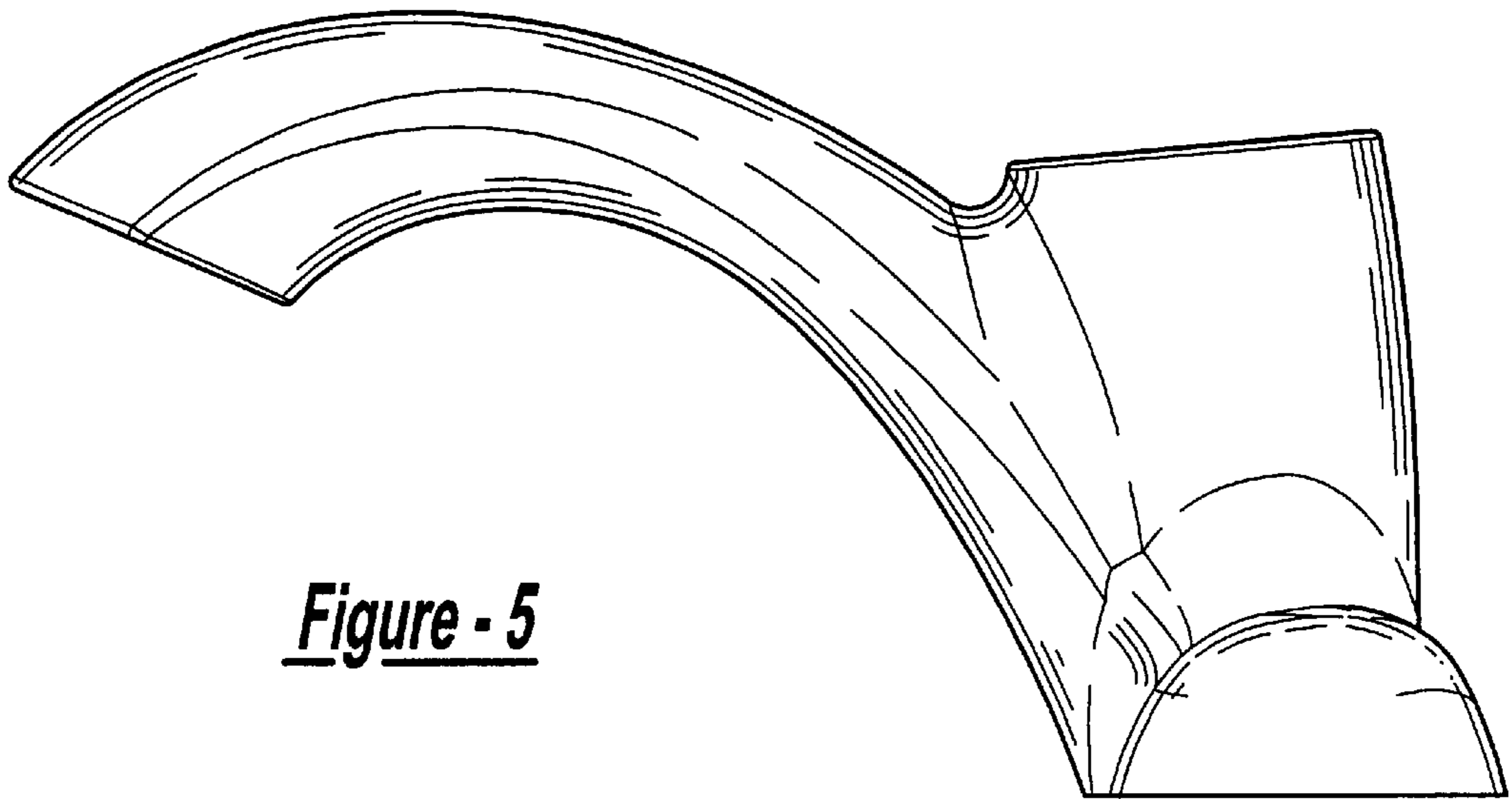

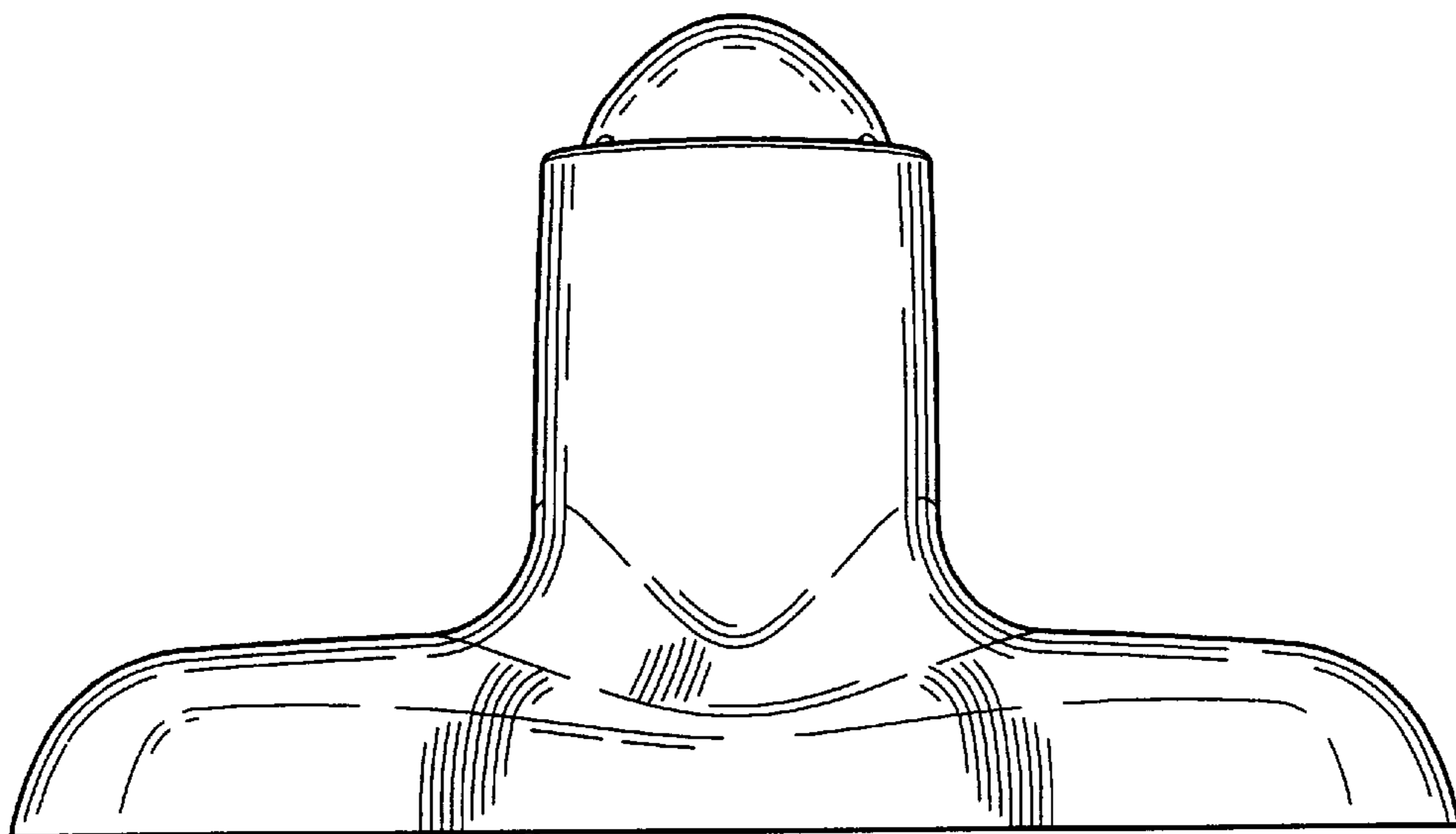

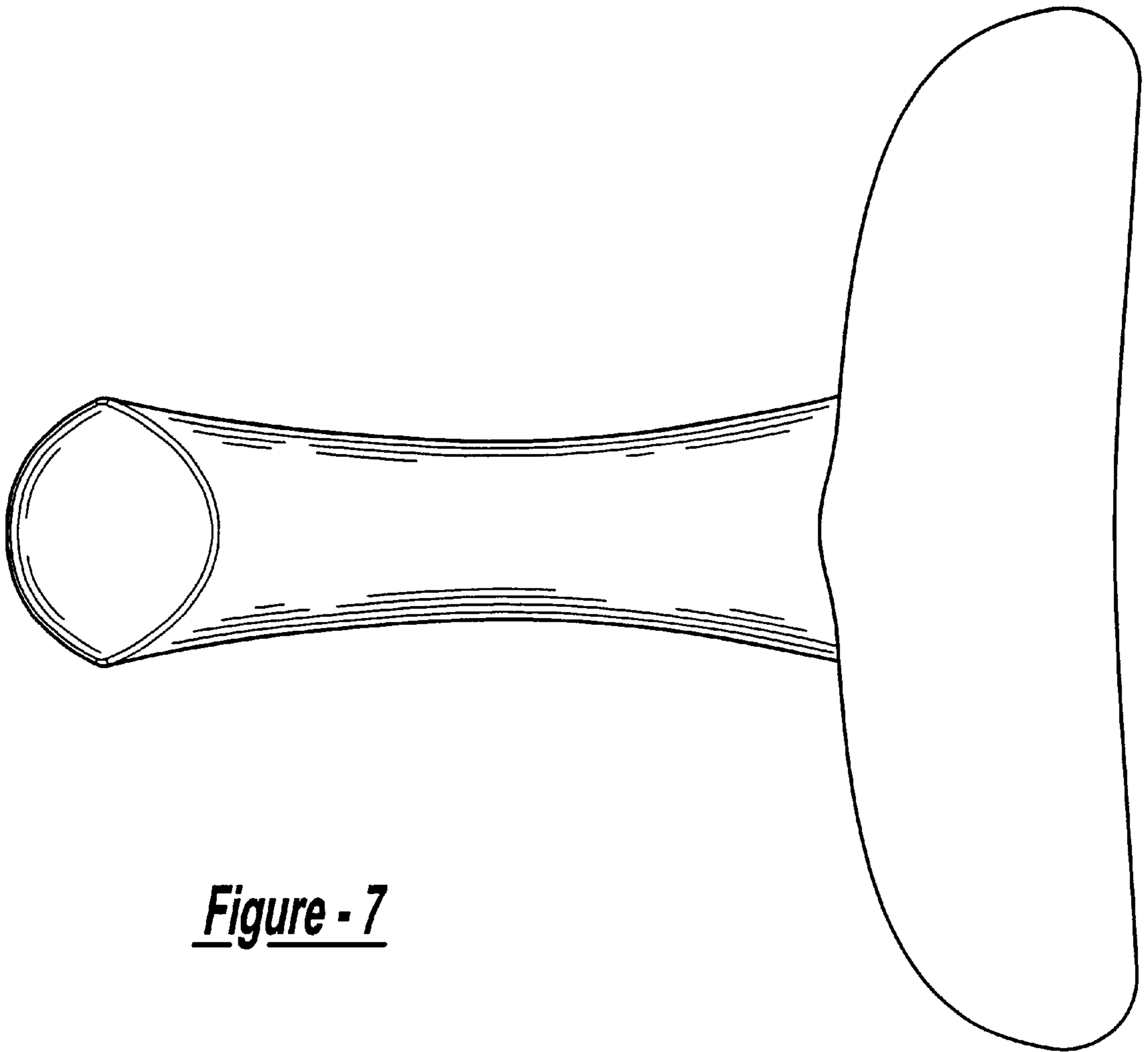
