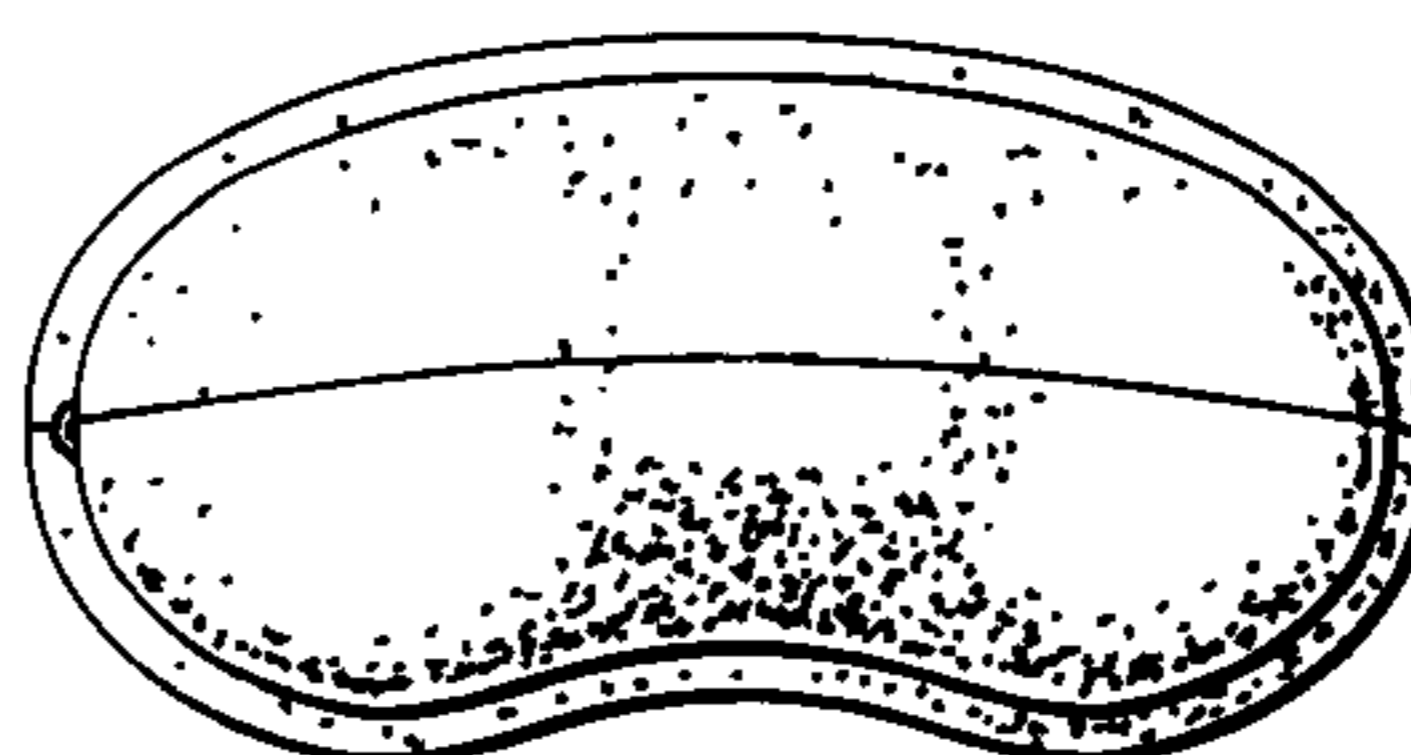
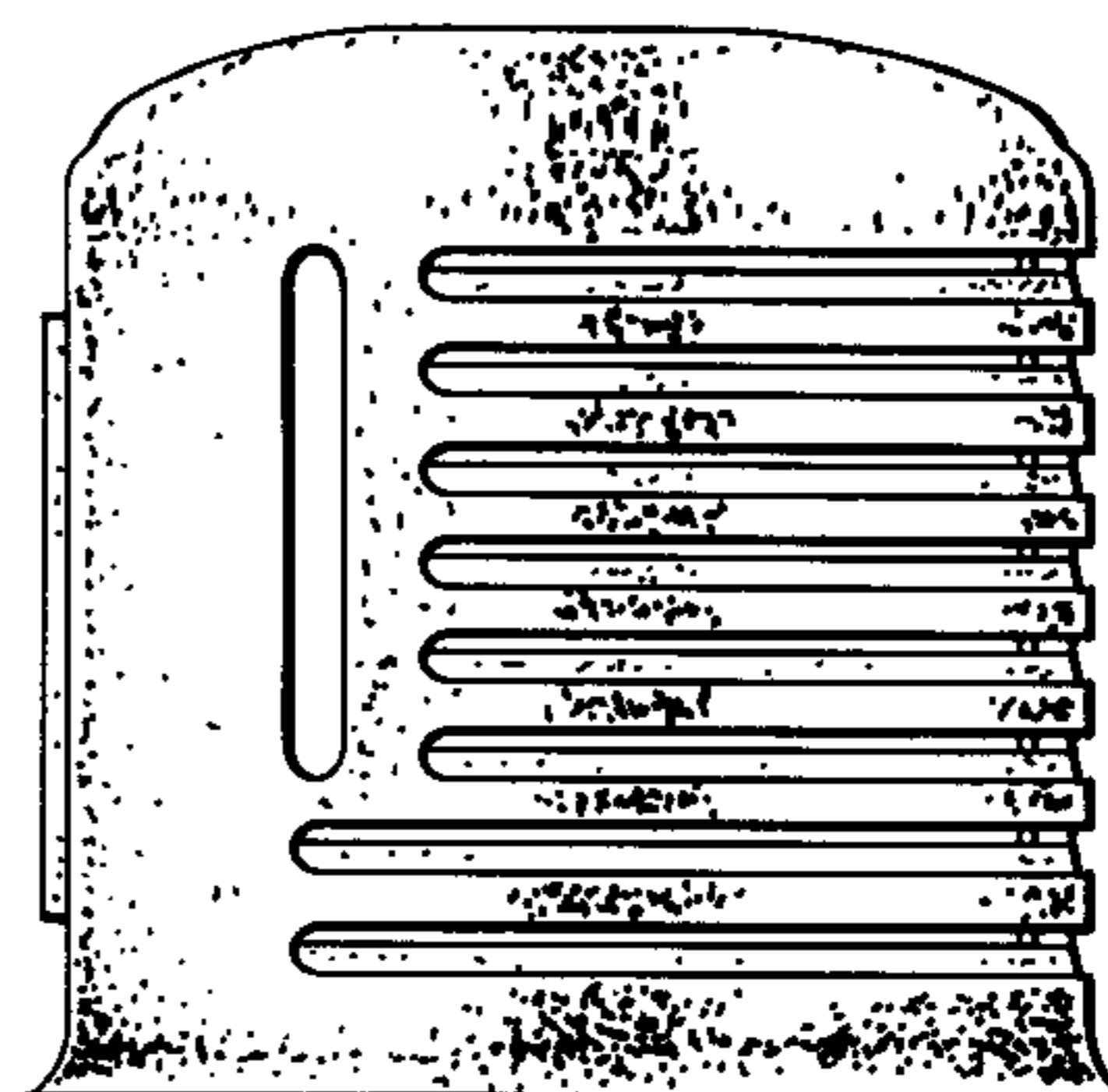
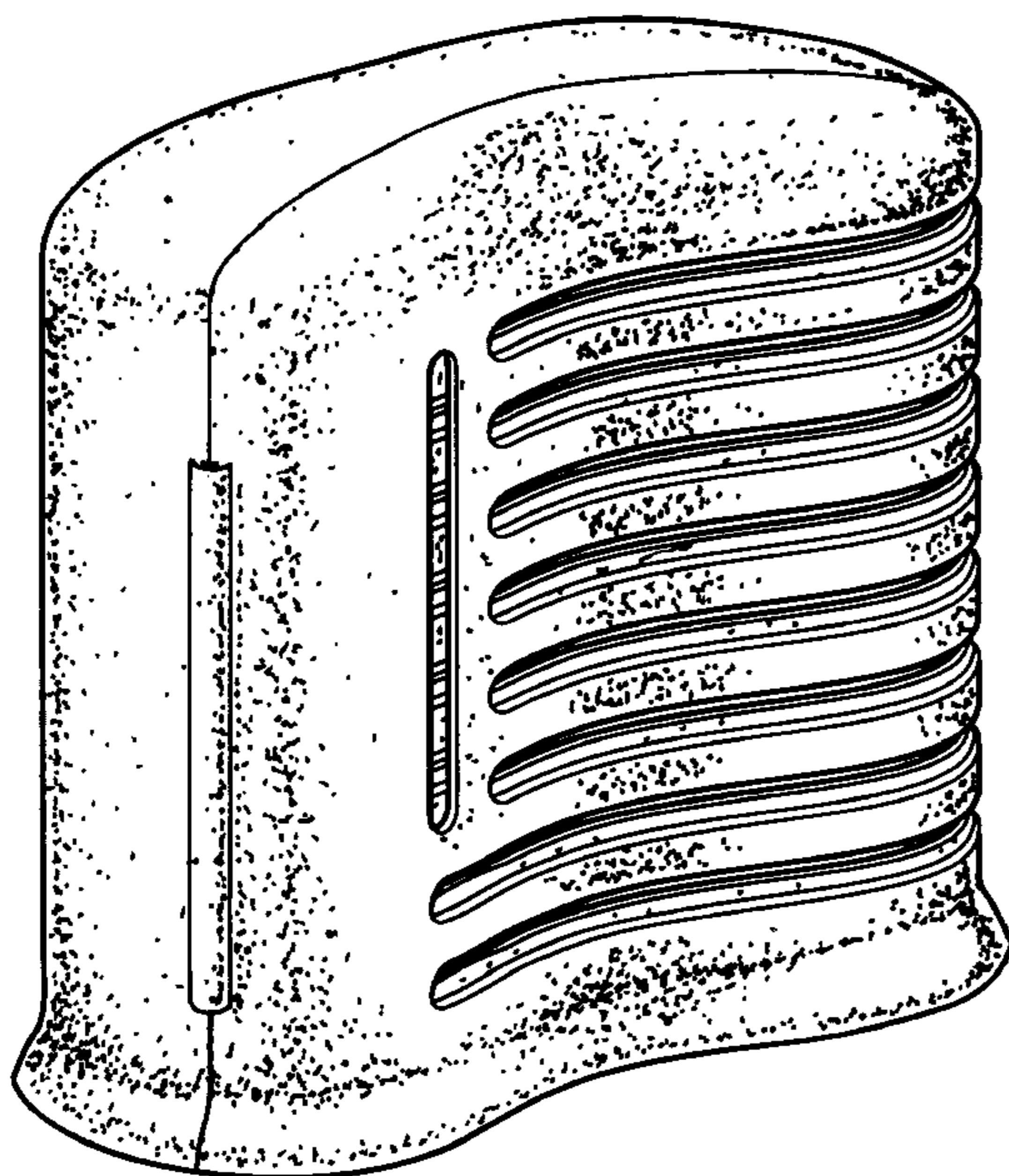
[57] CLAIM

DESCRIPTION

FIG. 1 is a perspective view of an air freshener showing our new design;
 FIG. 2 is a front view of the air freshener of FIG. 1;
 FIG. 3 is a rear view of the air freshener of FIG. 1;
 FIG. 4 is a left side elevational view of the air freshener of FIG. 1;
 FIG. 5 is a right side elevational view of the air freshener of FIG. 1;

 FIG. 7 is a bottom plan view of the air freshener of FIG. 1.
 FIG. 8 is a perspective view of a second embodiment of an air freshener;

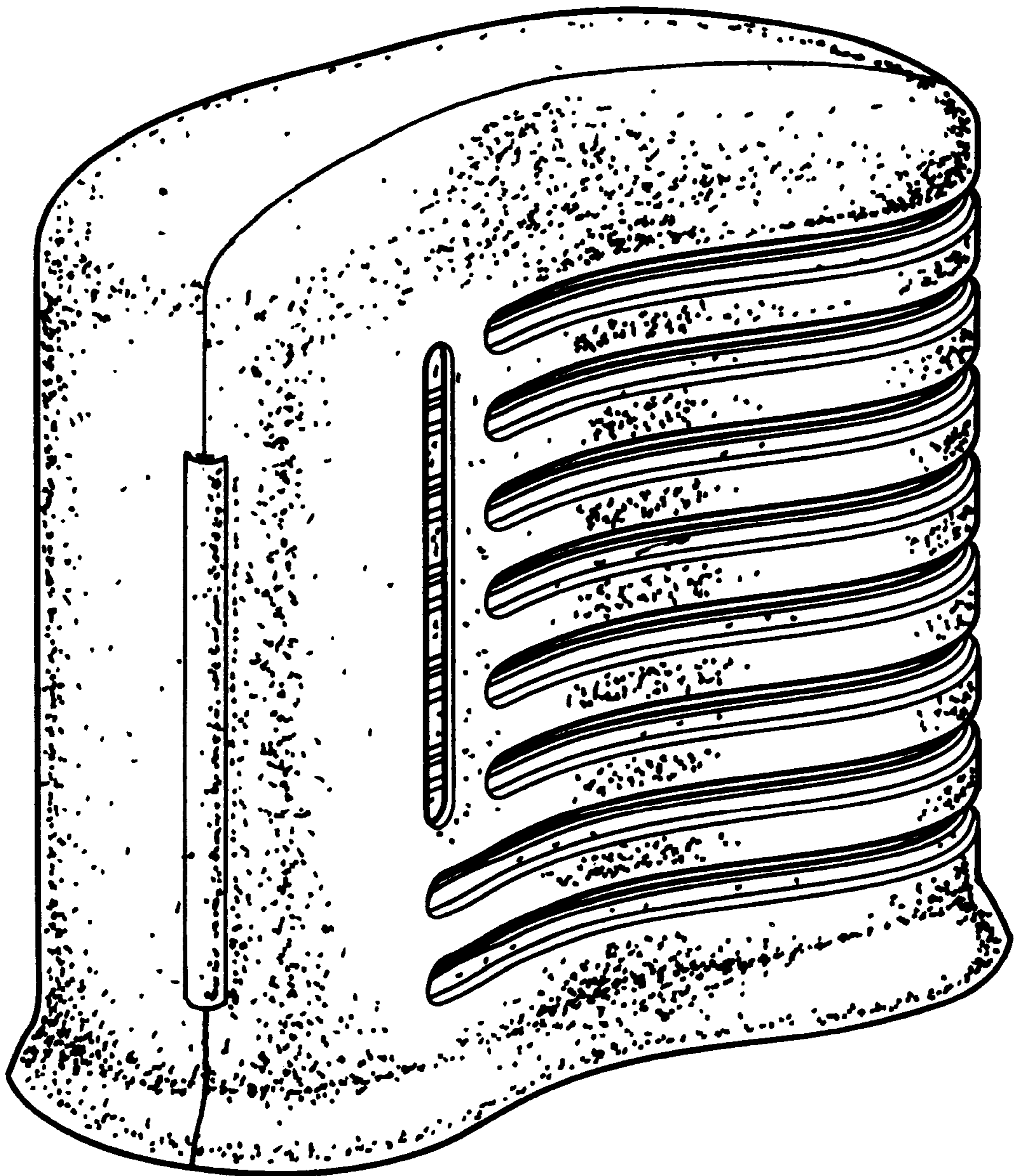

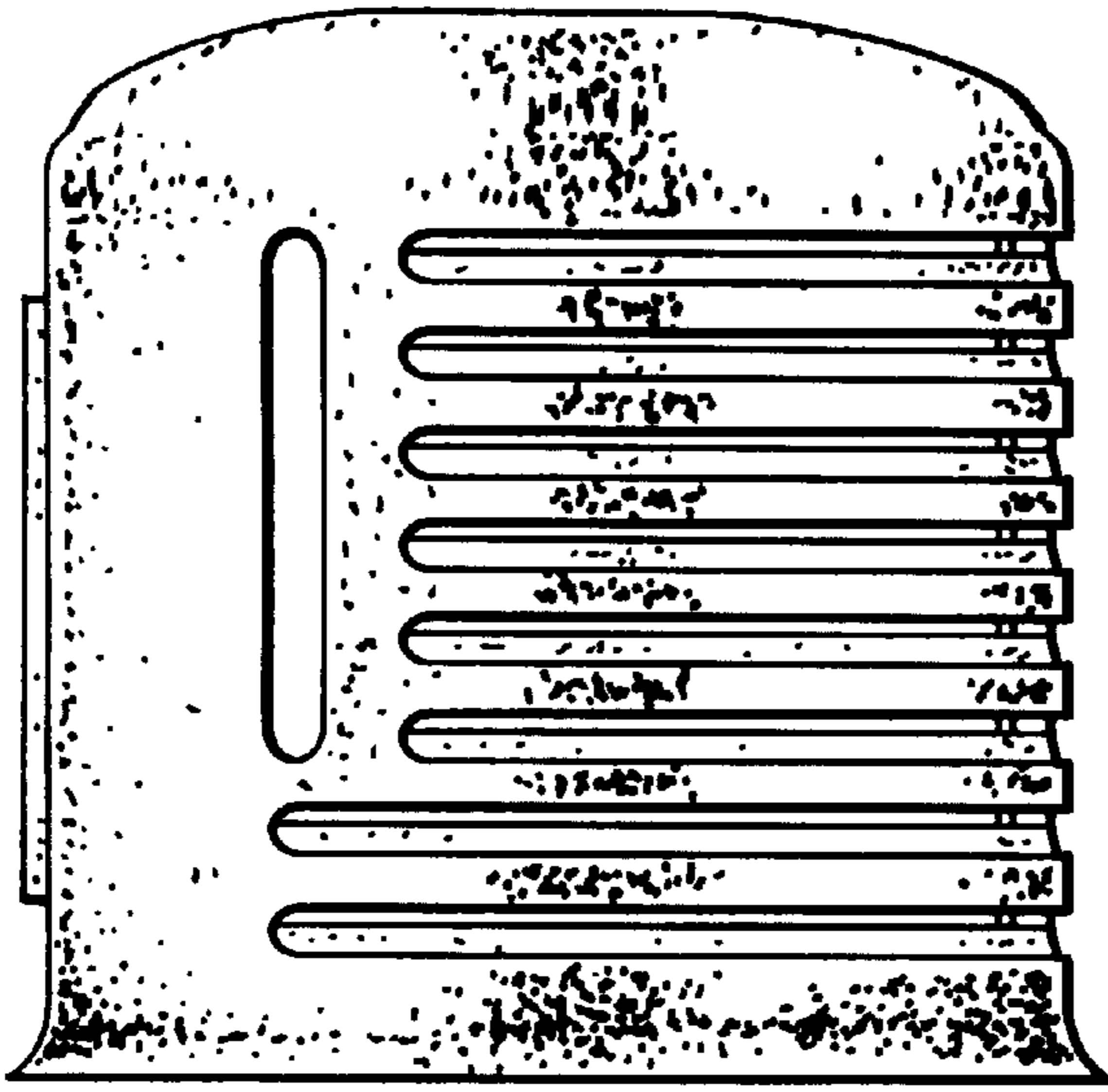

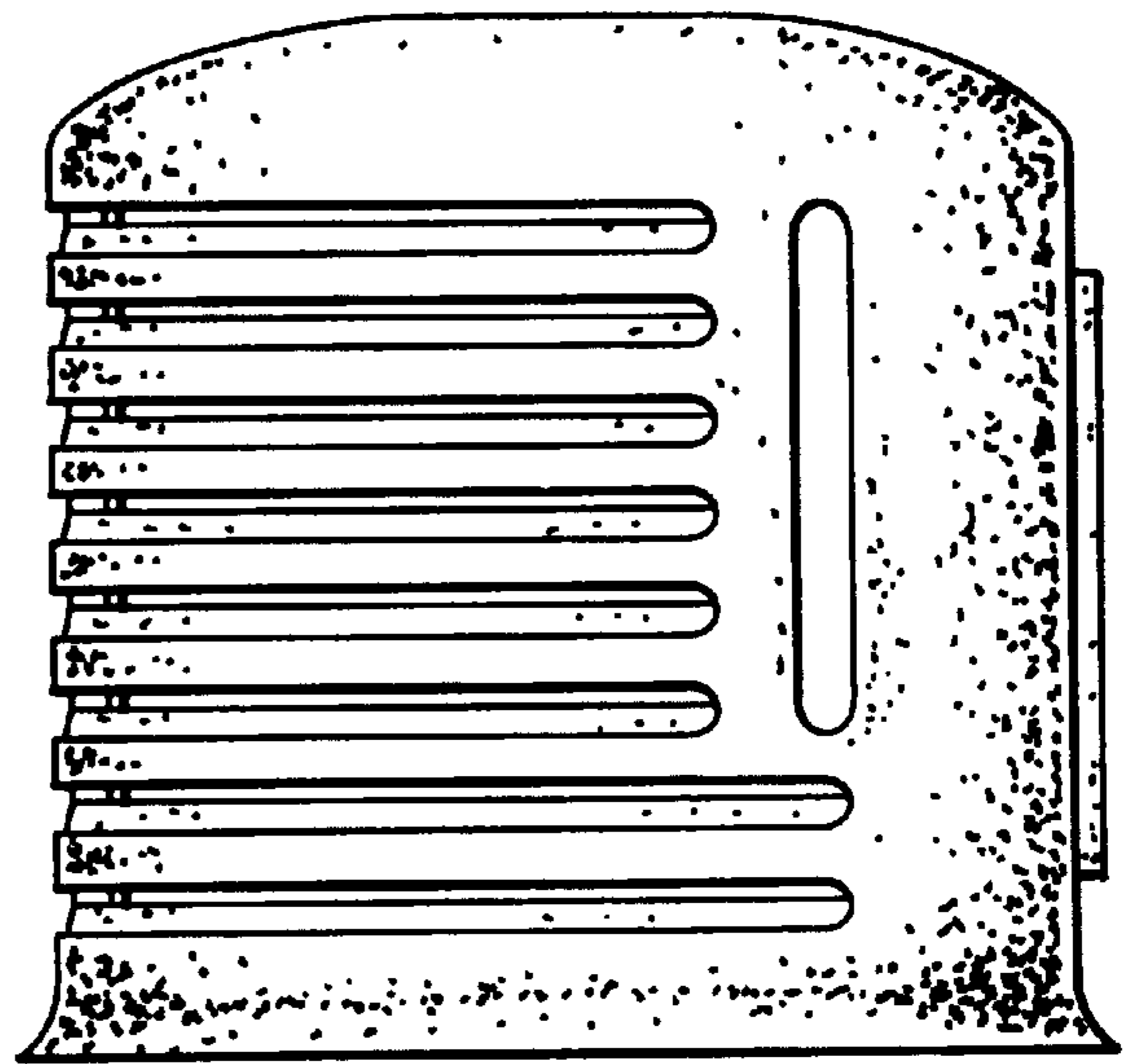

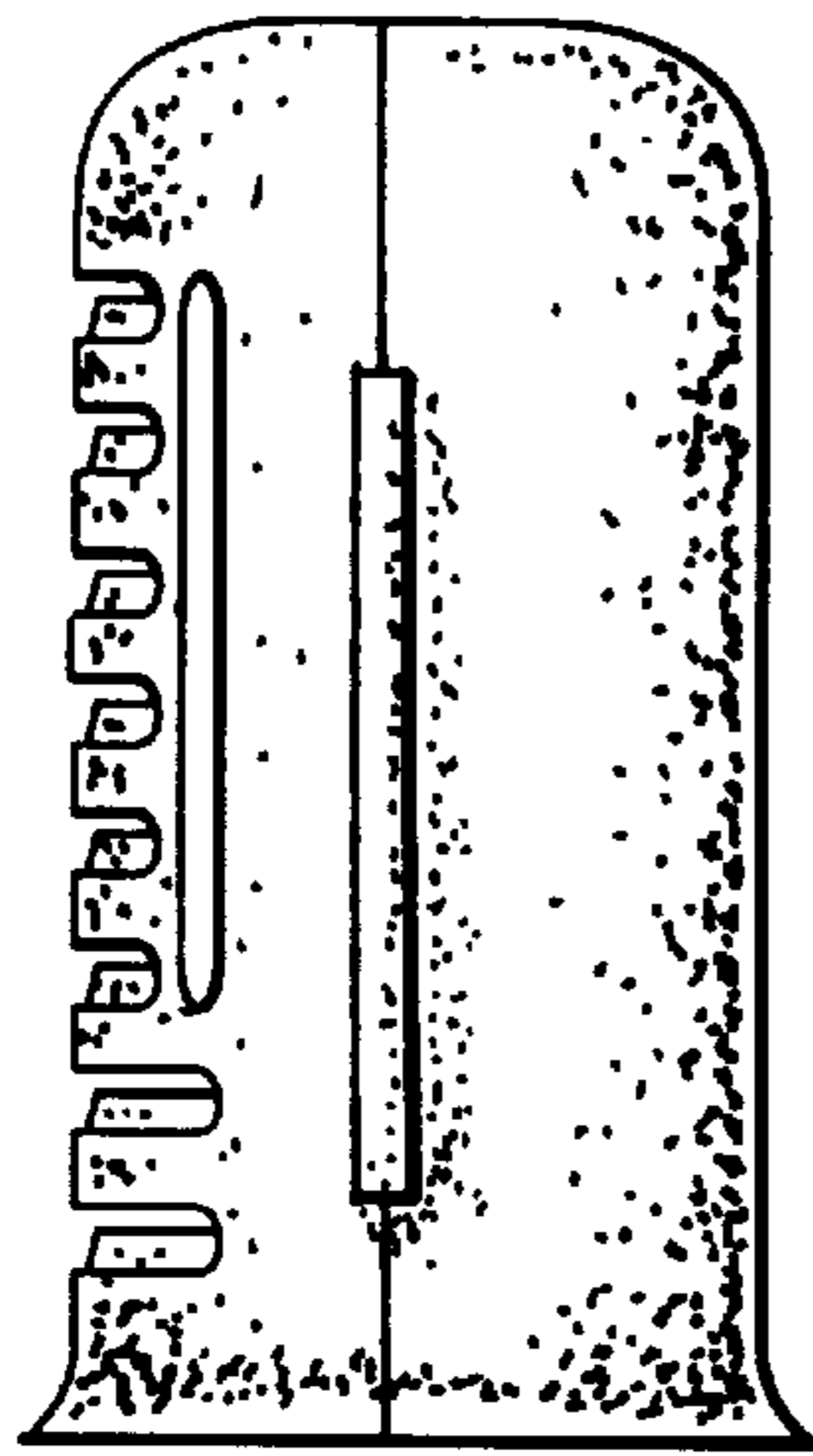

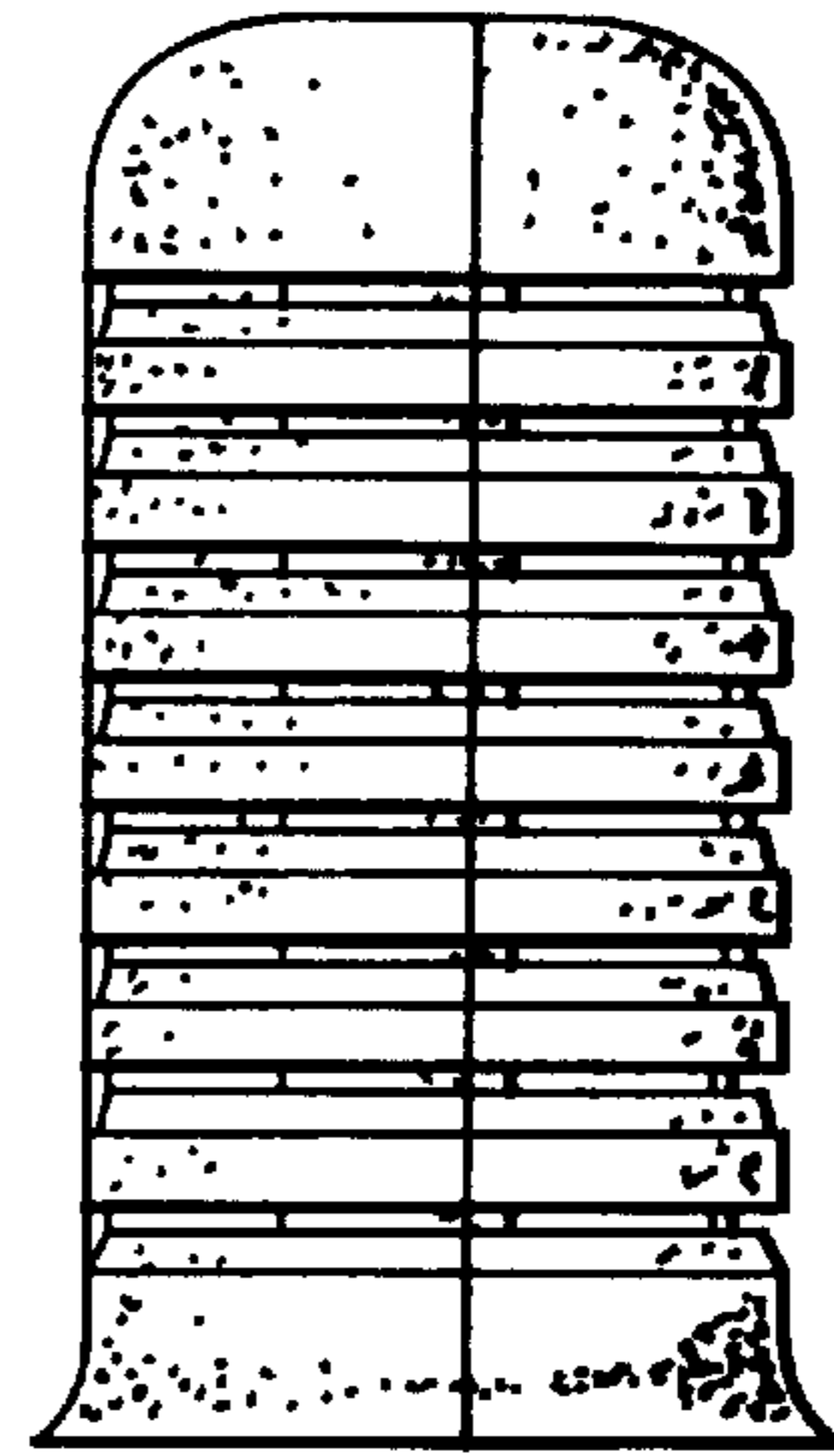

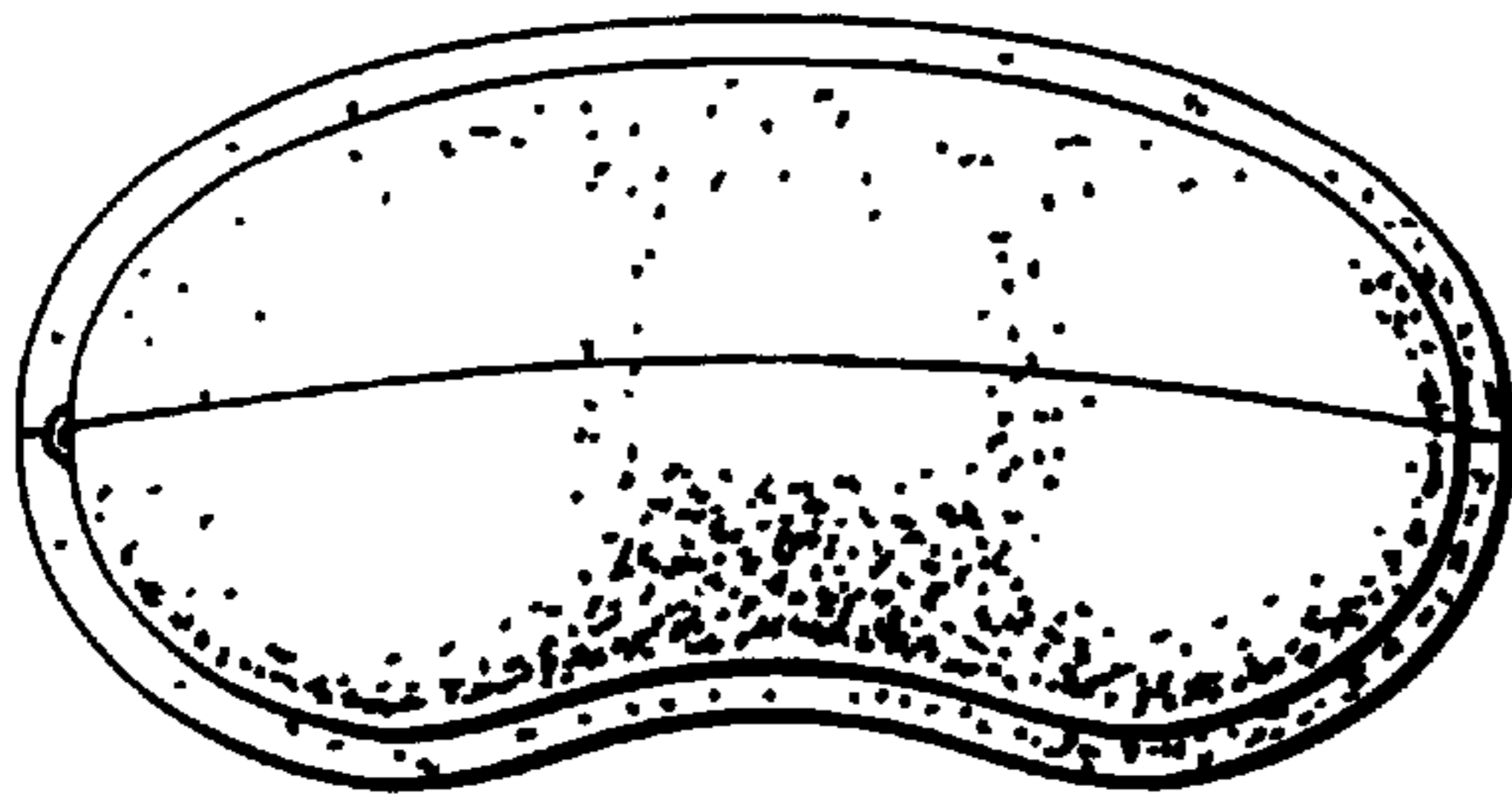

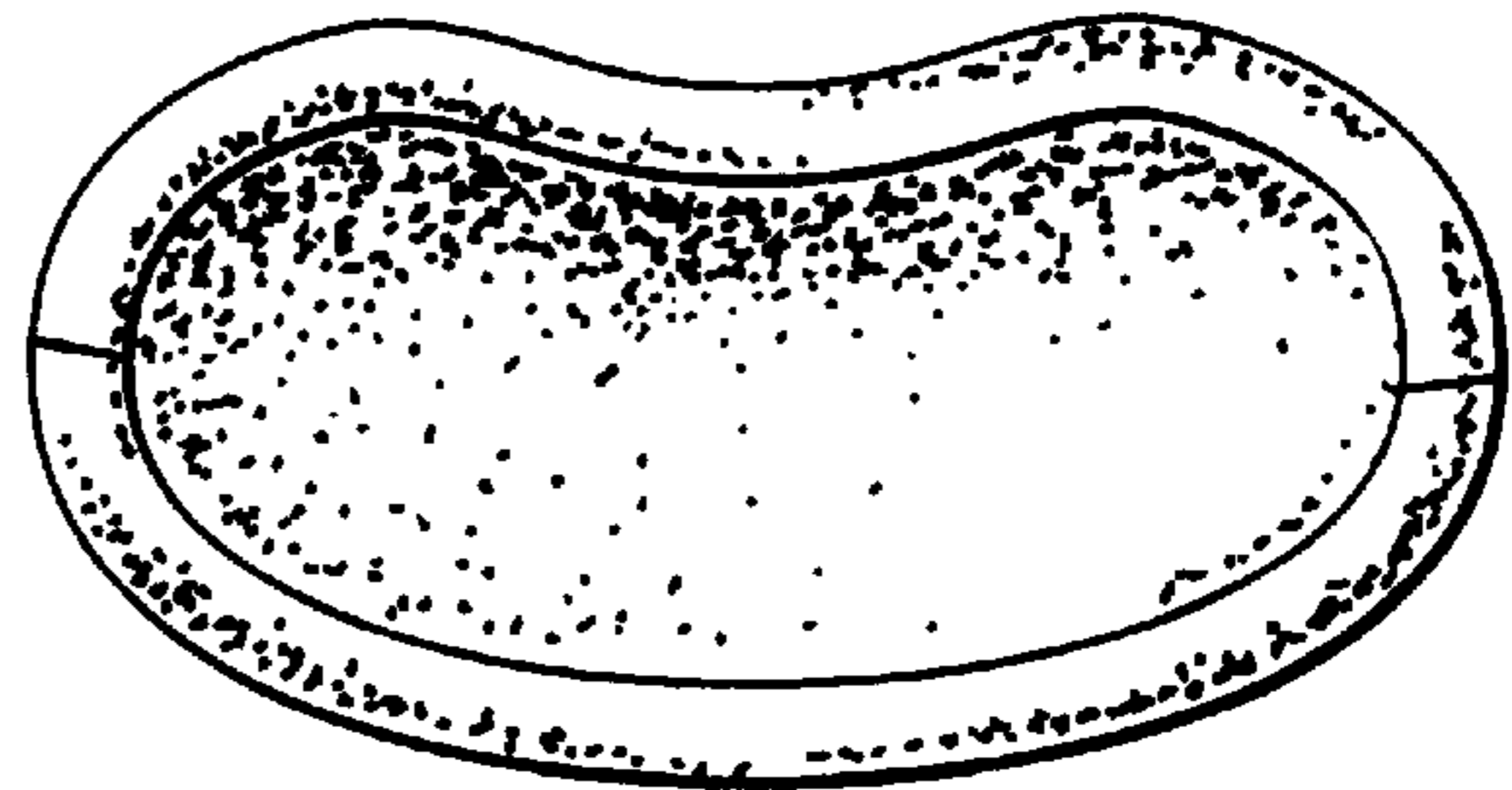

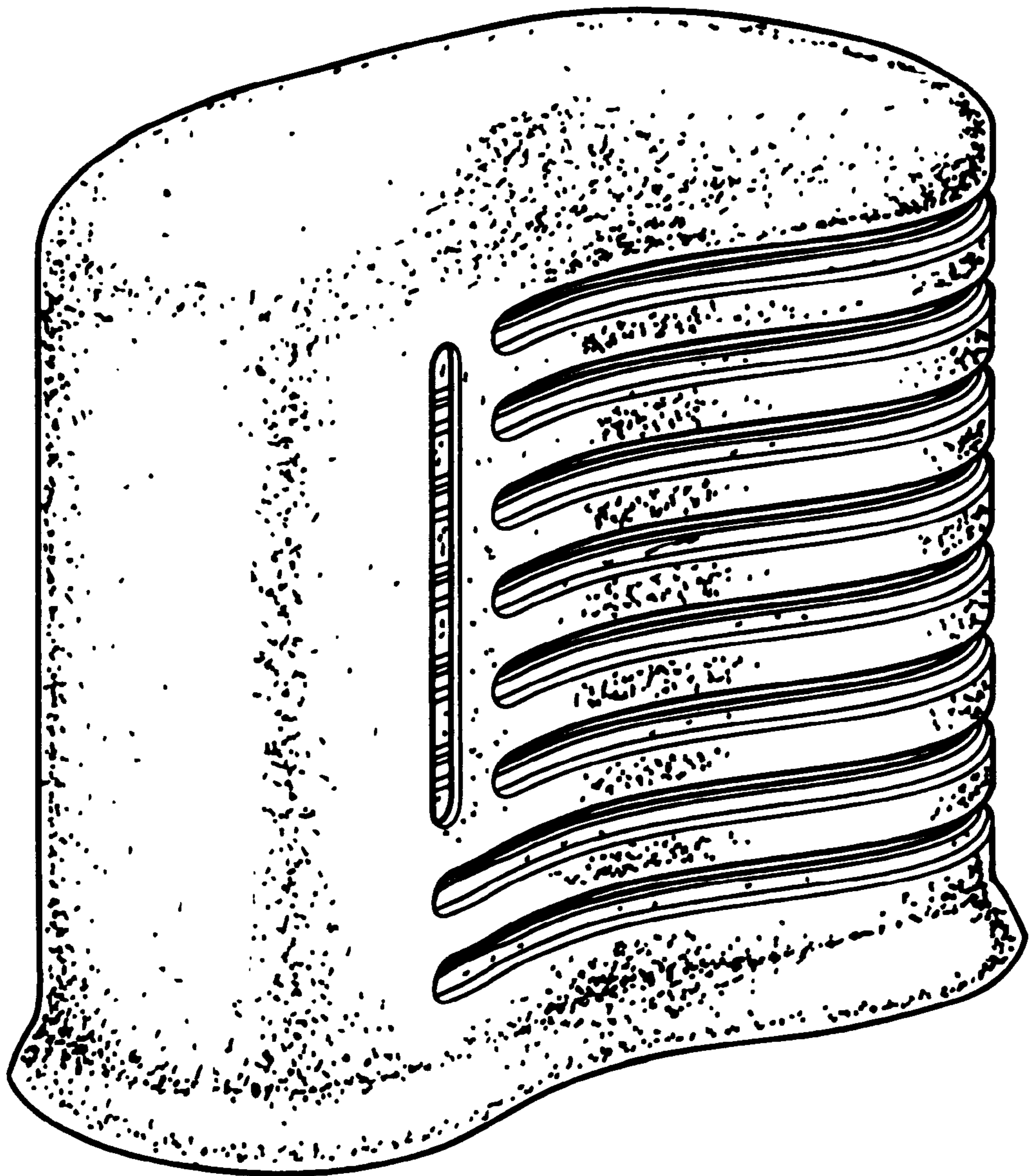

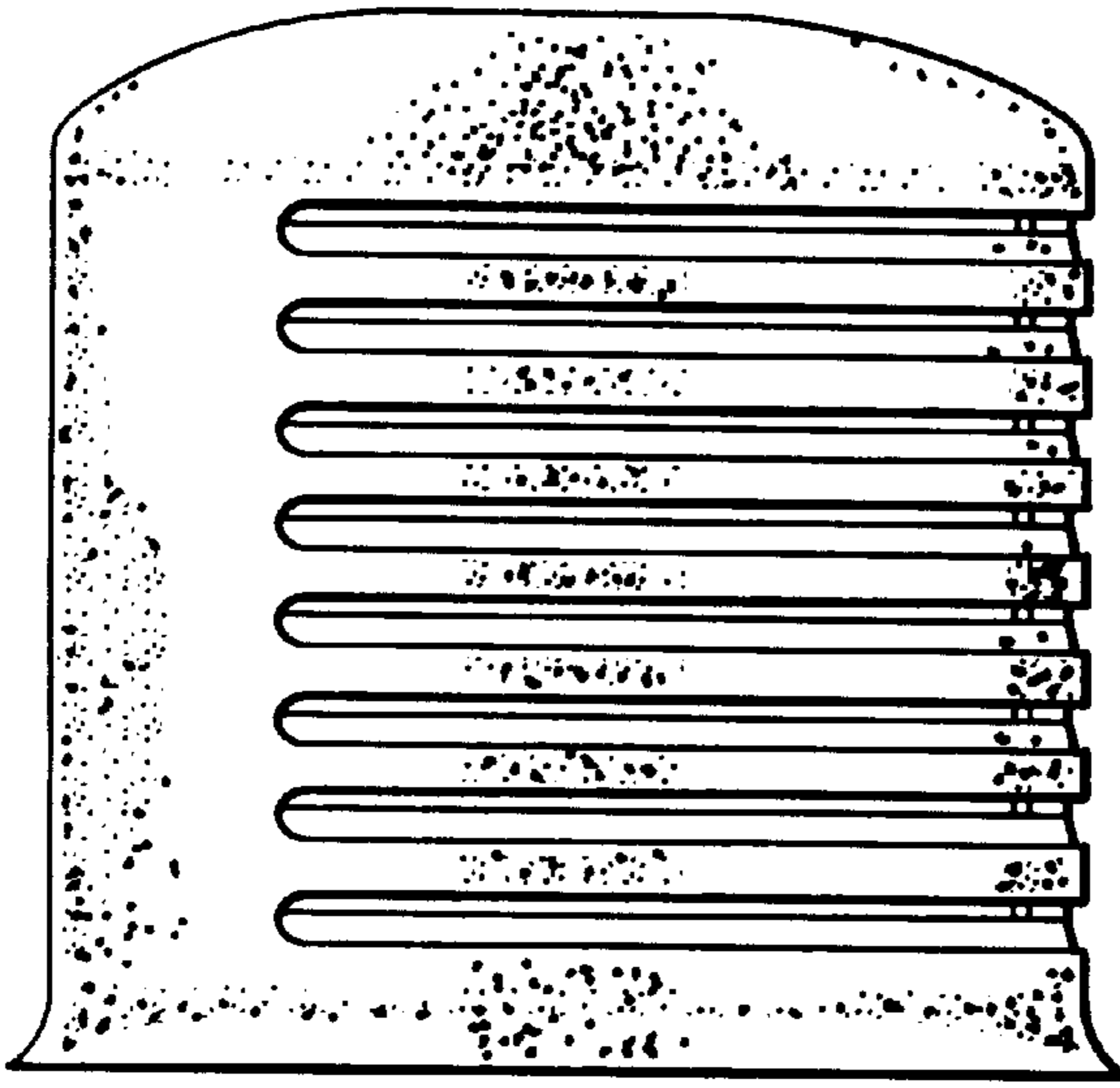

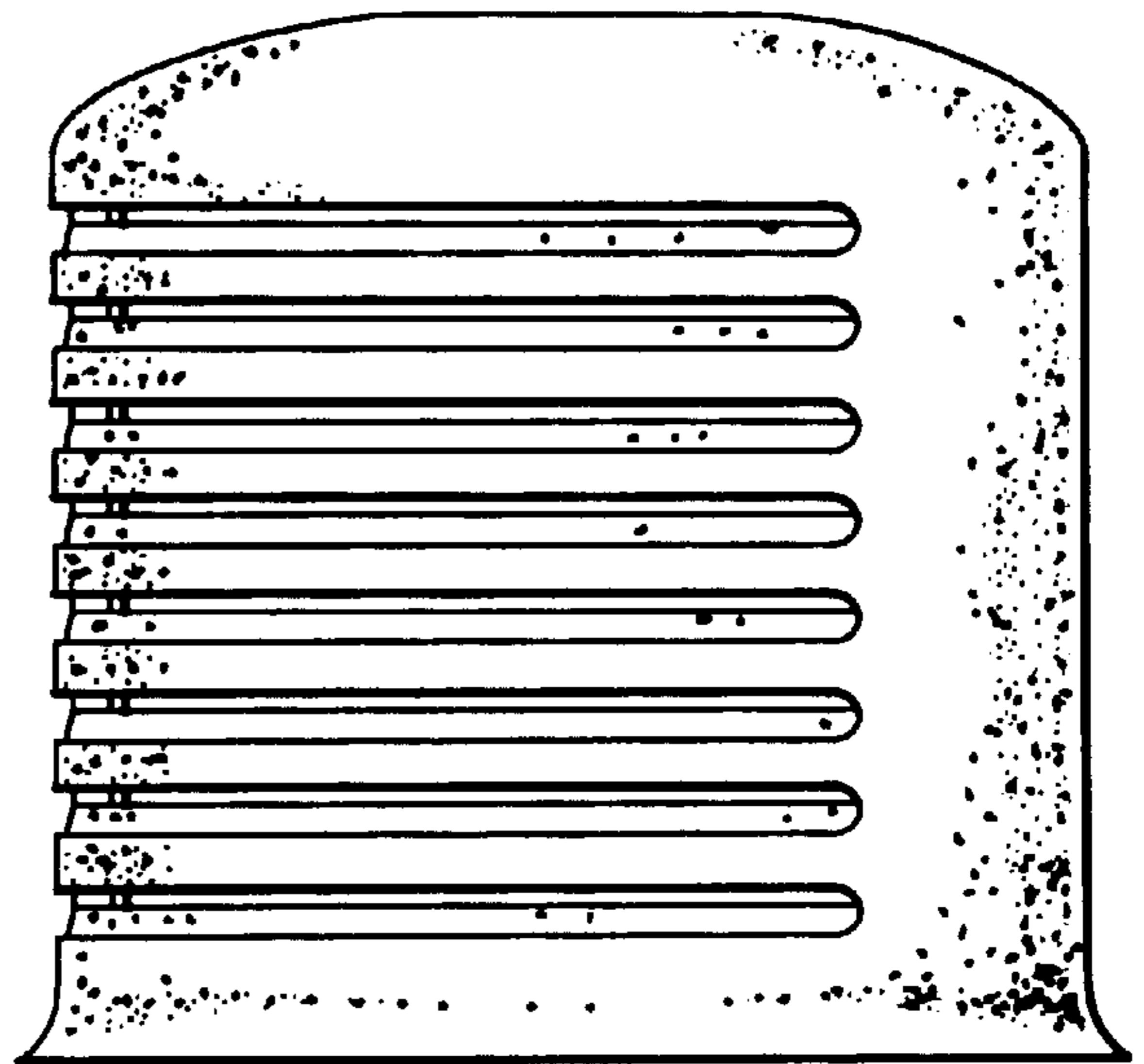
