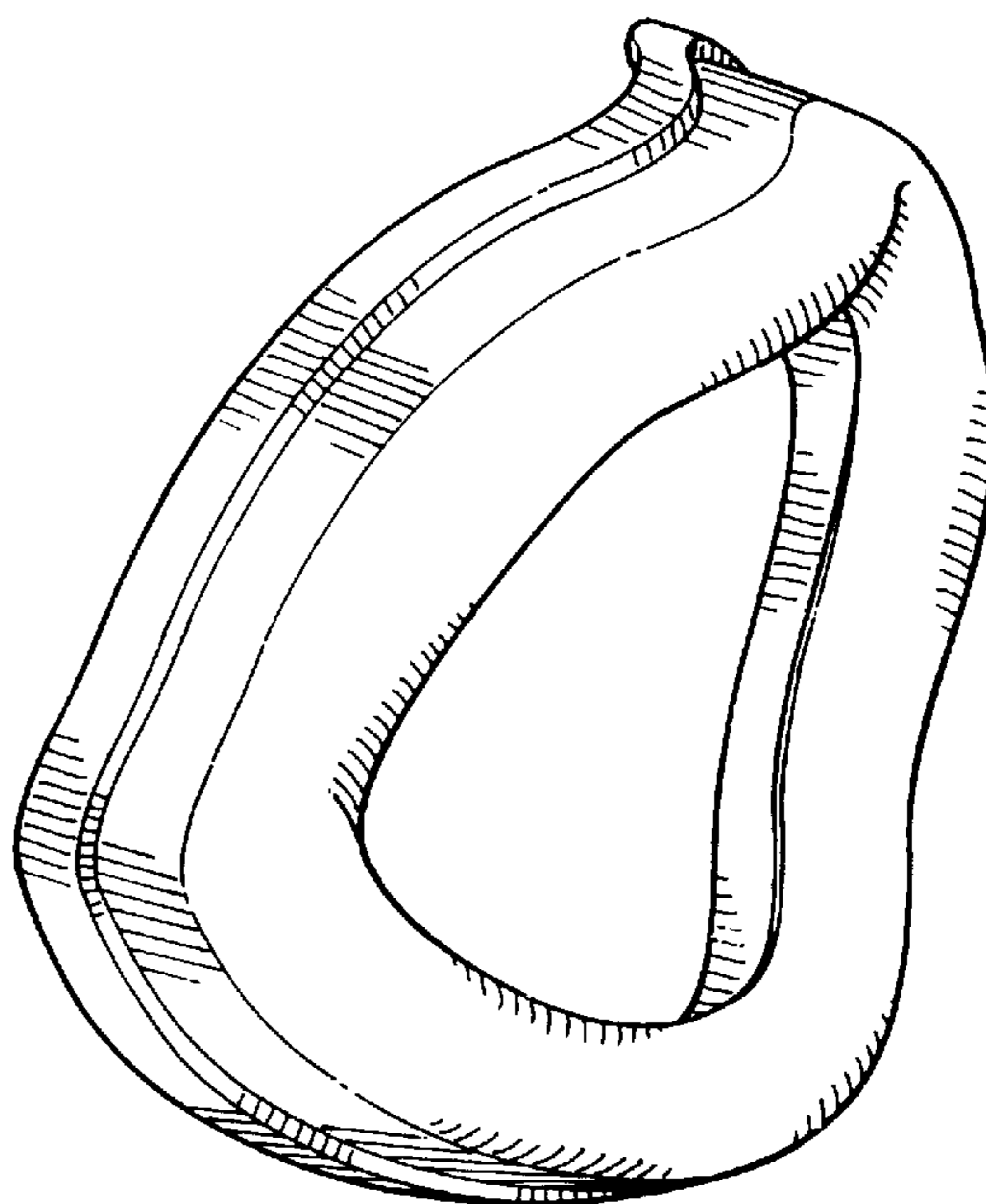
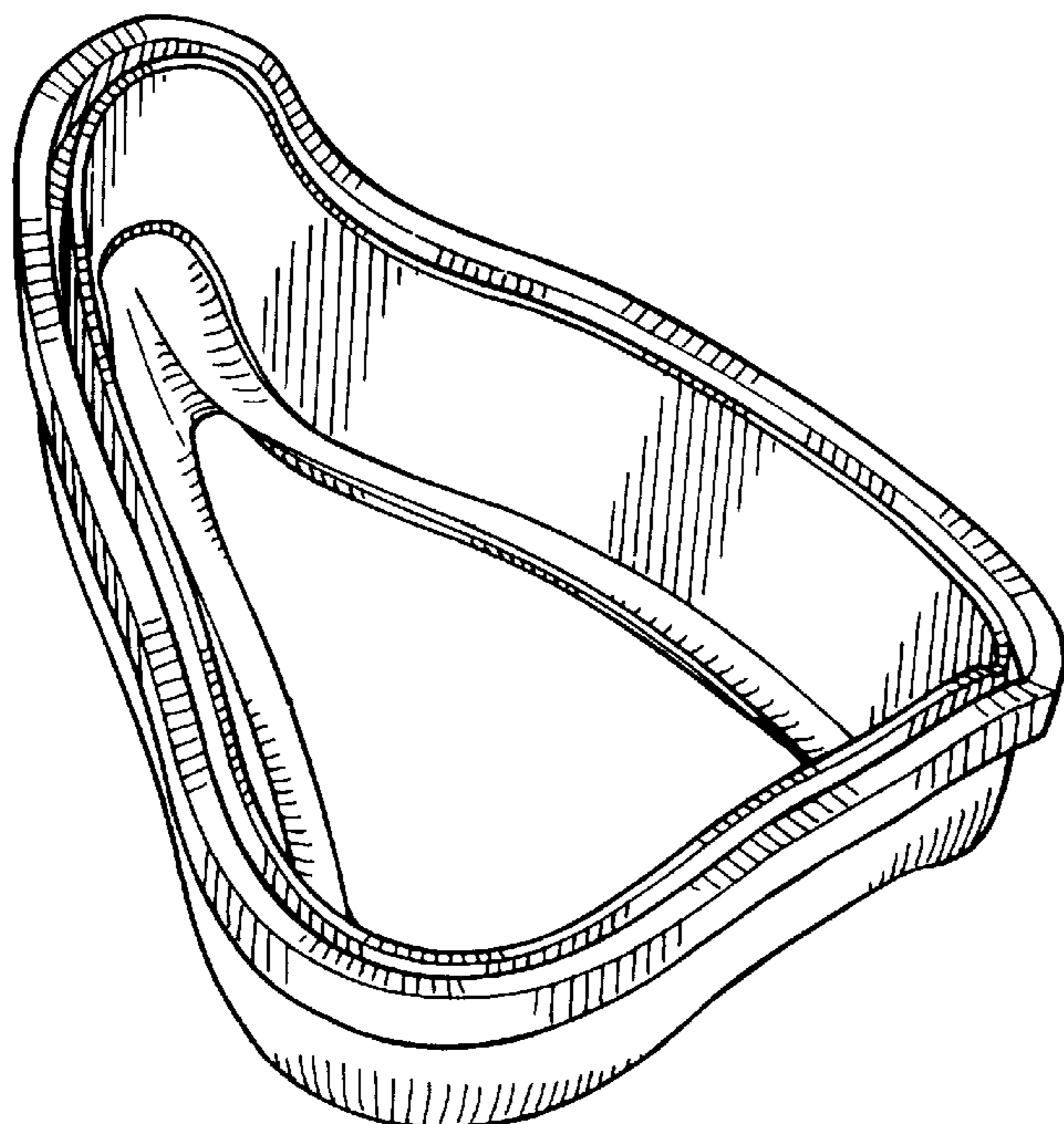

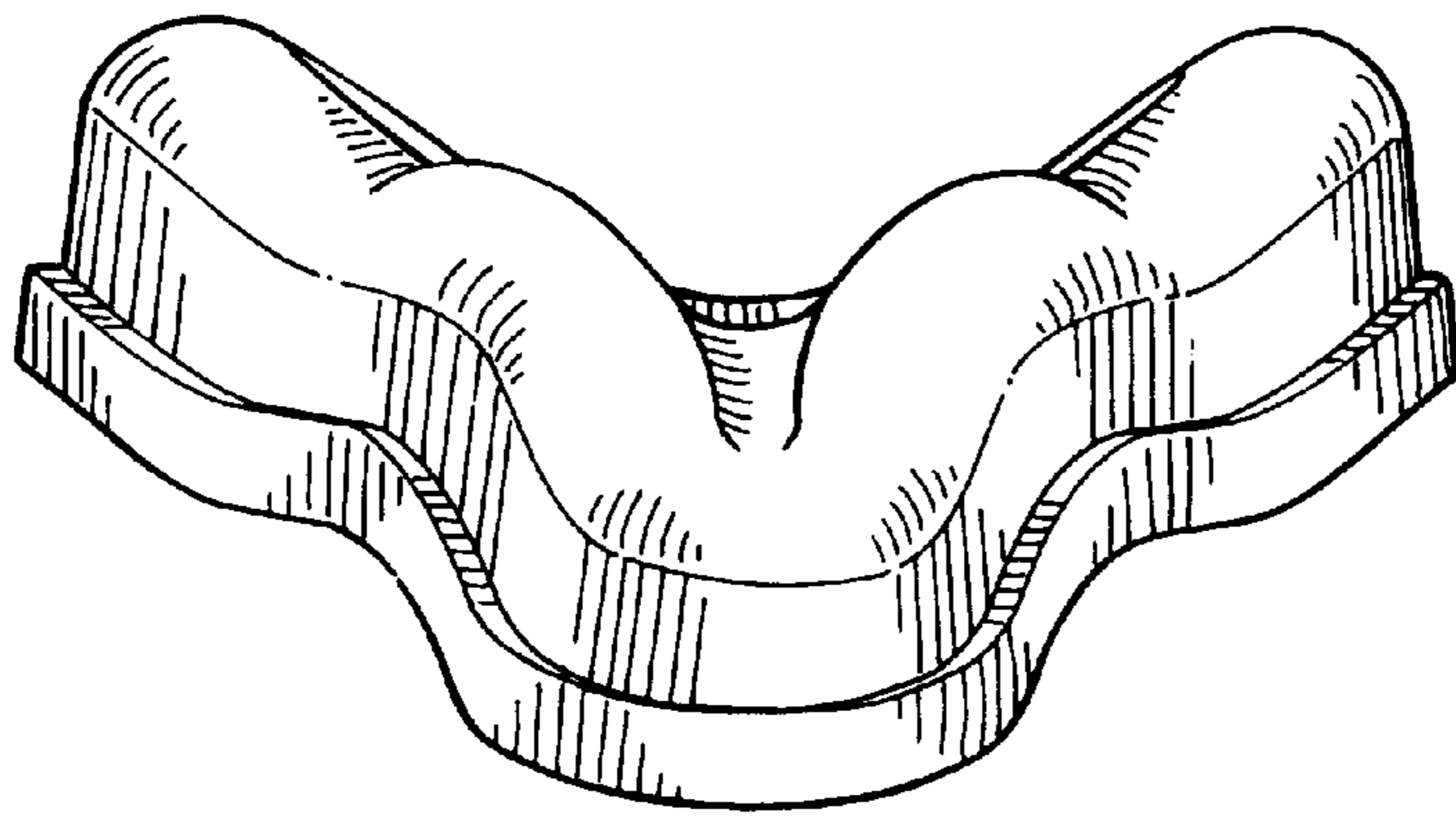
The ornamental design for a mask cushion, as shown and described.

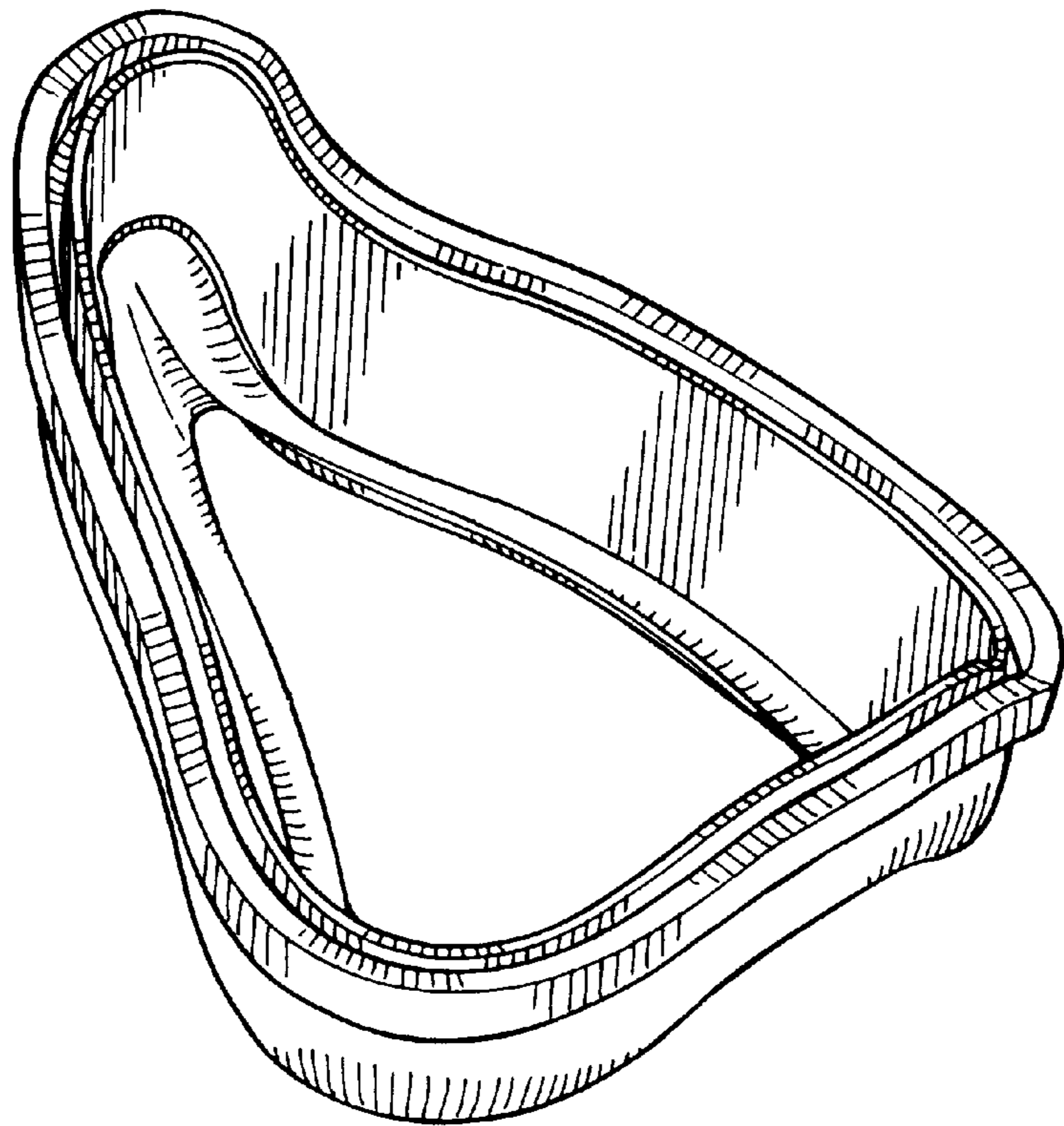
FIG. 1 is a top view;

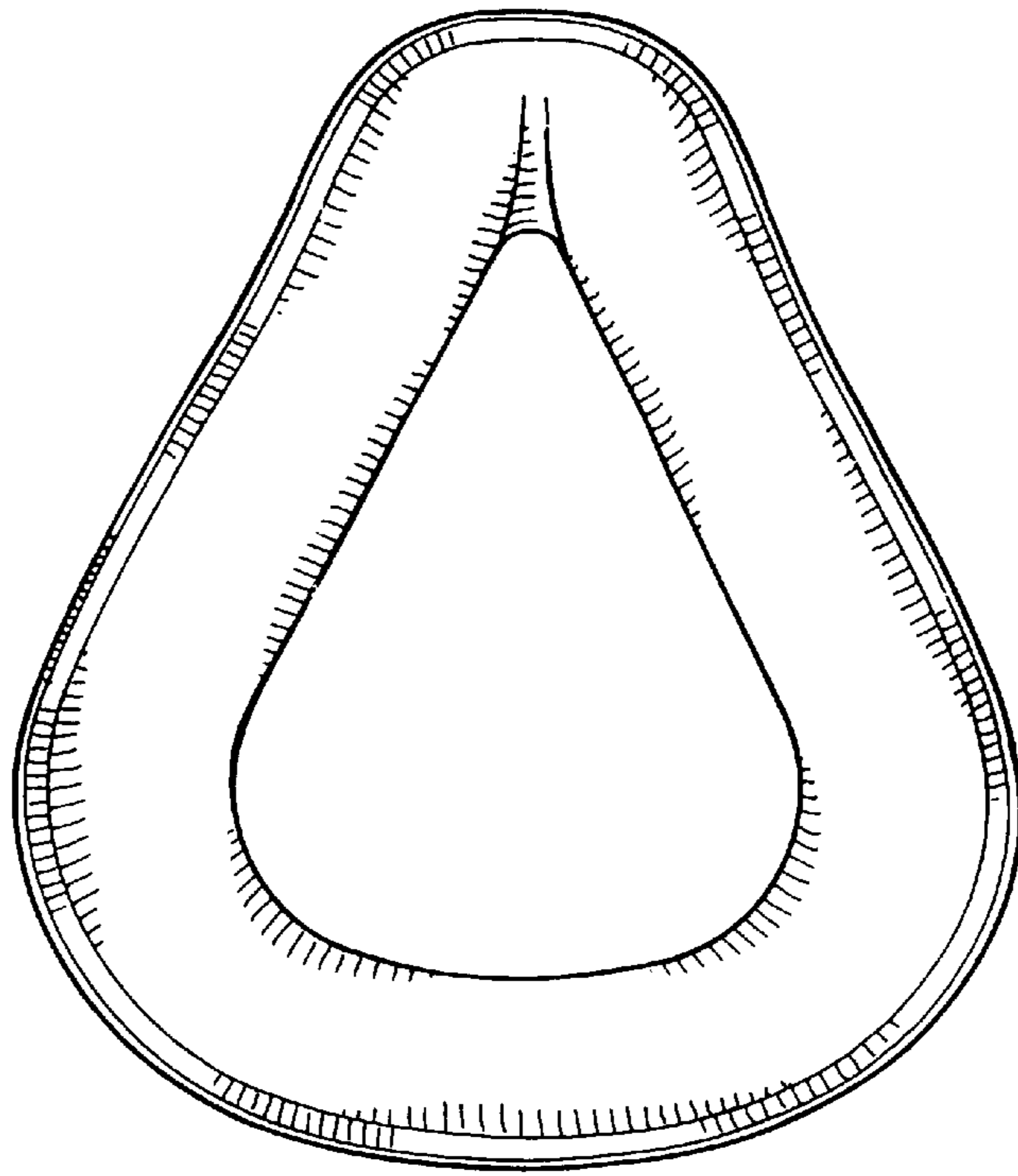




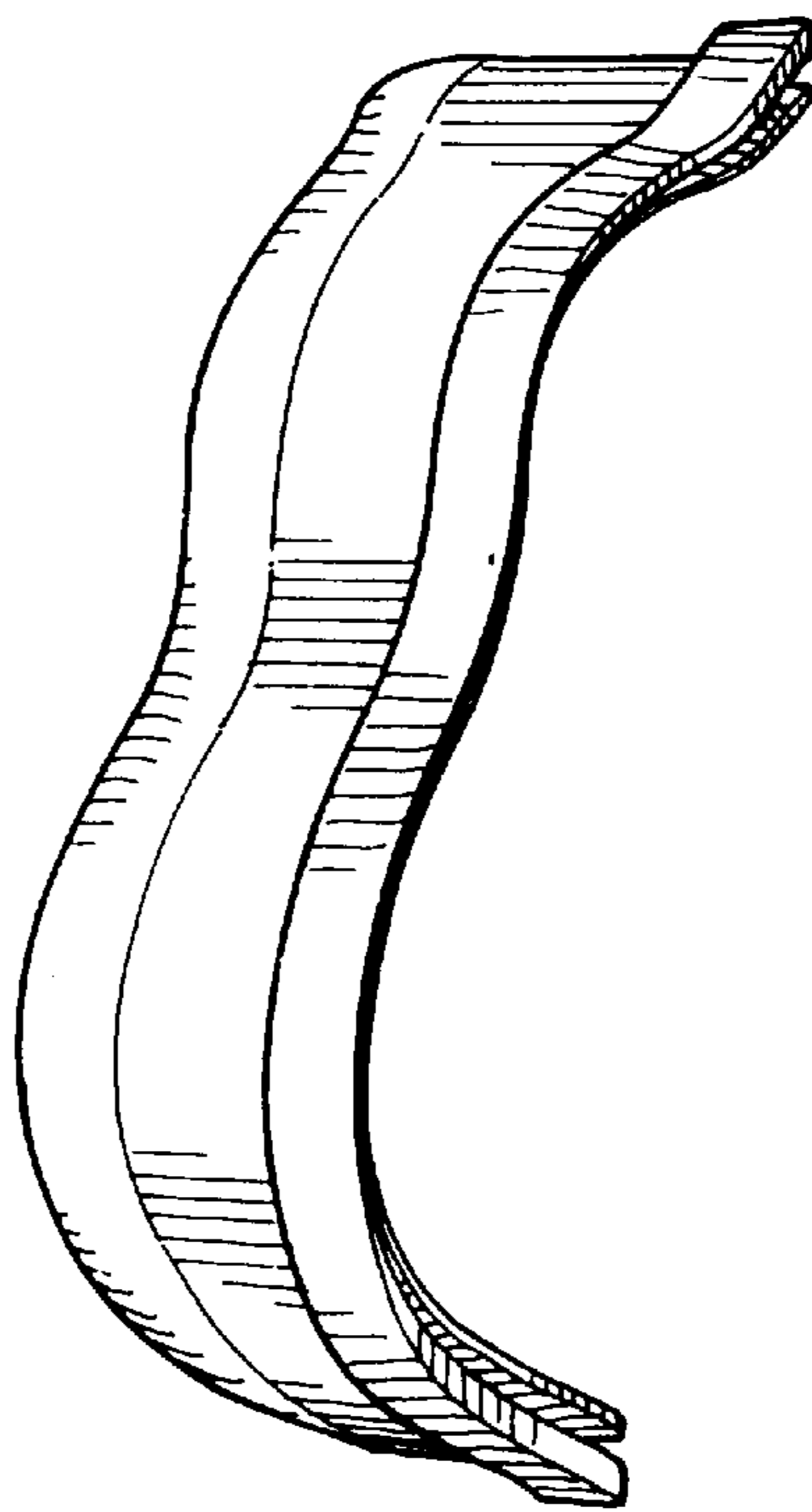

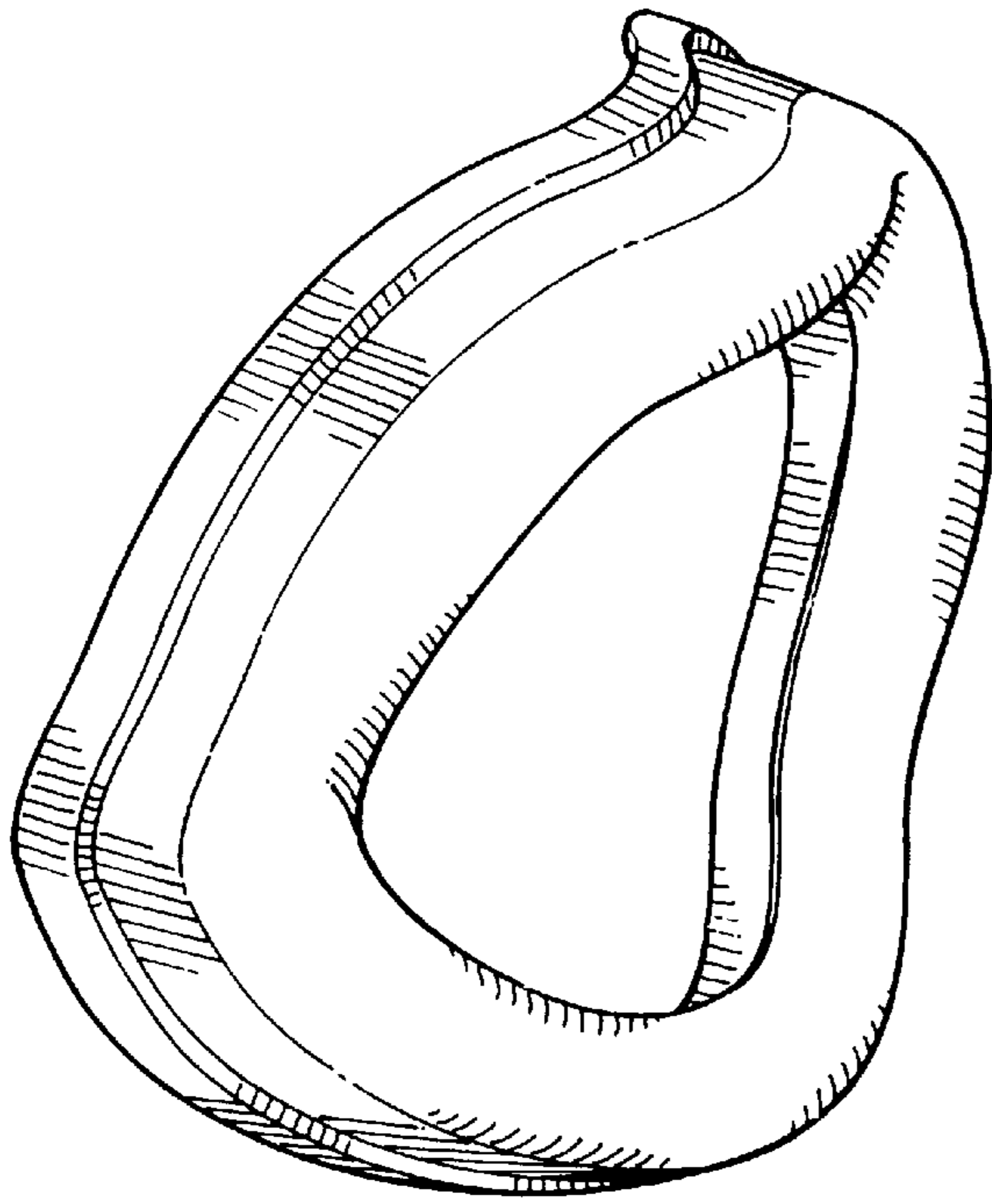

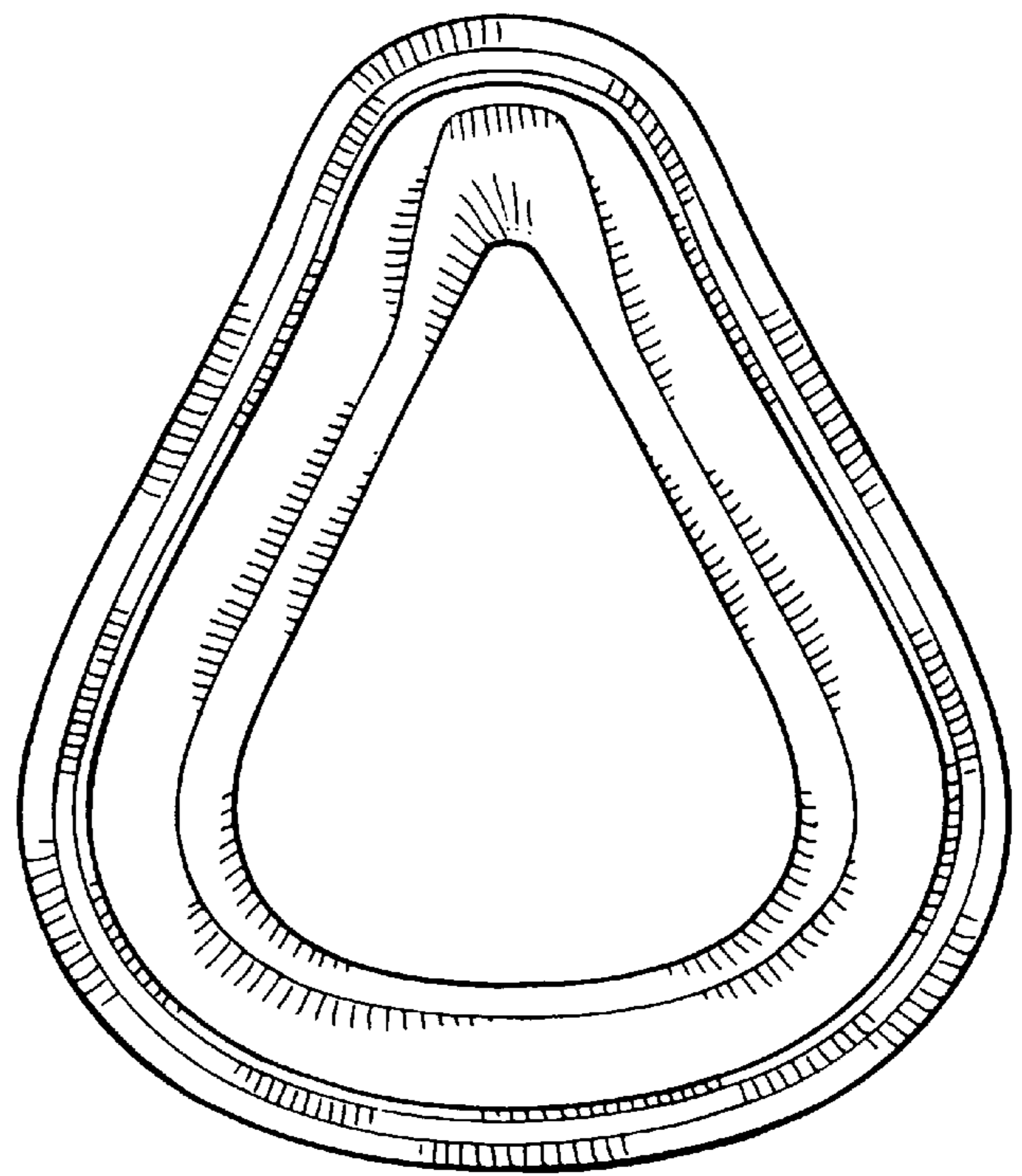

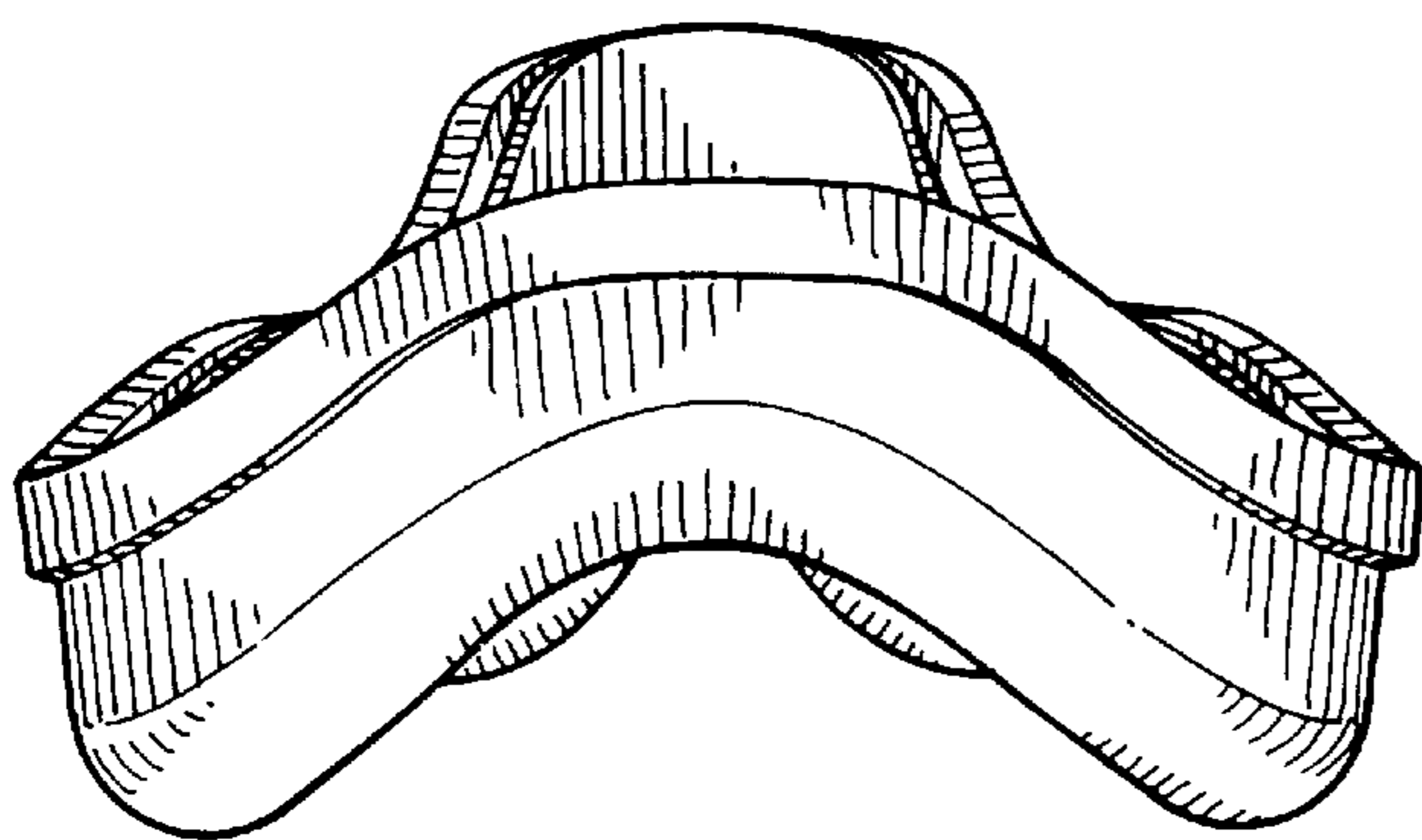
