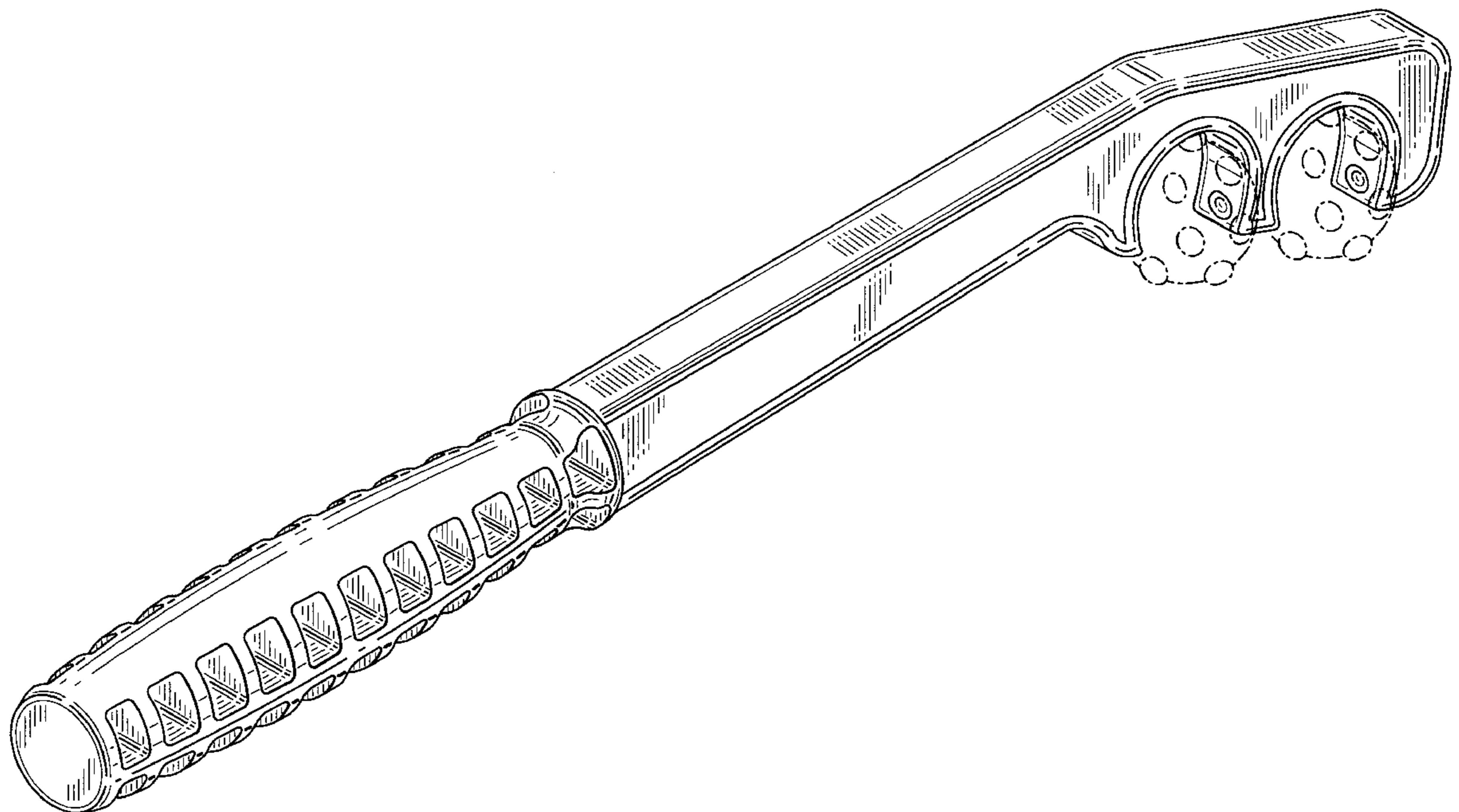
[57] **CLAIM**

The ornamental design for a handle for magnetic ball massage device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of handle for magnetic ball massage device, showing our new design, the broken line showing of the magnetic massage balls being for illustrative purposes only and forming no part of the claimed design; FIG. 2 is a front elevational view of FIG. 1, the rear elevational view not being shown as it is substantially a mirror image of the front elevational view; FIG. 3 is a left side elevational view of FIG. 2, FIG. 4 is a right side elevational view of FIG. 2; FIG. 5 is a top plan view of FIG. 2; FIG. 6 is a bottom plan view of FIG. 2; FIG. 7 is a perspective view of a second embodiment of the handle for magnetic ball massage device, showing our new design, with the difference being the handle tapers at both ends, and the broken line showing of the massage balls being for illustrative purposes only and forming no part of the claimed design; FIG. 8 is a front elevational view of FIG. 7, the rear elevational view not being shown as it is substantially a mirror image of the front elevational view; FIG. 9 is a left side elevational view of FIG. 8; FIG. 10 is a right side elevational view of FIG. 8; FIG. 11 is a top plan view of FIG. 8; and, FIG. 12 is a bottom plan view of FIG. 8.

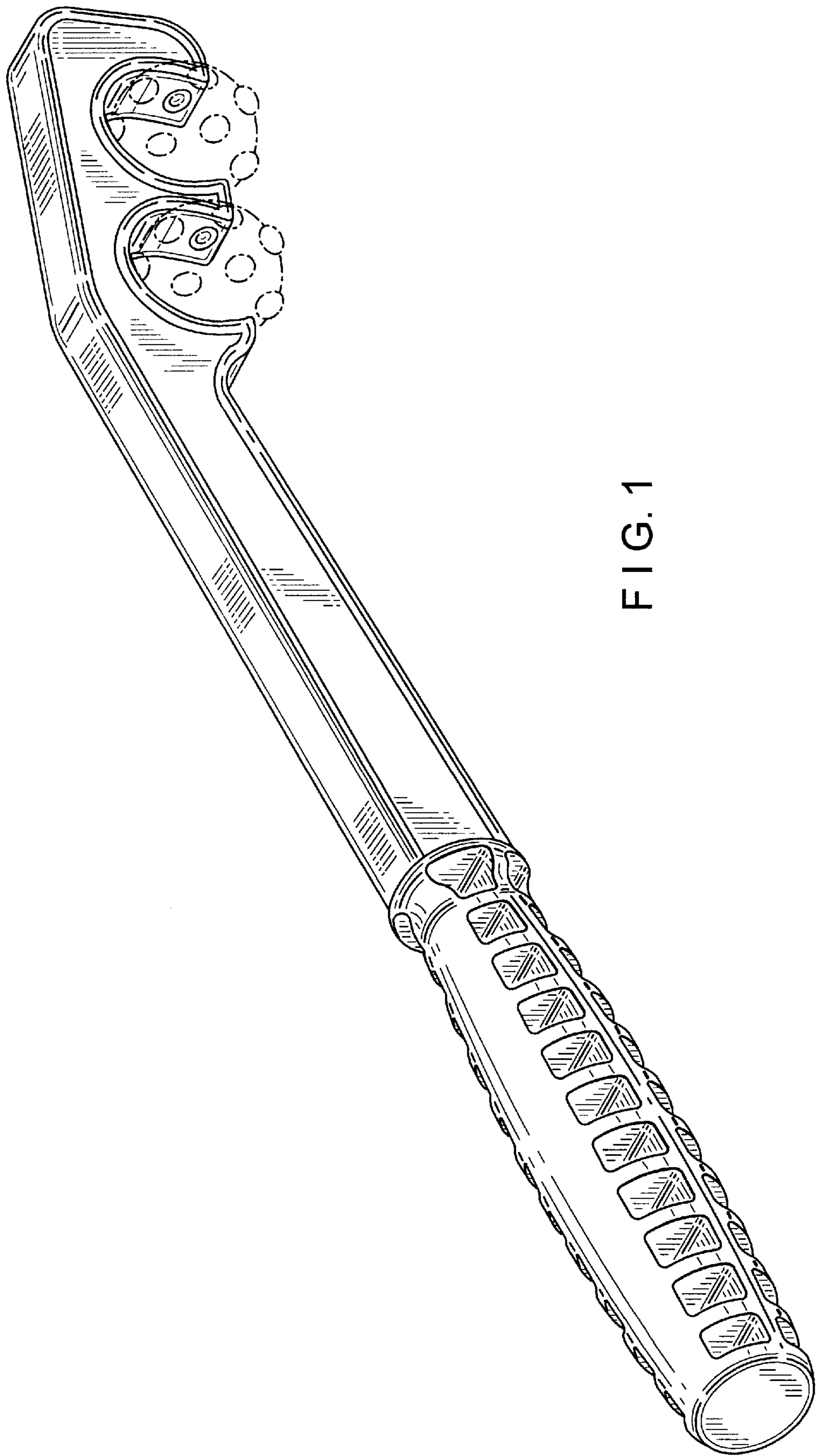

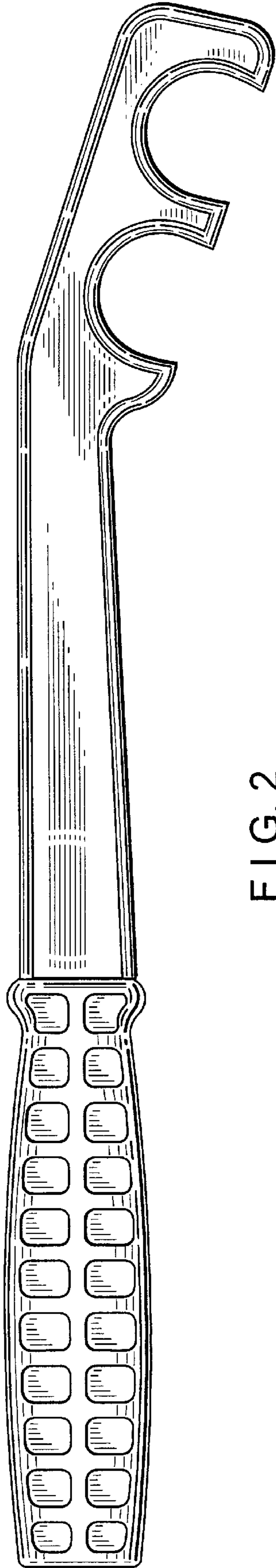

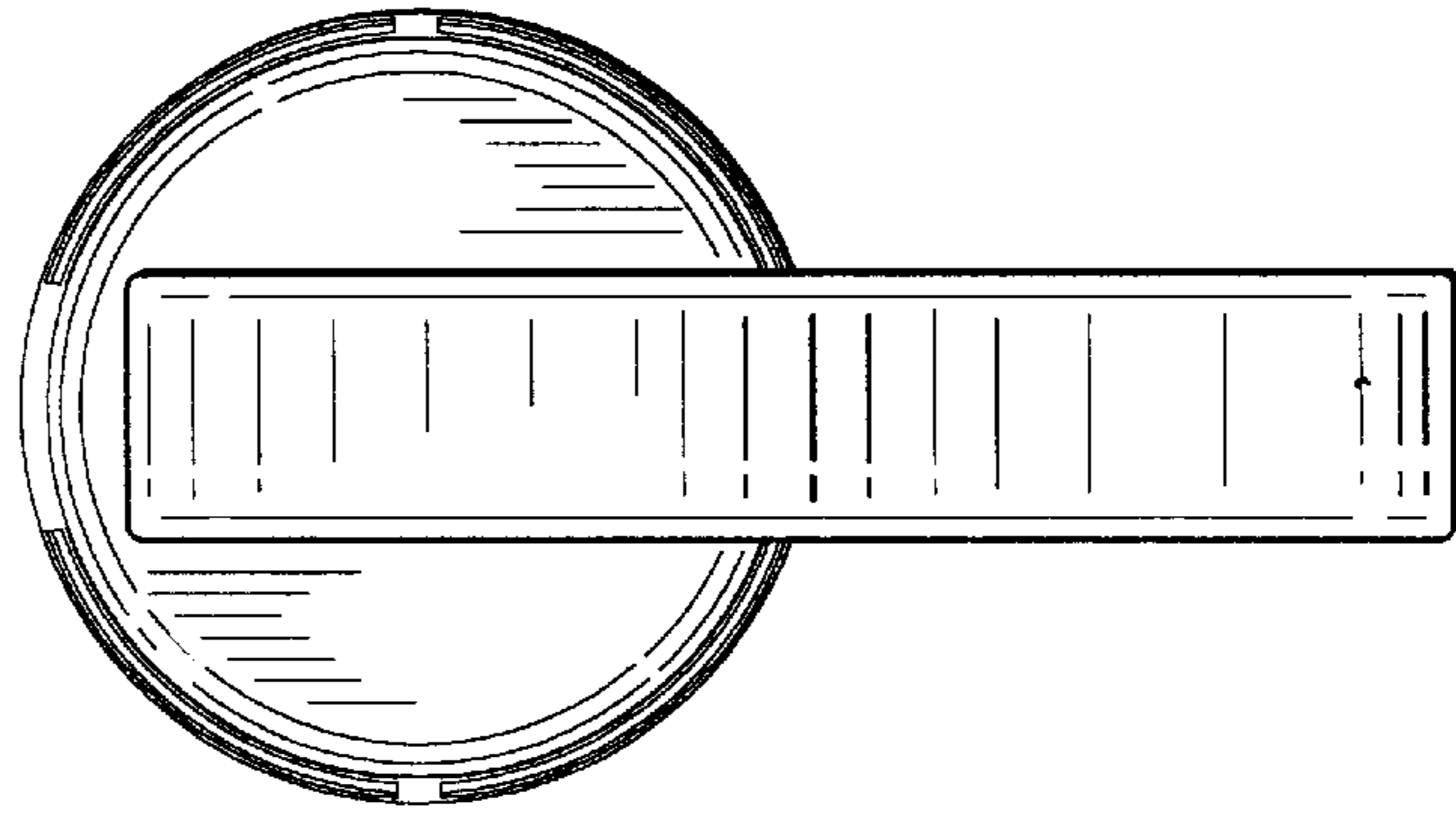

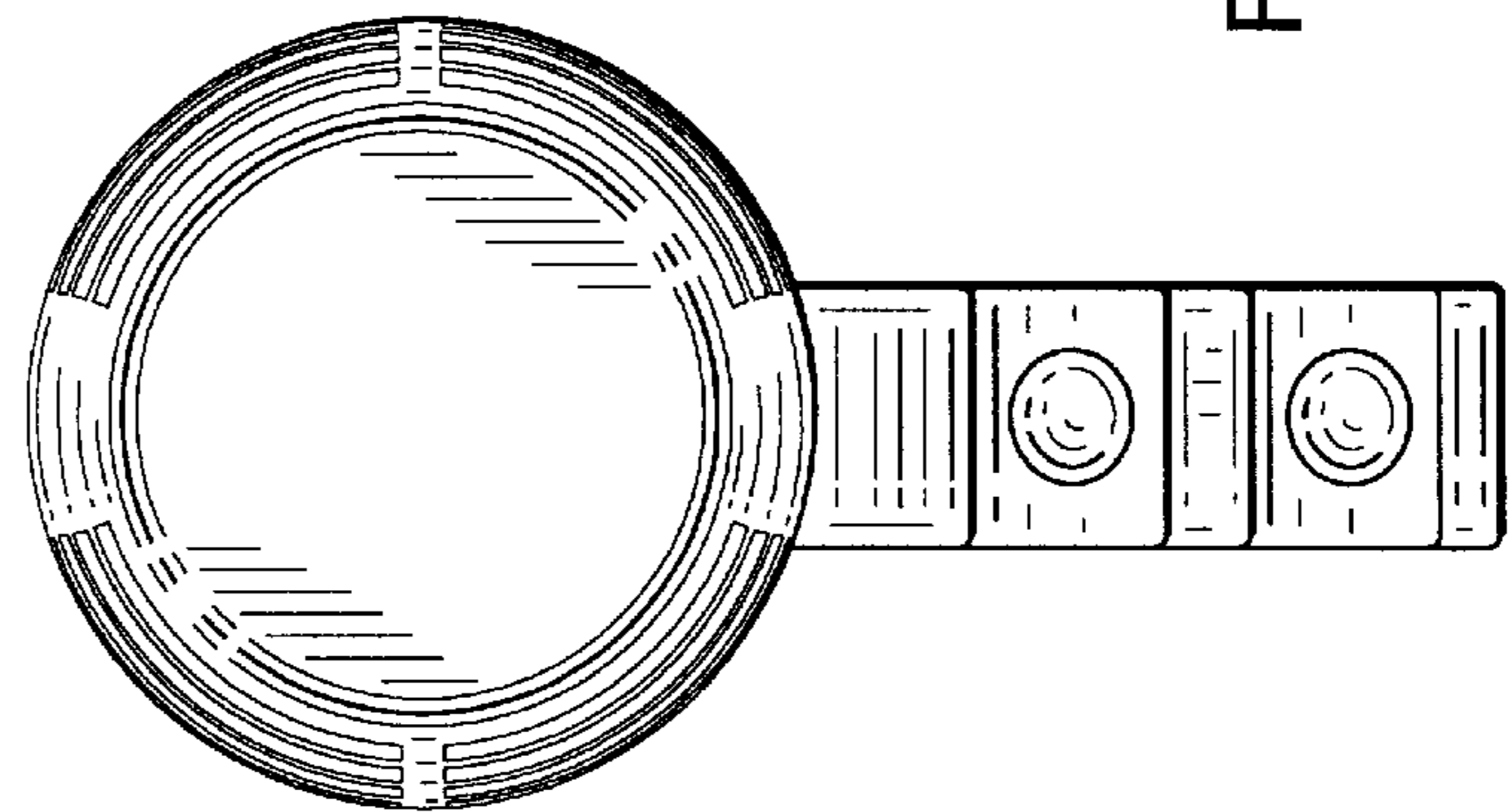

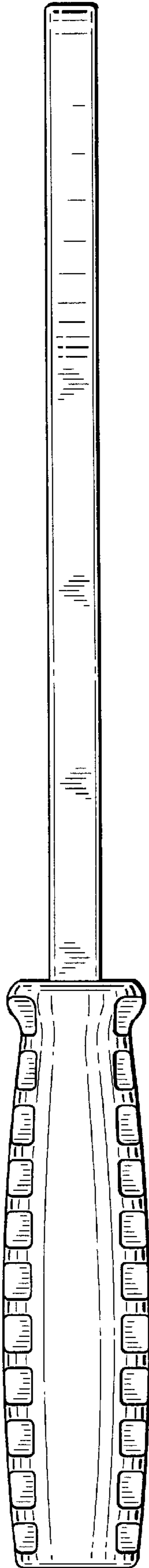

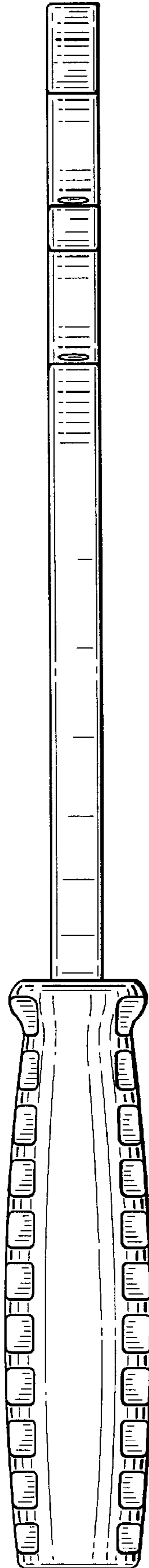

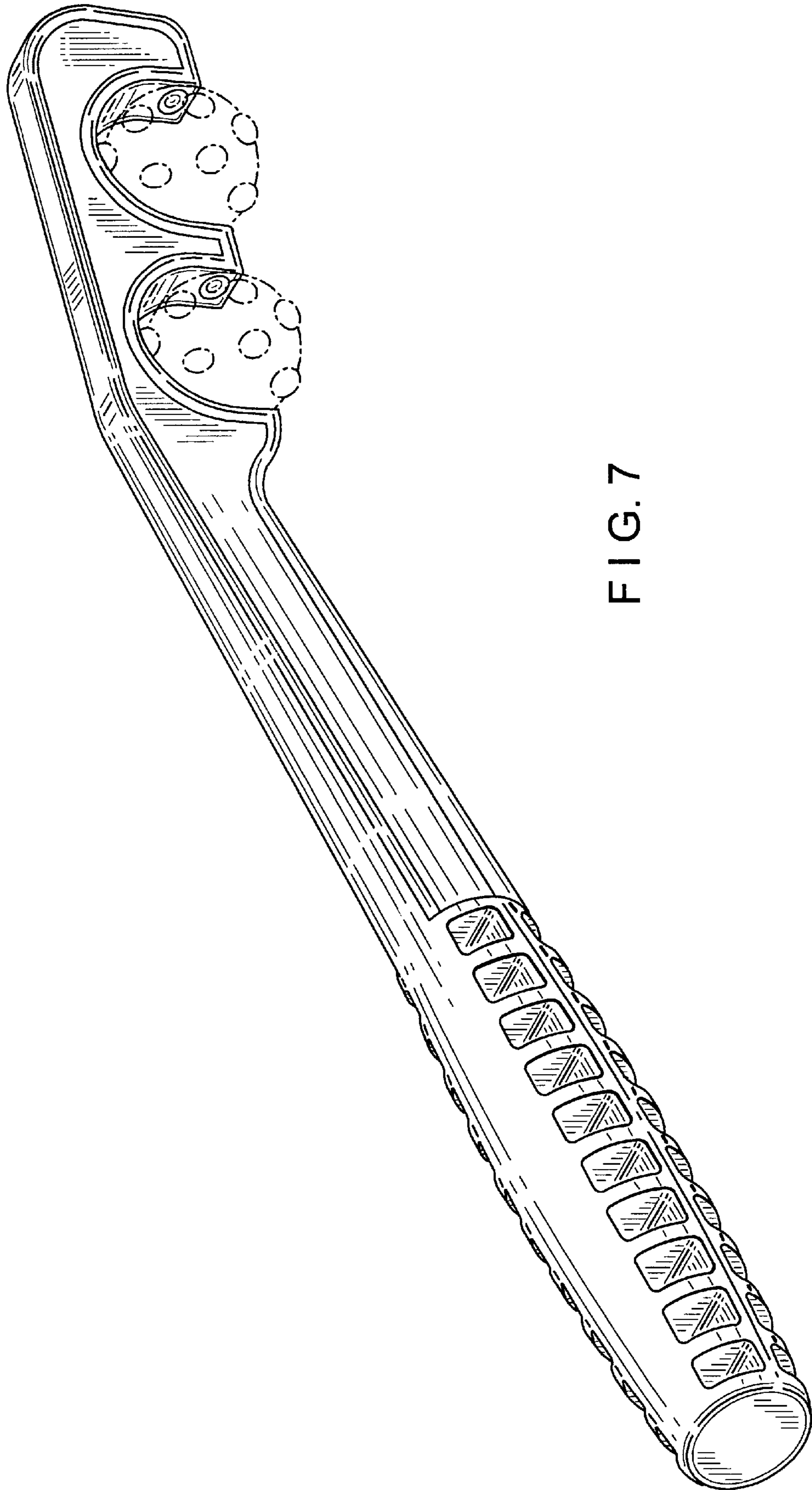

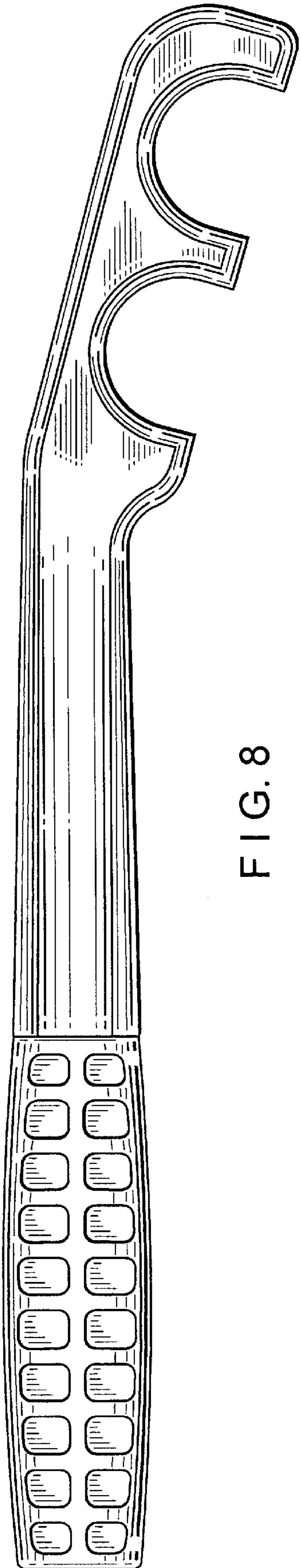

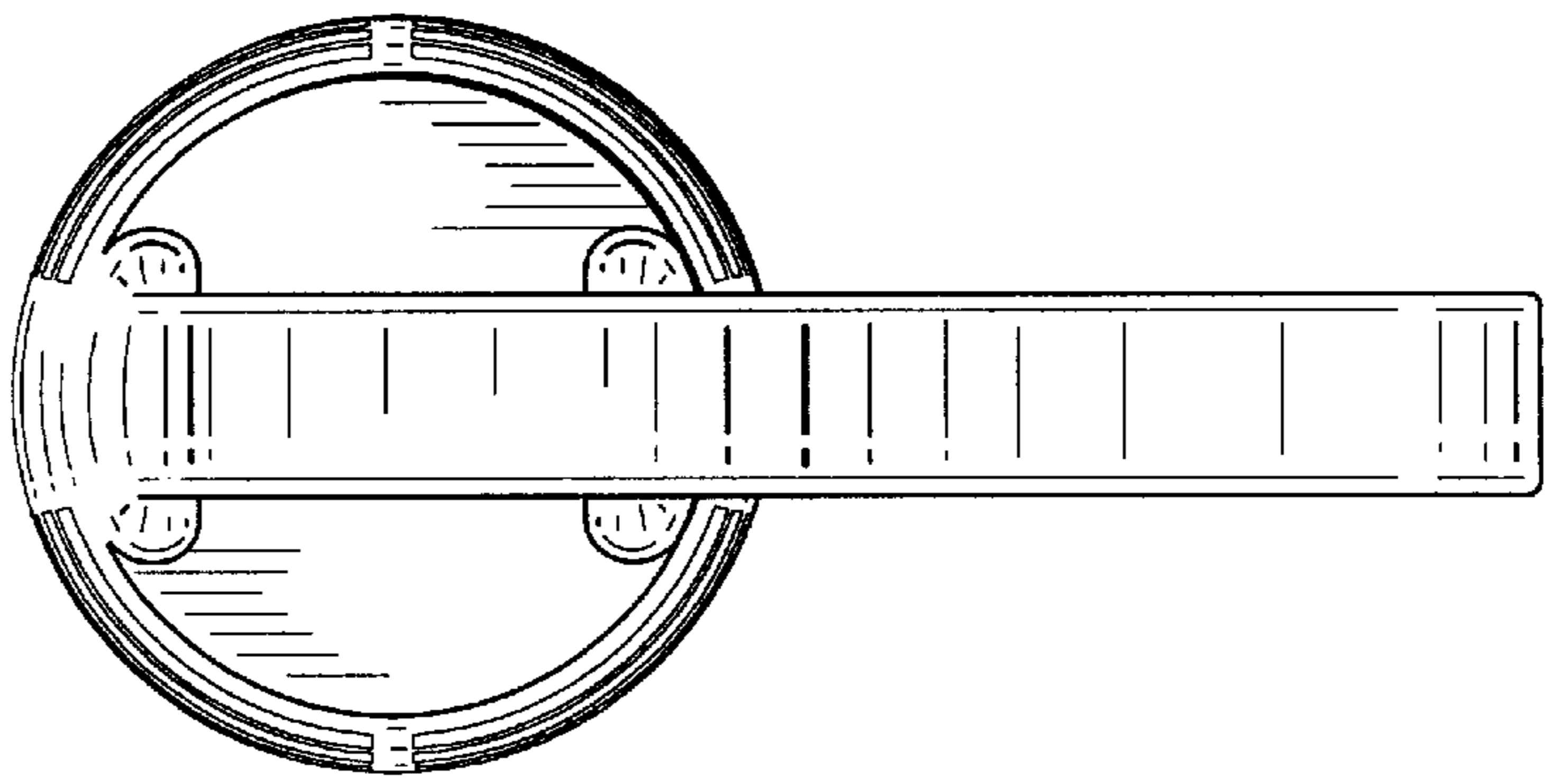

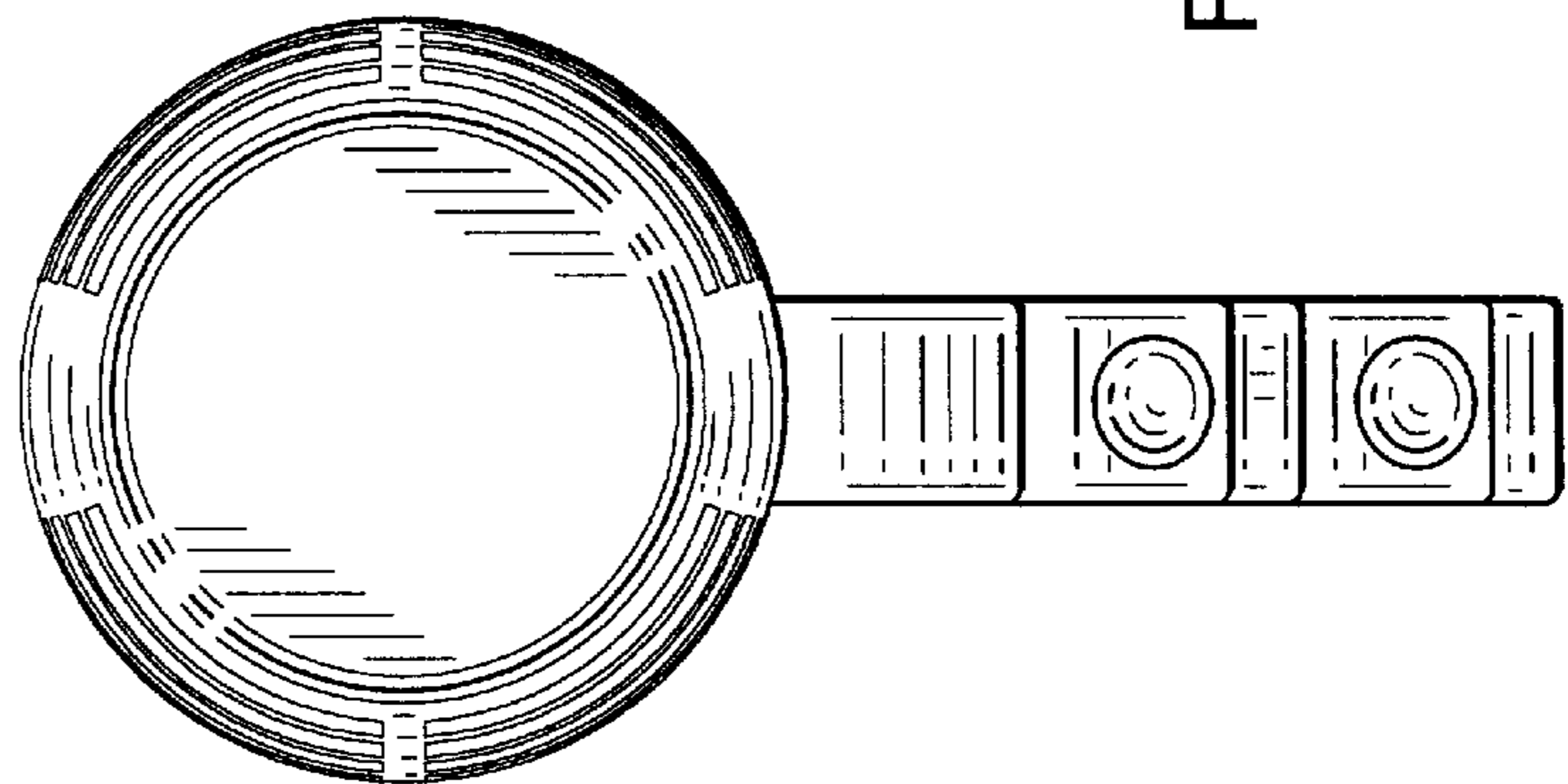

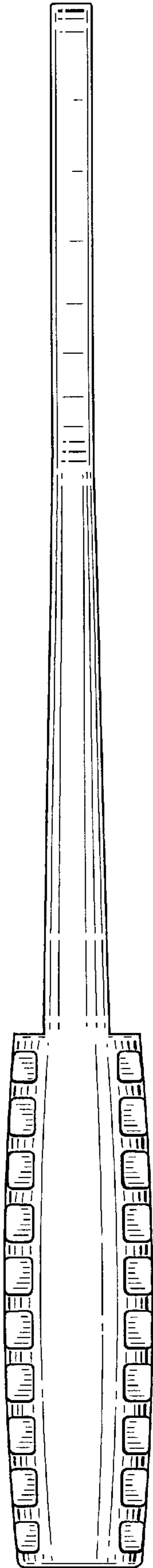

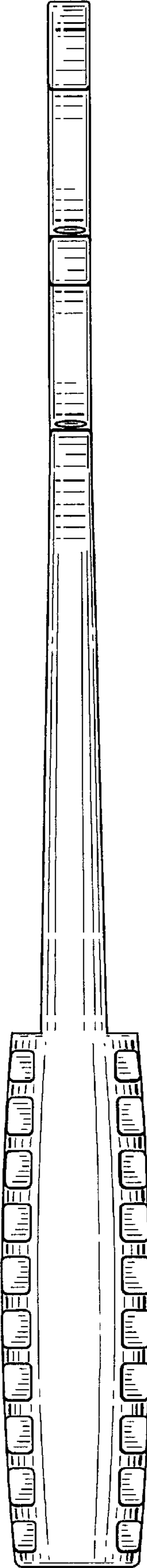
