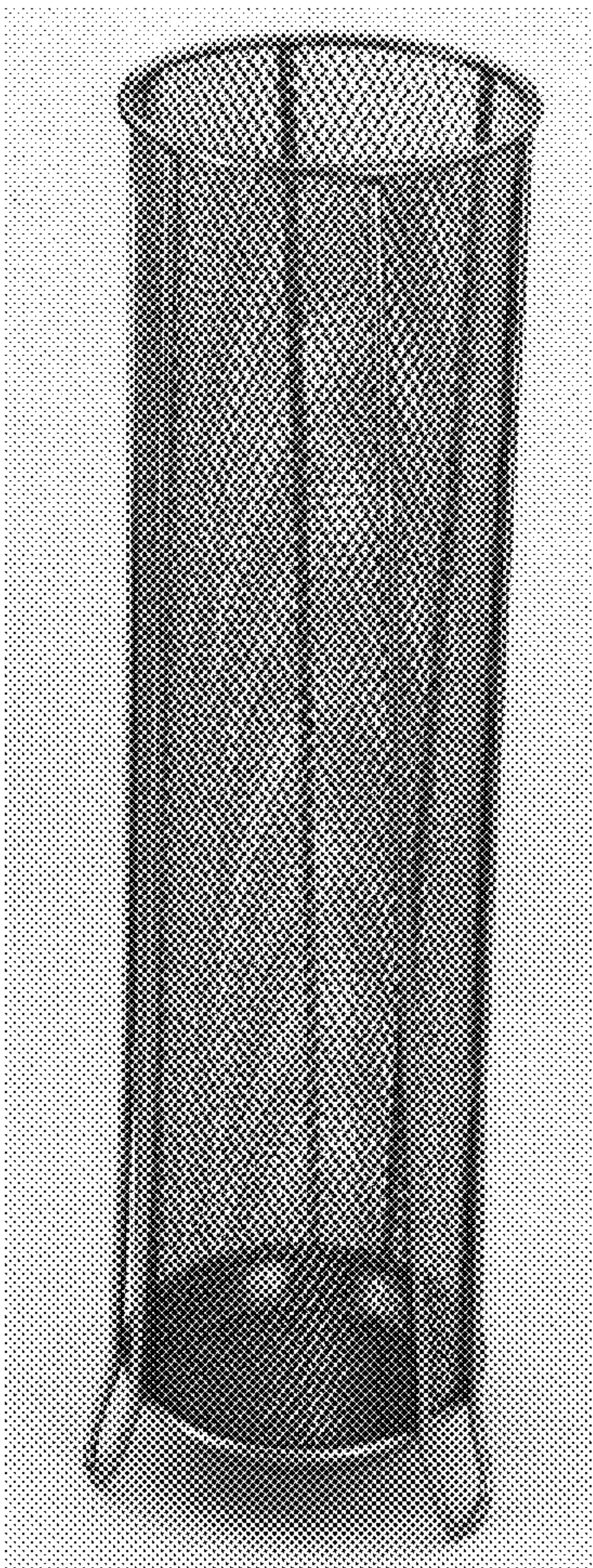
[57] **CLAIM**

The ornamental design for a towel holder, as shown and described.

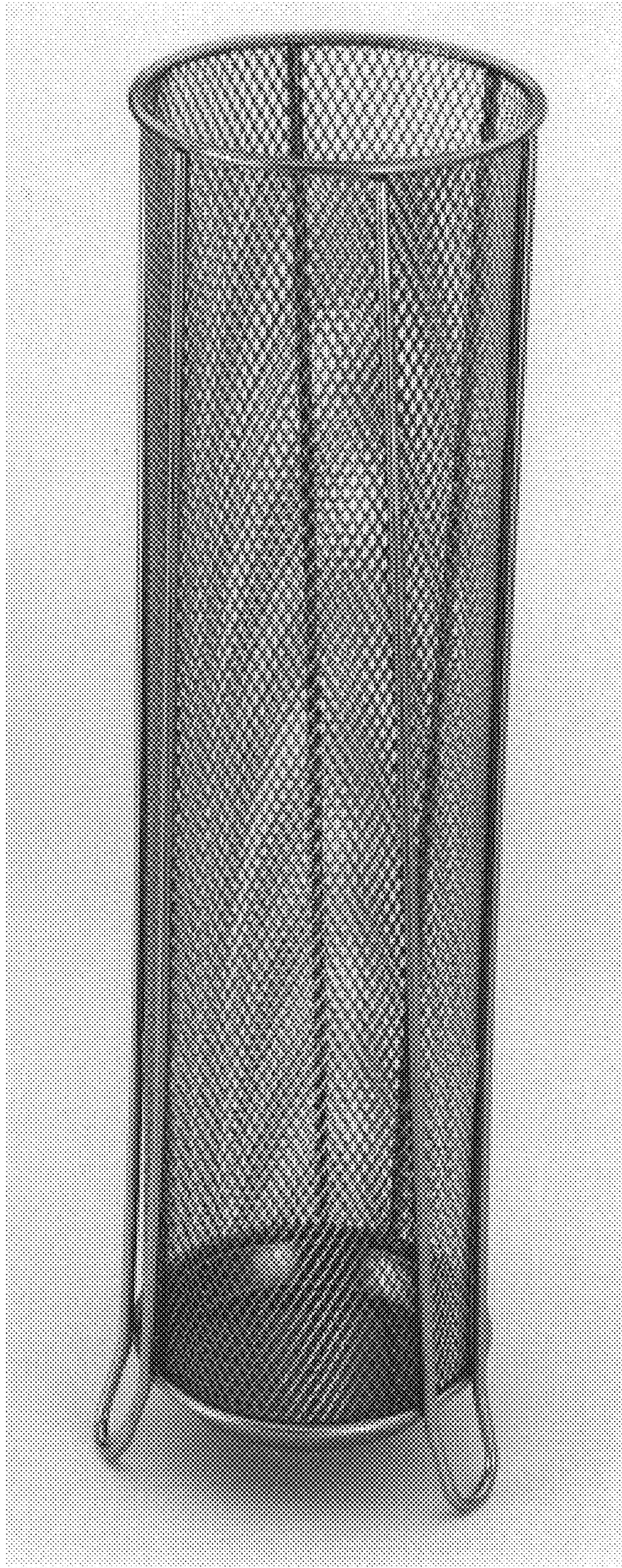
**DESCRIPTION**

FIG. 1 is a perspective view of a towel holder showing our new design;

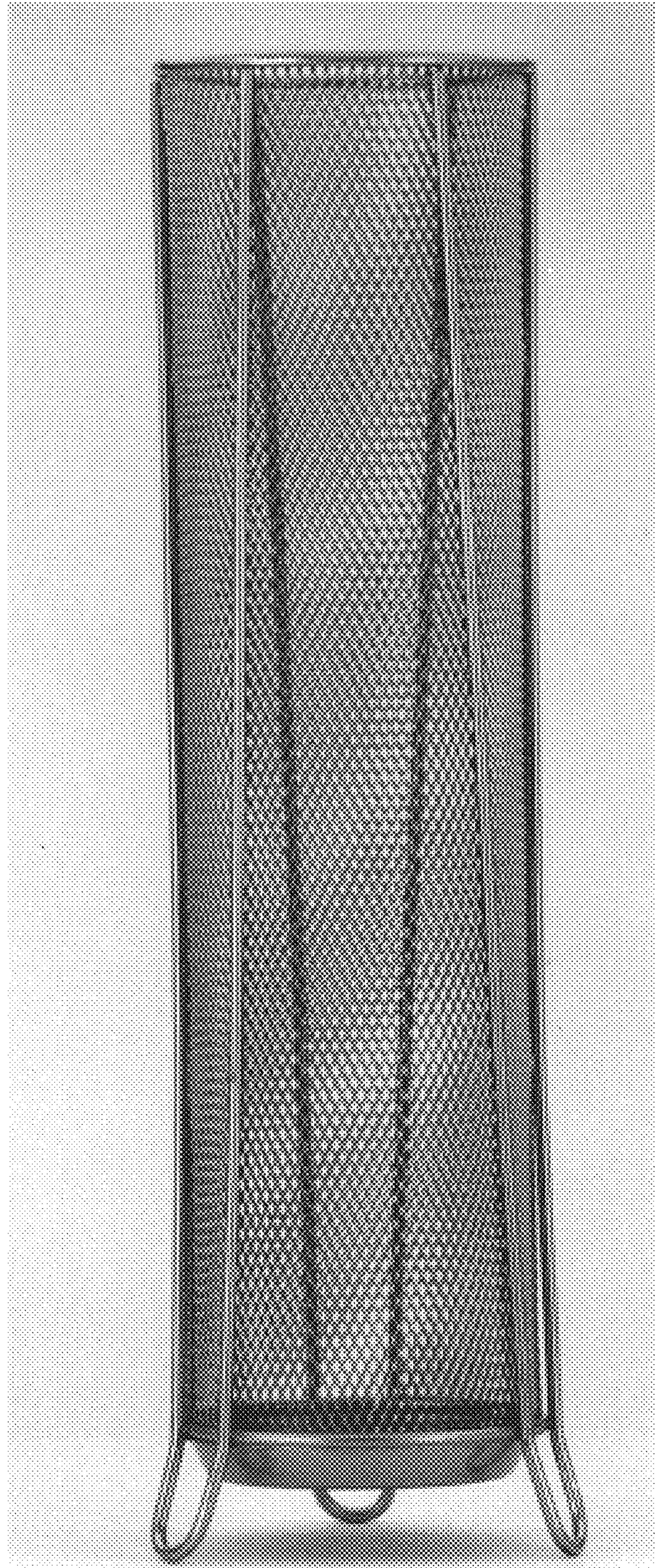






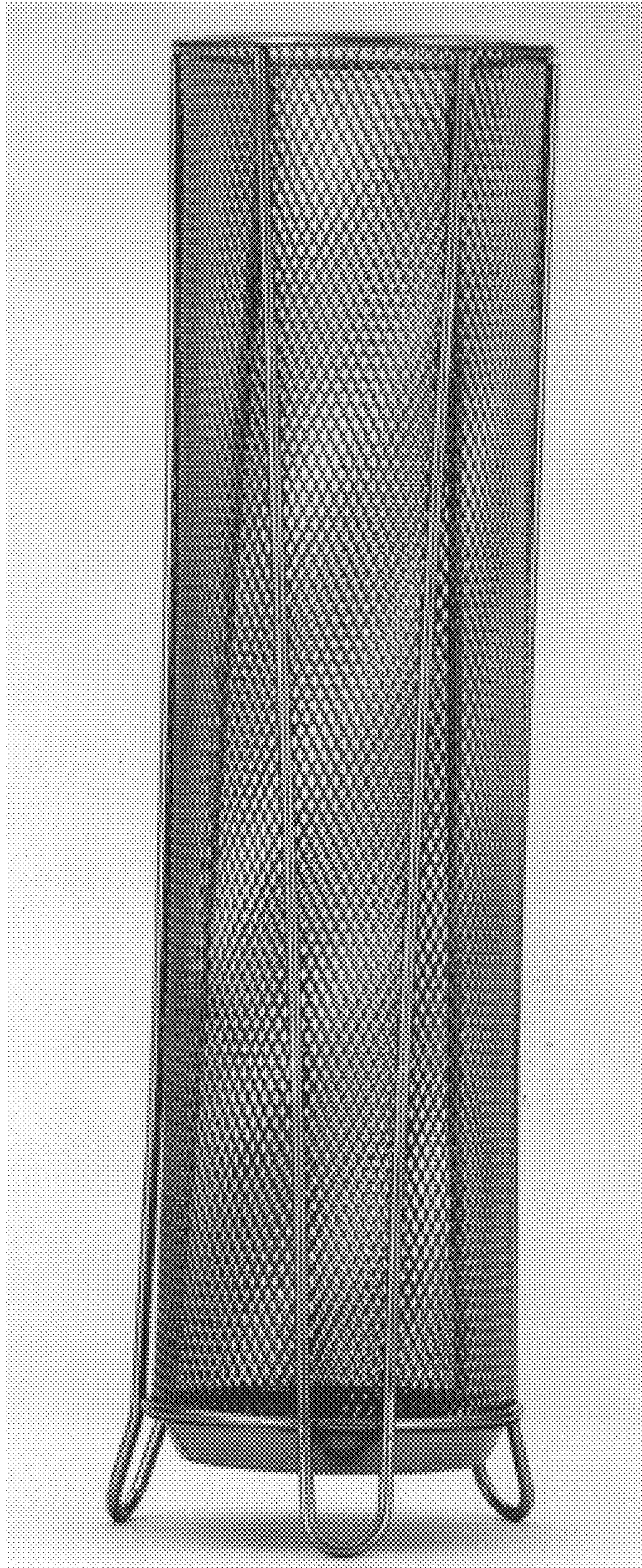

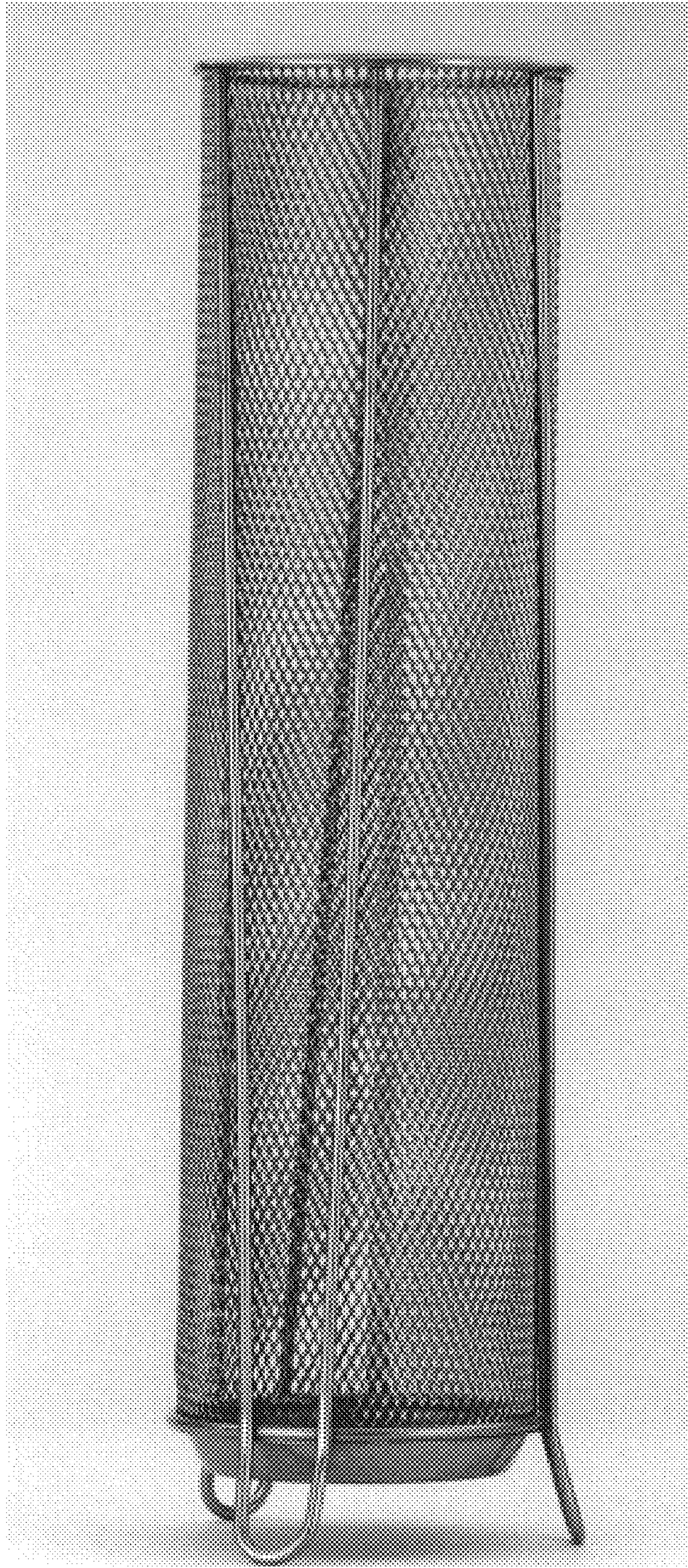

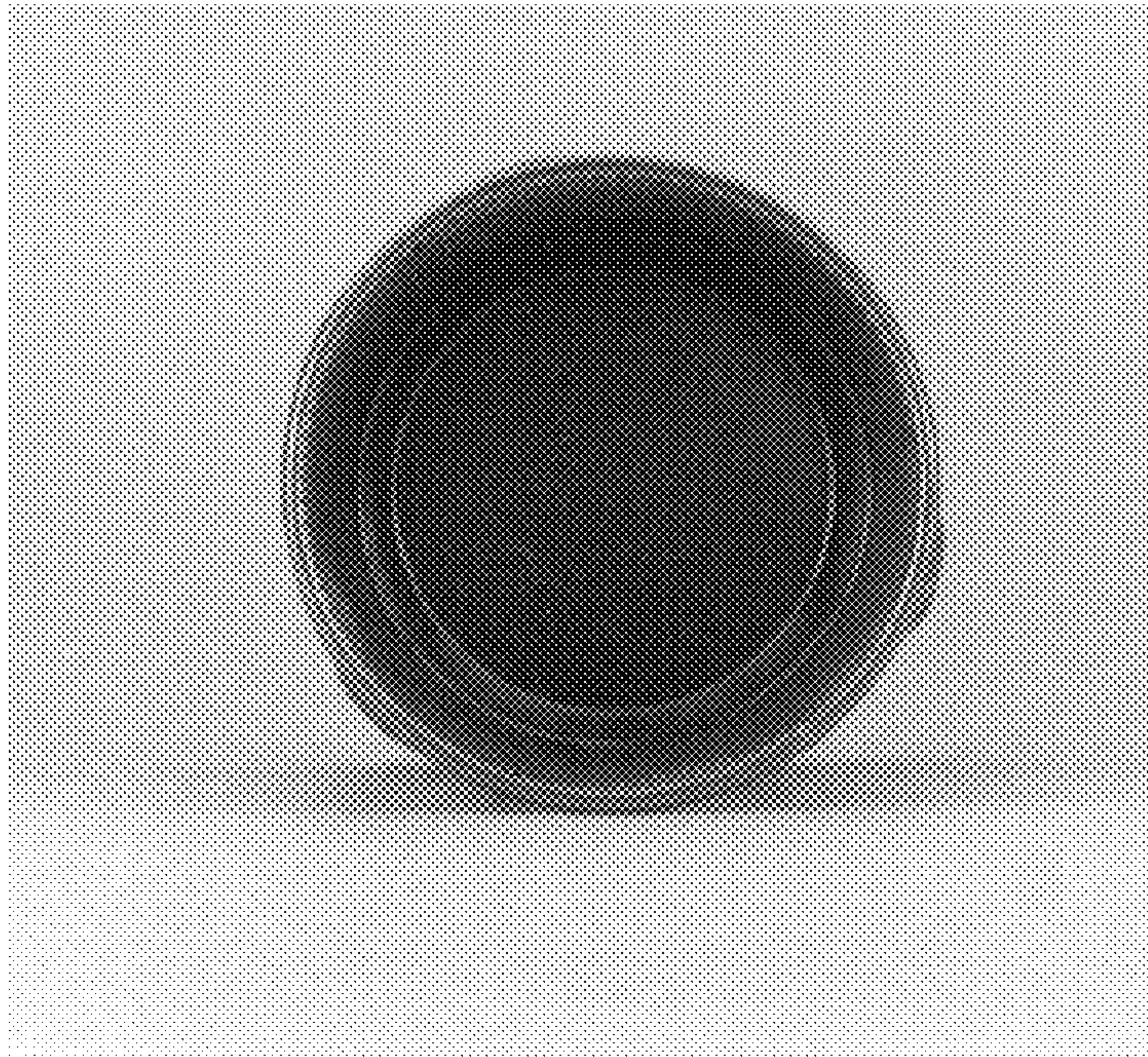

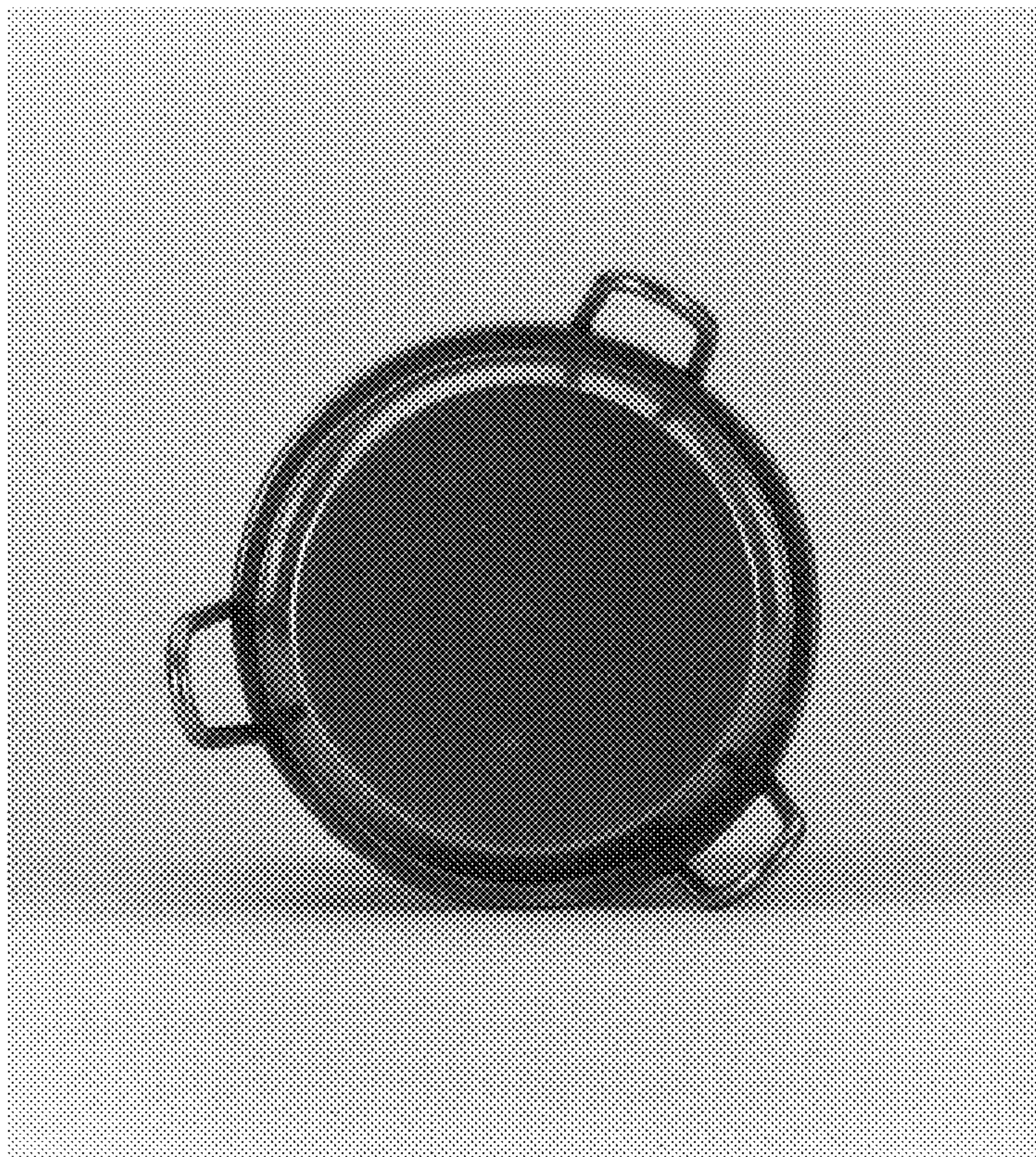
