[57] CLAIM

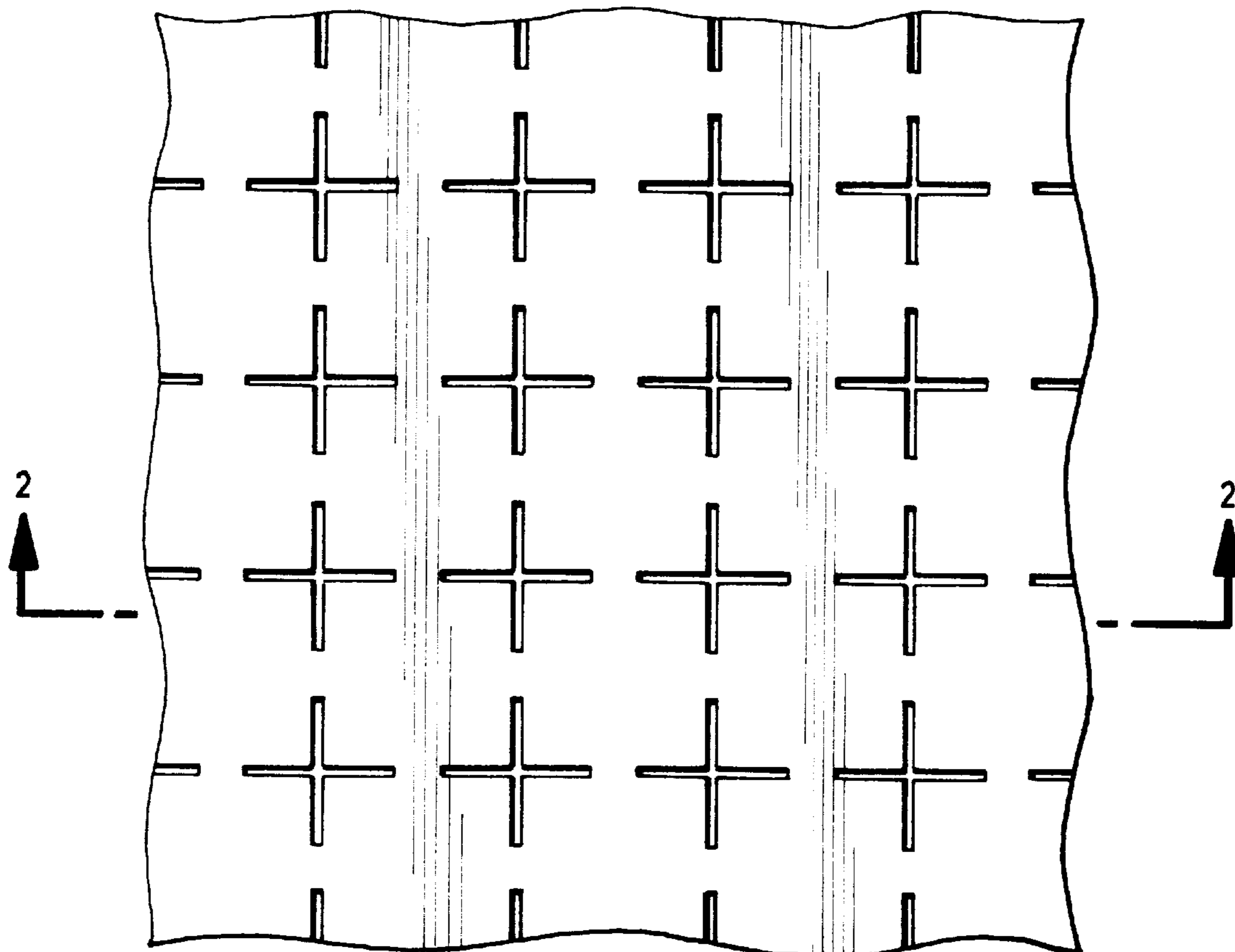
We claim the ornamental design for an absorbent paper product, as shown and described.

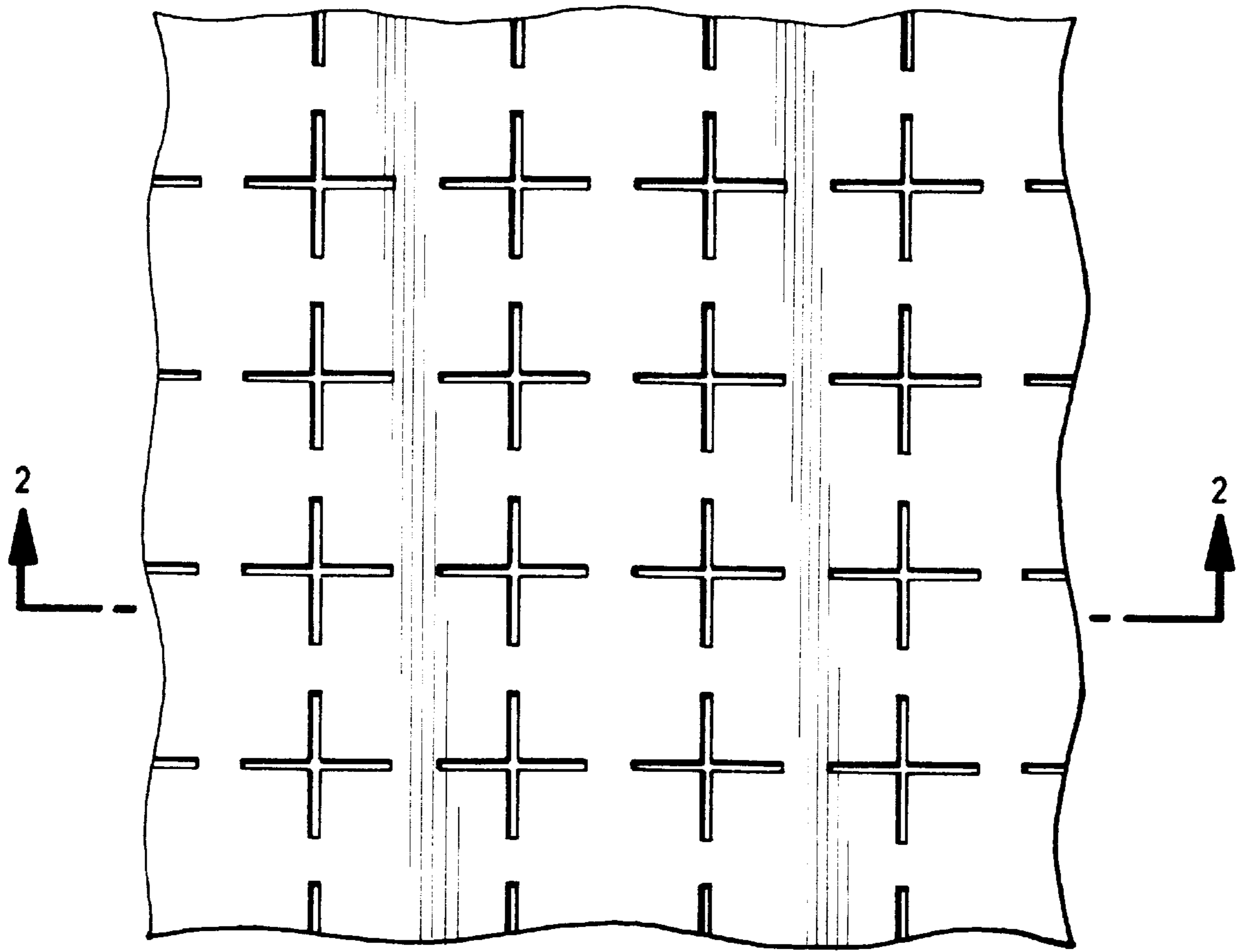
