The ornamental design for a side chair frame, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the side chair frame comprising my new design;

FIG. 4 is a side elevational view thereof, the opposite elevational view being a mirror image;

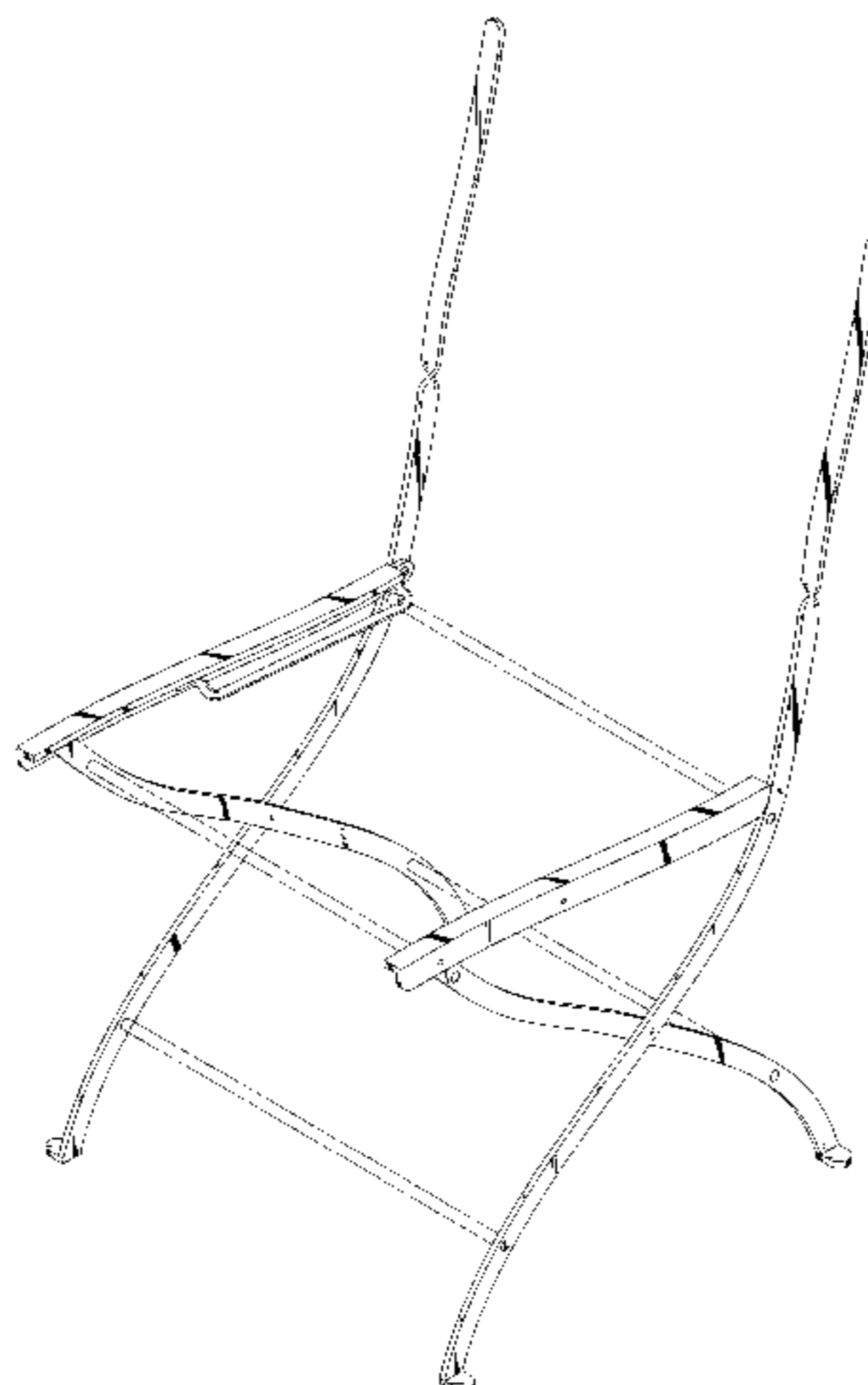
FIG. 5 is a back elevational view thereof;

FIG. 6 is a bottom view thereof; and,

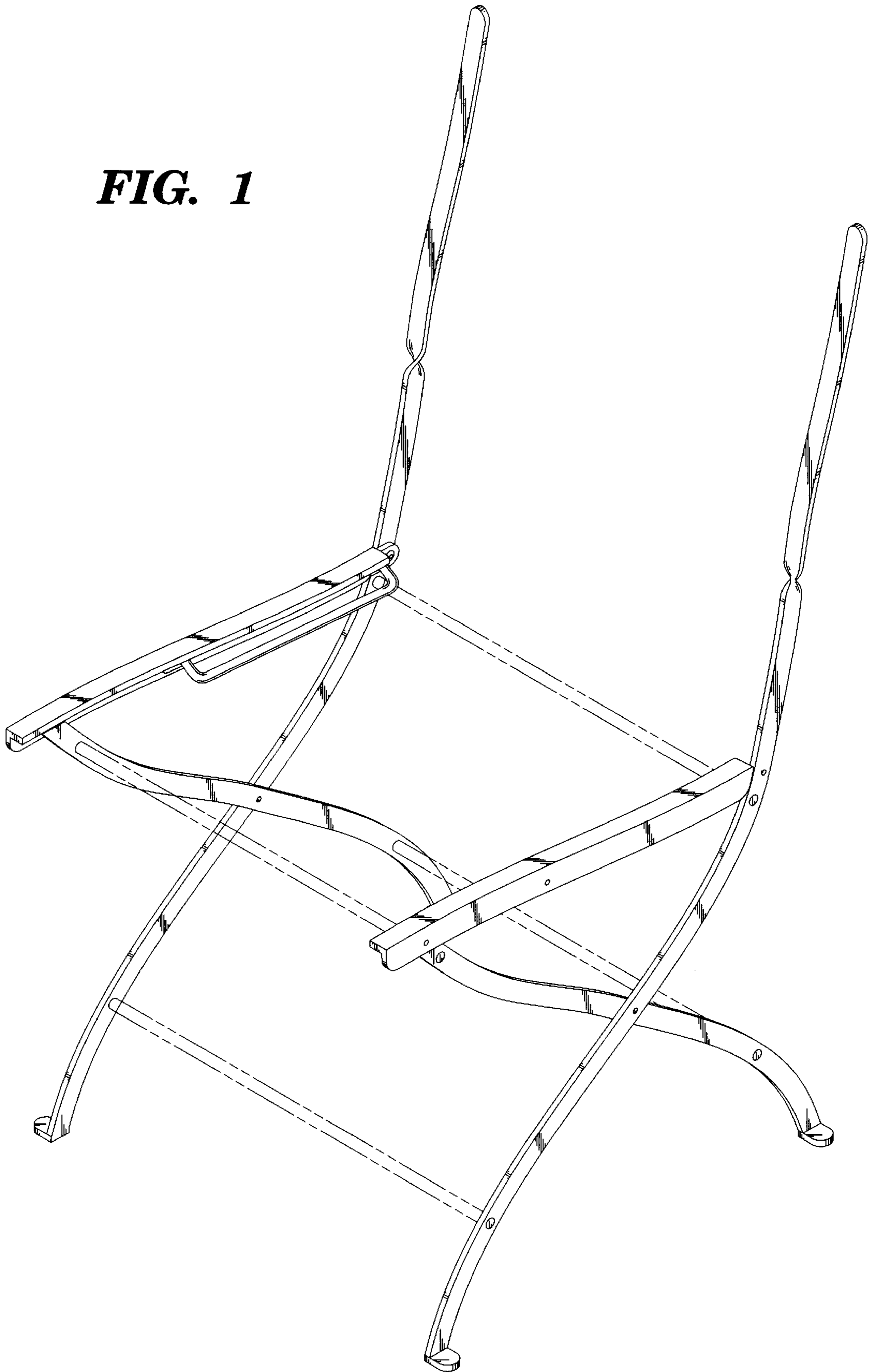
FIG. 7 is a side elevational view of the arm chair shown in folded condition.

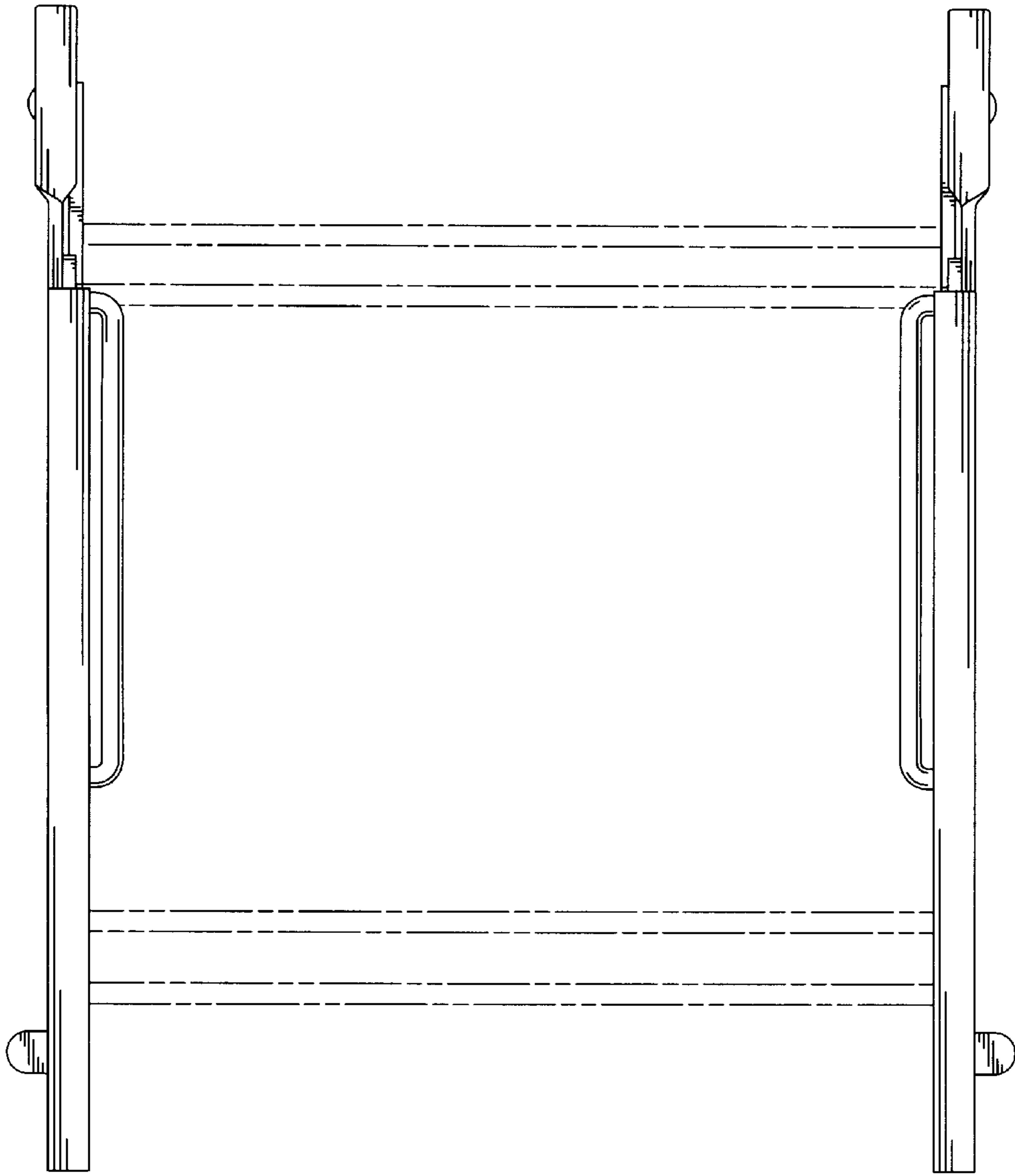

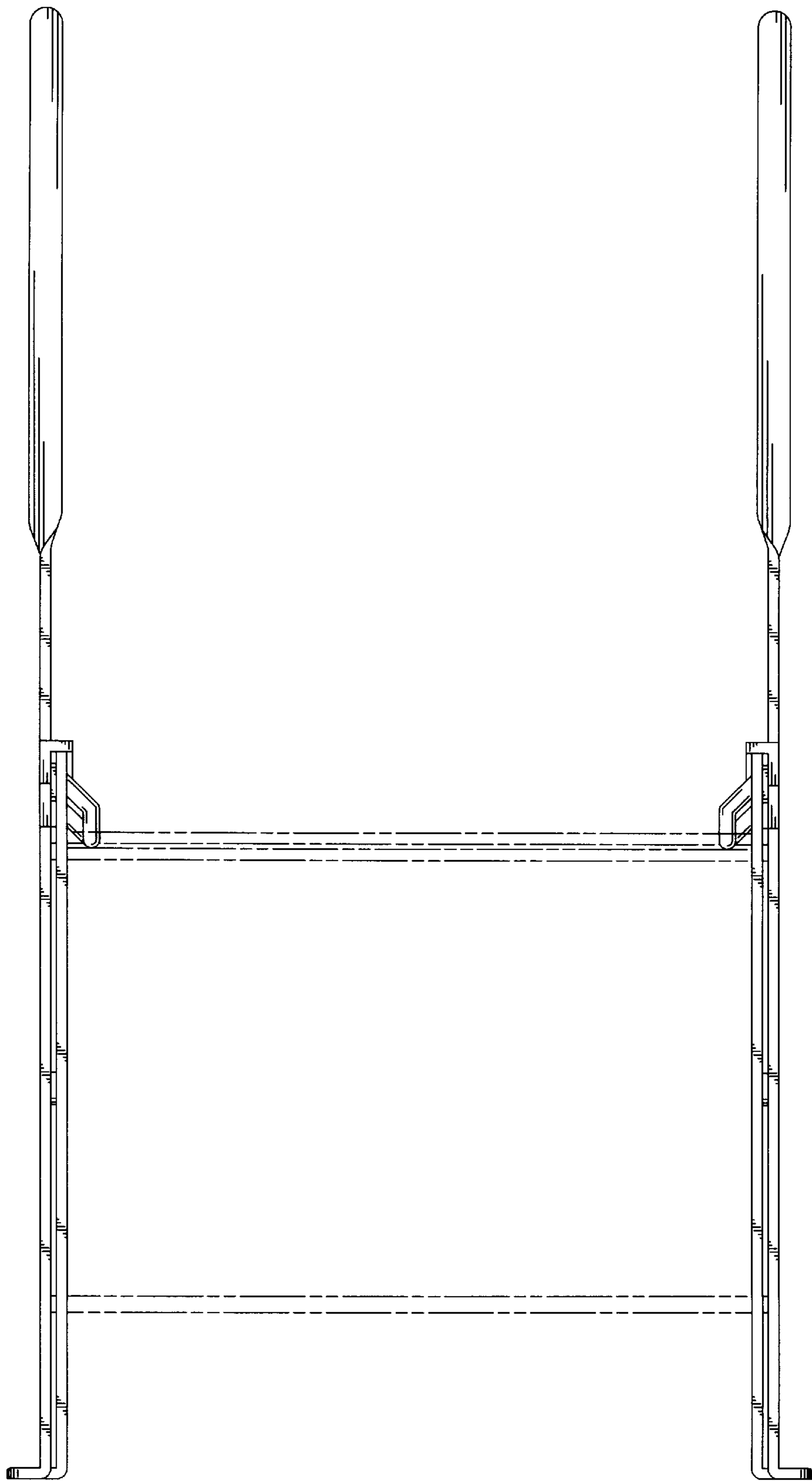

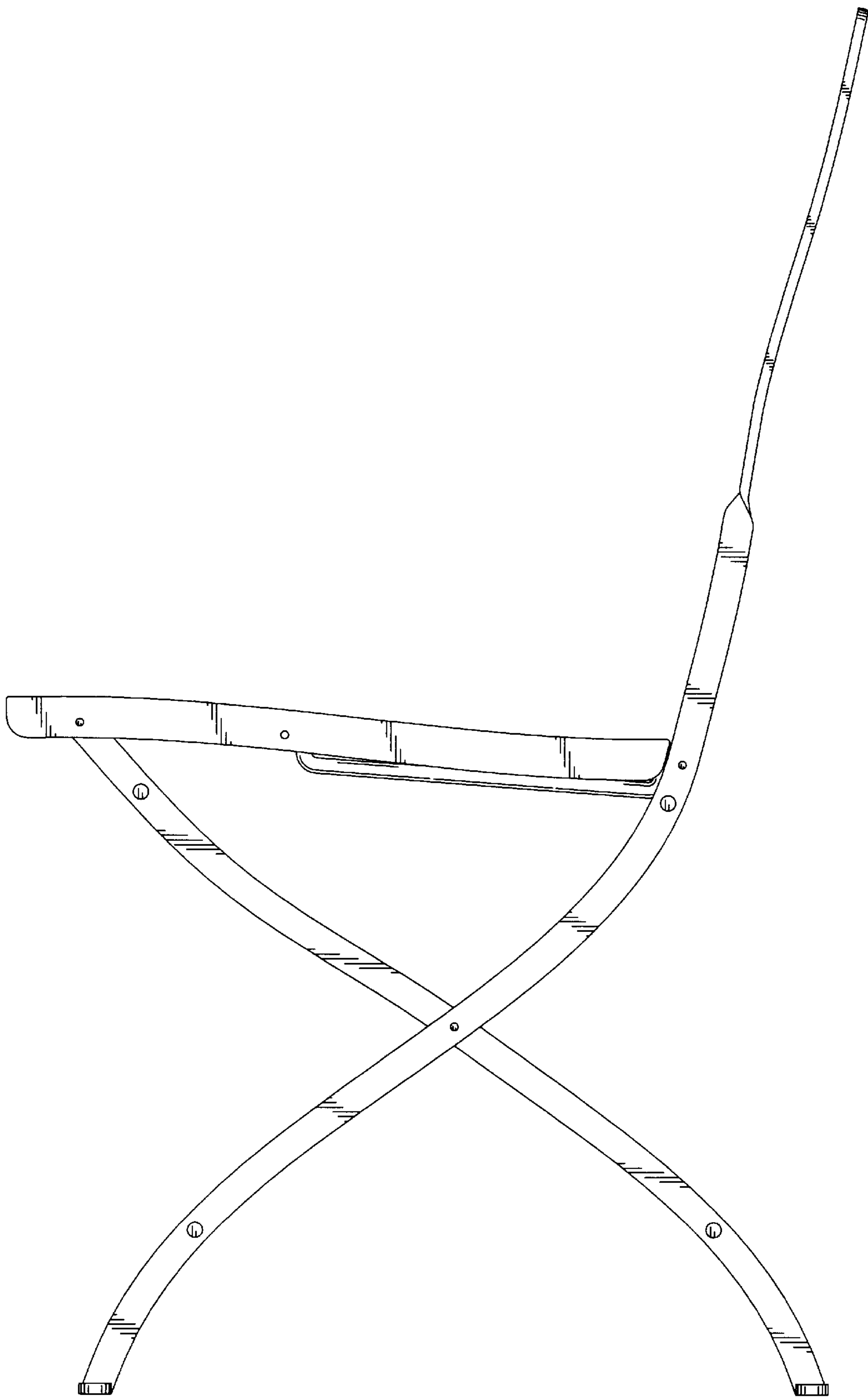




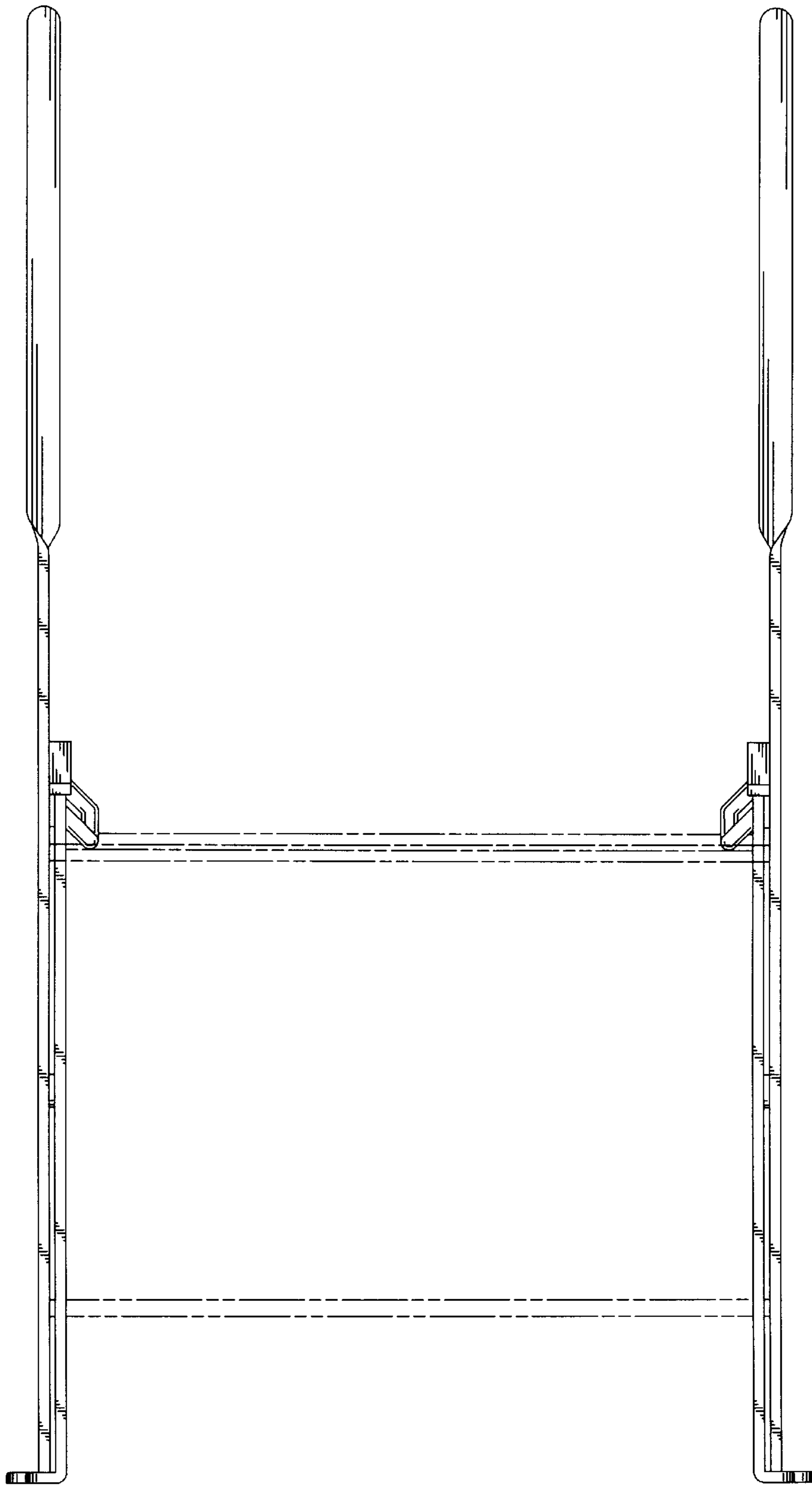

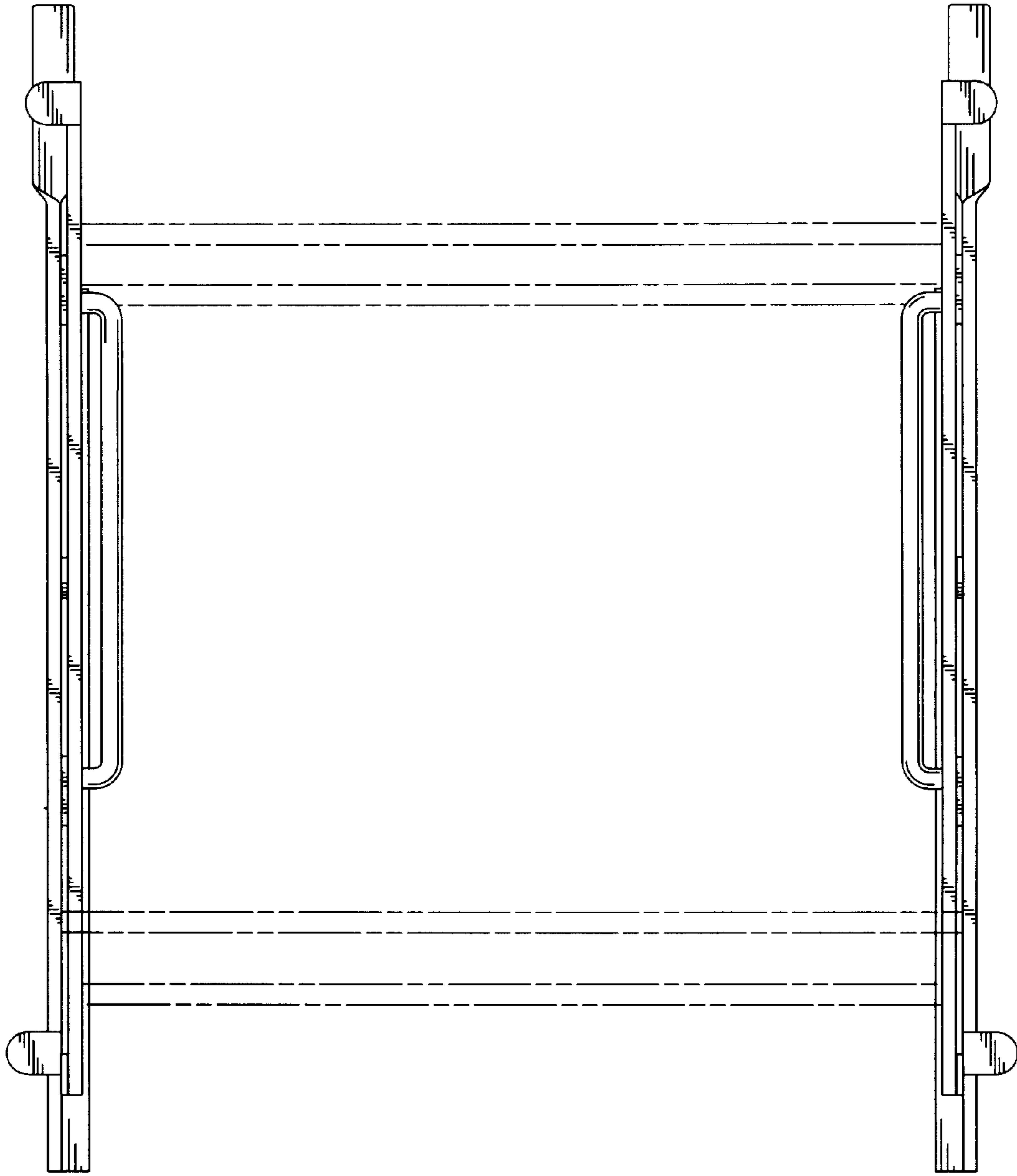

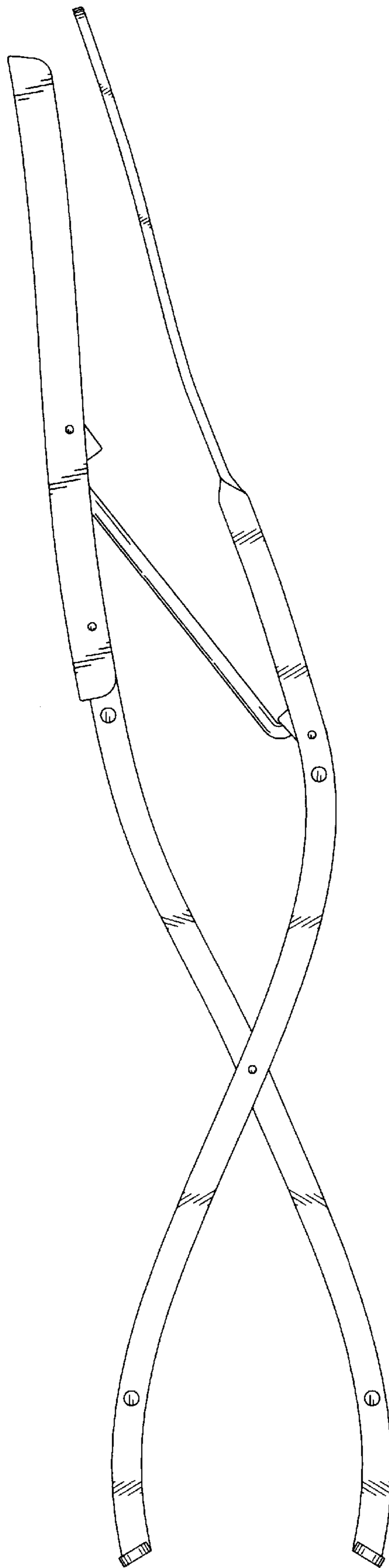
