DESCRIPTION

FIG. 1 is a left perspective view of a bedstead showing my new design;

FIG. 2 is a side view, the opposite side being a mirror image thereof;

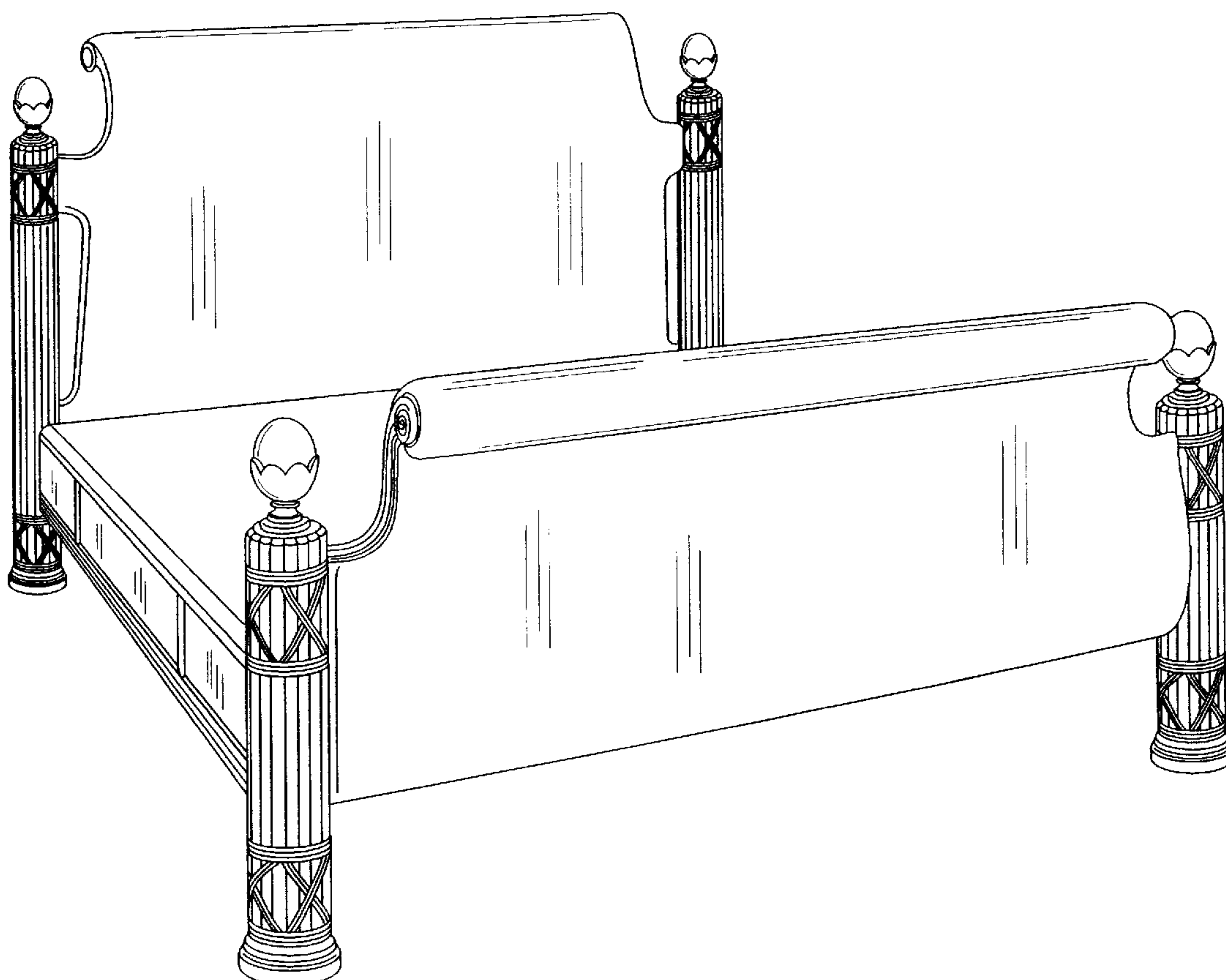
FIG. 3 is a front view of the headboard section thereof;

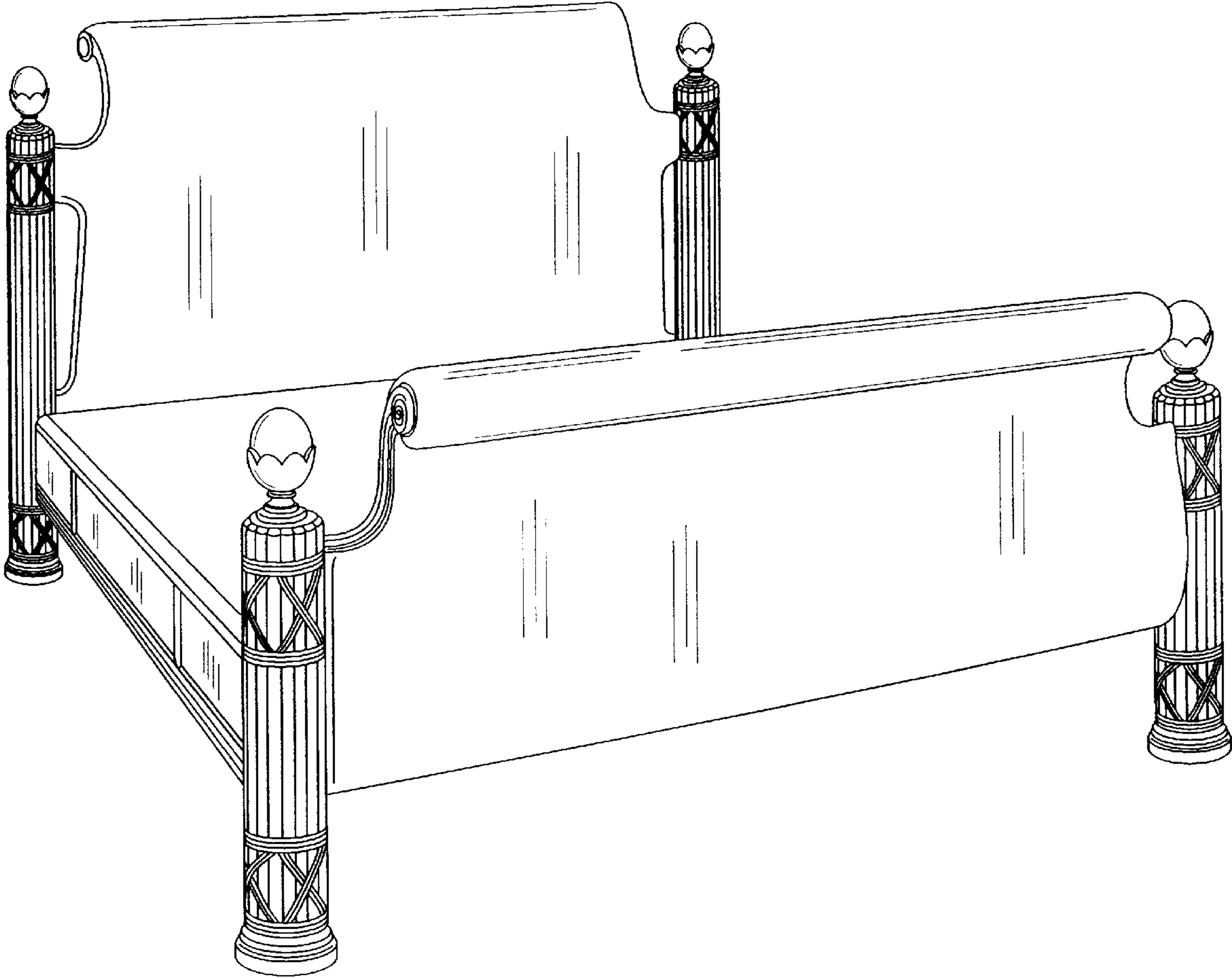

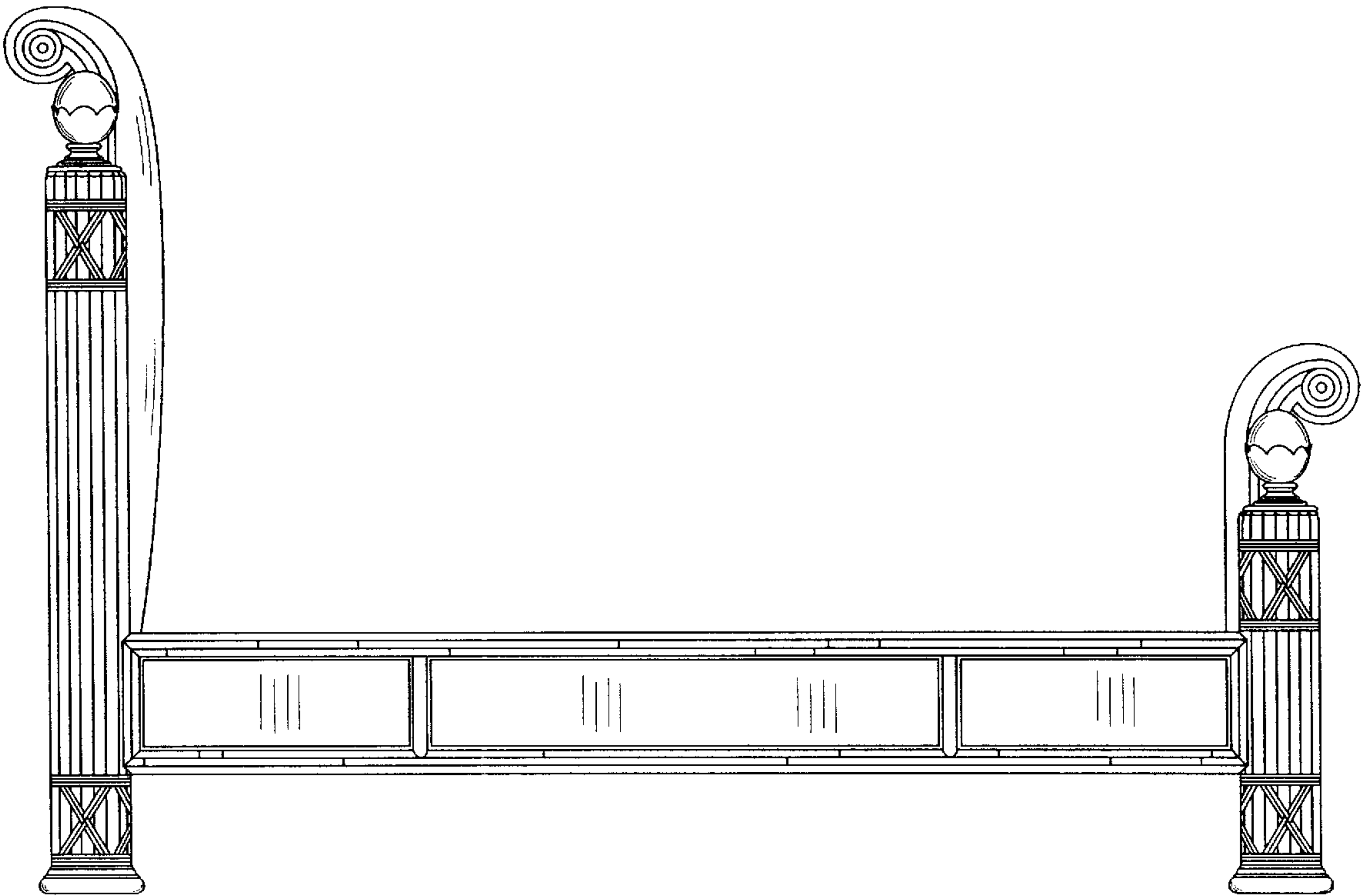

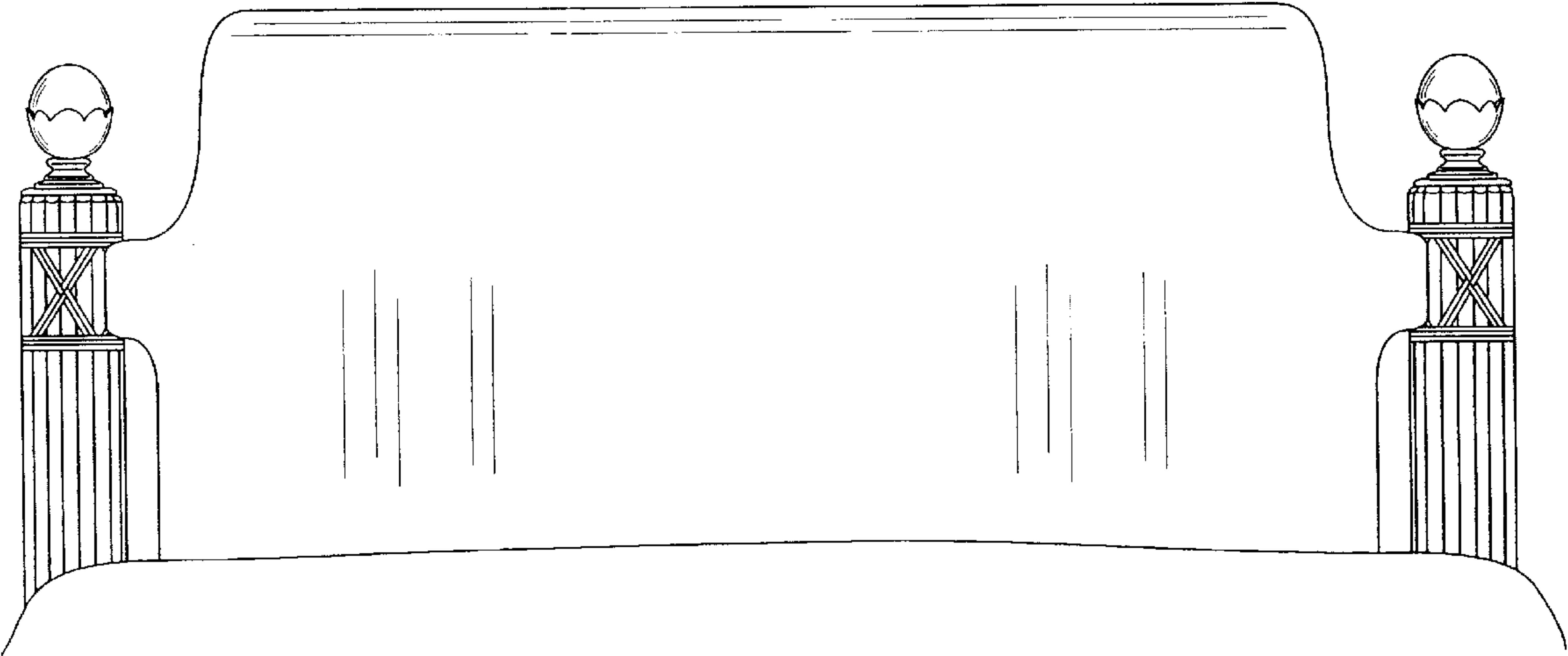

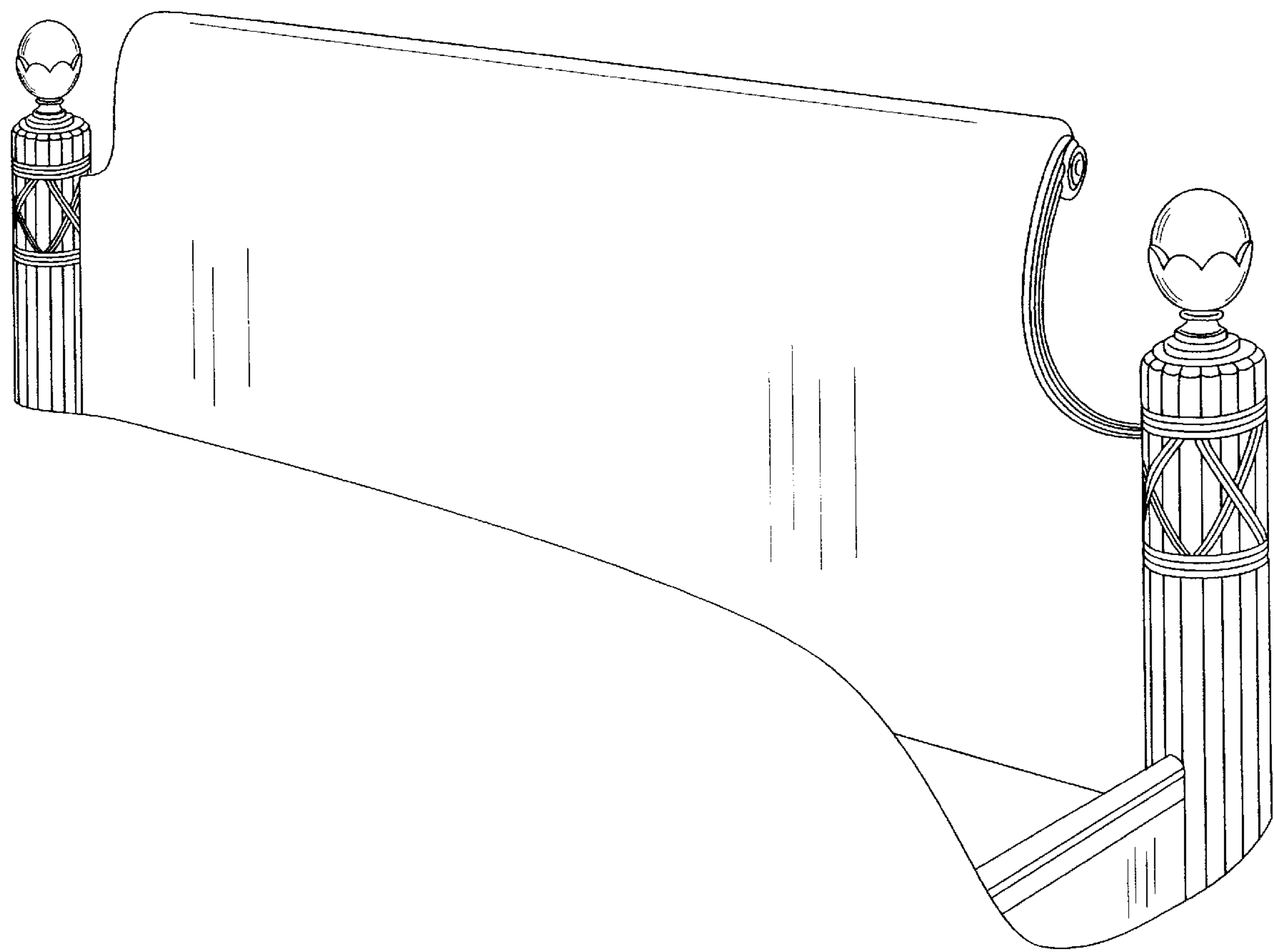

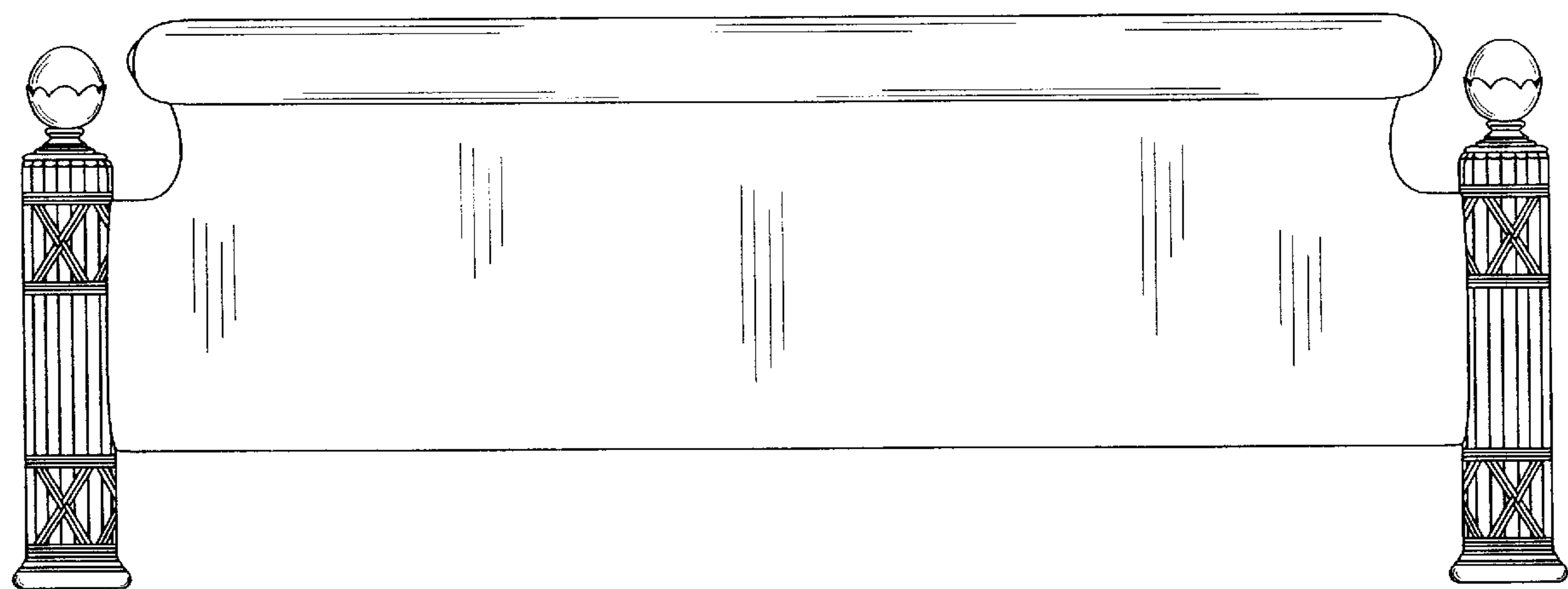
