FIG. 11 is a right-side elevational view of FIG. 7;

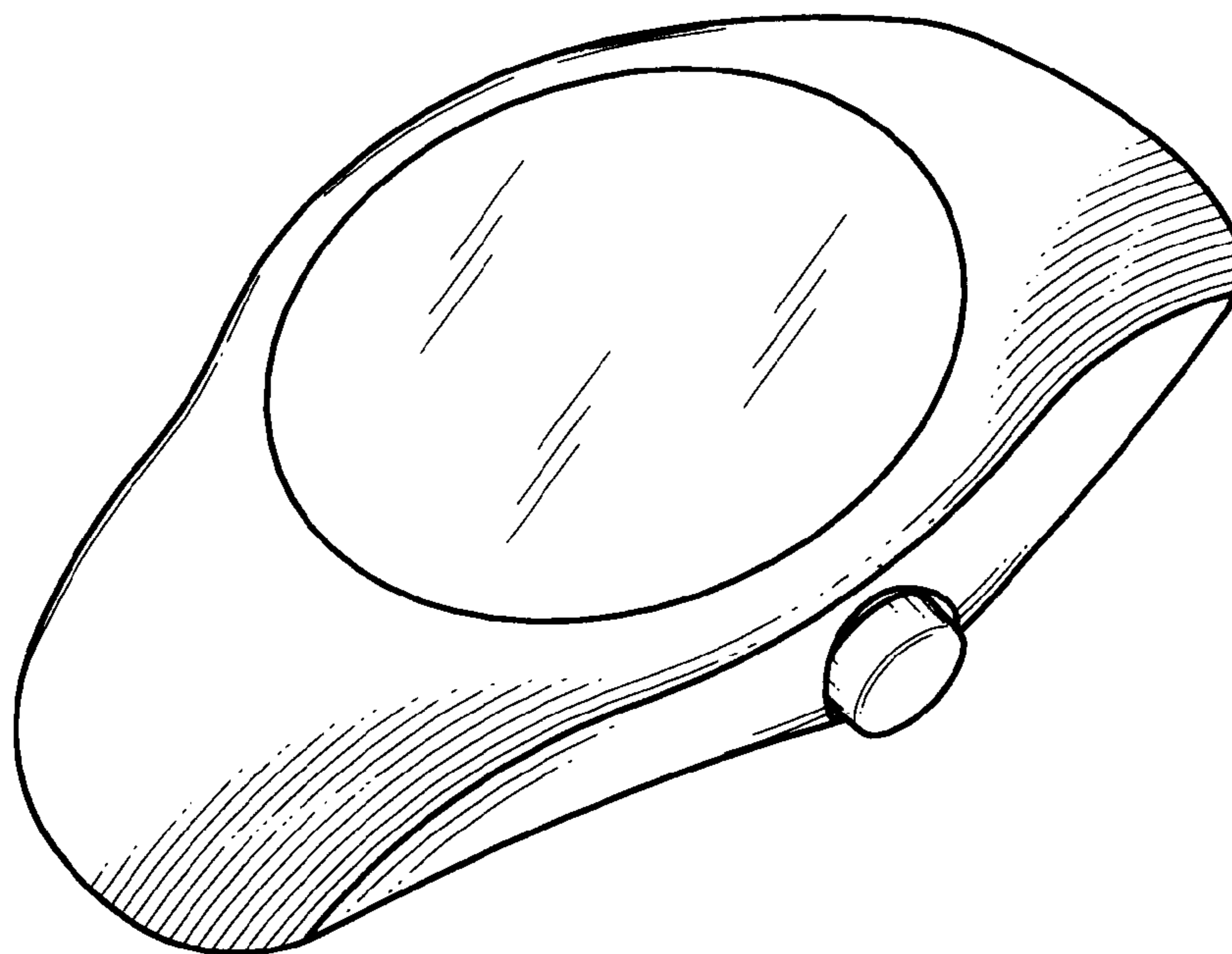
FIG. 12 is a left-side elevational view of FIG. 7;

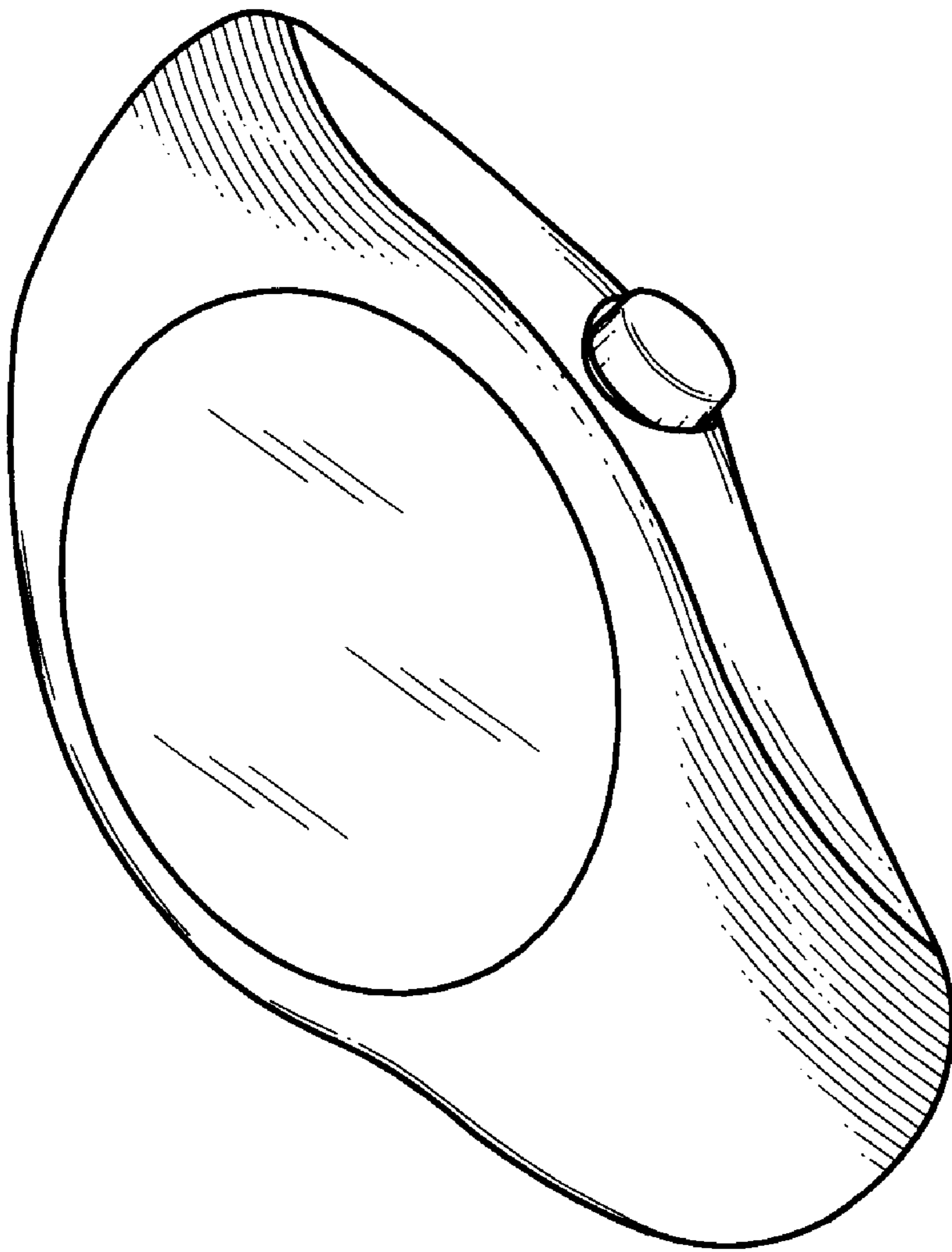

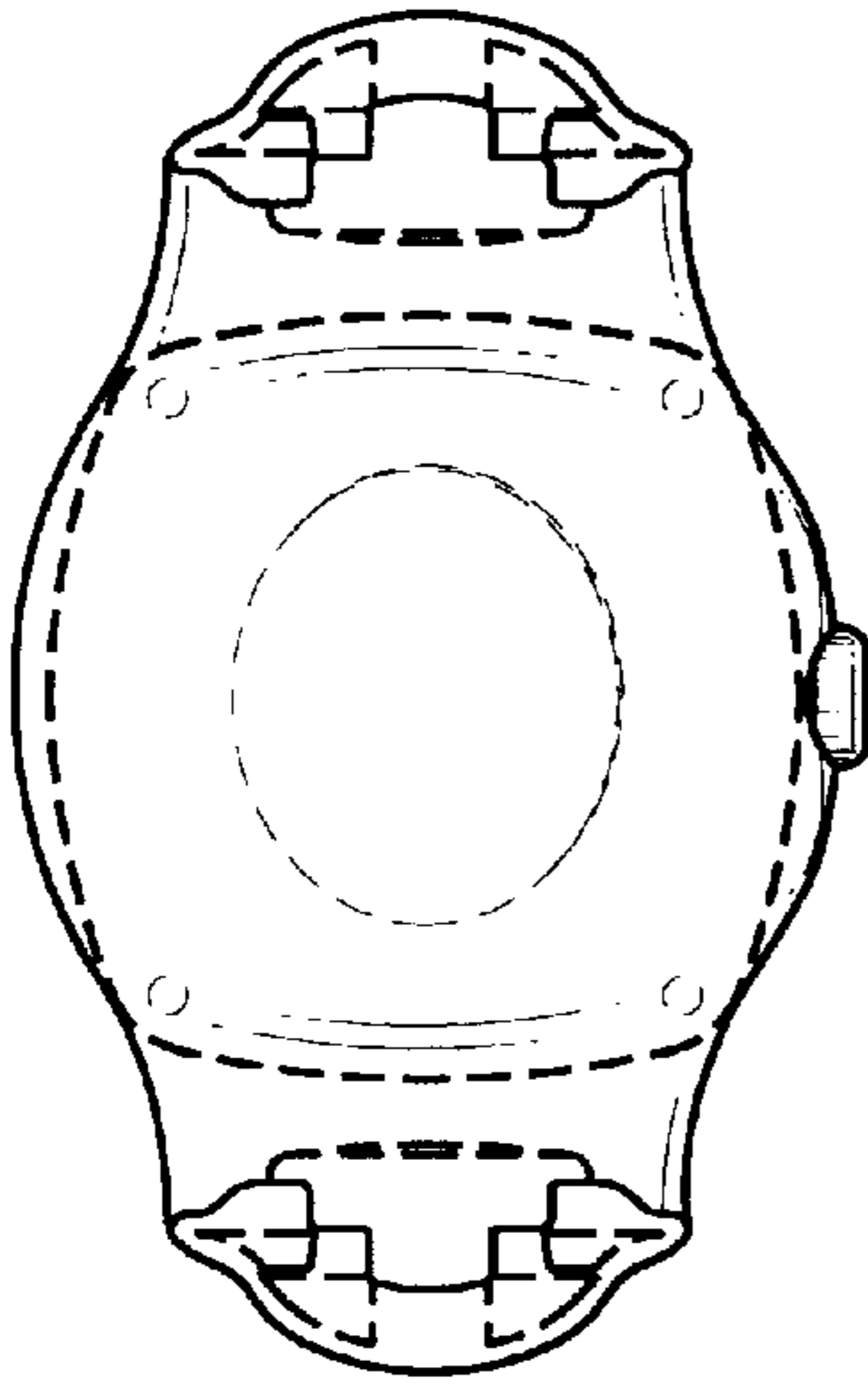

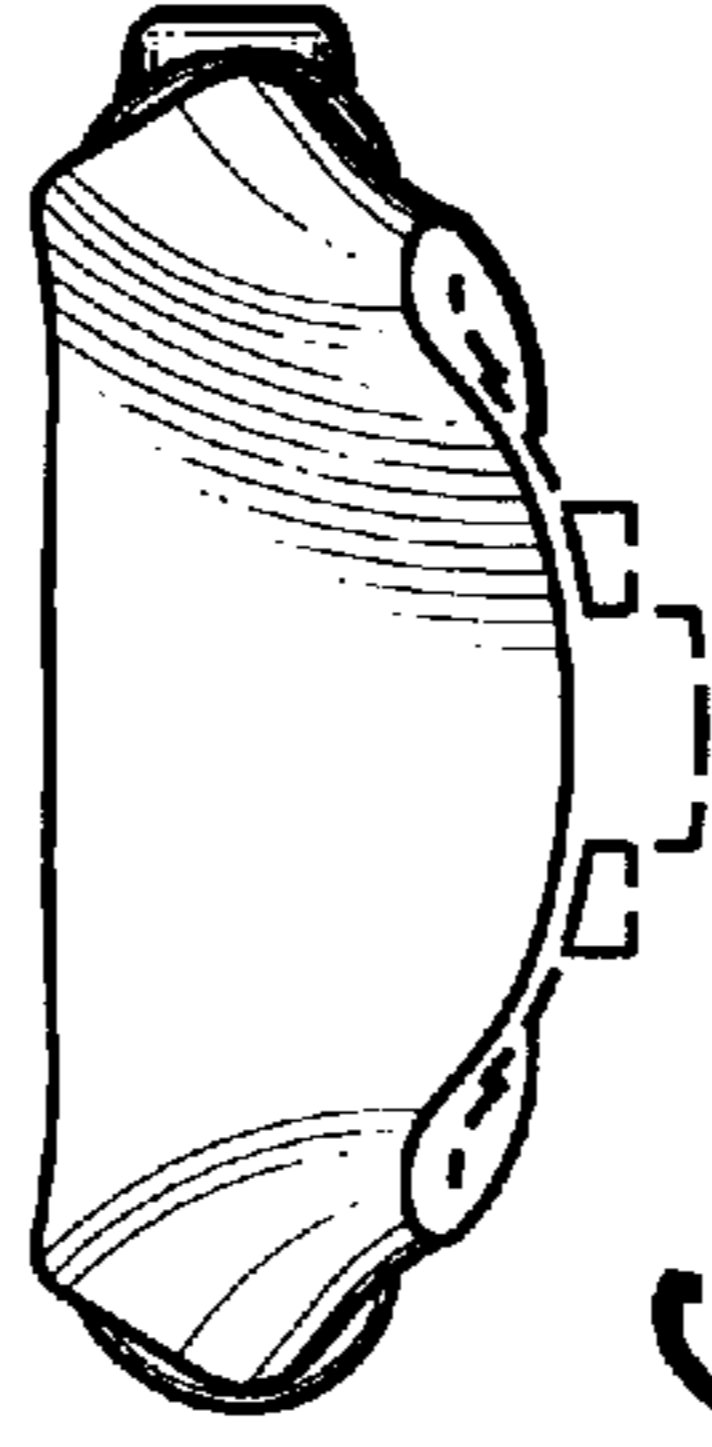

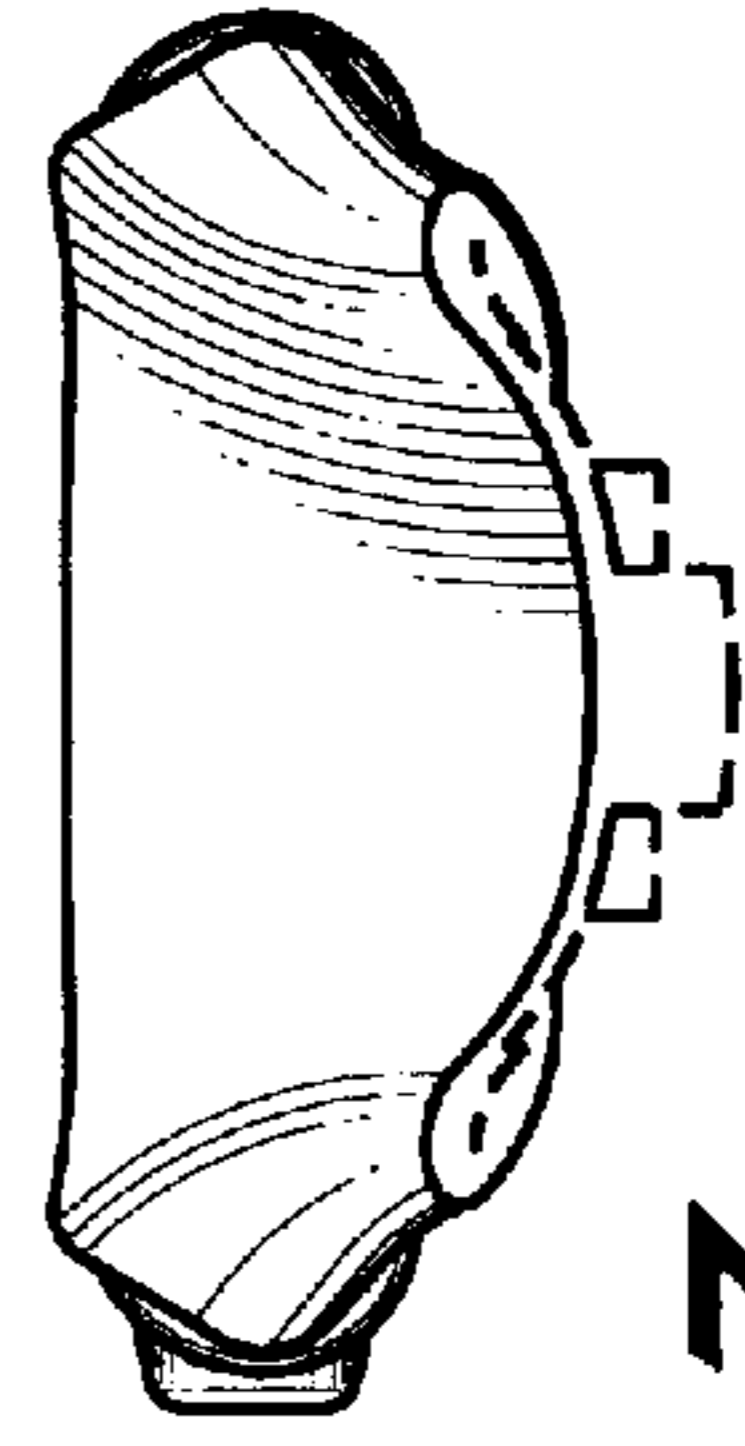

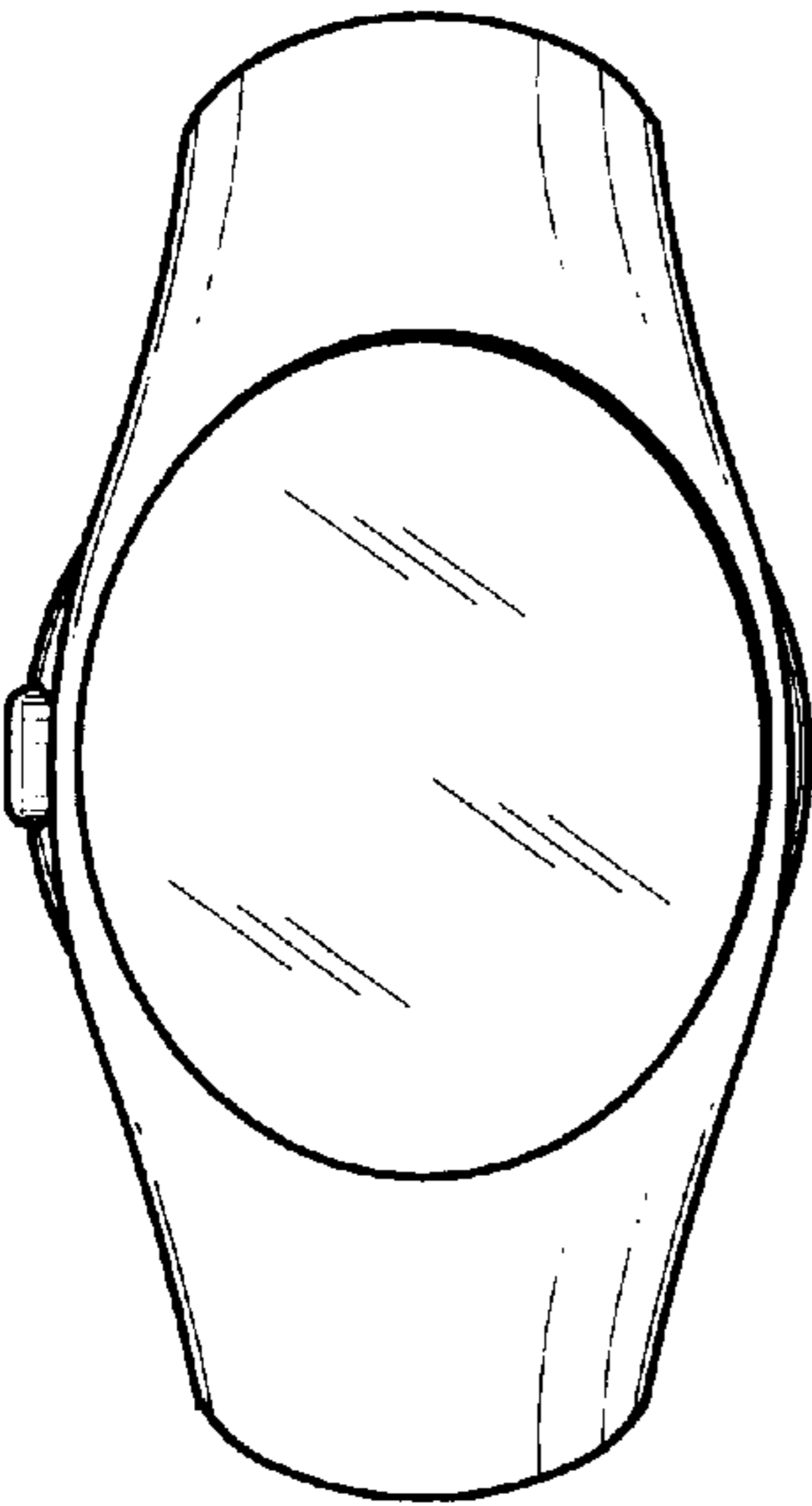

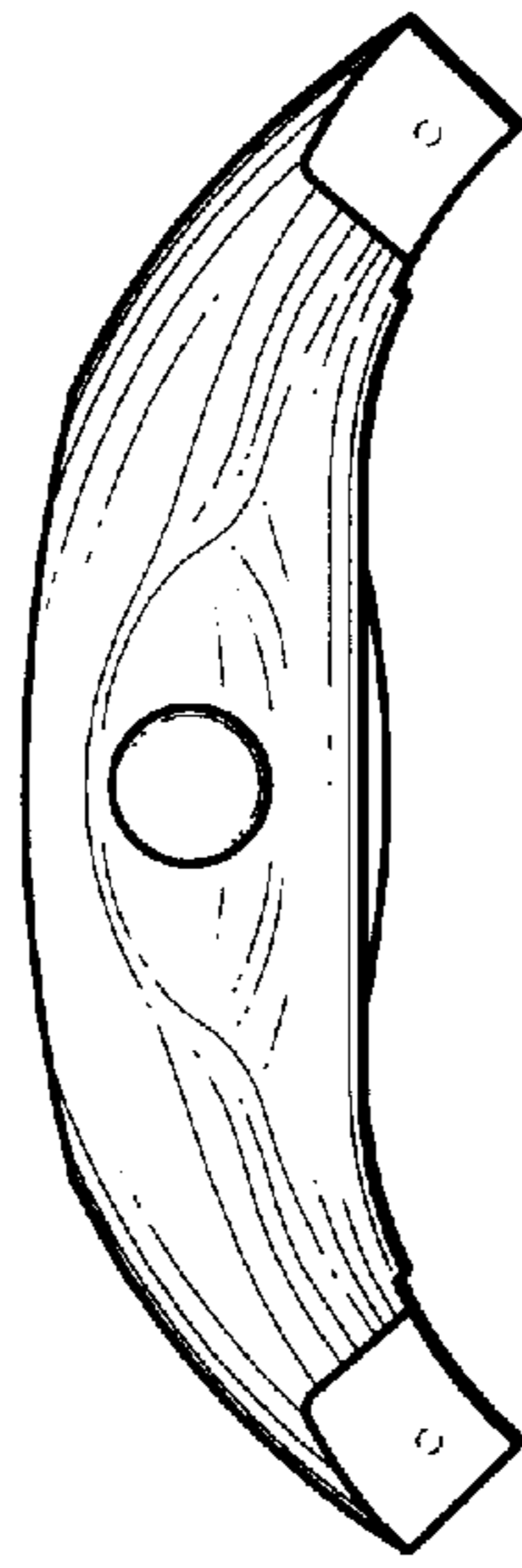

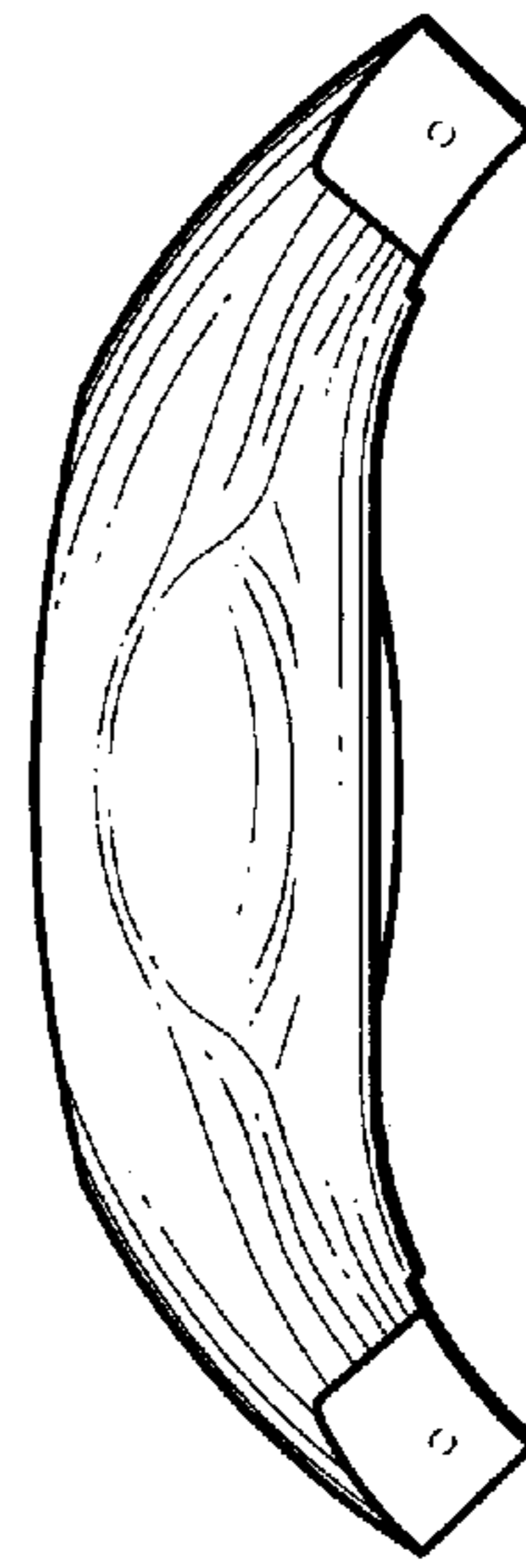

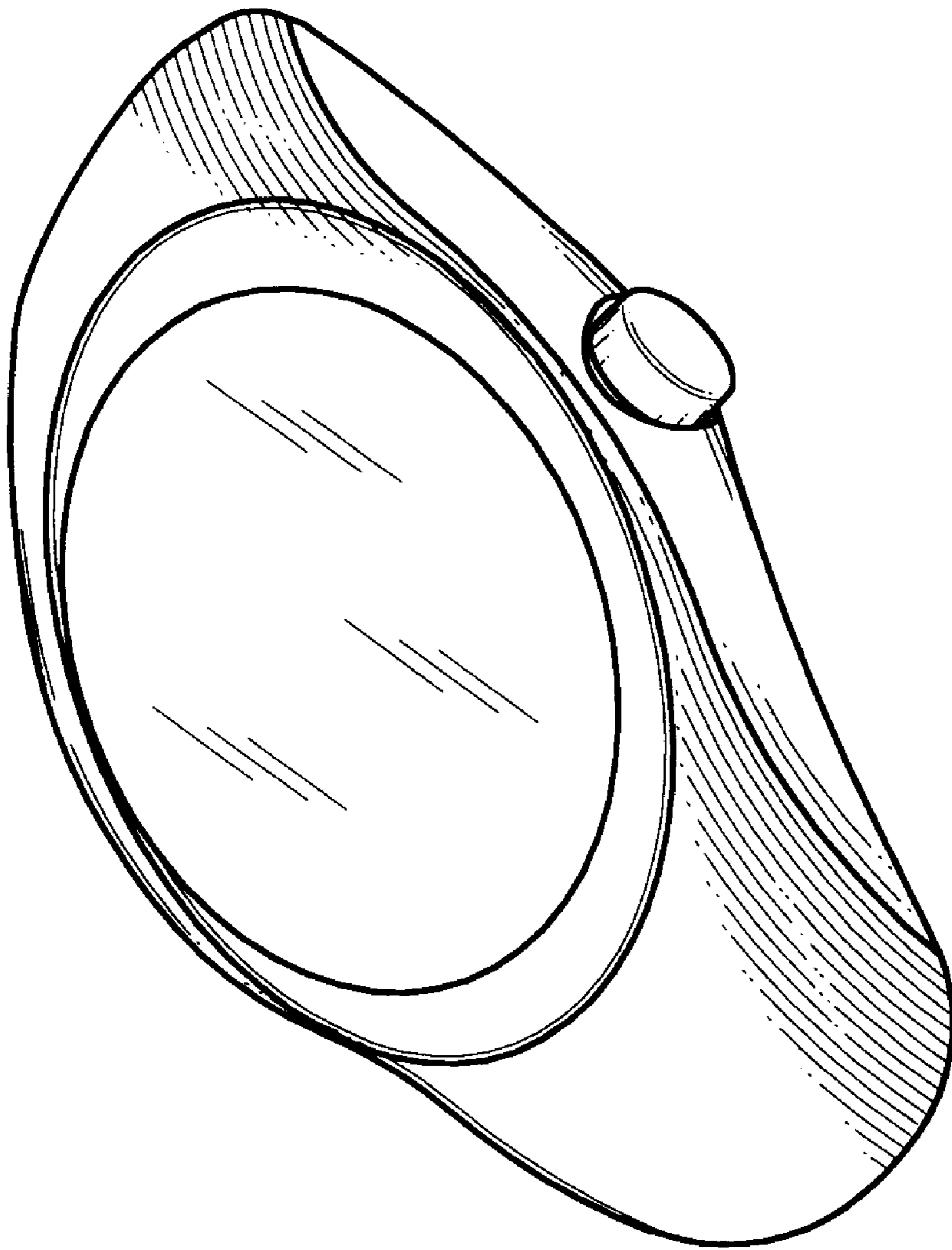

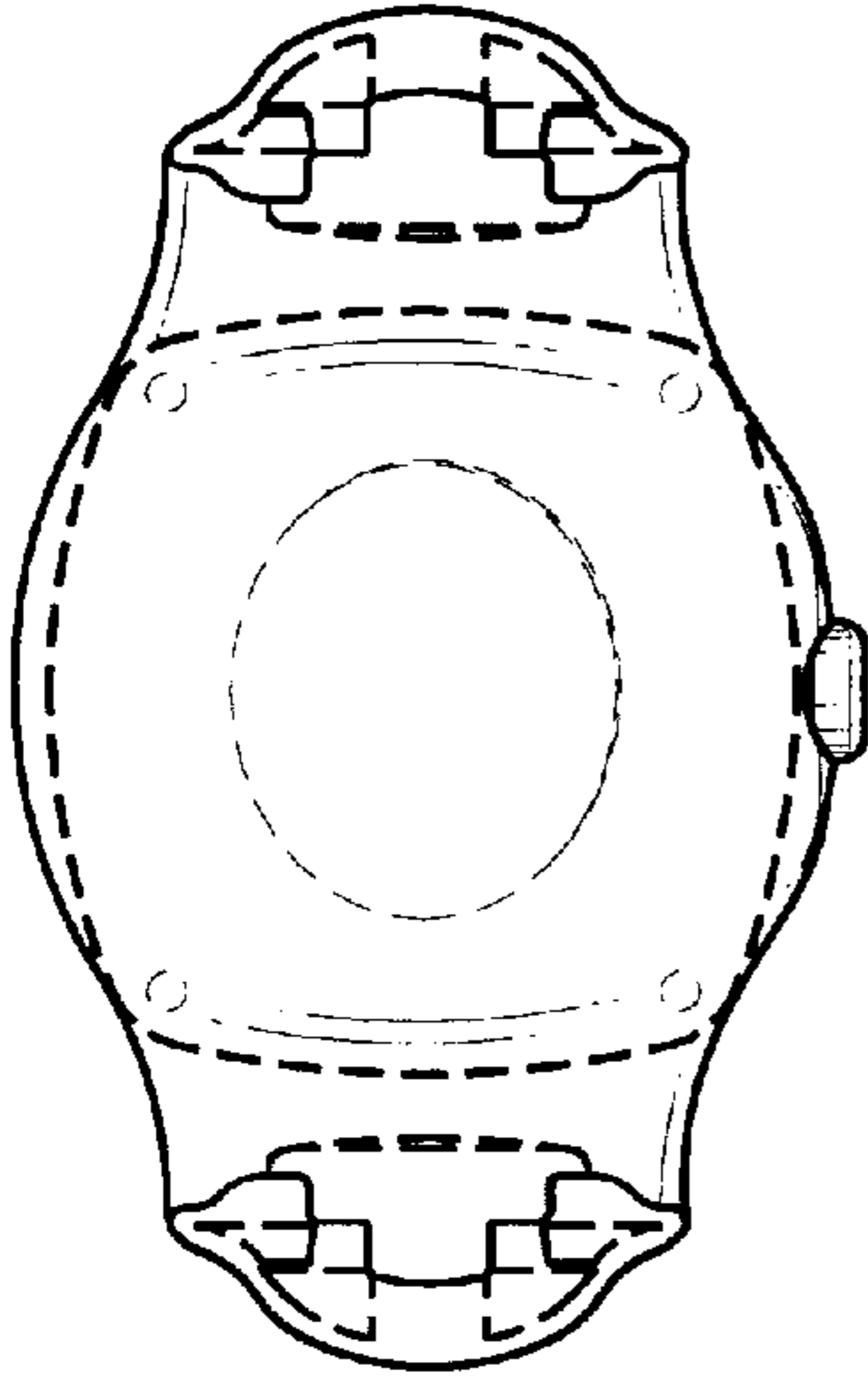

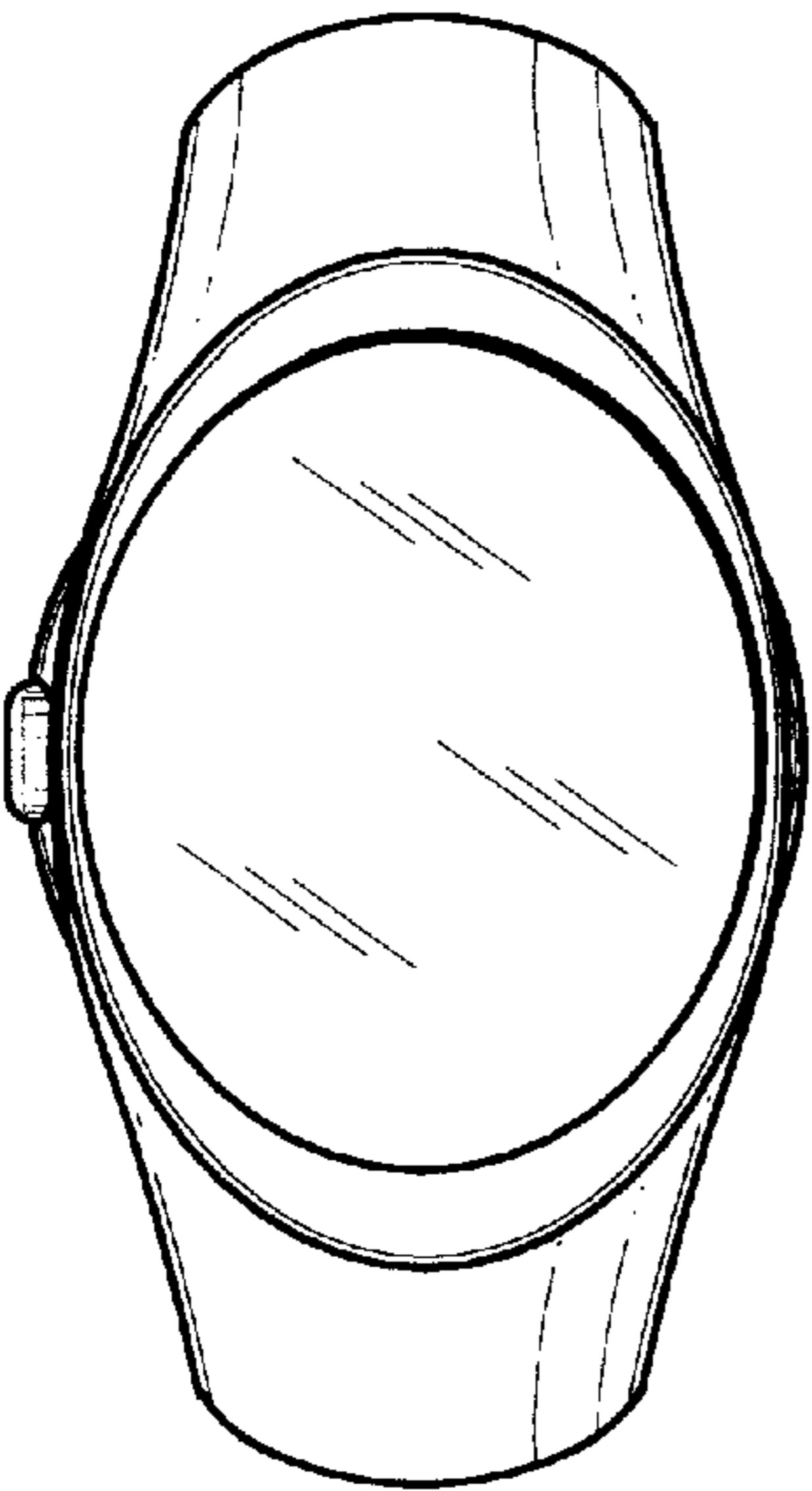

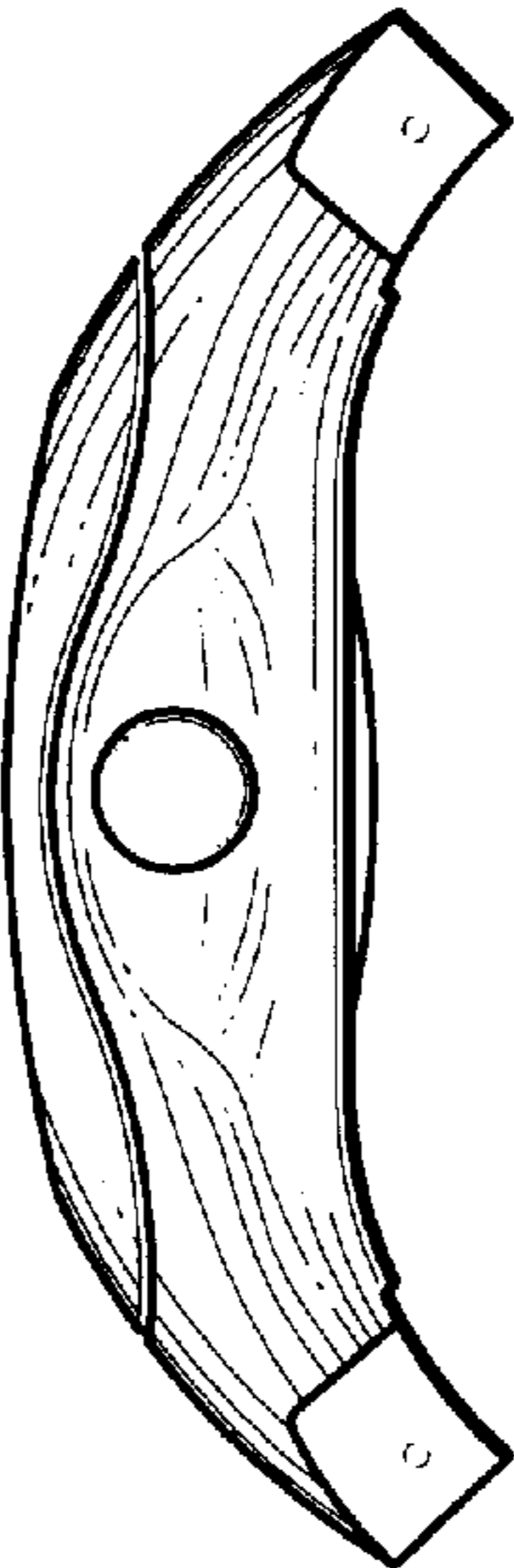

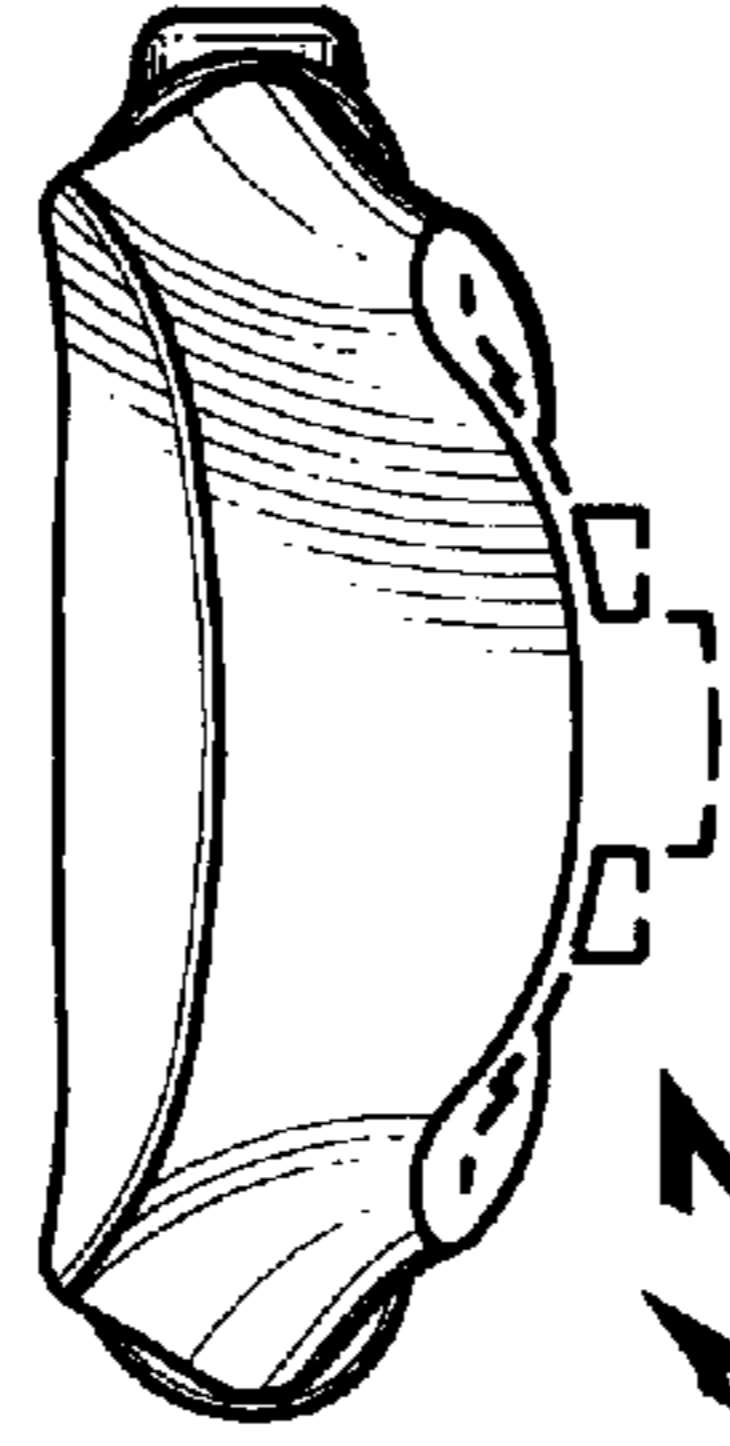

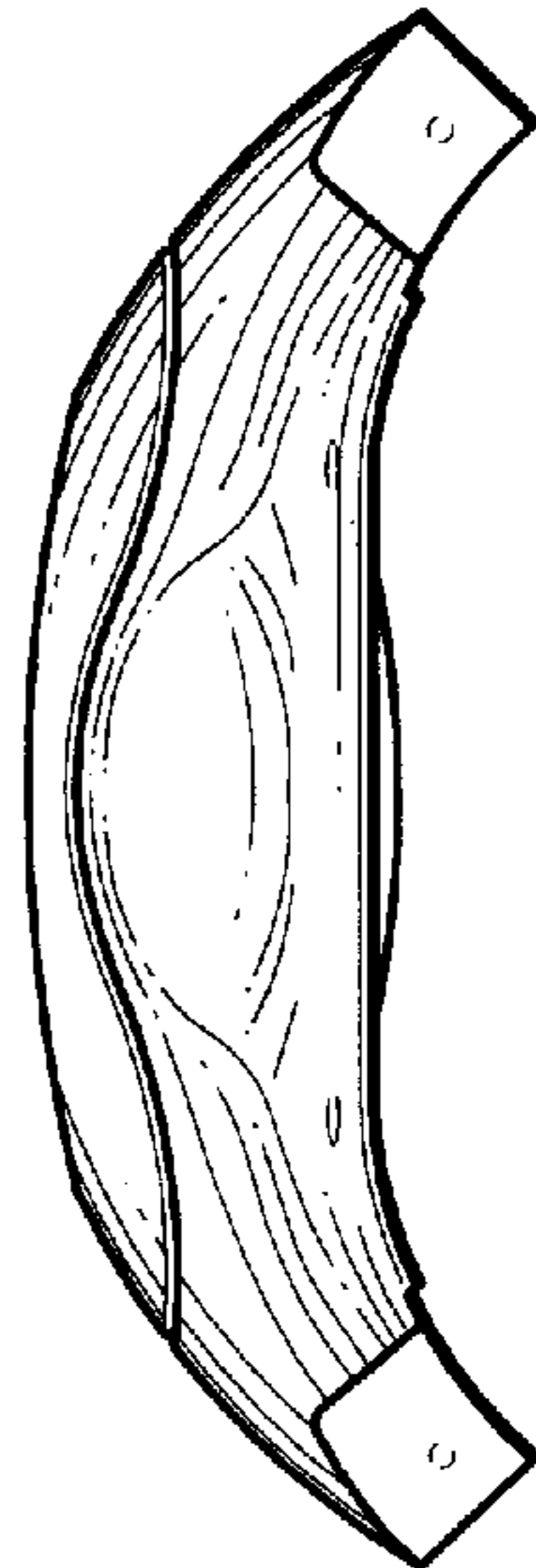

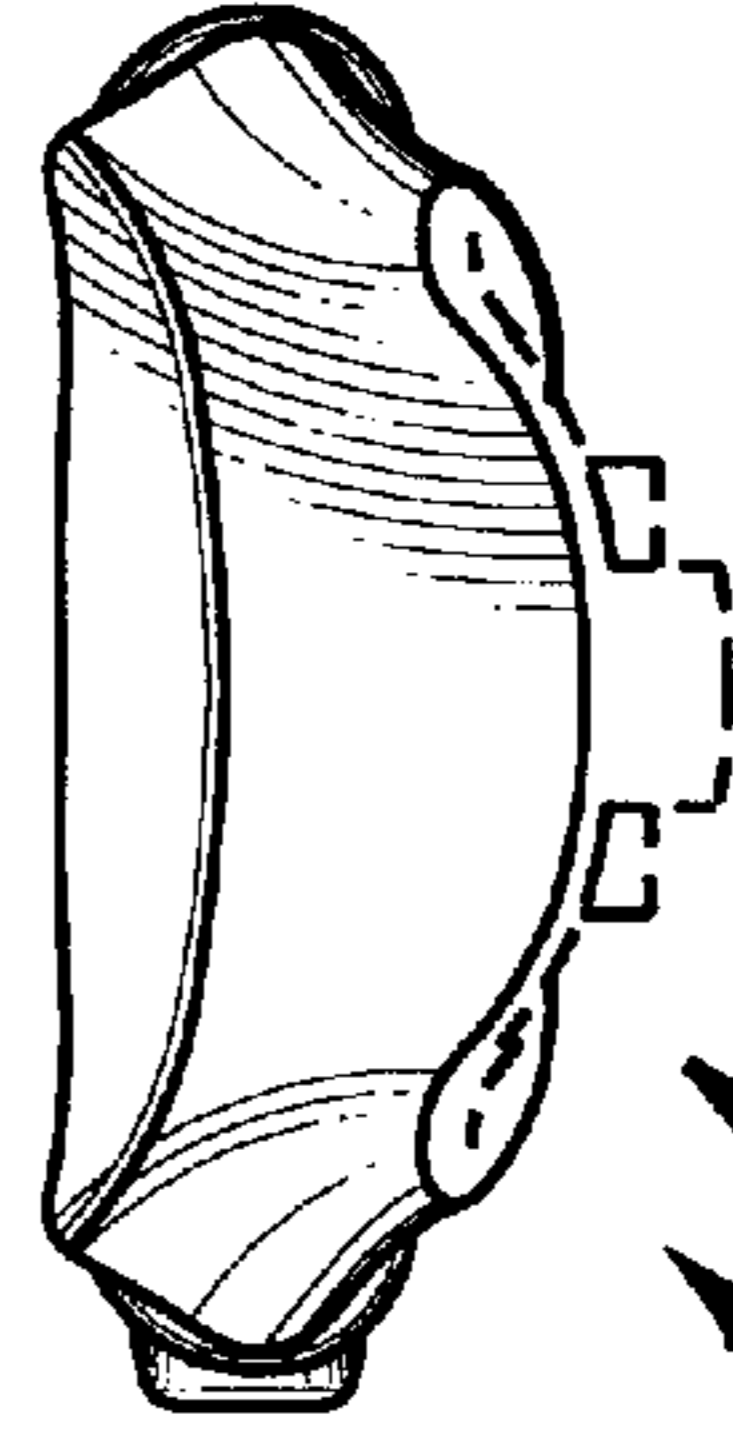
