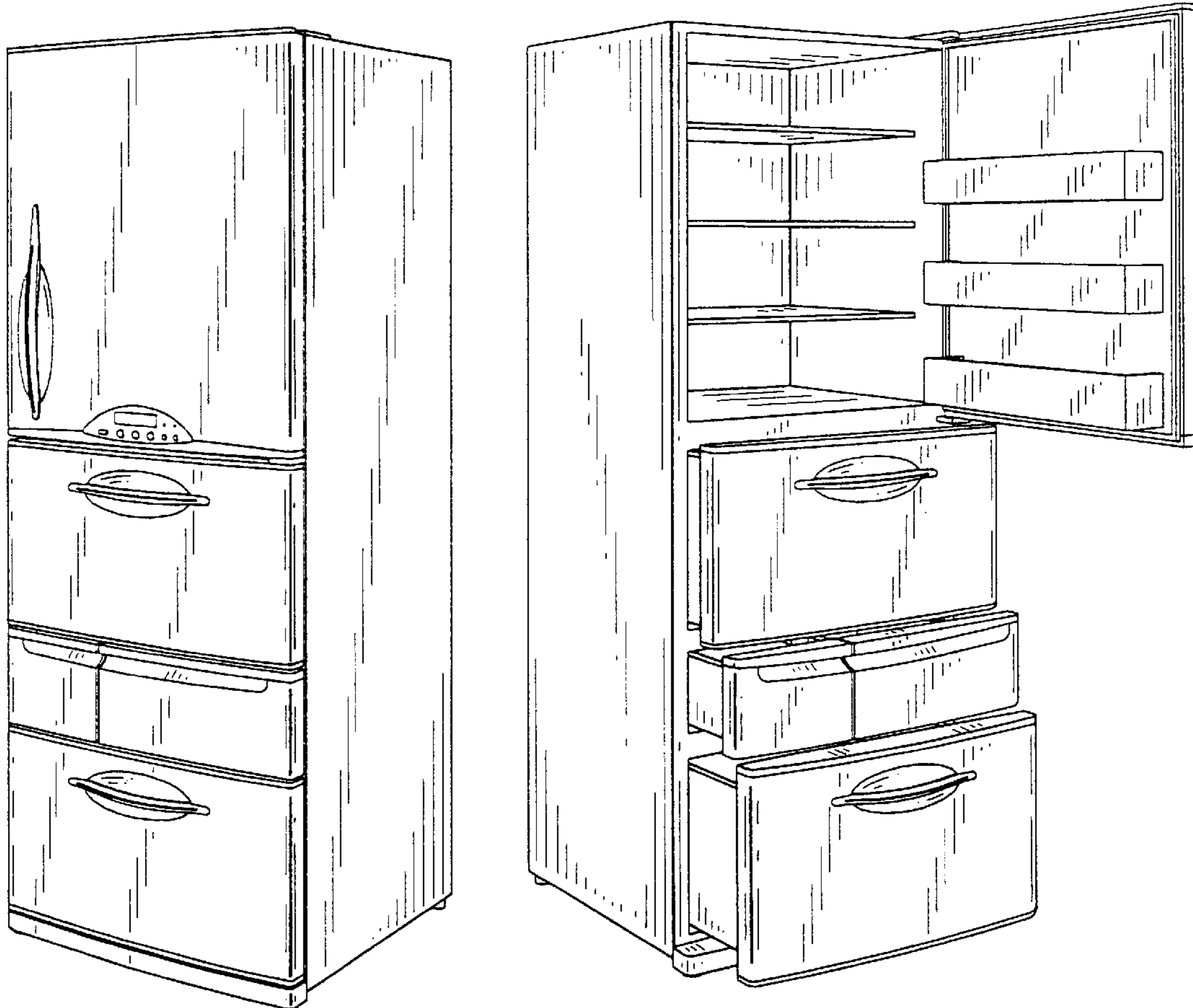

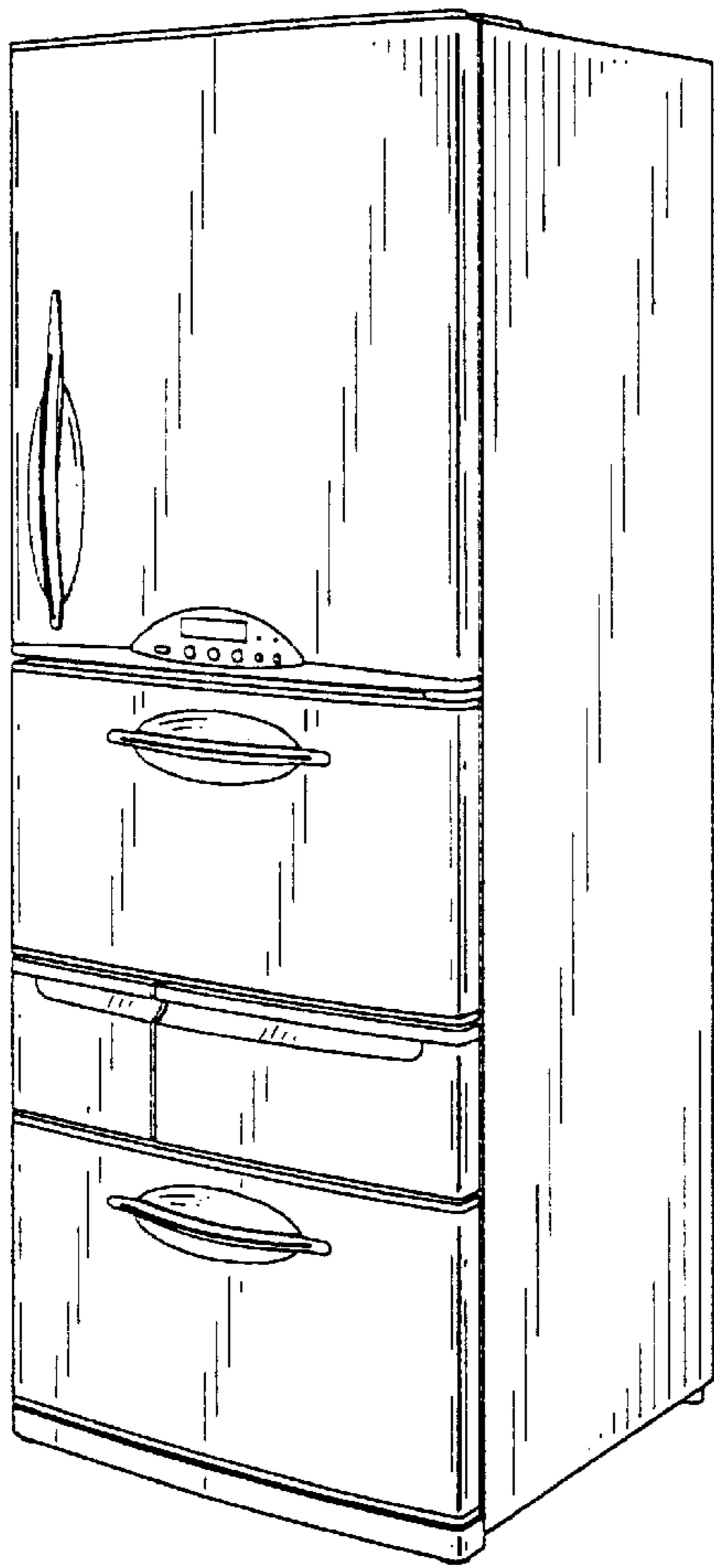
The ornamental design for refrigerator, as shown and described.

**DESCRIPTION**

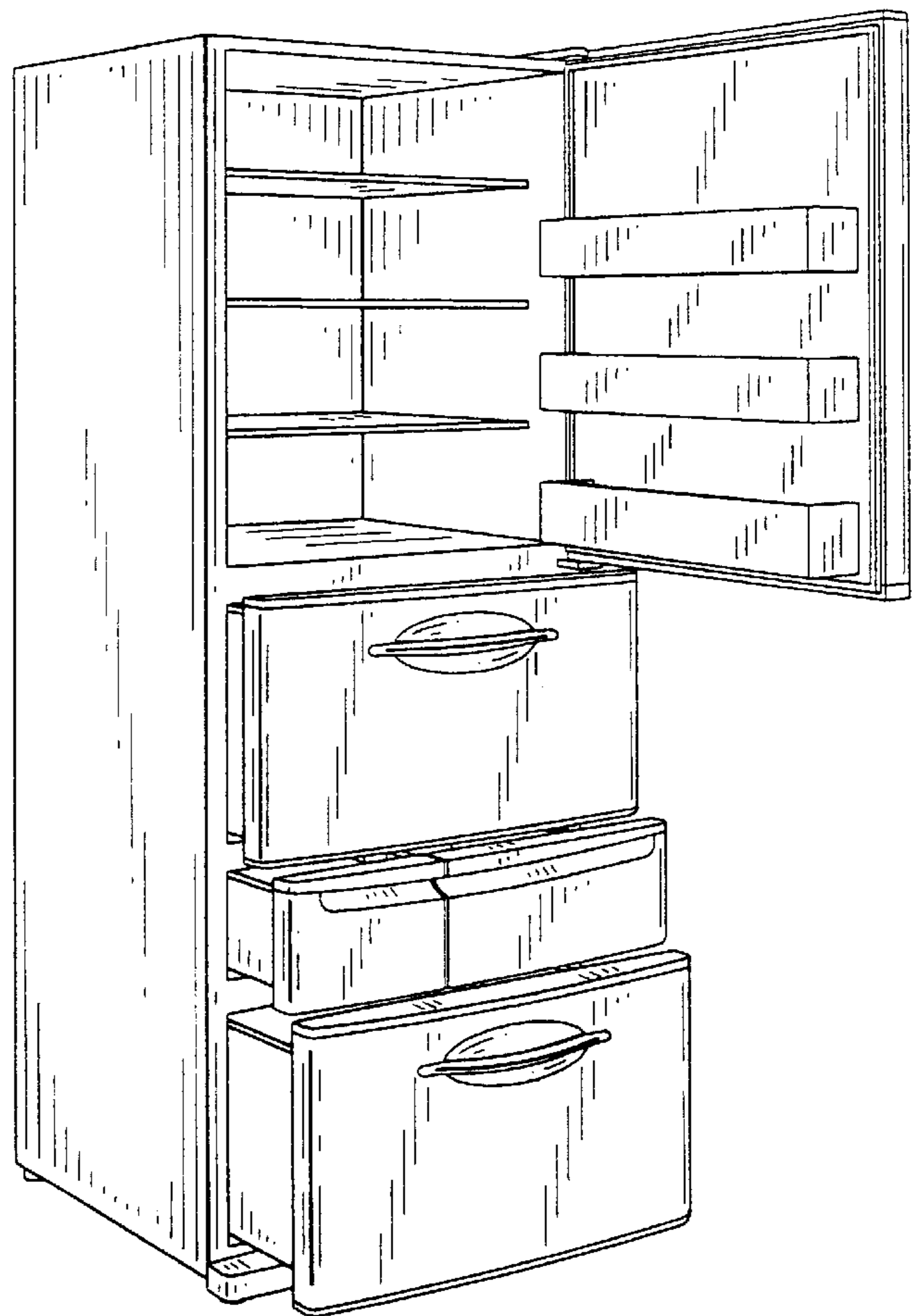
FIG. 1 is a front and right side perspective view of refrigerator, showing our new design;

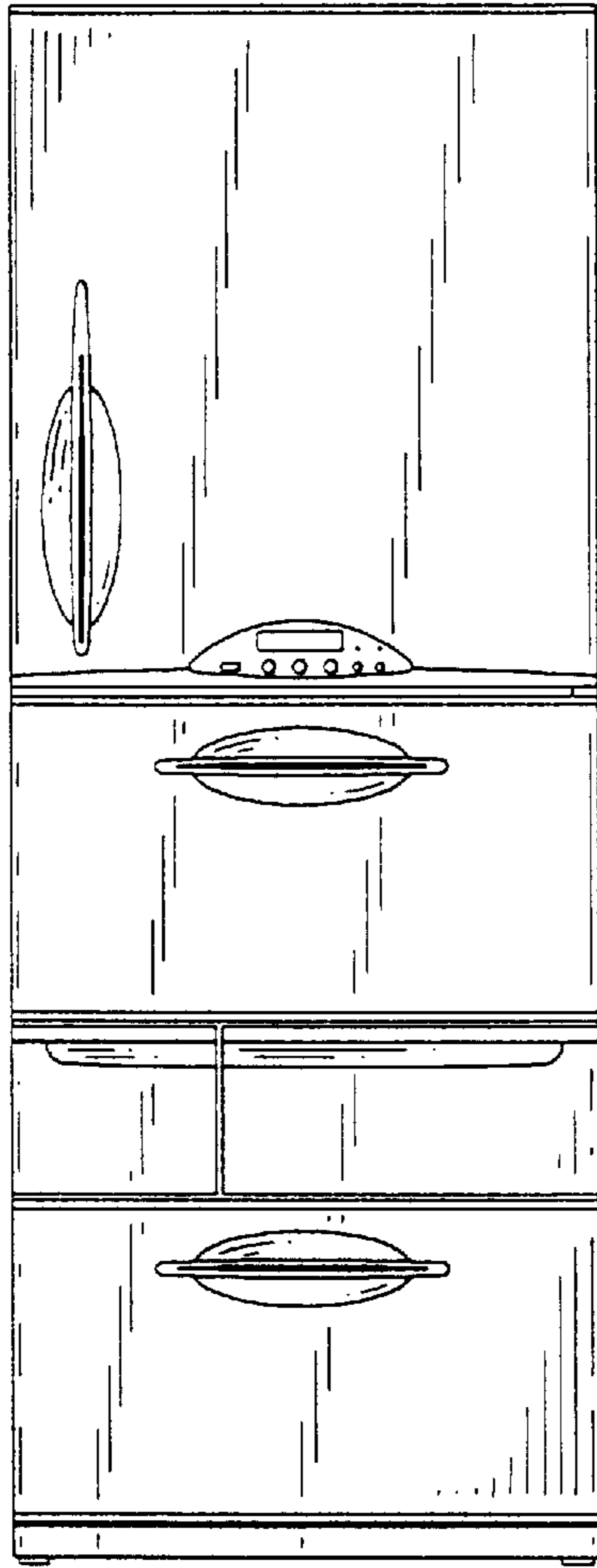




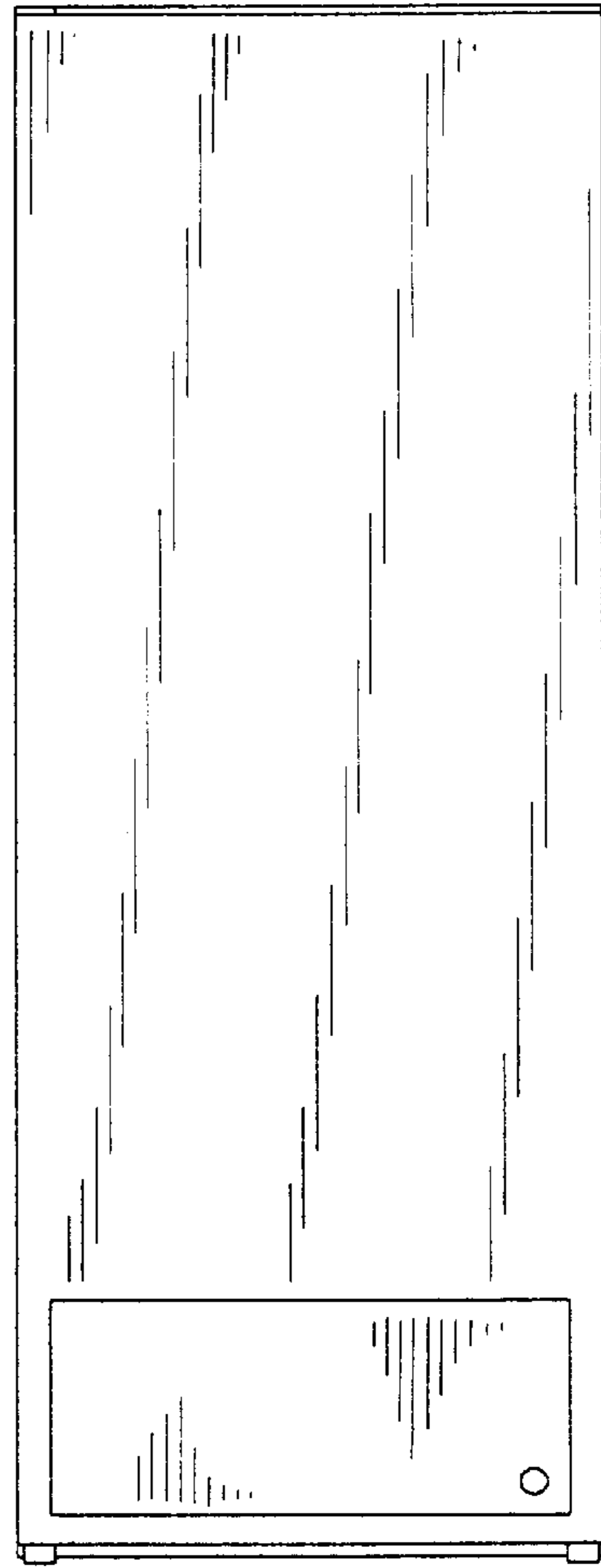

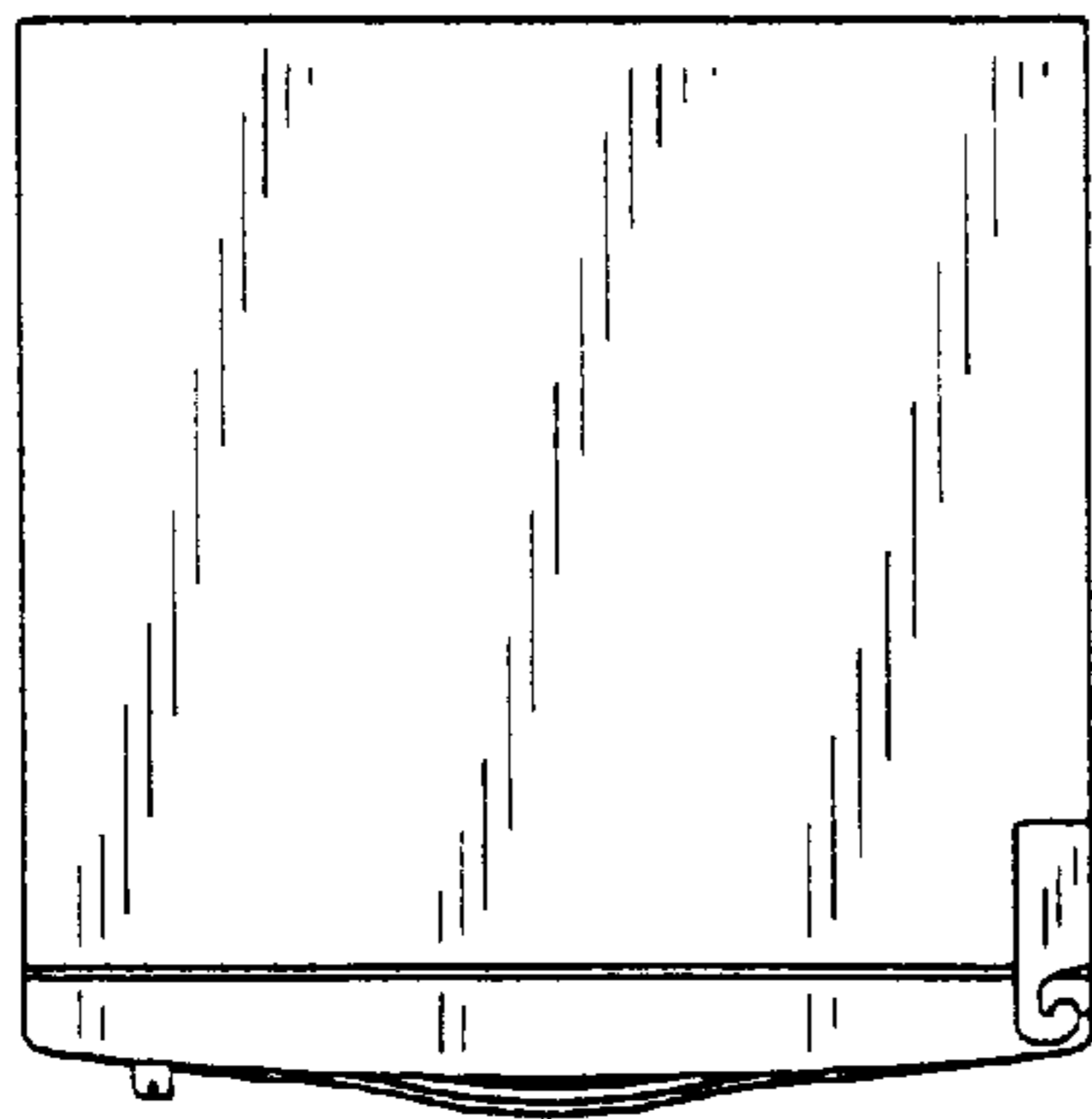

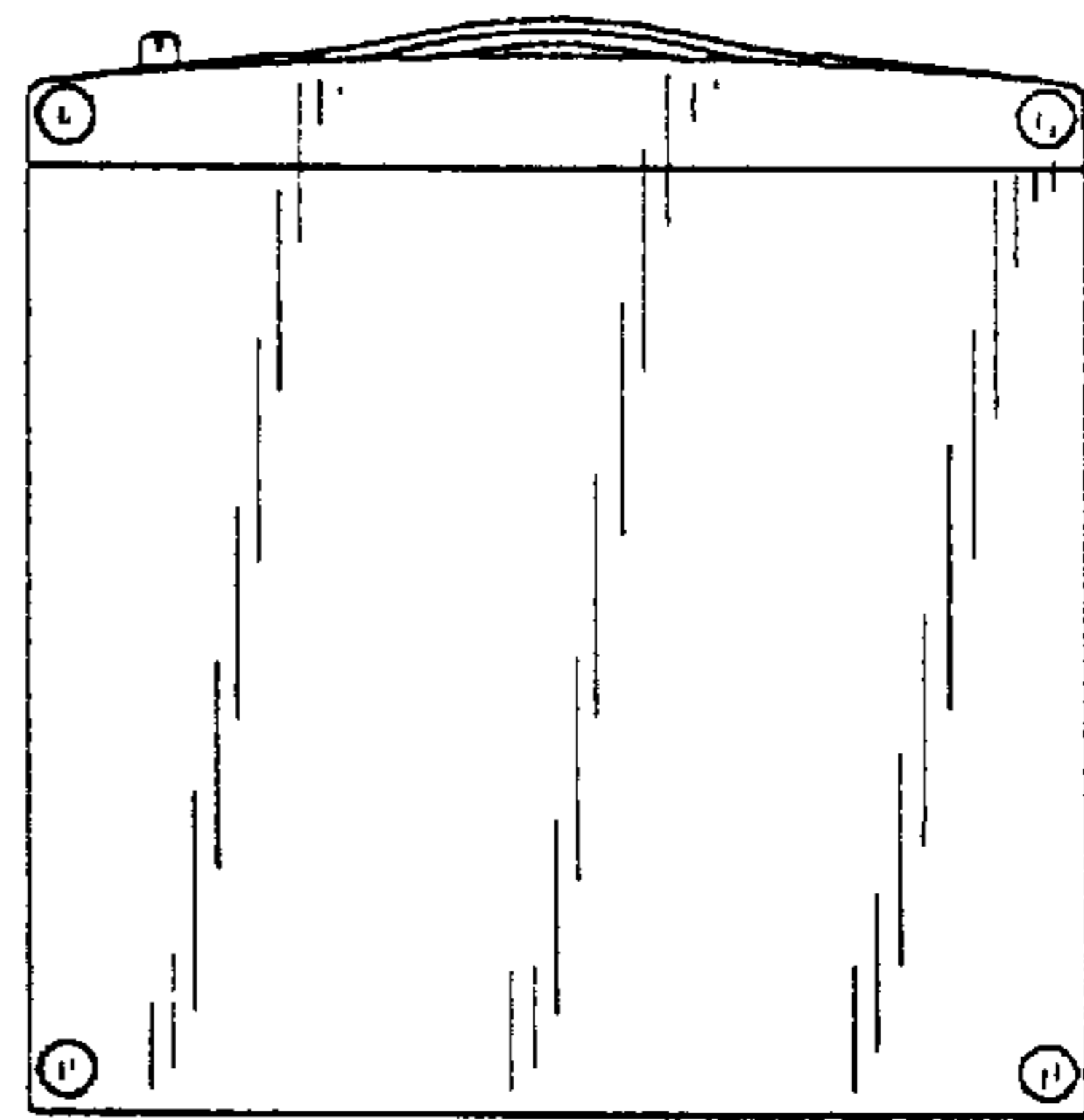

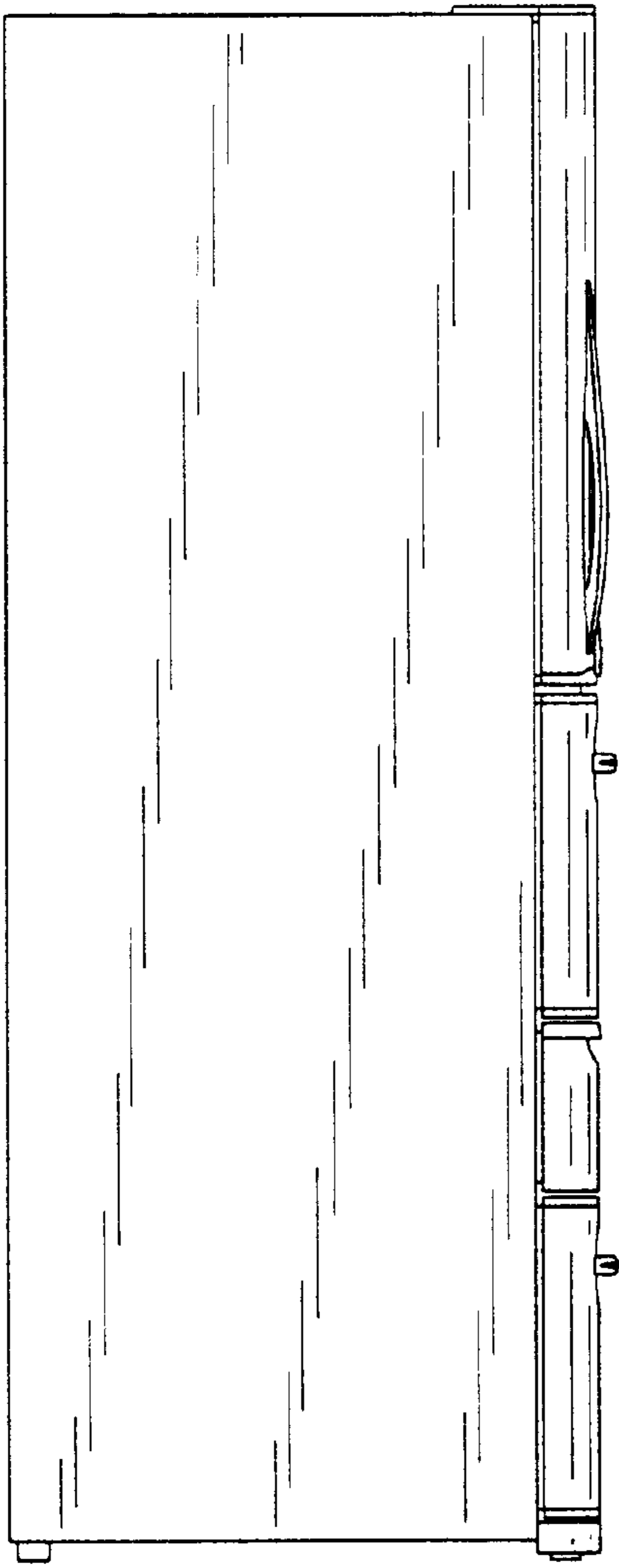

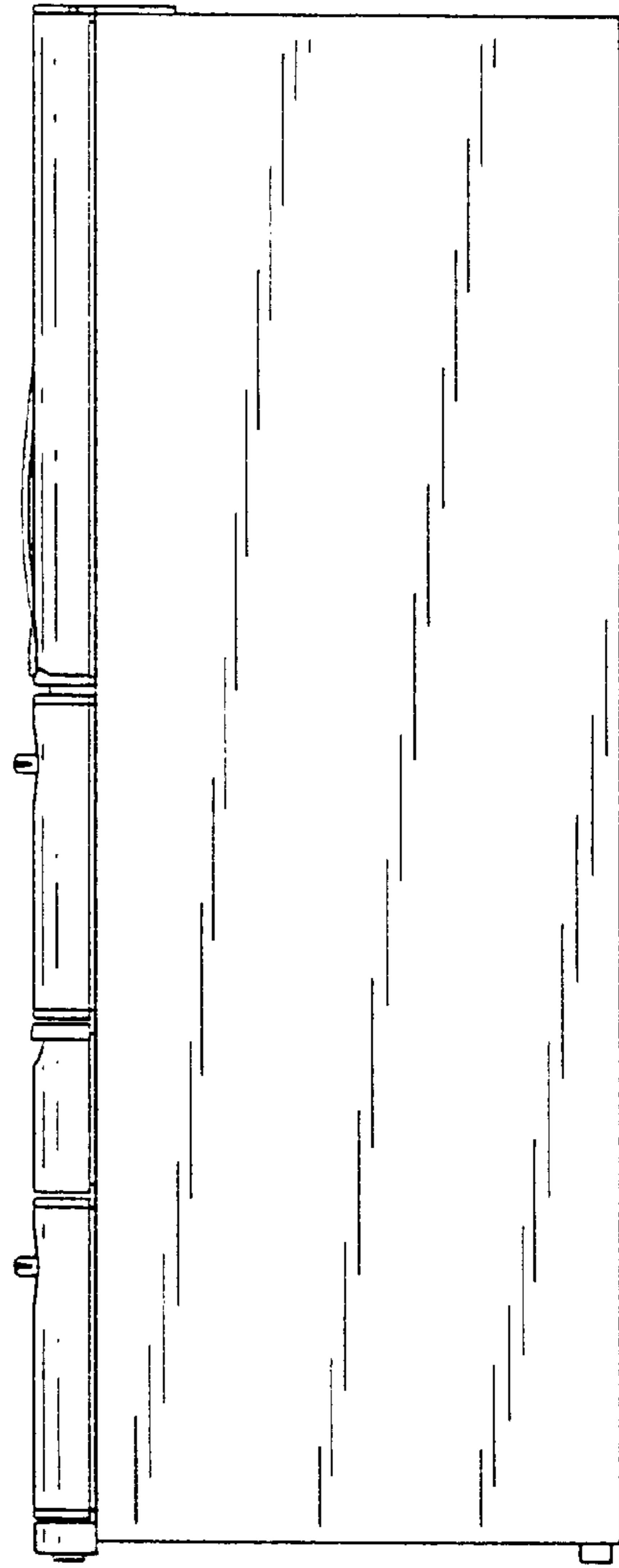
