[57] **CLAIM**

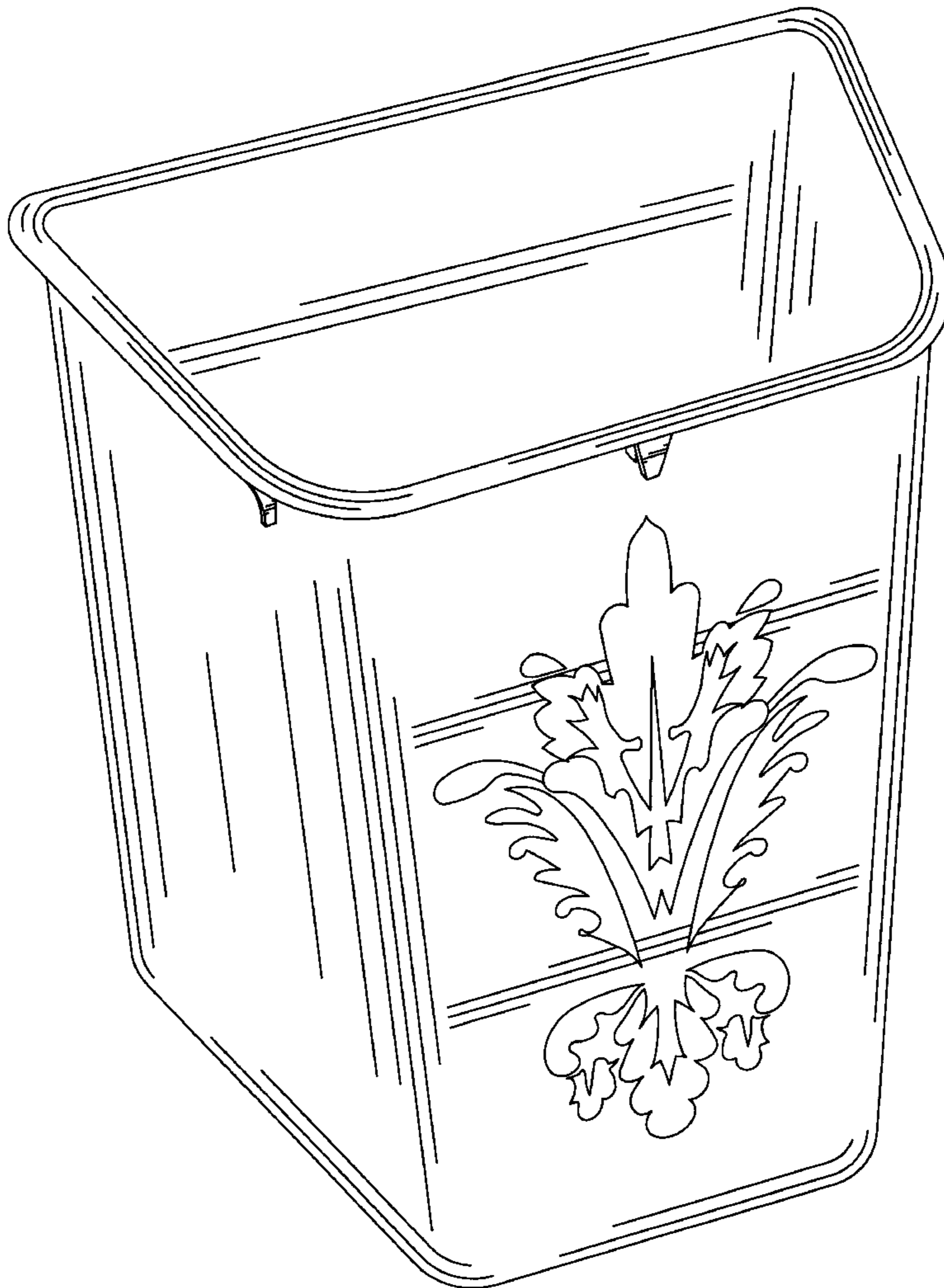
The ornamental design for a hanging waste basket, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the hanging waste basket showing my new design;  
FIG. 2 is a front orthogonal view thereof;

FIG. 4 is a right side orthogonal view thereof; the left side orthogonal view being a mirror image thereof;

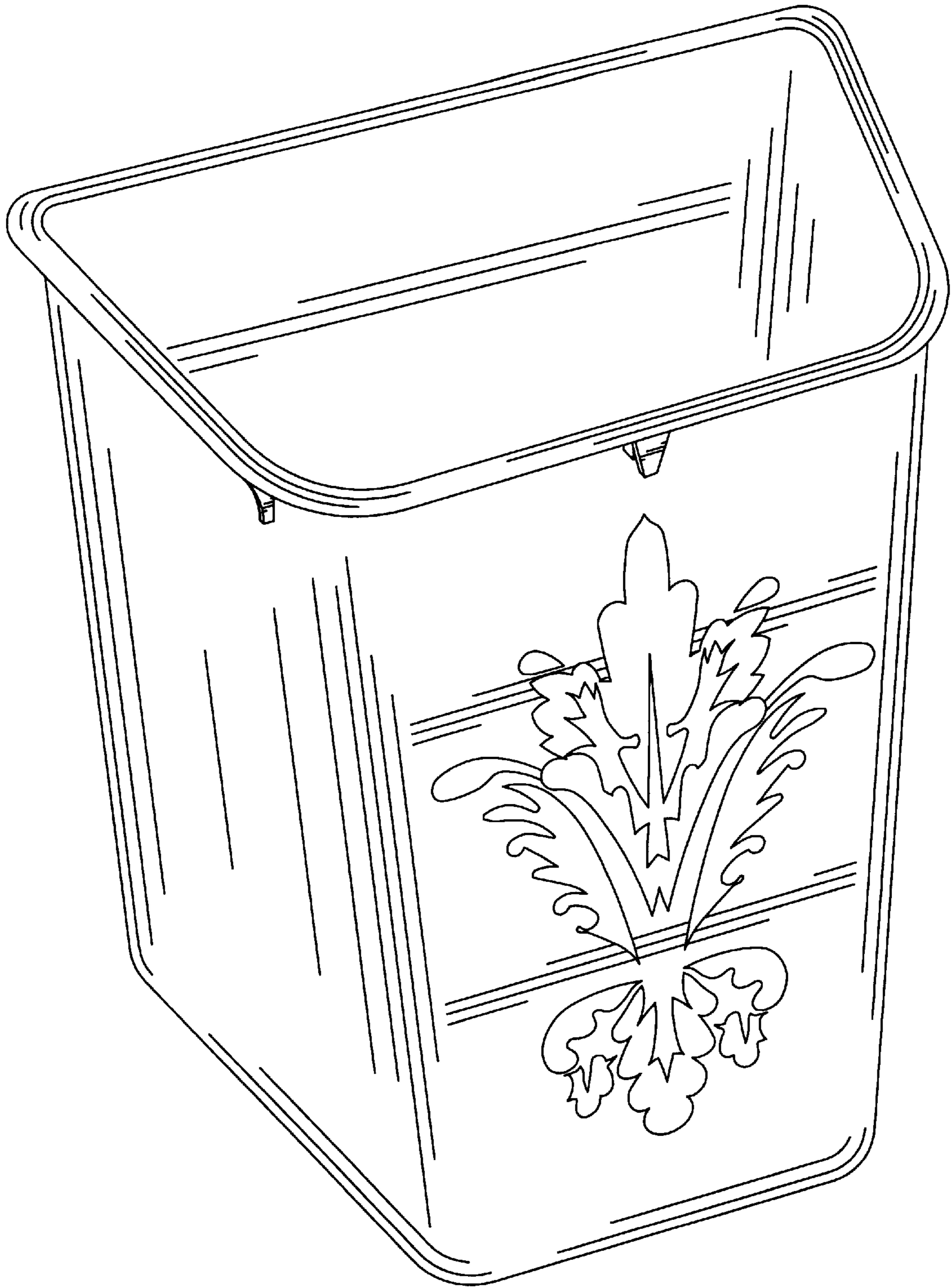

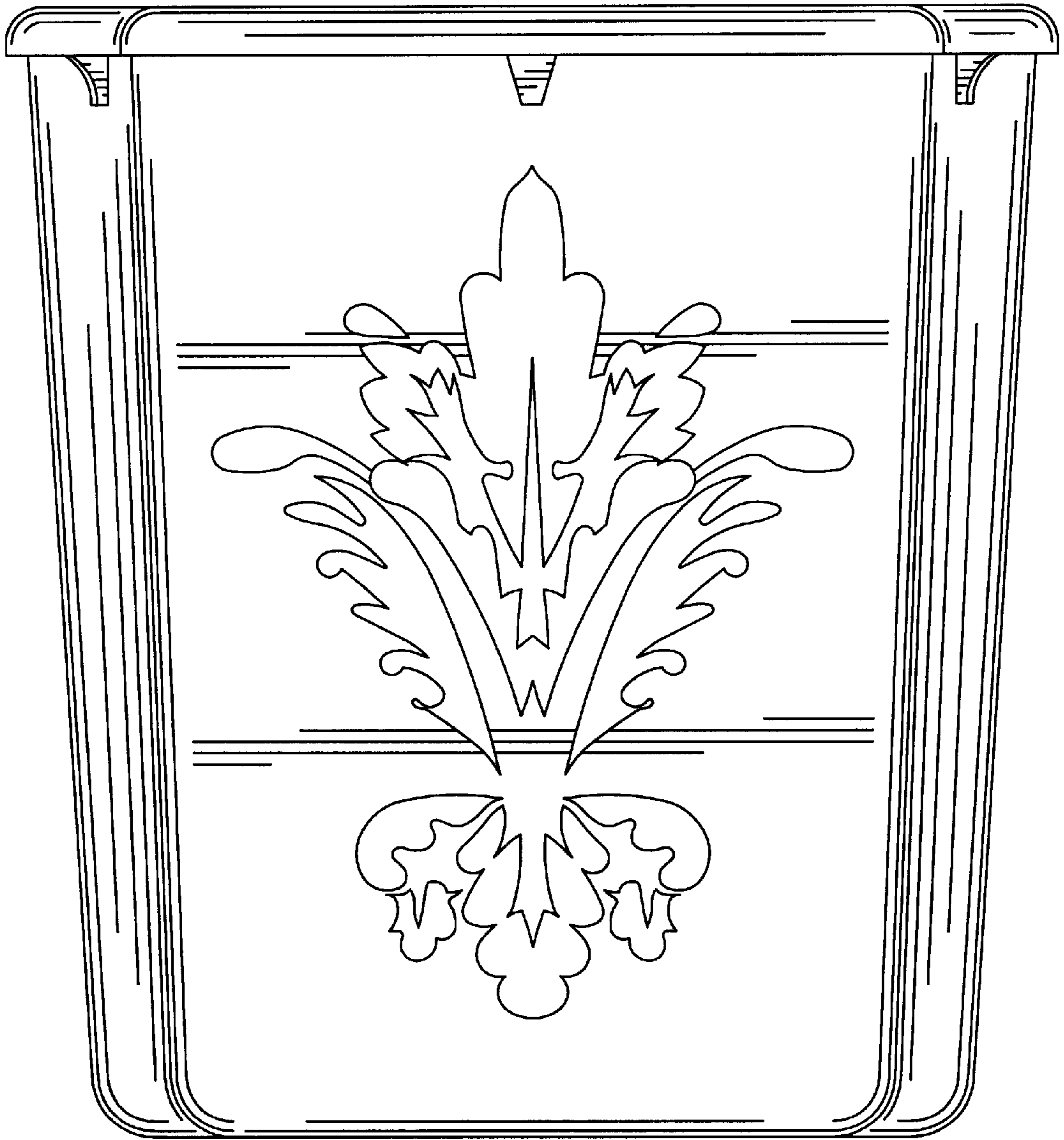

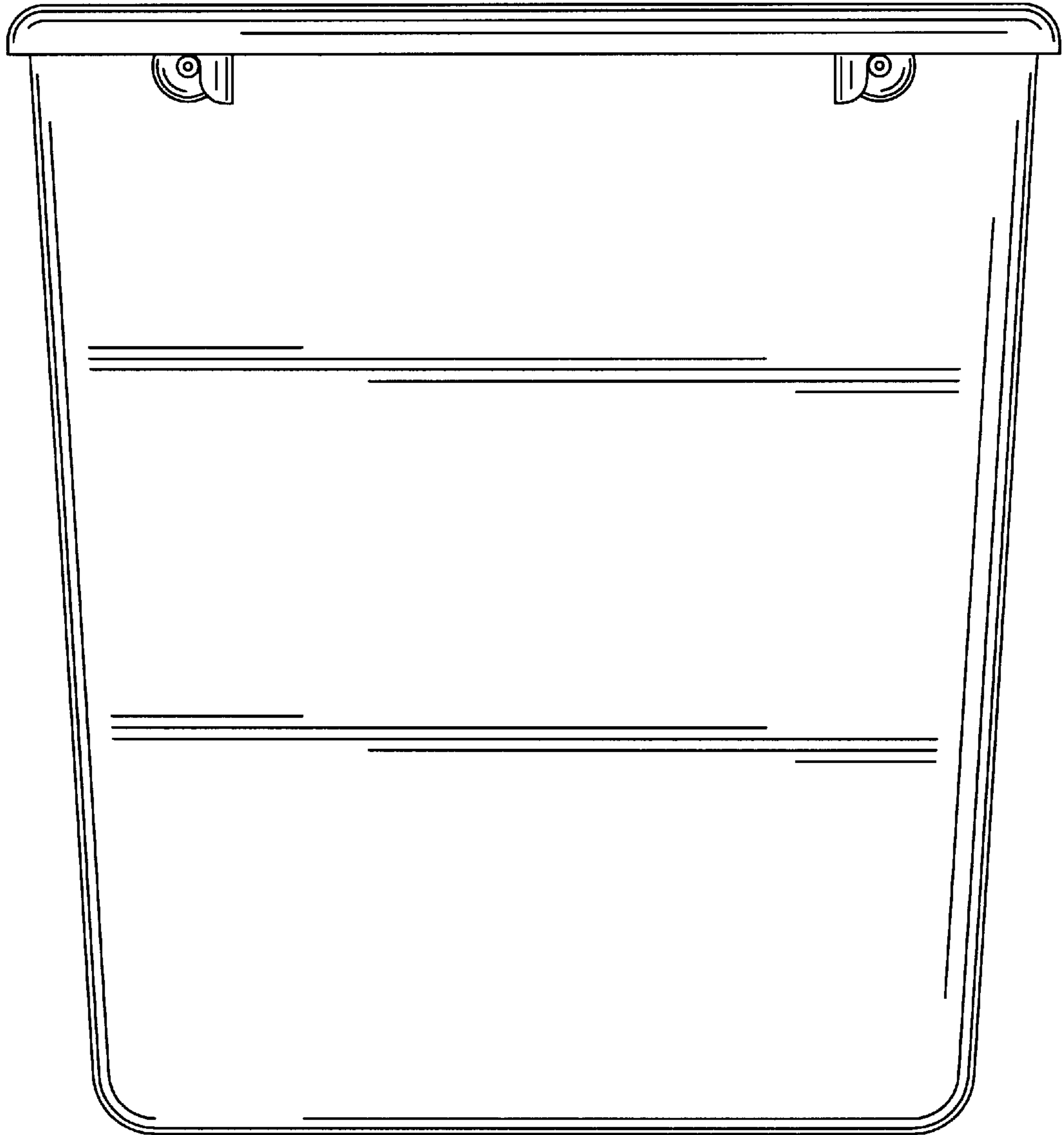

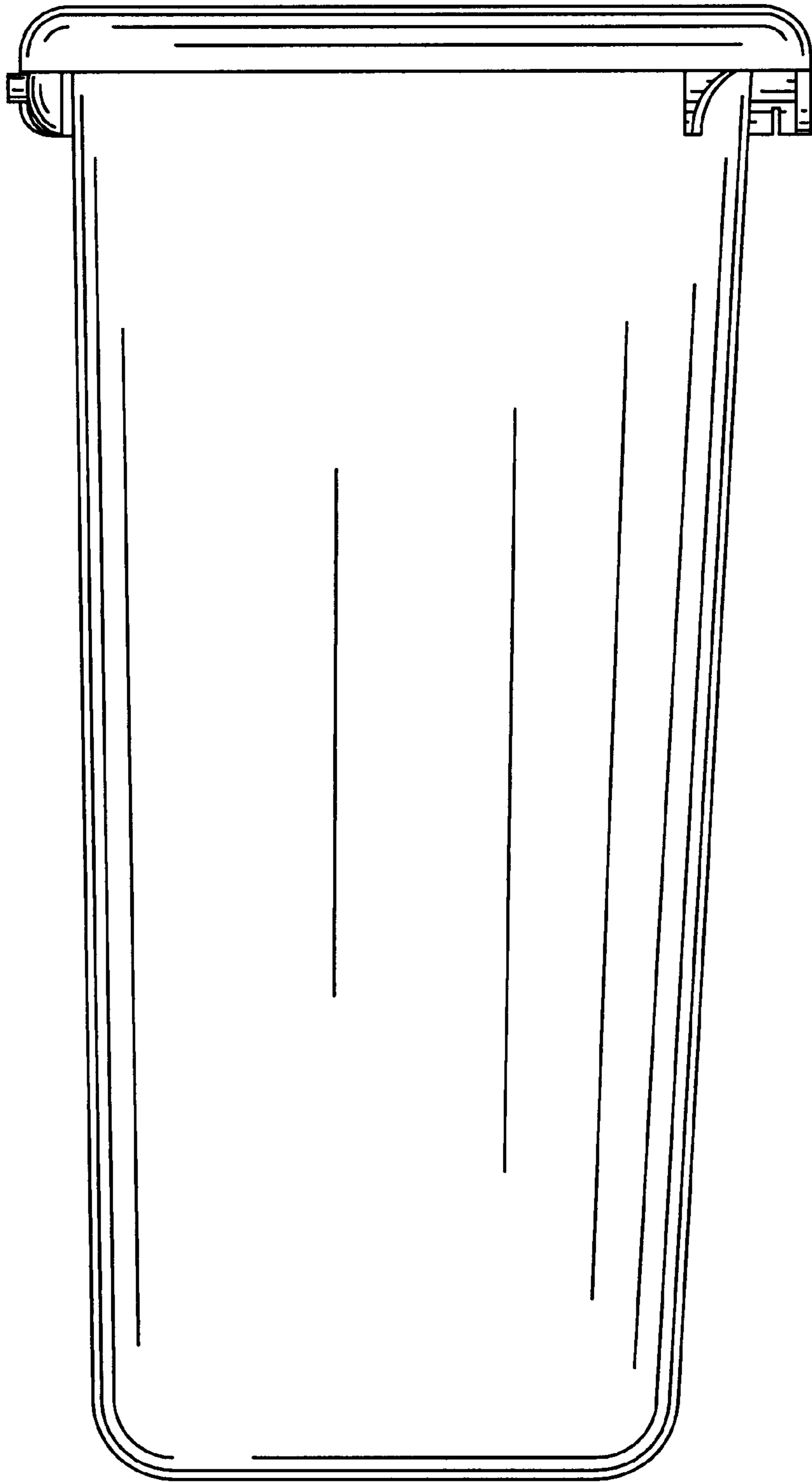

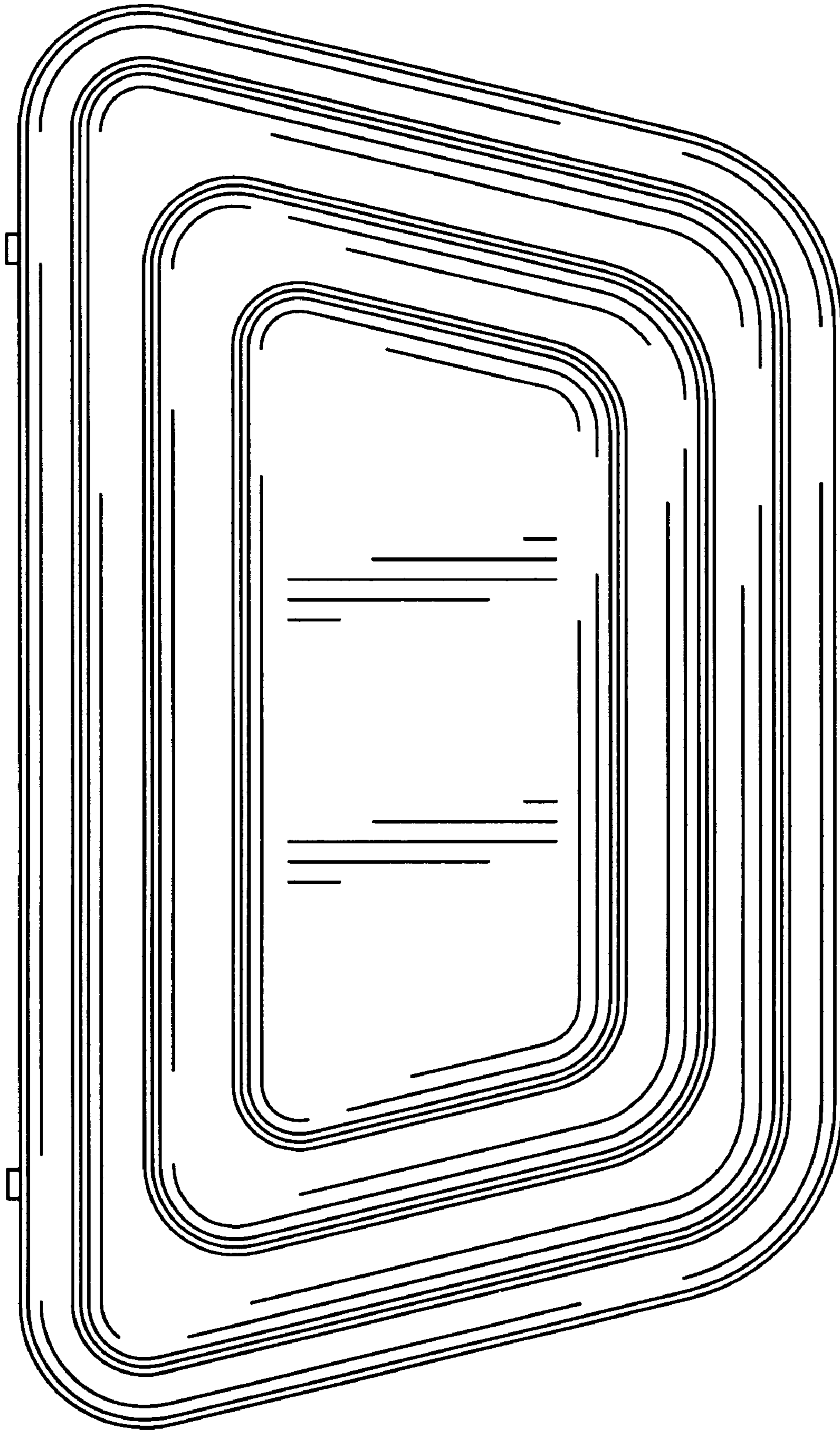

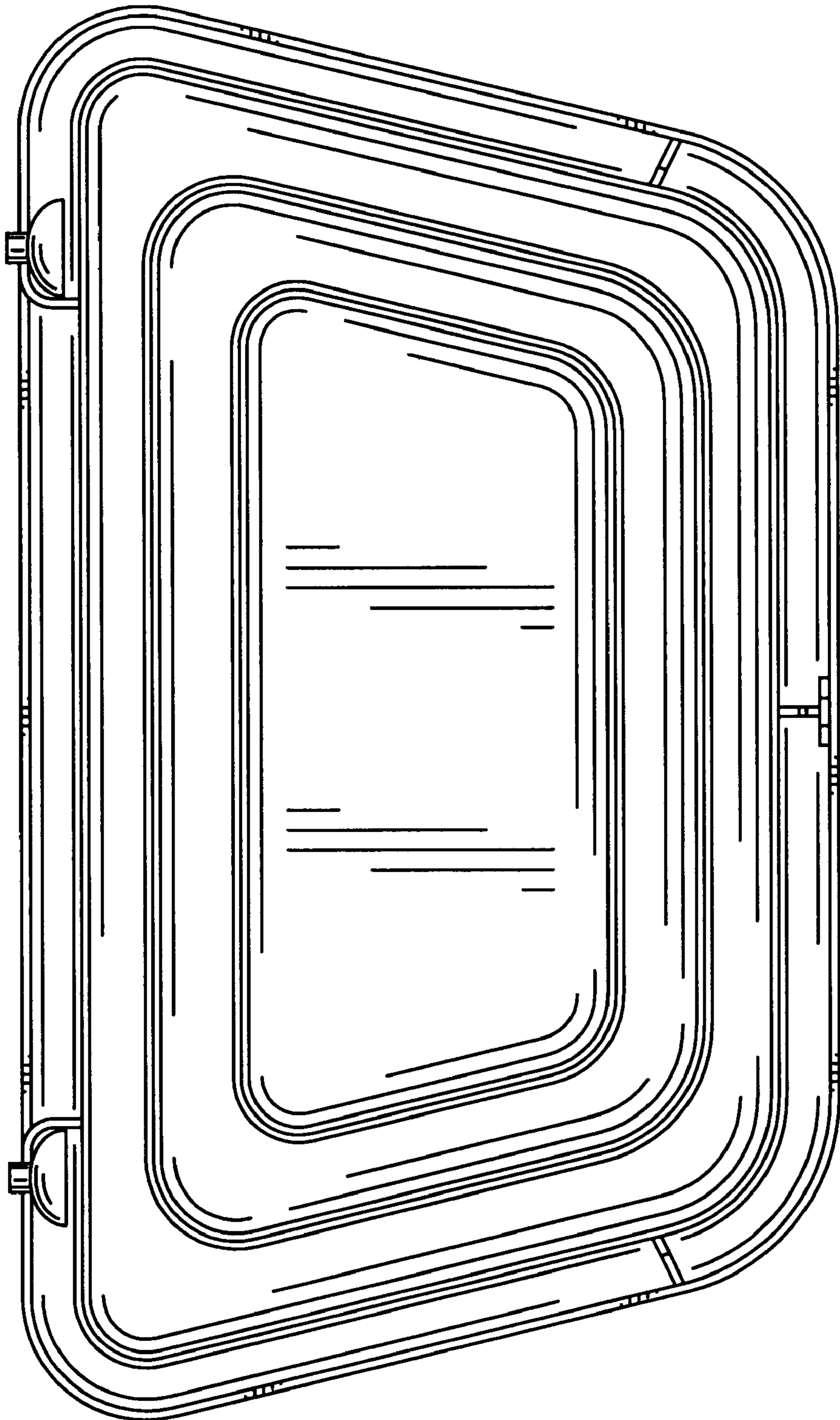
