The ornamental design for a hat, as shown and described.

DESCRIPTION

FIG. 1 is a frontal view of a first embodiment of my new design for a hat, the broken lines showing images of hair and a headband being for illustrative purposes only and form no part of the claimed design;

FIG. 2 is a frontal view of a second embodiment of my new design for a hat, the broken lines showing images of hair being for illustrative purposes only and form no part of the claimed design;

FIG. 3 is a rear view of the embodiments of my new design for a hat as shown in FIGS. 1 and 2, the broken lines showing images of hair being for illustrative purposes only and form no part of the claimed design;

FIG. 4 is a frontal view of a third embodiment of my new design for a hat;

FIG. 5 is a rear view of the embodiment of my new design for a hat;

FIG. 6 is a top view of the embodiments of my new design for a hat as shown in FIGS. 1-5;

FIG. 7 is a side view of the embodiments of my new design for a hat as shown in FIGS. 1-5; and,

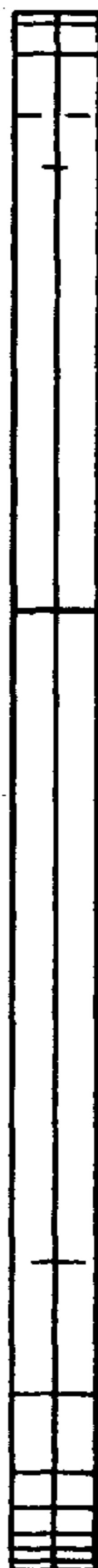

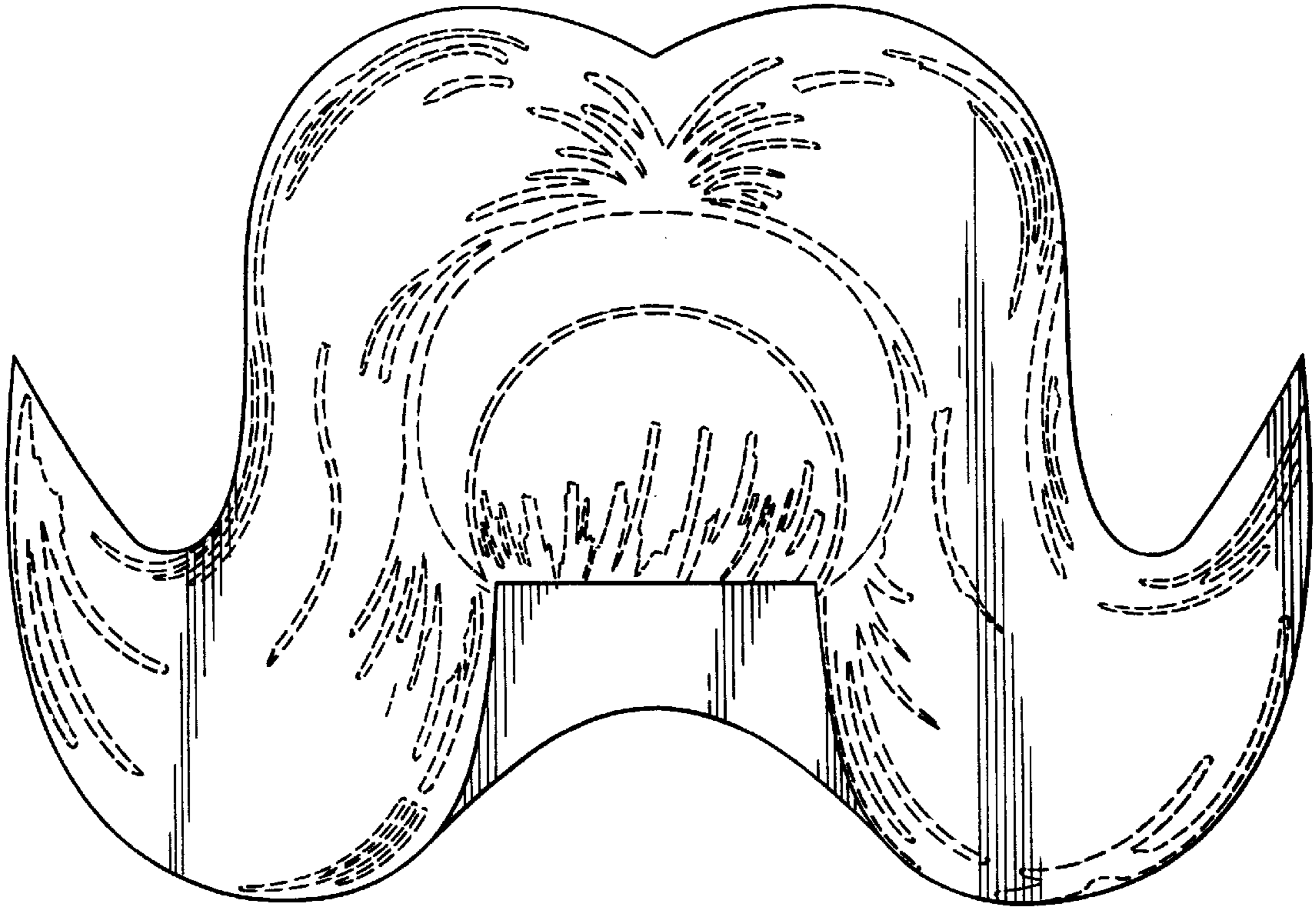

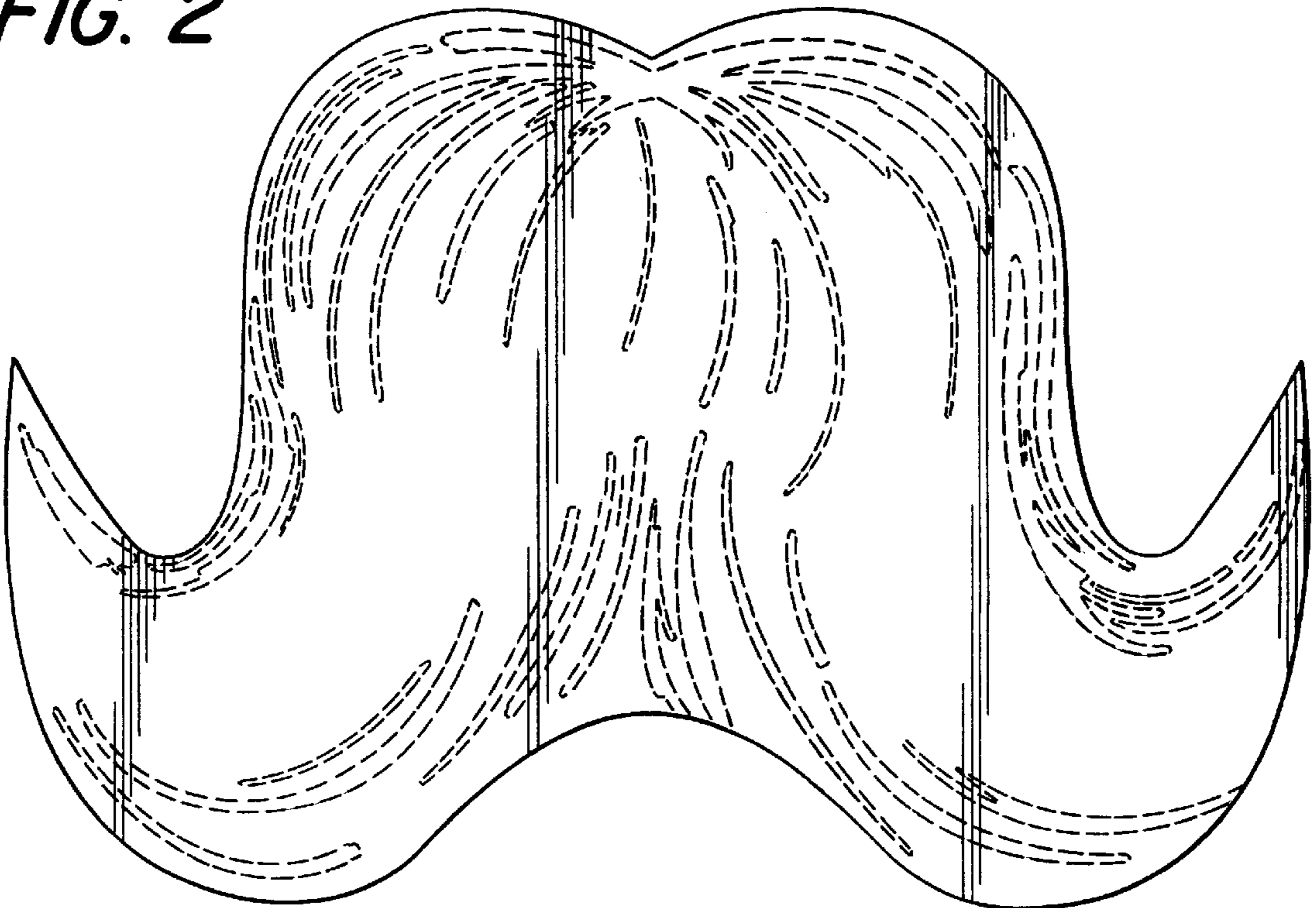

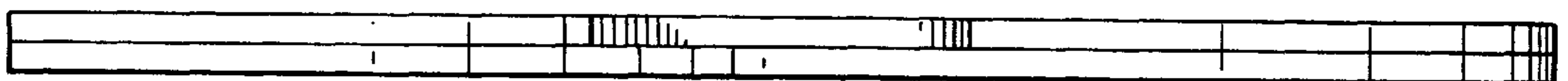

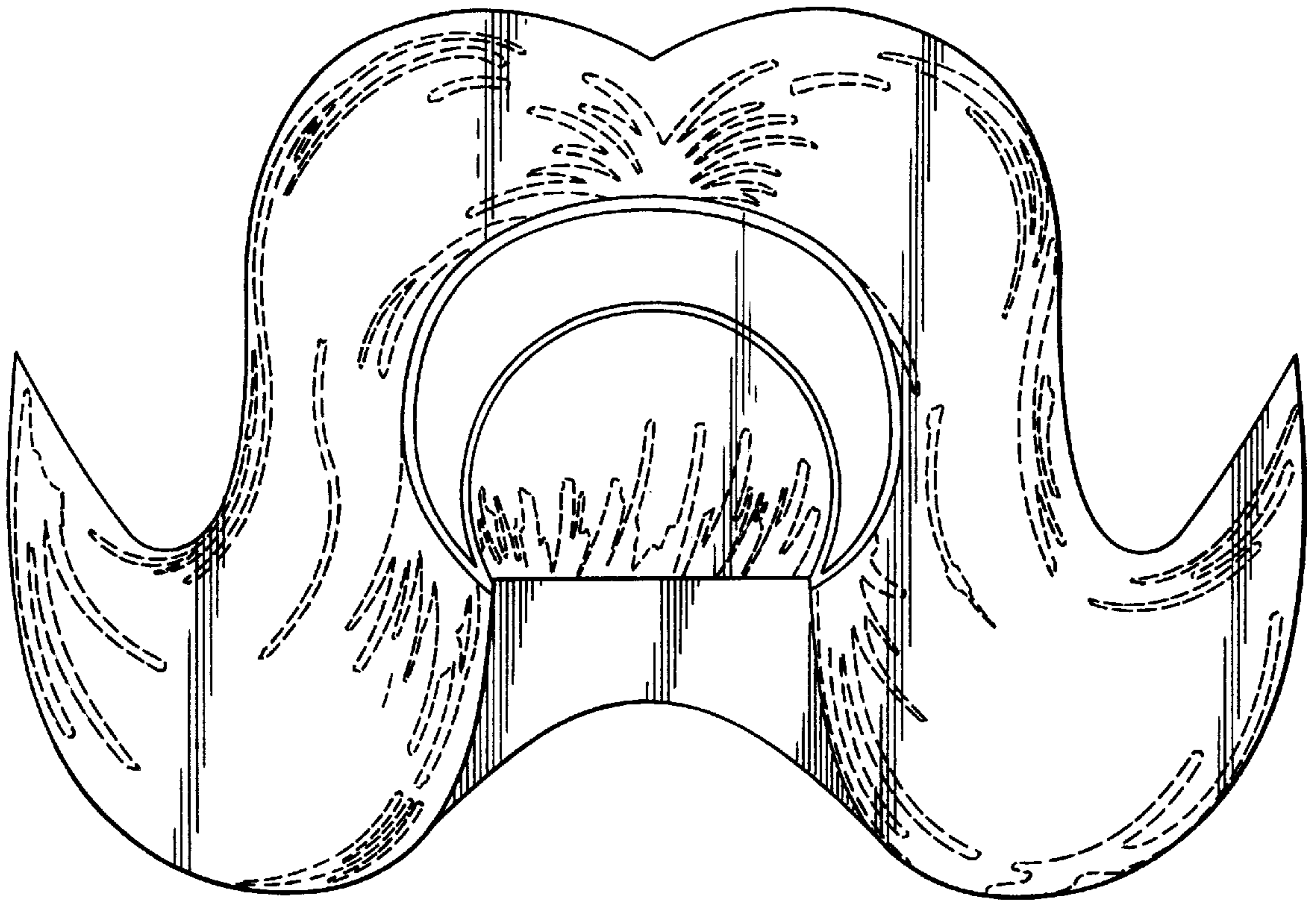

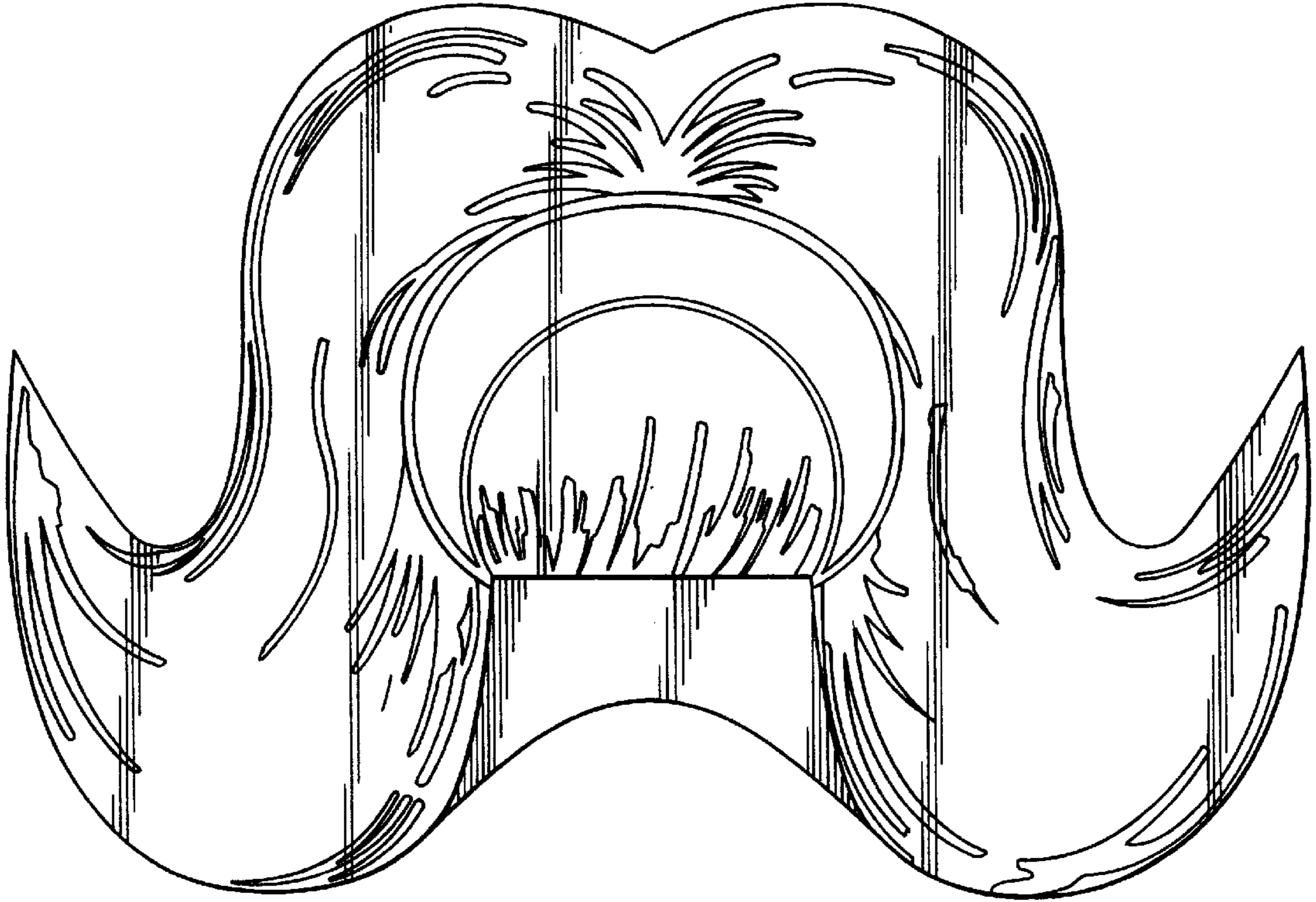
