FIG. 1 is a top plan view of a hand grip showing my new design;

FIG. 2 is a side elevational view thereof, the opposite side elevational view being a mirror image thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a perspective view thereof;

FIG. 5 is a front elevational view thereof, the rear elevational view being a mirror image thereof;

FIG. 6 is a perspective view of a second embodiment of the design shown in FIG. 1, with an alternative side and bottom design;

FIG. 7 is a front elevational view of the second embodiment shown in FIG. 6, the rear elevational view being a mirror image thereof;

FIG. 8 is a side elevational view of the second embodiment shown in FIG. 6 thereof, the opposite side elevational view being a mirror image thereof;

FIG. 9 is a top plan view of the second embodiment shown in FIG. 6 thereof;

FIG. 10 is a bottom plan view of the second embodiment shown thereof;

FIG. 11 is a front elevational view of a third embodiment of the design, it being understood that the top and side views are the same as those shown in the second embodiment and that the opposite side elevational view is a mirror image thereof;

FIG. 12 is a bottom plan view of the third embodiment of FIG. 11; and,

FIG. 13 is a perspective view of a fourth embodiment of the design similar to the second embodiment, the only difference being the fibrous surface design which is understood to be repeated uniformly throughout the surface of the embodiment.

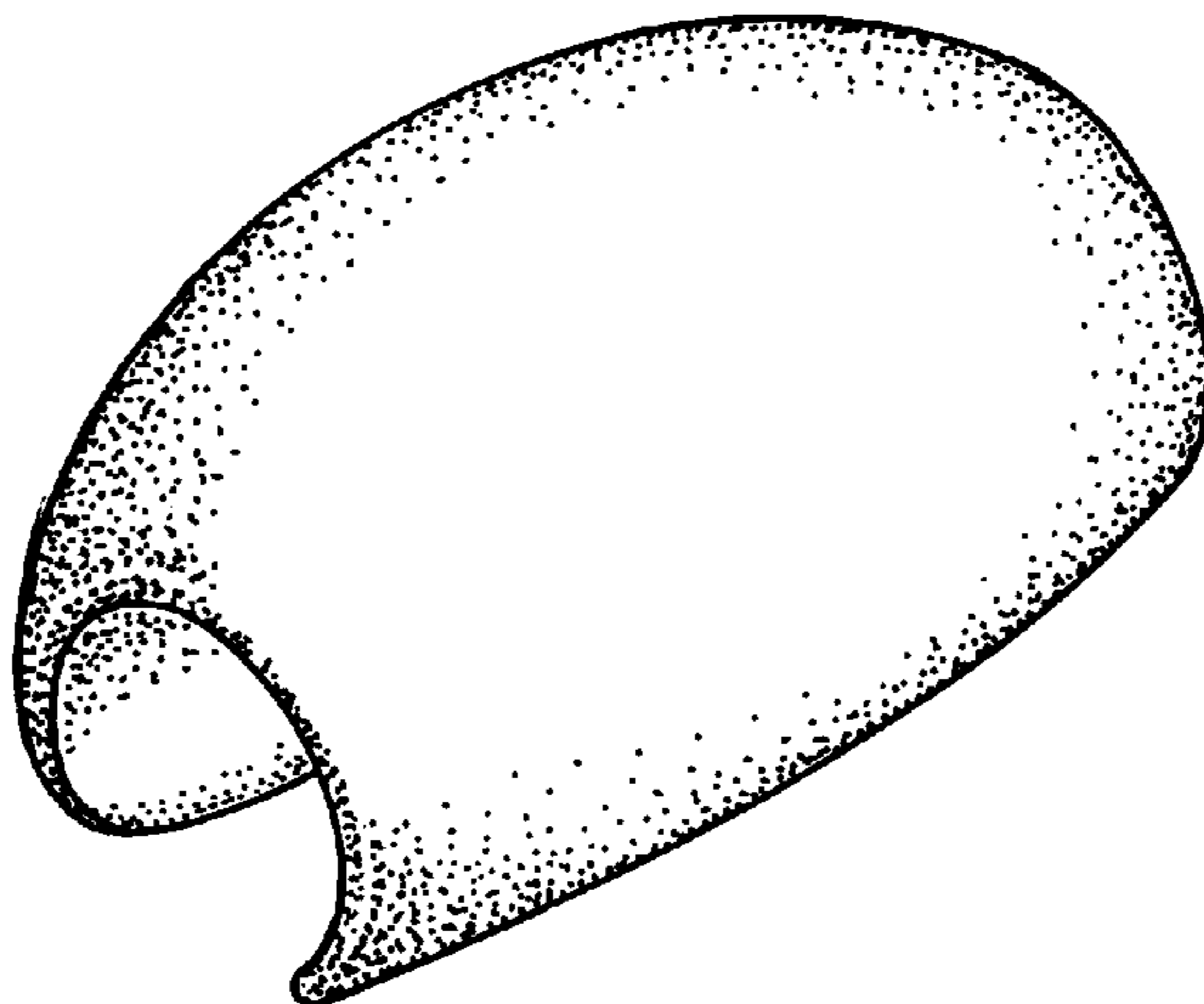

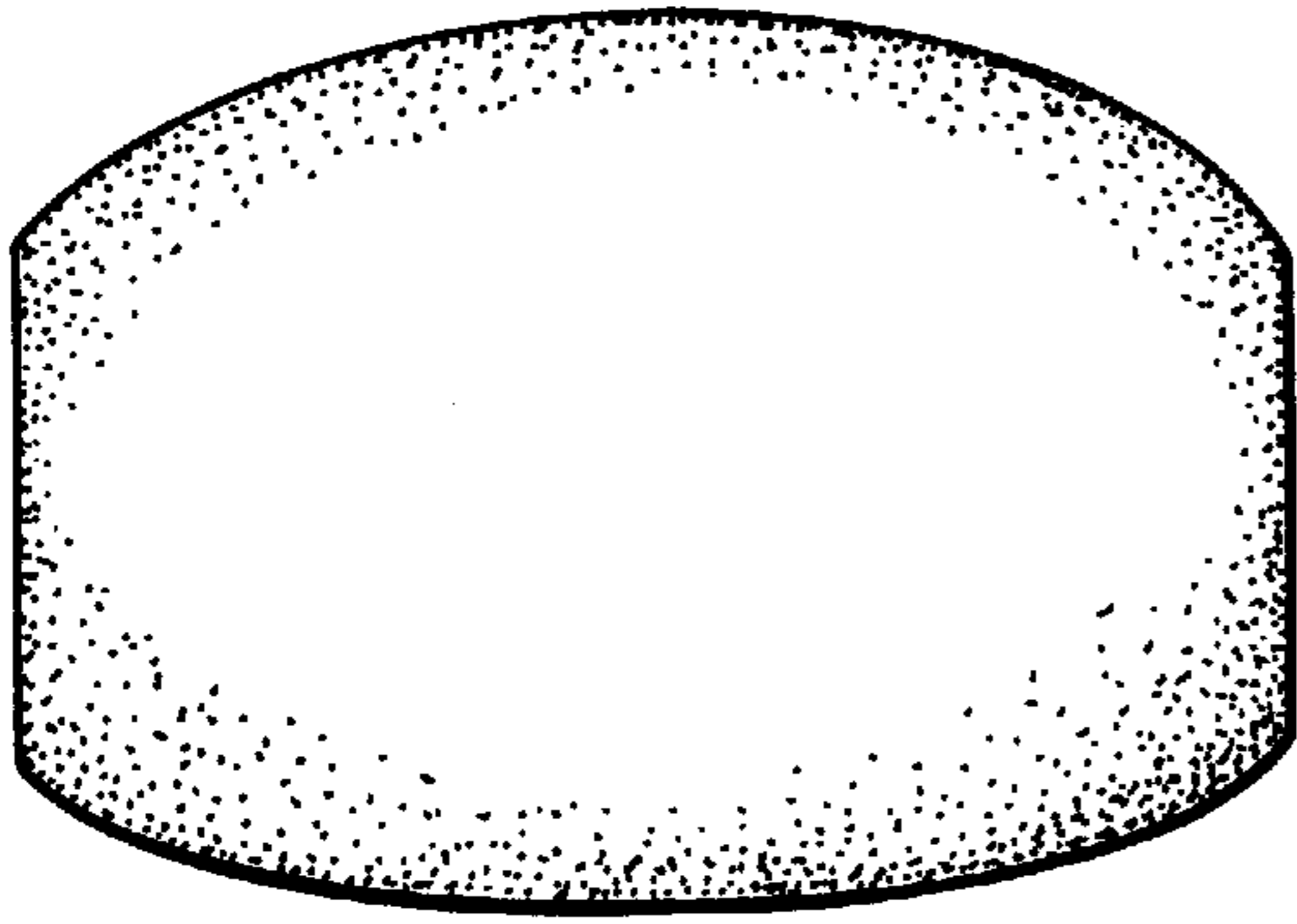

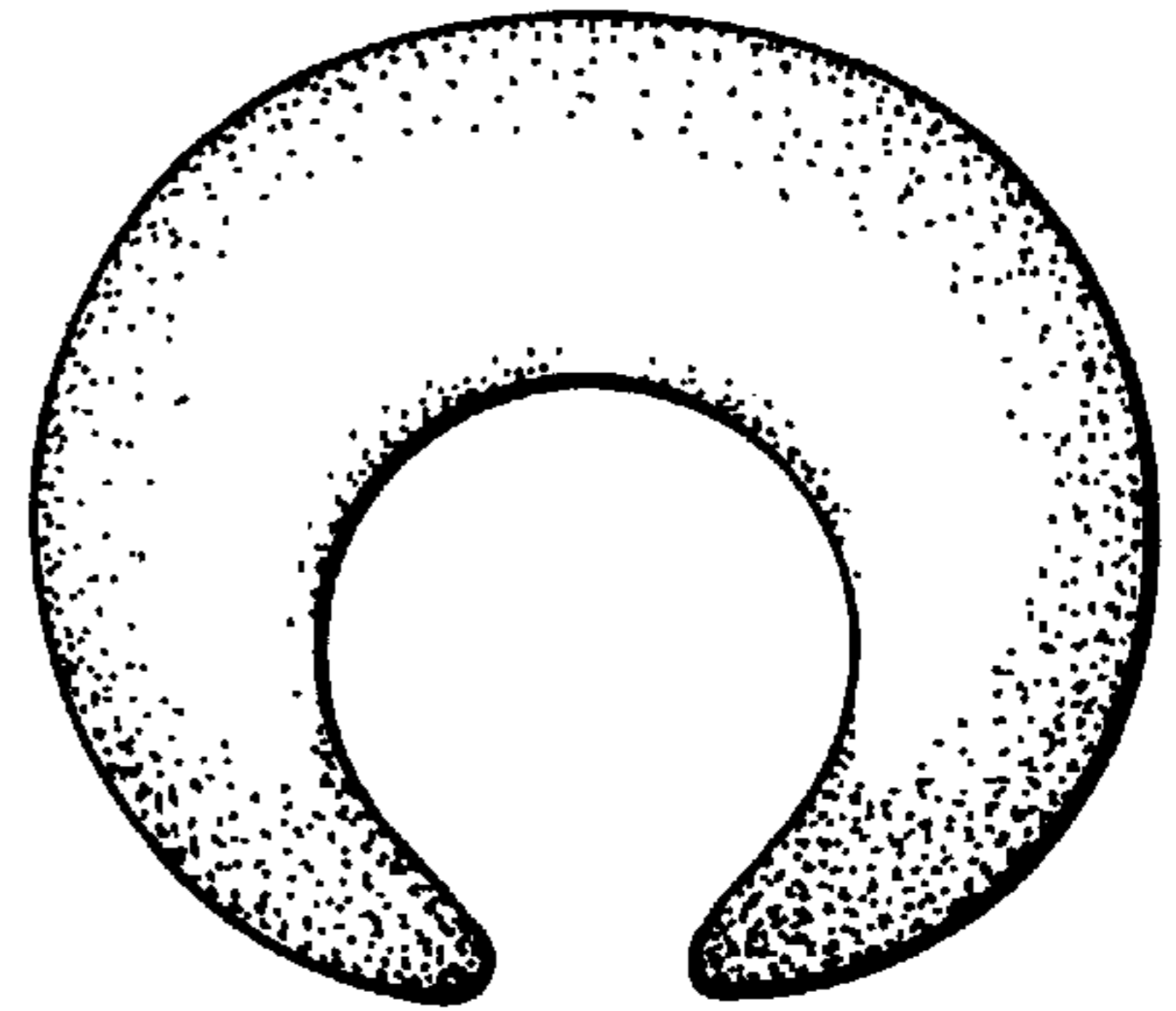
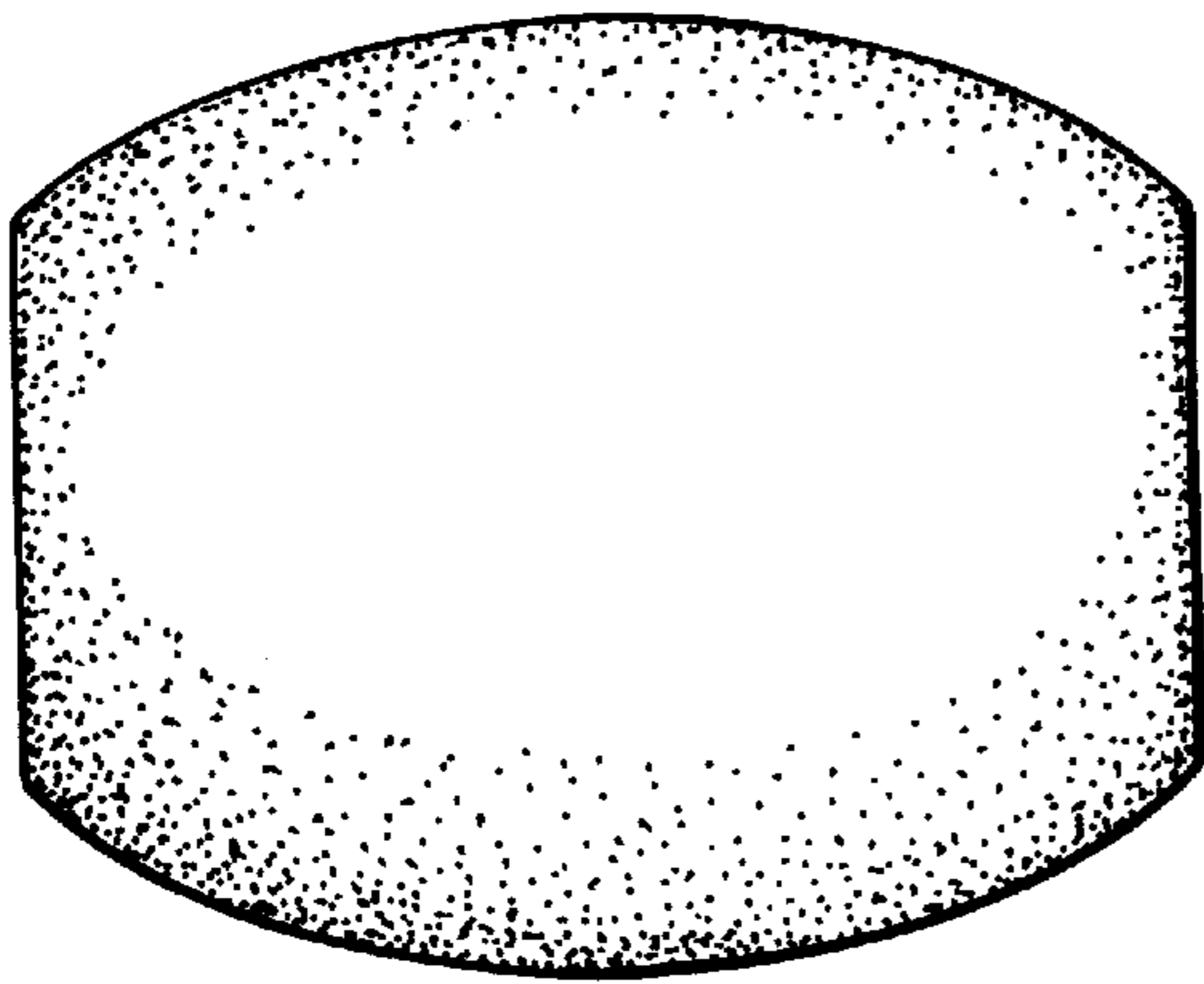
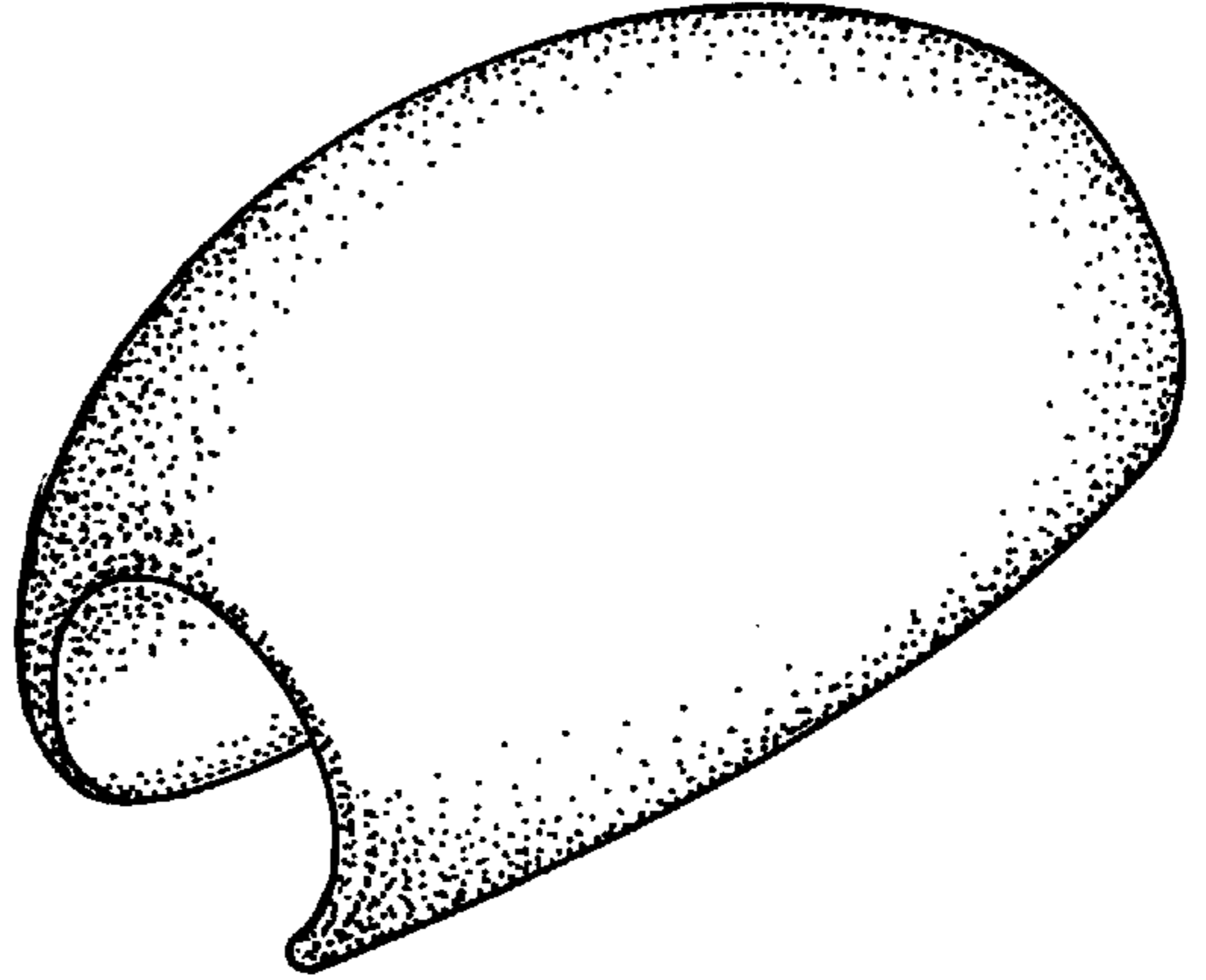

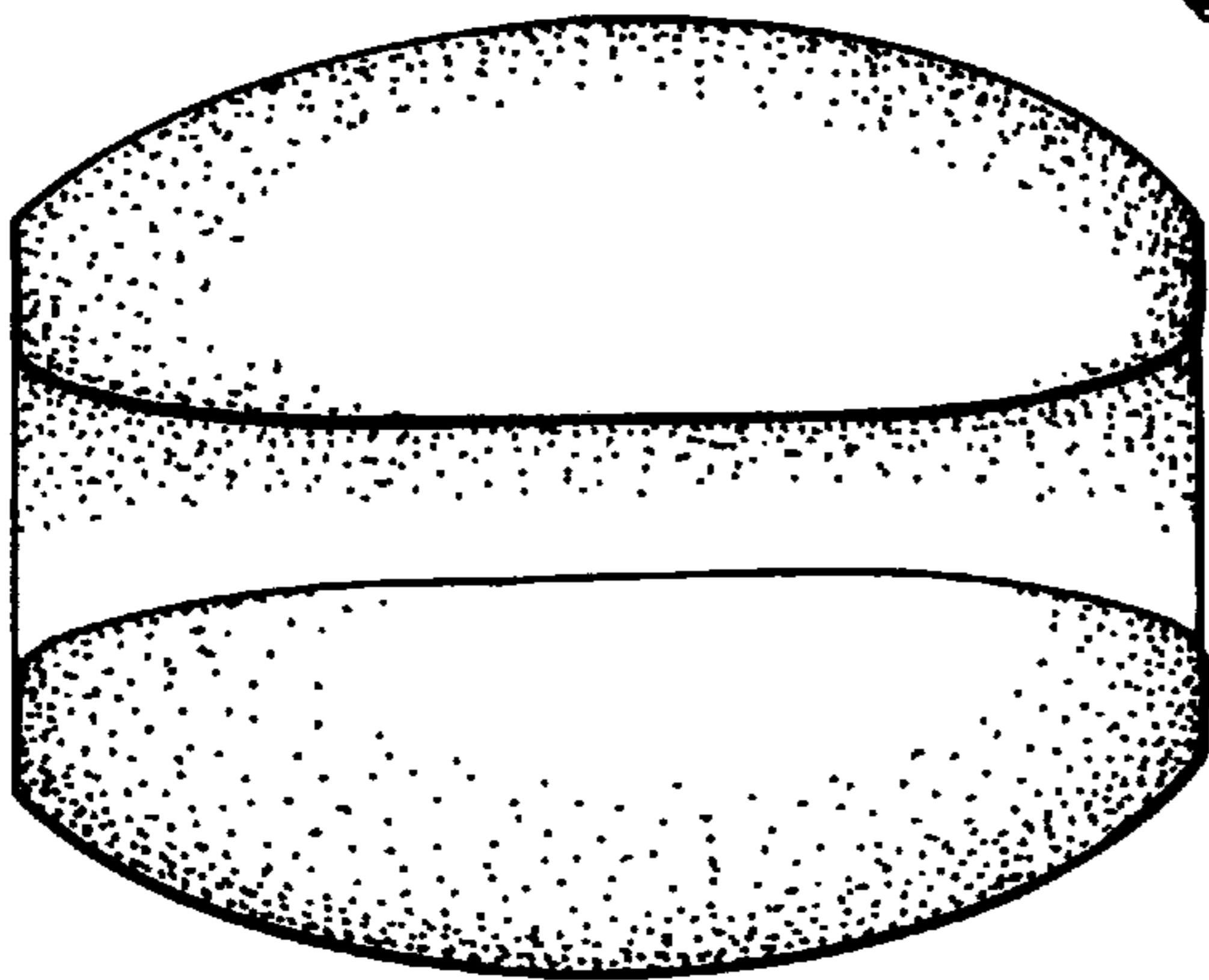

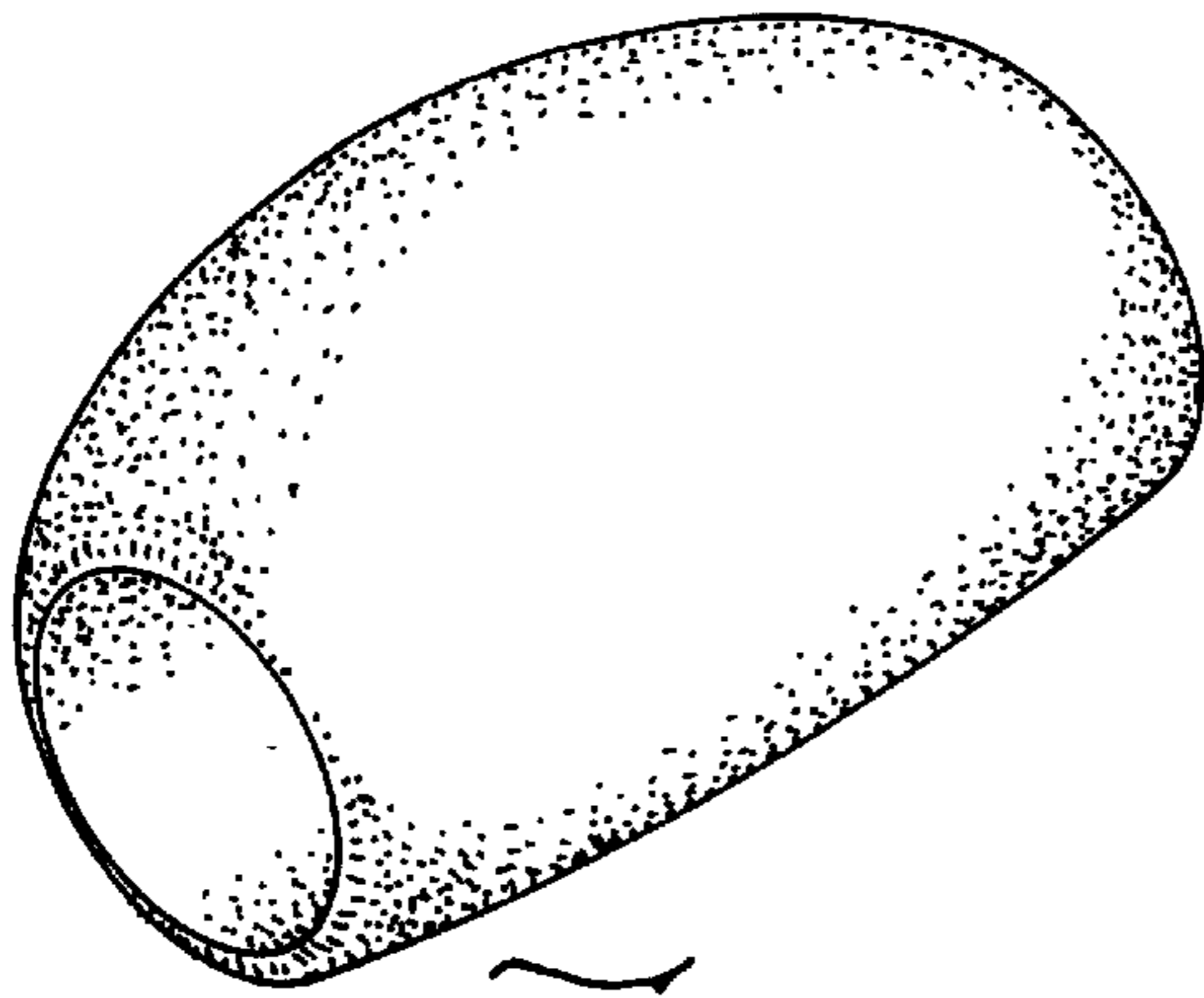

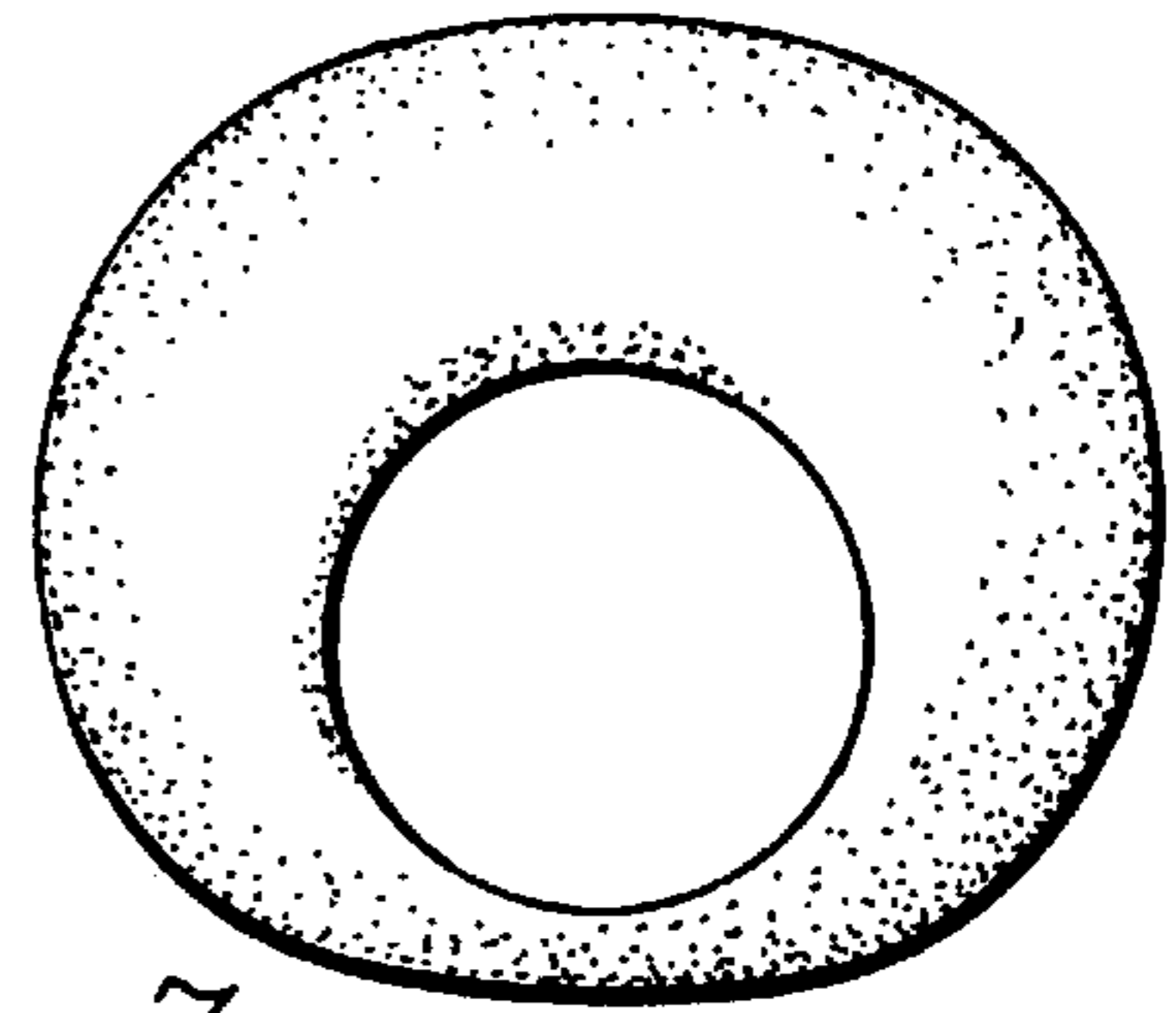

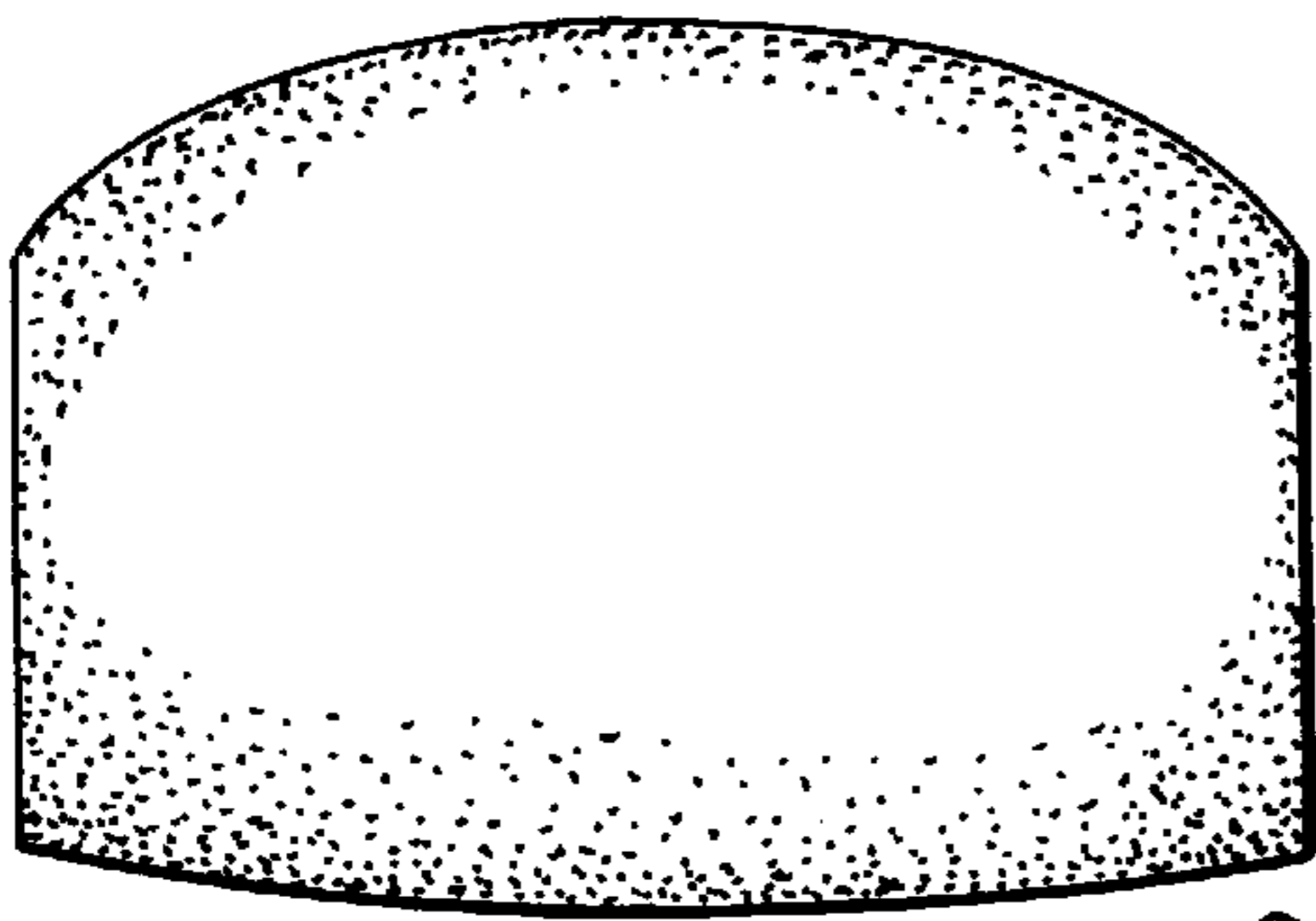

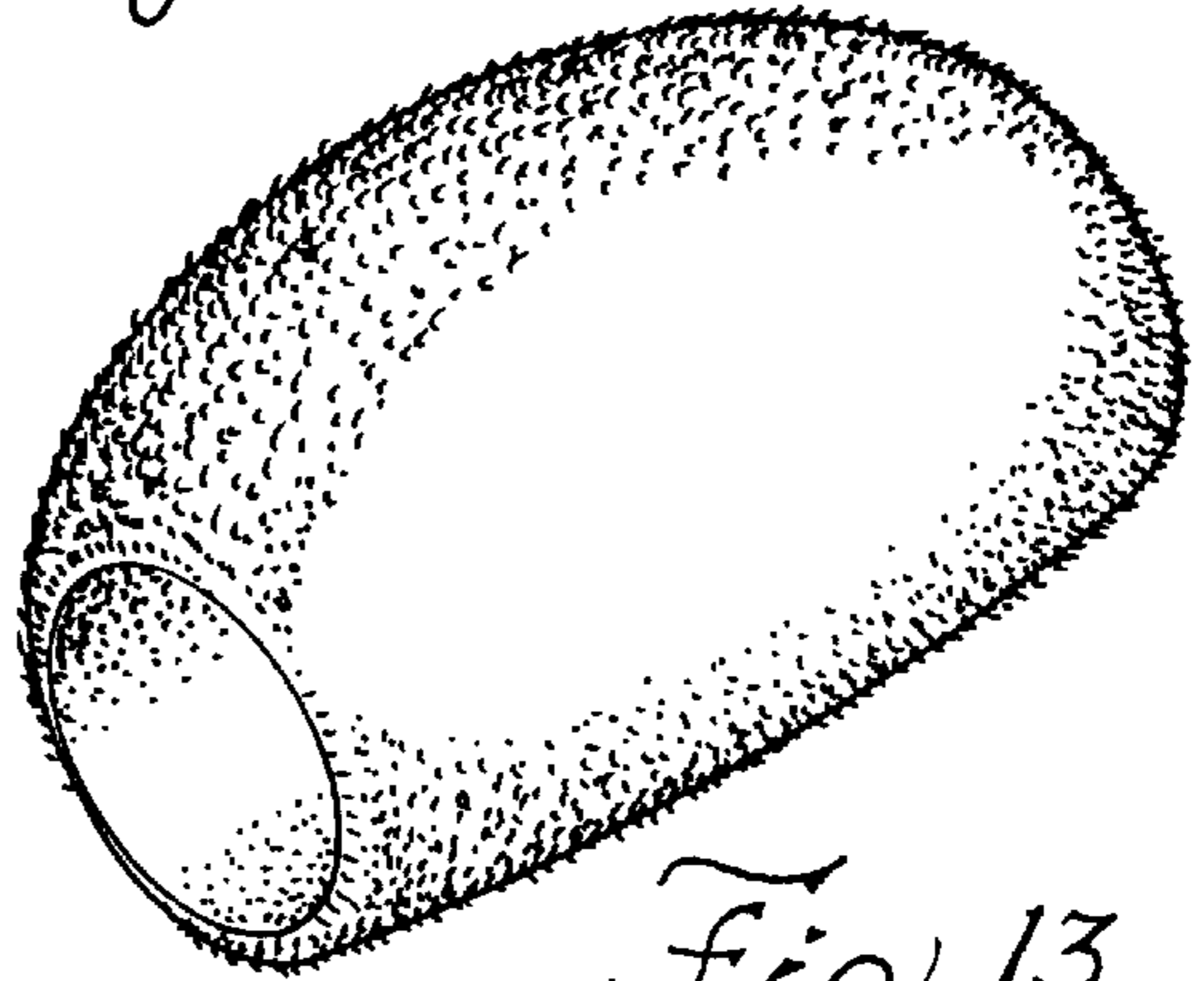

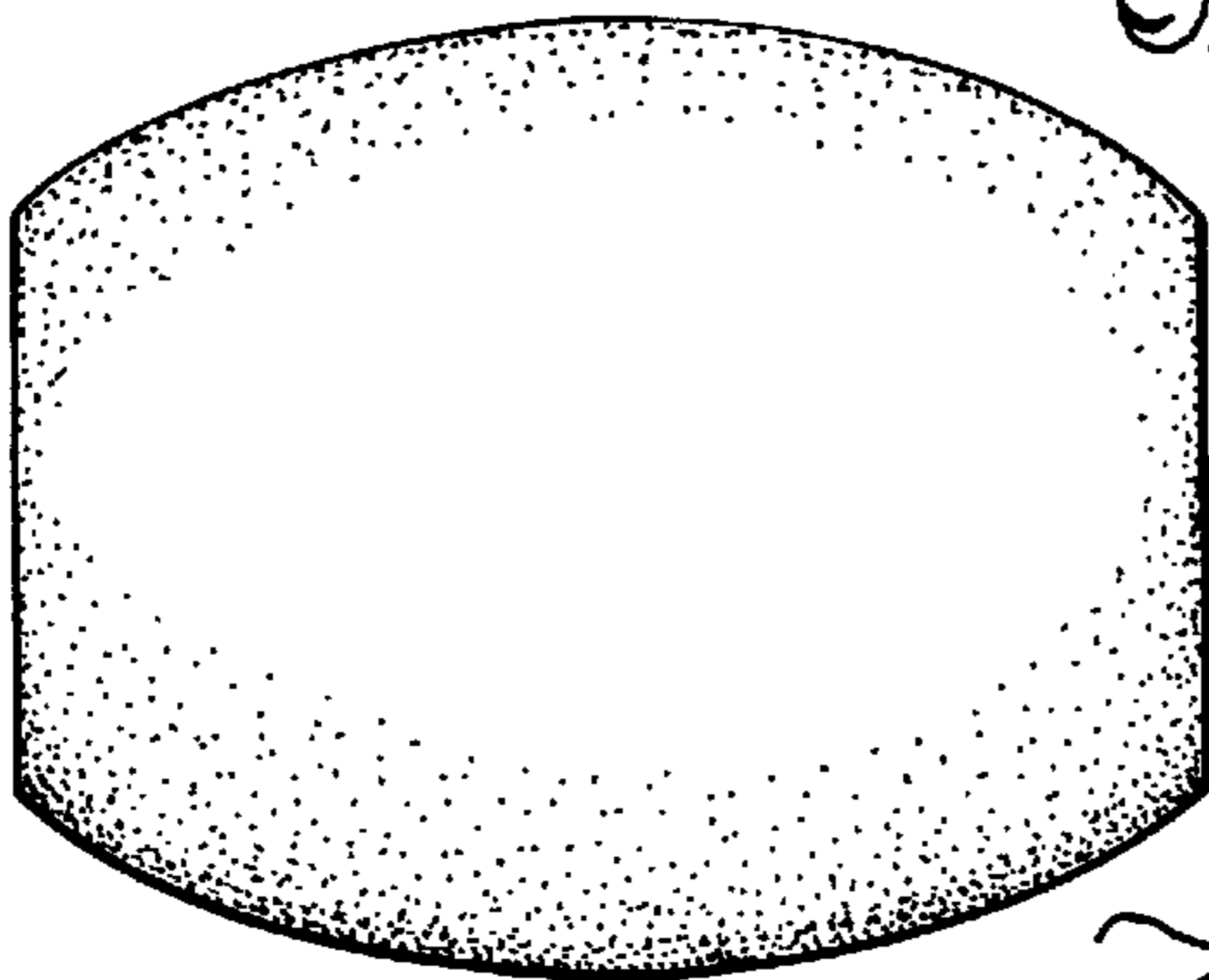

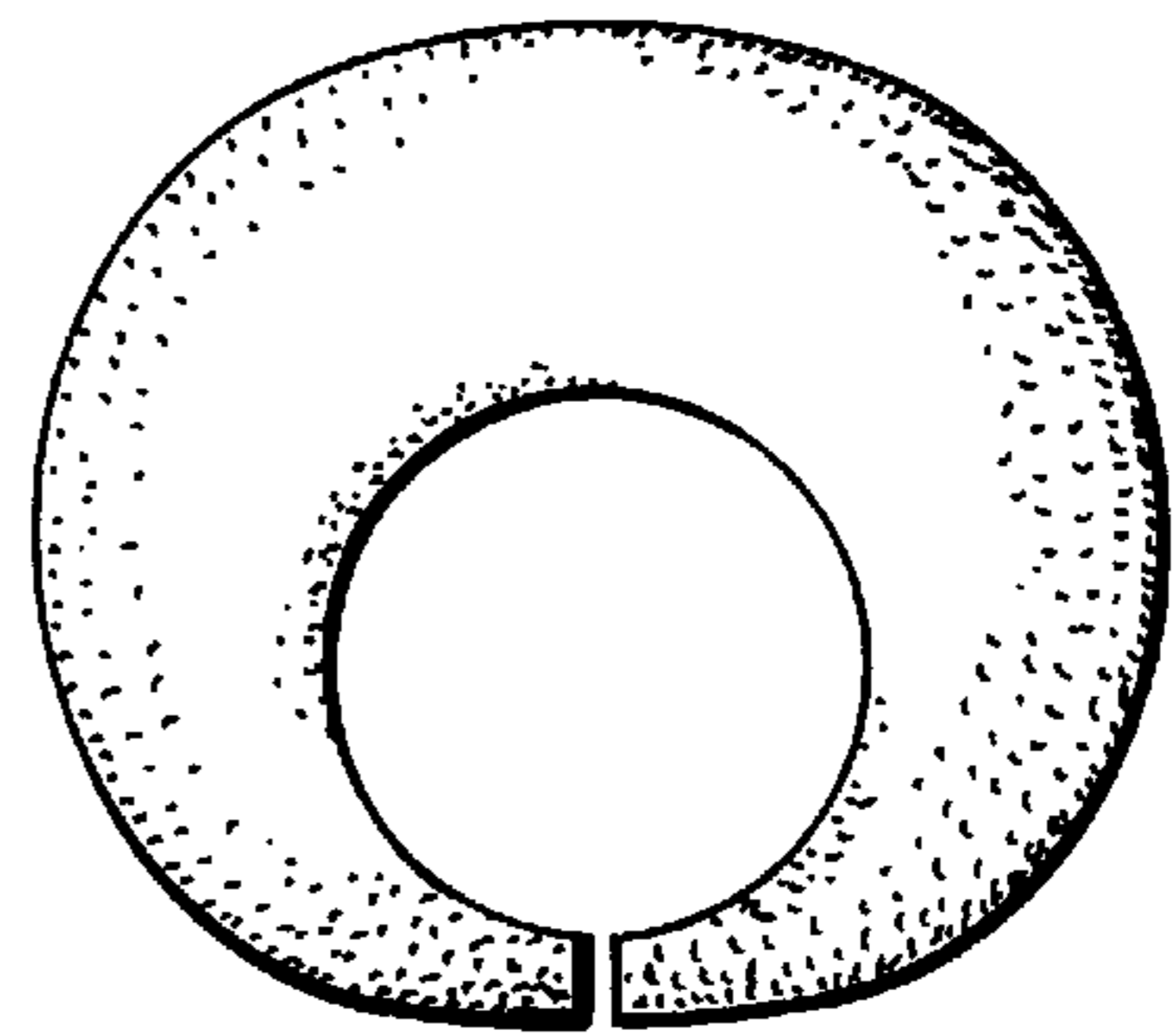

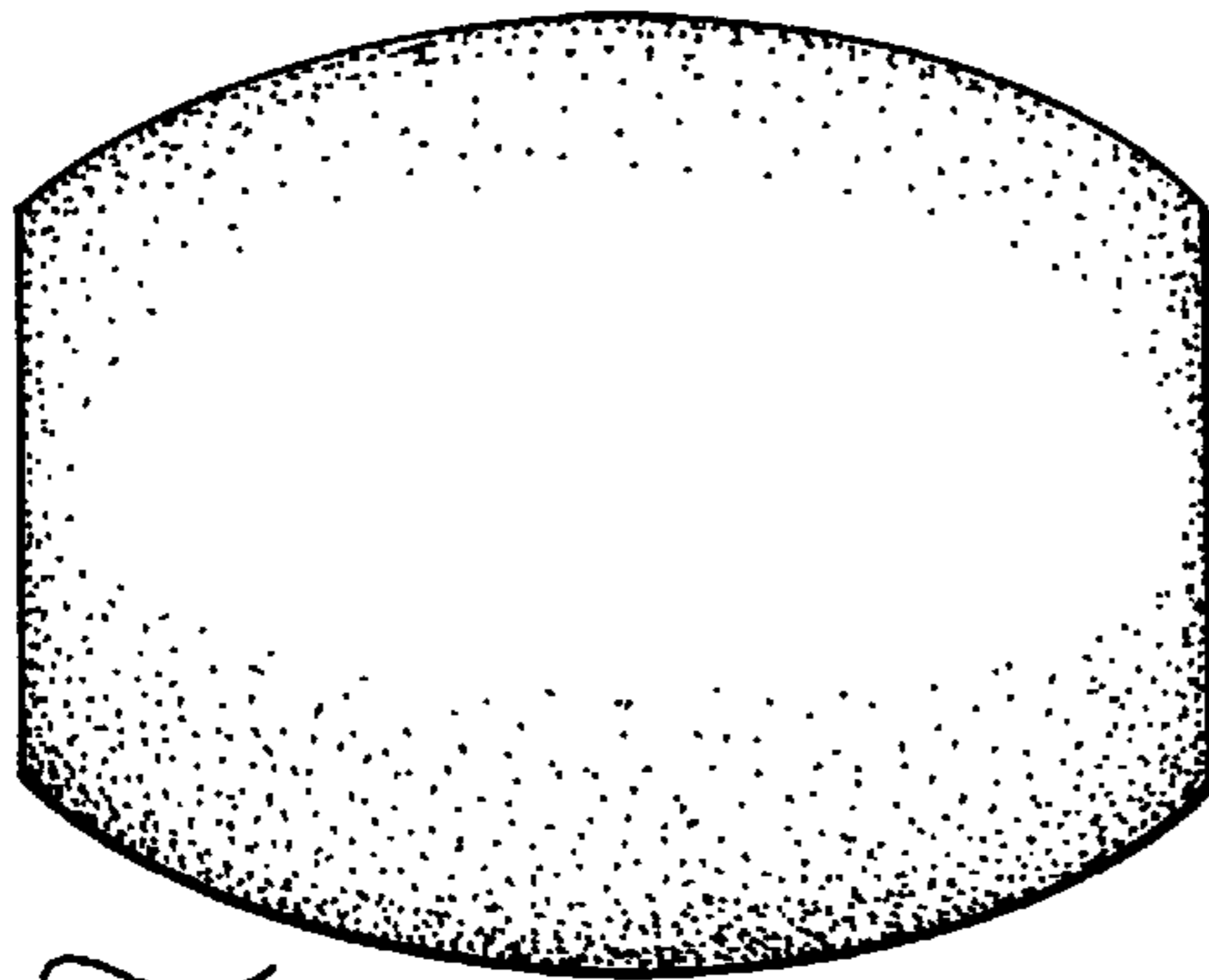

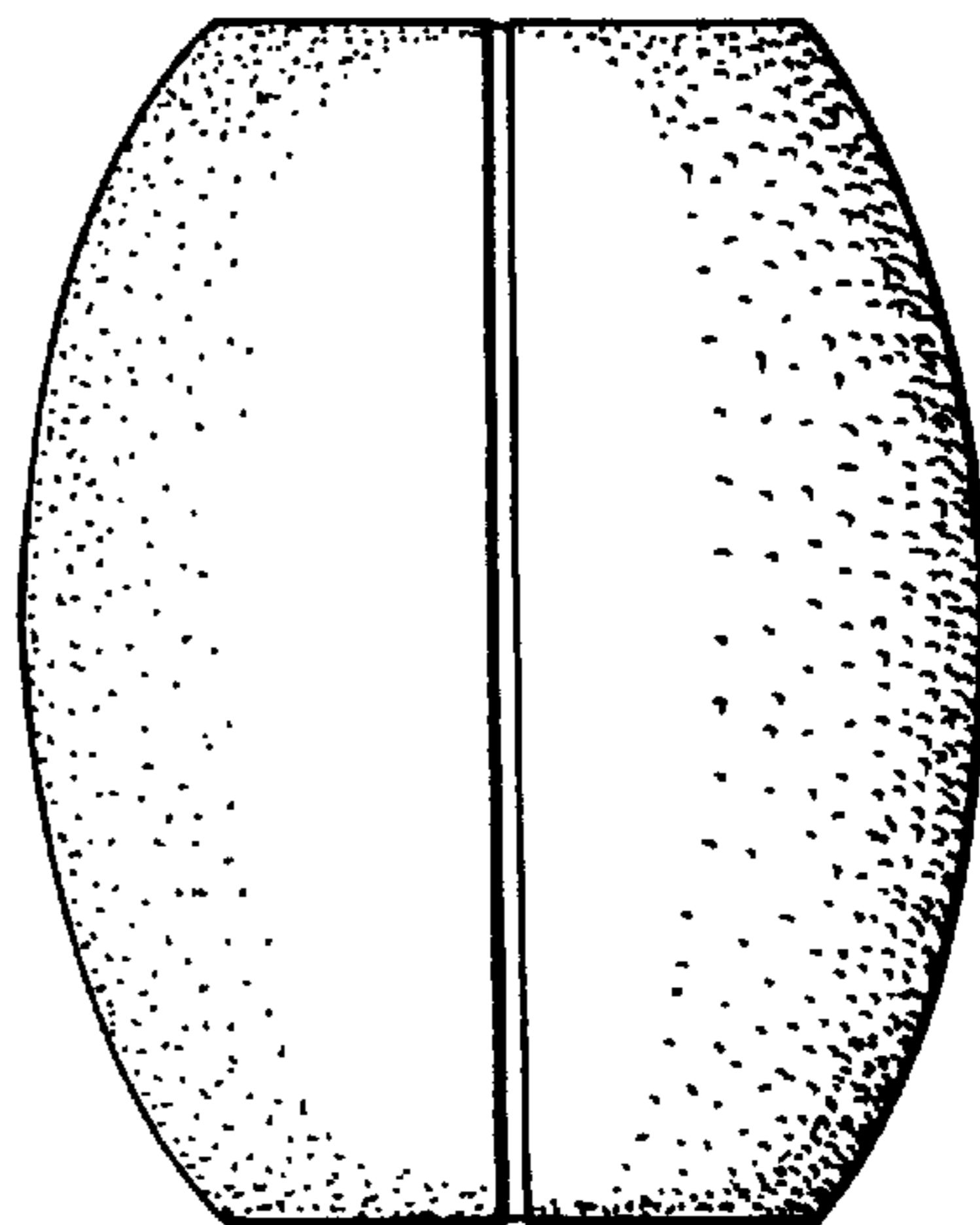
