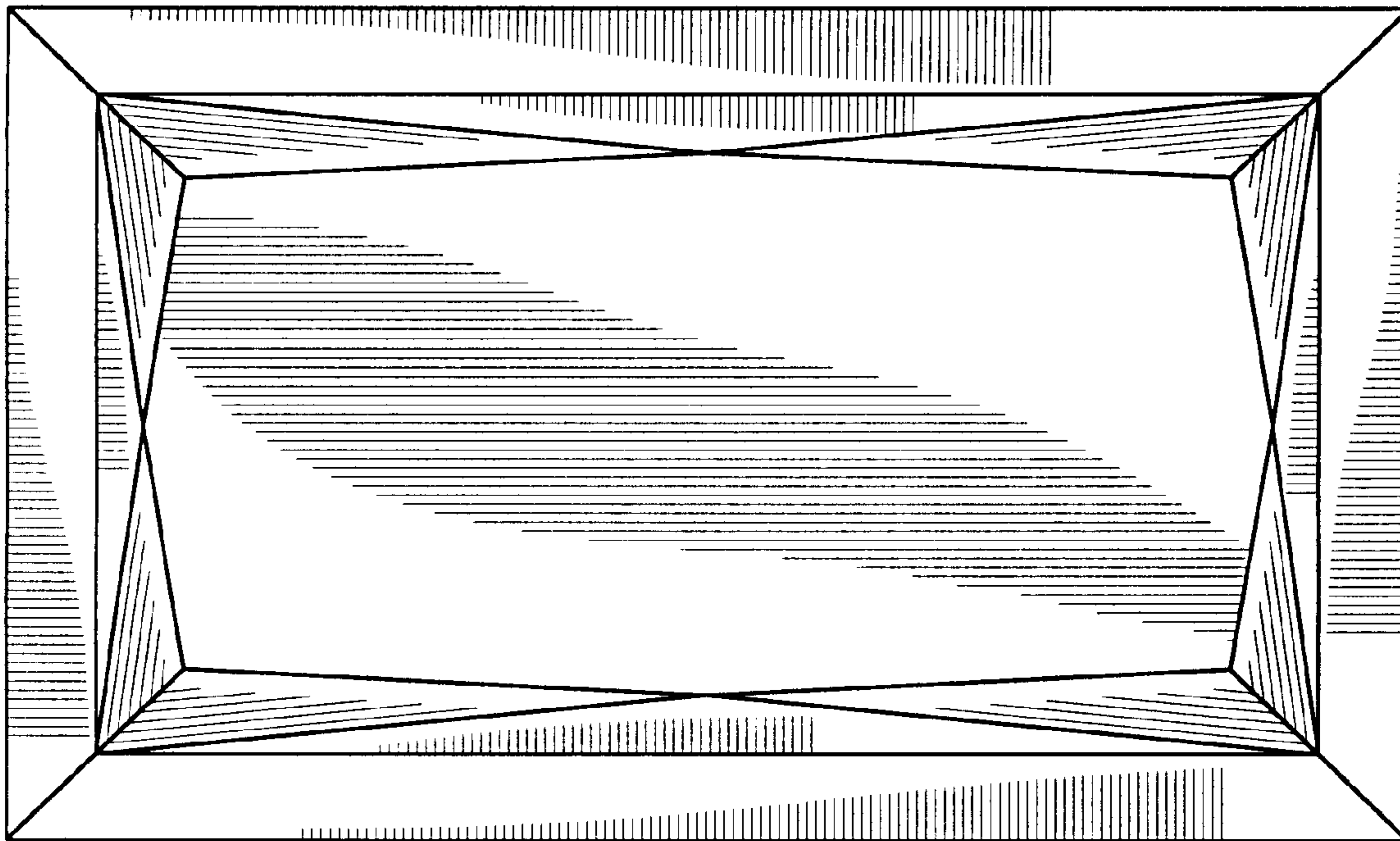
FIG. 1 is the top view of the precious gemstone design.

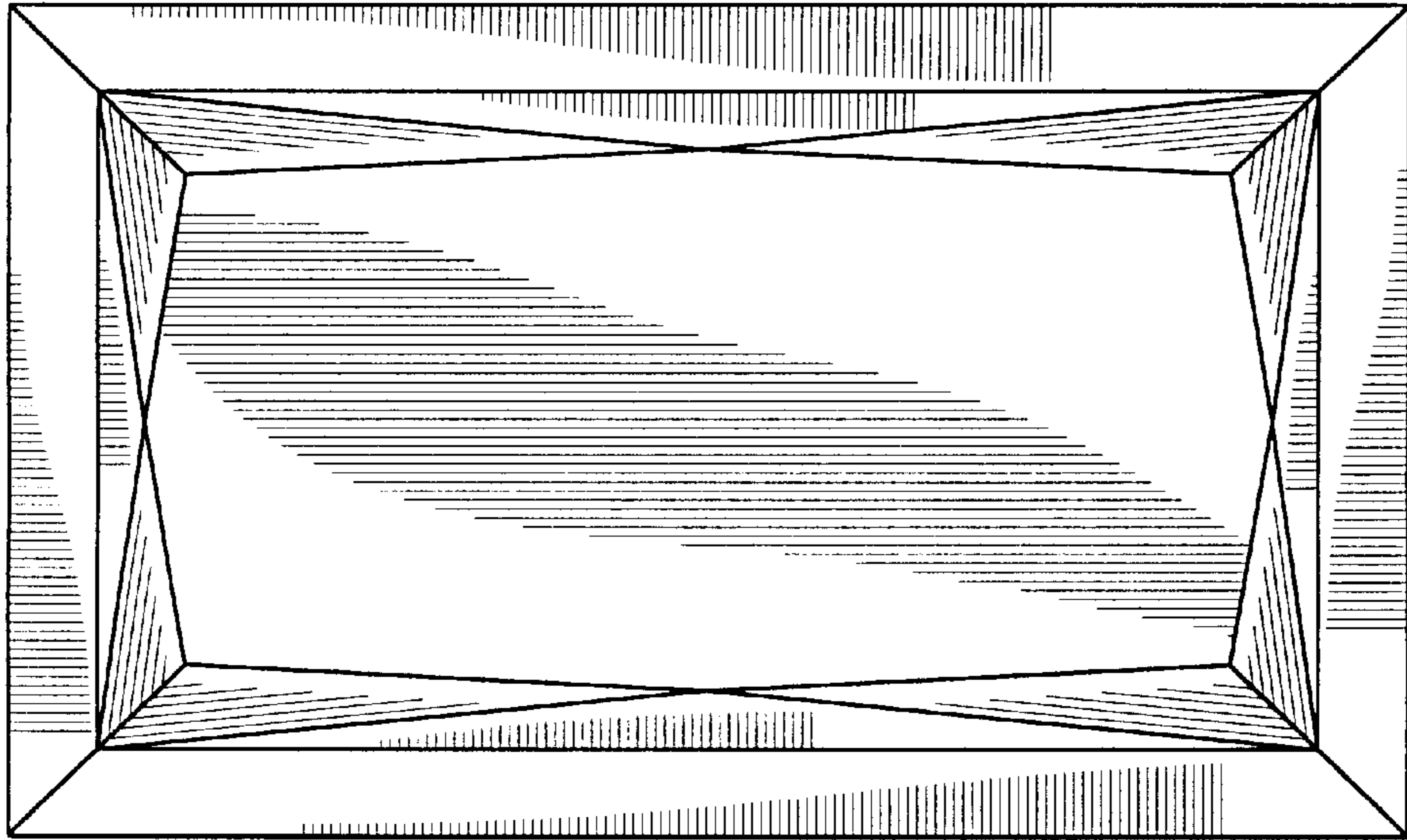

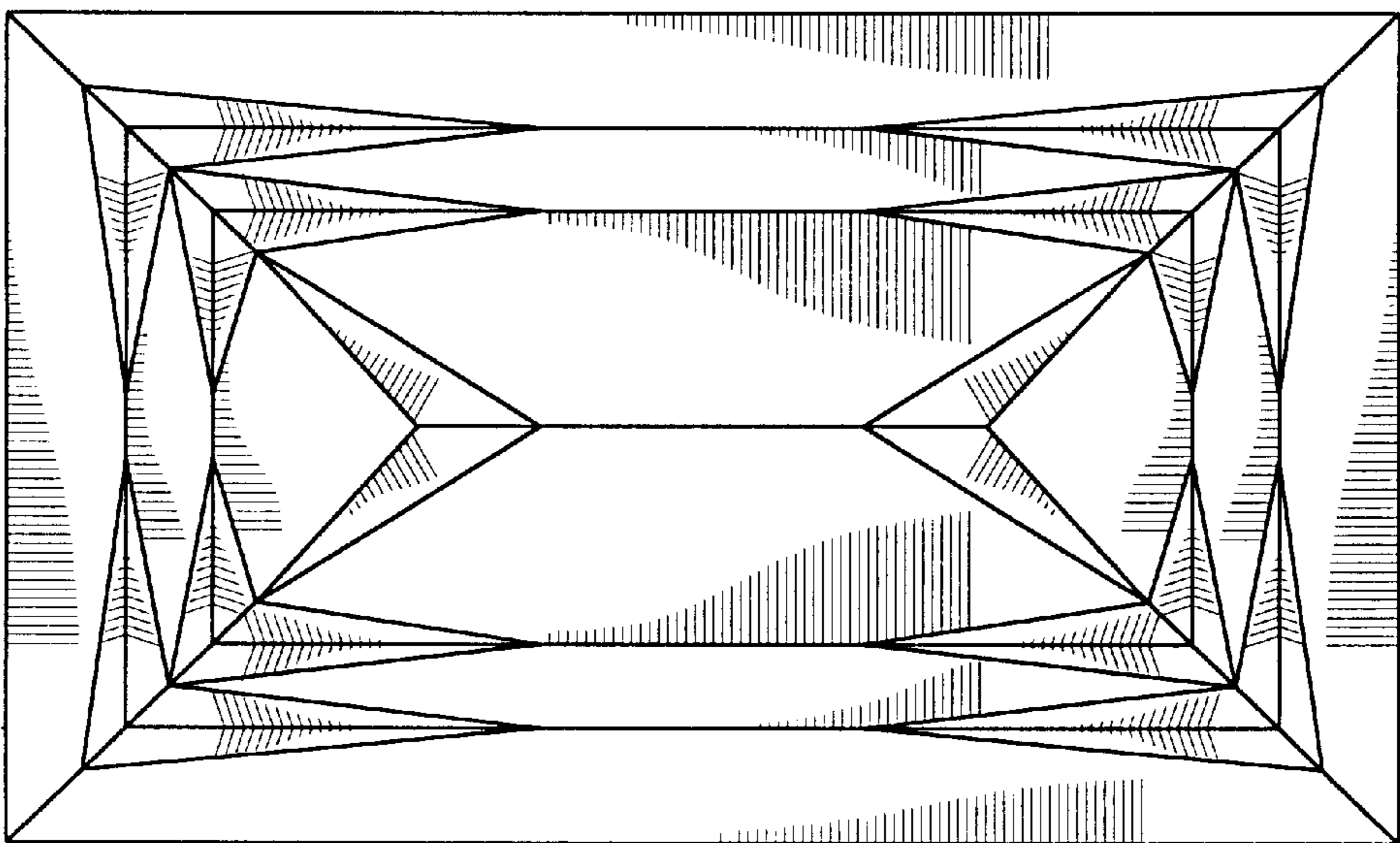

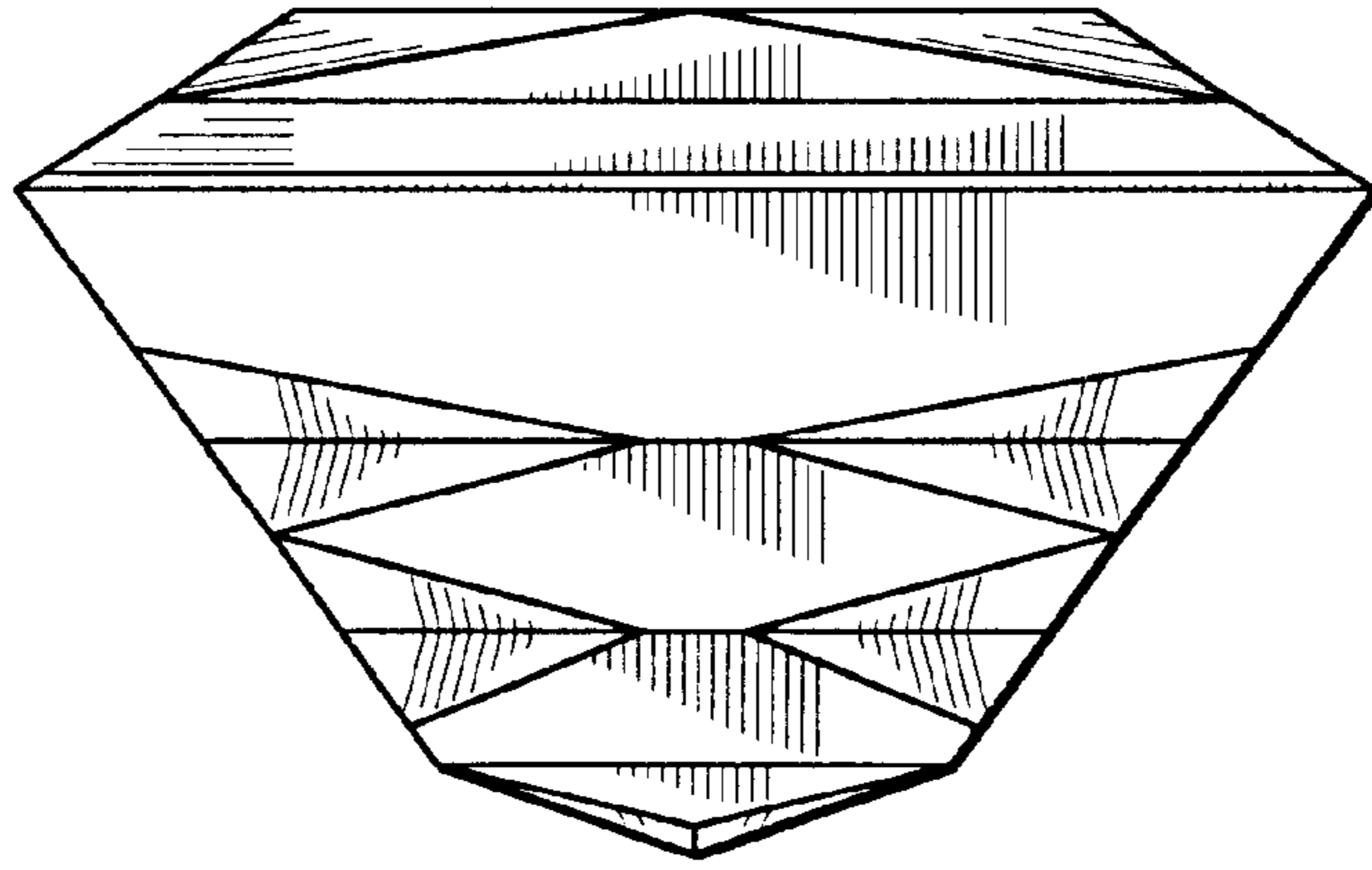

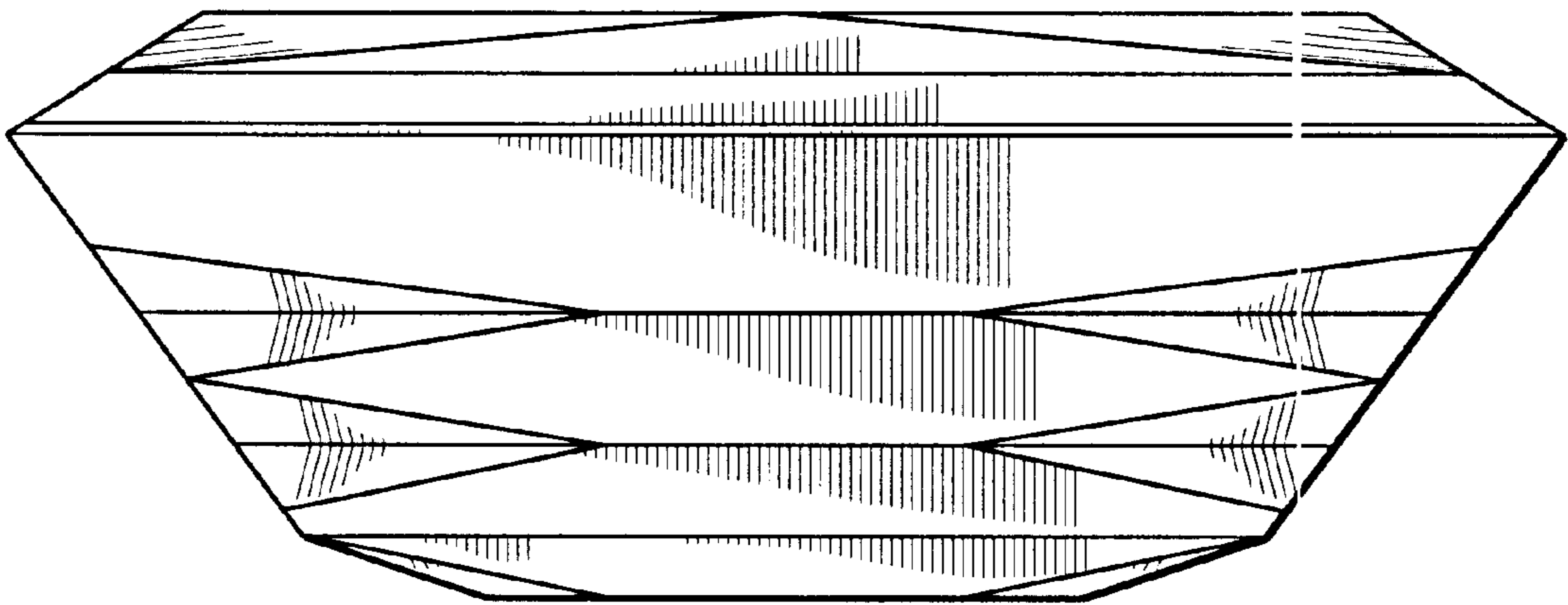

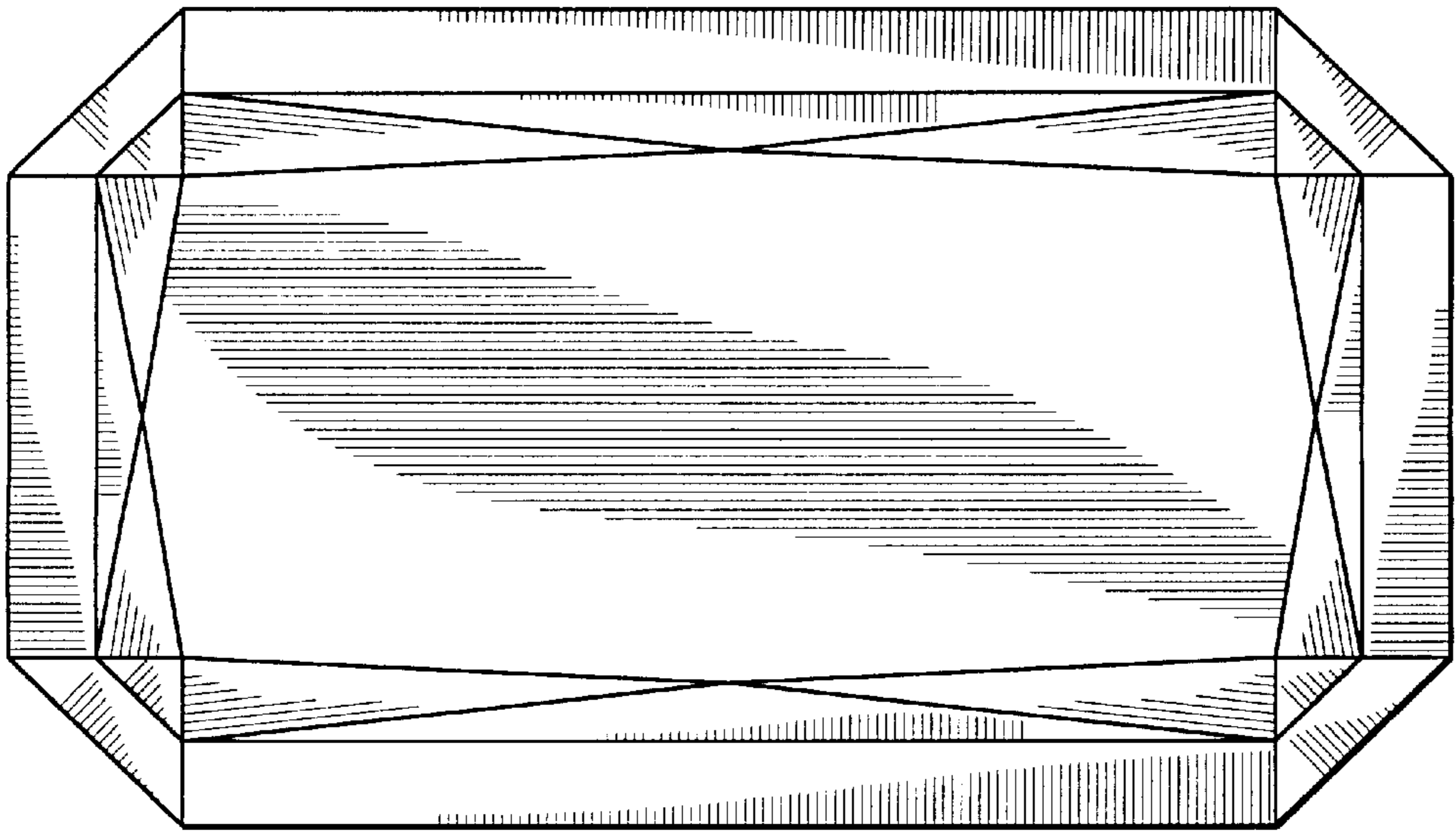

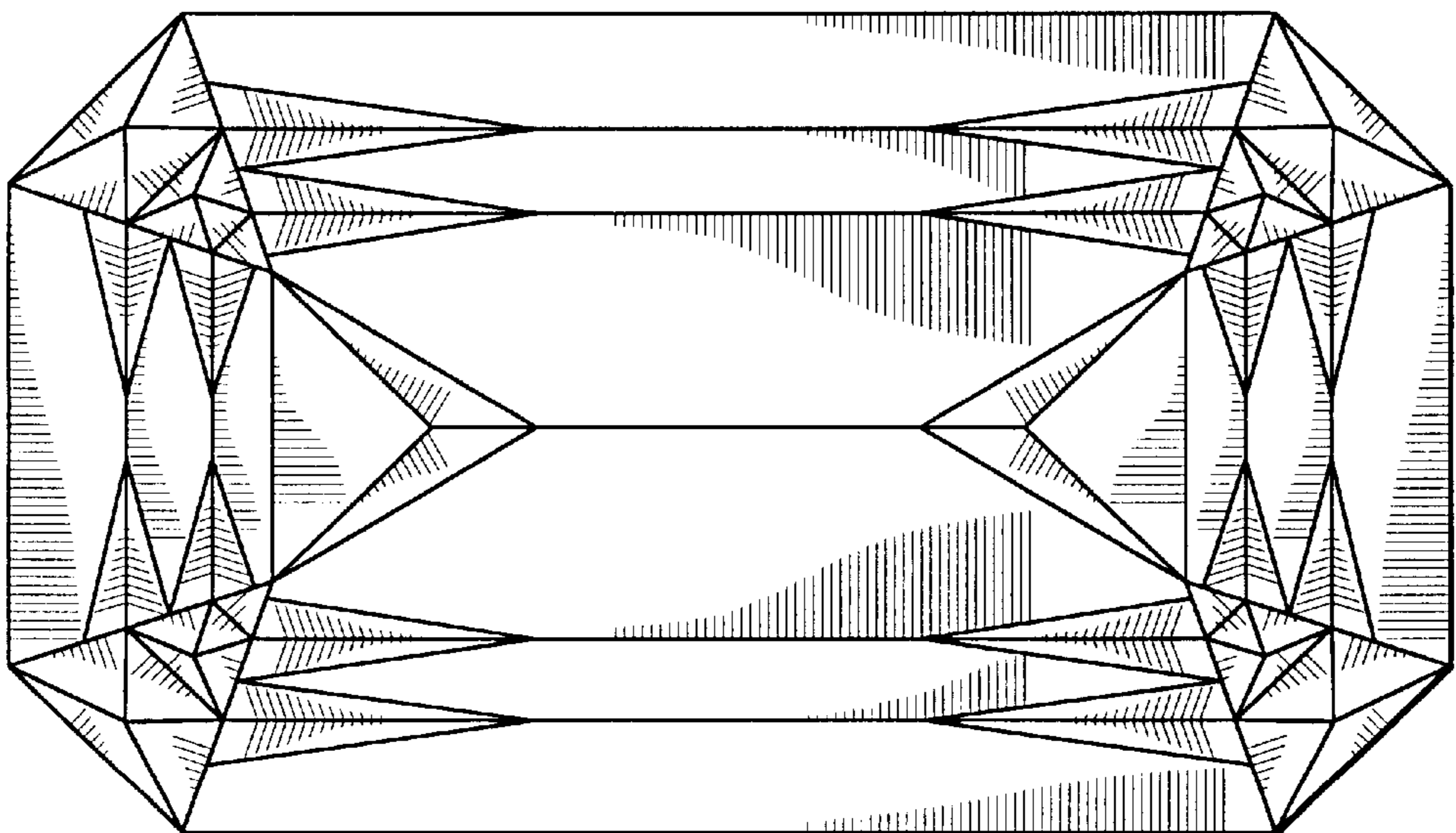

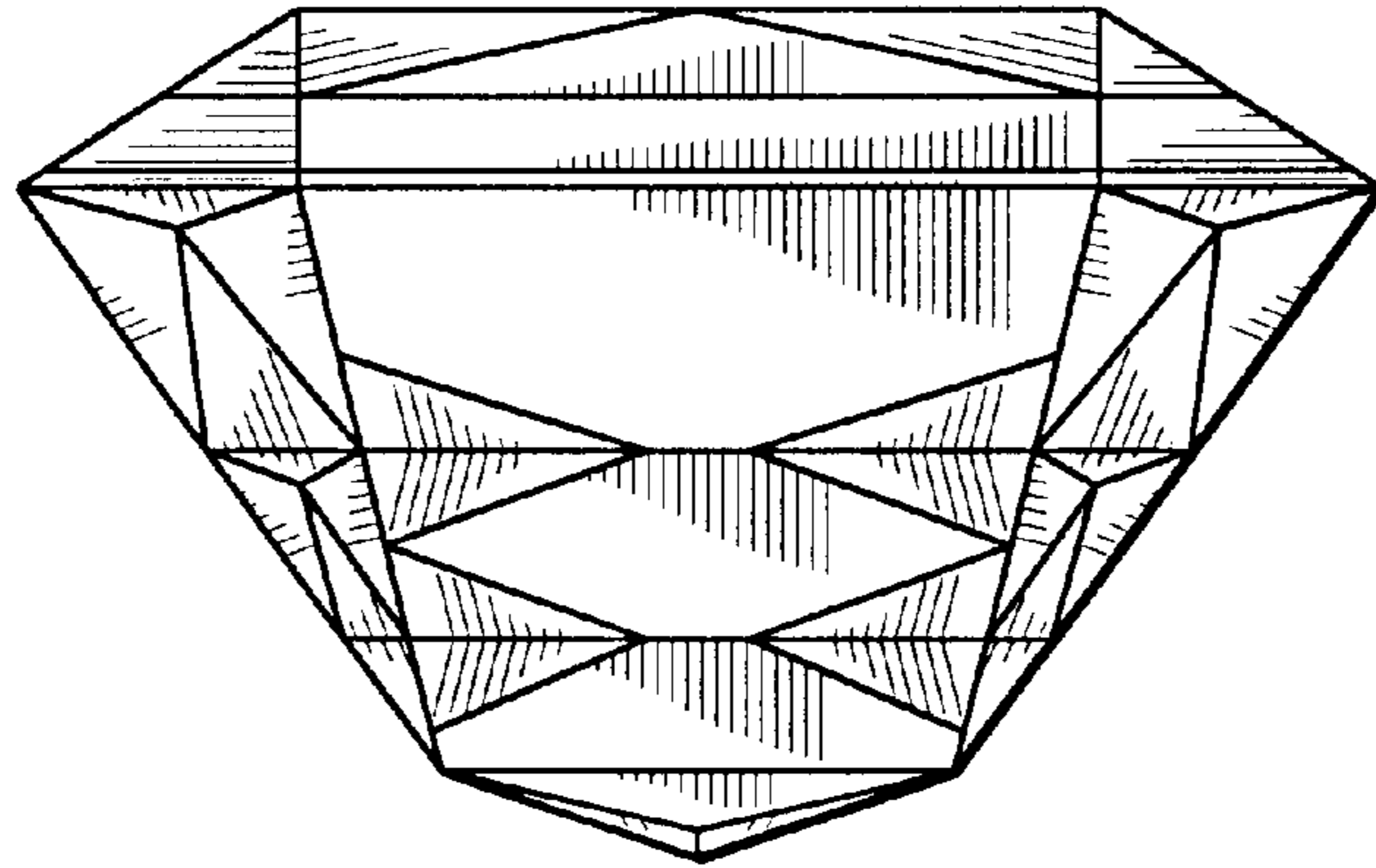

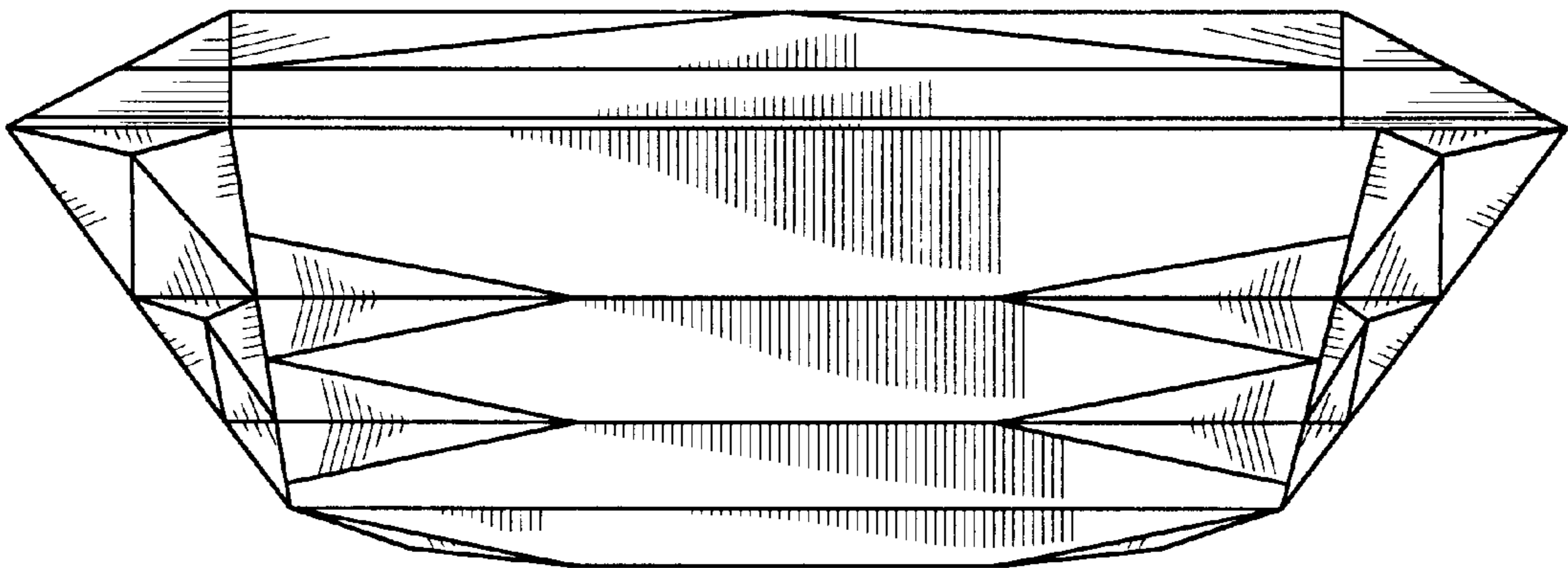

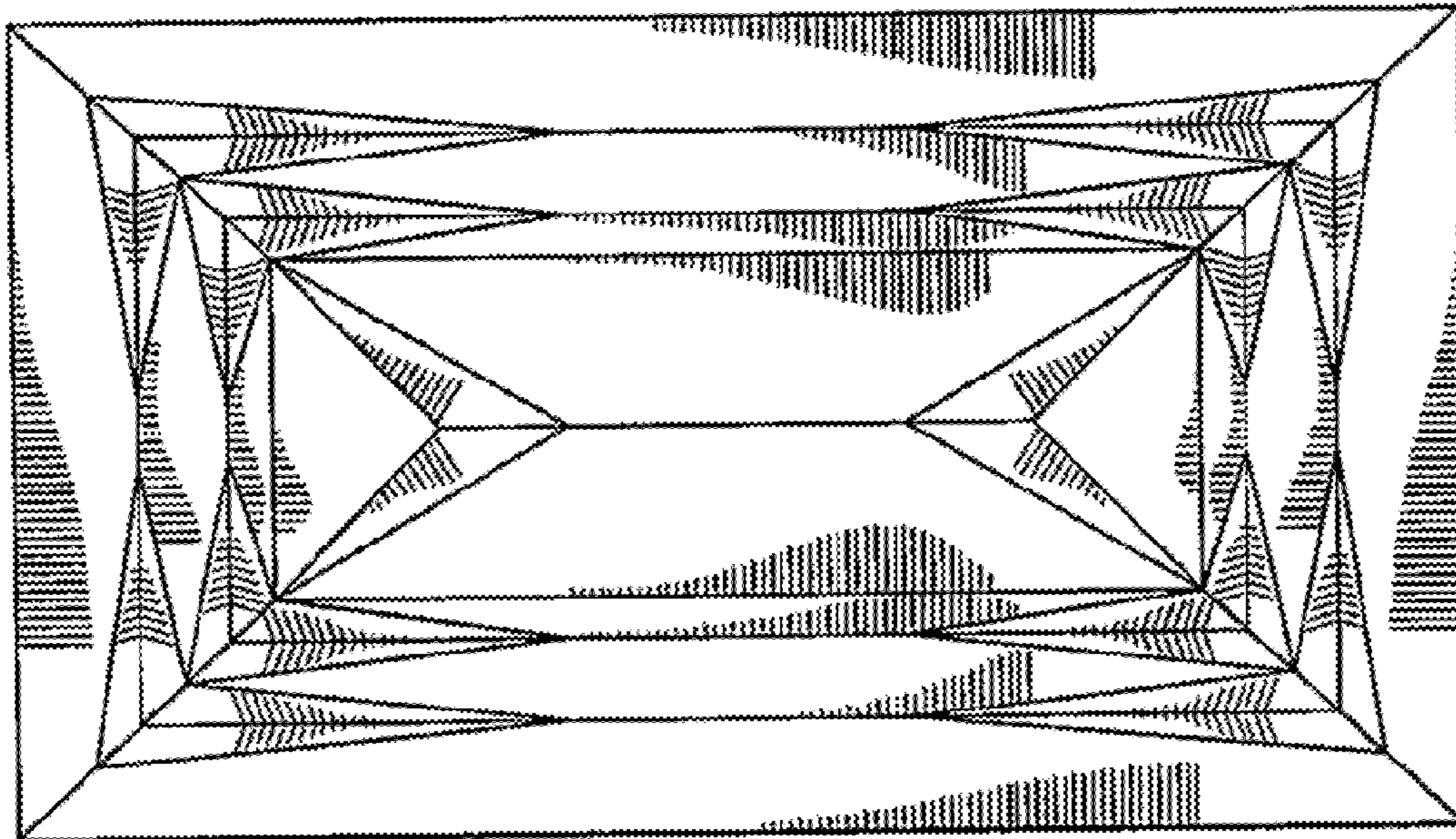

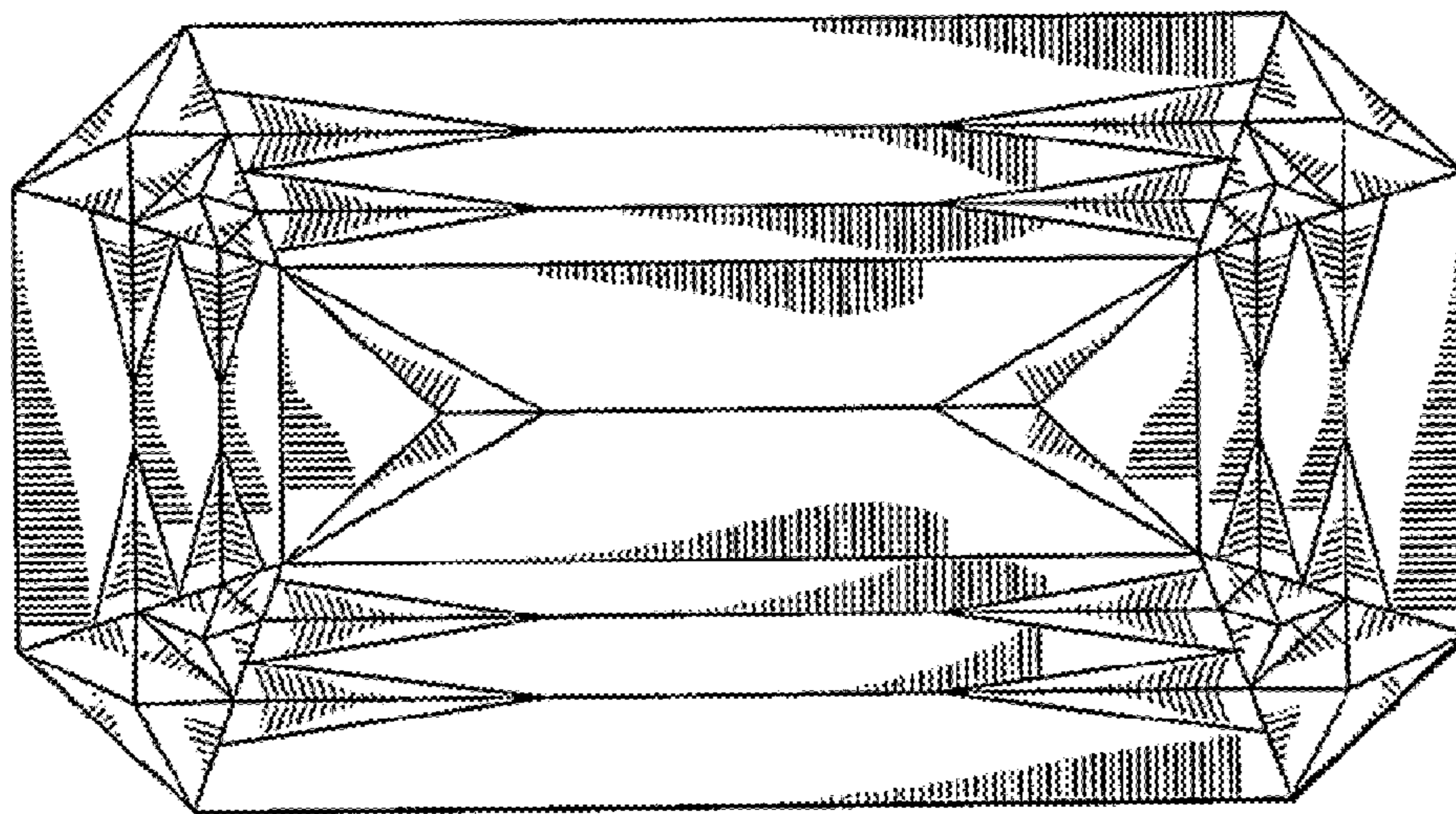
