[57] CLAIM

The ornamental design for a belt-mountable wallet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the belt-mountable wallet showing my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a side elevation view thereof;

FIG. 4 is a rear elevation view thereof;

FIG. 5 is a side elevation view thereof;

FIG. 6 is a top view thereof;

FIG. 7 is a bottom view thereof; and,

FIG. 8 is a perspective view thereof in combination with an optional shoulder strap.

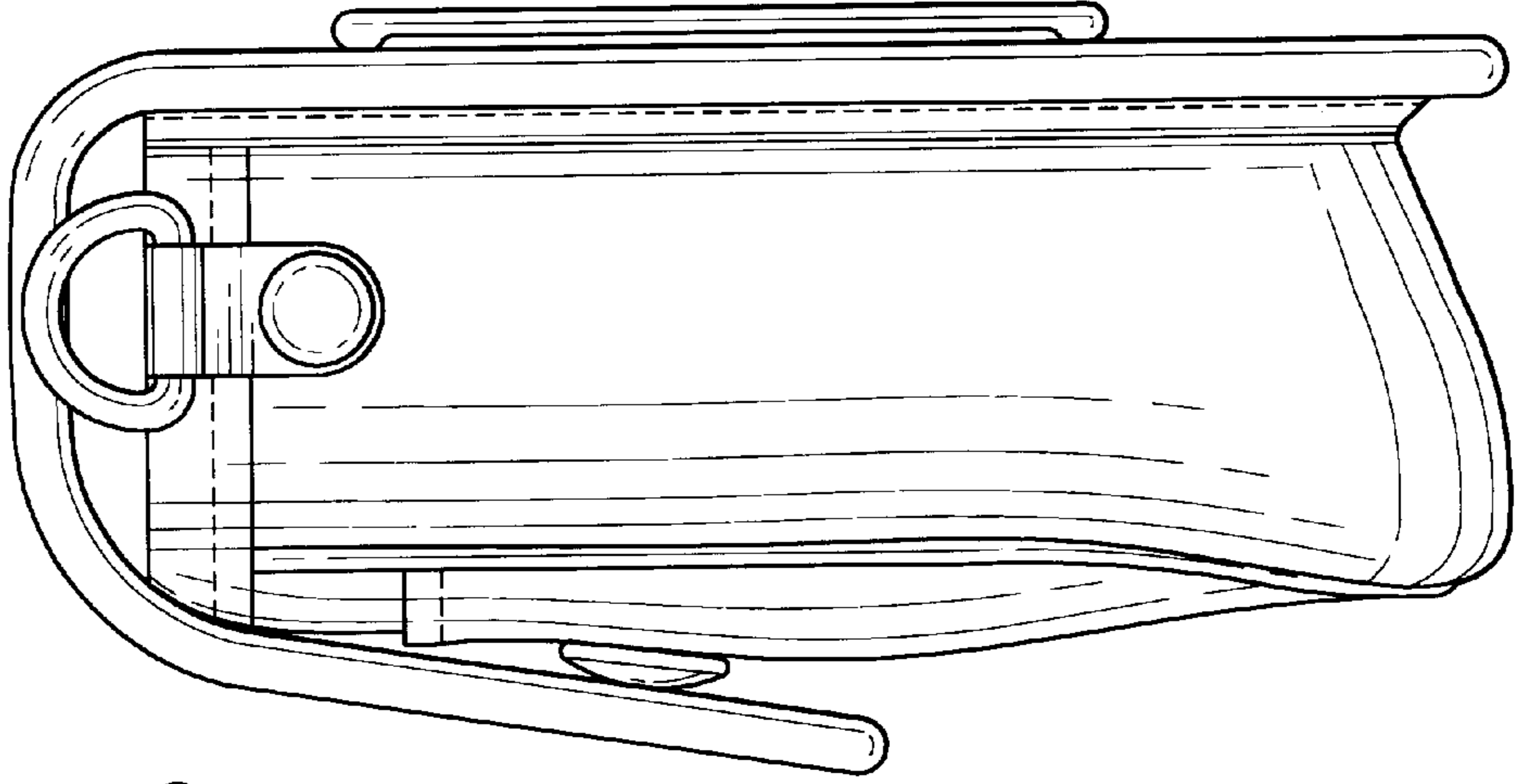

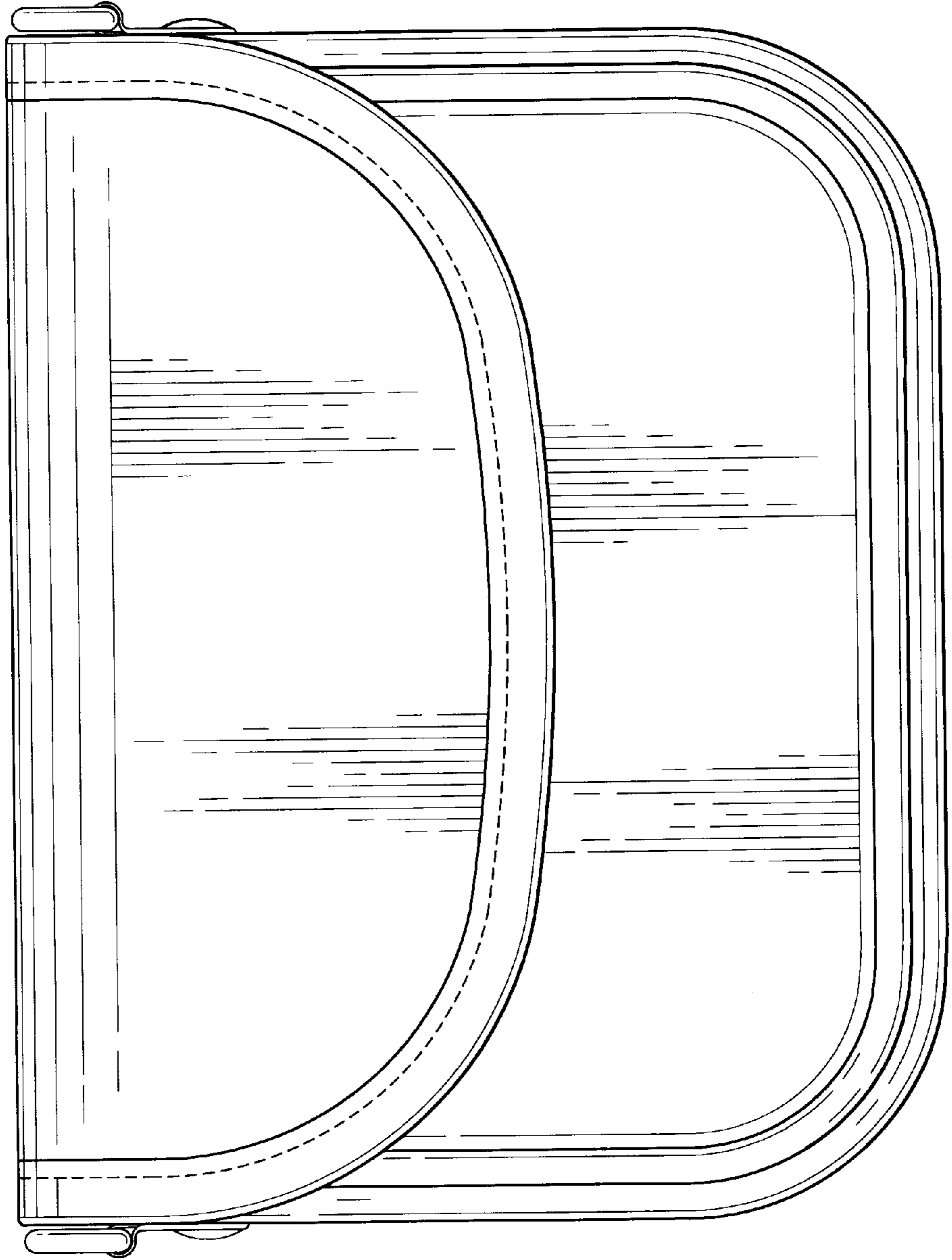

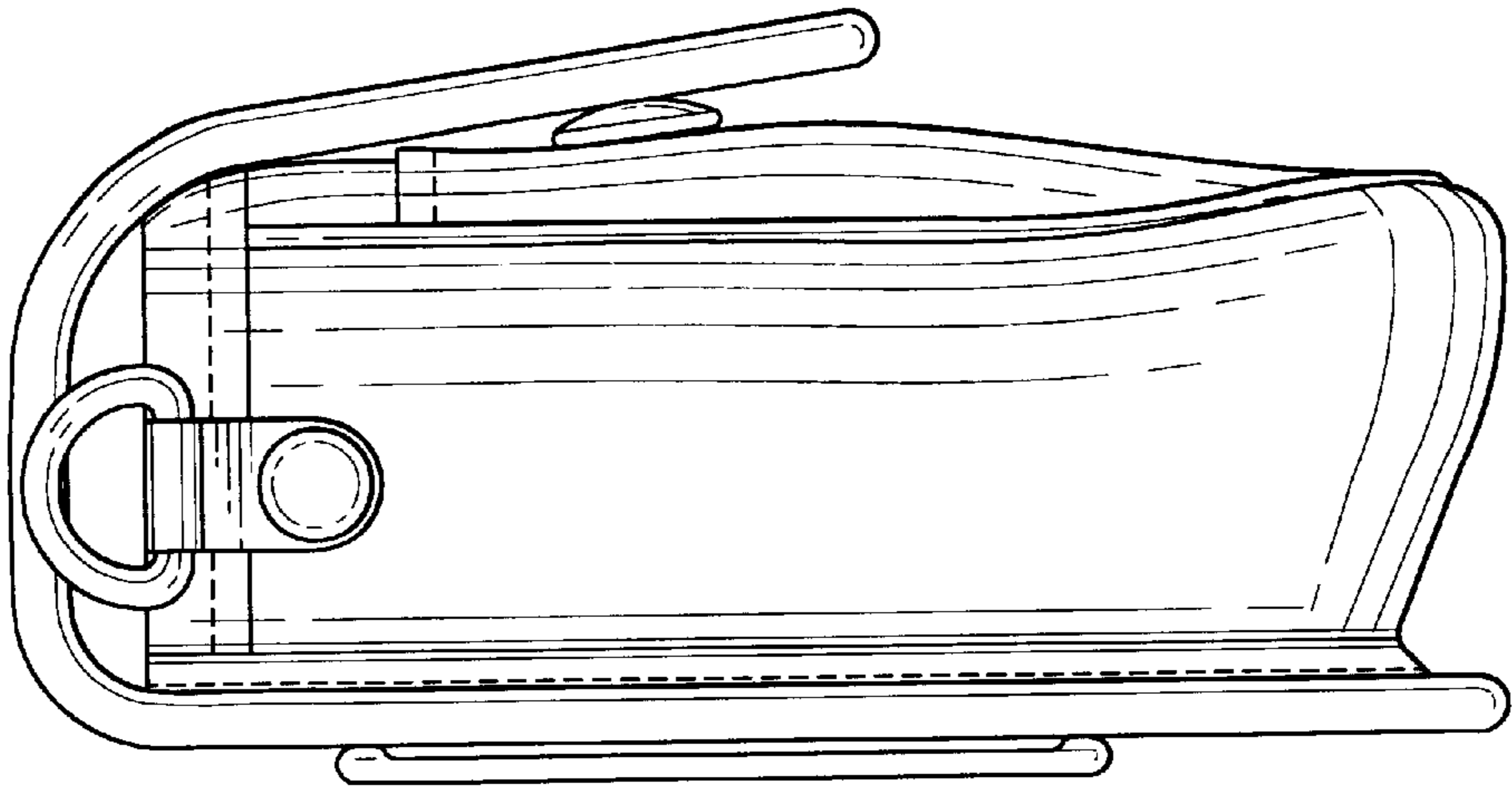

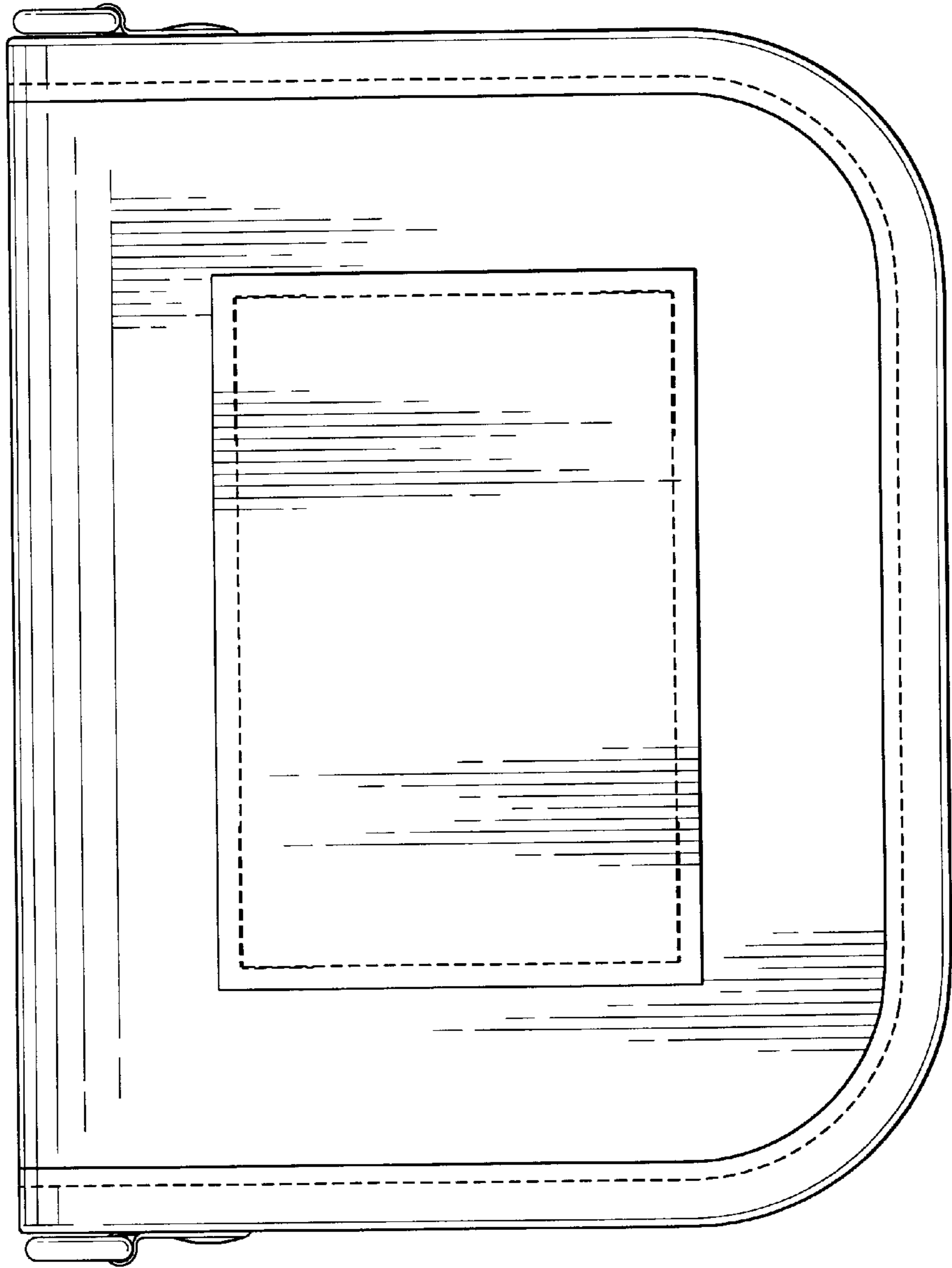

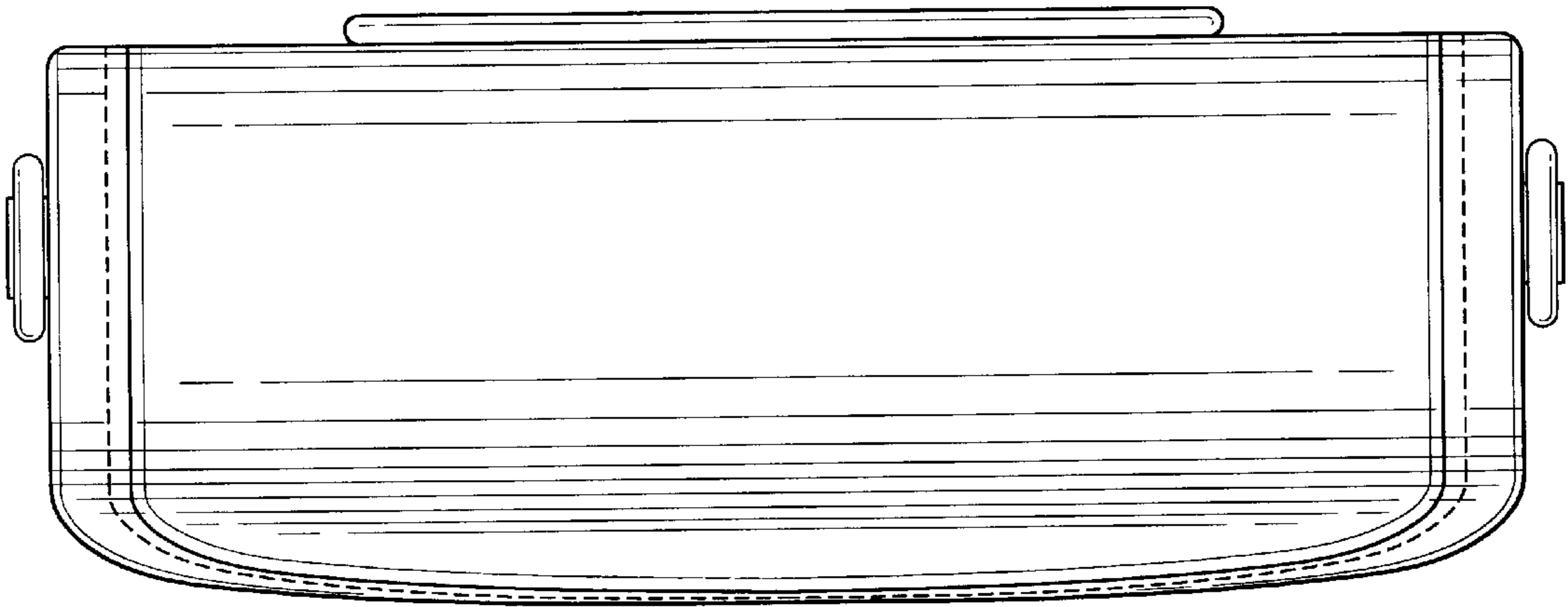

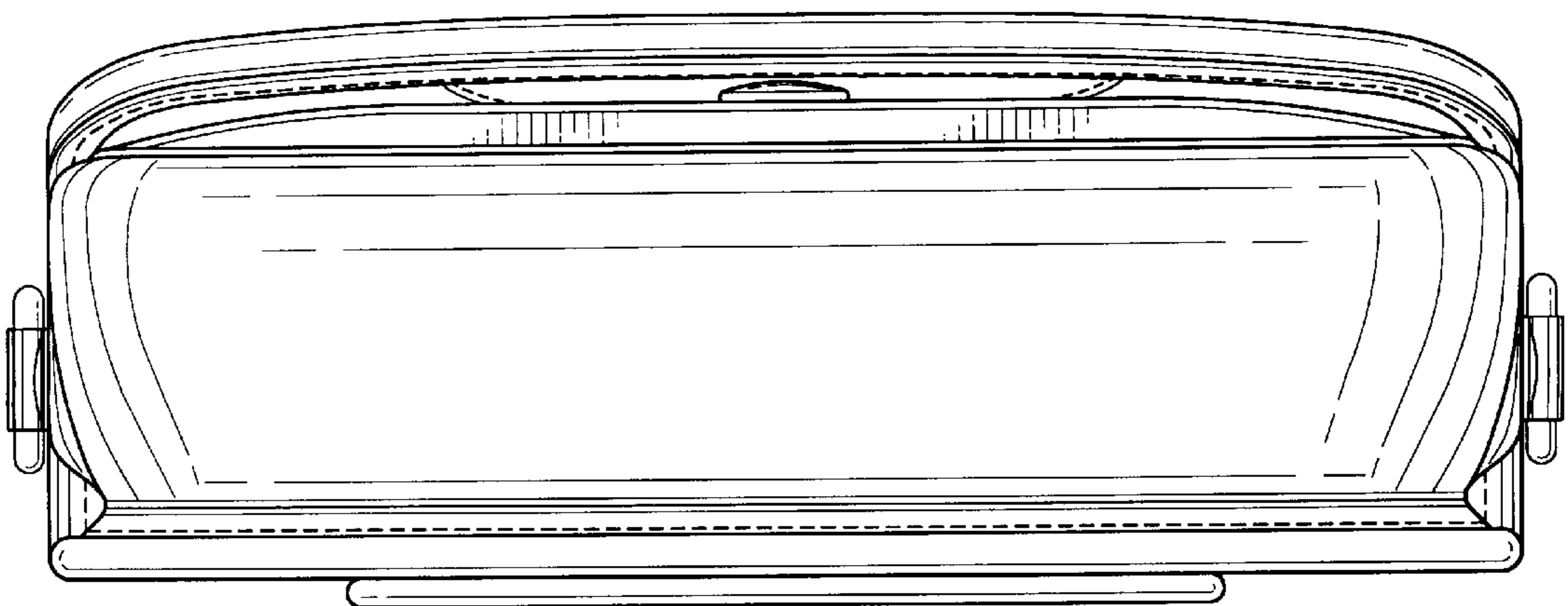
