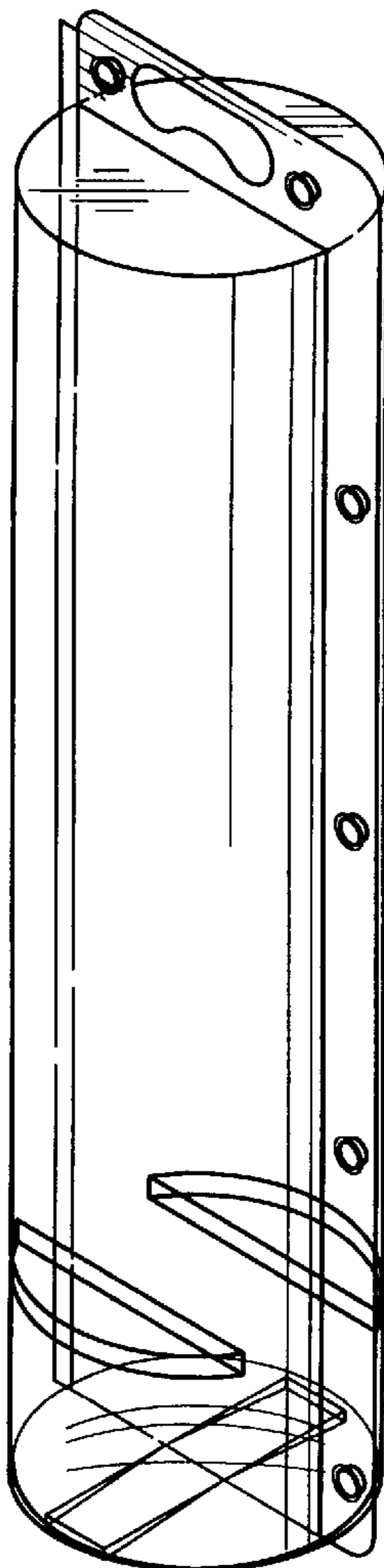
[57] **CLAIM**

**DESCRIPTION**

FIG. 1 shows a perspective view of my design for a plant package;  
FIG. 2 shows a side view thereof;

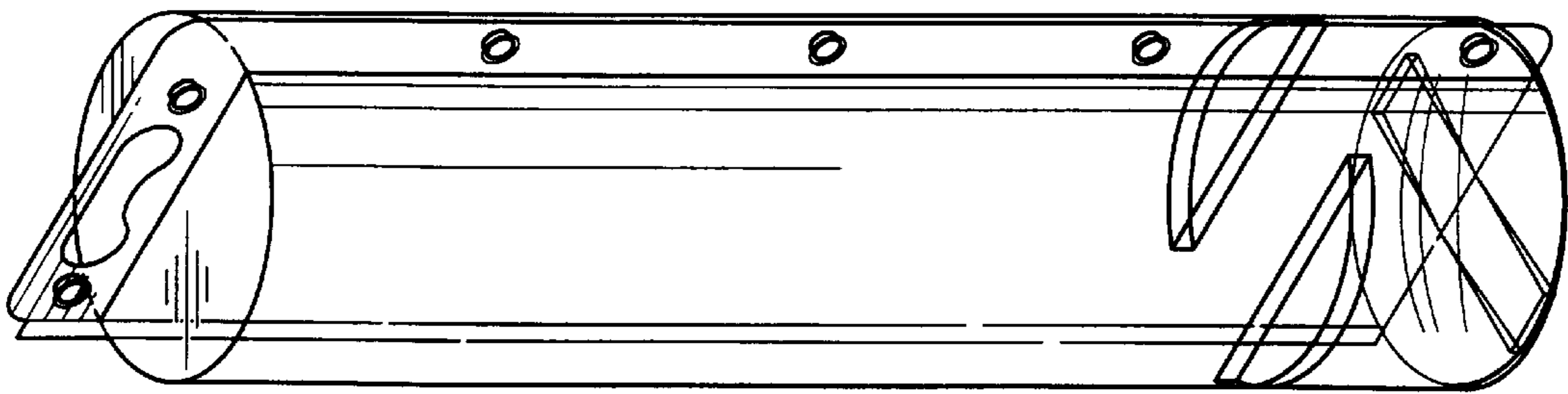

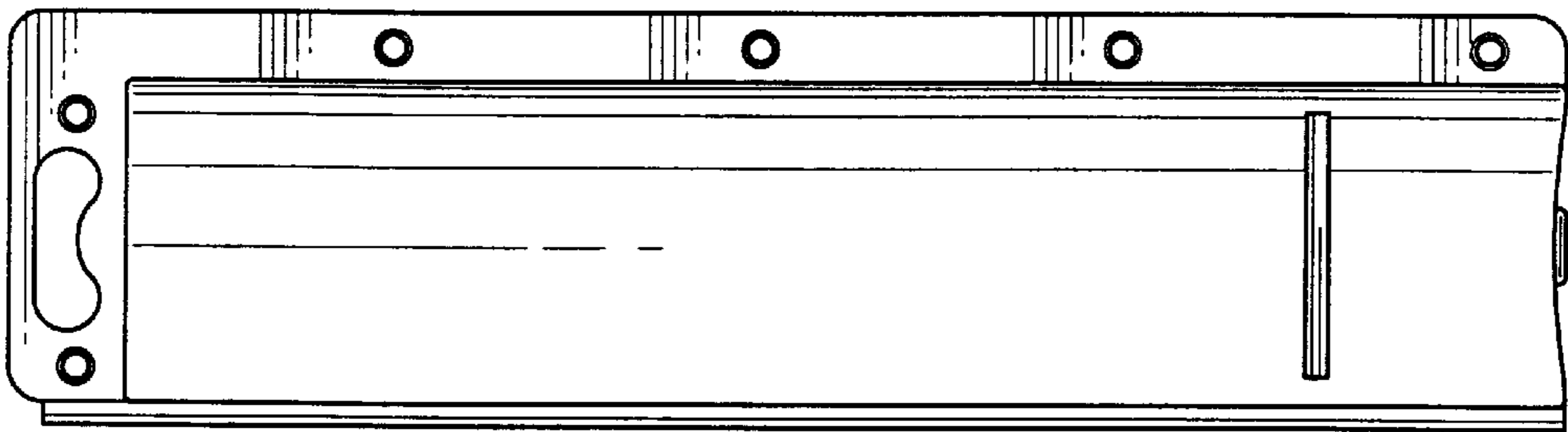

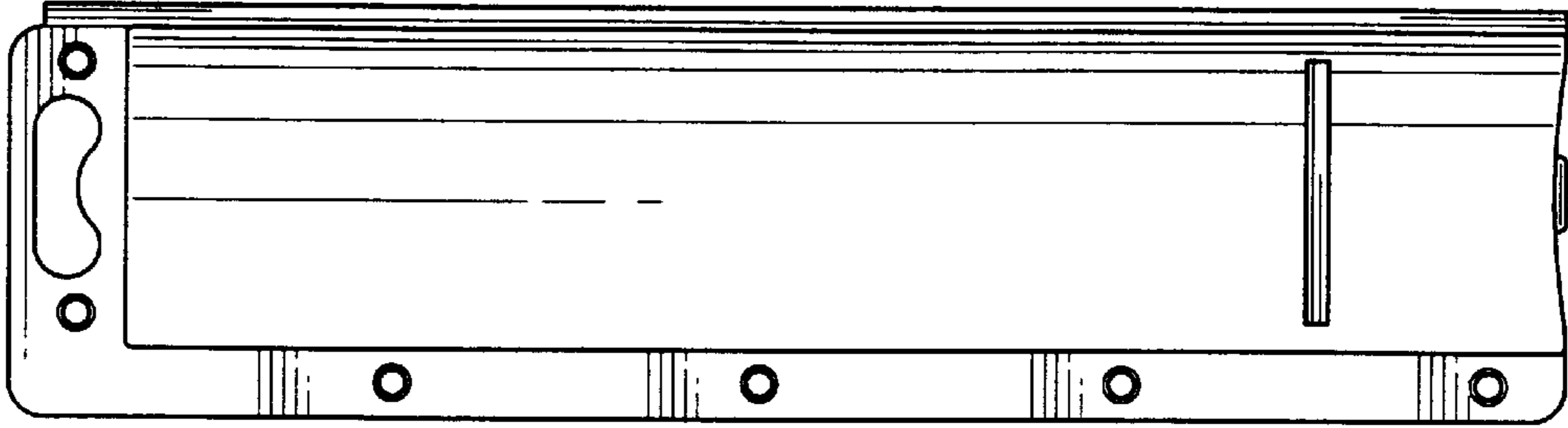

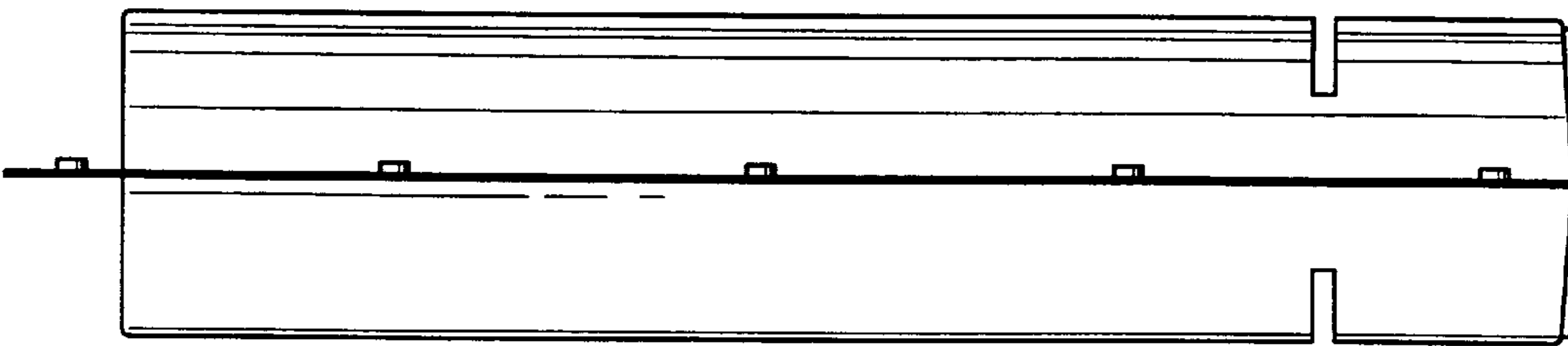

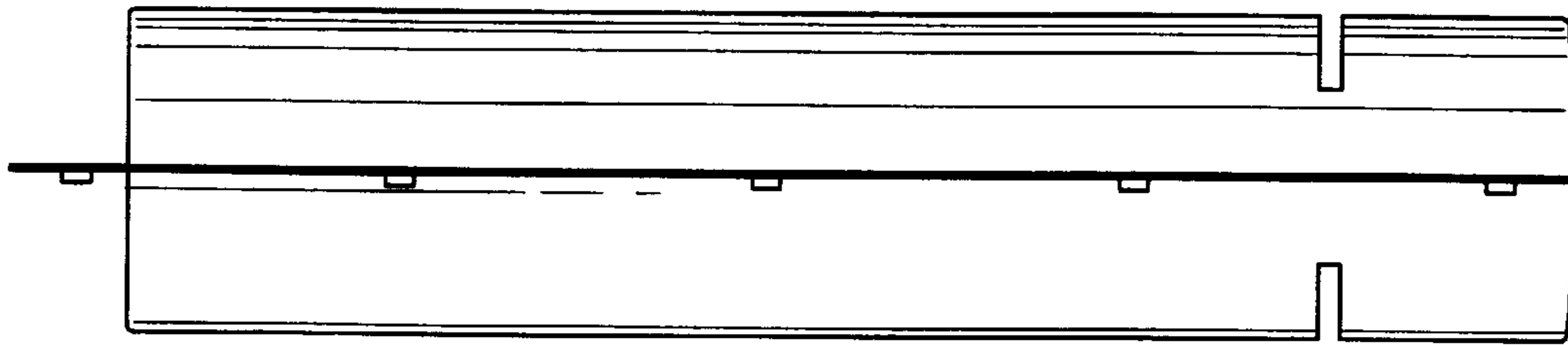

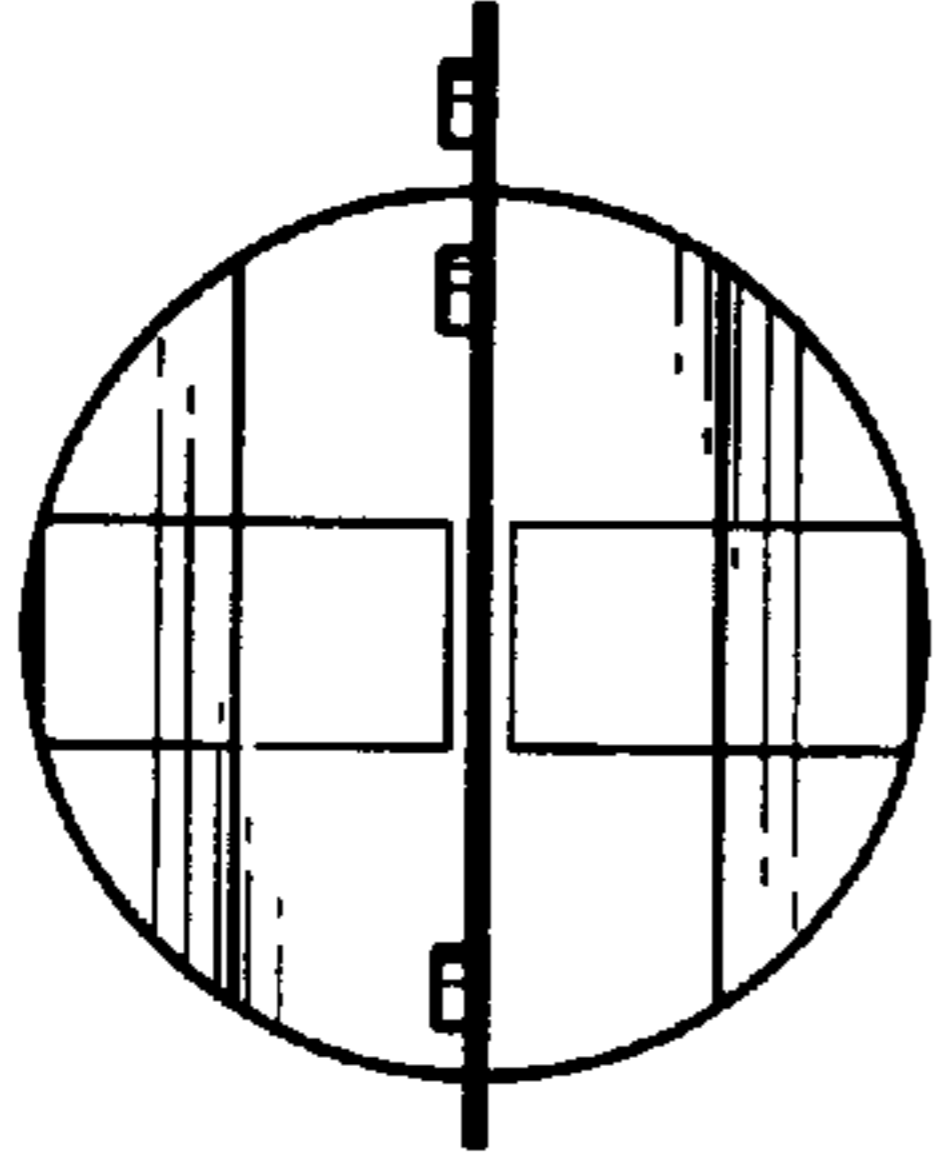

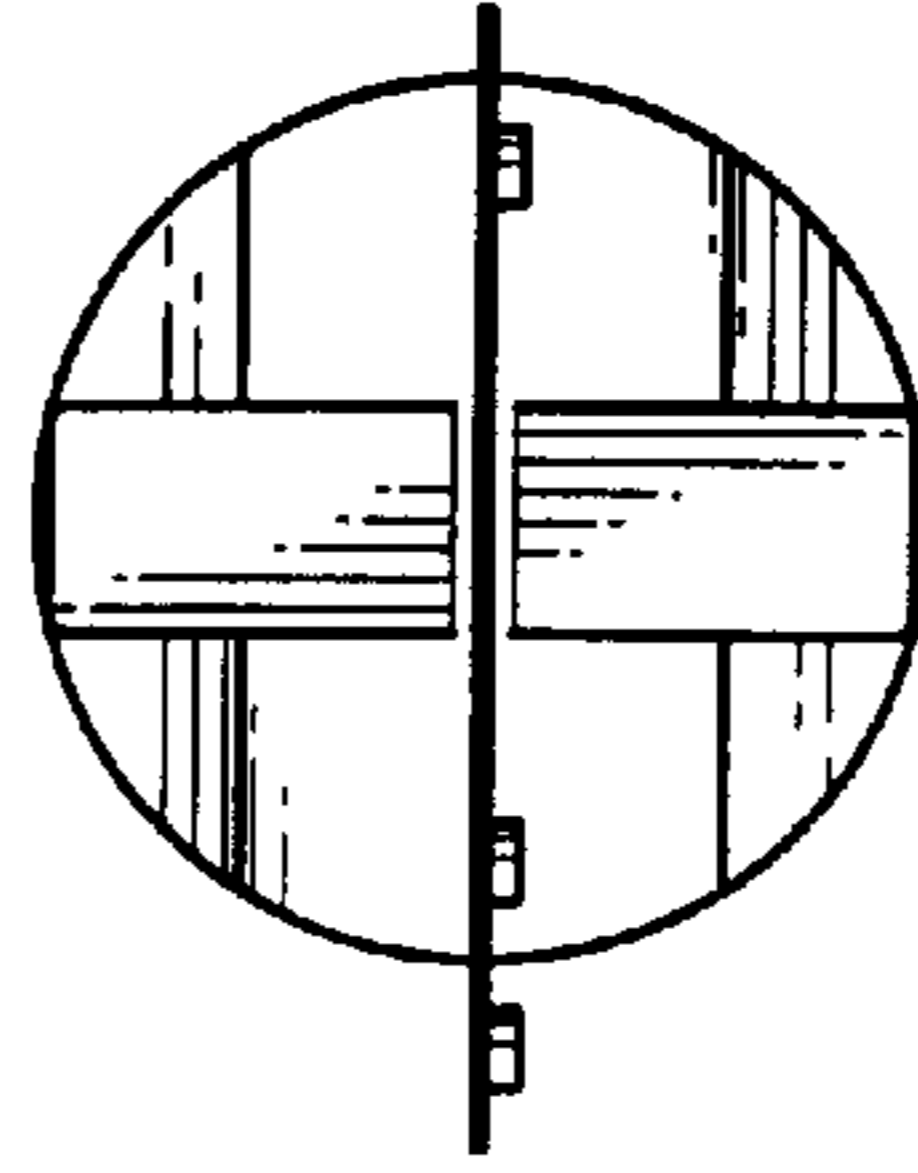
