[57] **CLAIM**

The ornamental design for a football hitch plug with a display surface, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a football hitch plug with a display surface showing my new design;  
 FIG. 2 is a front elevational view of the football hitch plug with a display surface;  
 FIG. 3 is a right side elevational view of the football hitch plug with a display surface;  
 FIG. 4 is a top plan view of the football hitch plug with a display surface and a bottom view of the football hitch plug with a display surface as the bottom and top views are identical;  
 FIG. 5 is a rear elevational view of the football hitch plug with a display surface; and,  
 FIG. 6 is a perspective view, shown at a reduced scale, of the football hitch plug with a display surface mounted on the hitch of a vehicle.

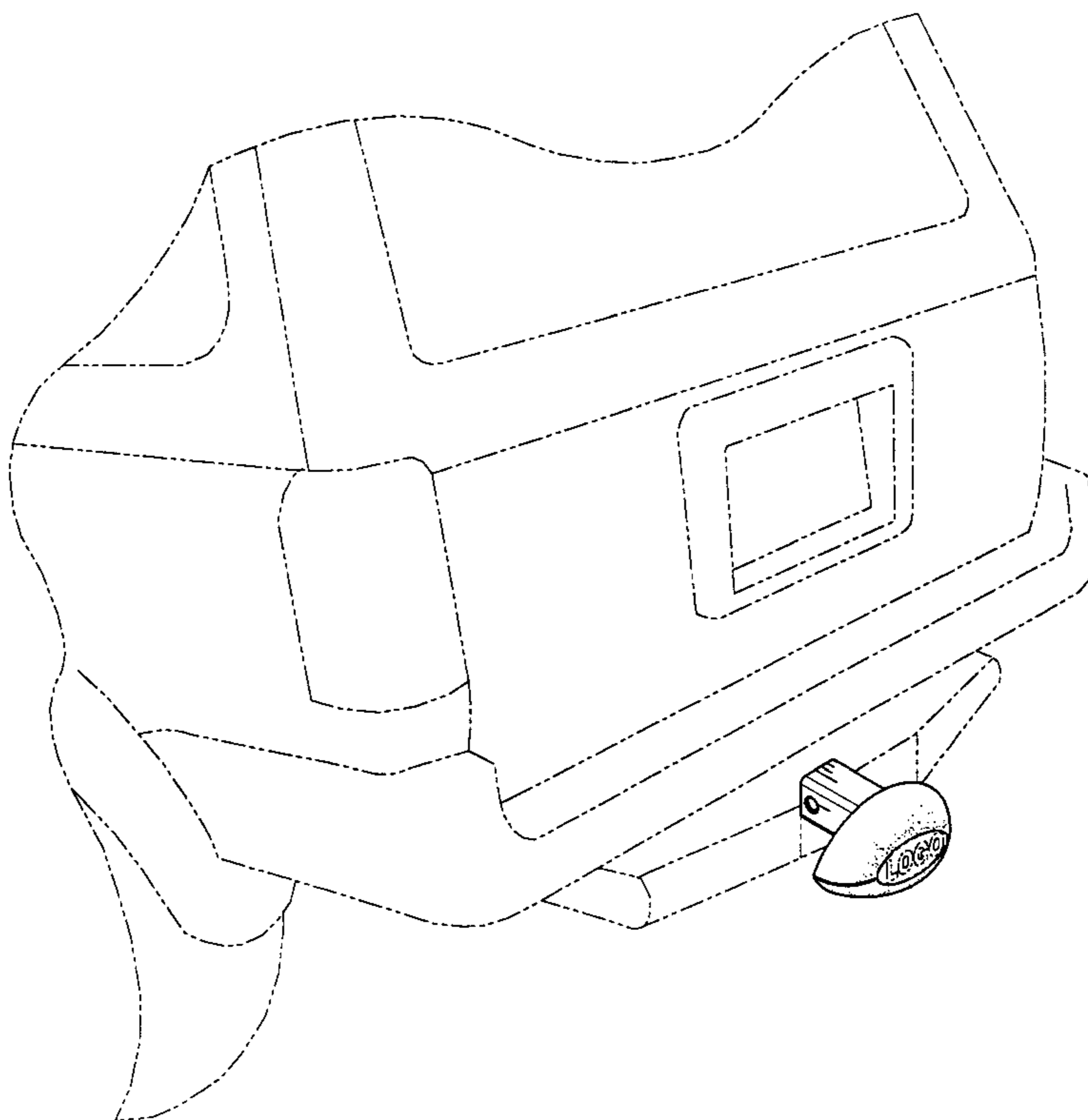

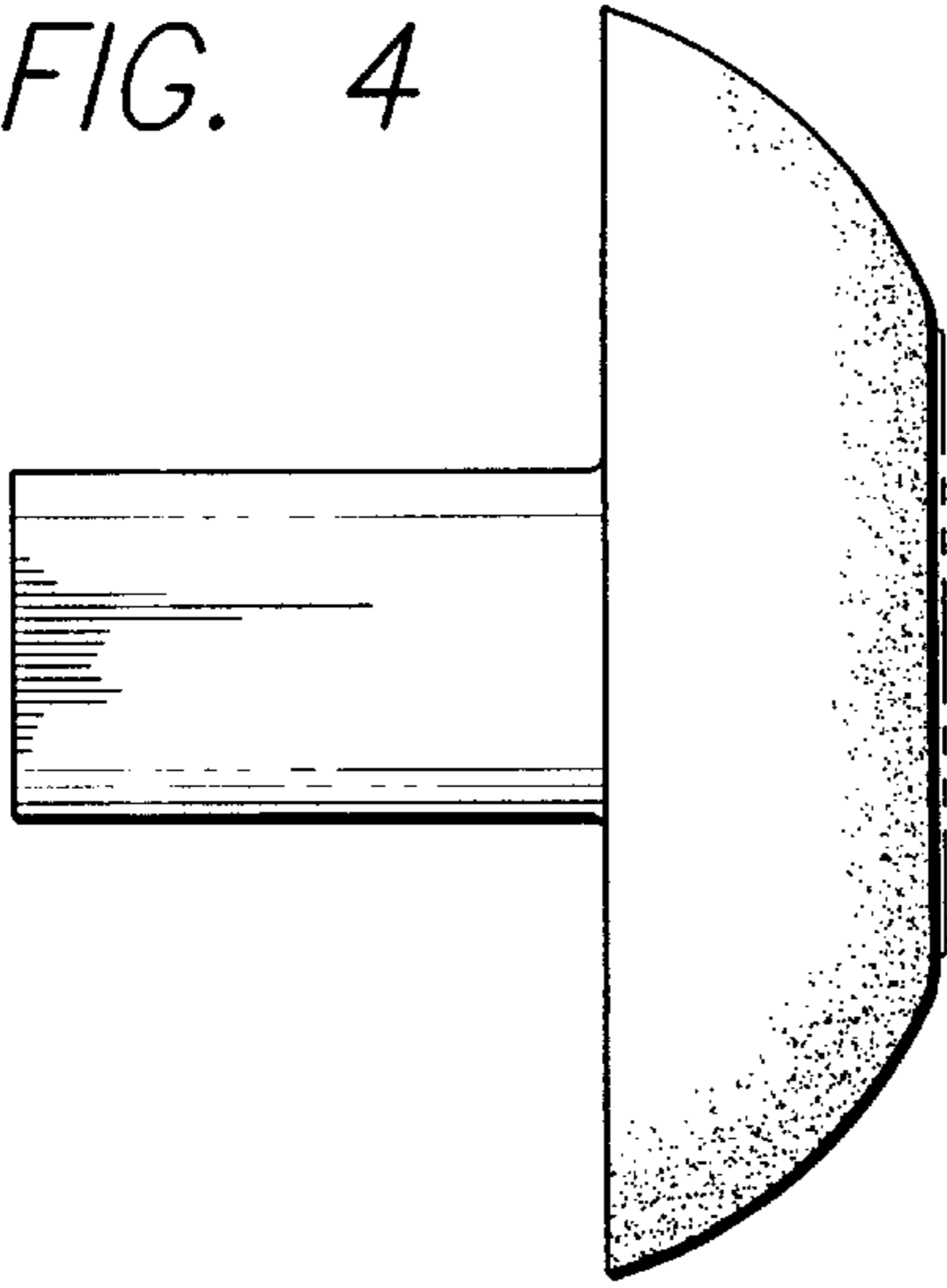

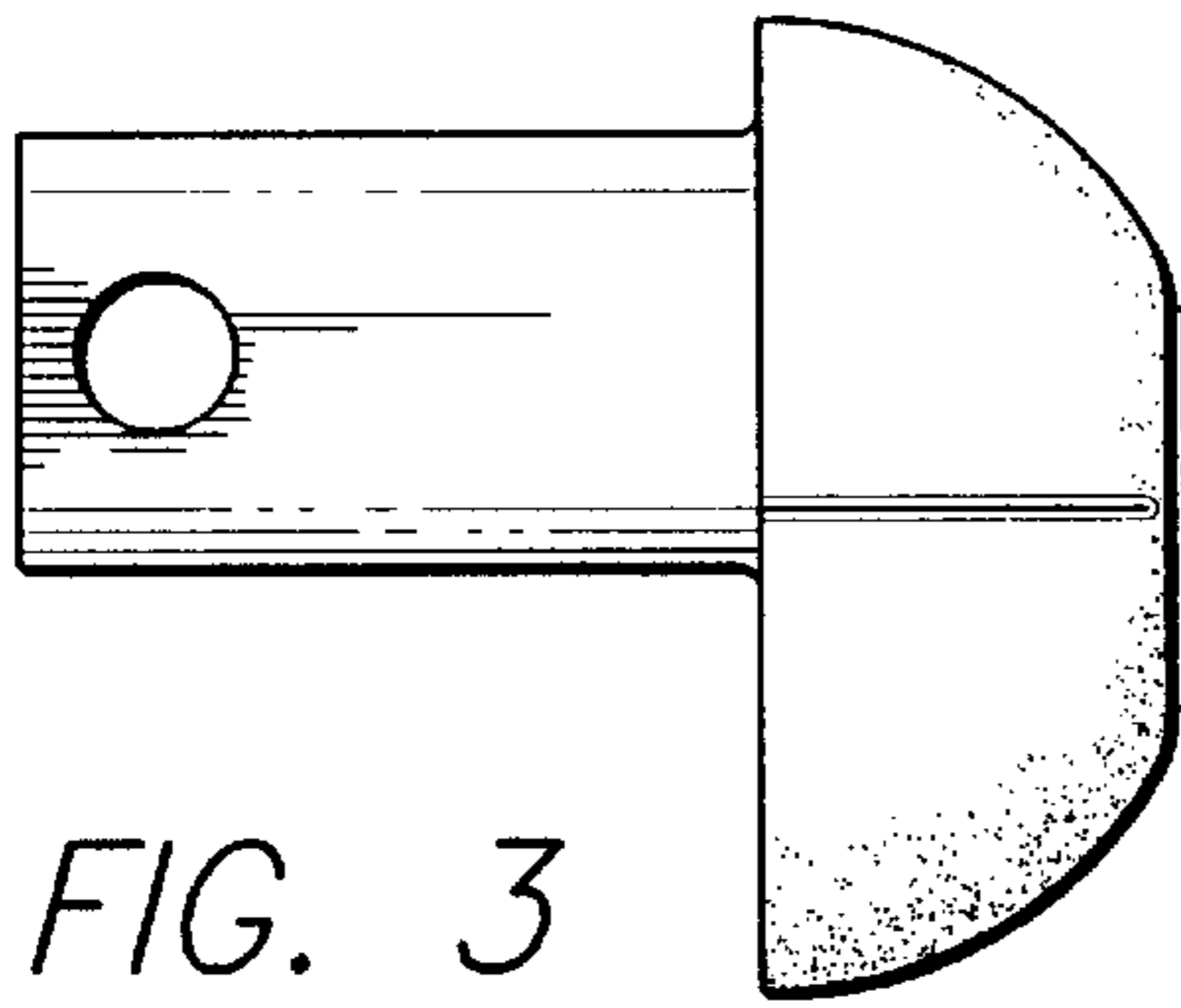
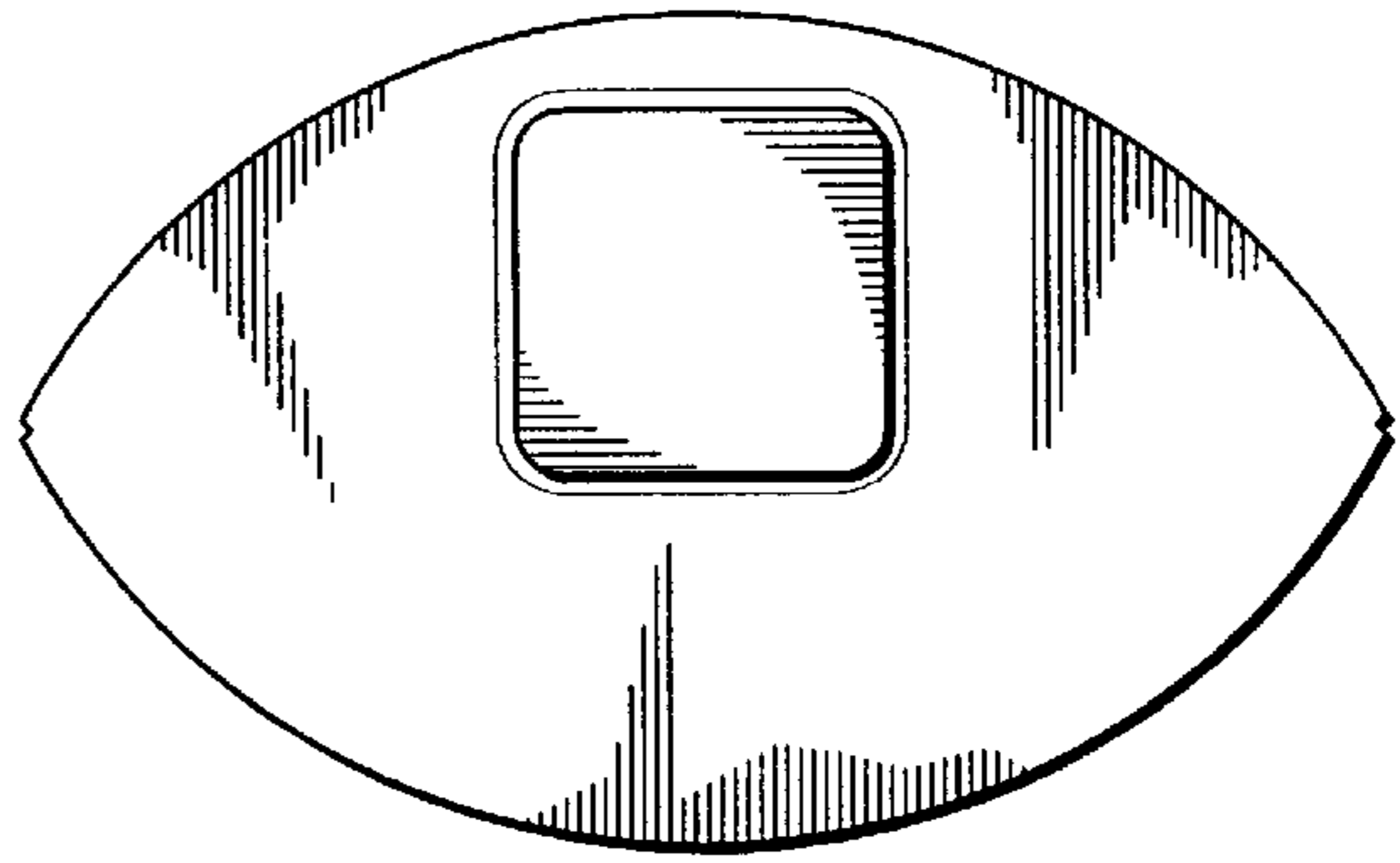

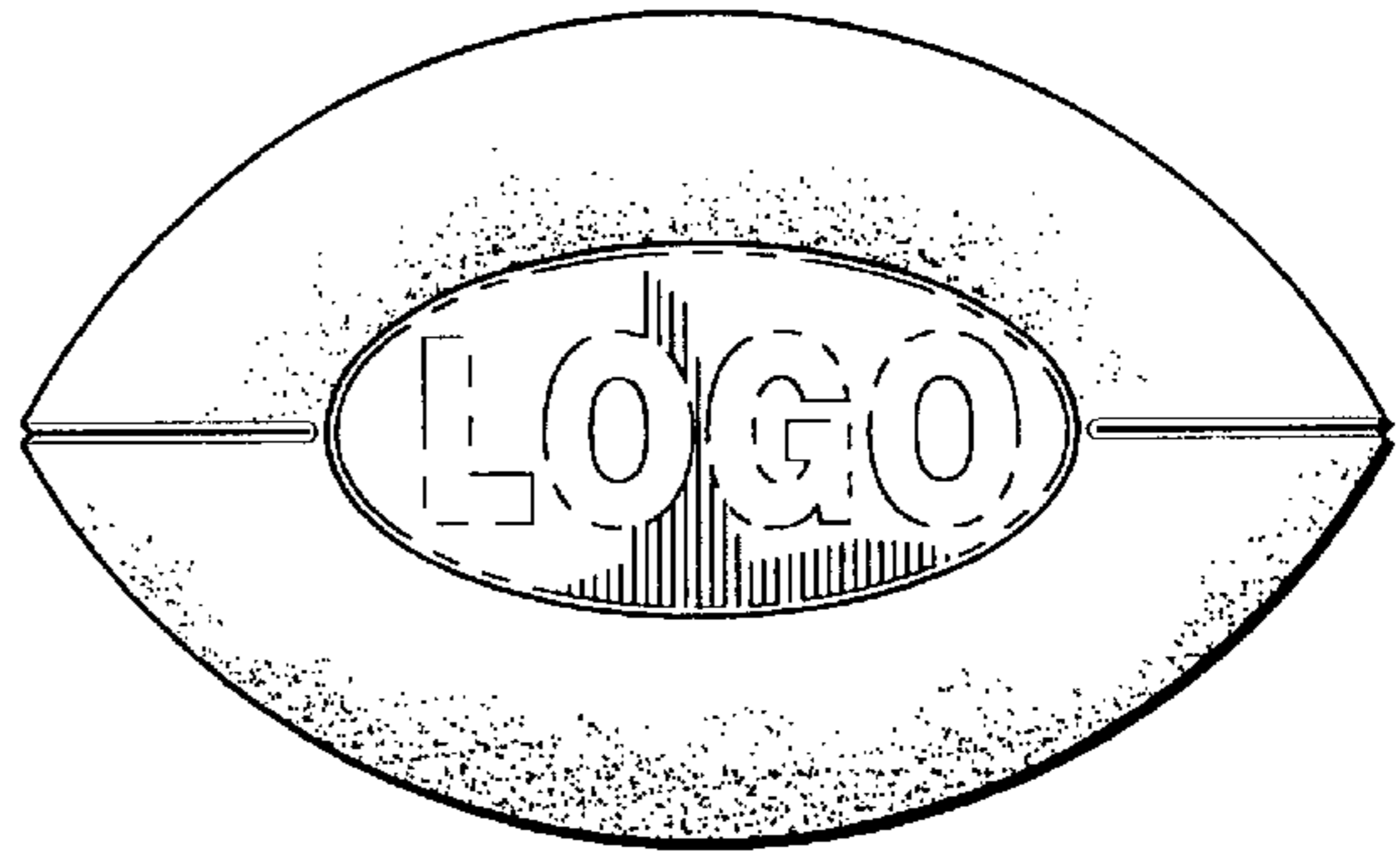

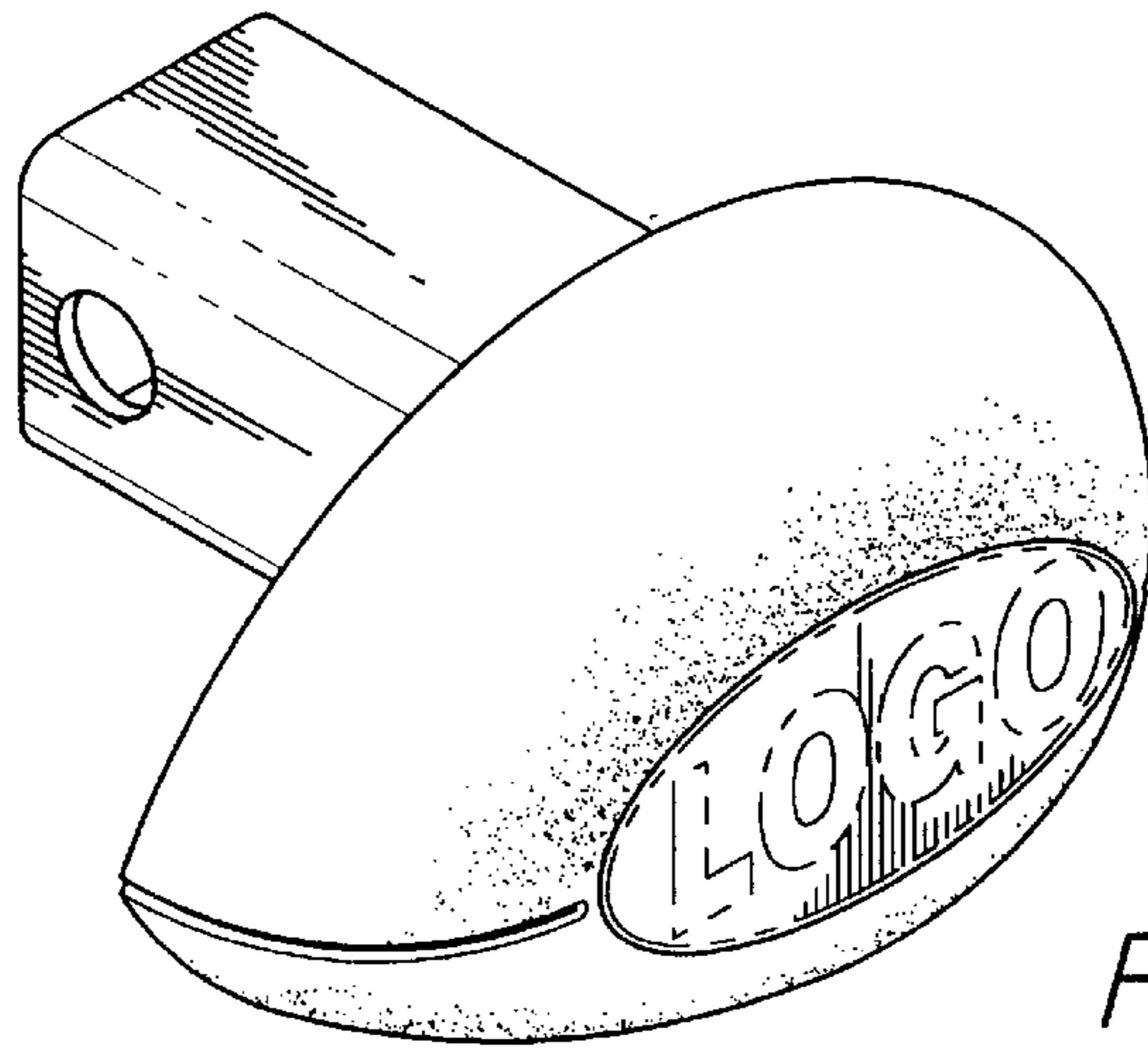

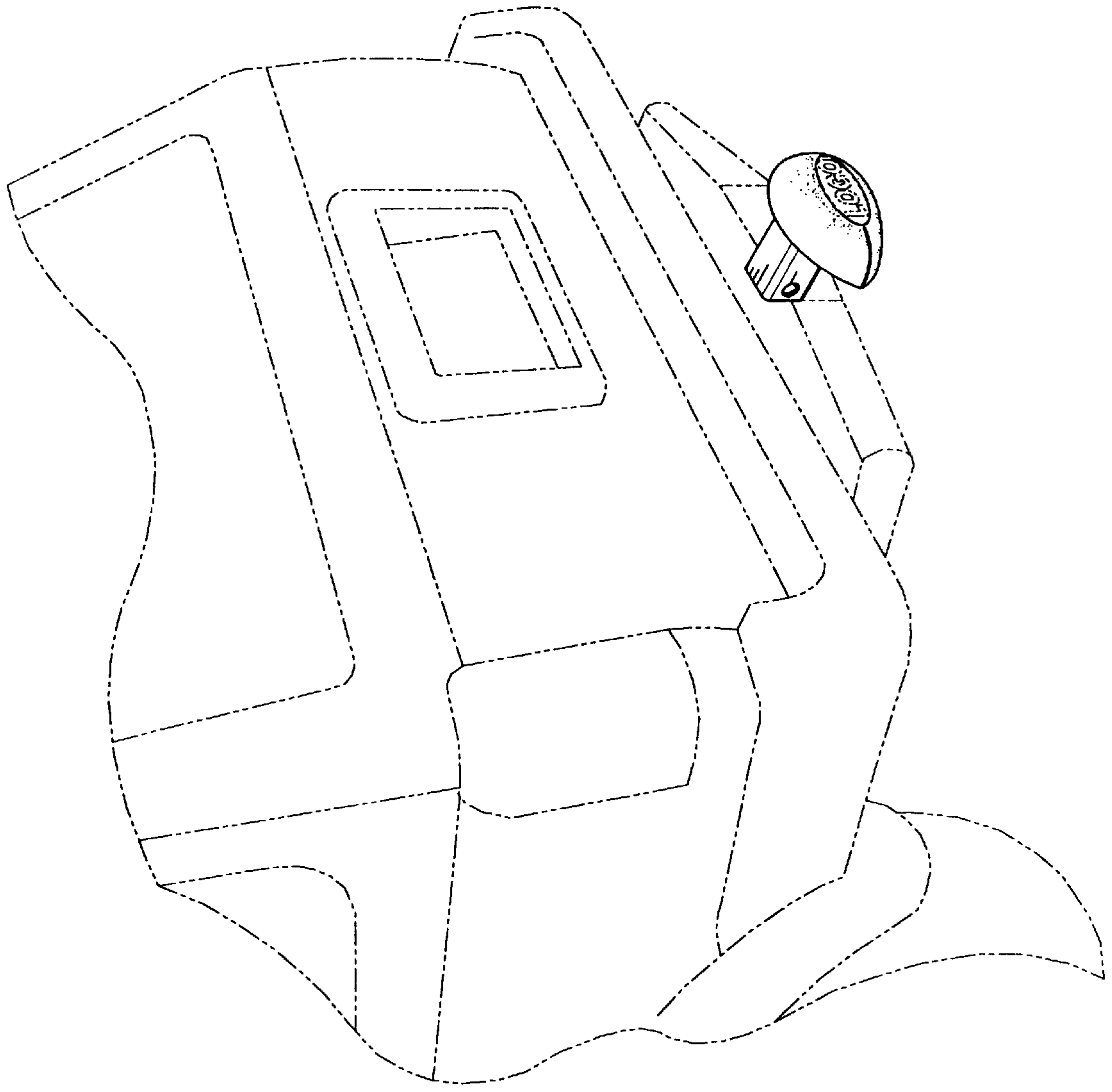
