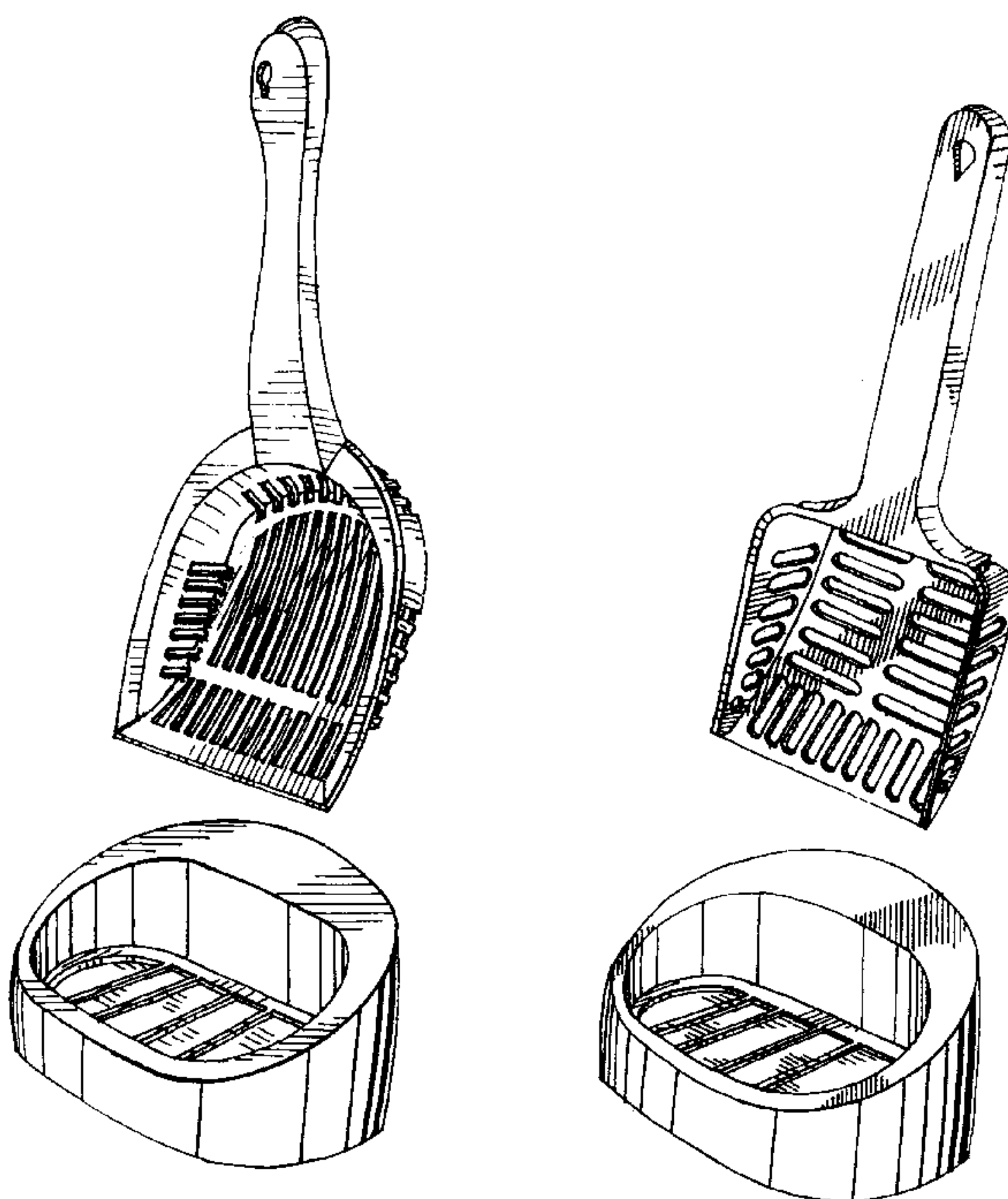
[57] **CLAIM**

The ornamental design of a combined litter scoop and pedestal, as shown and described.

DESCRIPTION

FIG. 1 is an exploded front perspective view of a combined litter scoop and pedestal showing my new design;

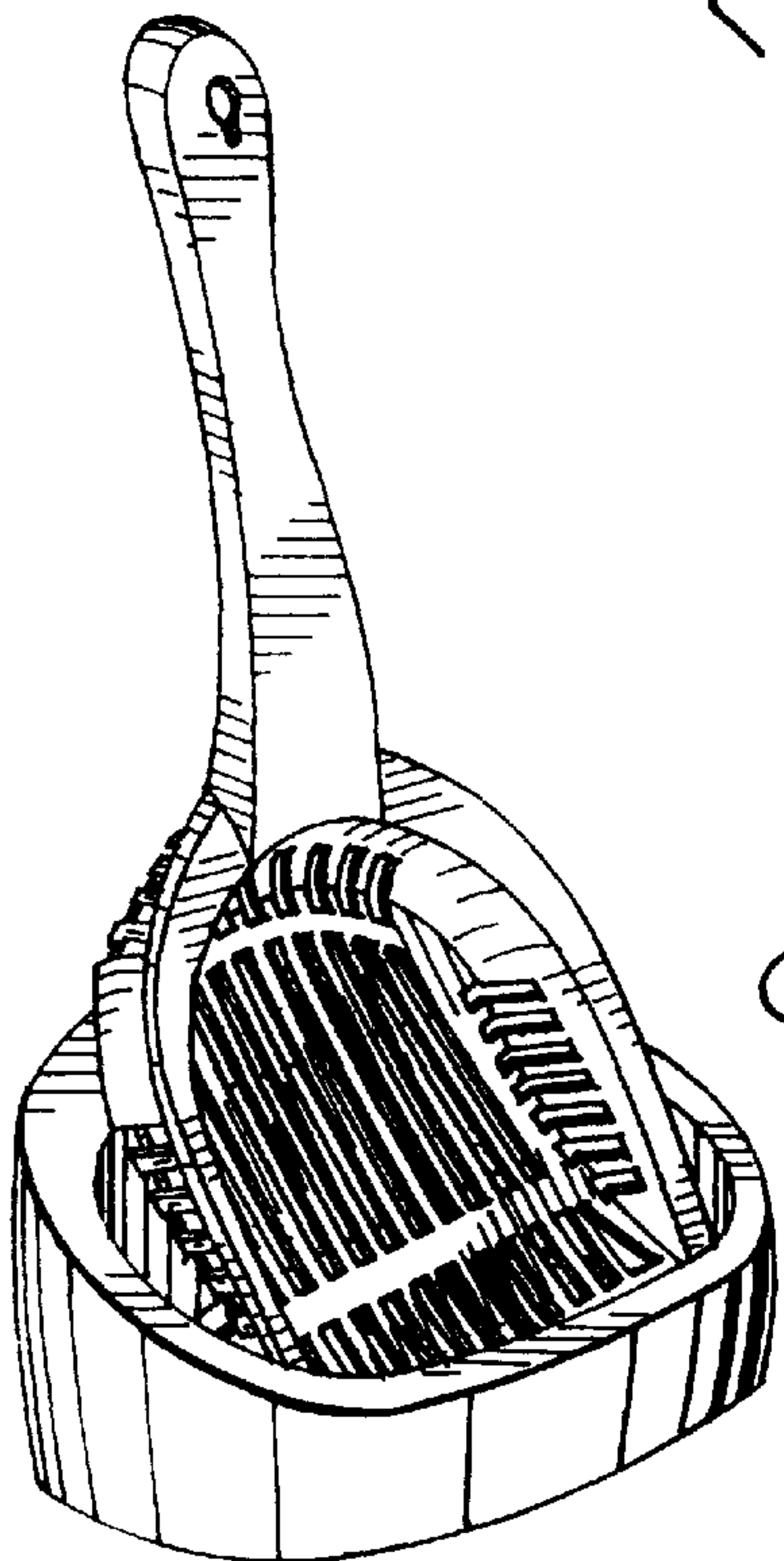
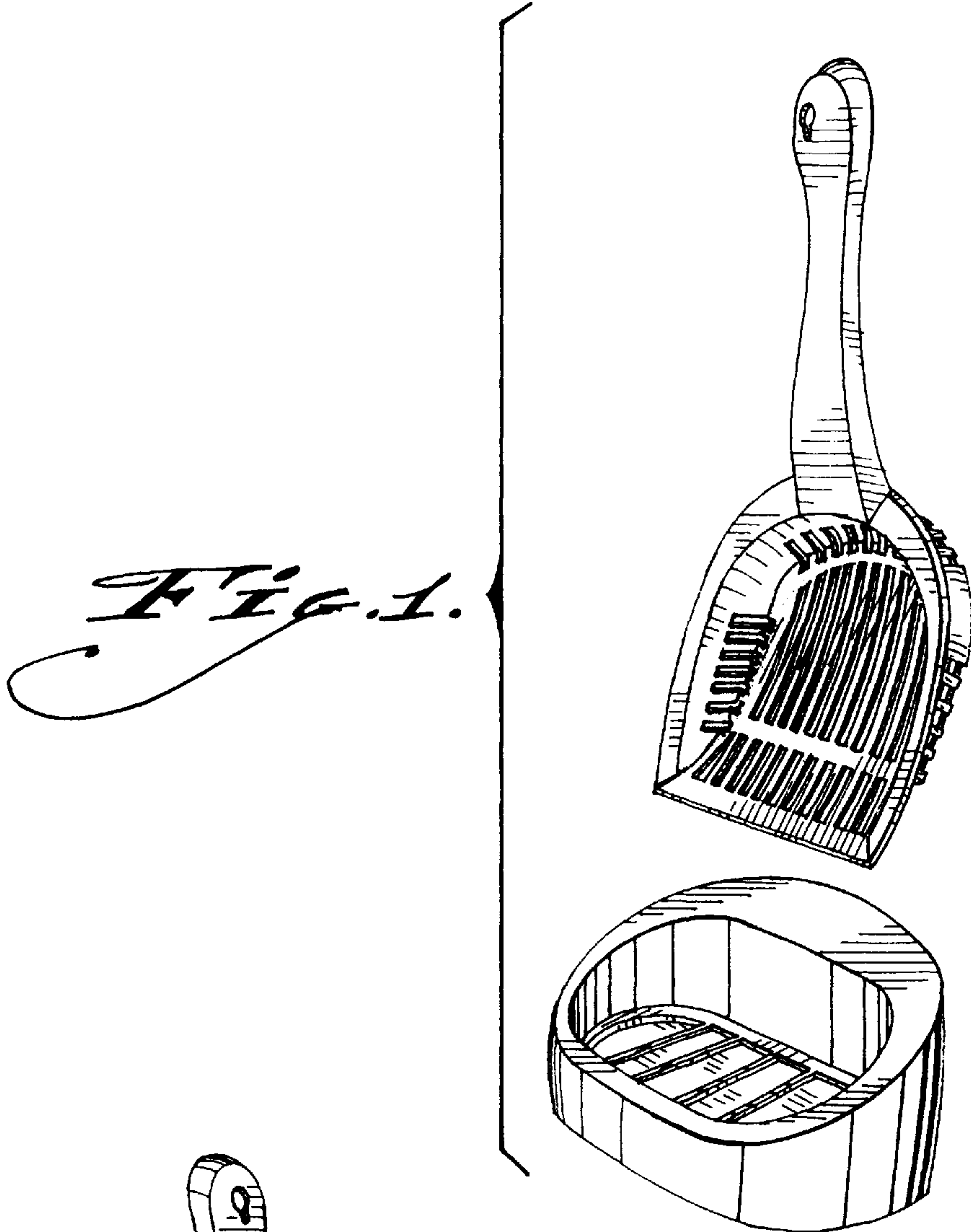

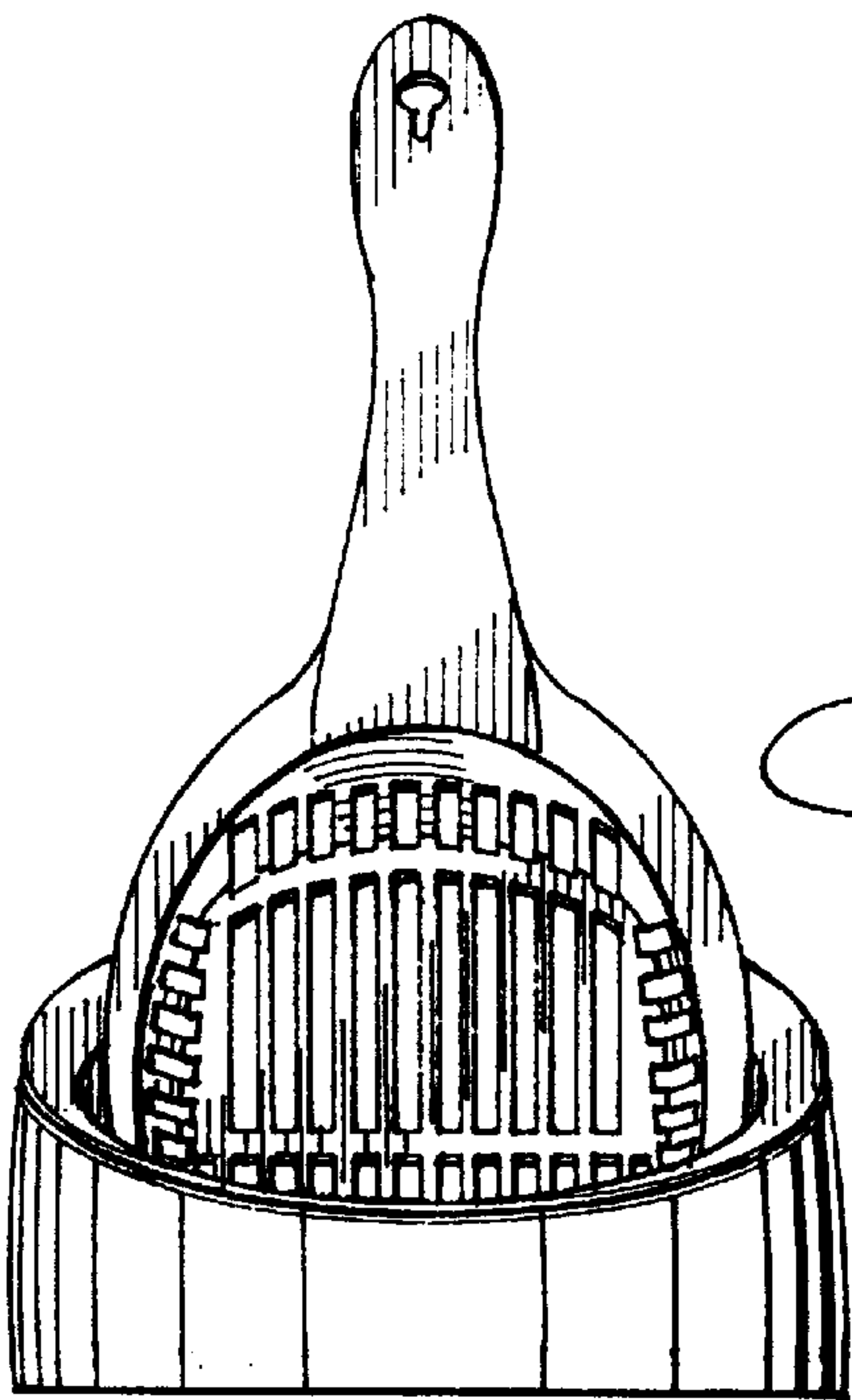
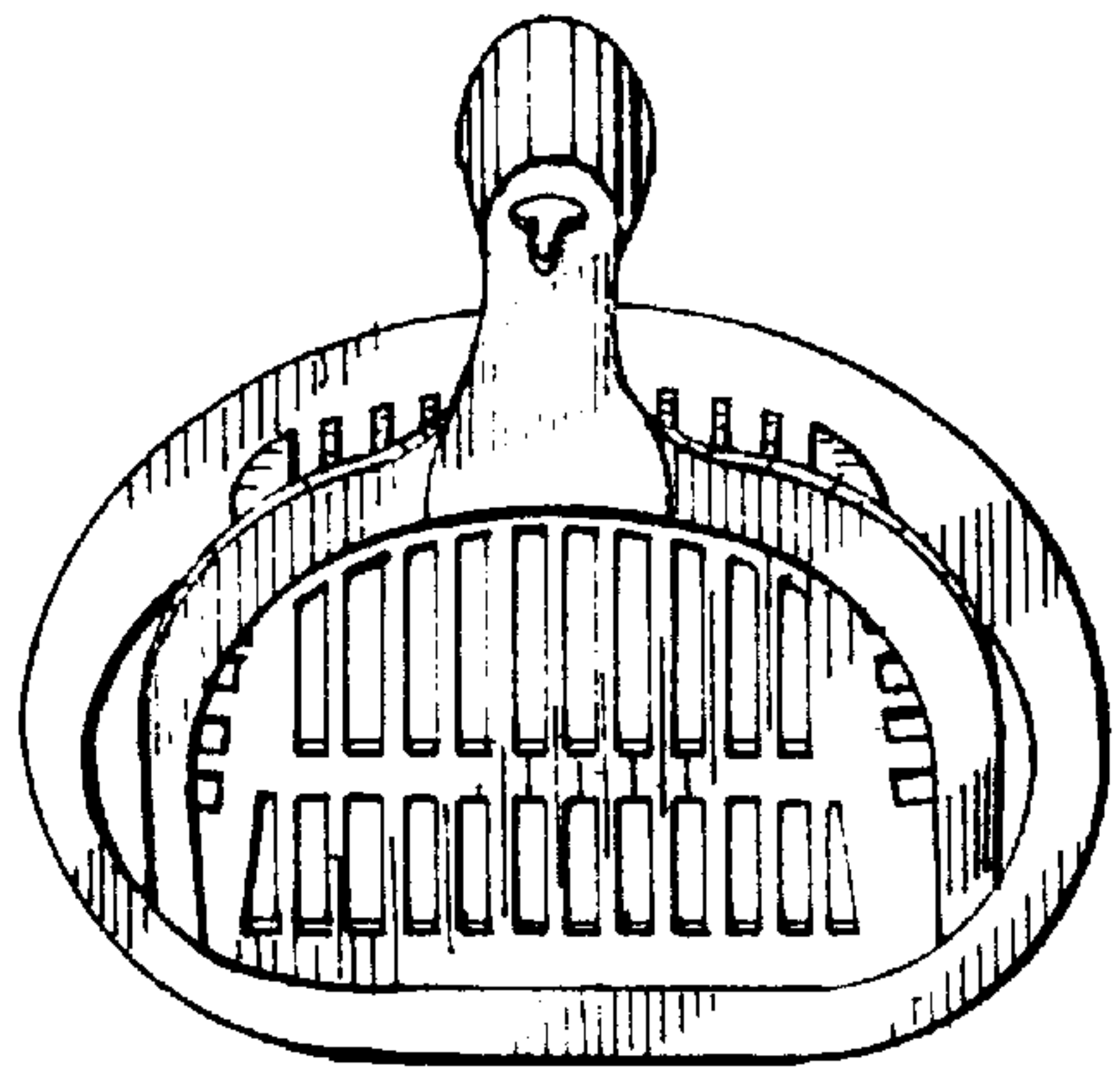
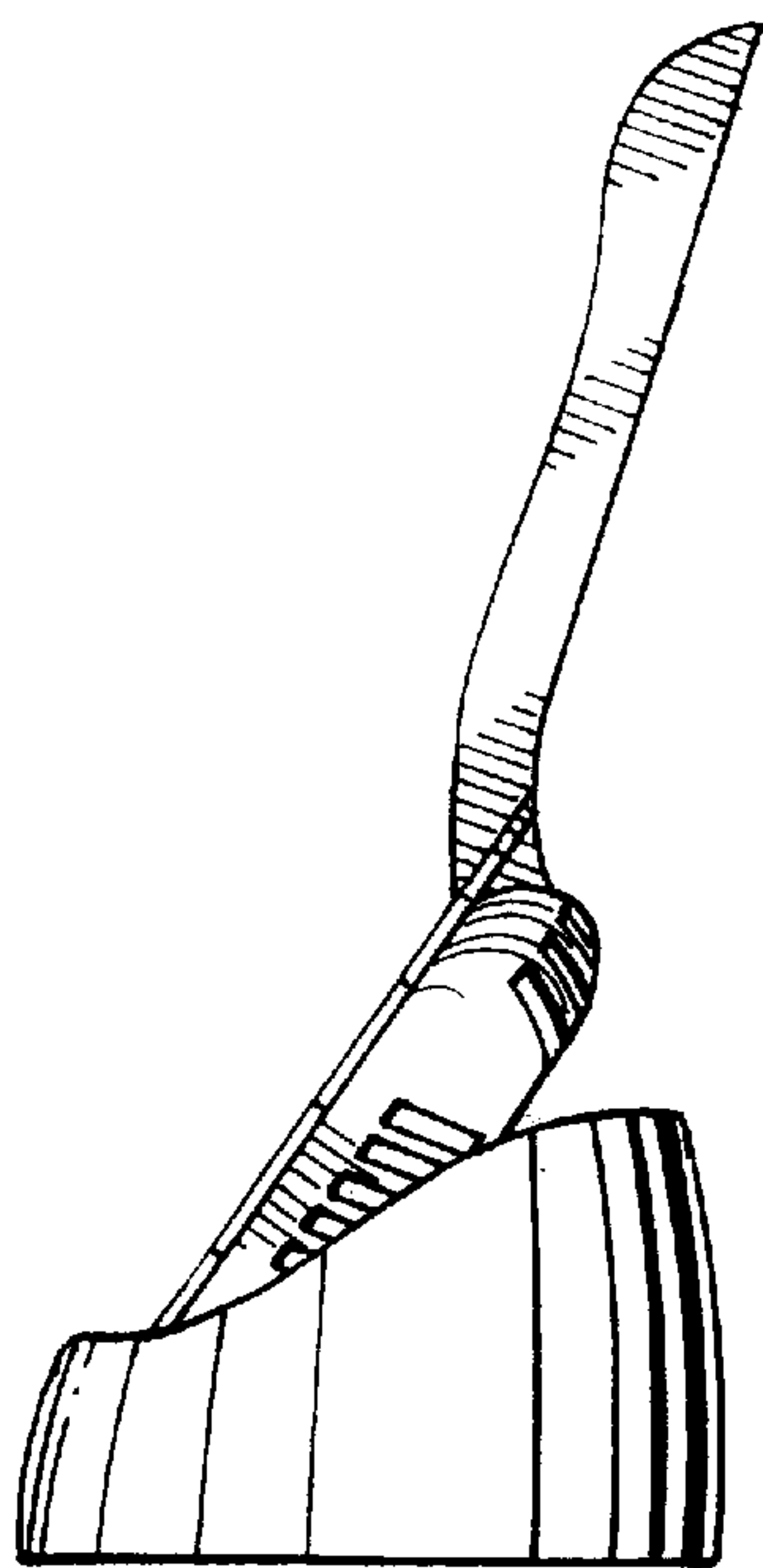

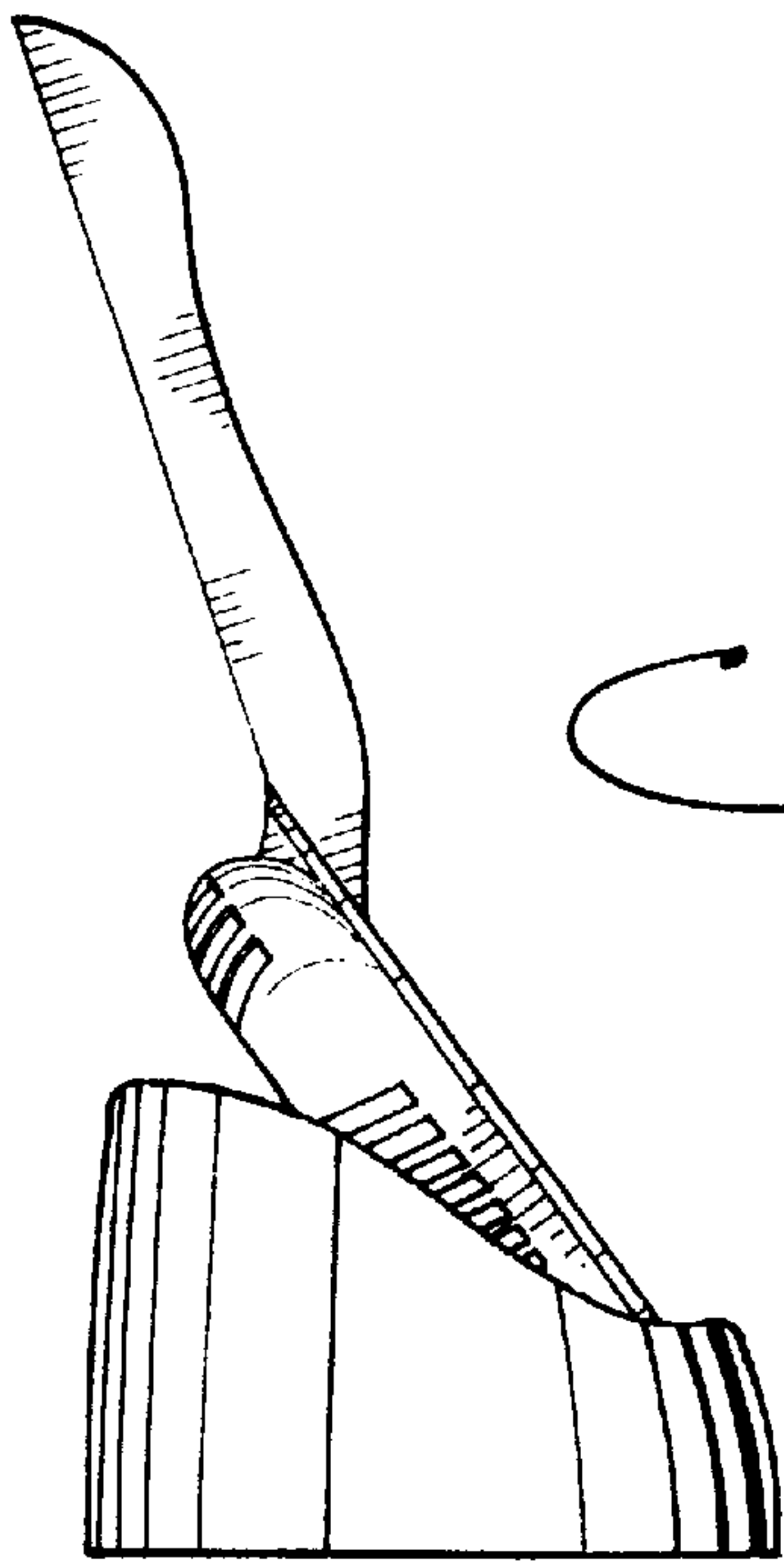

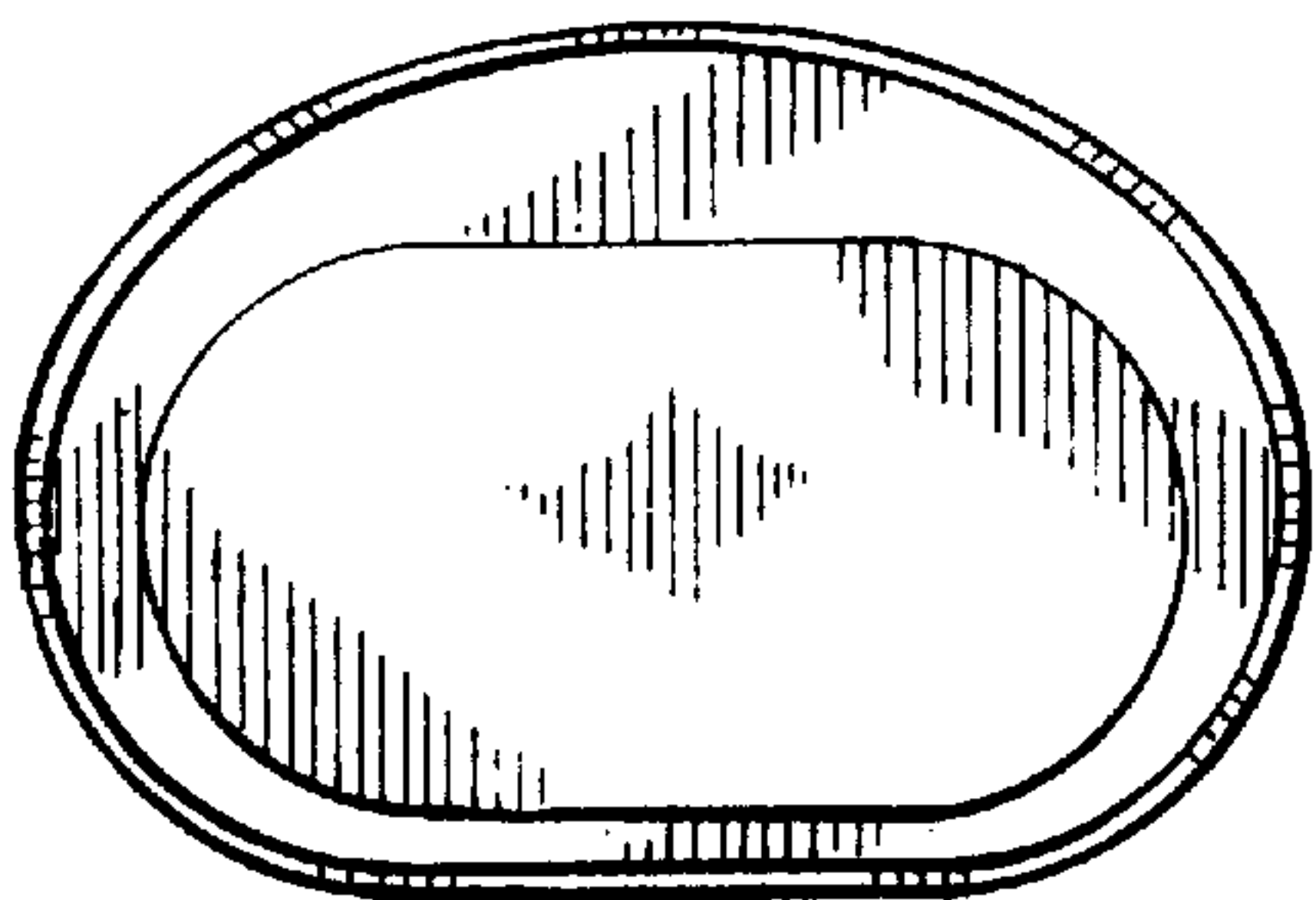
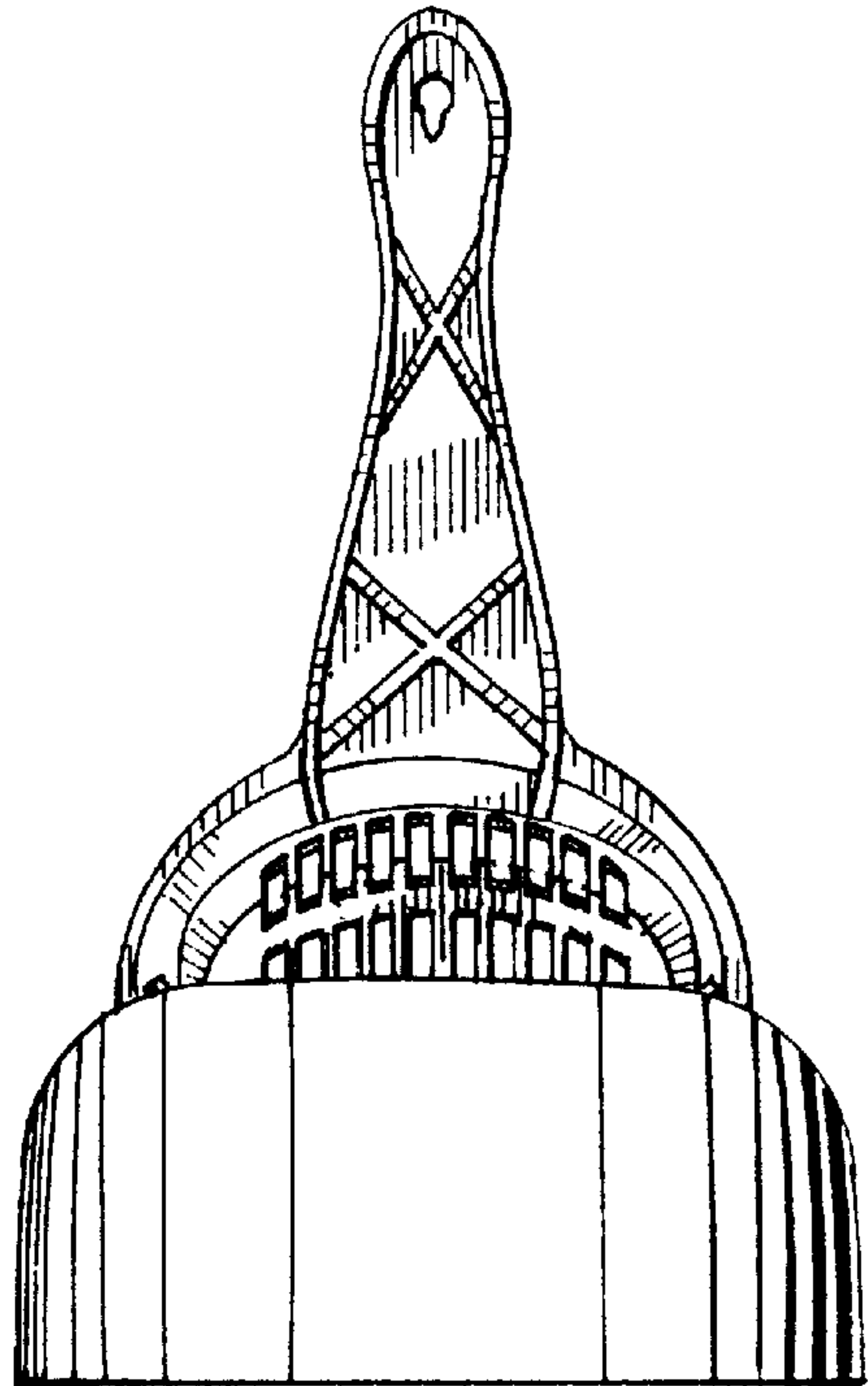

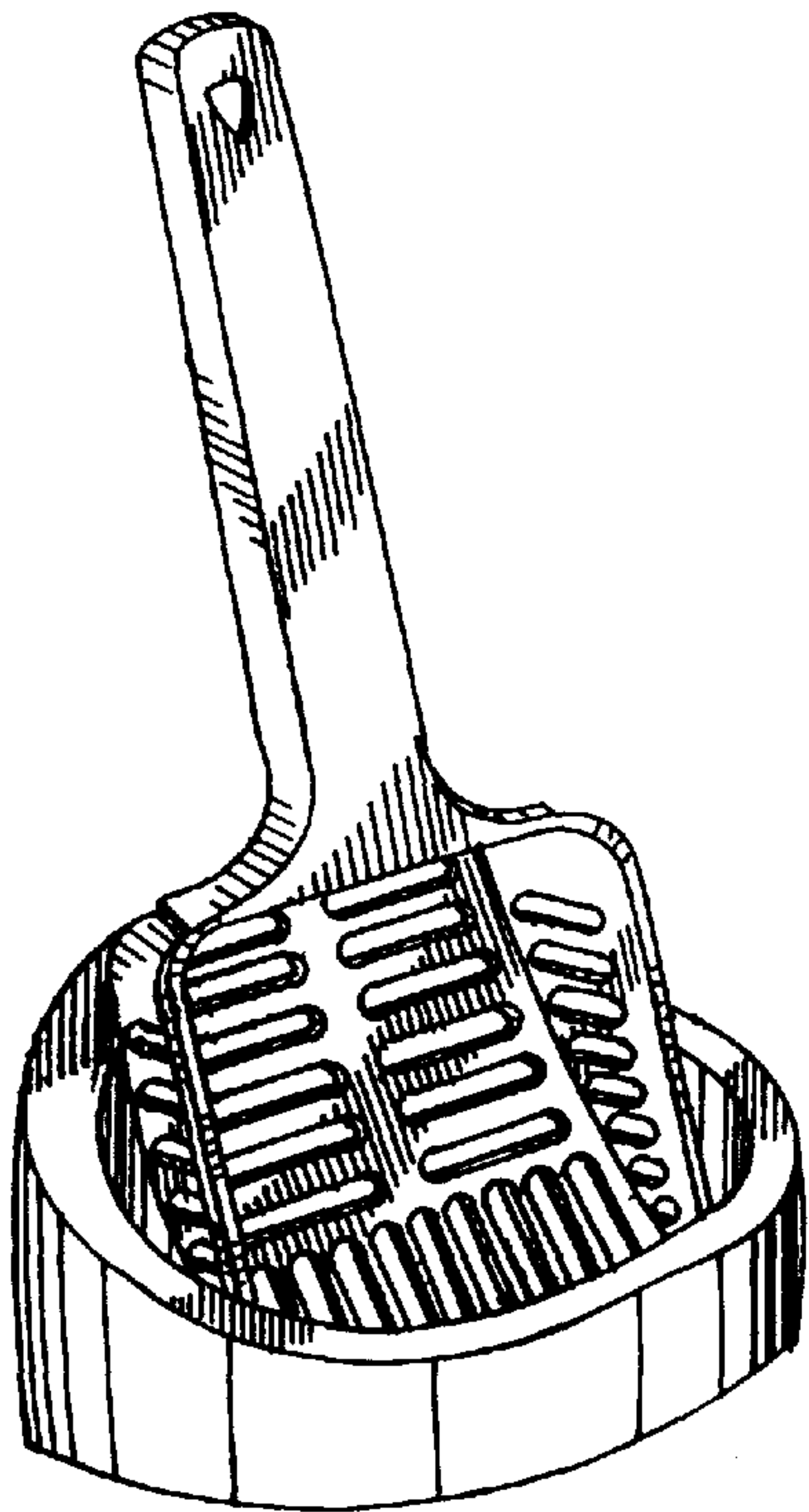
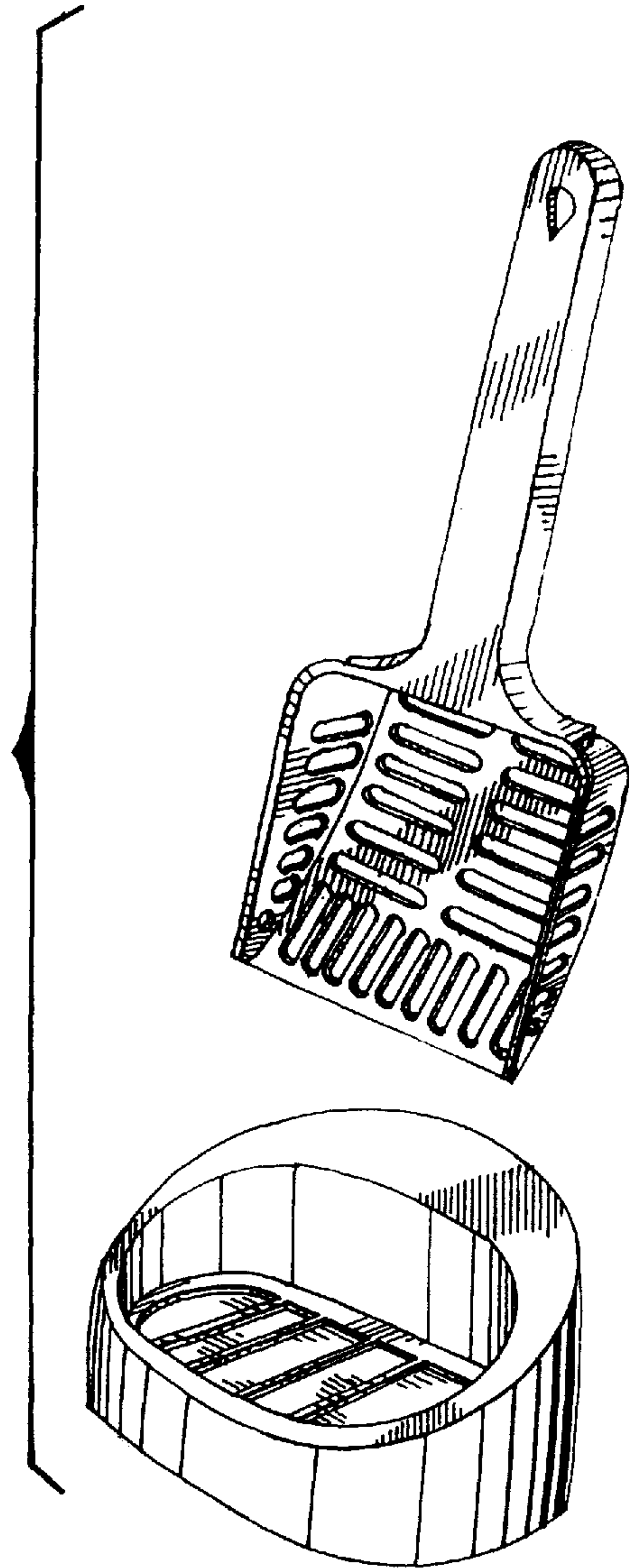

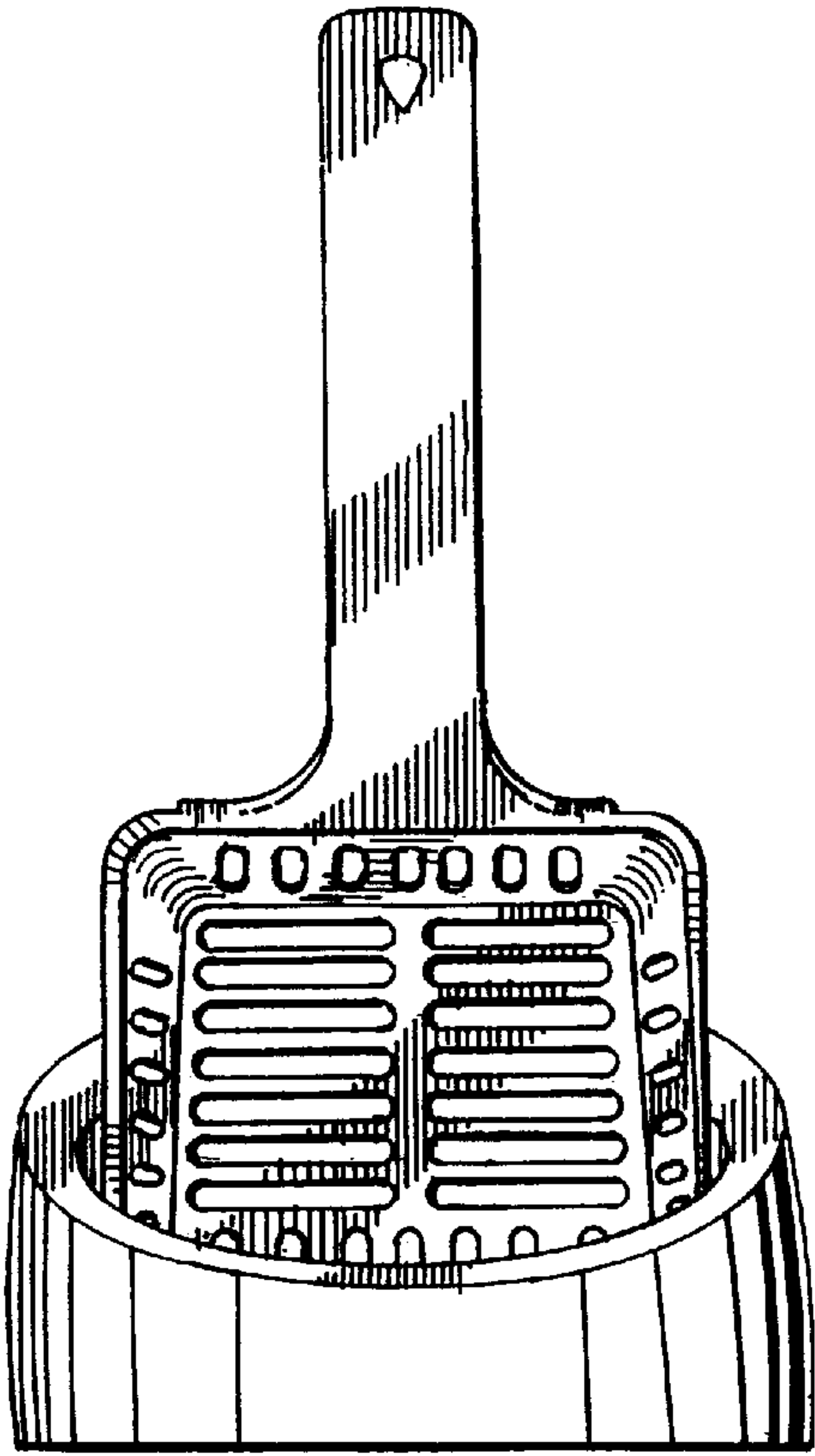
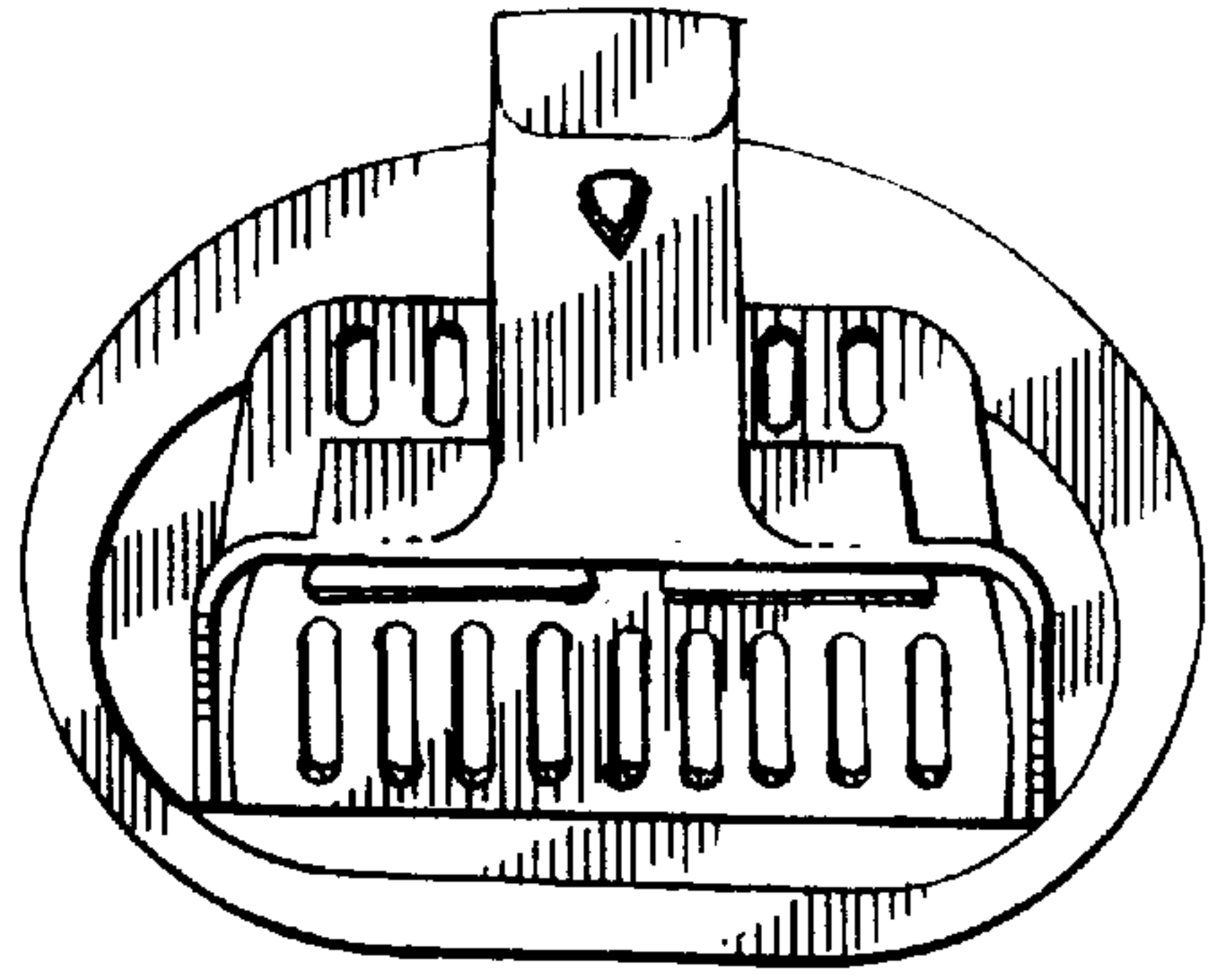

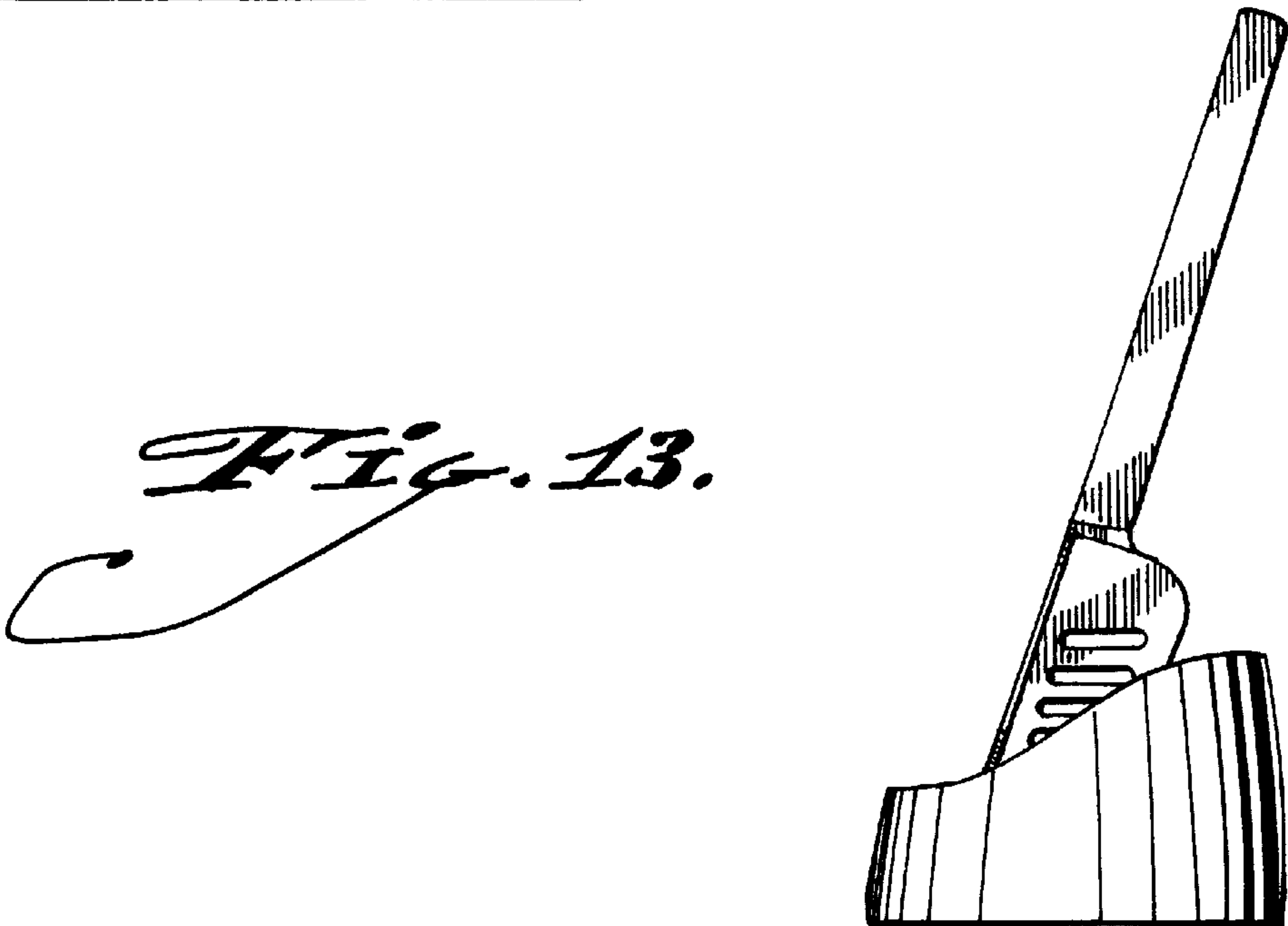

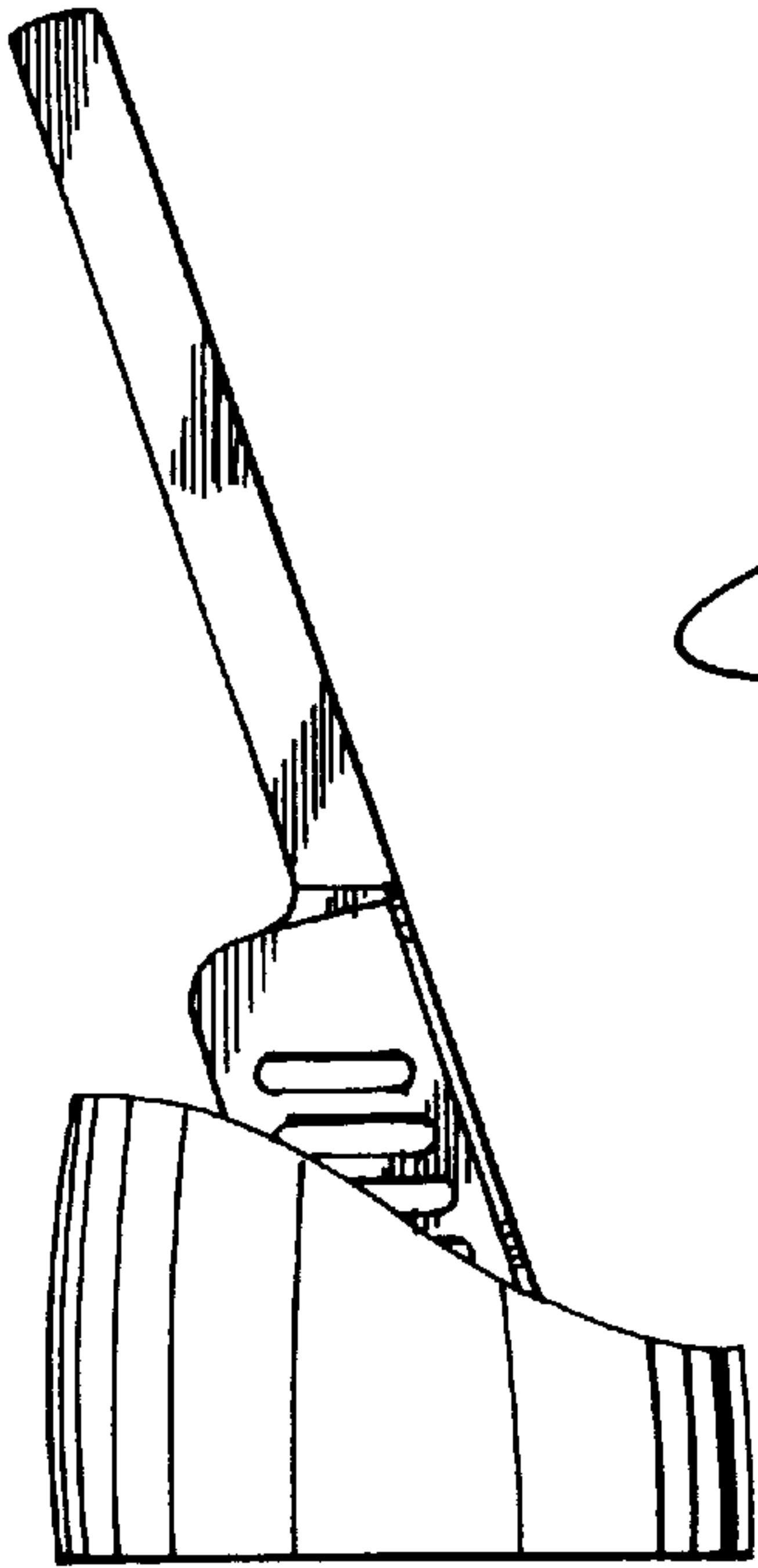

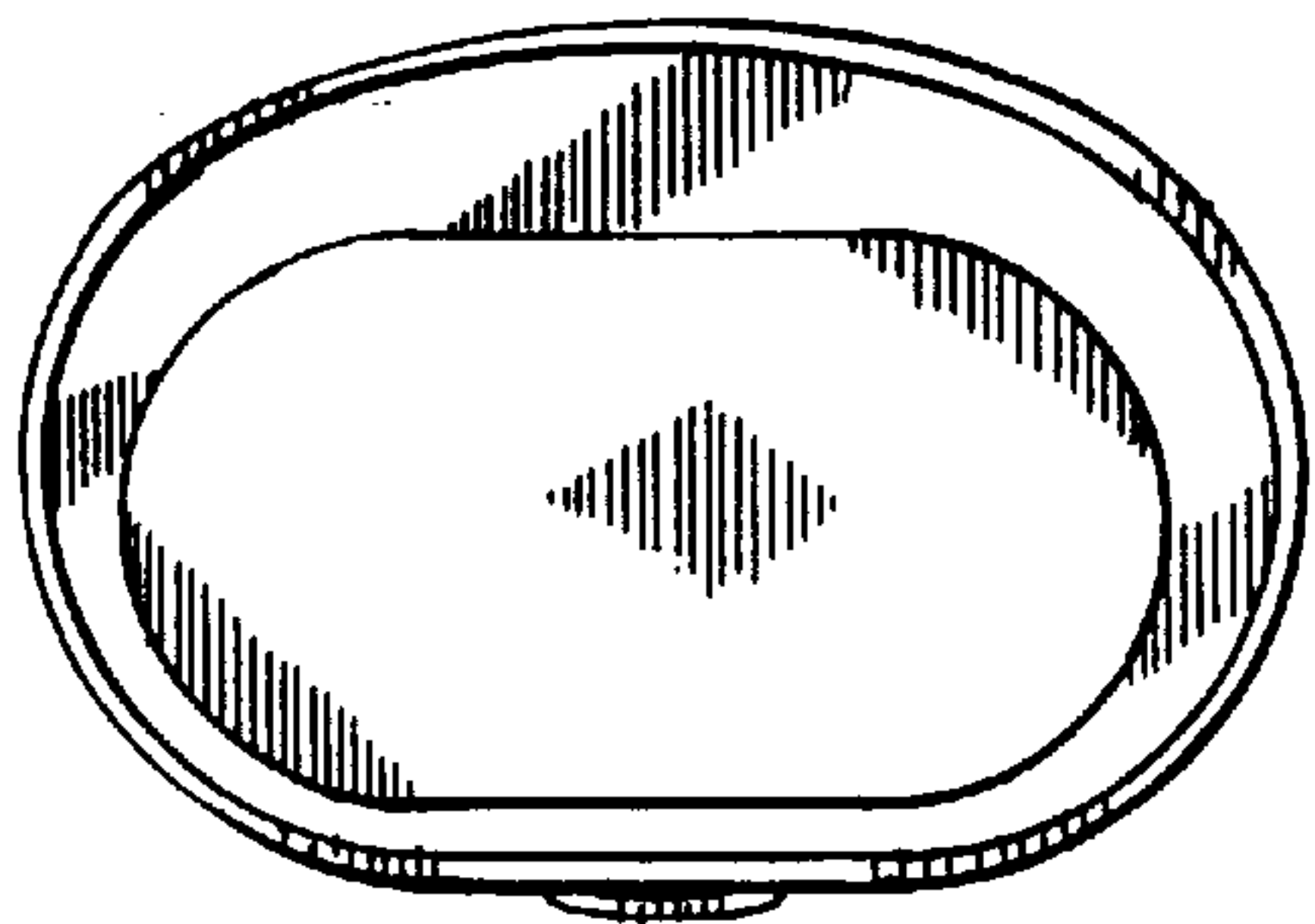
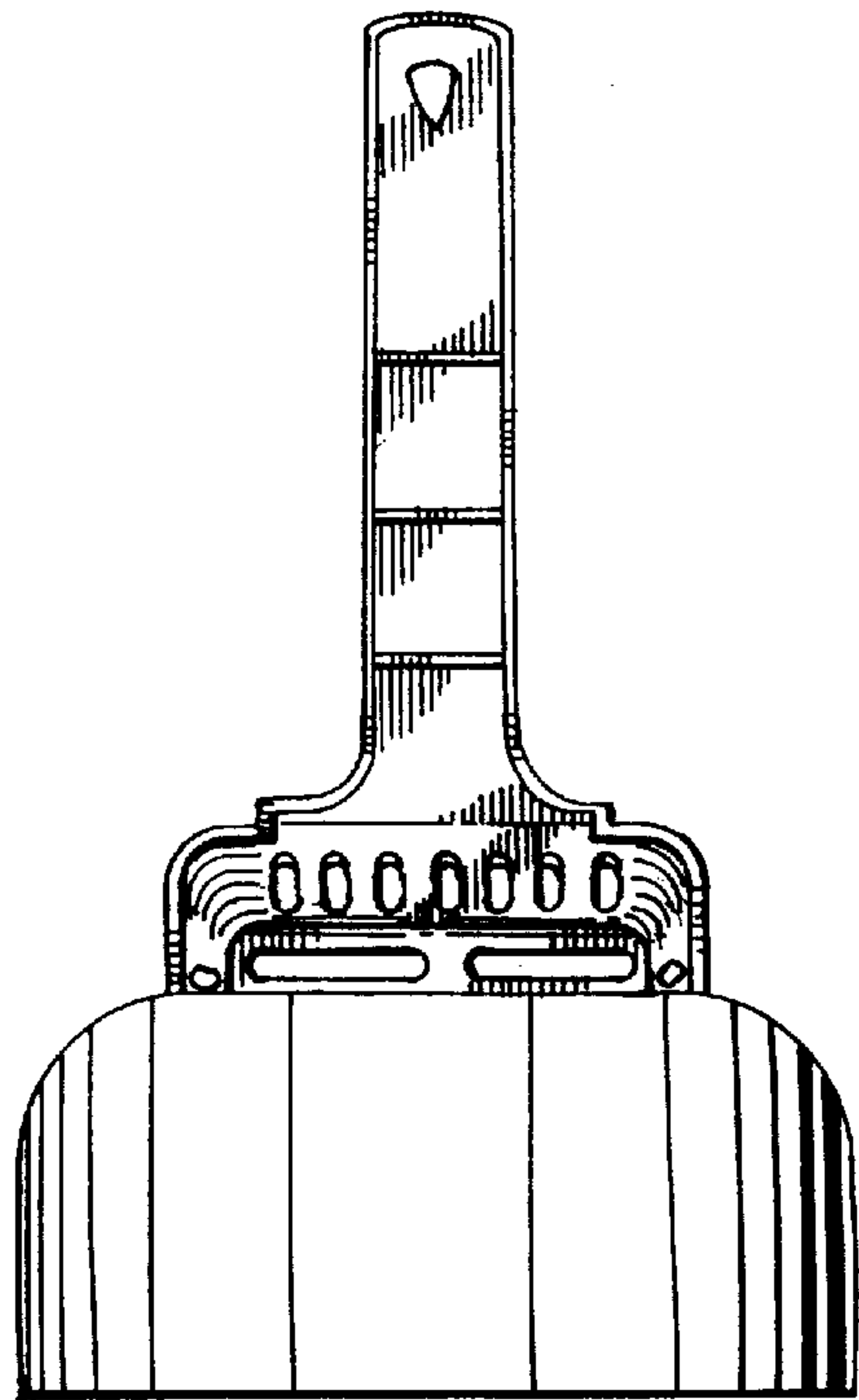
