[57] **CLAIM**

The ornamental design for a pillow carrying case, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pillow carrying case in the closed position.

FIG. 2 is a perspective view of the pillow carrying case, in the open position, in full lines with a pillow shown in broken lines representing environmental association matter being for illustrative purposes only and forming no part of the claimed invention.

FIG. 3 is a front elevational view of the pillow carrying case.

FIG. 4 is a rear elevational view thereof.

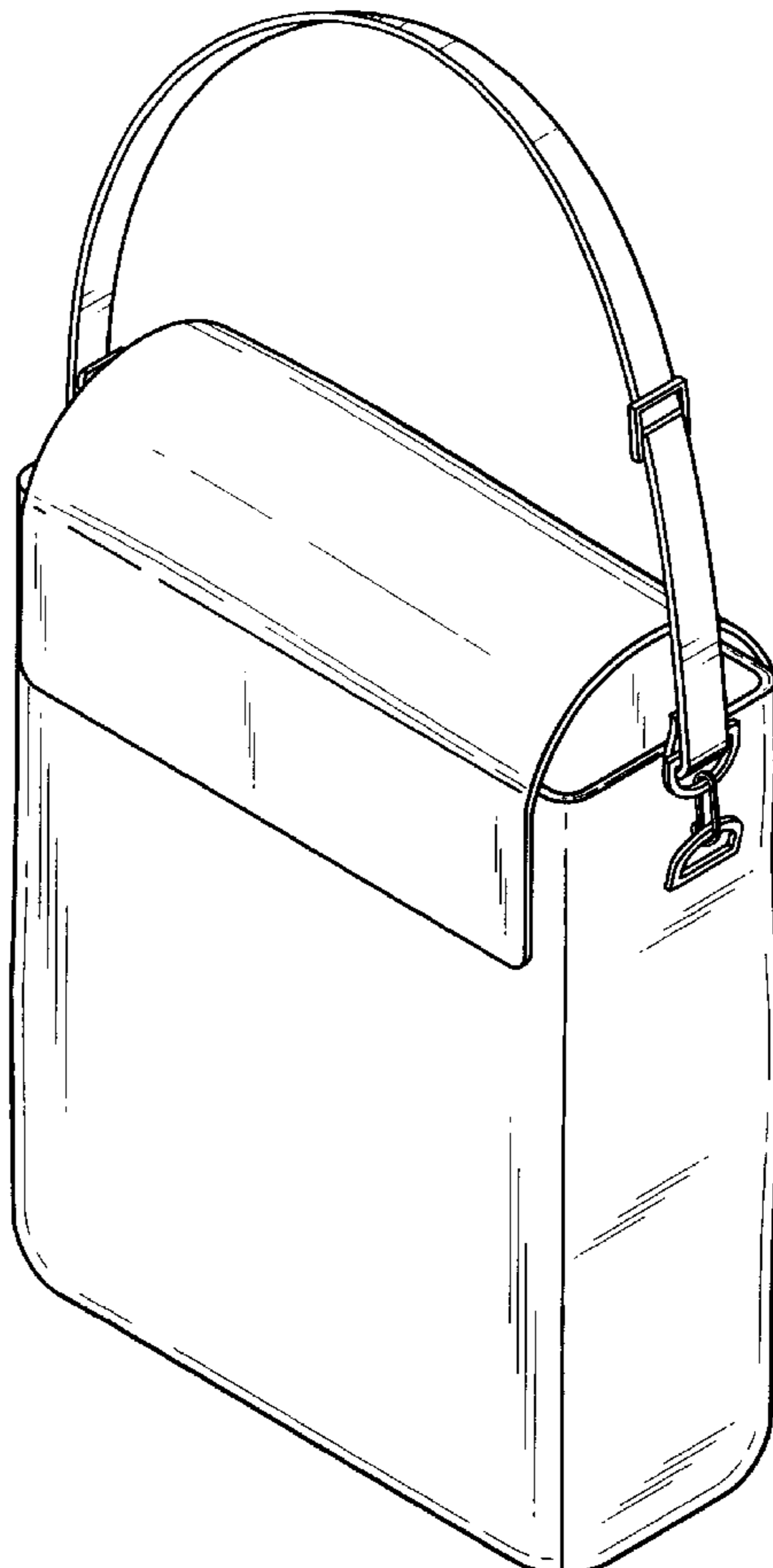
FIG. 5 is a right side elevational view thereof.

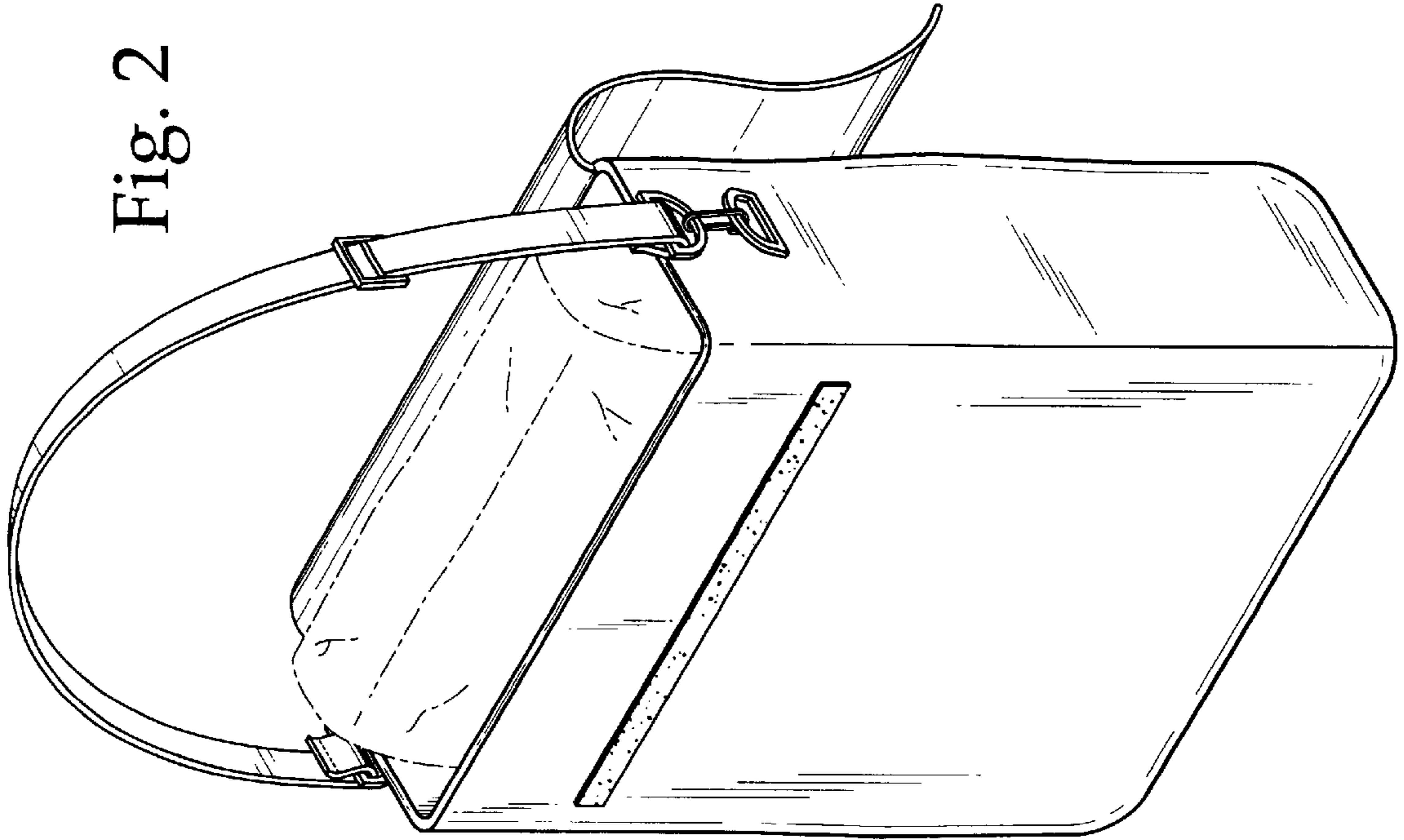

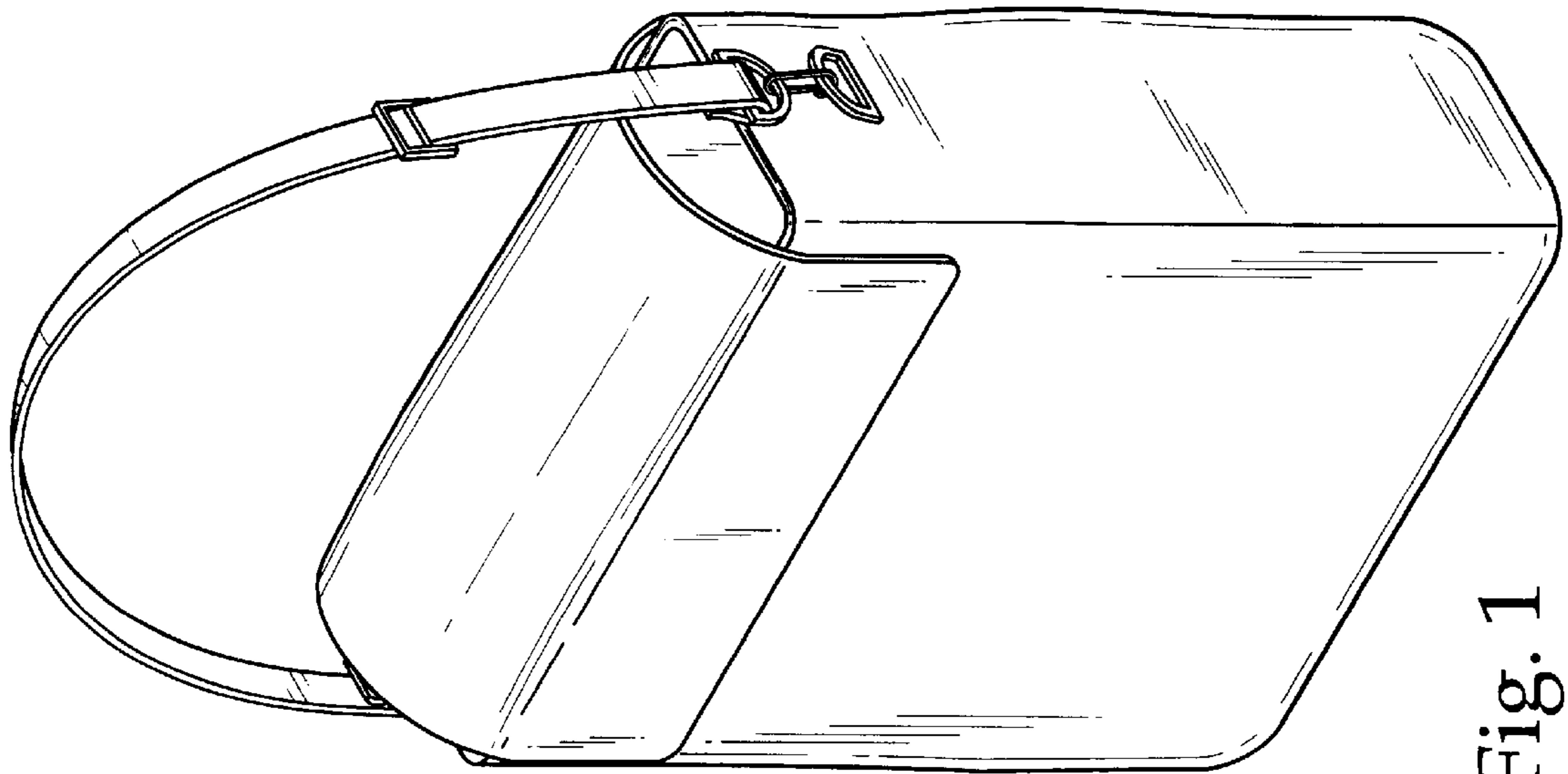

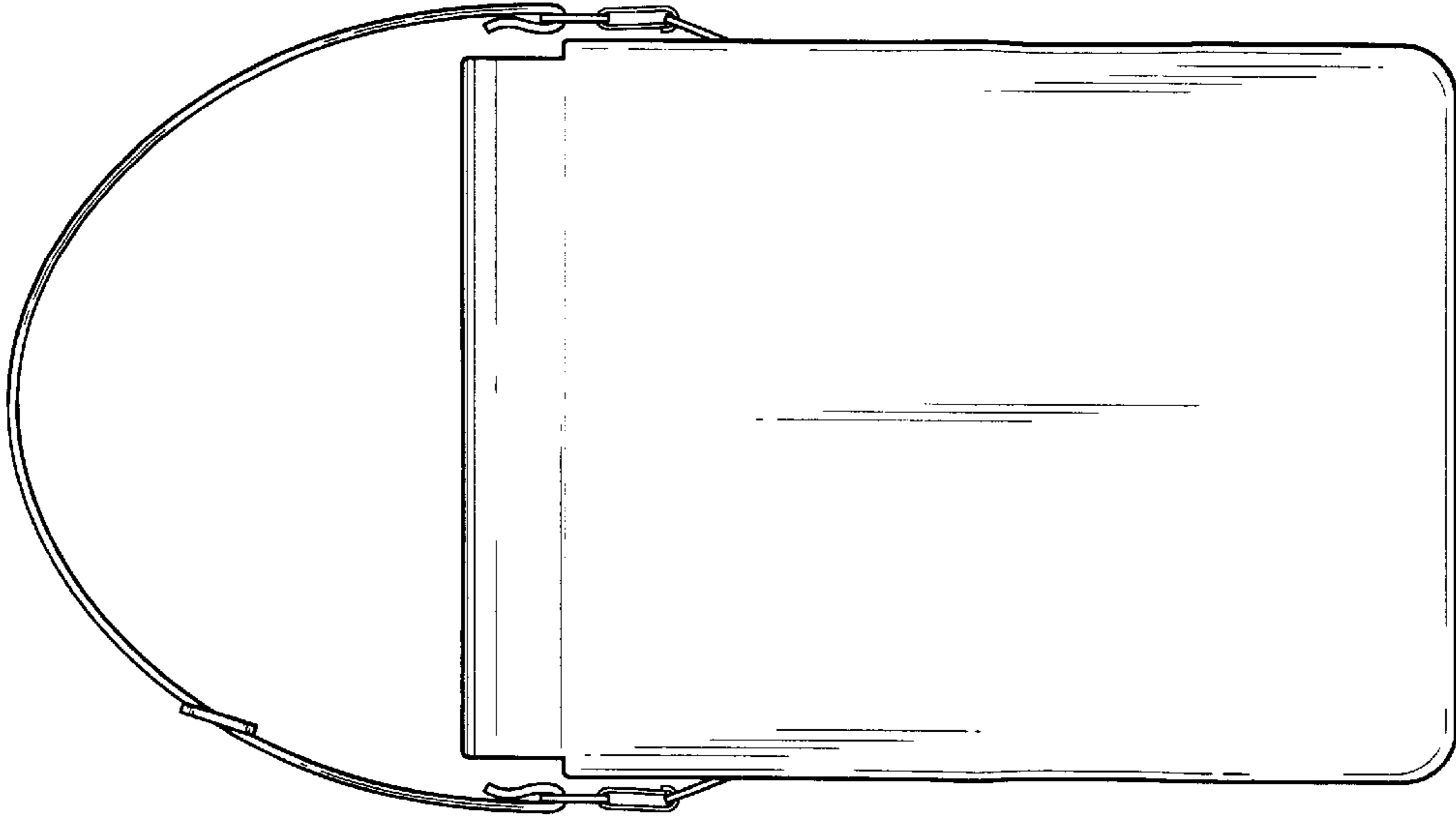

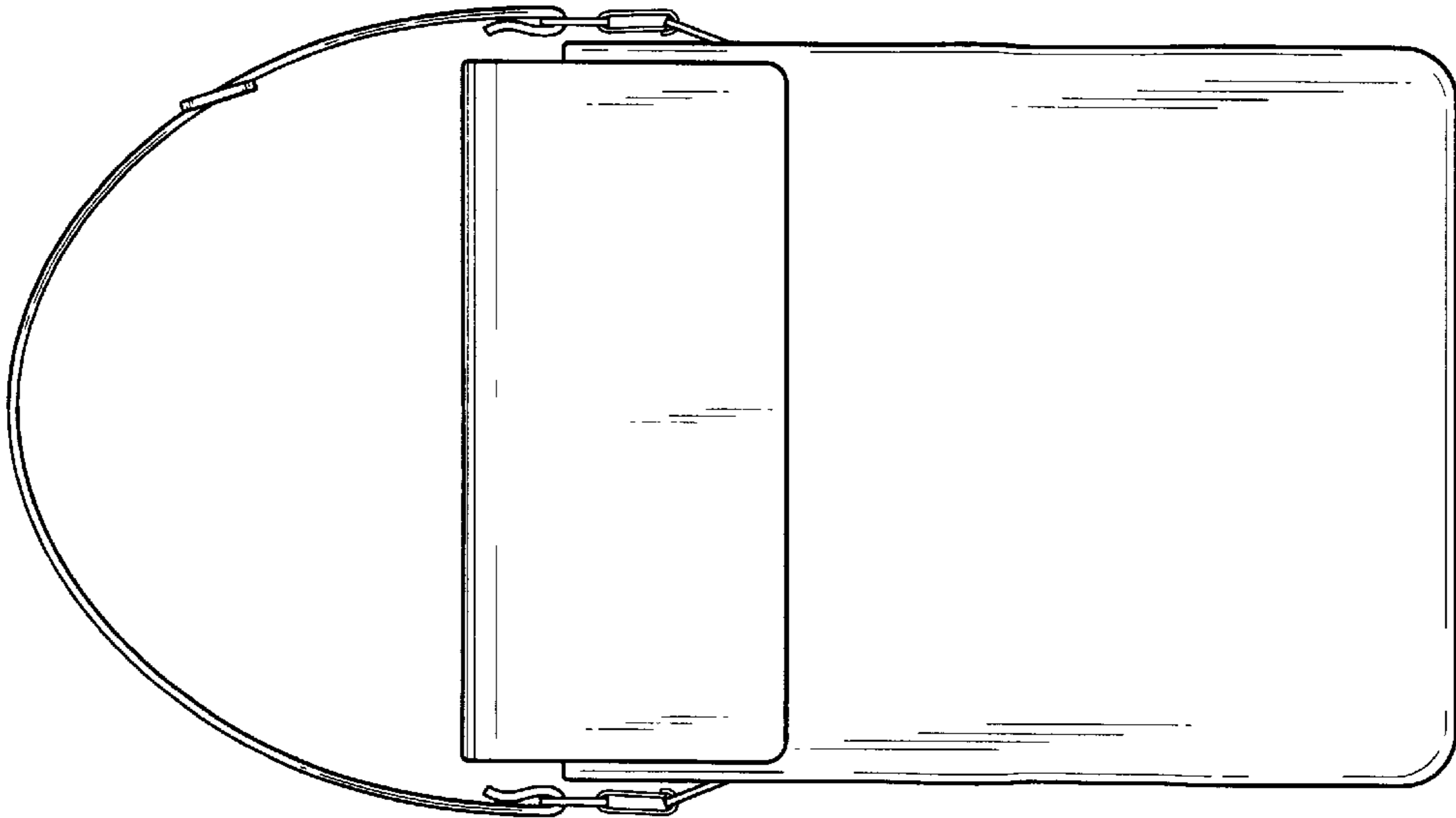

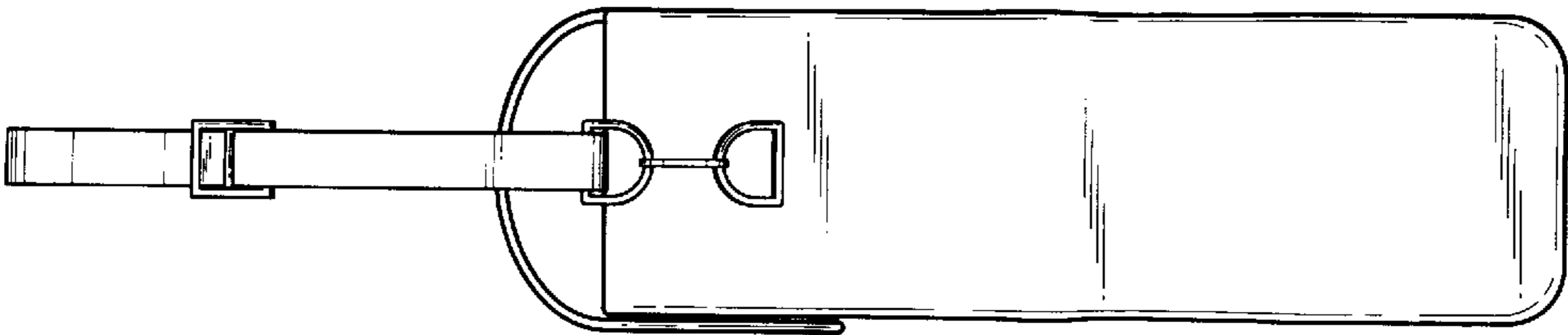

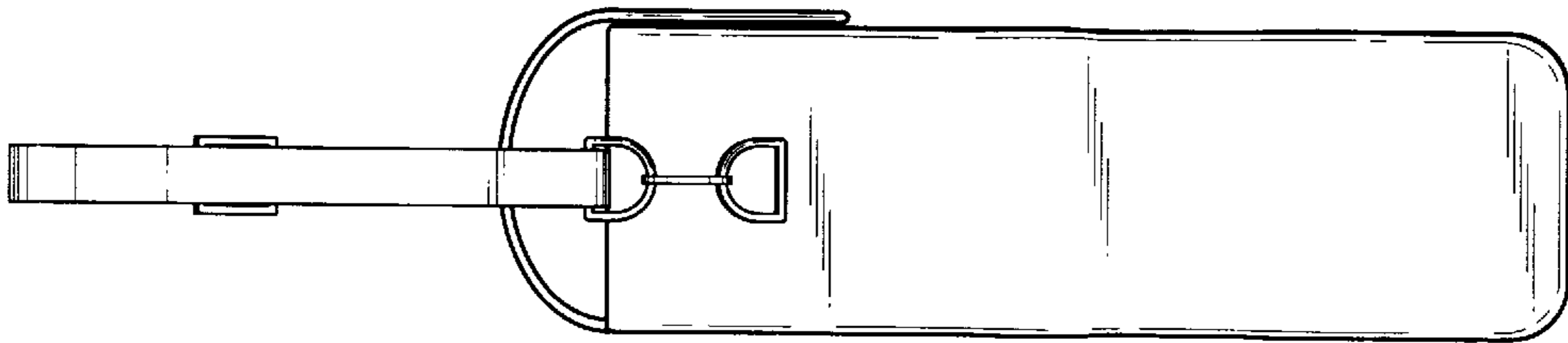

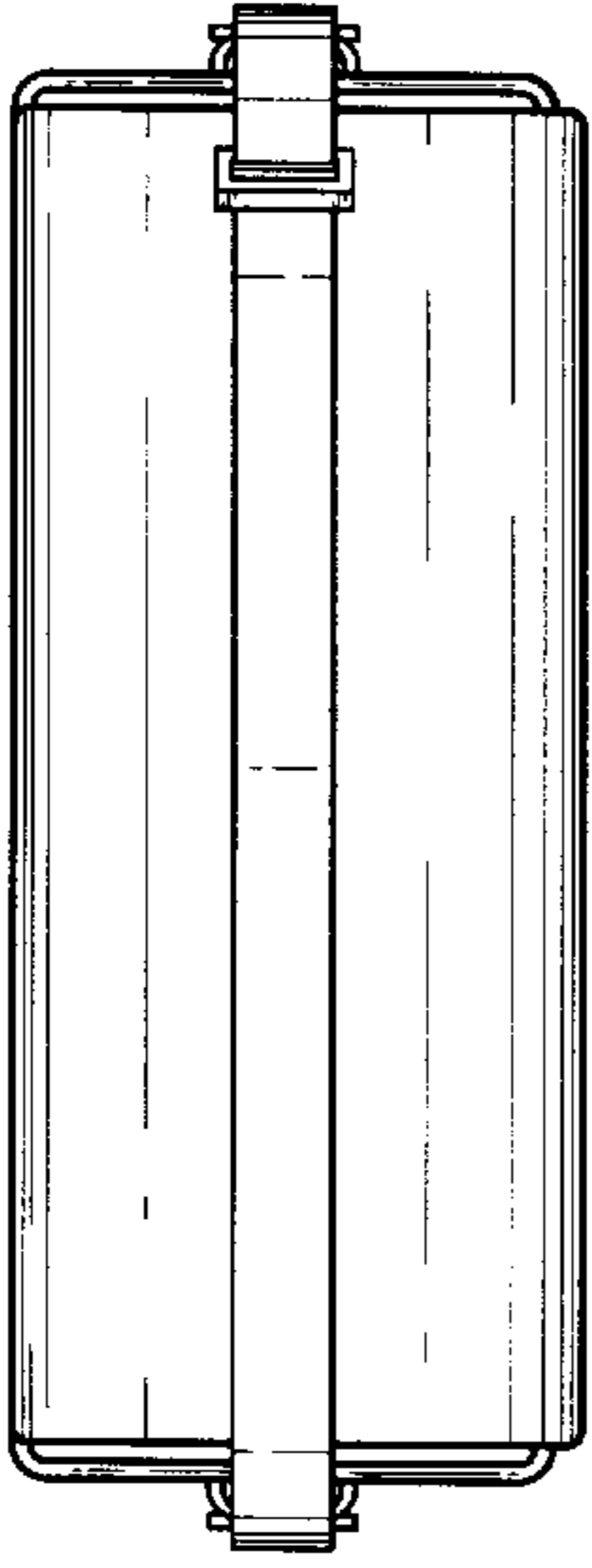

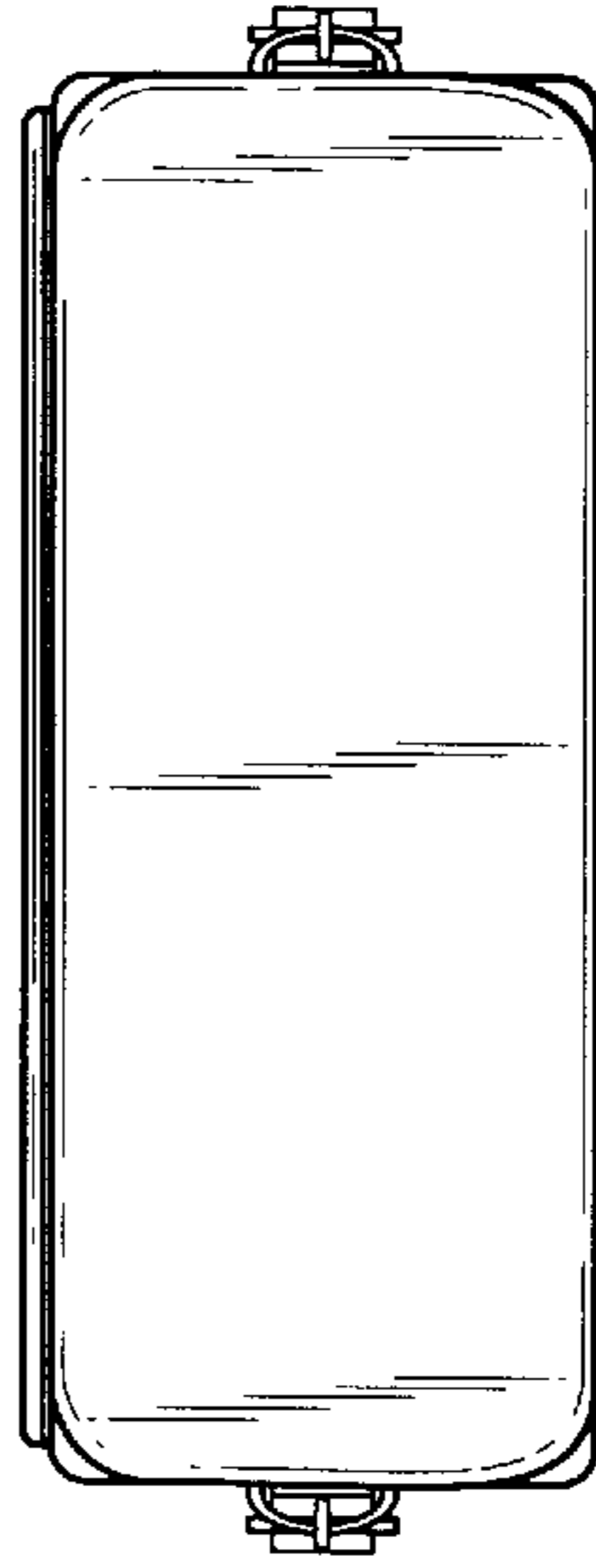
