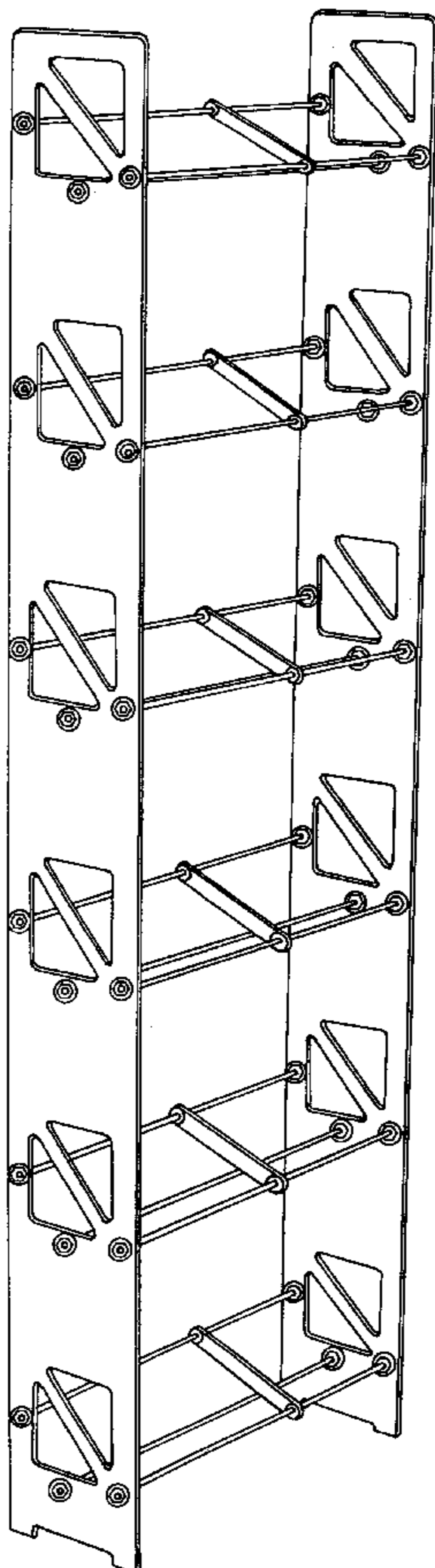
[57] **CLAIM**

The ornamental design for a "multi-media rack", as shown and described.

**DESCRIPTION**

FIG. 1 is a left, front perspective view of a multi-media rack showing my new design.  
FIG. 2 is a front, plan view of the multi-media rack of FIG. 1.

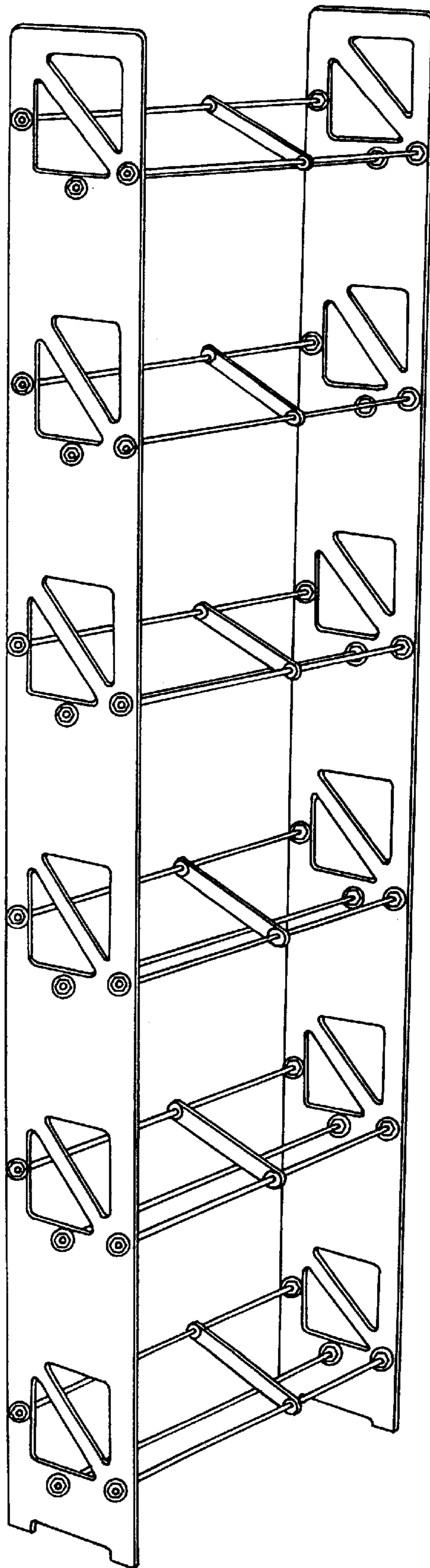

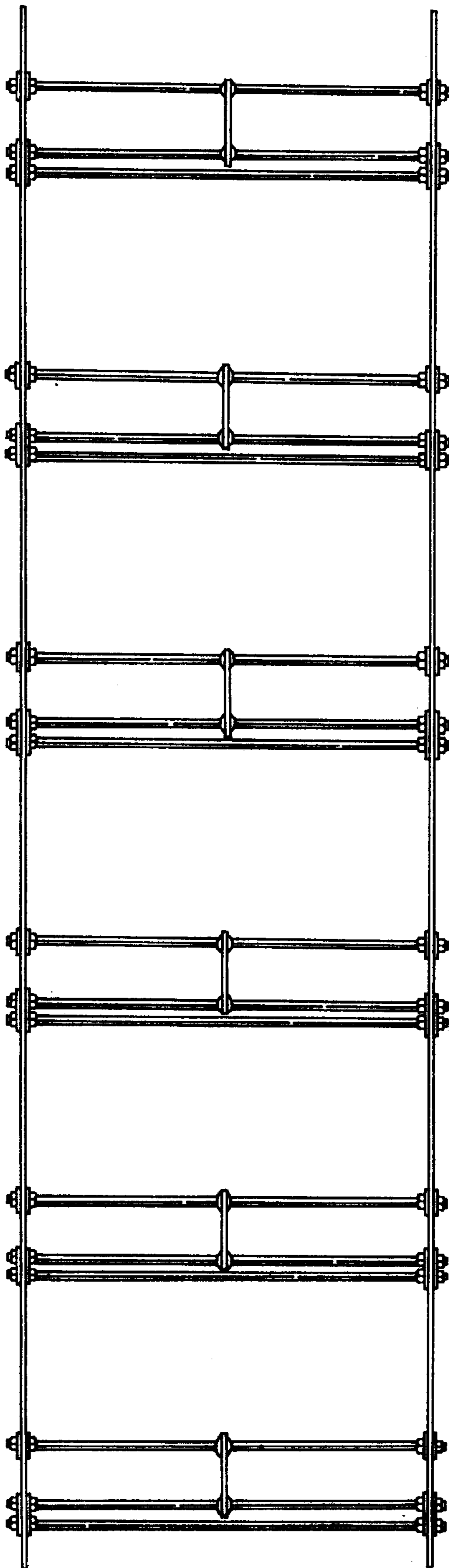

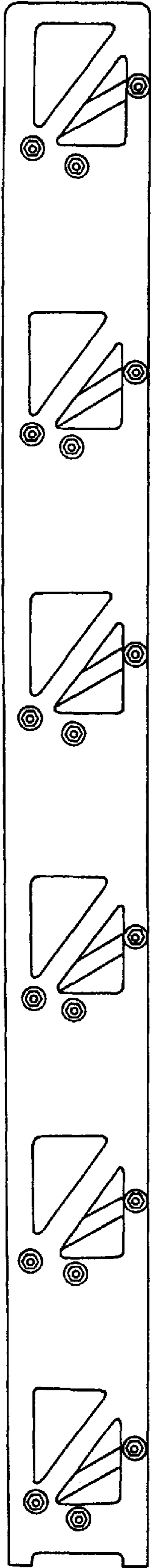

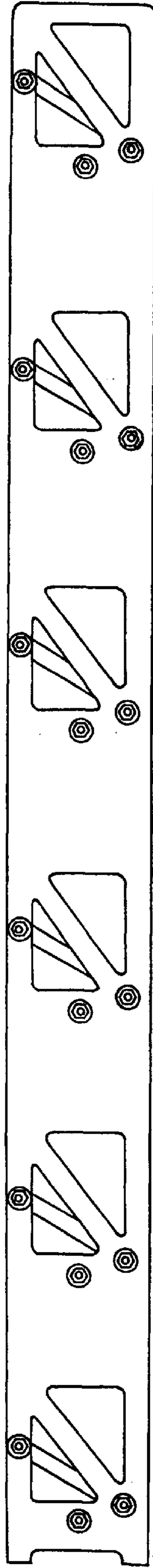

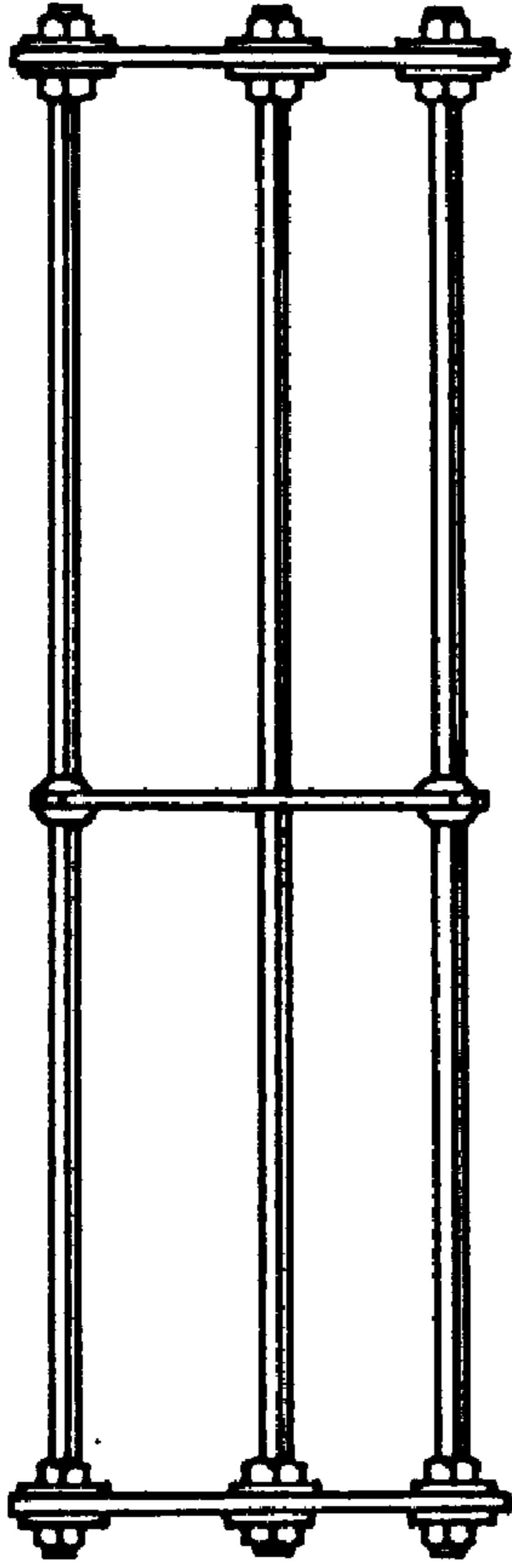

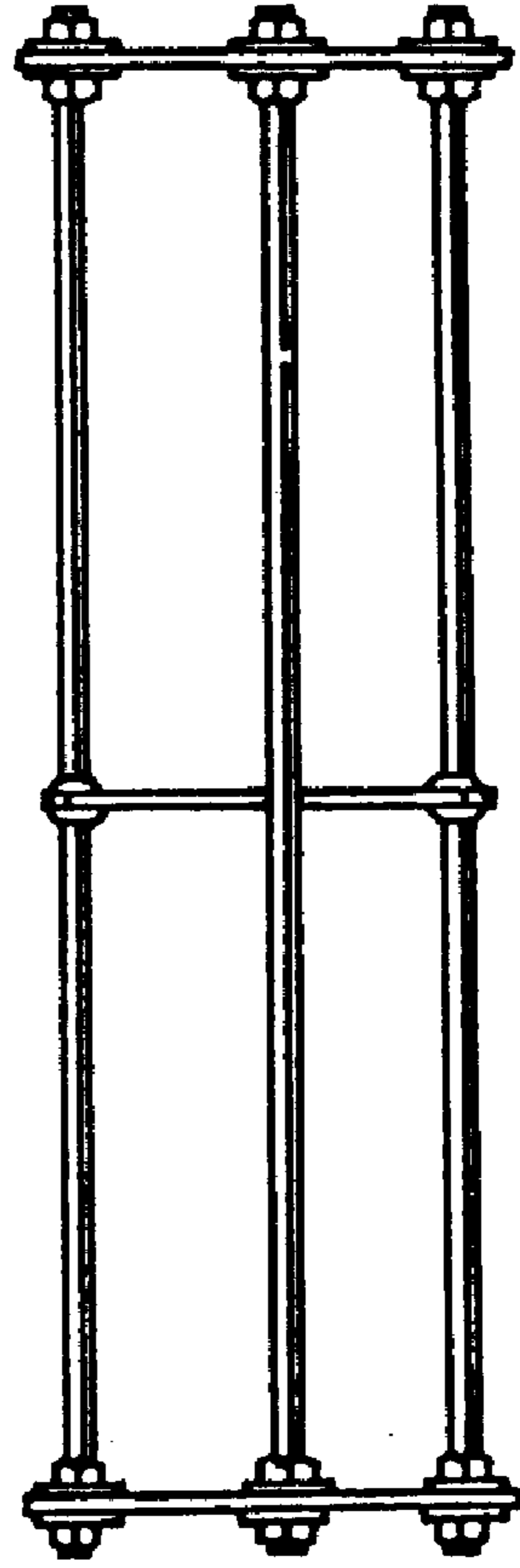

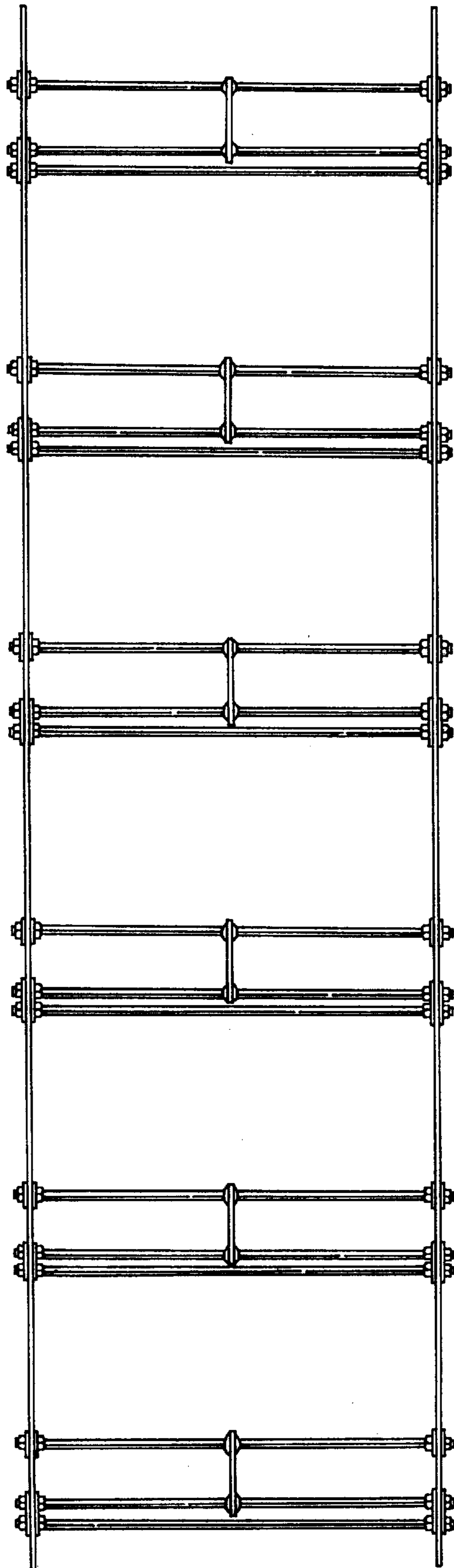
