[57] **CLAIM**

The ornamental design for a colored six pack holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a colored six pack holder

showing my new design, the holder being lined for the color pink;

FIG. 2 is a second embodiment of the colored six pack holder of FIG. 1, lined for the color blue;

FIG. 3 is a third embodiment of the colored six pack holder of FIG. 1, lined for the colors violet or purple;

FIG. 4 is a fourth embodiment of the colored six pack holder of FIG. 1, lined for the colors gray or silver;

FIG. 5 is a fifth embodiment of the colored six pack holder of FIG. 1, lined for the color green;

FIG. 6 is a sixth embodiment of the colored six pack holder of FIG. 1, lined for the color brown;

FIG. 7 is a seventh embodiment of the colored six pack holder of FIG. 1, lined for the colors yellow or gold;

FIG. 8 is an eighth embodiment of the colored six pack holder in FIG. 1, lined for the color orange;

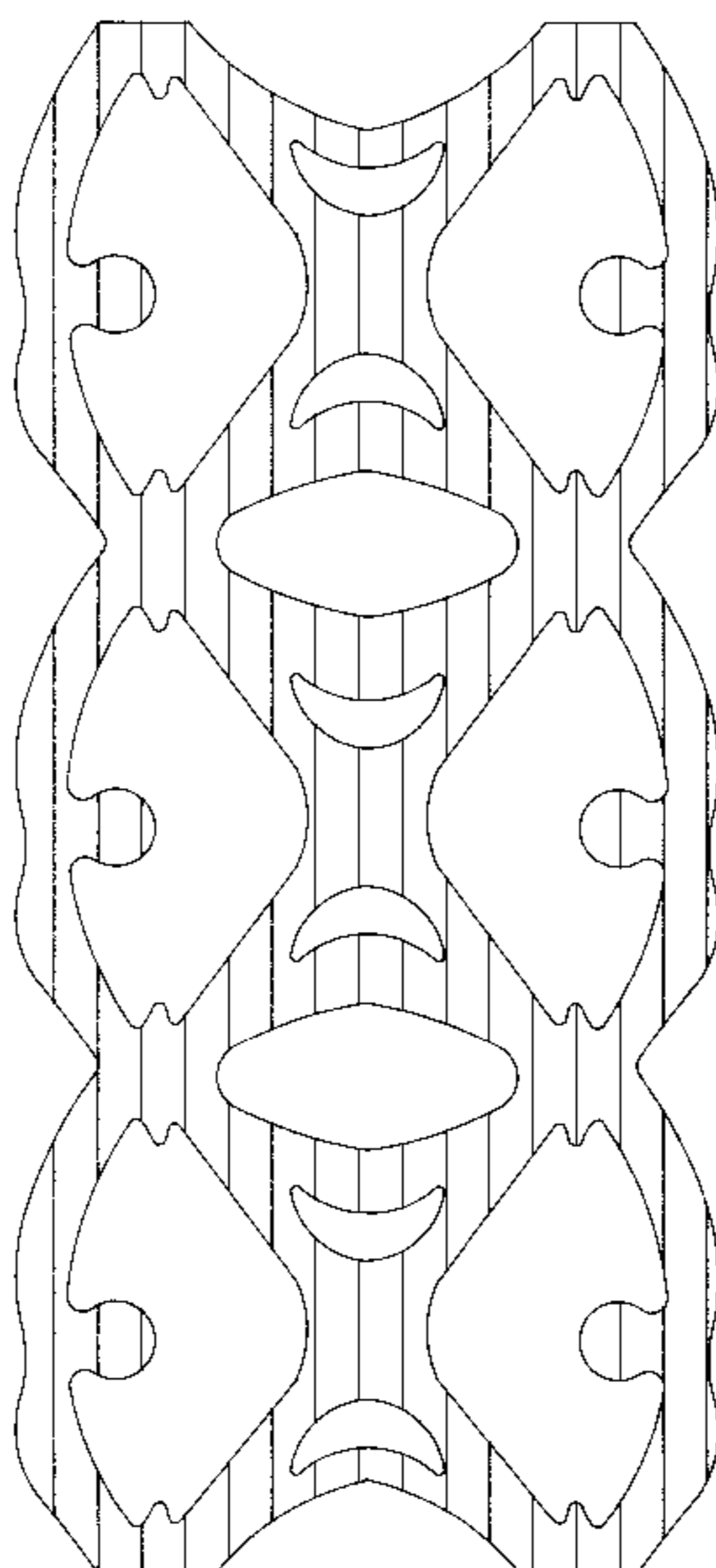
FIG. 9 is a ninth embodiment of the colored six pack holder of FIG. 1, lined for the color black;

FIG. 10 is an end view of the colored six pack holder, this view being identical for all embodiments, except for the colors as indicated in Figure descriptions 1-9; and,

FIG. 11 is a side view of the colored six pack holder, this view being identical for all embodiments except for the colors as indicated in Figure descriptions 1-9.

The drawing FIGS. 1-9, showing the plan view of a colored six pack holder, are lined for color using standard PTO symbols.

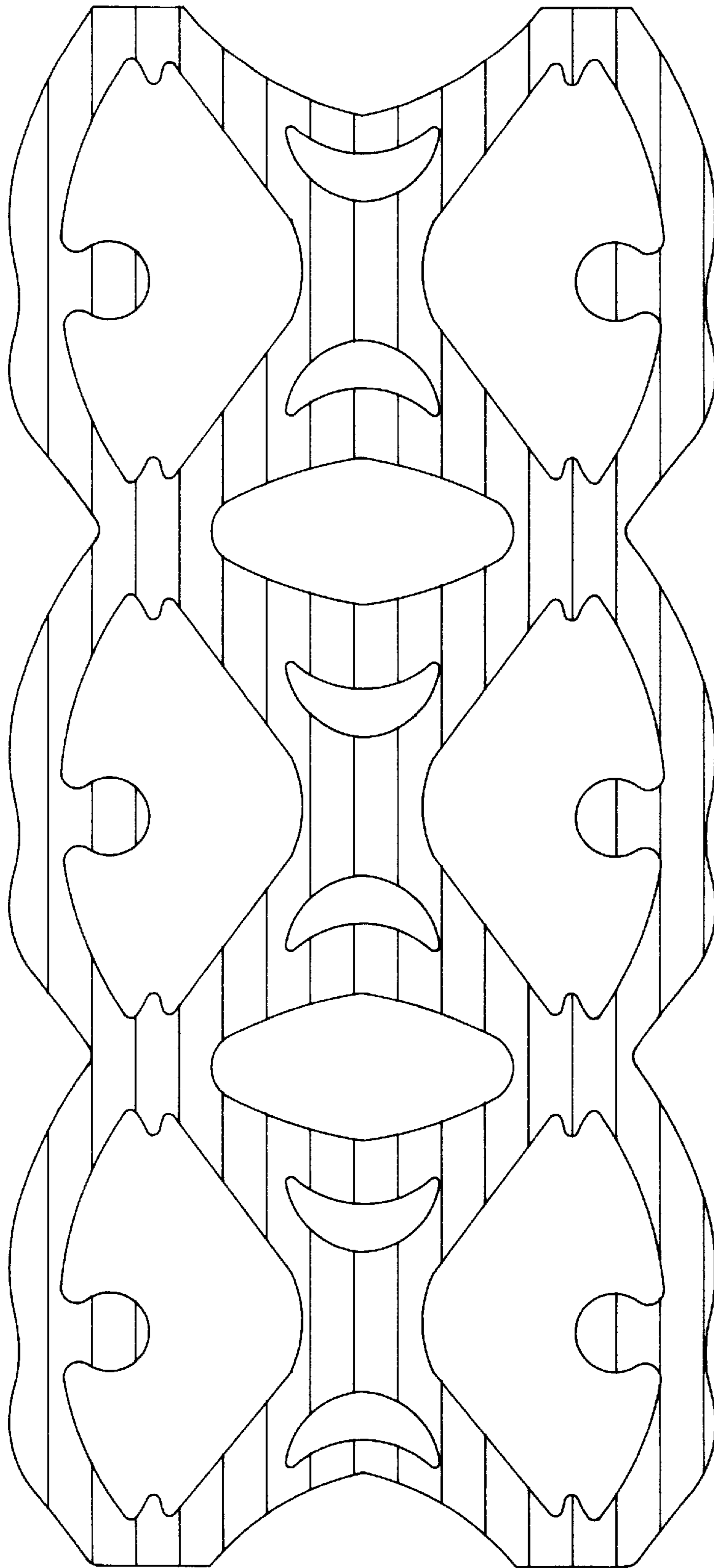

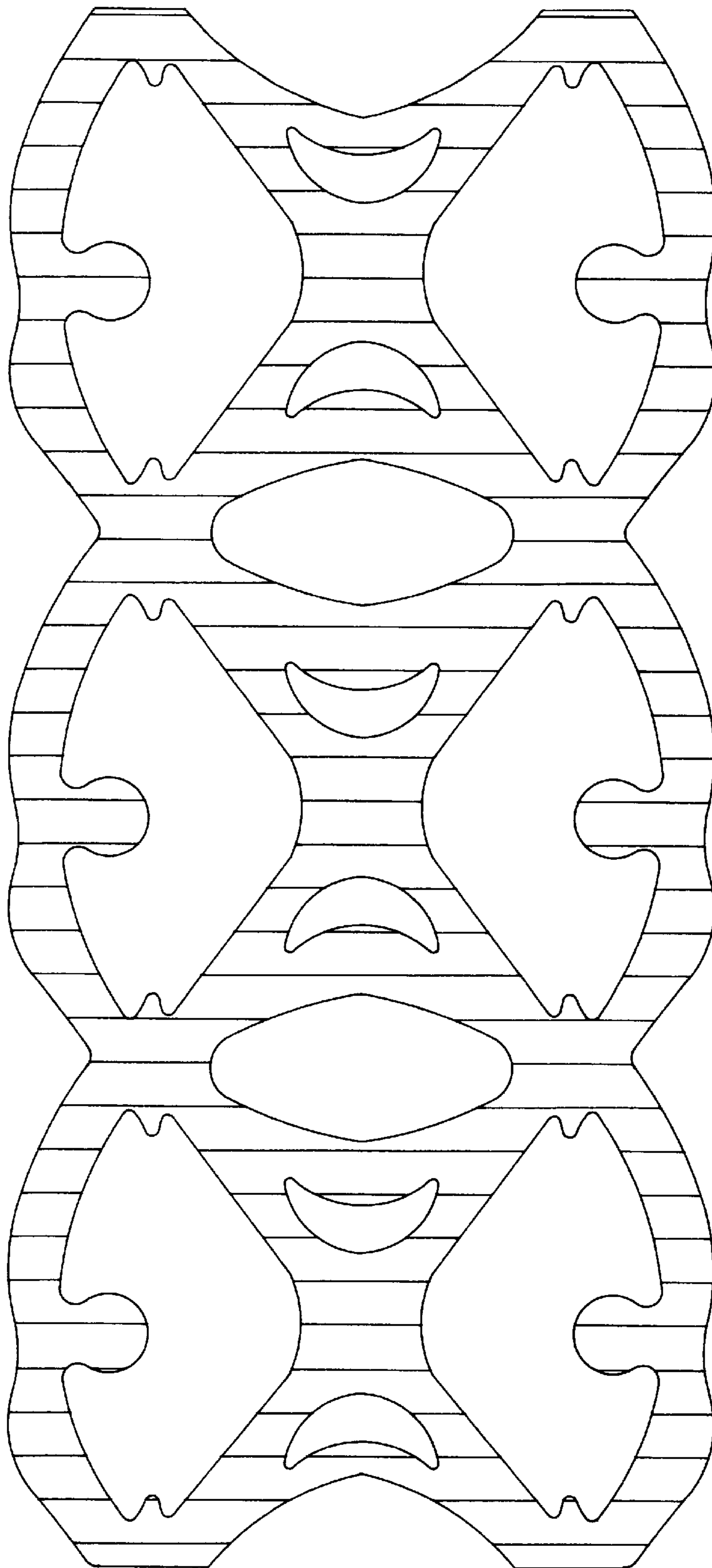

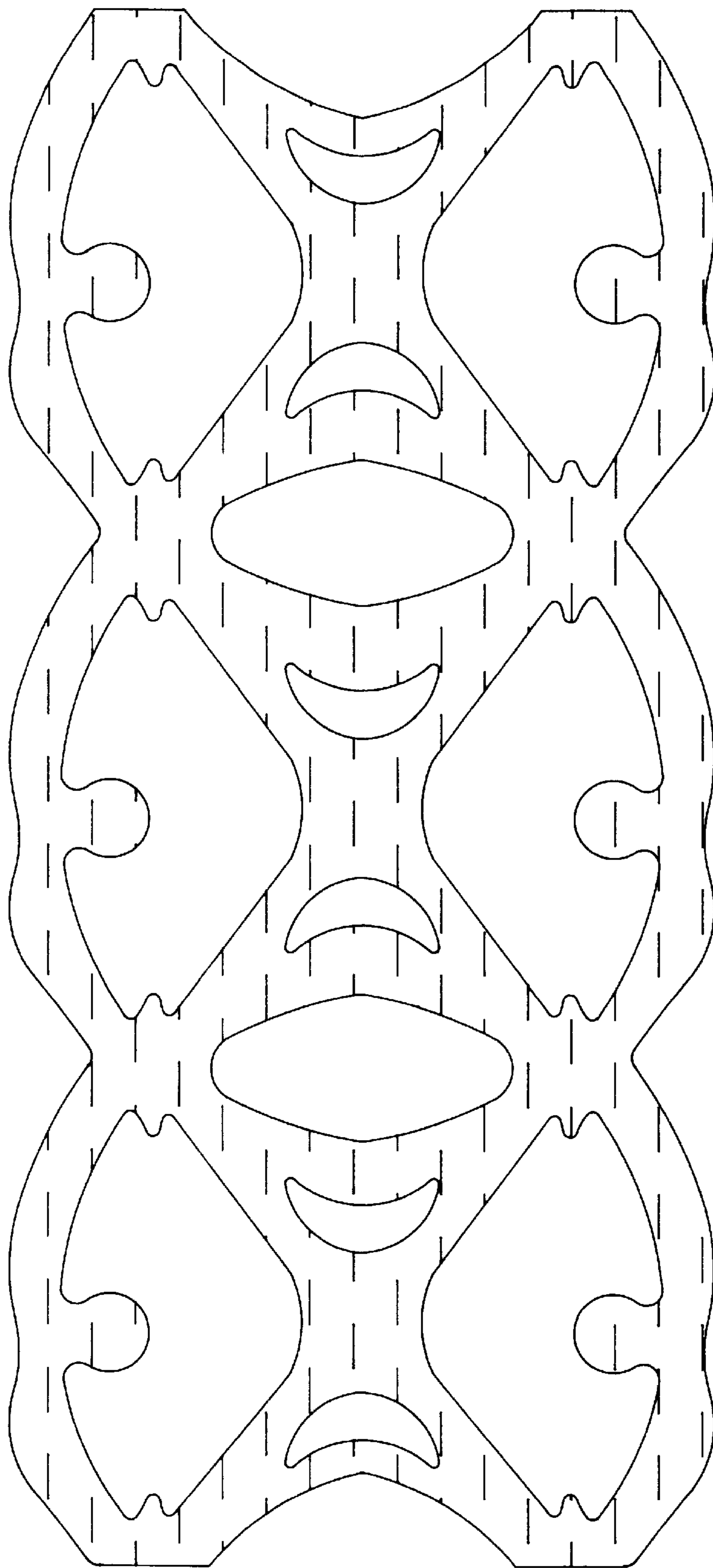

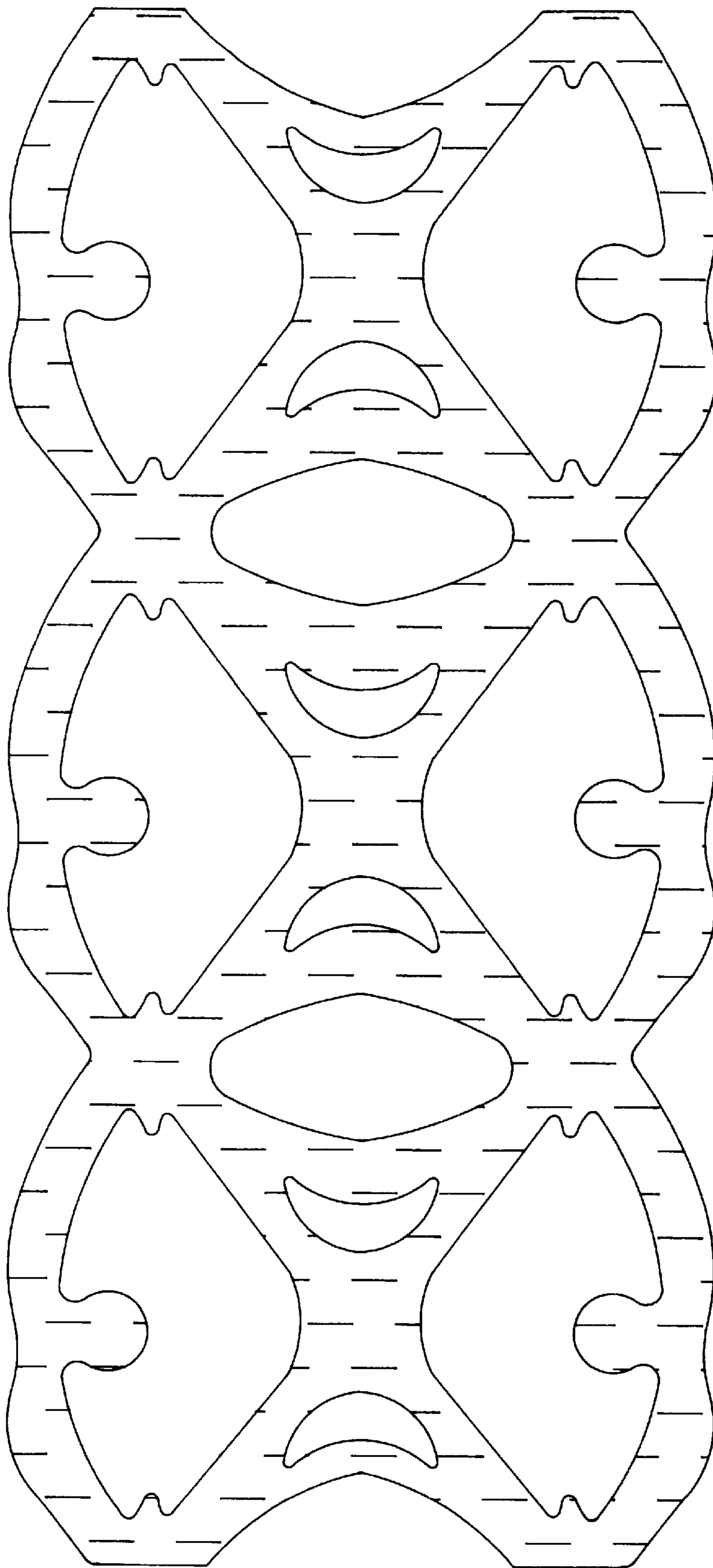

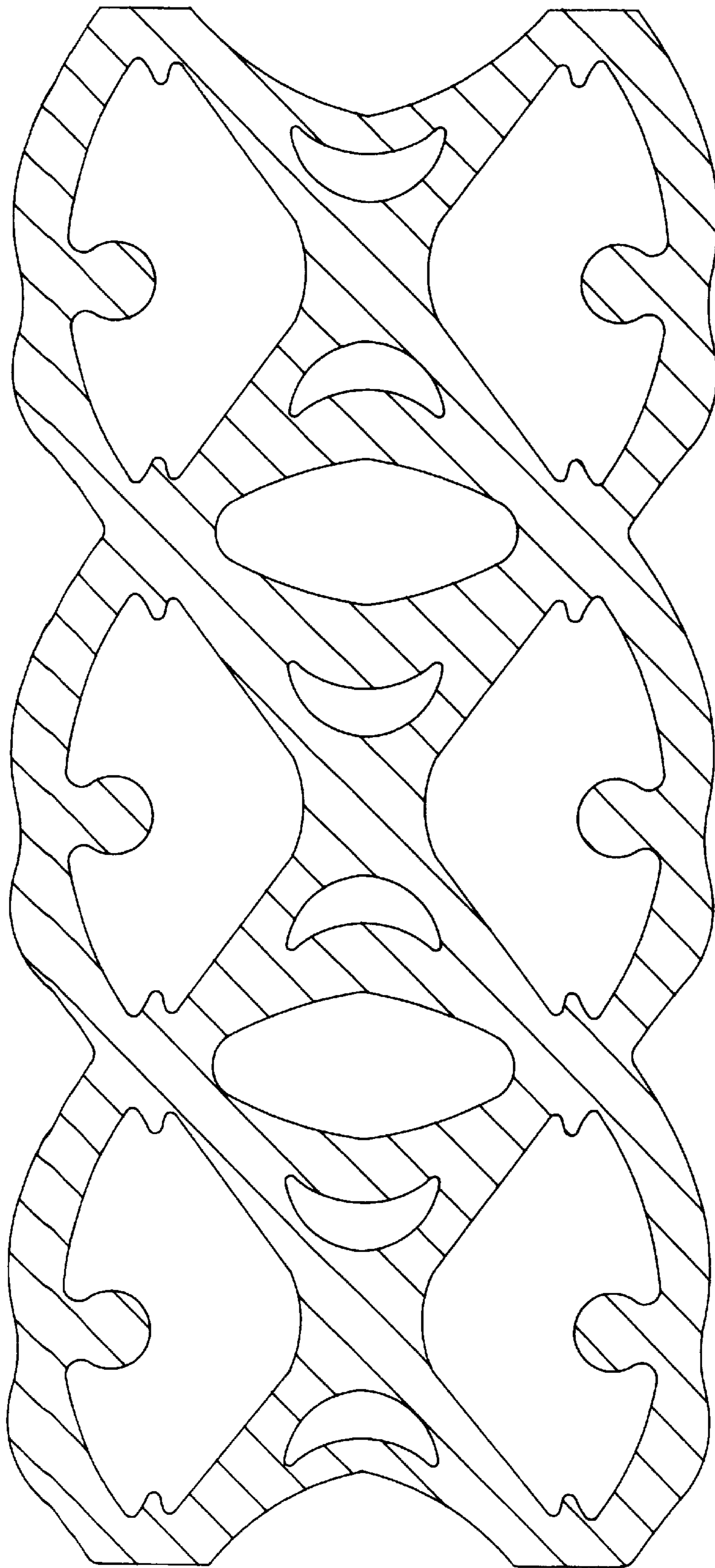

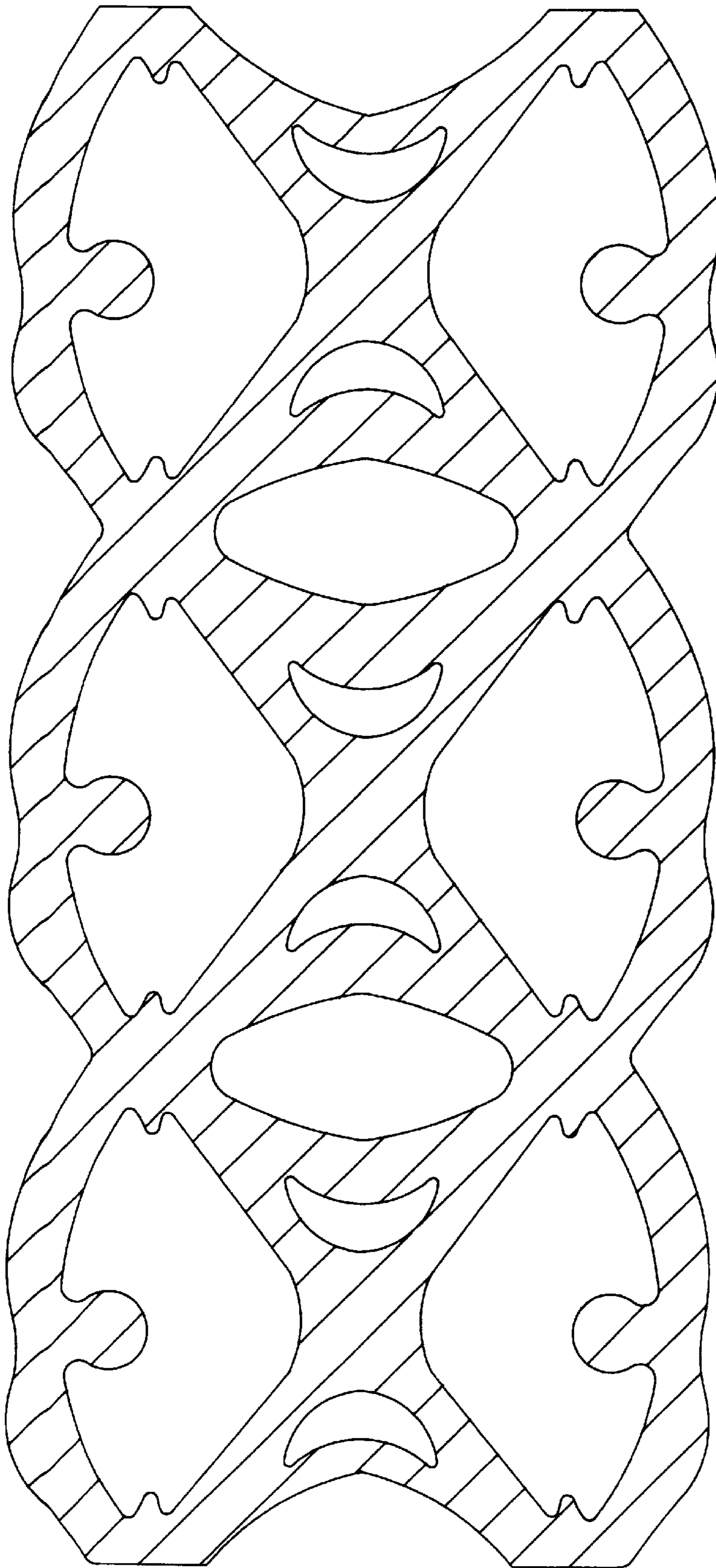

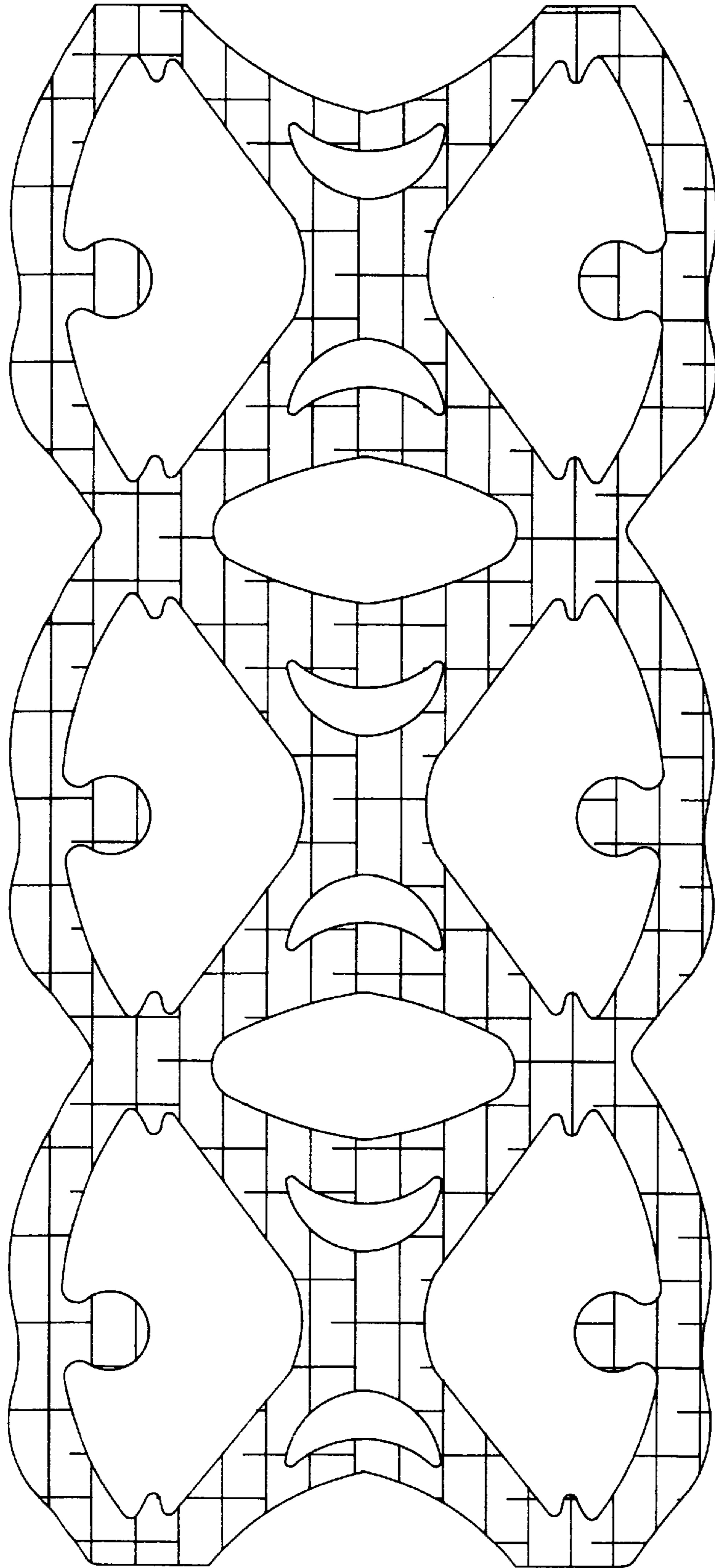

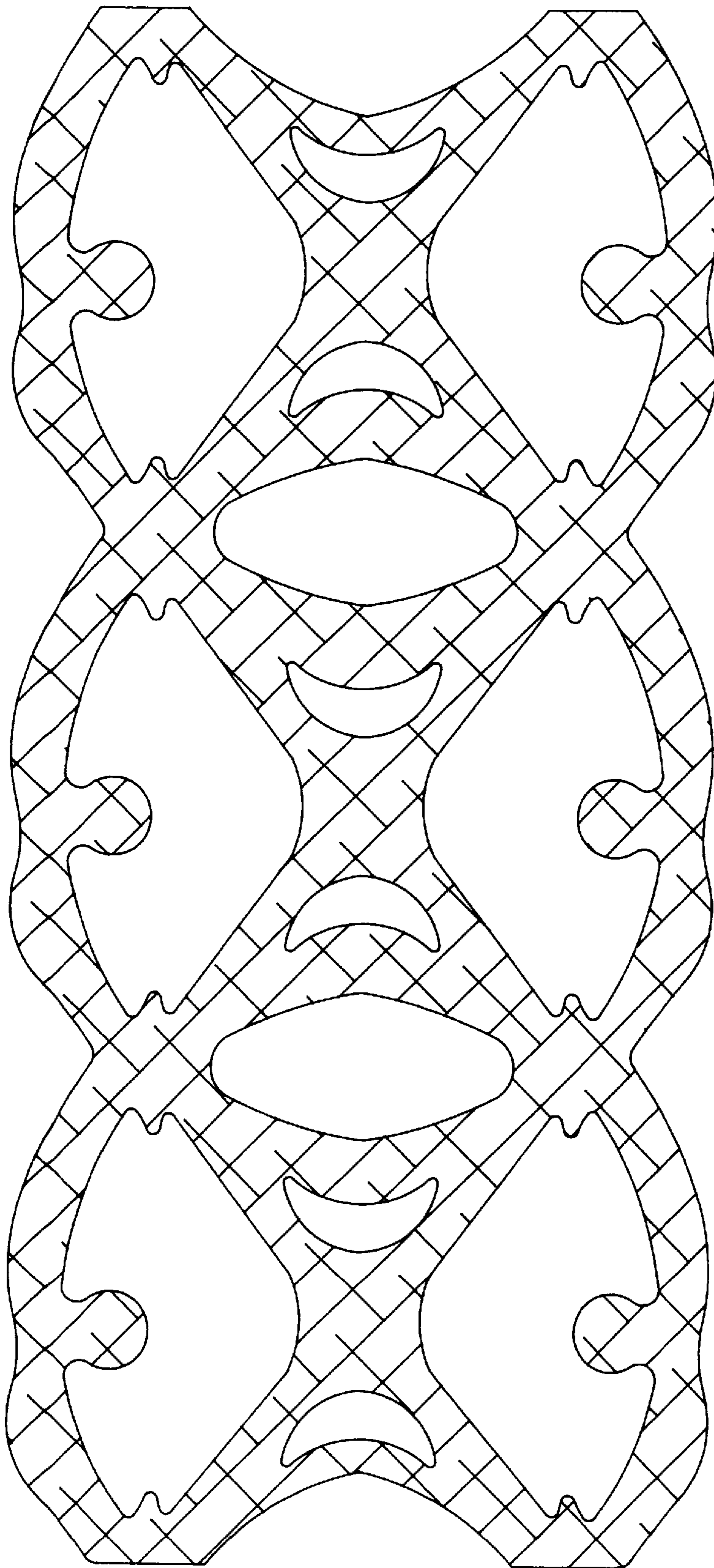

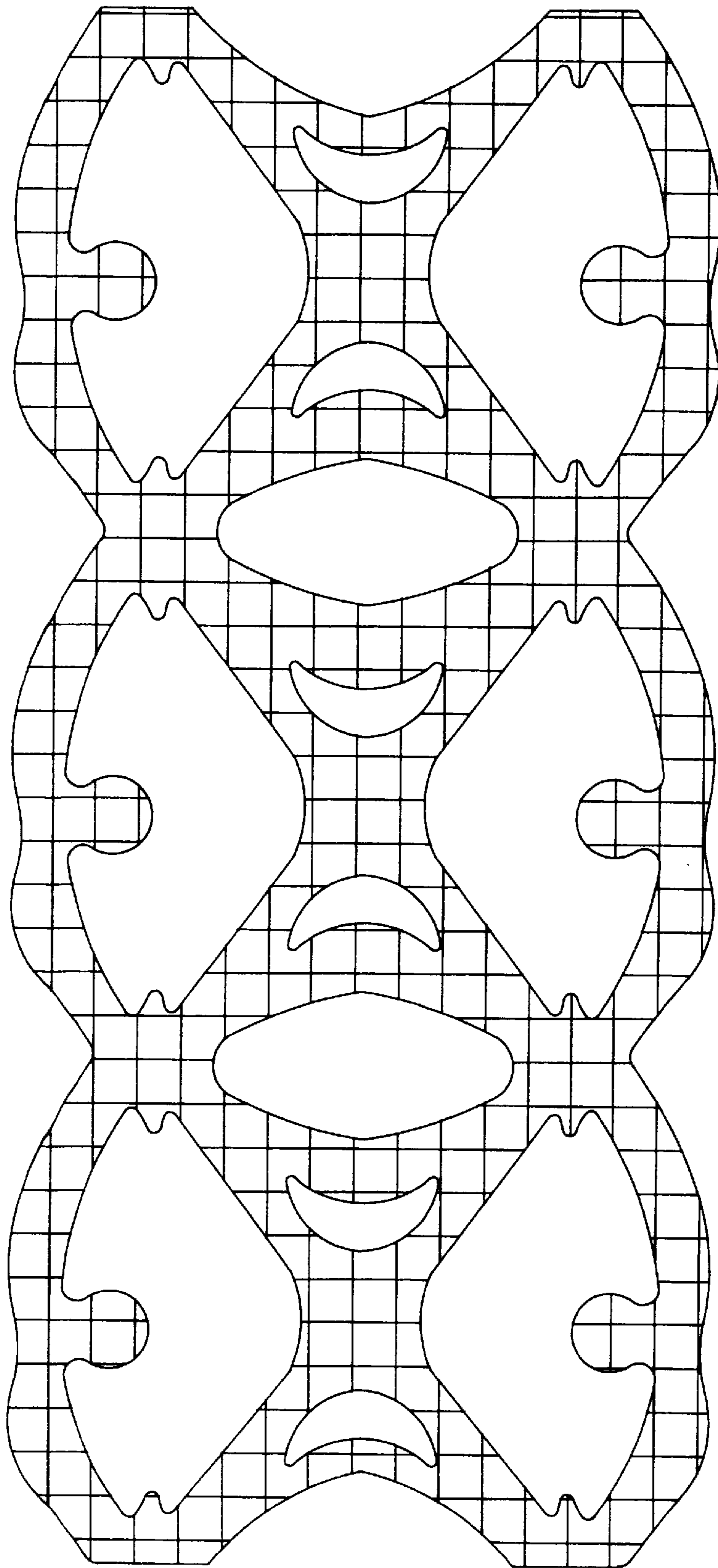

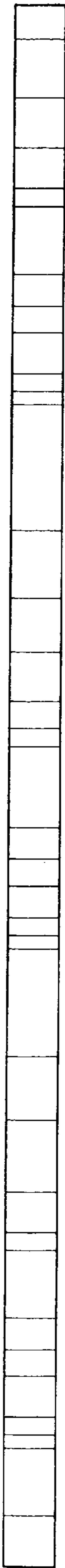

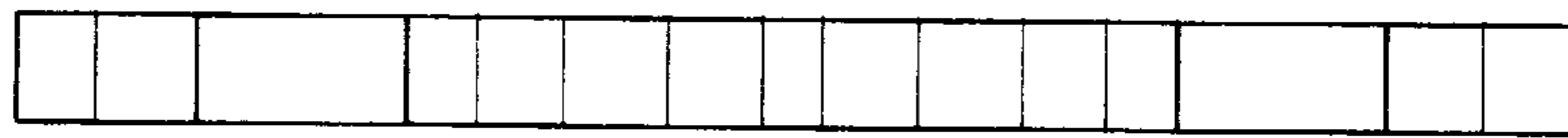
